(57) **CLAIM**

The ornamental design for a head worn cockpit avionics display, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a head worn cockpit avionics display showing my new design, the broken lines indicate environmental structure and form no part of the claimed design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a rear elevational view thereof;

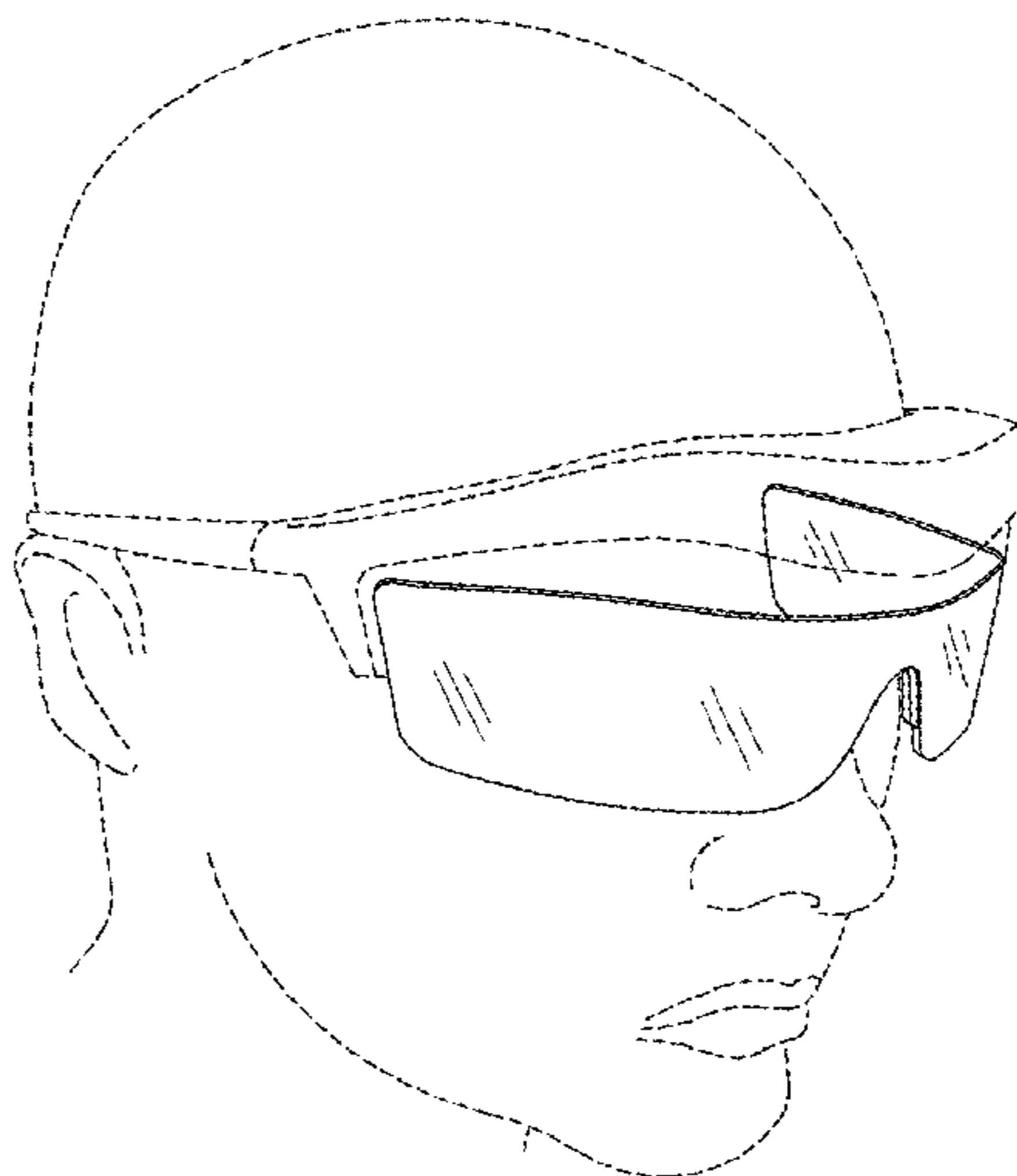
FIG. 6 is a right side elevational view thereof; and,

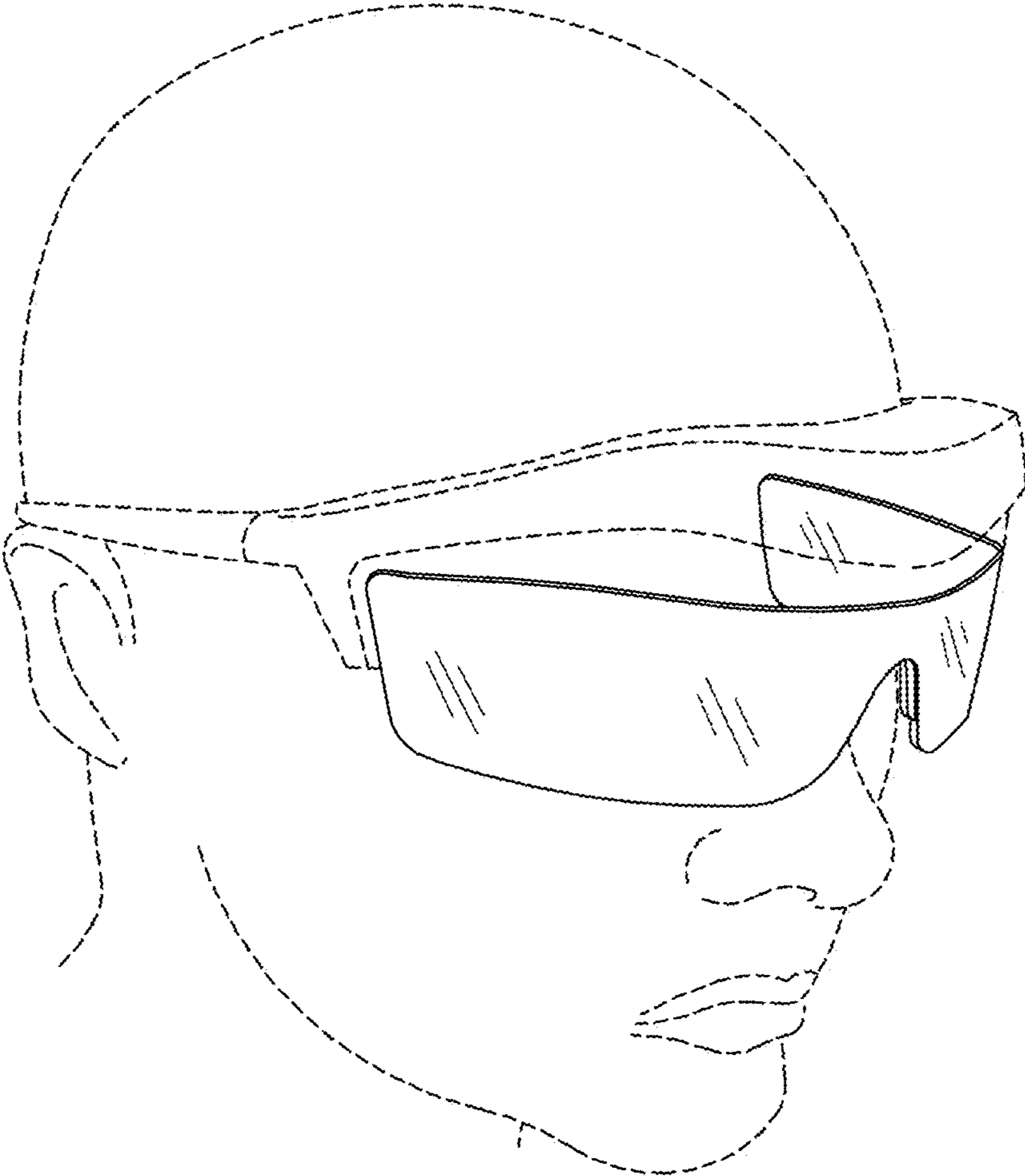

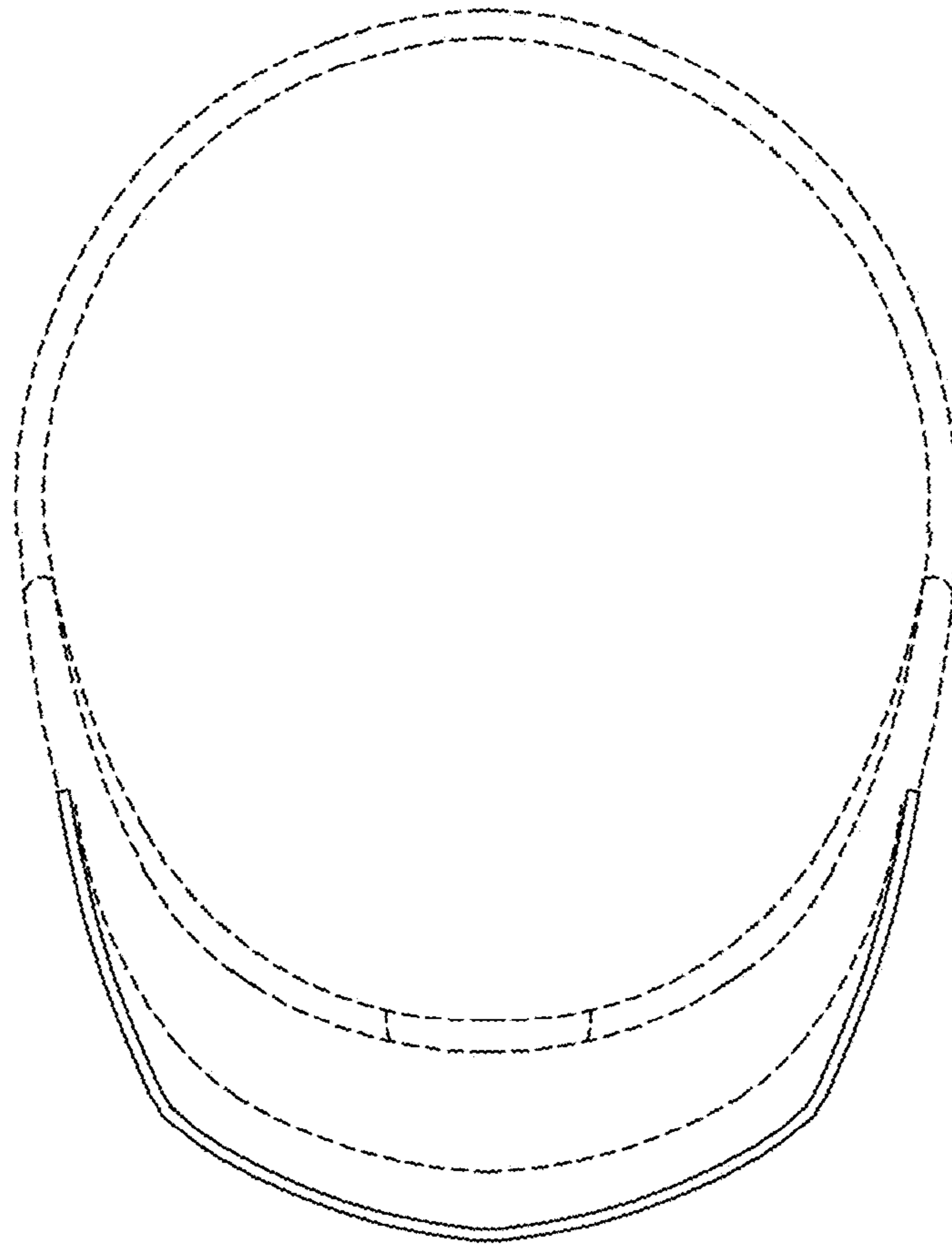

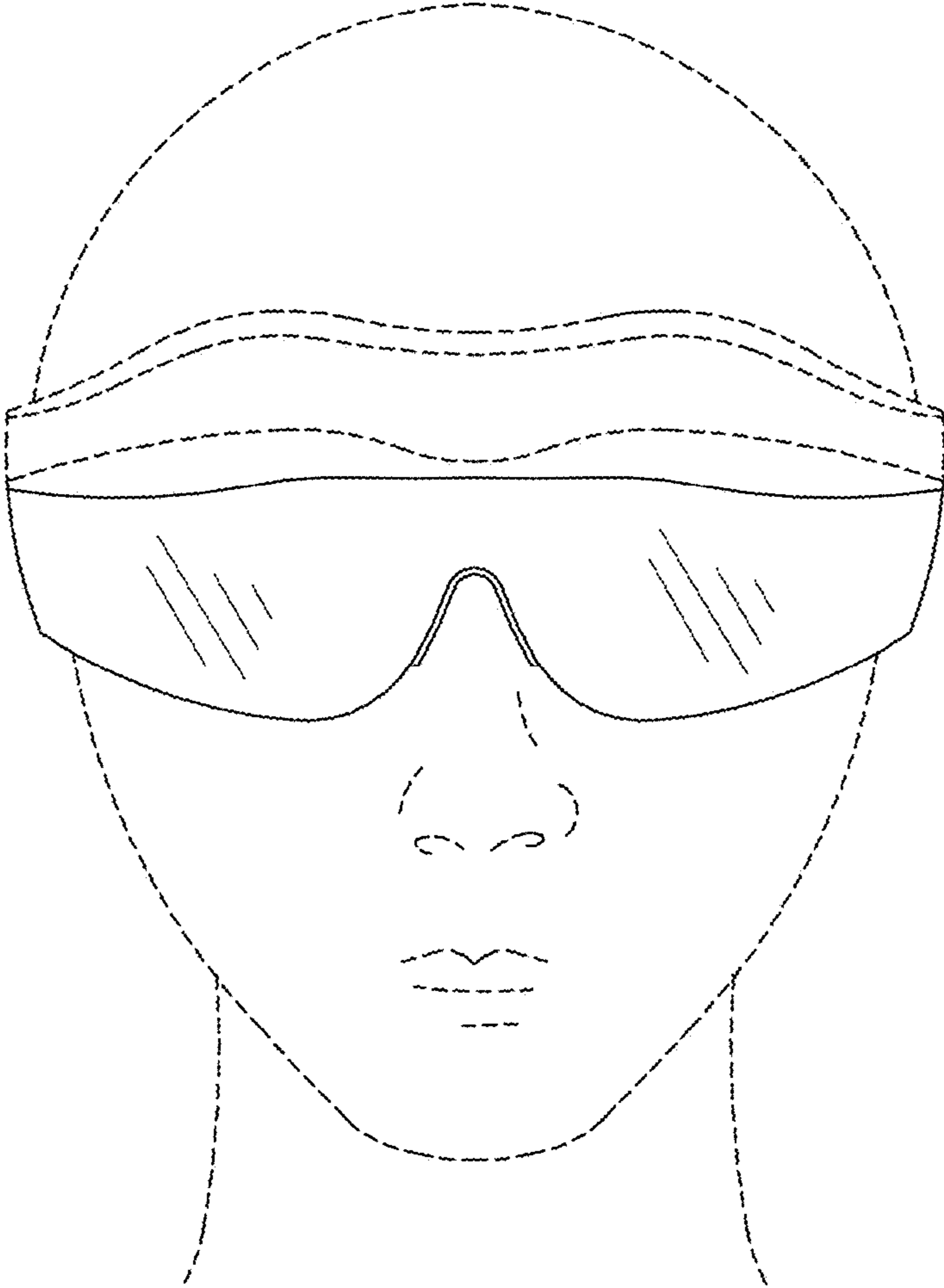

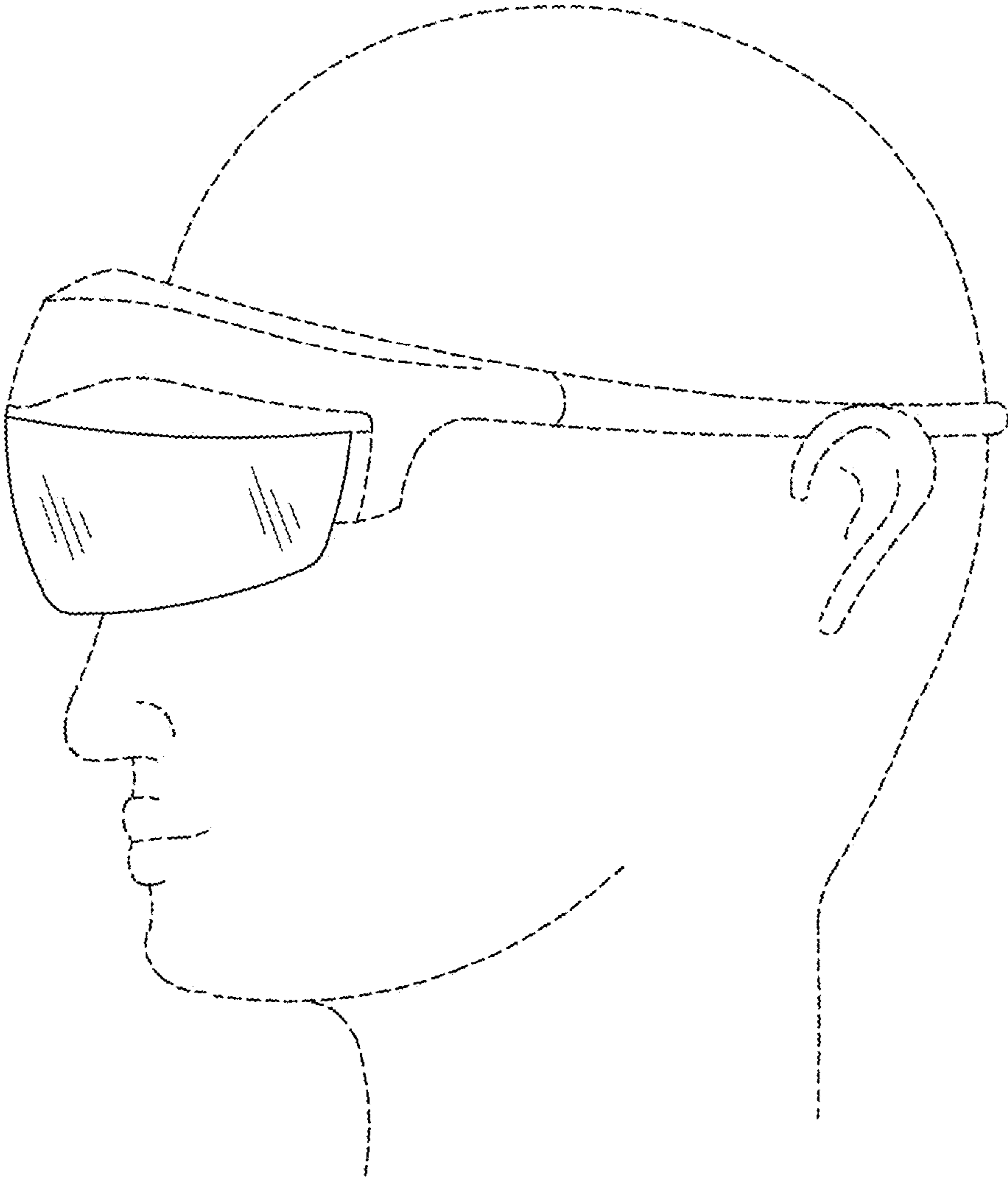

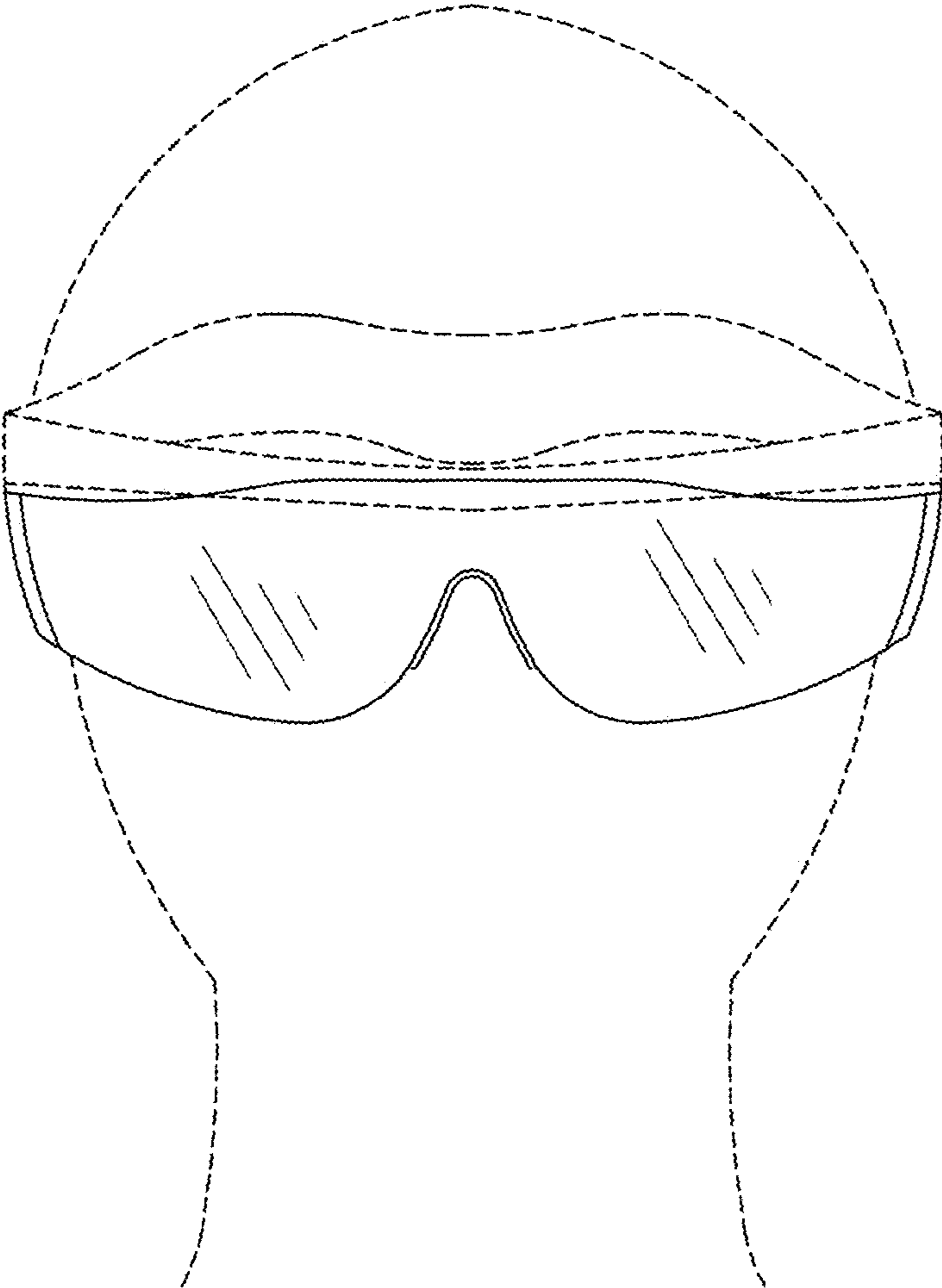

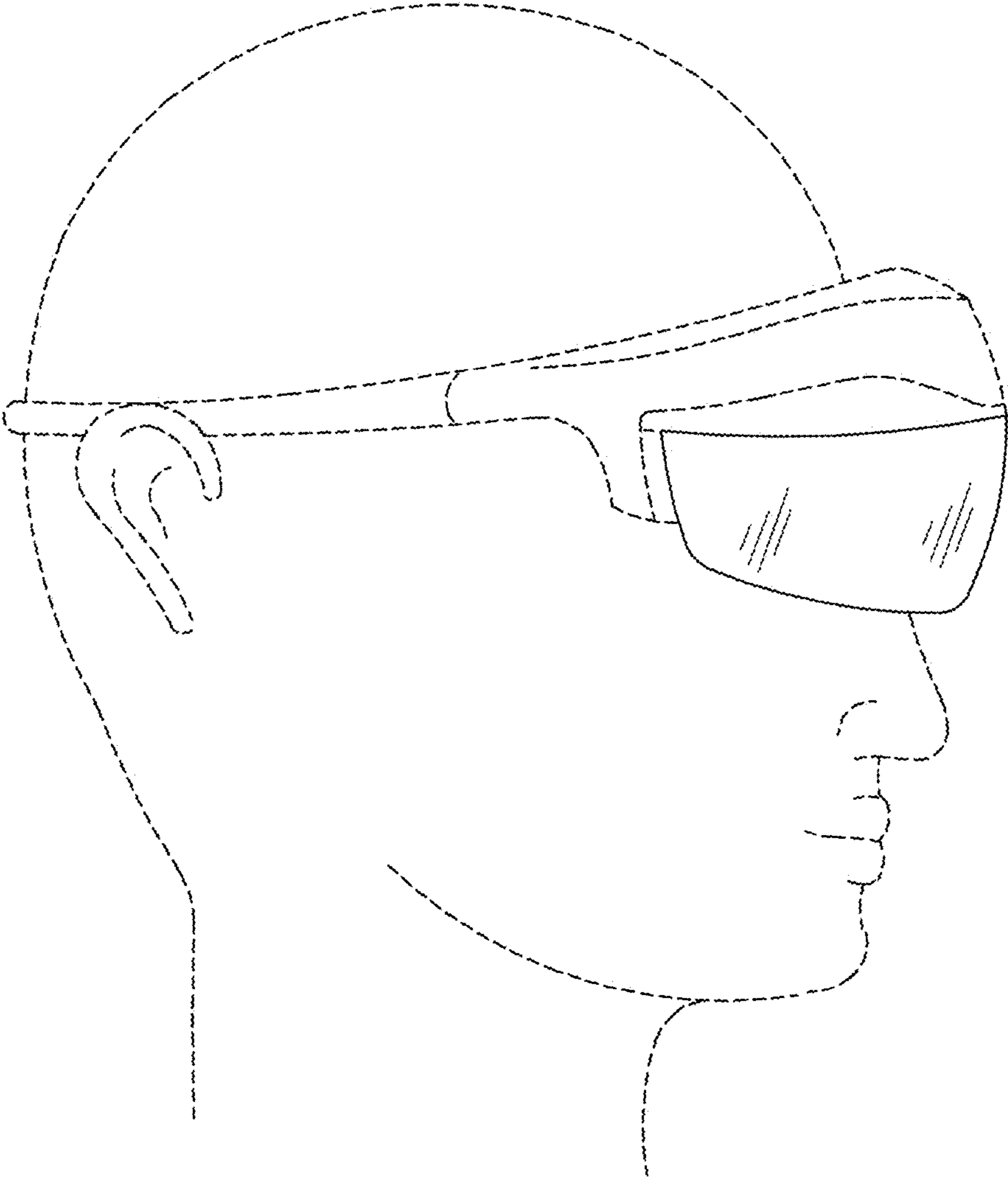

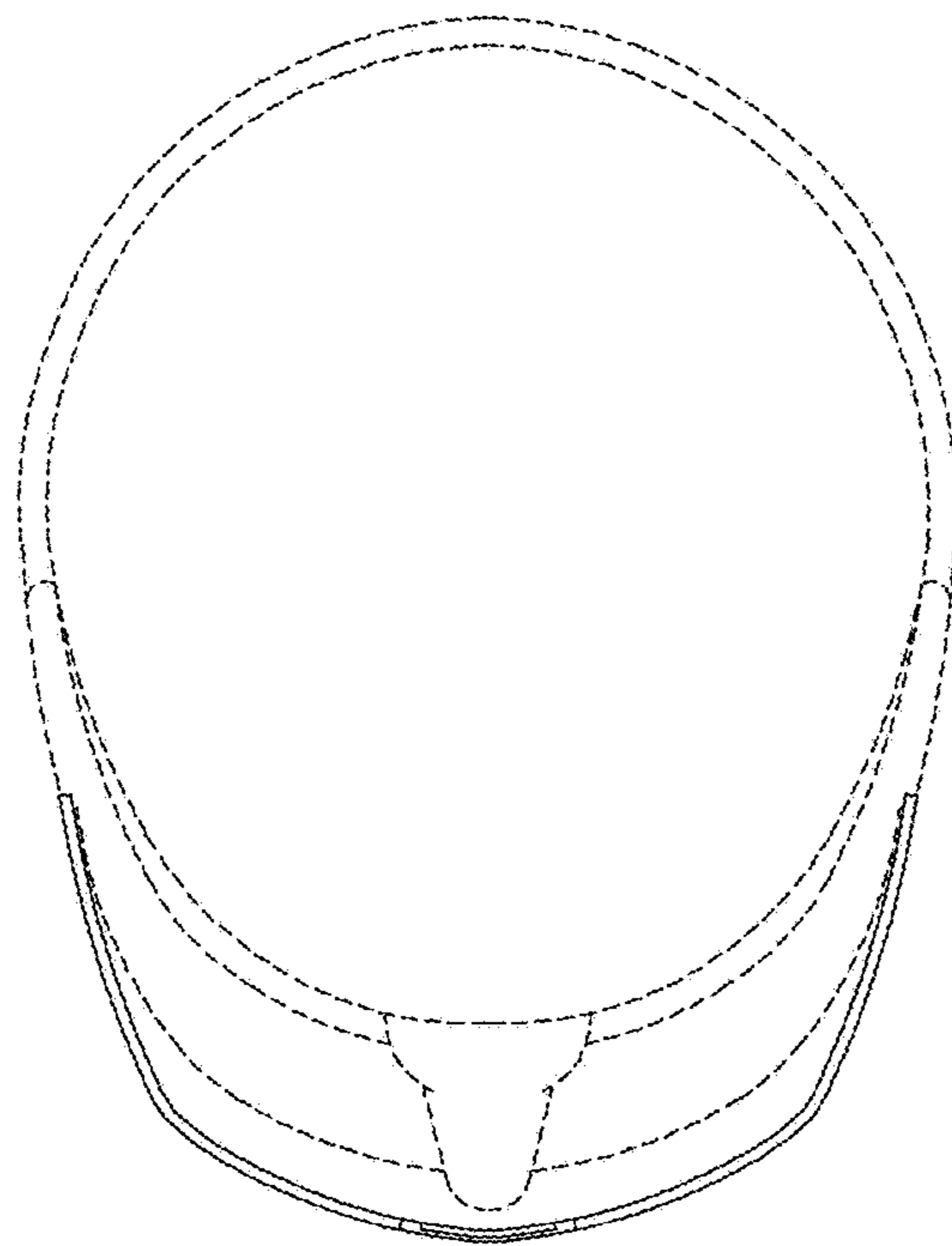
