The ornamental design for a swing, as shown and described.

DESCRIPTION

FIG. 1 is a perspective and partial view of the lower portion of a swing showing my new design; FIG. 2 is a front view of the swing; FIG. 3 is a rear view of the swing shown in FIG. 2; FIG. 4 is a left side view of the swing shown in FIG. 2; FIG. 5 is a right side view of the swing shown in FIG. 2; FIG. 6 is a top view of the swing shown in FIG. 2; and, FIG. 7 is a bottom view of the swing shown in FIG. 2. Elements shown in broken lines show environmental structures or non-claimed portions of the swing and form no part of our design.

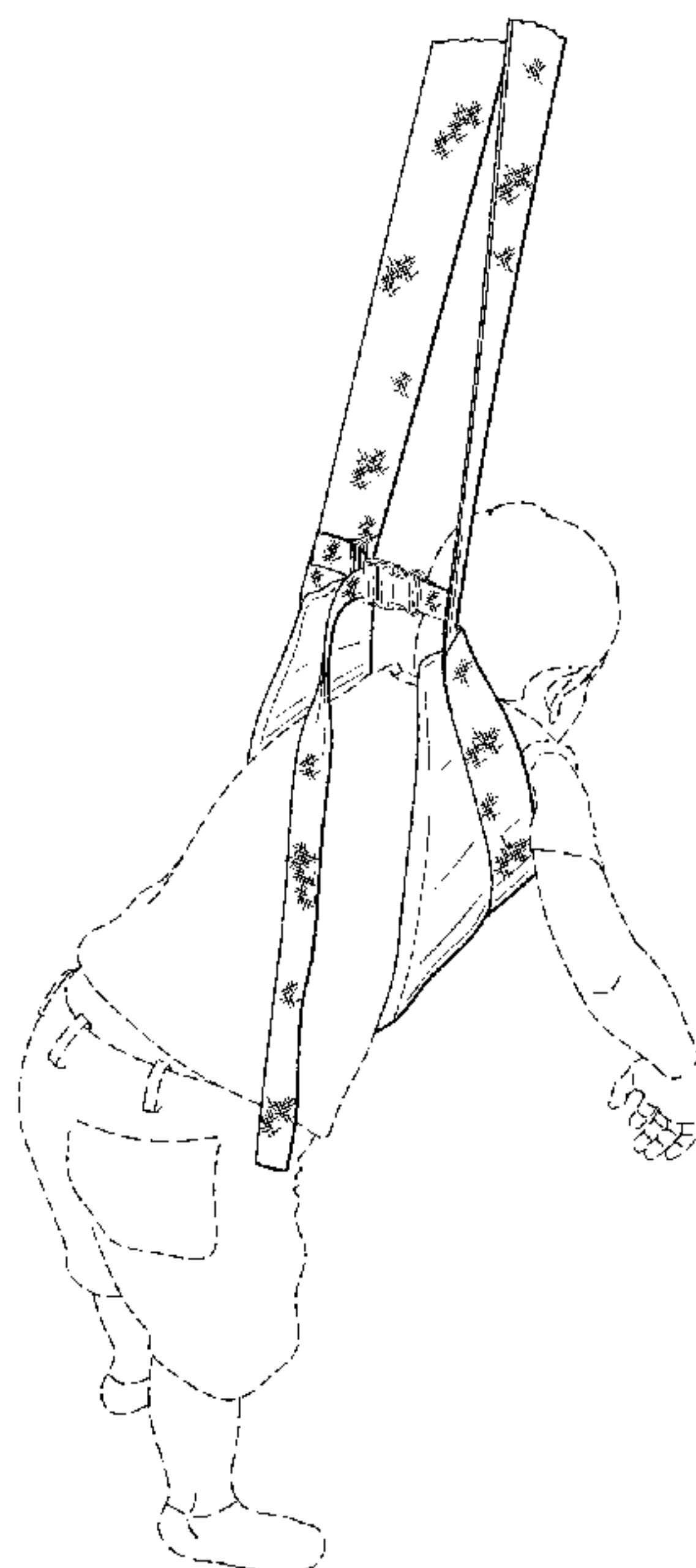

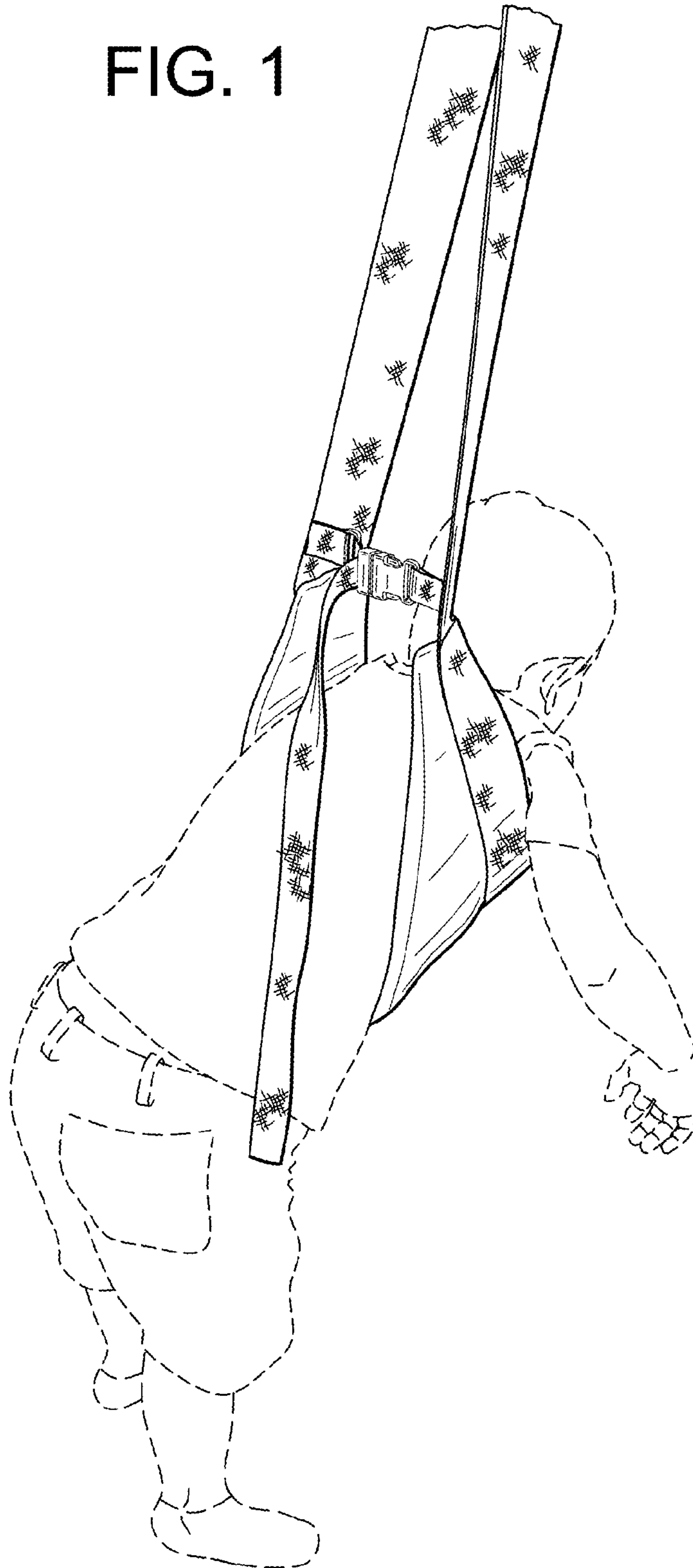

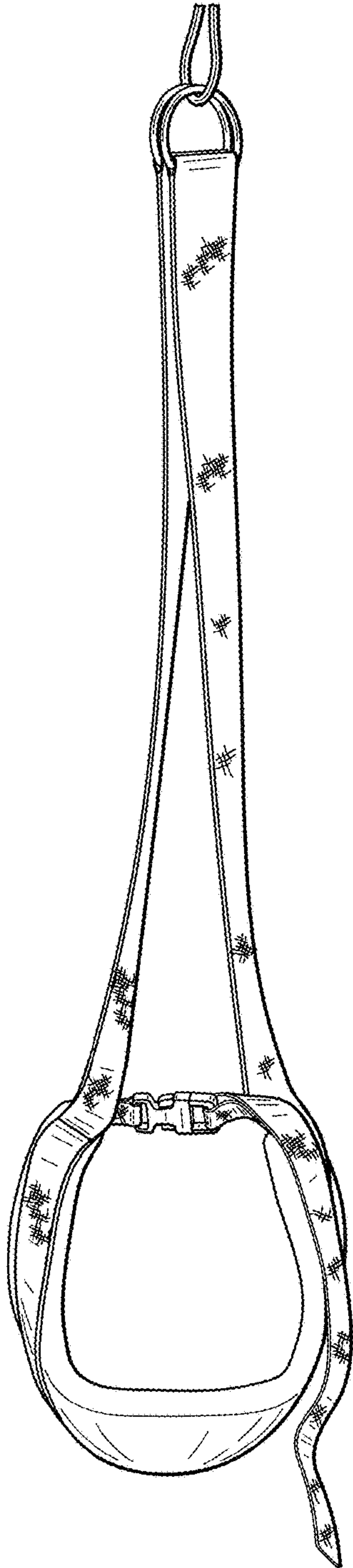

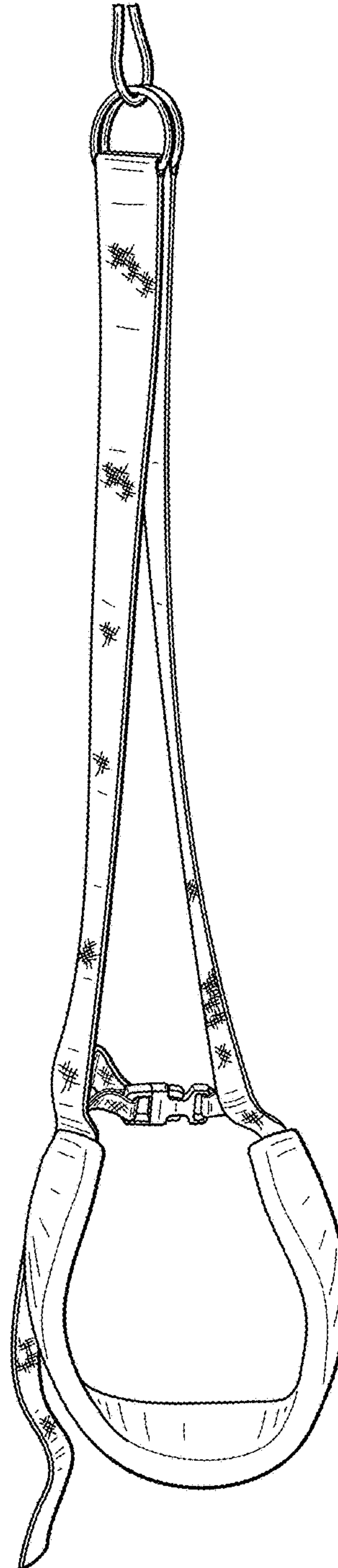

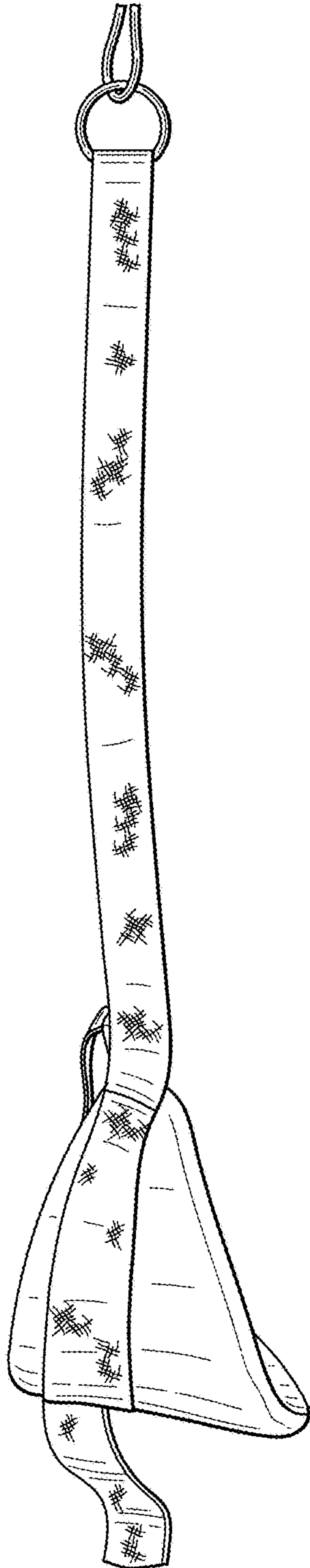

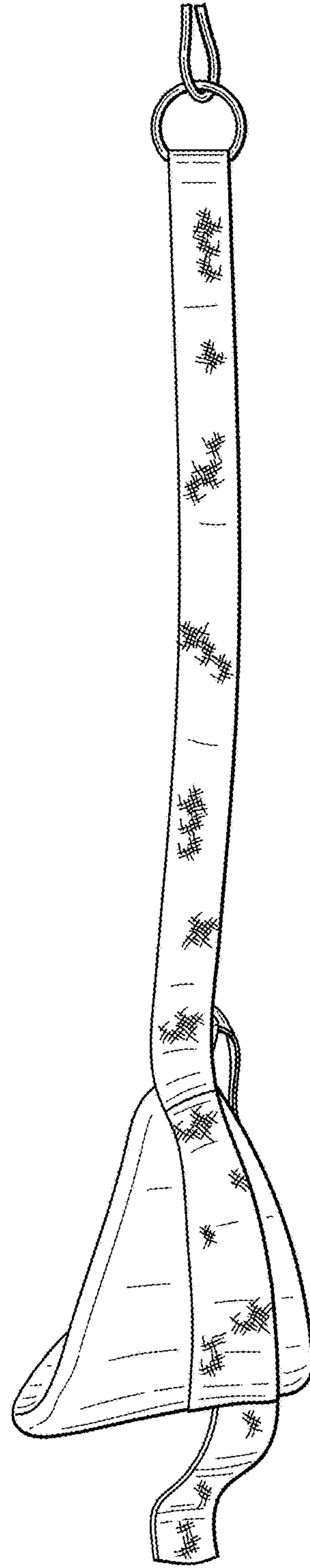

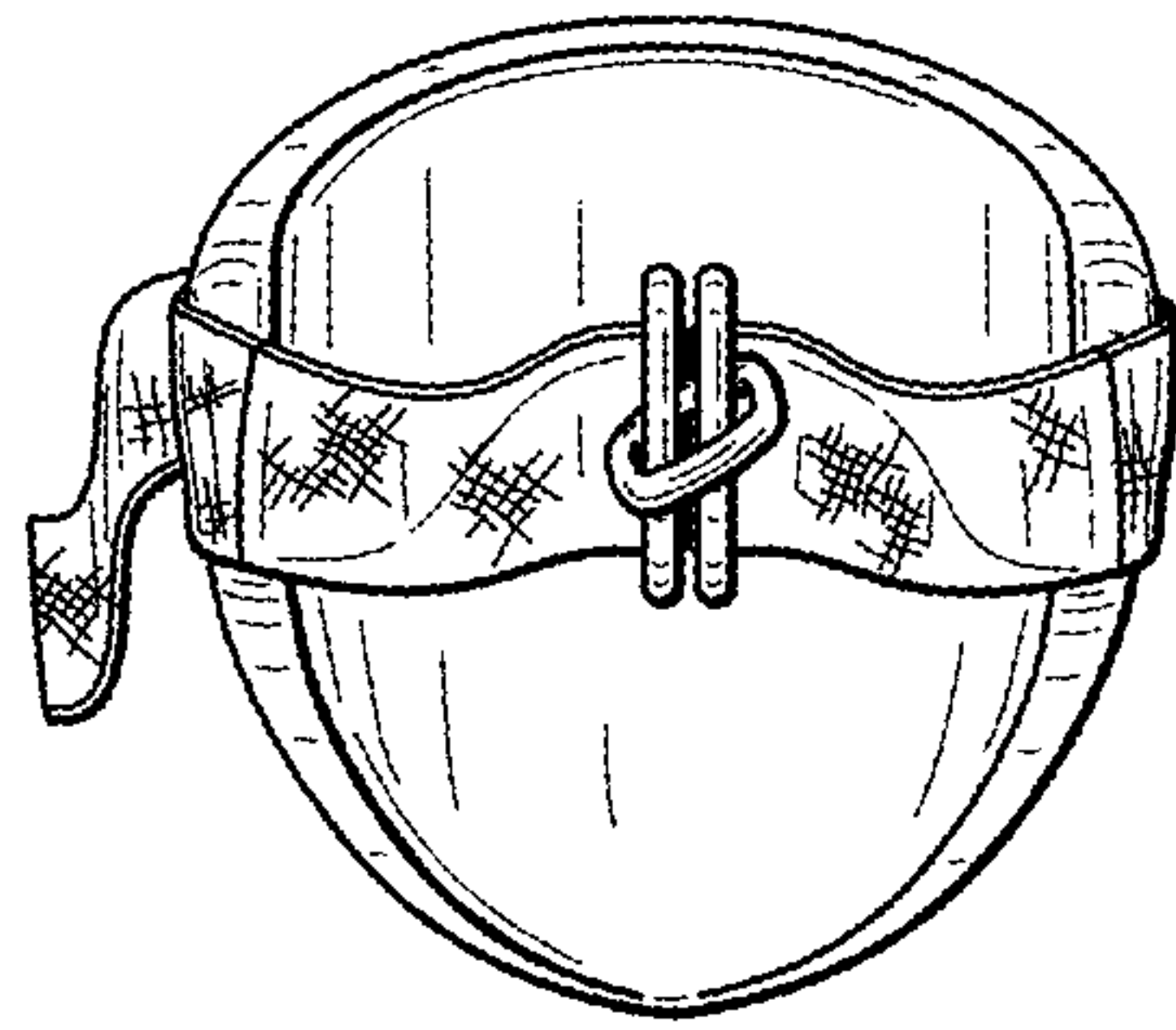
