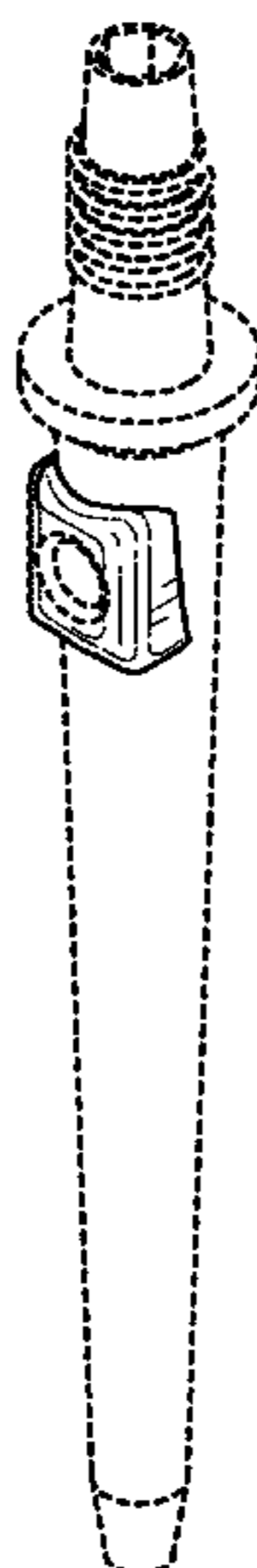
DESCRIPTION

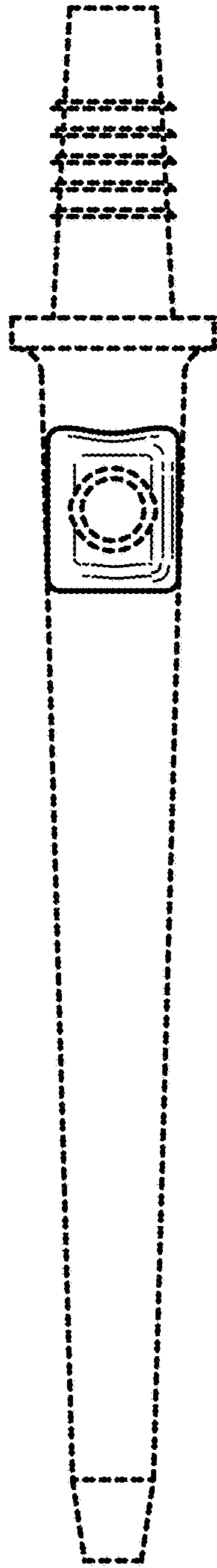

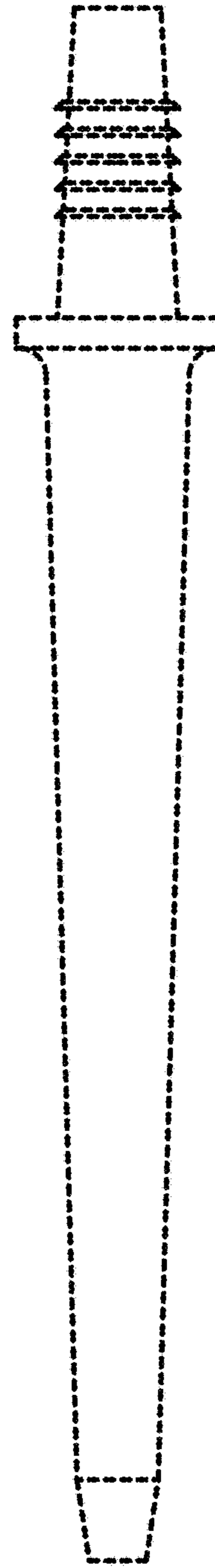

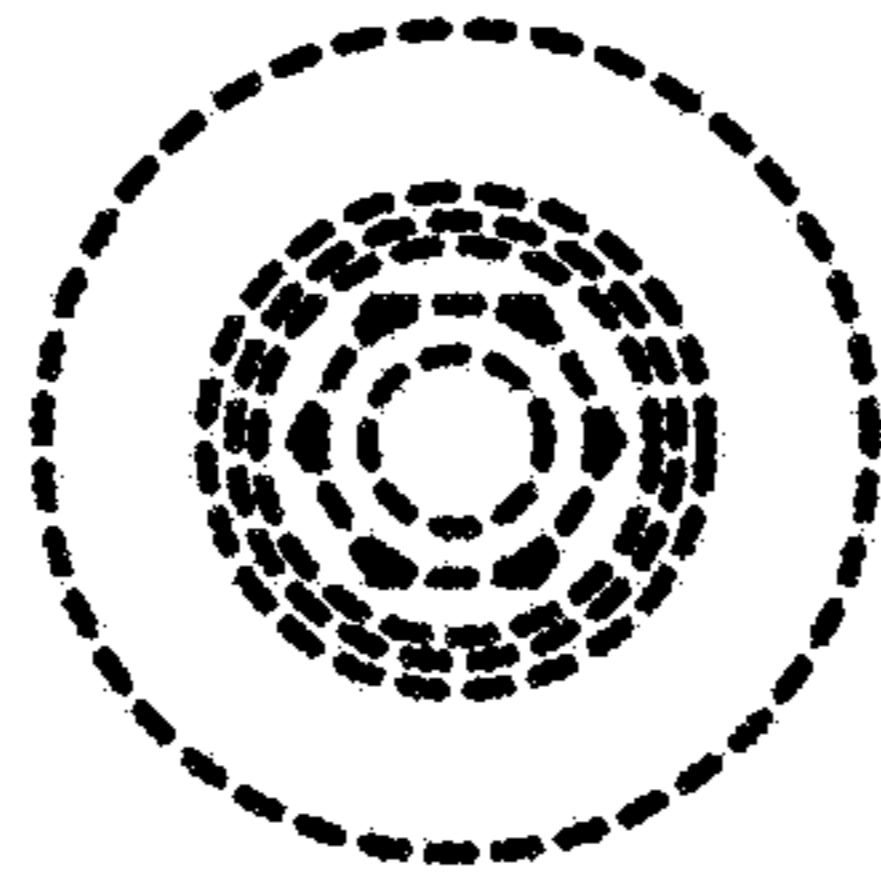

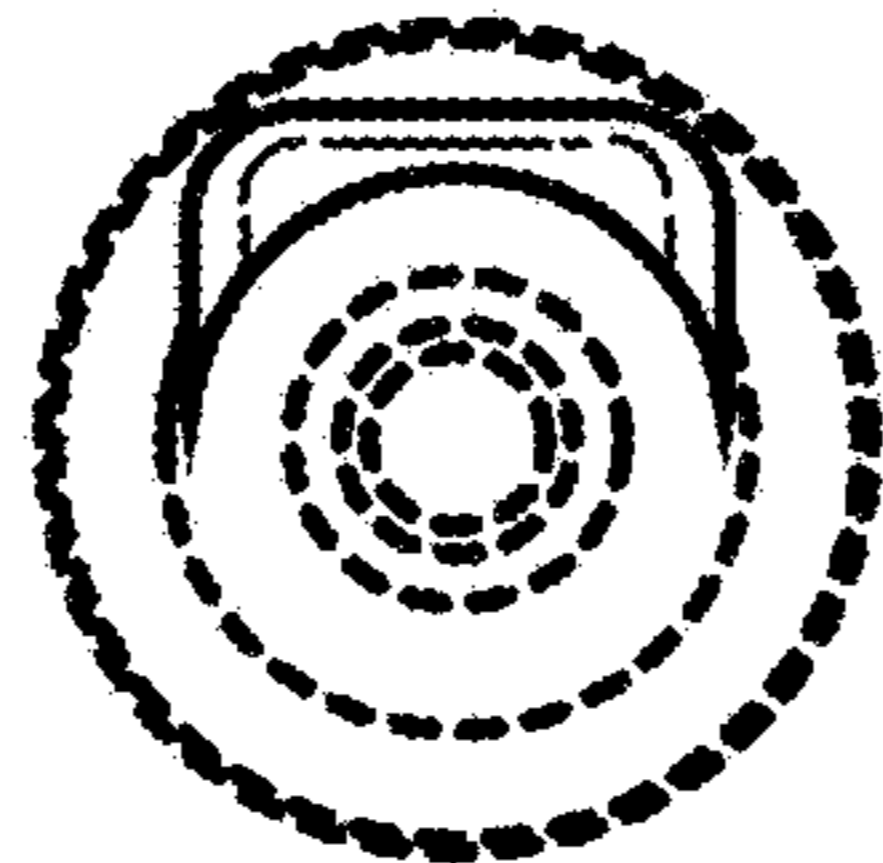

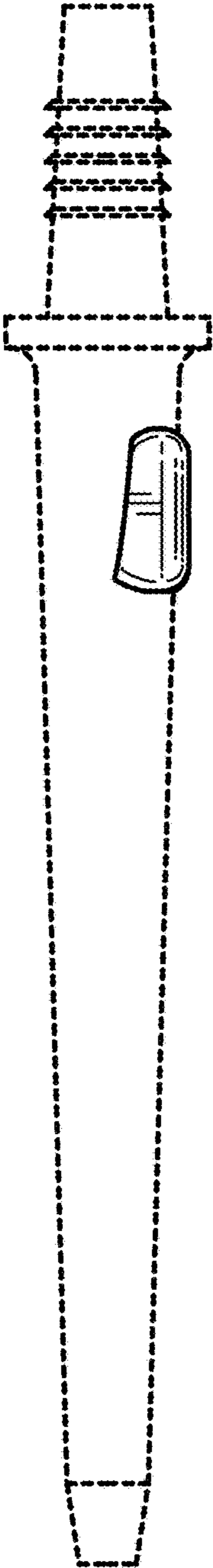

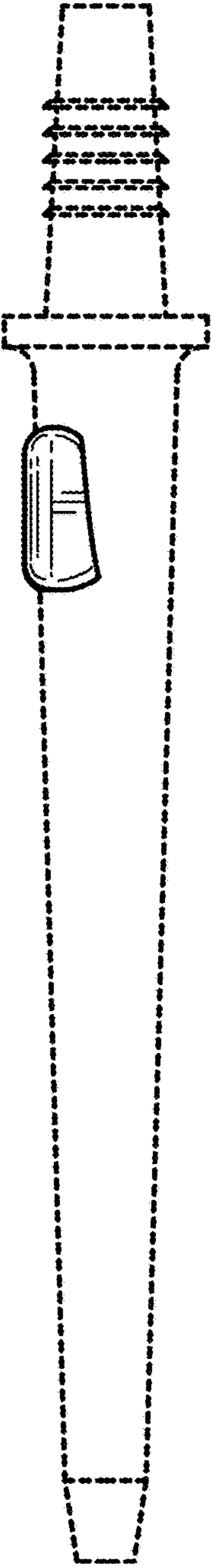

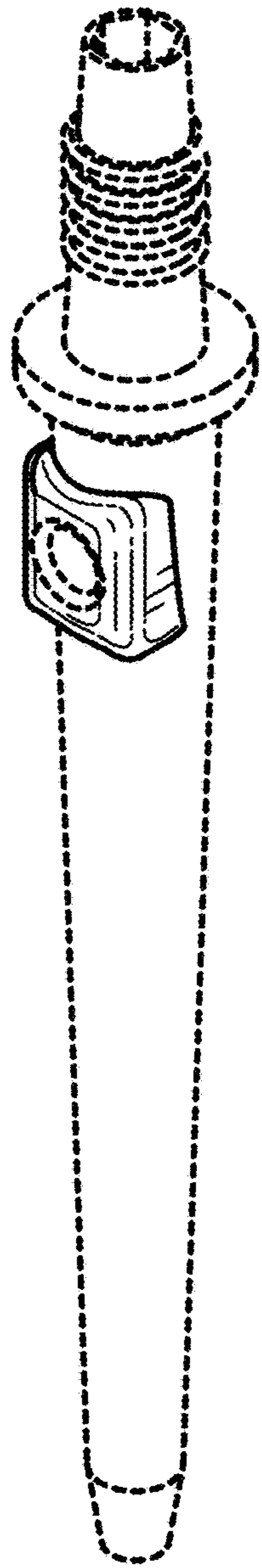

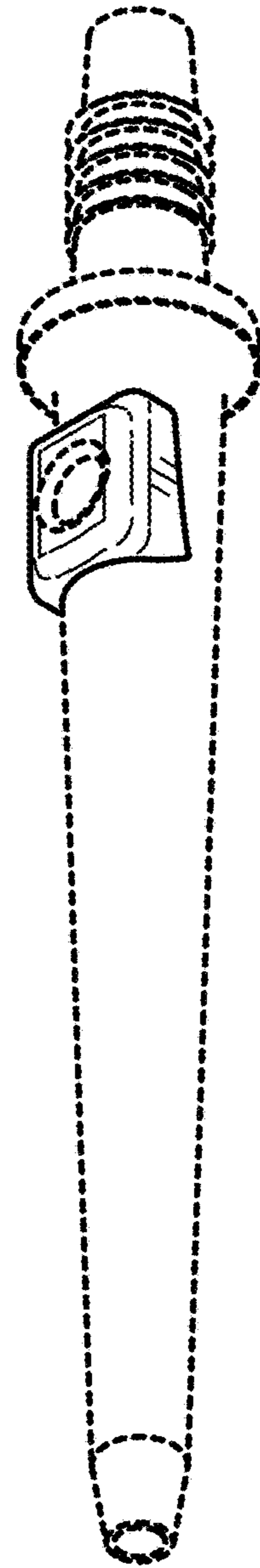
