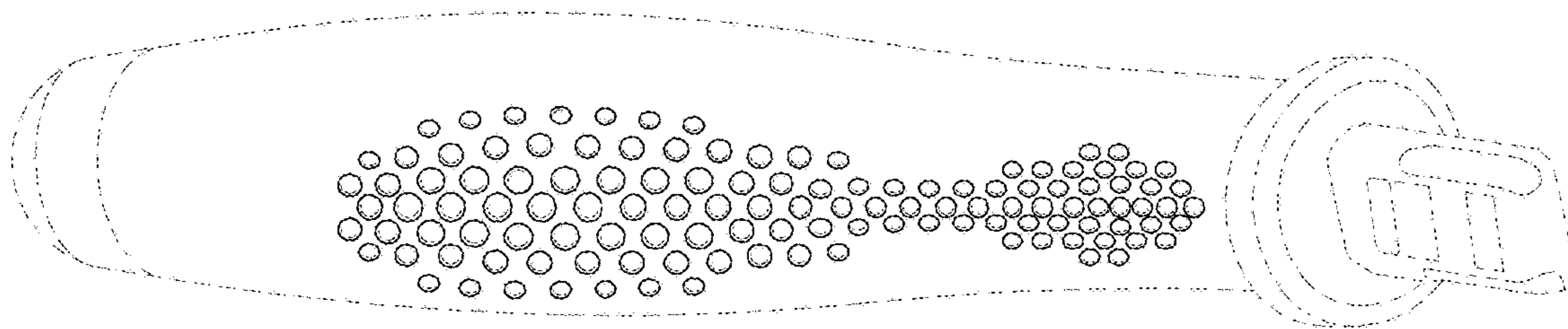

I claim the ornamental design for a razor handle, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of the razor handle of the present invention.
 FIG. 2 is a top perspective view of the razor handle of the present invention.
 FIG. 3 is a top plan view of the razor handle of the present invention.
 FIG. 4 is a bottom plan view of the razor handle of the present invention.
 FIG. 5 is a right side elevation view of the razor handle of the present invention.
 FIG. 6 is a left side elevation view of the razor handle of the present invention.
 FIG. 7 is a front elevation view of the razor handle of the present invention; and,
 FIG. 8 is a rear elevation view of the razor handle of the present invention.

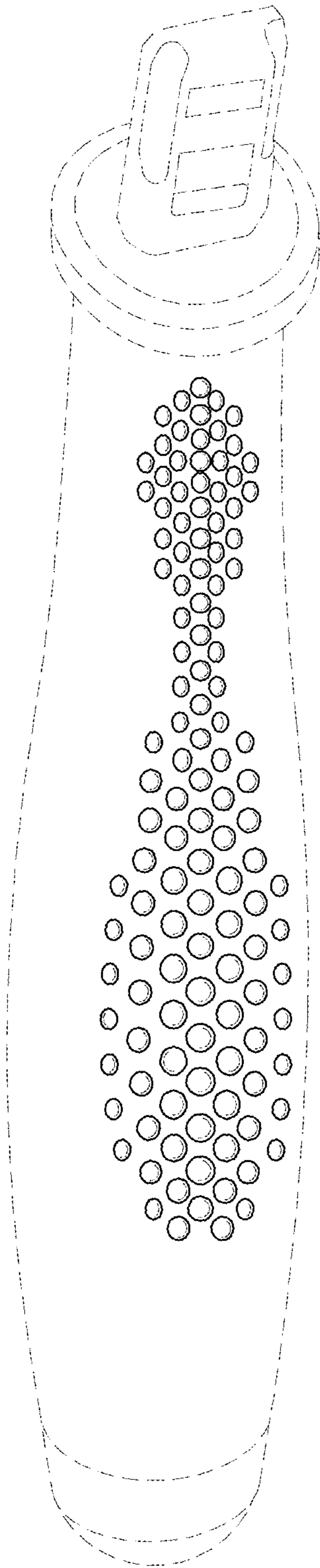

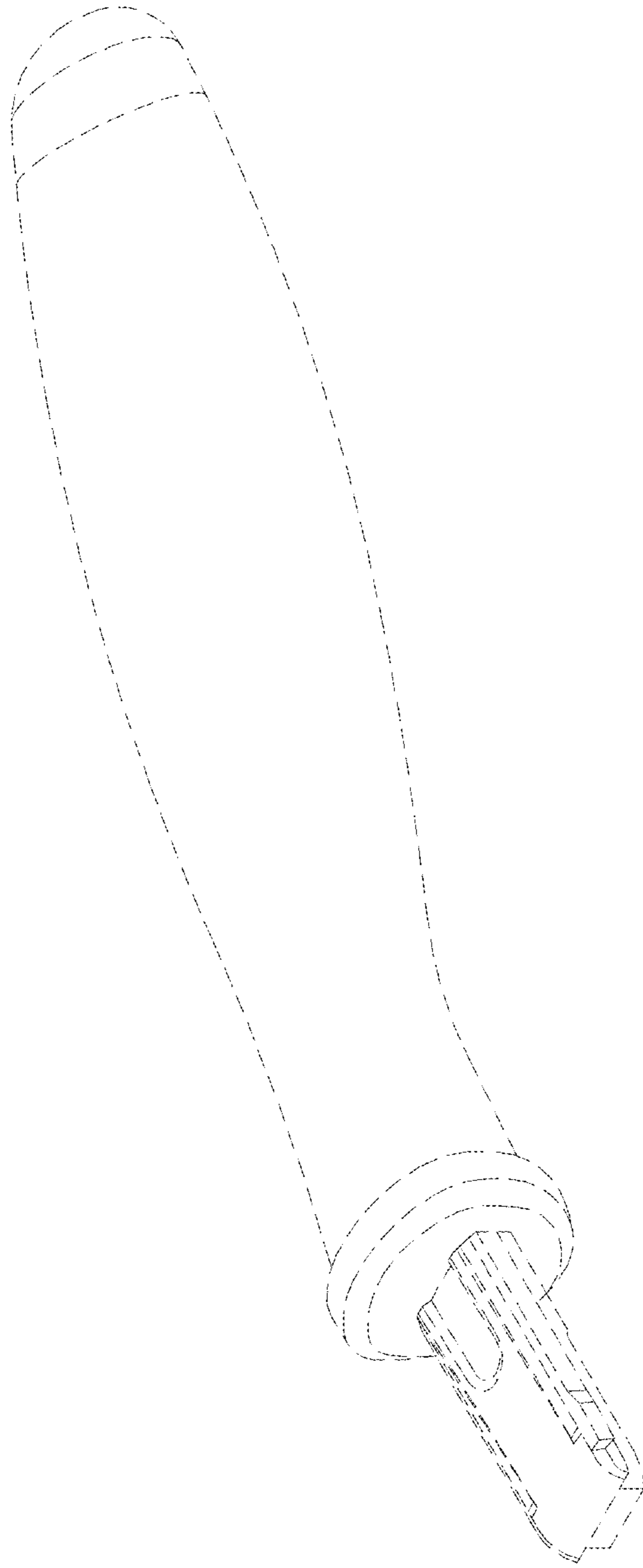

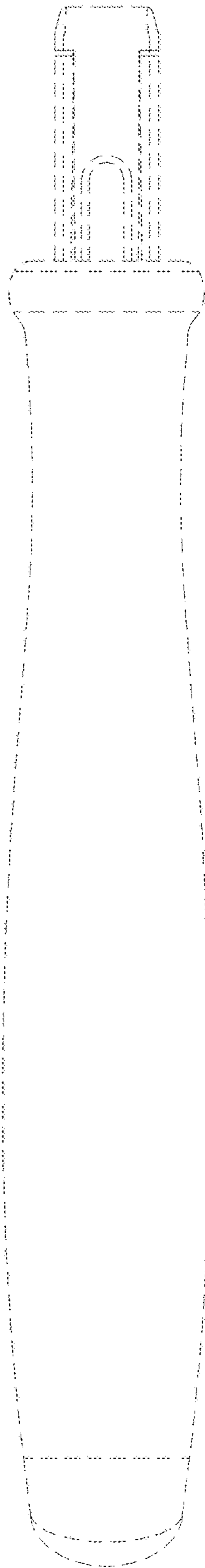

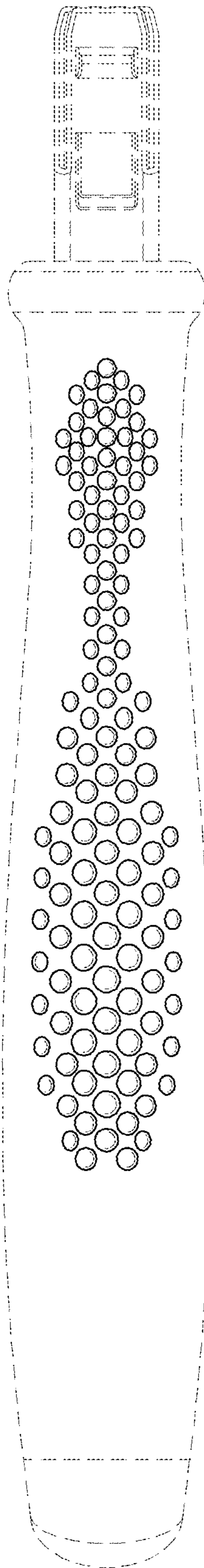

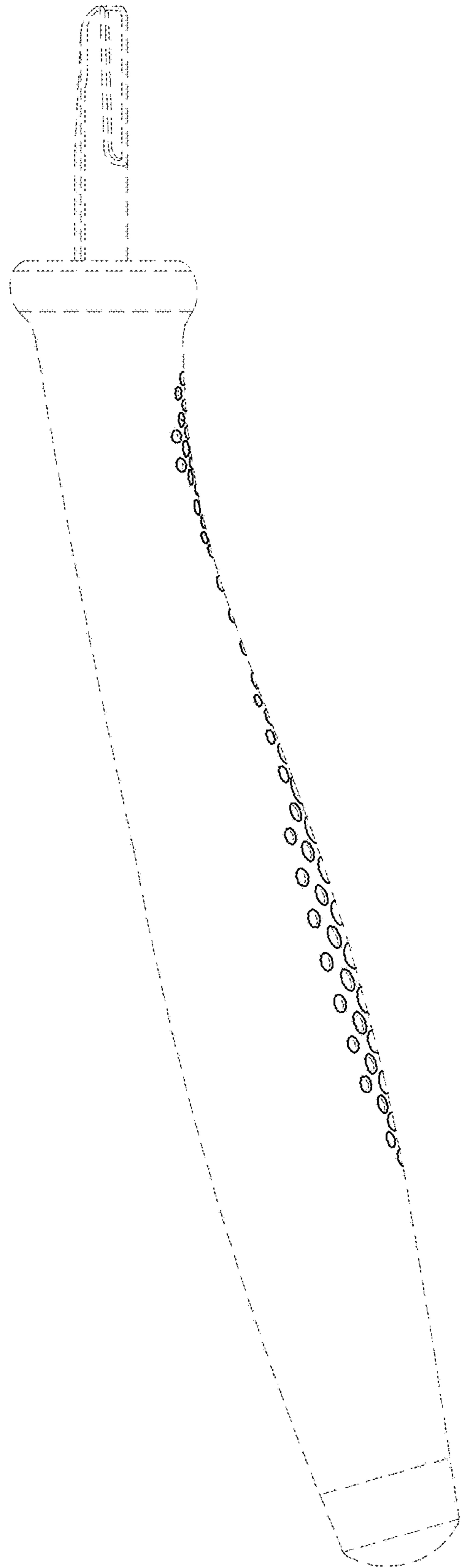

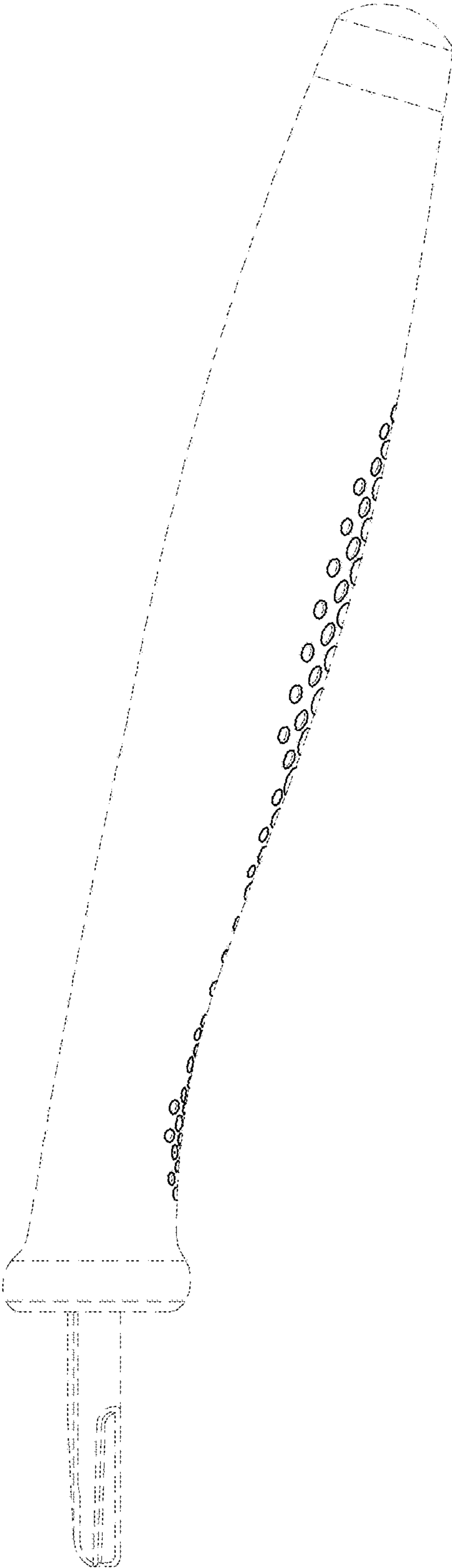

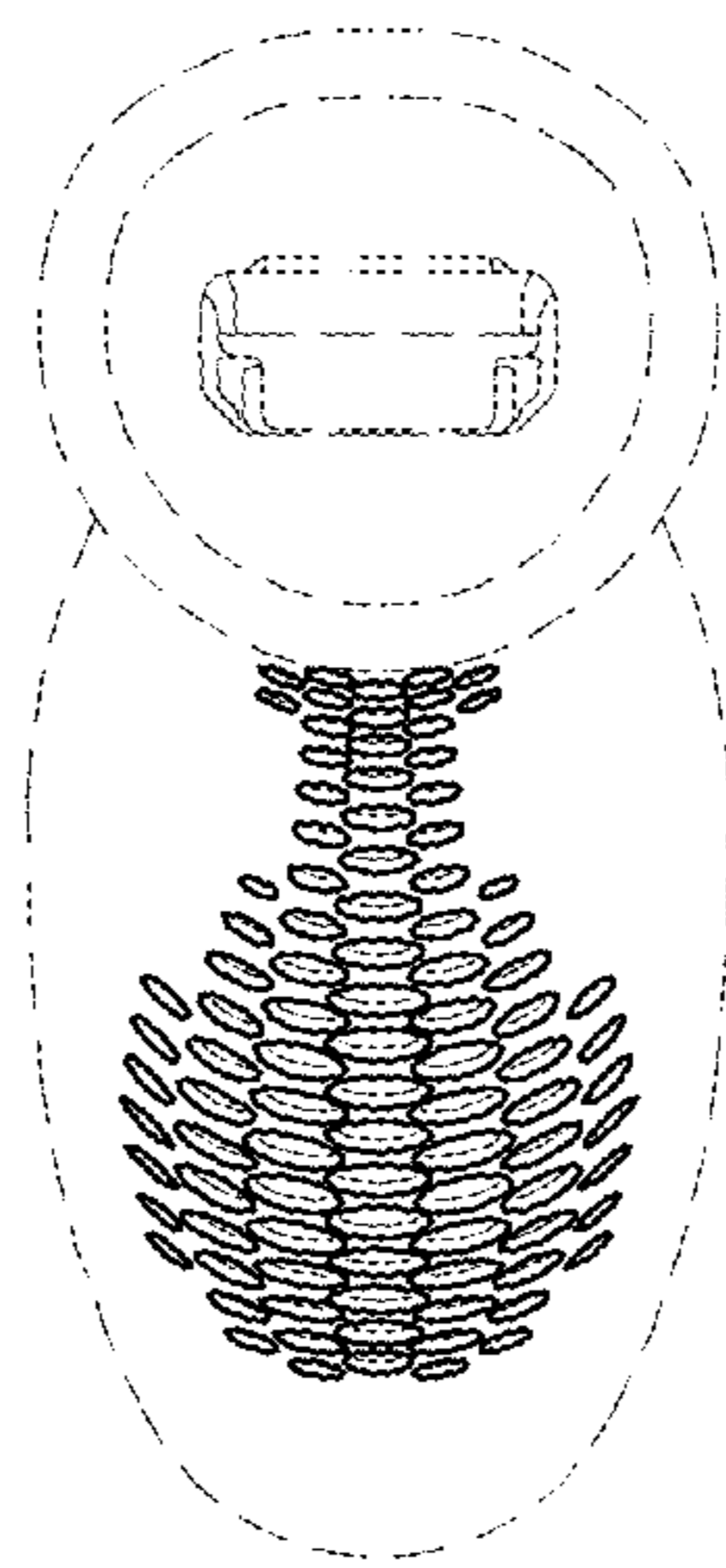

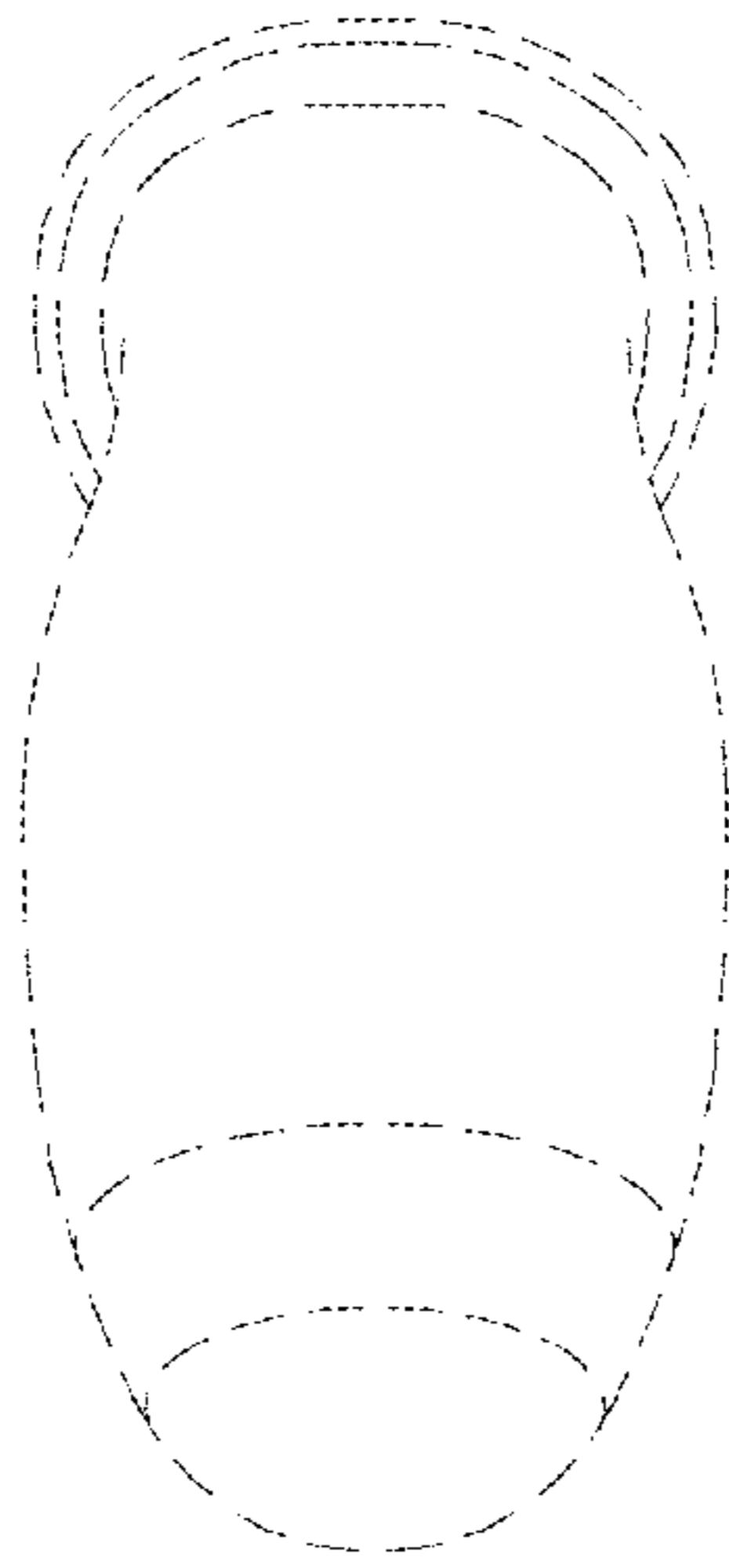
