The ornamental design for a simulative baseball stadium novelty hat, as shown and described.

DESCRIPTION

FIG. 1 is a top isometric view of a simulative baseball stadium novelty hat;

FIG. 2 is a bottom isometric view of the simulative baseball stadium novelty hat of FIG. 1;

FIG. 3 is a top plan view of the simulative baseball stadium novelty hat of FIG. 1;

FIG. 4 is a bottom plan view of the simulative baseball stadium novelty hat of FIG. 1;

FIG. 5 is a first side elevation view of the simulative baseball stadium novelty hat of FIG. 1;


FIG. 6 is a second side elevation view of the simulative baseball stadium novelty hat of FIG. 1;


















