(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a shoe showing our new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a side view thereof;  
FIG. 5 is another side view thereof;  
FIG. 6 is a front view thereof; and,  
FIG. 7 is a rear view thereof.

The broken lines in the figures show portions of the shoe that form no part of the claimed design.

The broken lines in the heel portion of the shoe depicted in the figures are intended to disclaim a contour line of the shoe. The surface area and checked pattern within and around the broken lines form part of the claimed design.

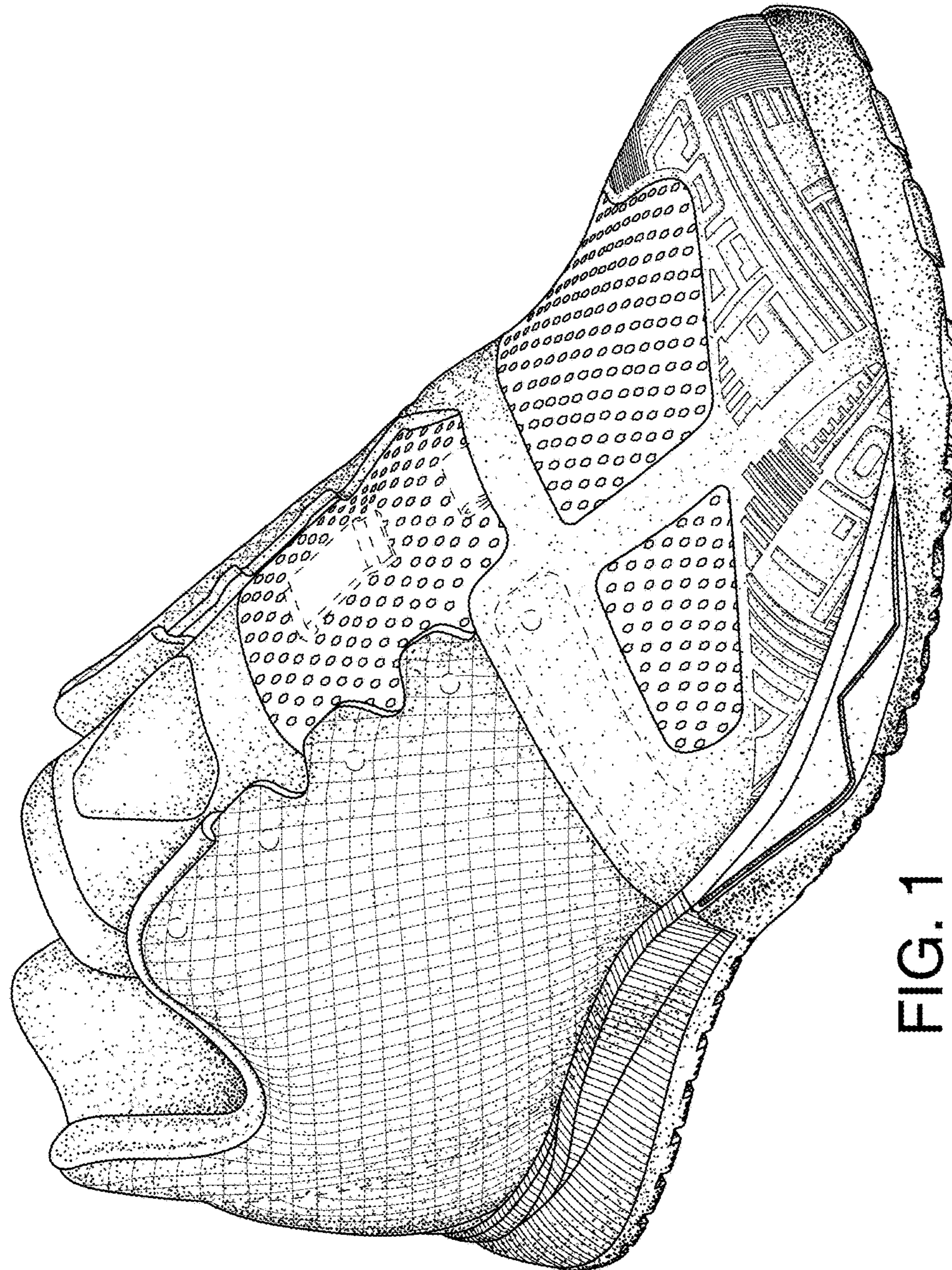

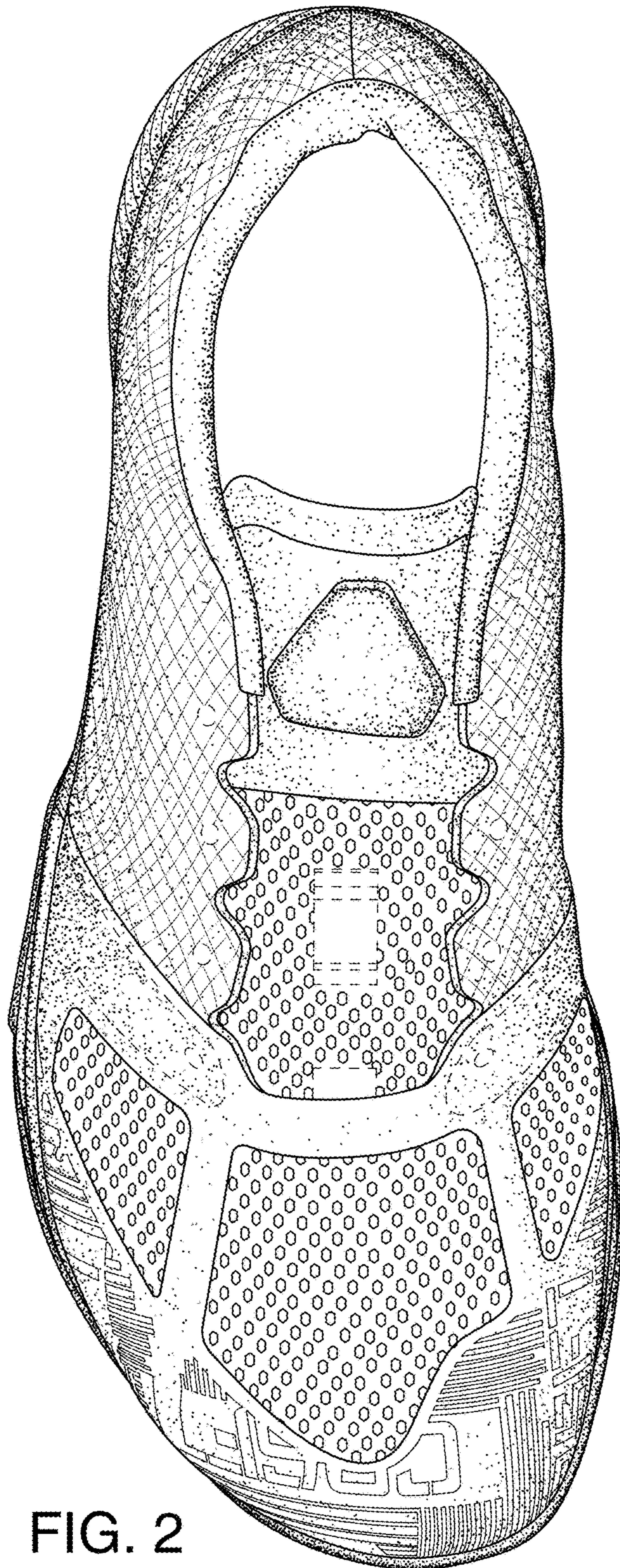

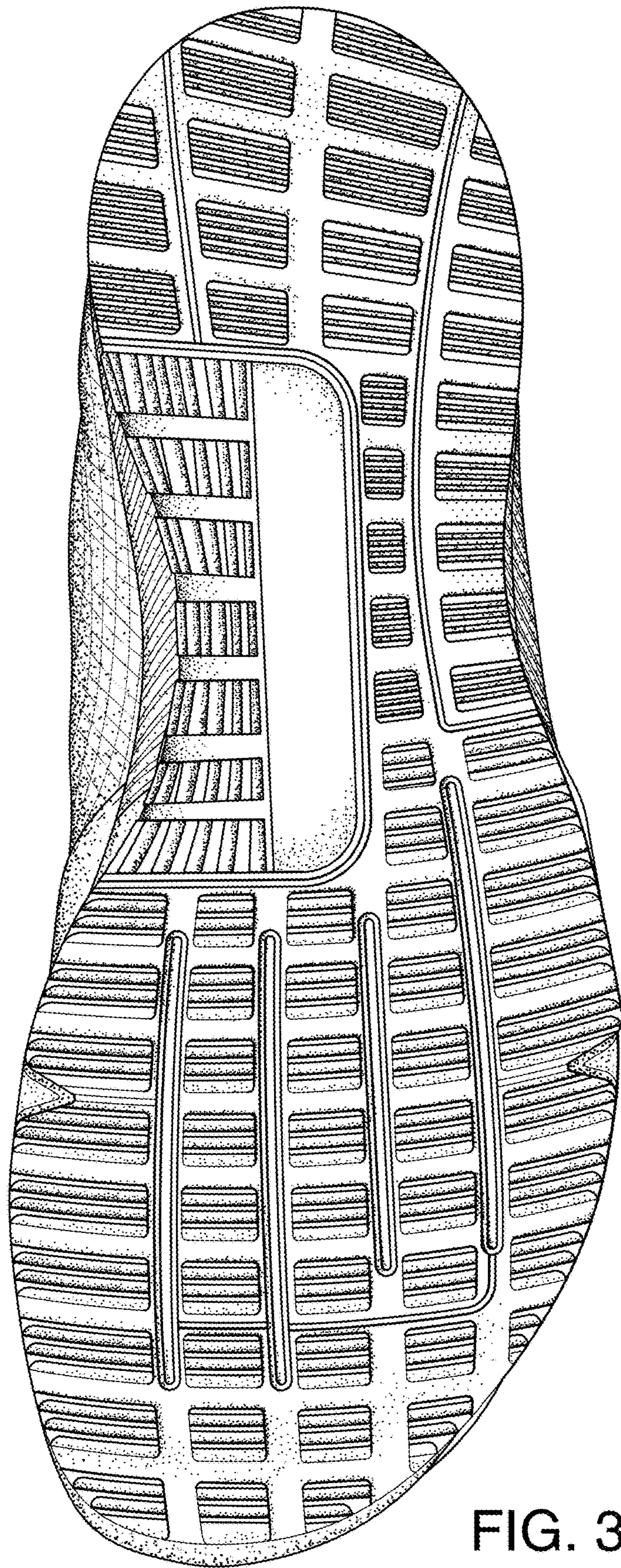

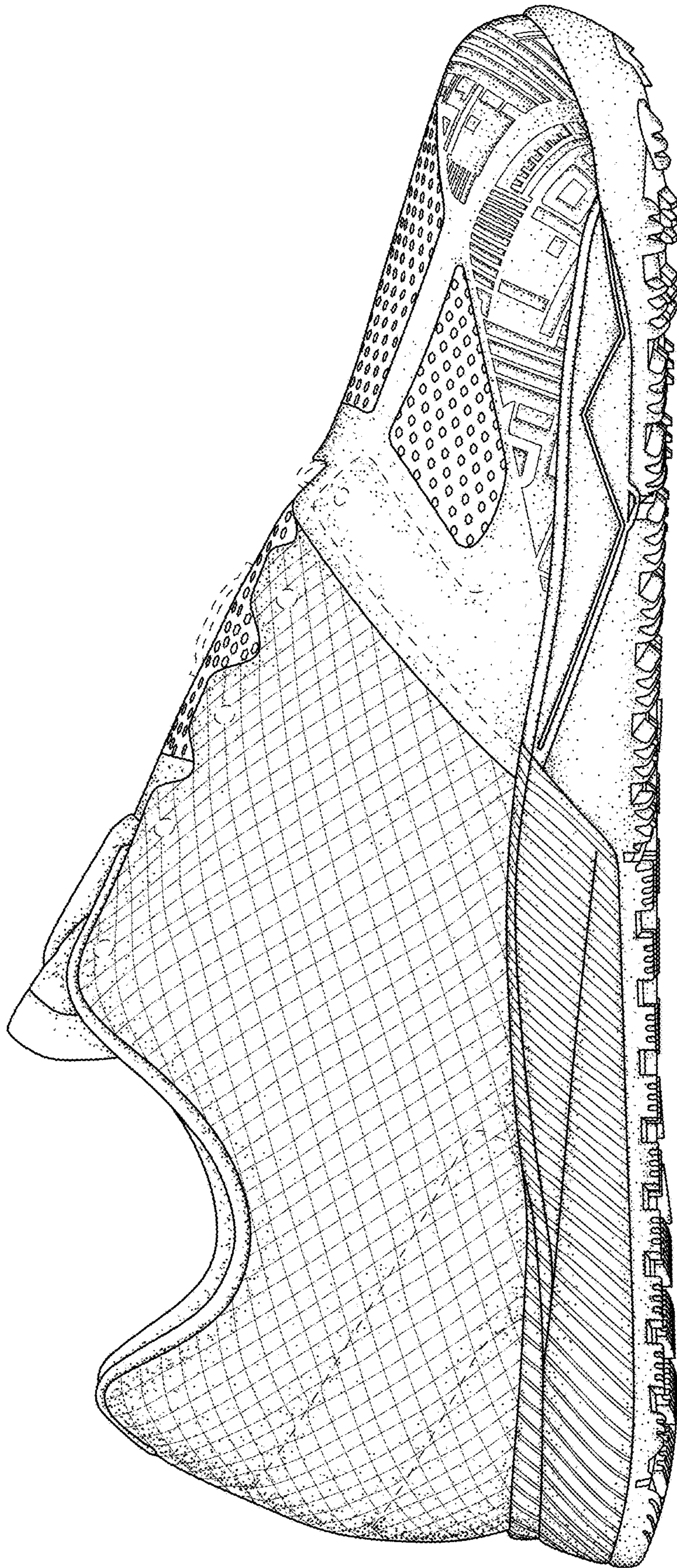

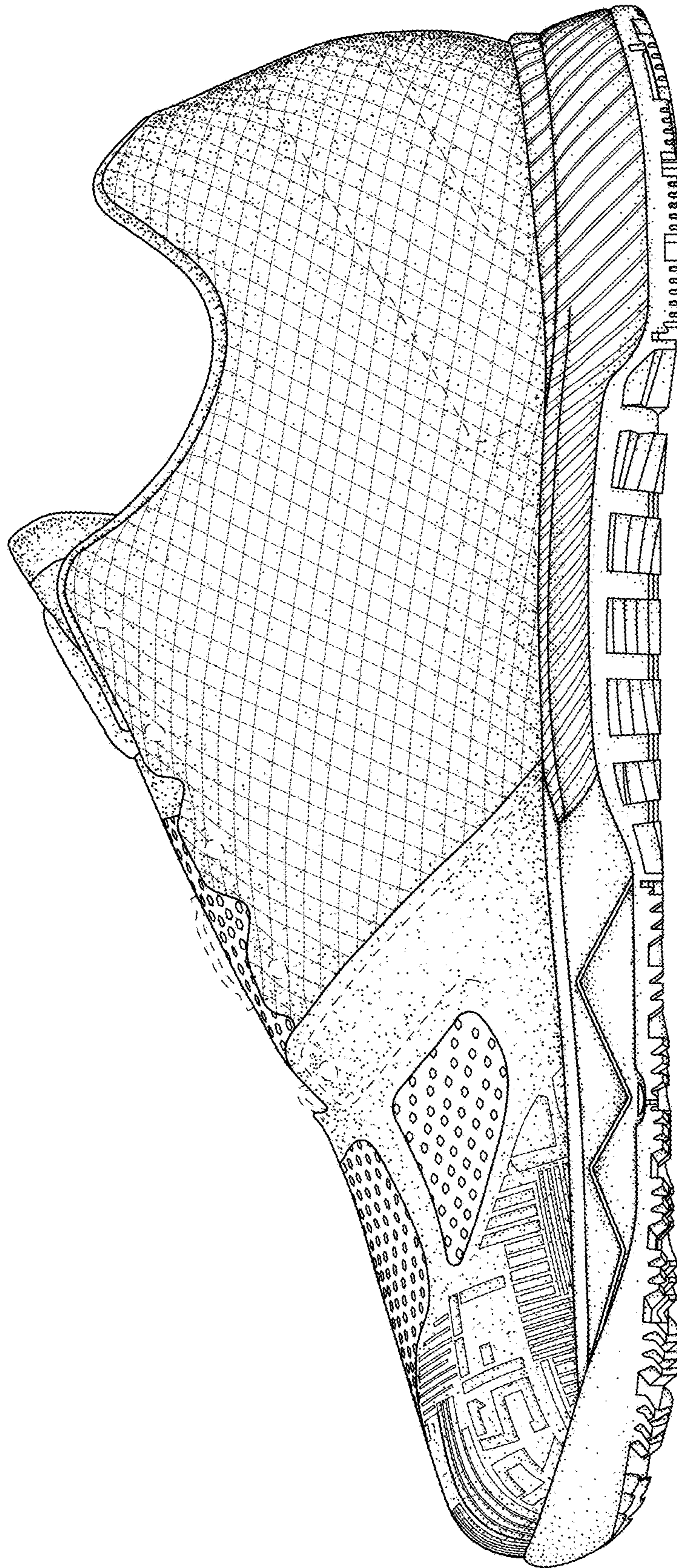

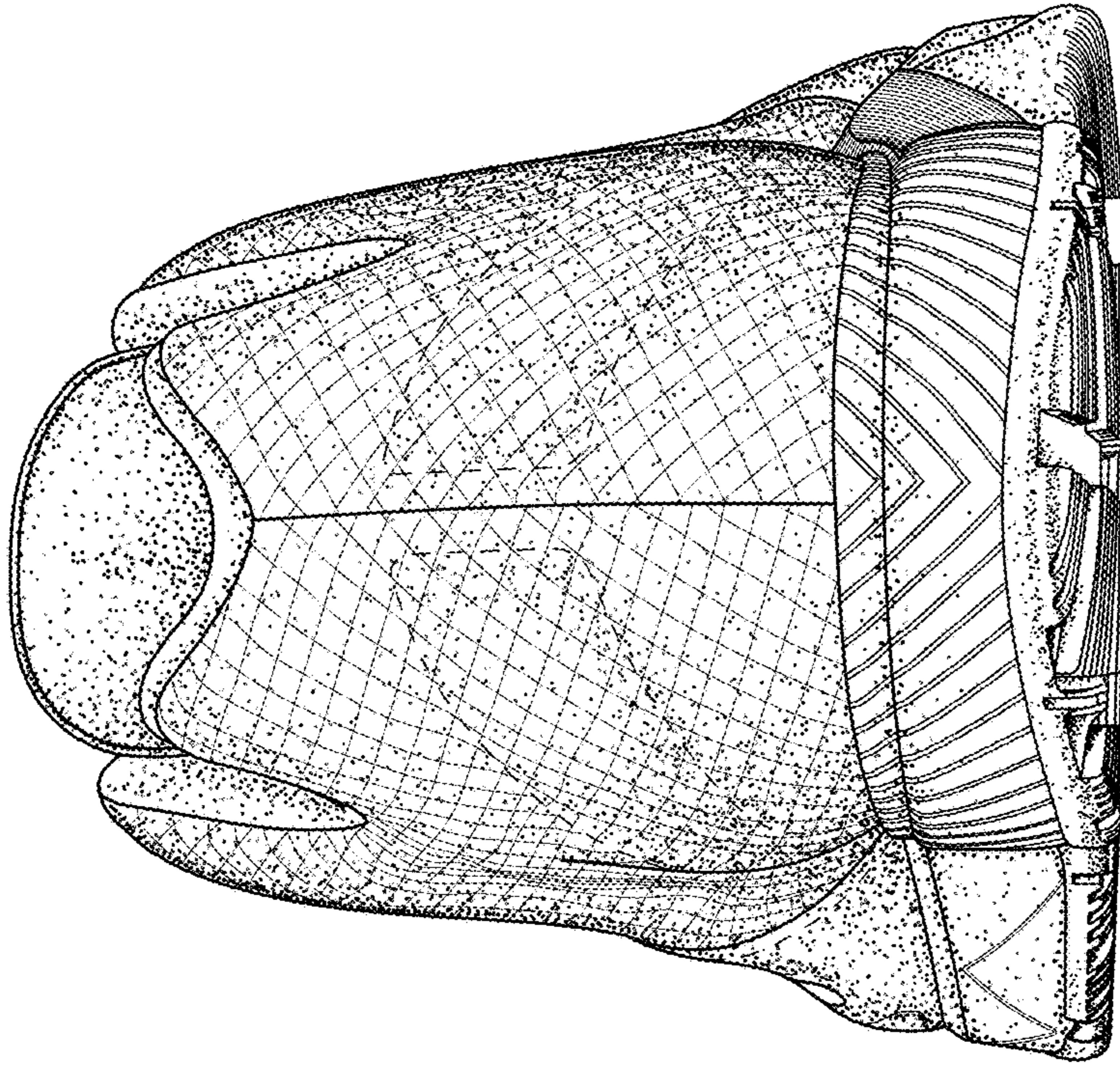

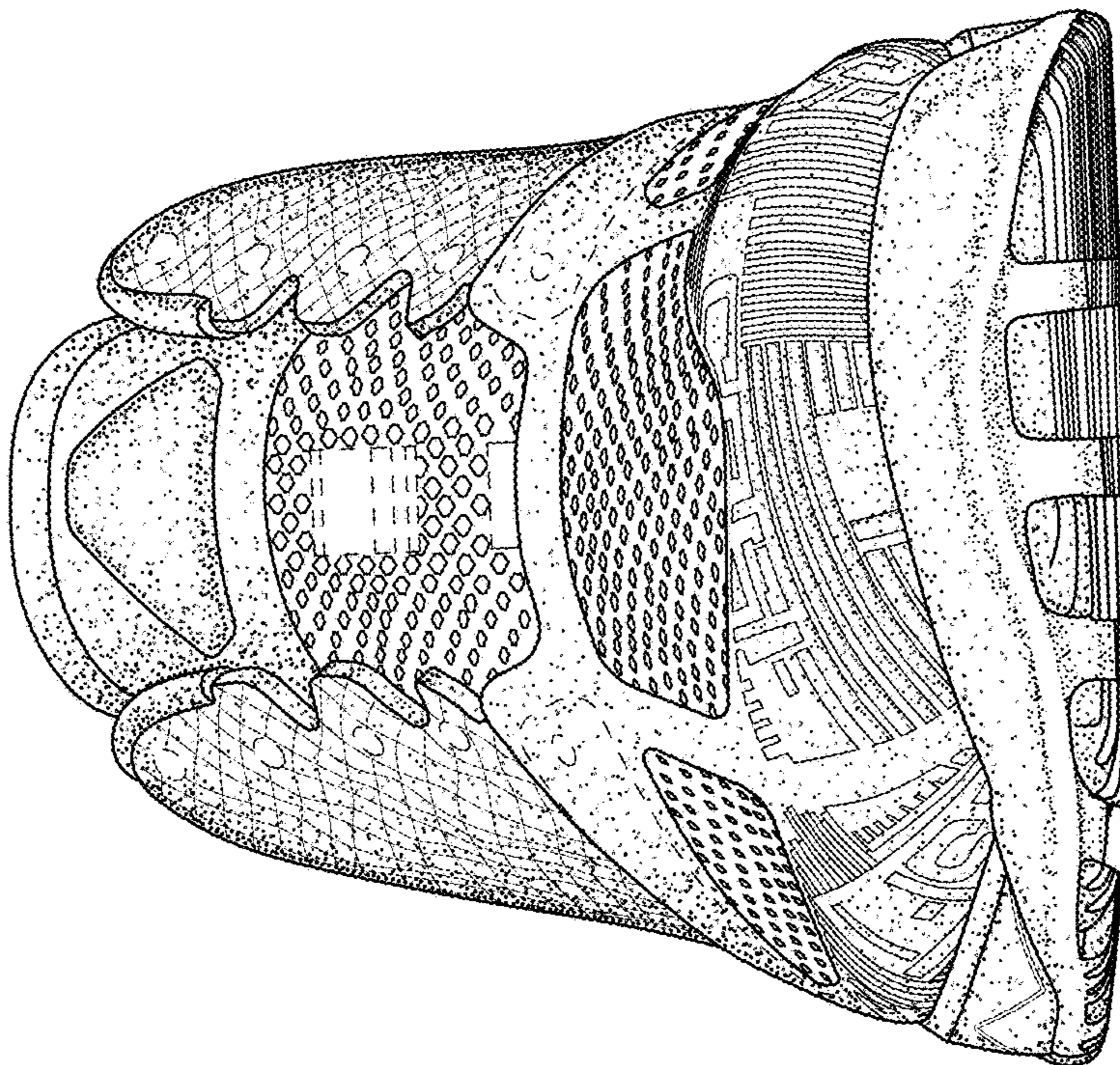
