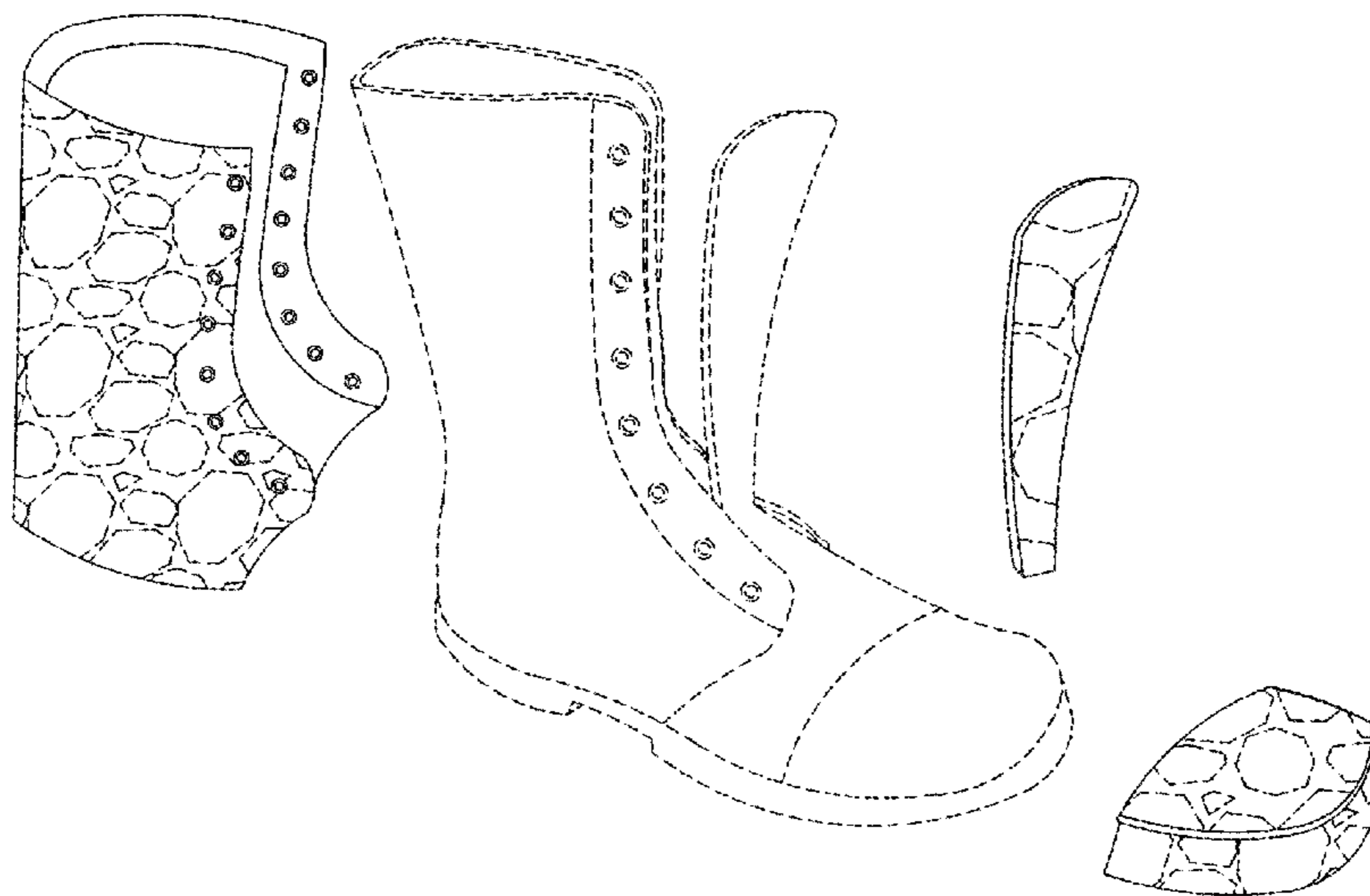
(57) **CLAIM**

The ornamental design for a removable boot cover, as shown and described.

DESCRIPTION

FIG. 1 is an exploded perspective view of a removable boot cover, with a boot shown in broken lines, showing my new design;
 FIG. 2 is a front view of the removable boot cover's heel portion, shown separately for ease of illustration;
 FIG. 3 is a back view of FIG. 2;
 FIG. 4 is a front view of the removable boot cover's tongue portion, shown separately for ease of illustration;
 FIG. 5 is a back view of FIG. 4;
 FIG. 6 is a top view of the removable boot cover's toe portion, shown separately for ease of illustration;
 FIG. 7 is a front view of FIG. 6;
 FIG. 8 is a left side perspective view of FIG. 6;
 FIG. 9 is a right side perspective view of FIG. 6;
 FIG. 10 is a bottom view of FIG. 6; and,
 FIG. 11 is a back view of FIG. 6.
 The broken lines of a boot and geometric pattern shown in the drawings represent portions of the removable boot cover that form no part of the claimed design.

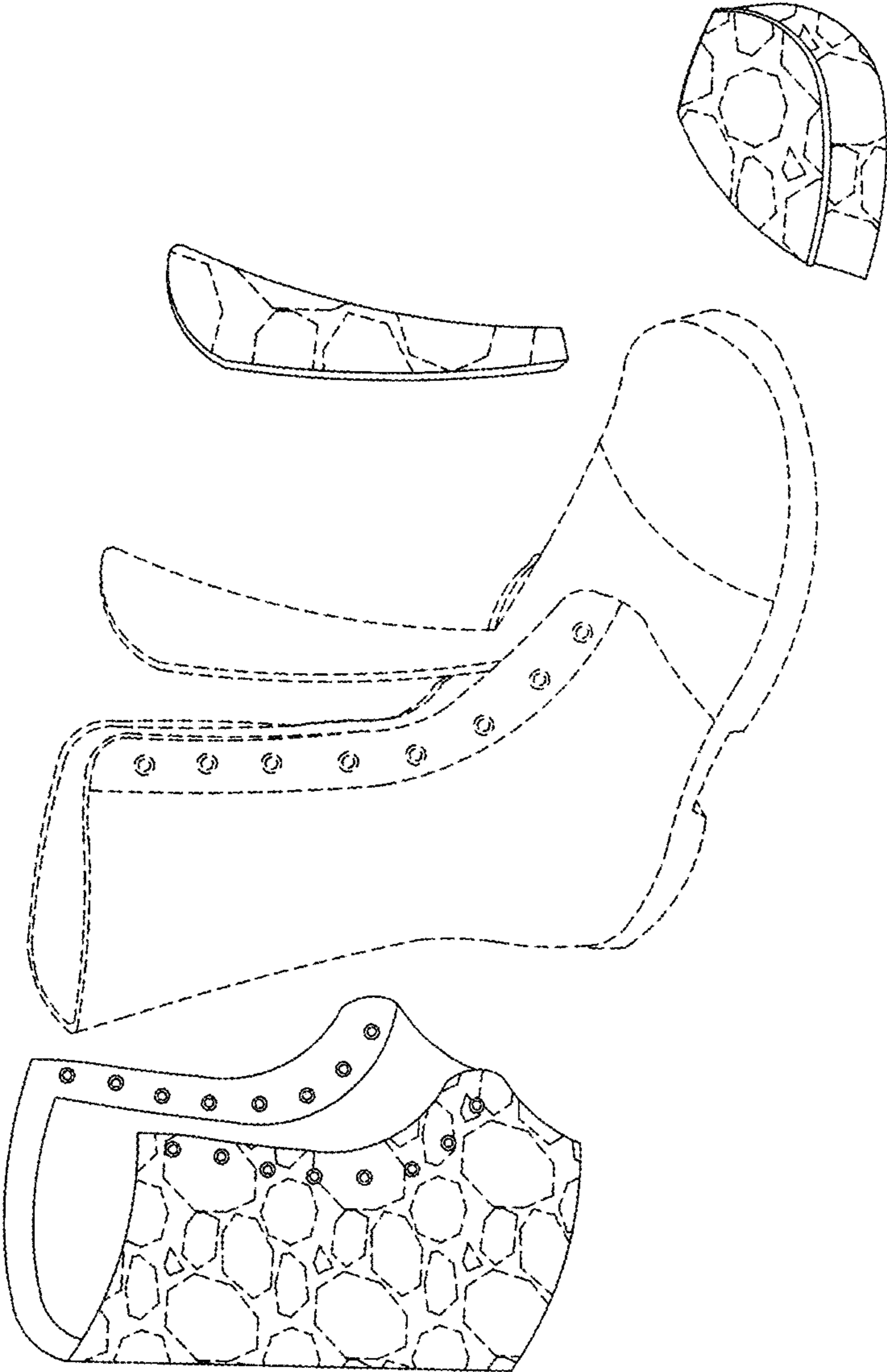

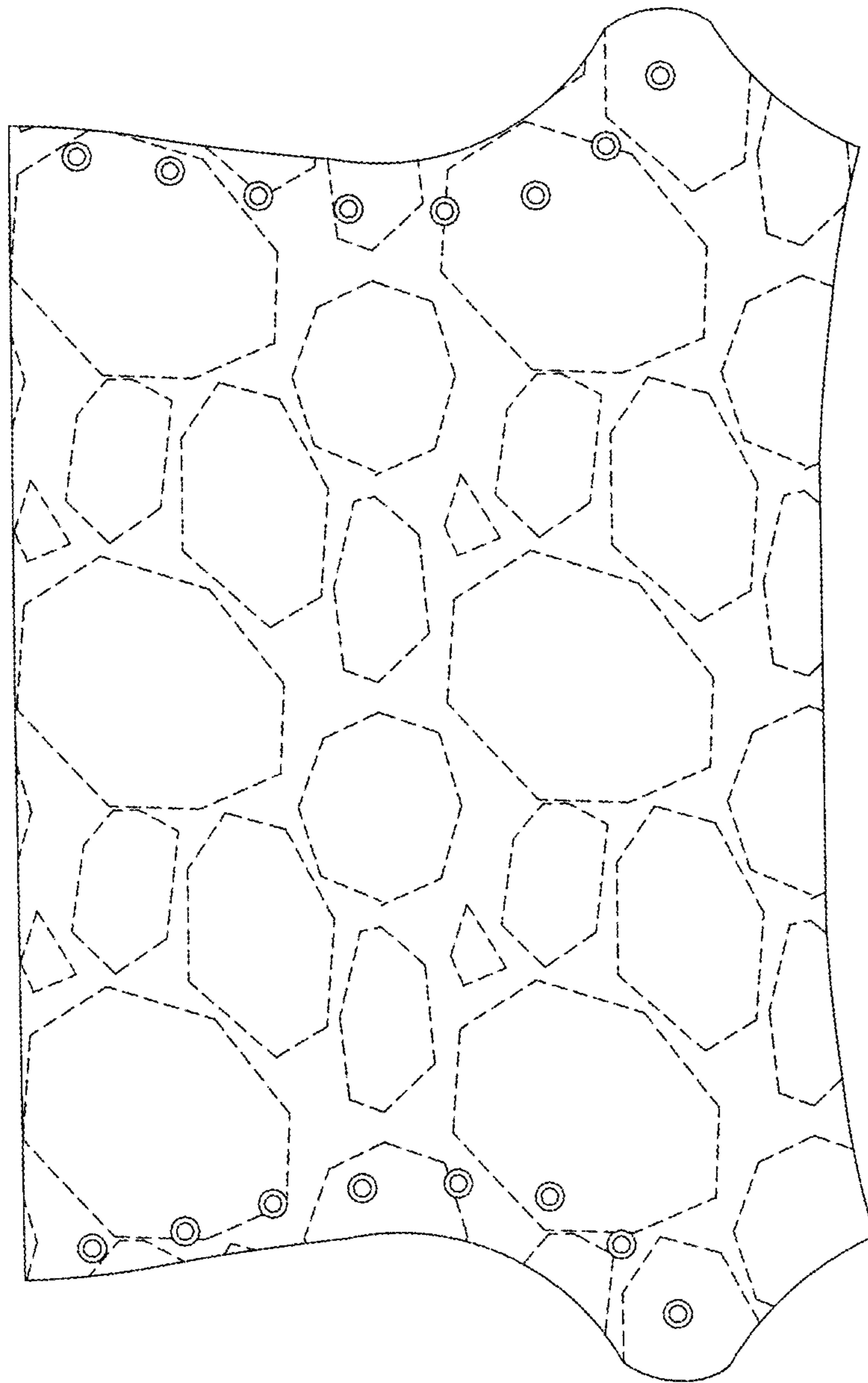

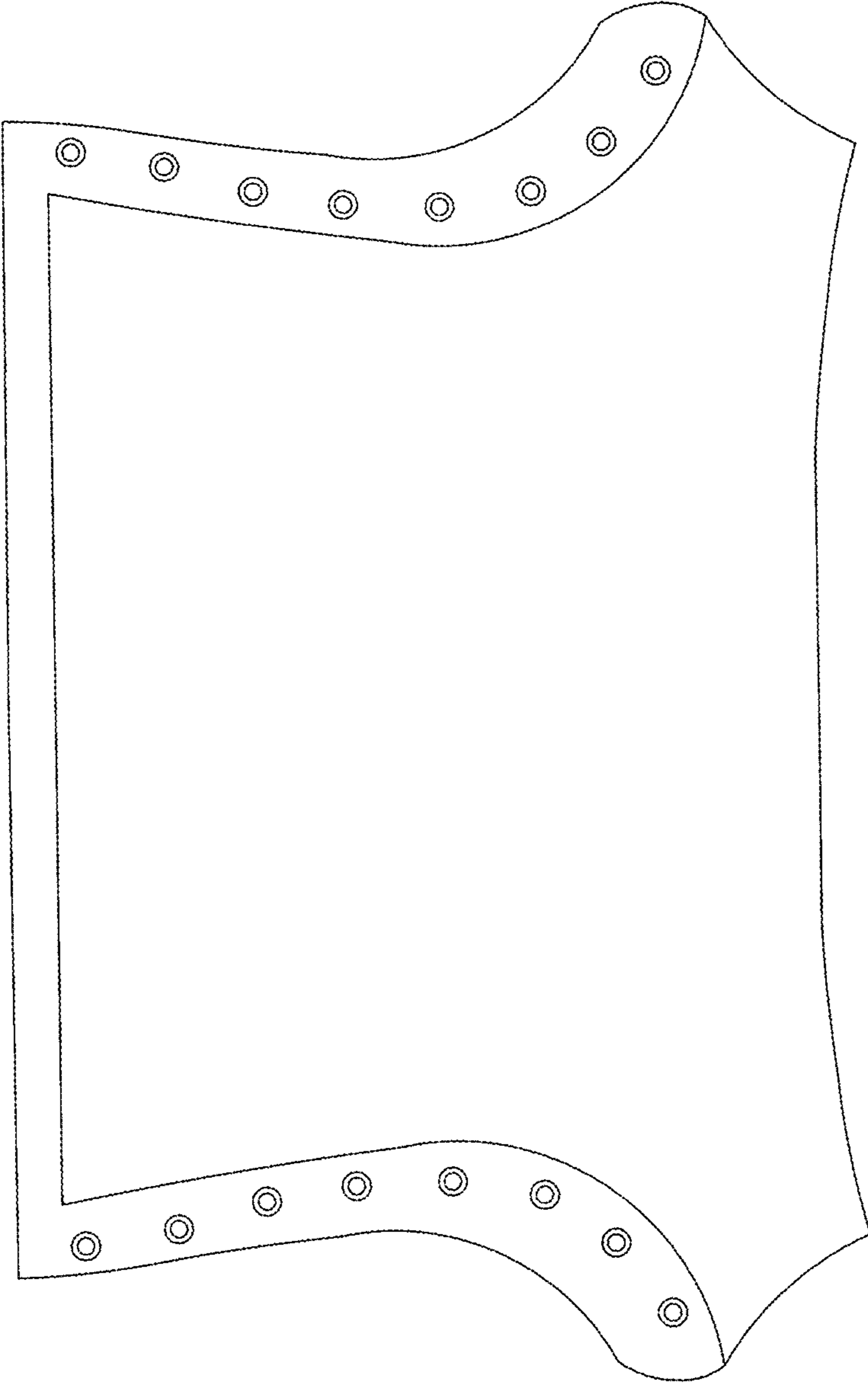

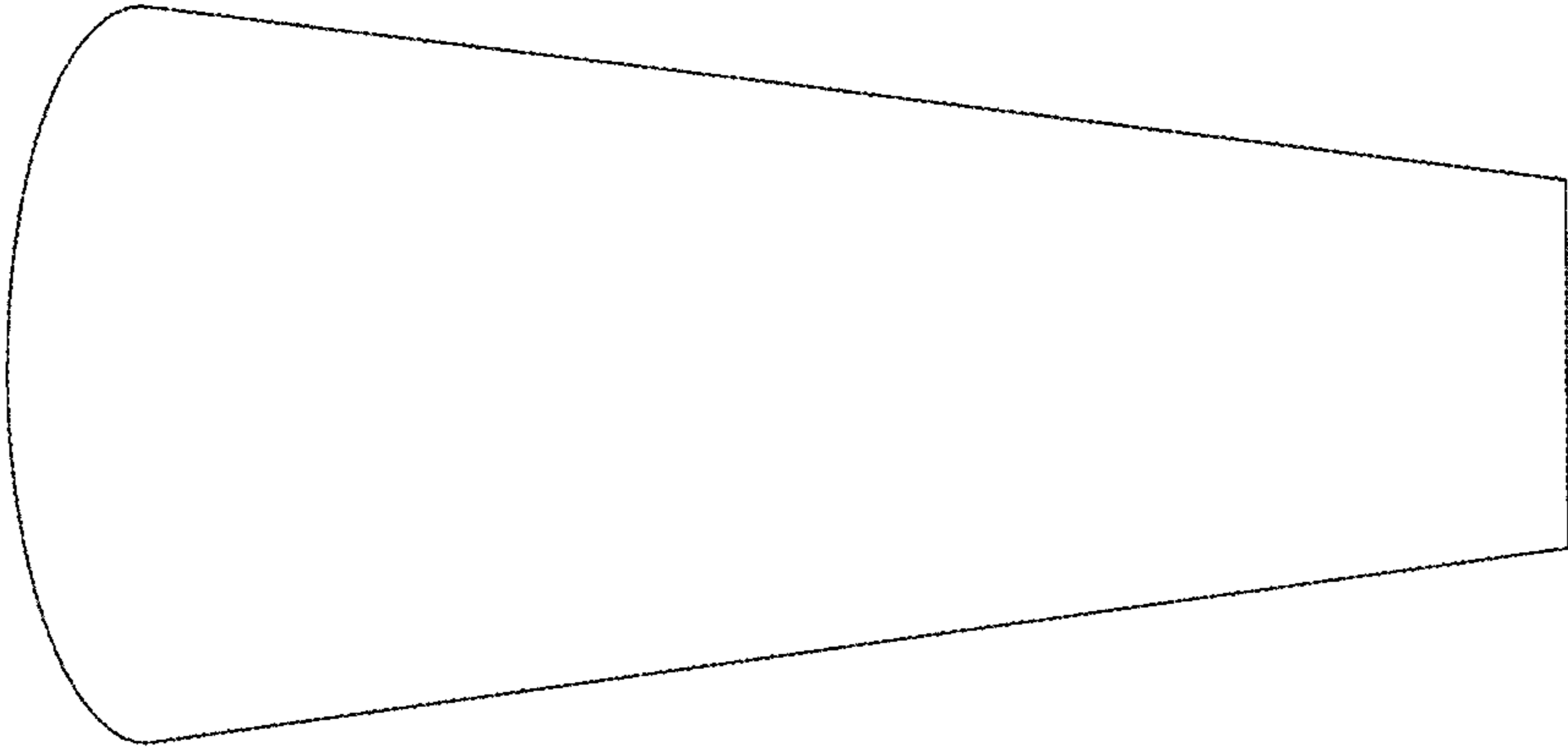

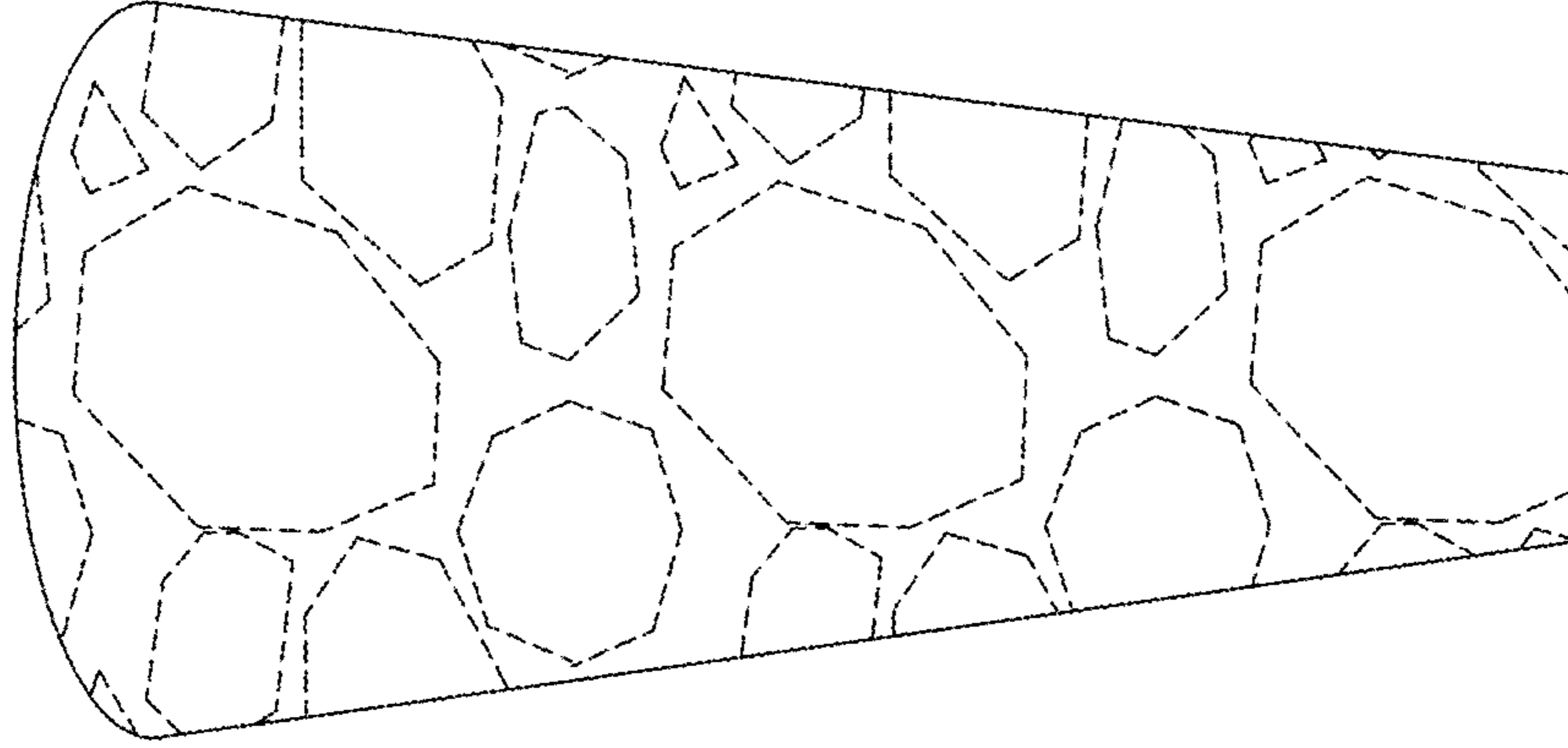

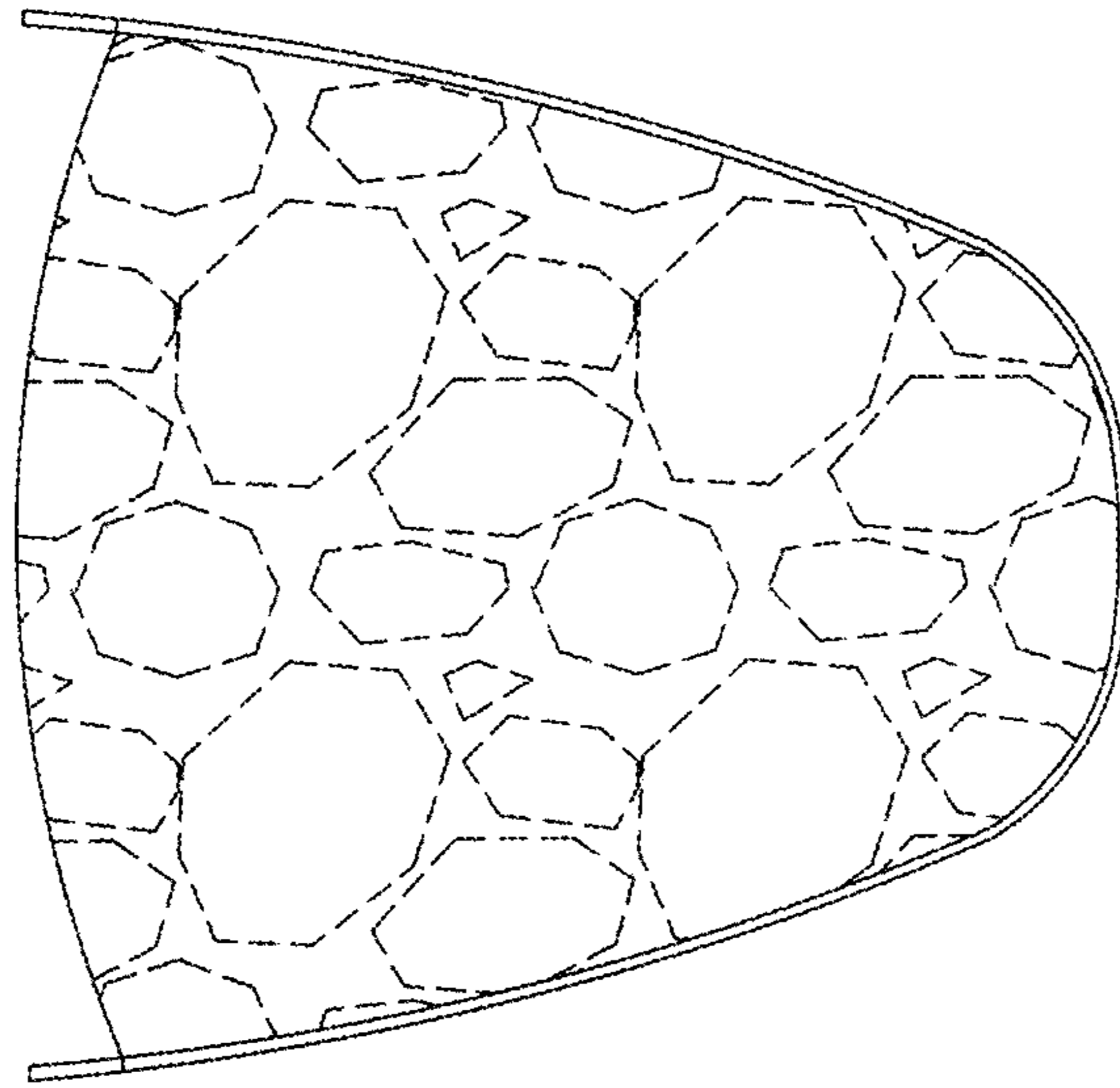

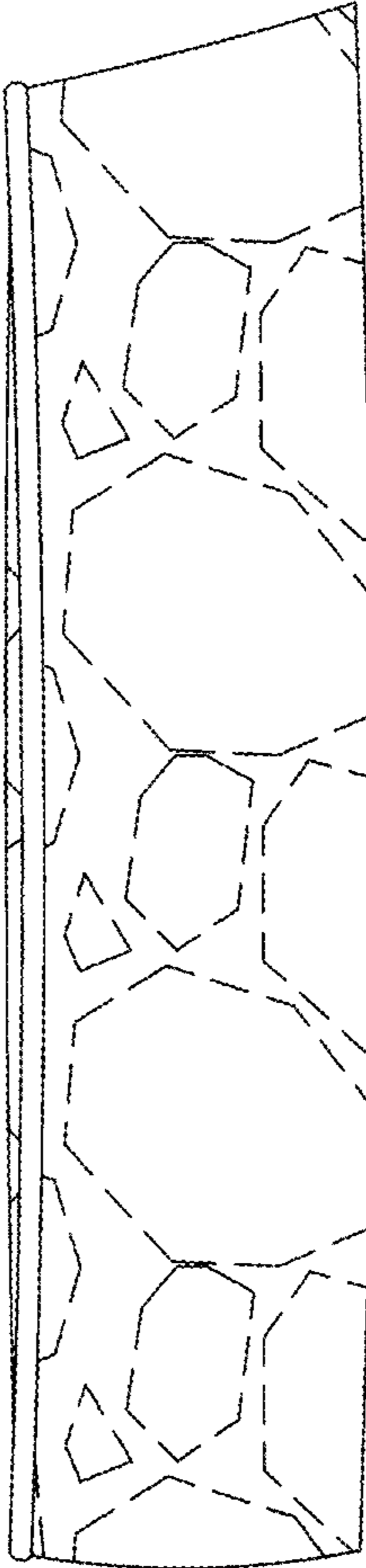

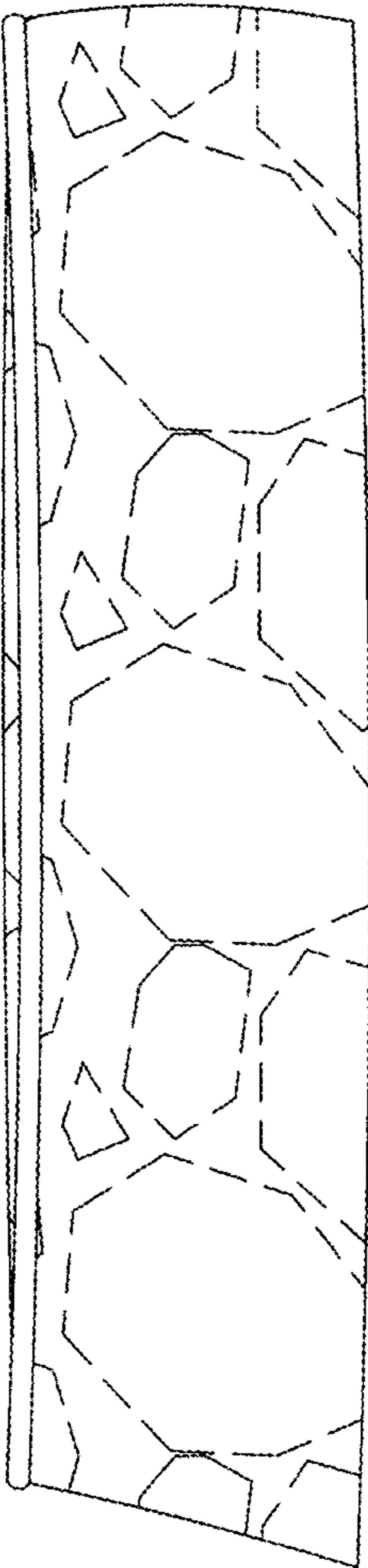

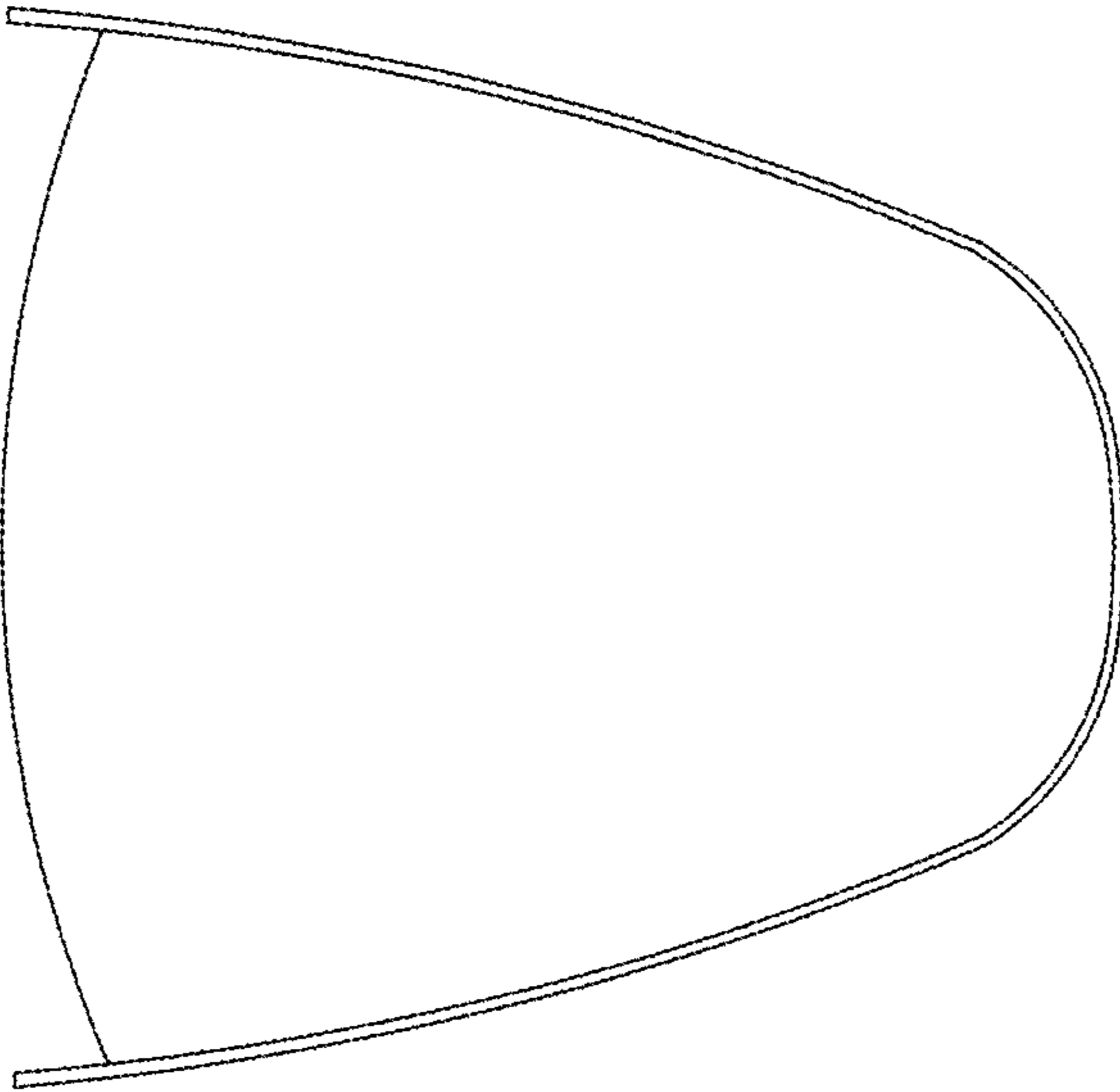

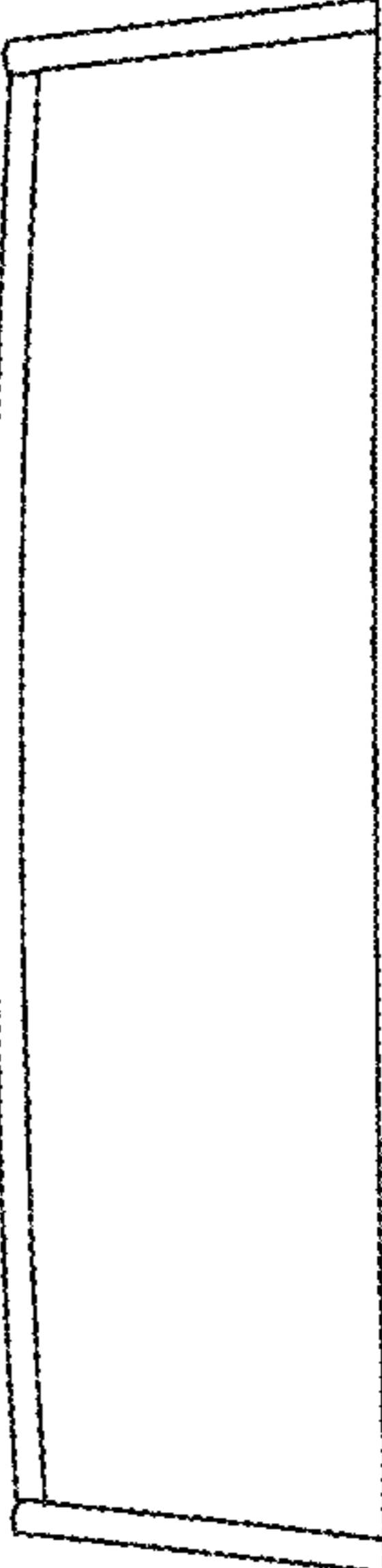
