(57) **CLAIM**

We claim the ornamental design for a pillow, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right perspective view of a pillow embodying our new design;  
FIG. 2 is a top plan view of the pillow;  
FIG. 3 is a bottom plan view of the pillow;  
FIG. 4 is a right side elevational view of the pillow;  
FIG. 5 is a left side elevational view of the pillow;  
FIG. 6 is a rear side elevational view of the pillow; and,  
FIG. 7 is a front side elevational view of the pillow.

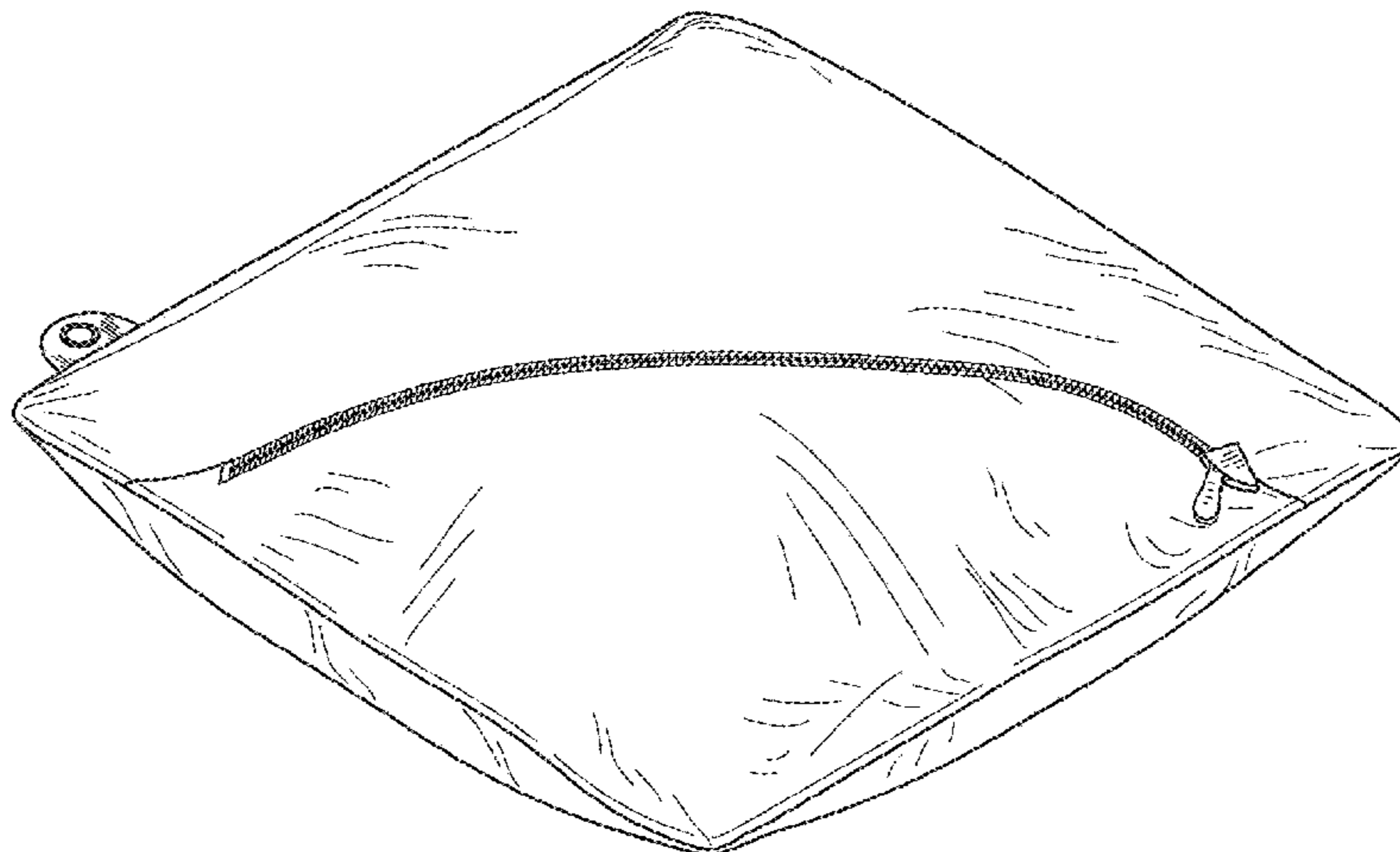

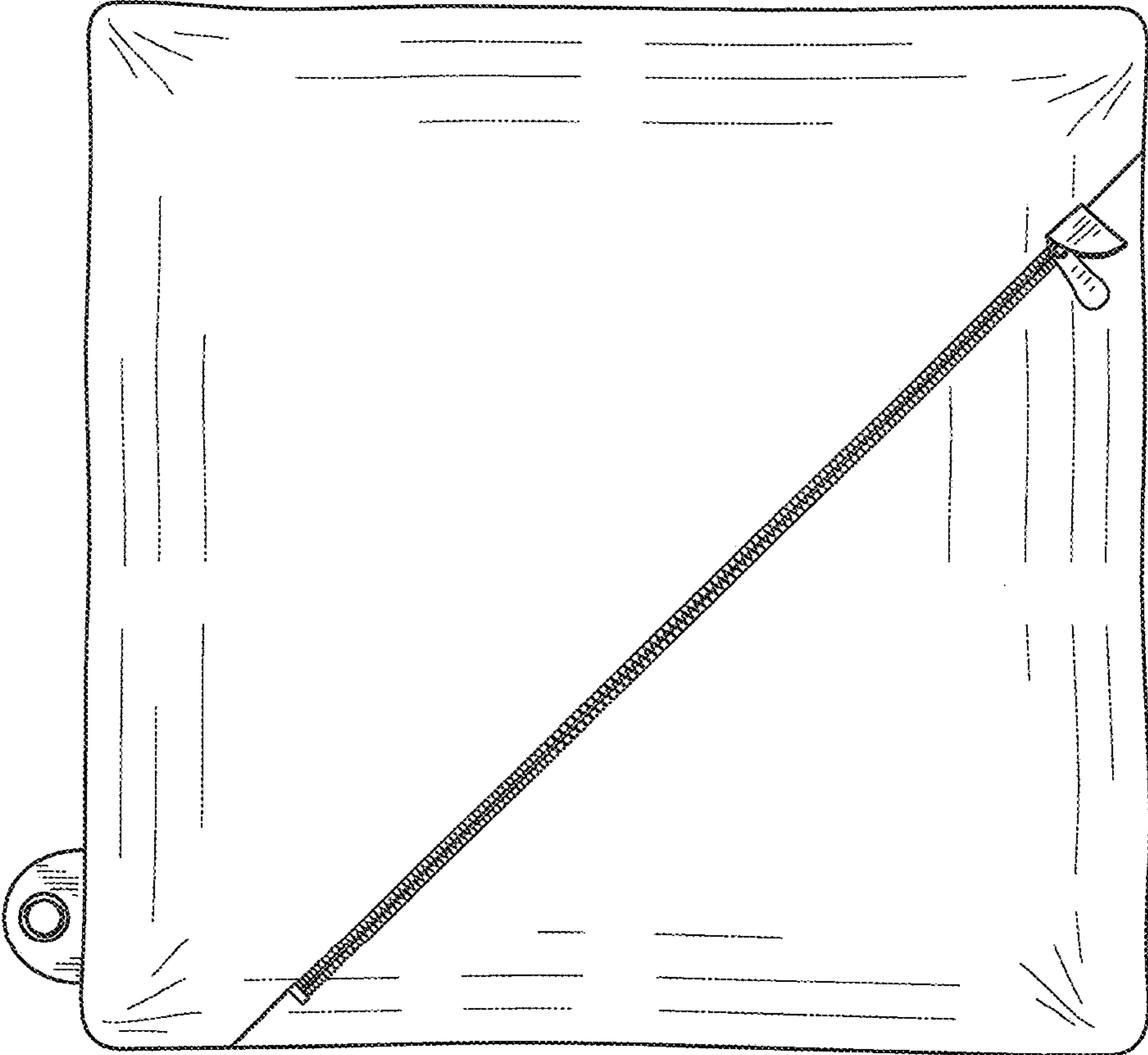

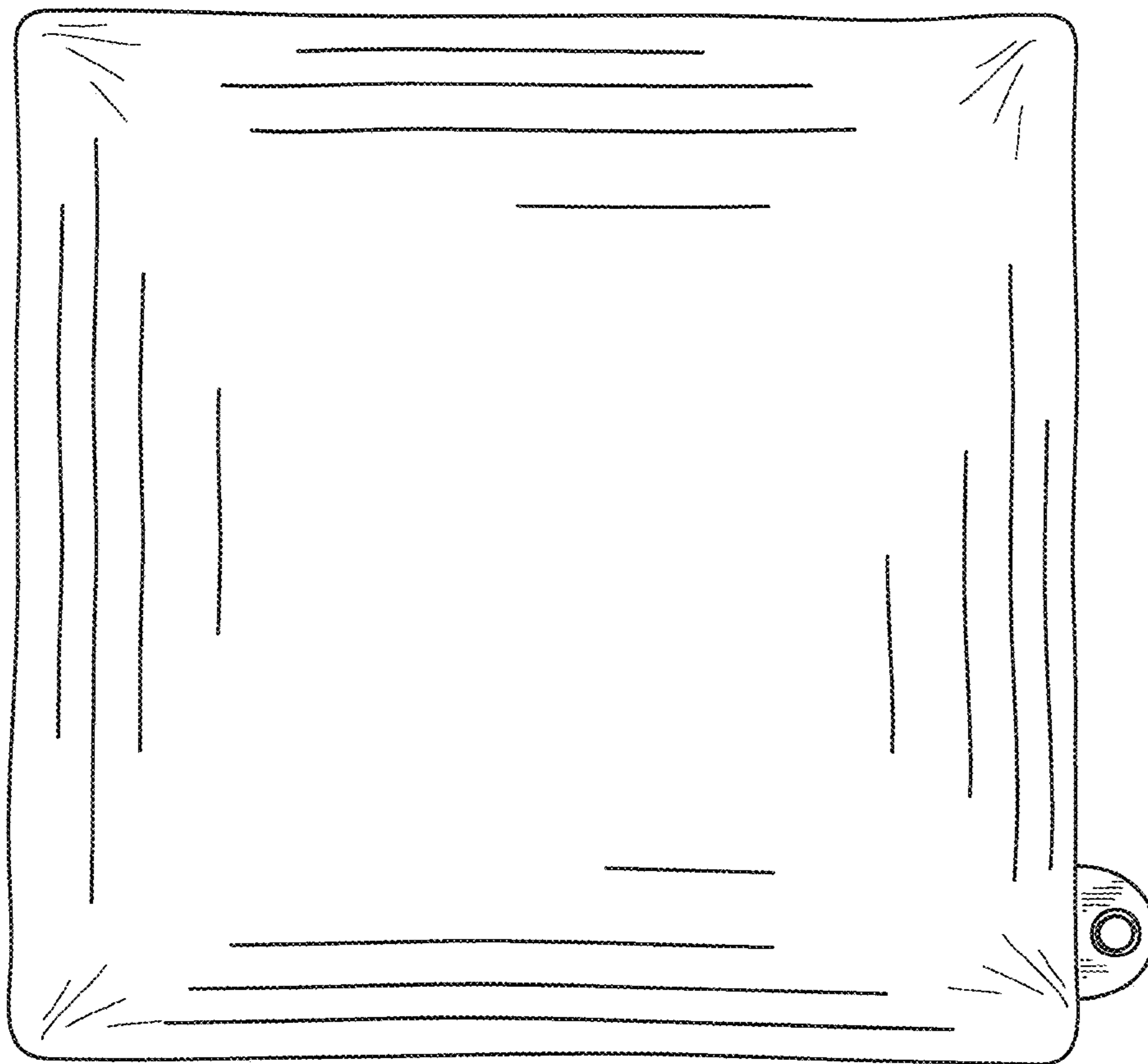

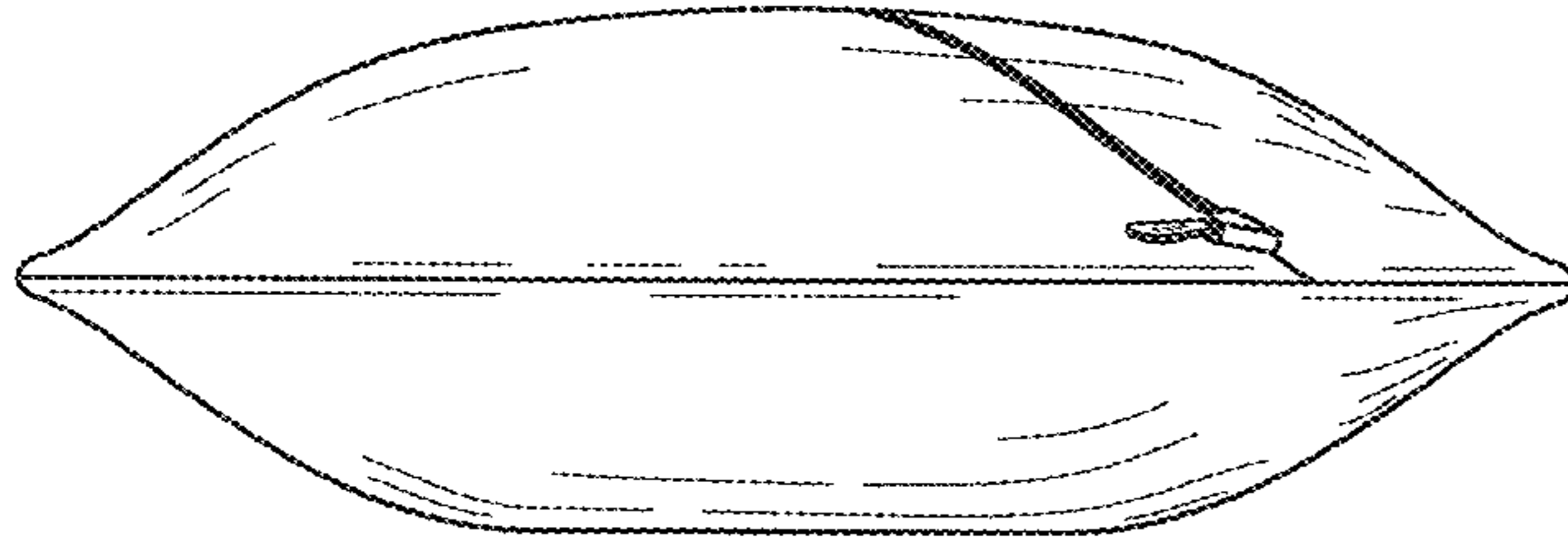

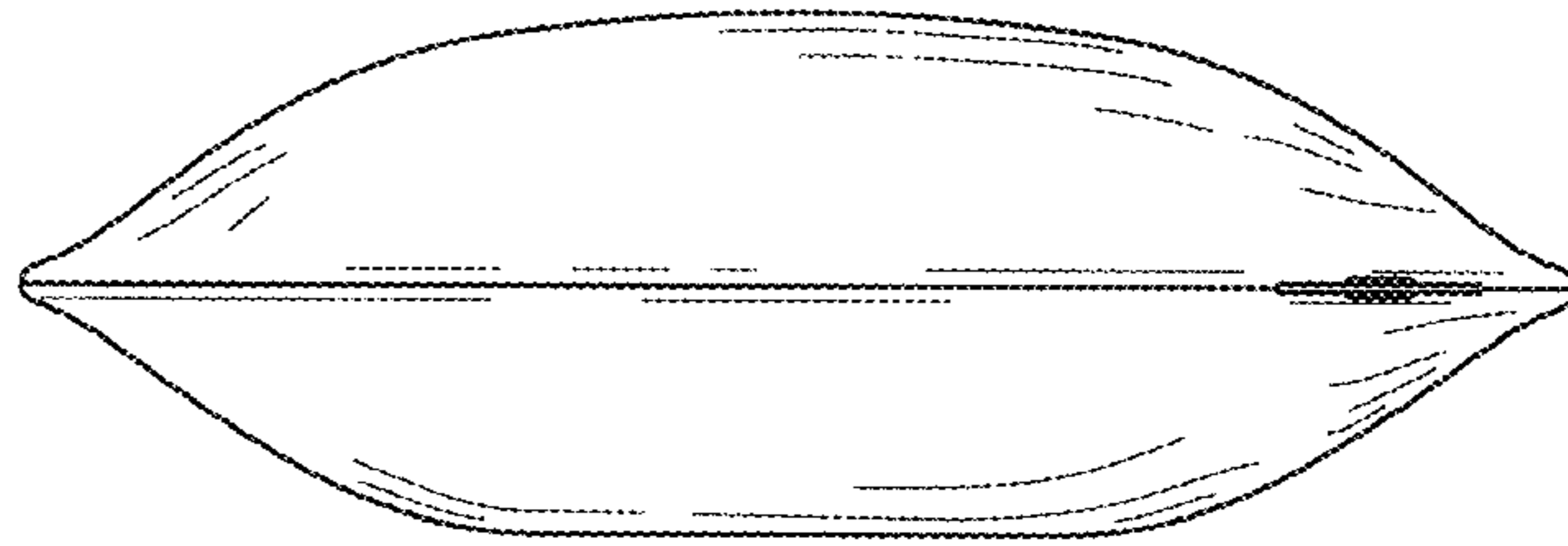

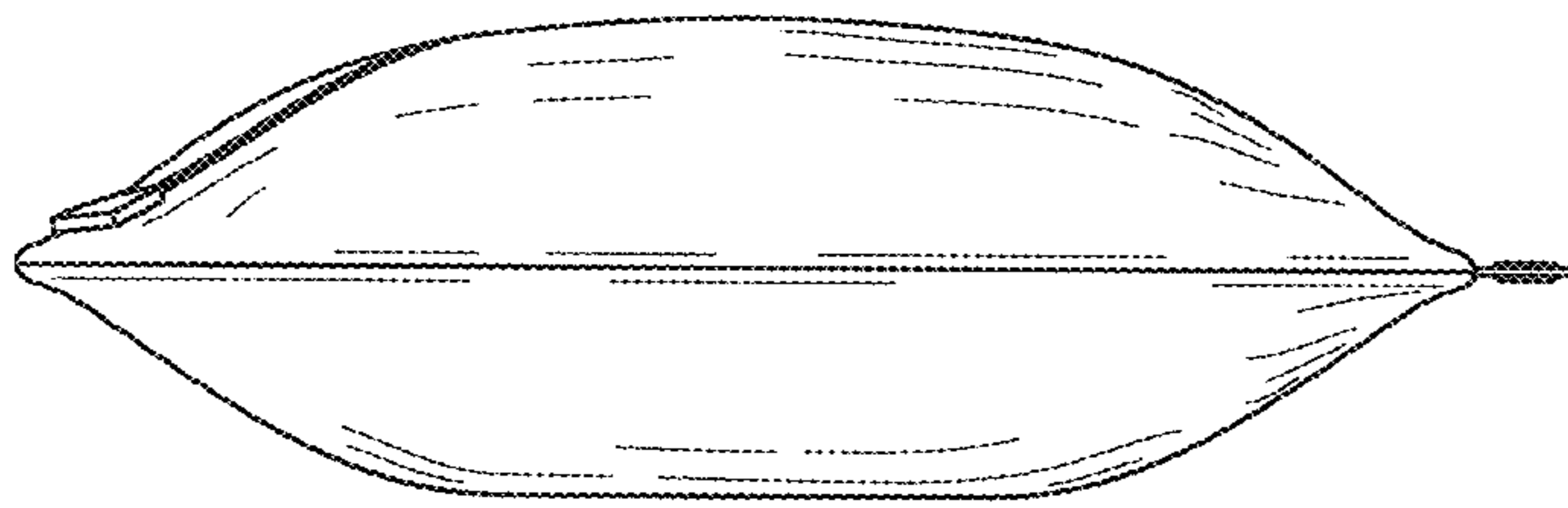
