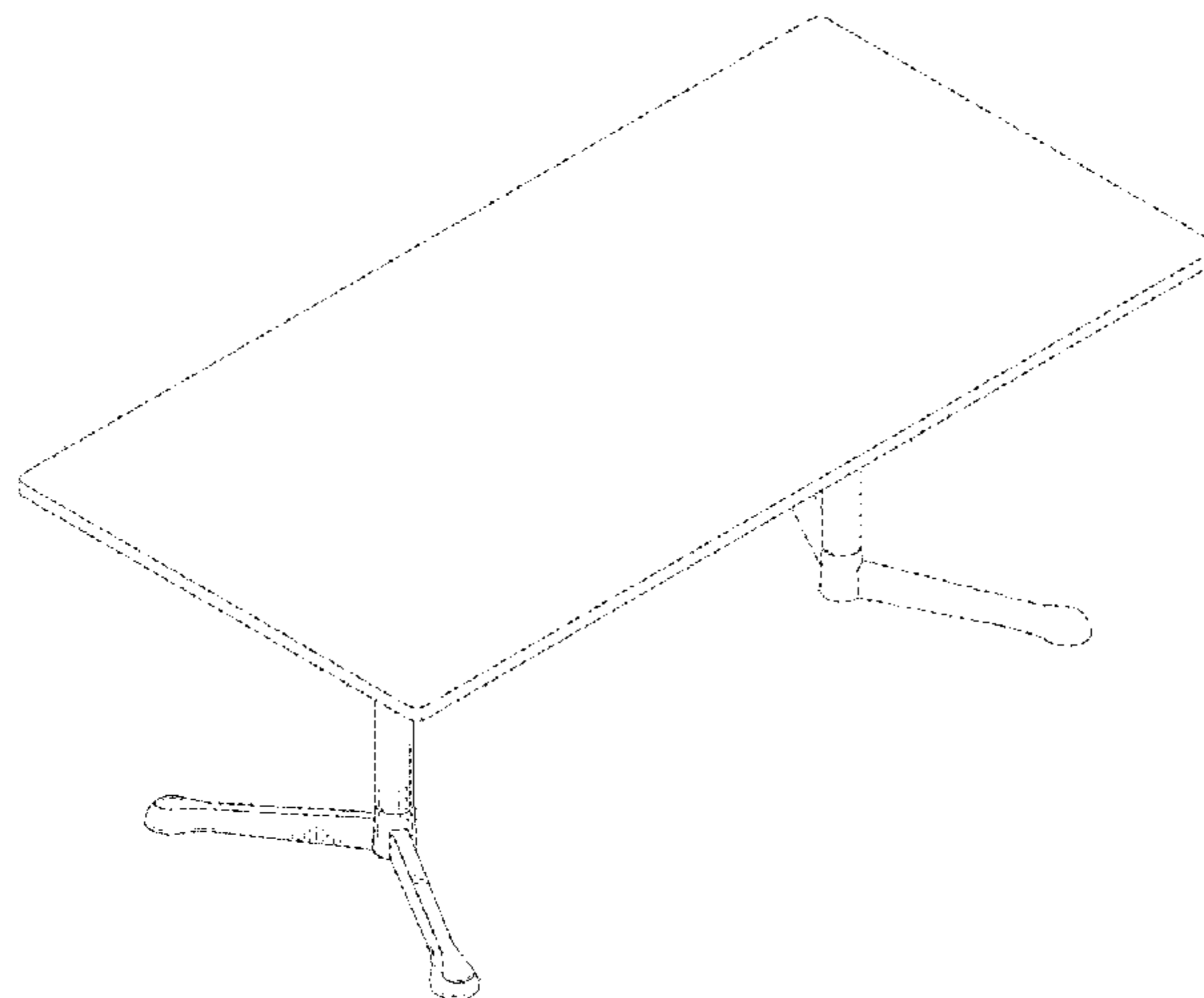
(57) **CLAIM**

The ornamental design for a table, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a table.  
FIG. 2 is a front elevation view thereof. A rear elevation view is a mirror image of the front elevation view.  
FIG. 3 is a left side elevation view thereof.  
FIG. 4 is a top plan view thereof.  
FIG. 5 is a bottom plan view thereof.  
FIG. 6 is an enlarged cross-sectional view taken along the line 6-6 in FIG. 4; and,  
FIG. 7 is an enlarged cross-sectional view taken along the line 7-7 in FIG. 4.  
The broken lines shown in the drawings illustrate portions of the table that form no part of the claimed design.

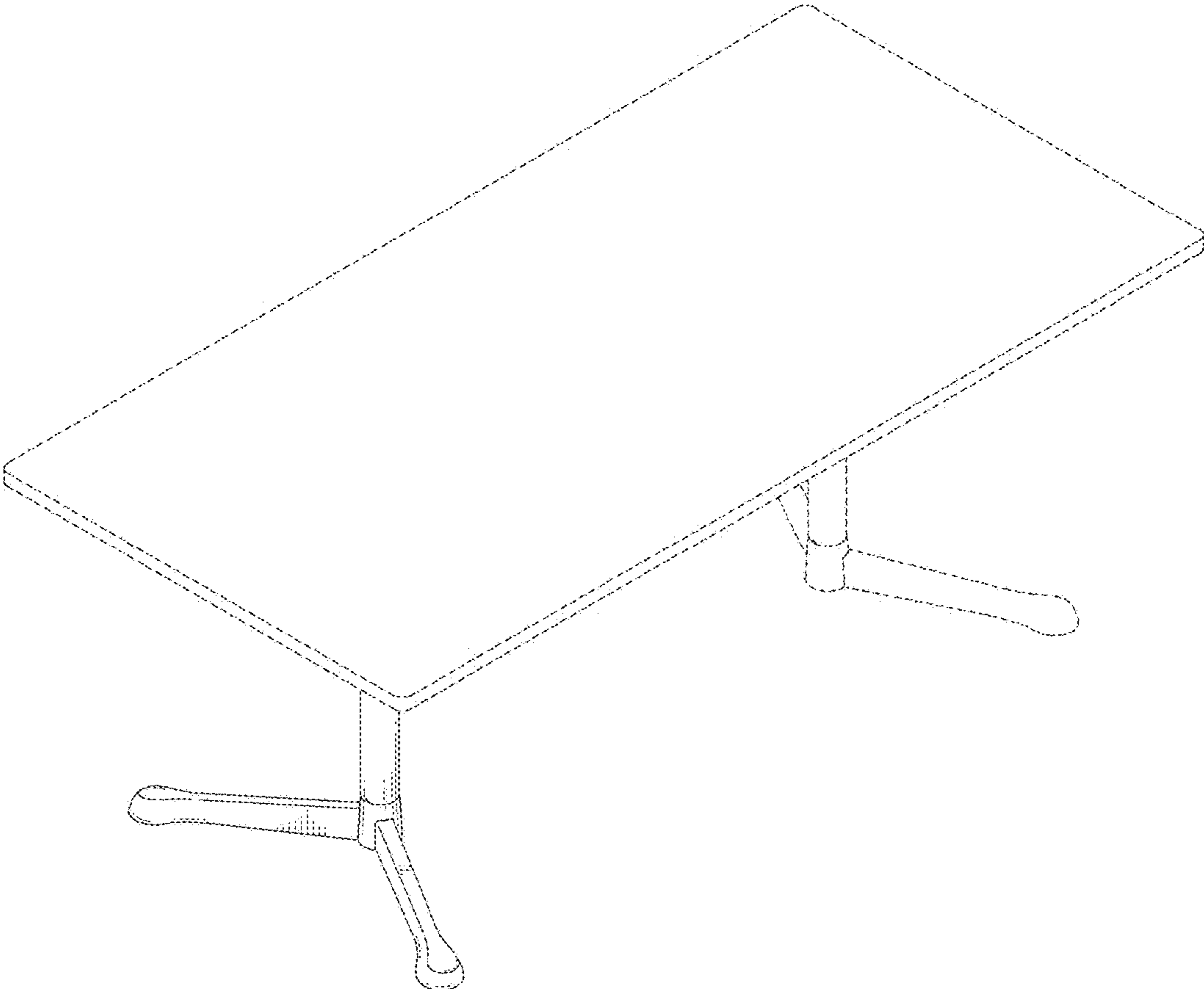

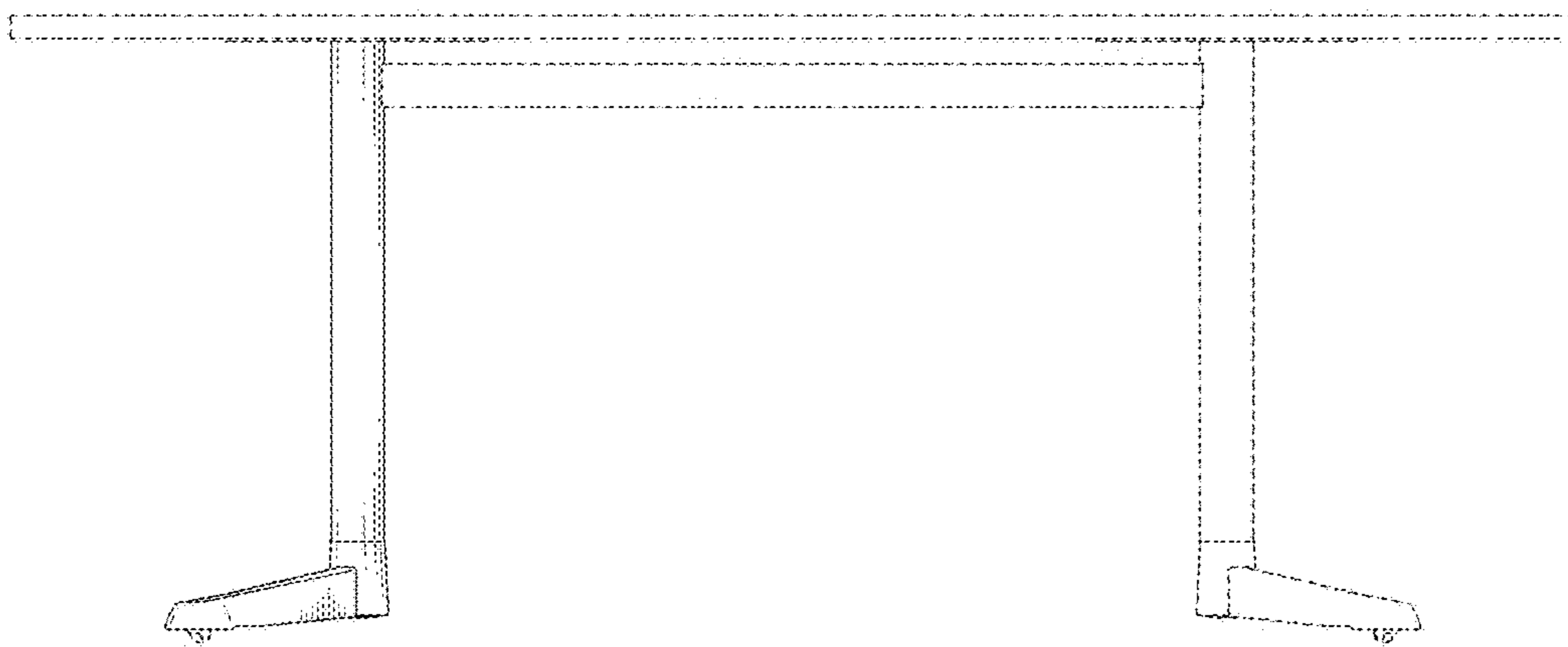

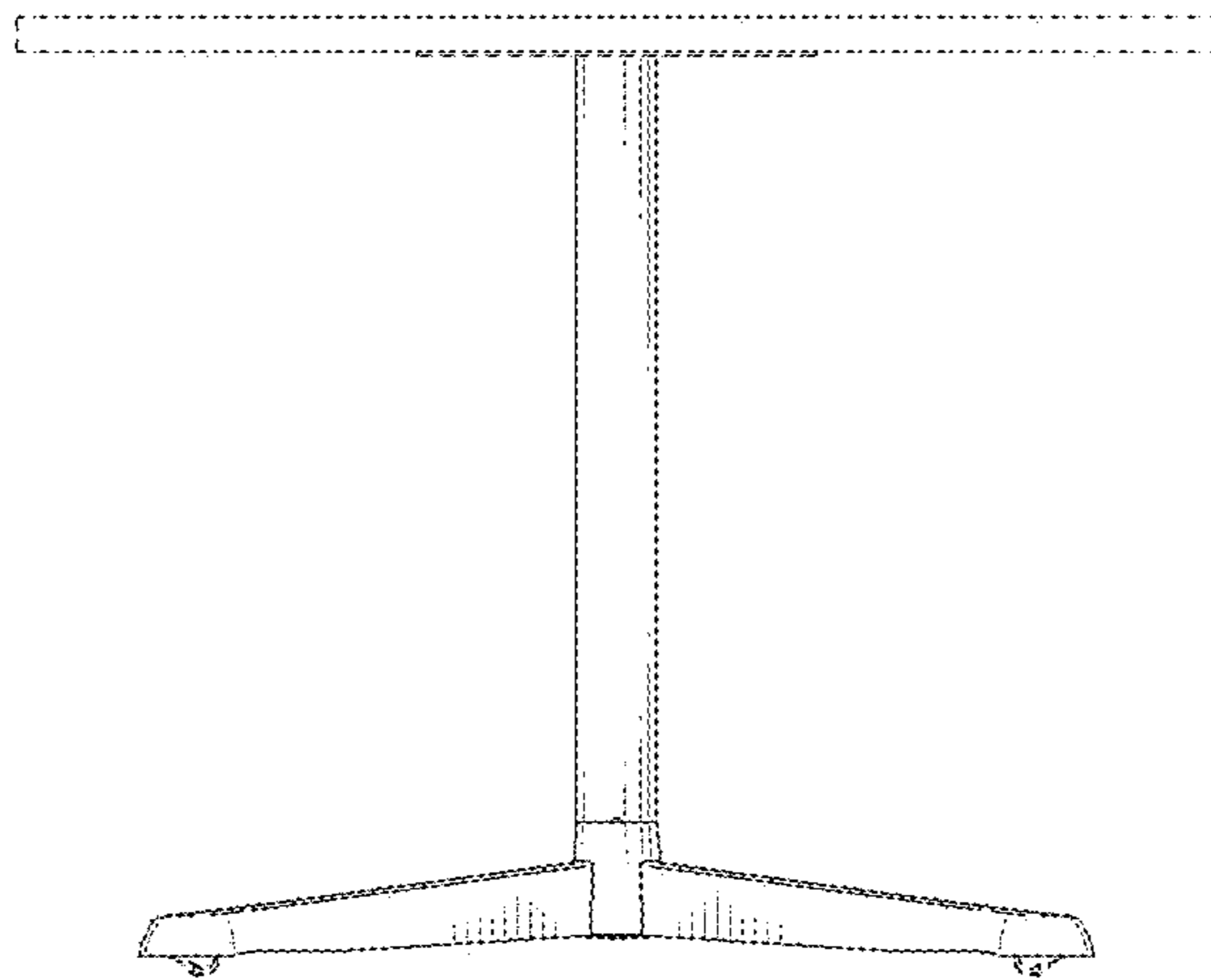

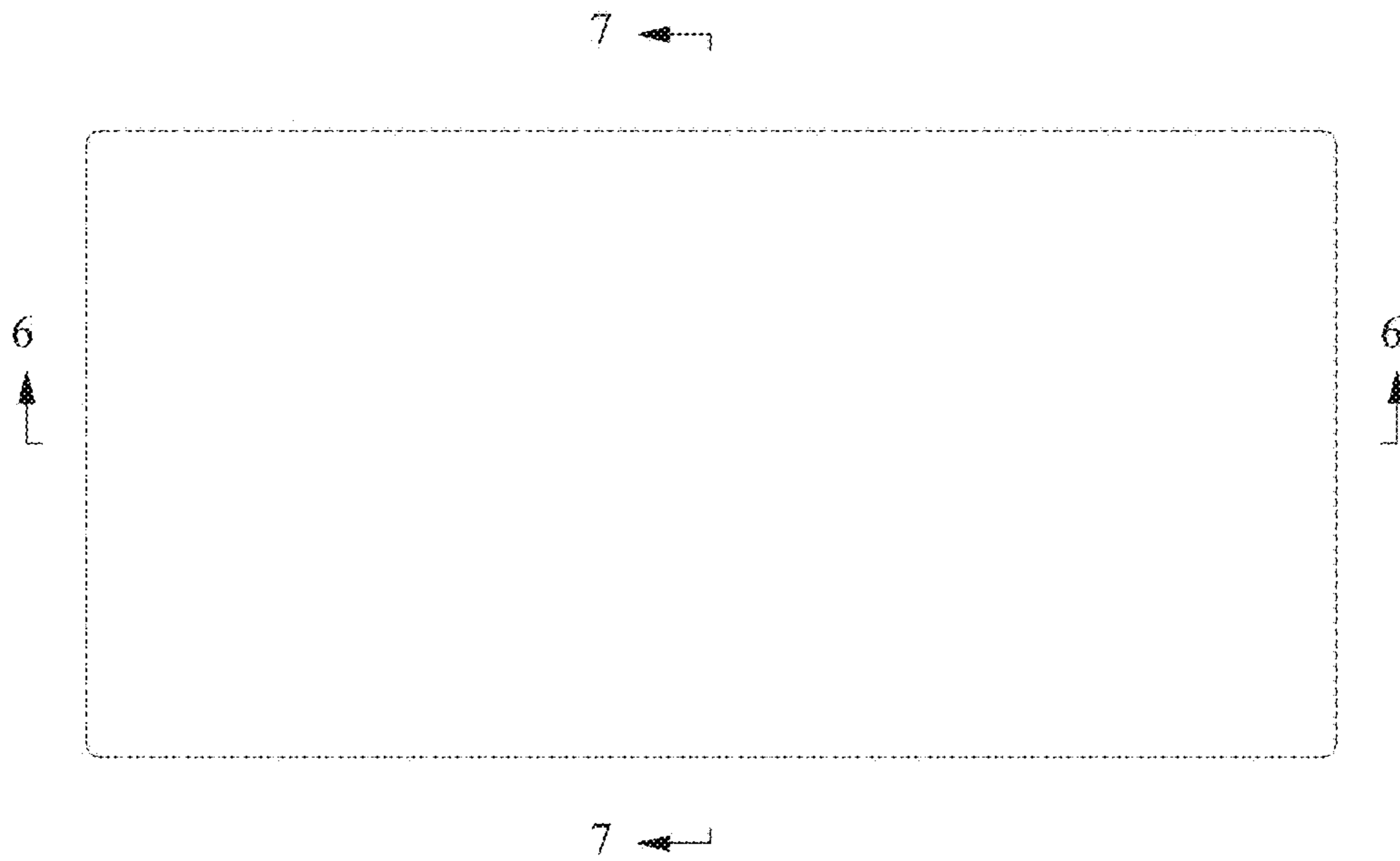

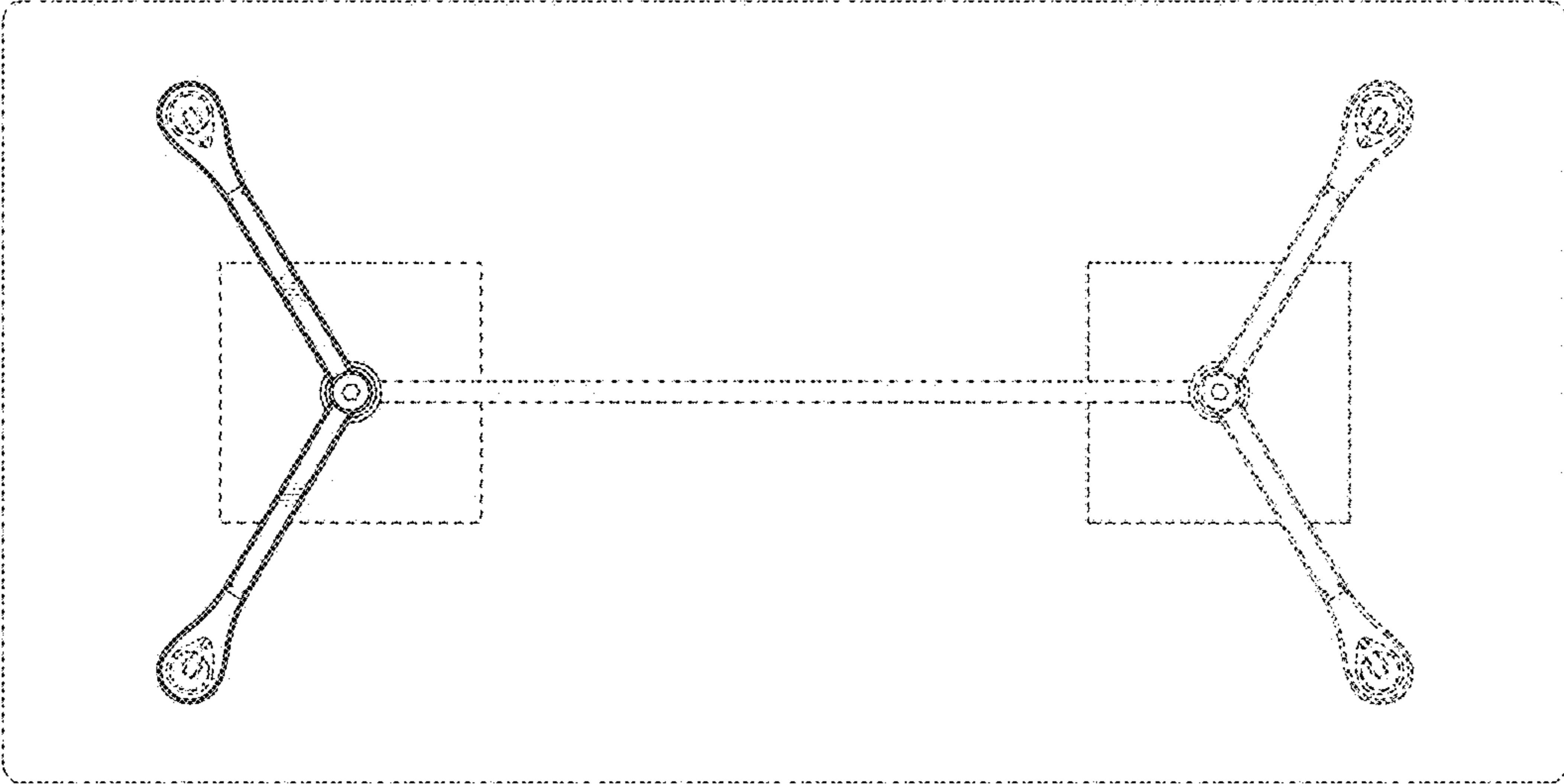

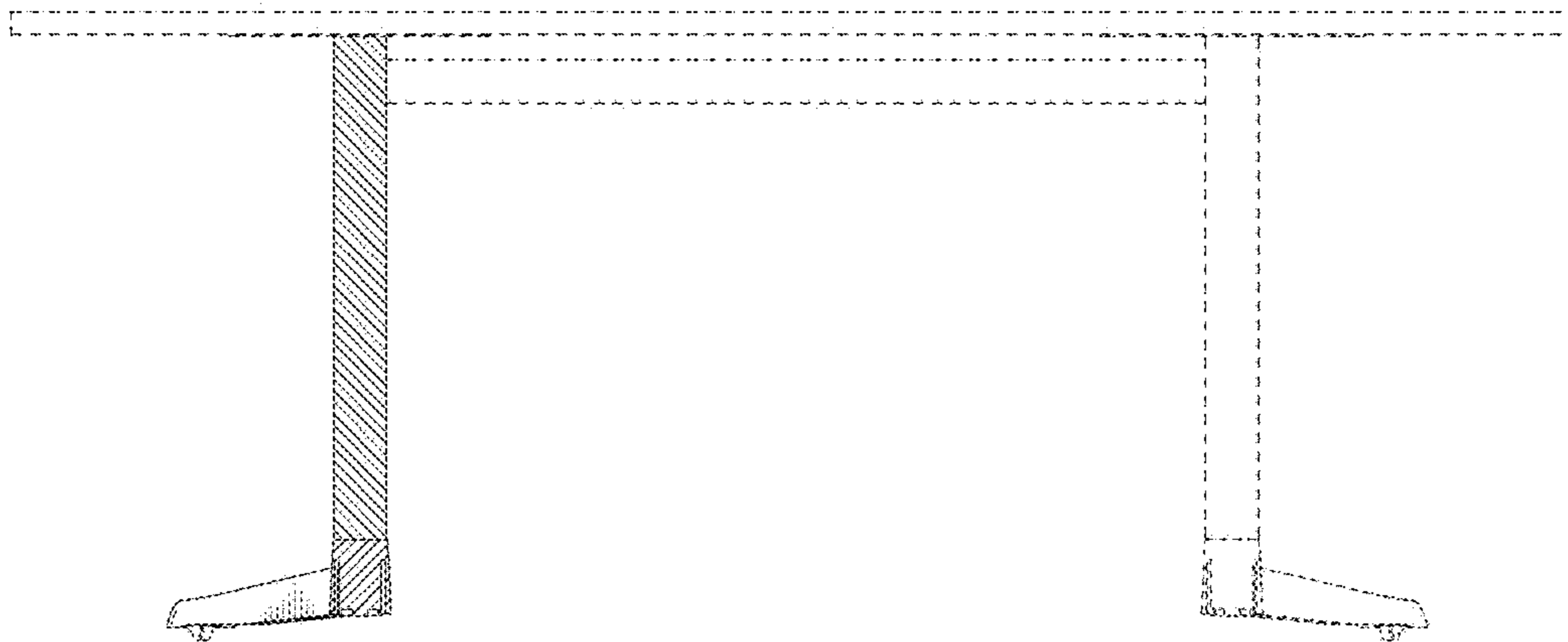
