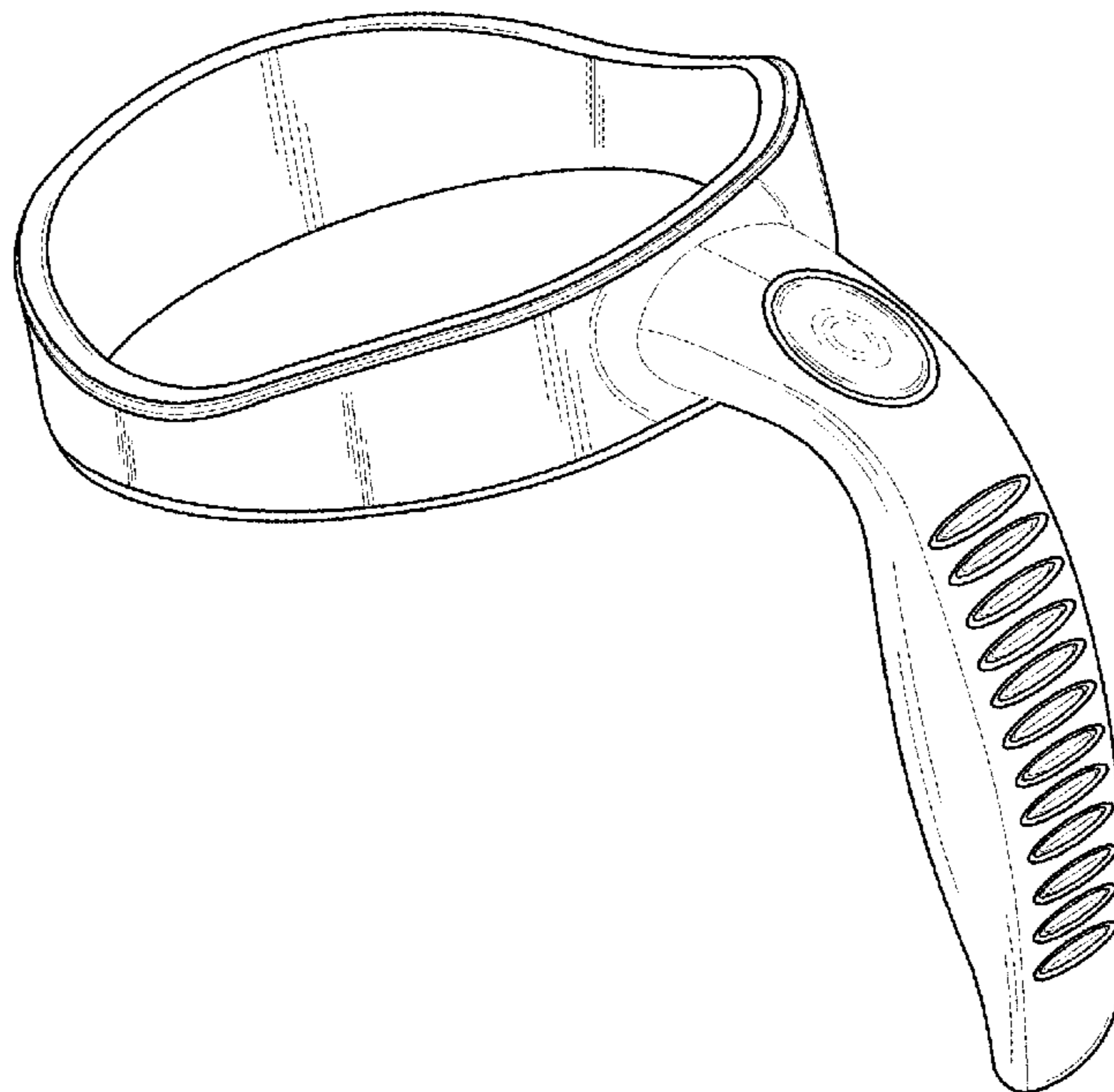
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a rear-right top perspective view for a removable handle for tumblers, showing my new design;

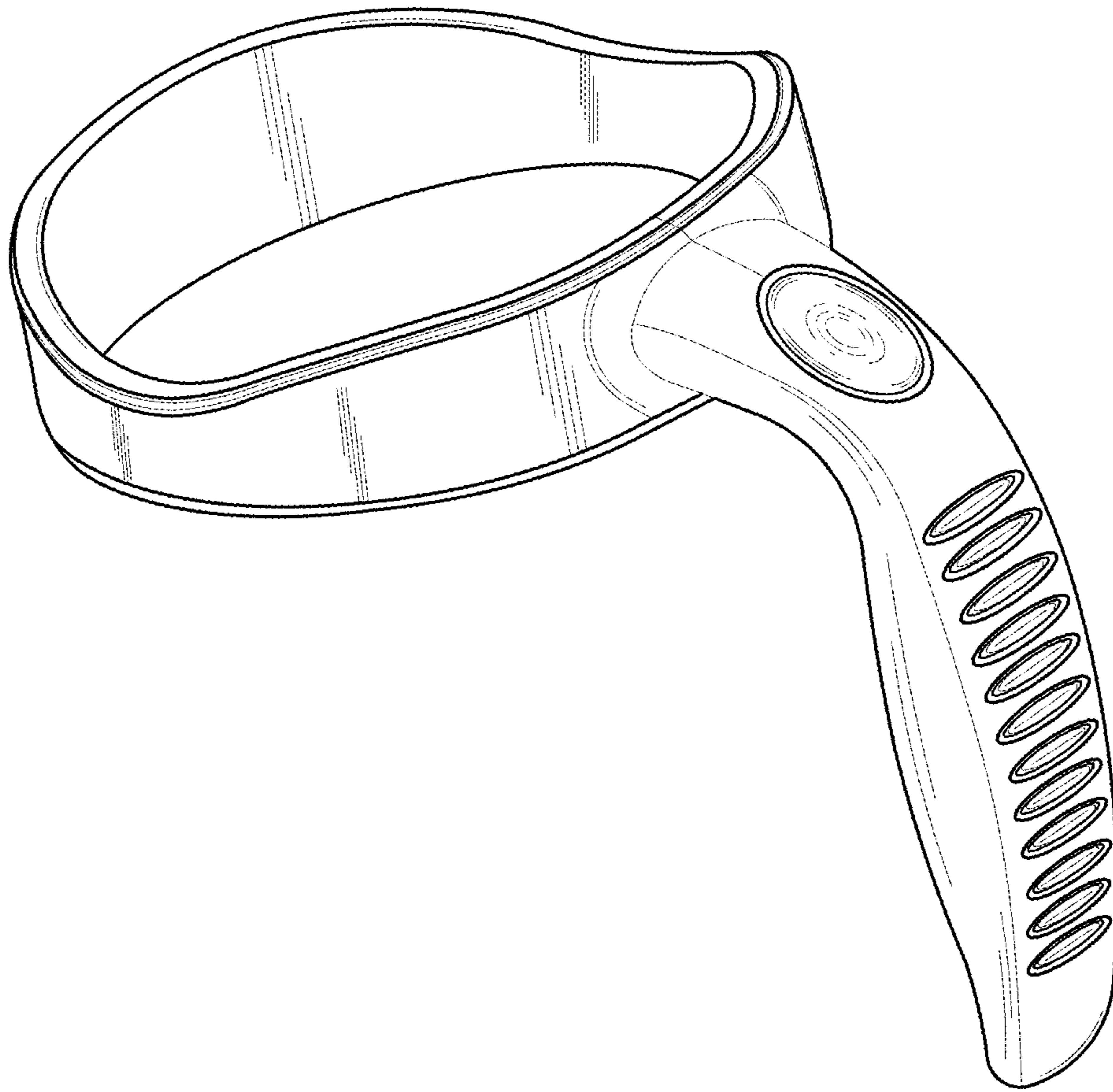

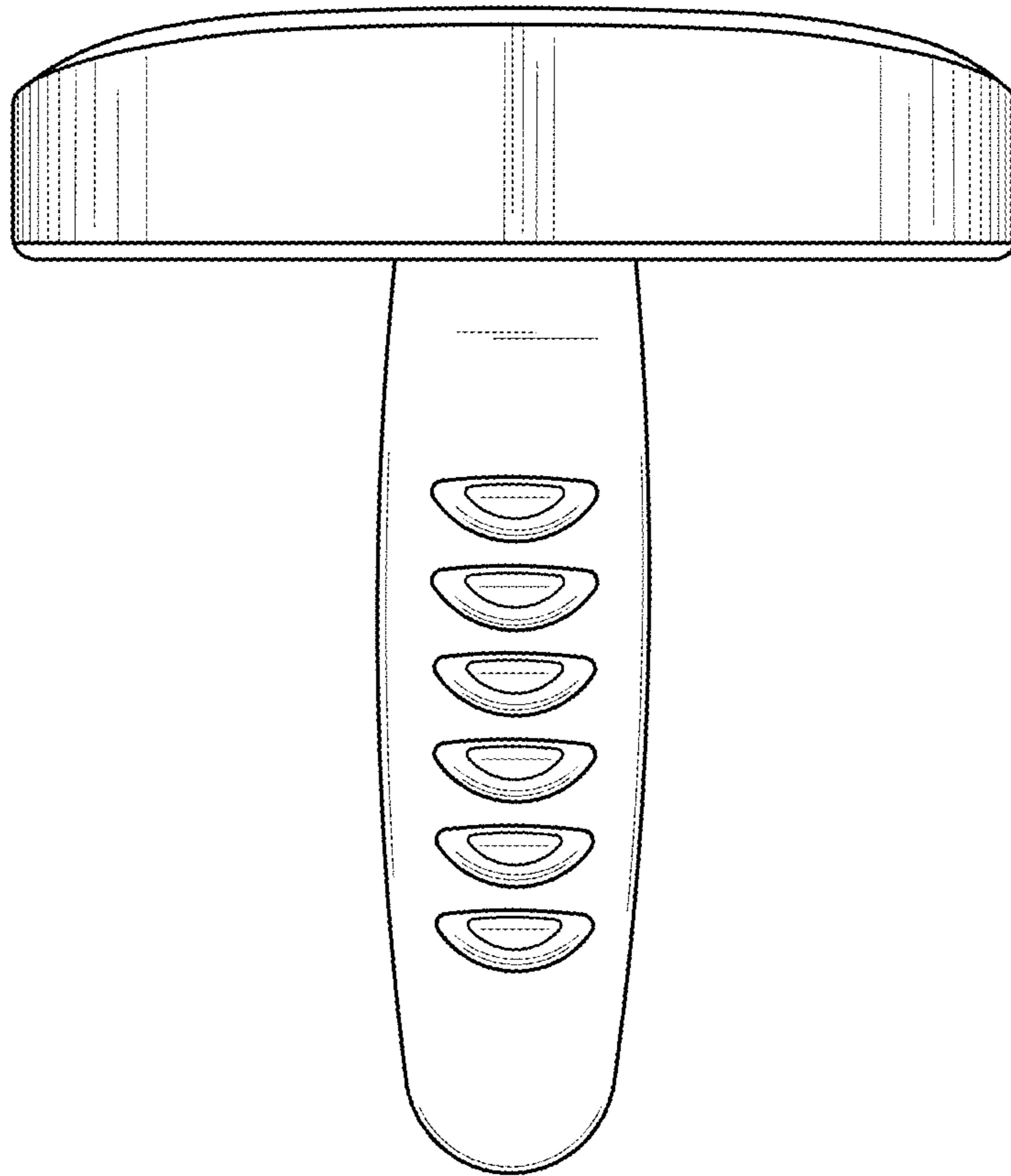

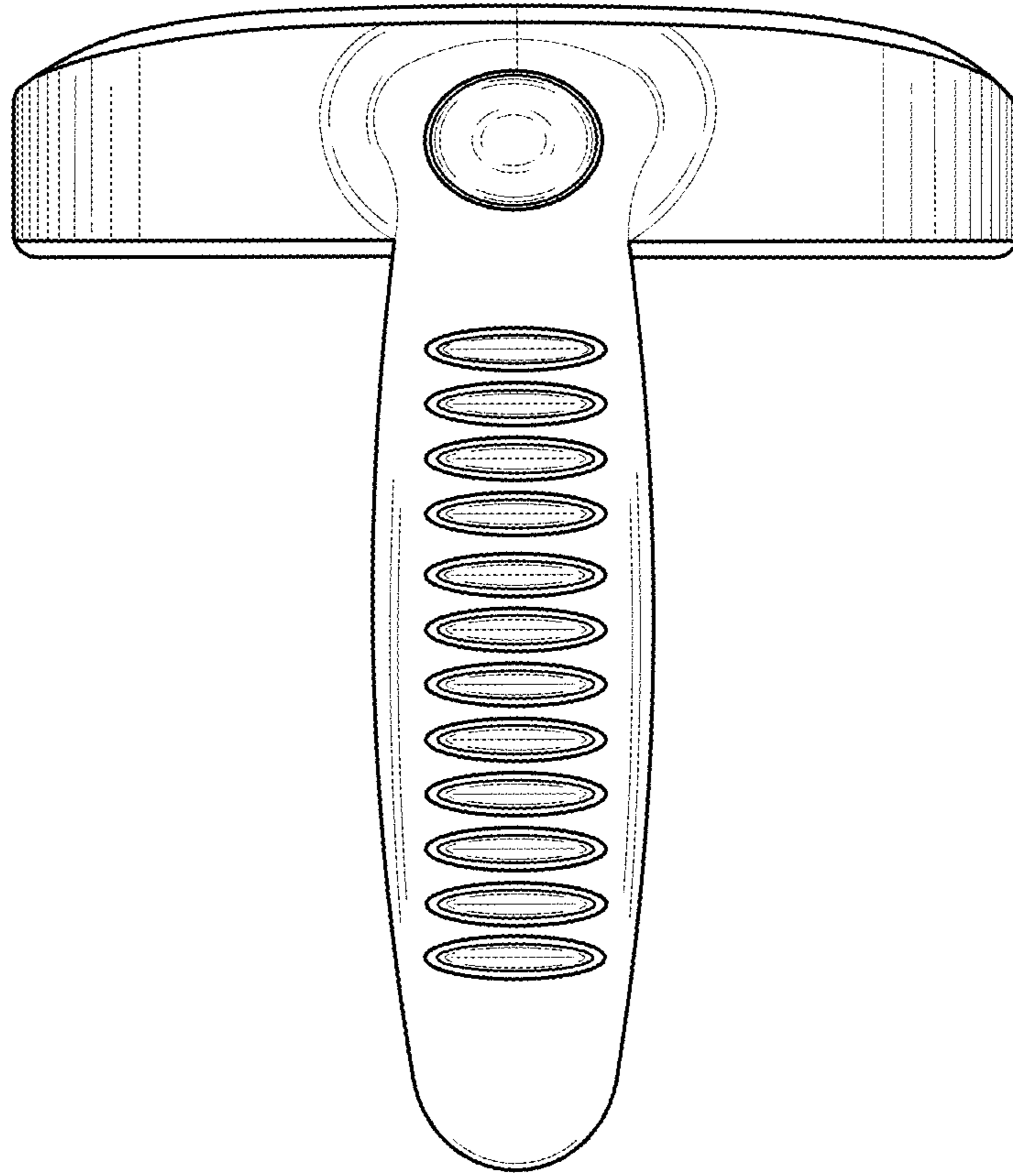

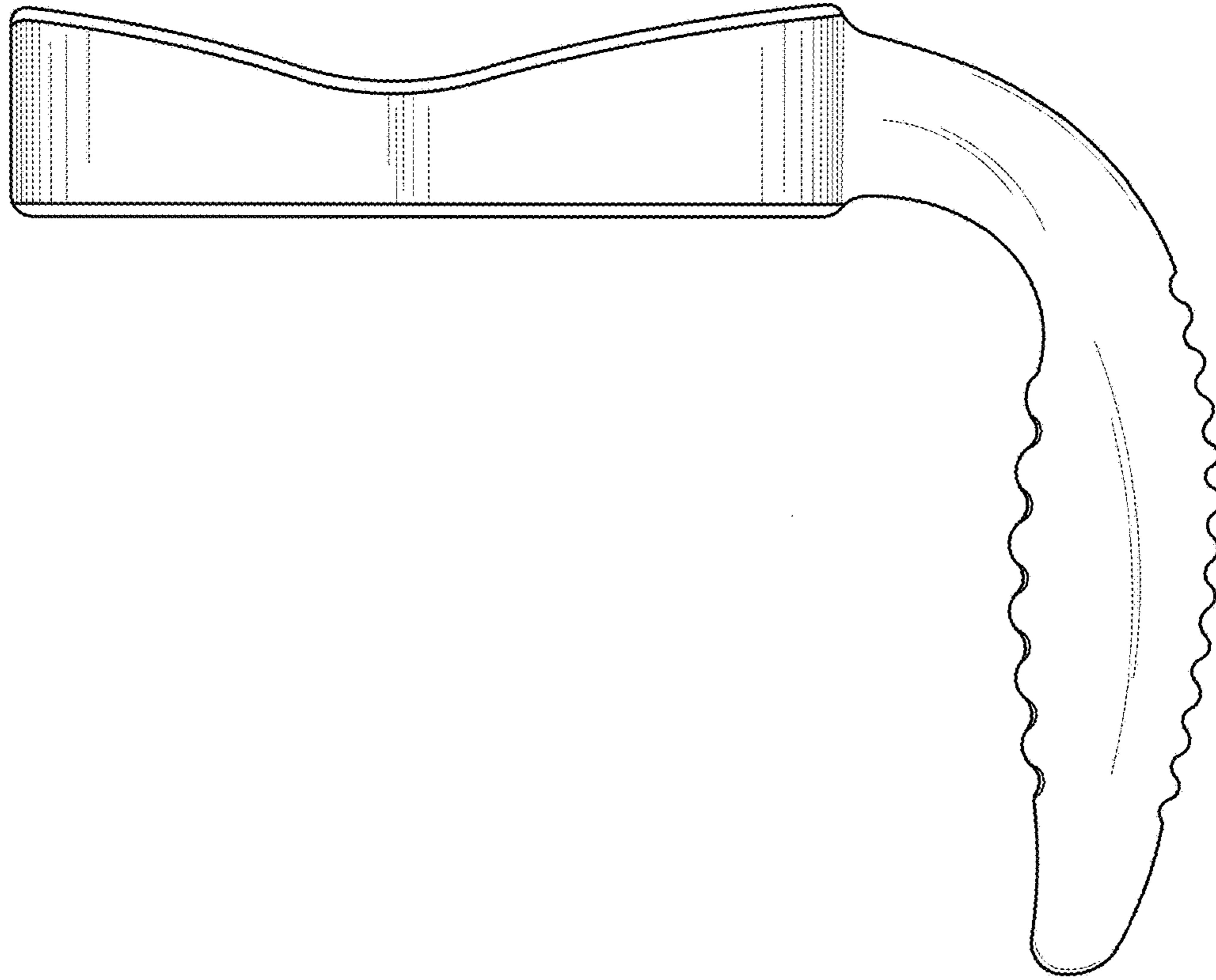

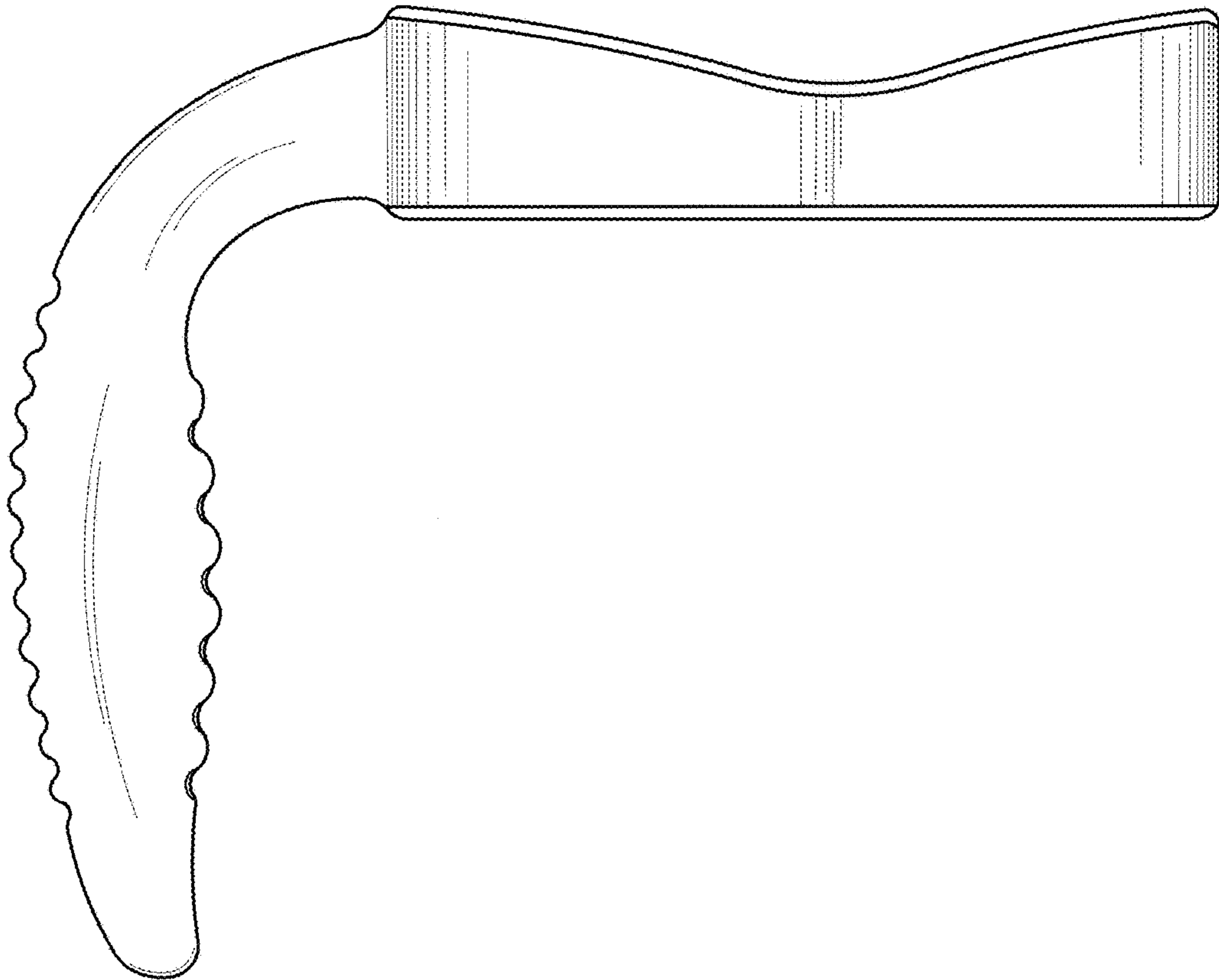

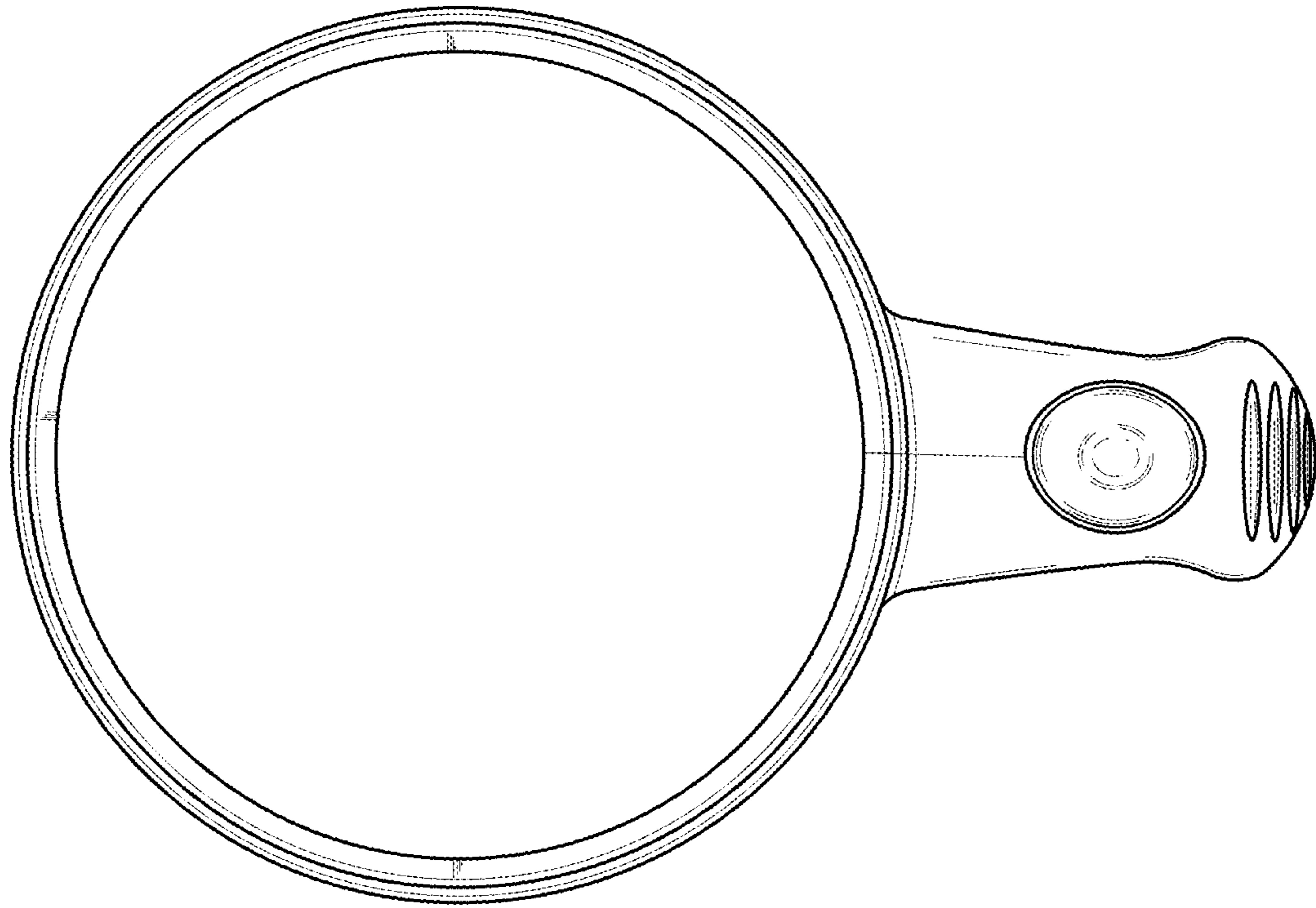

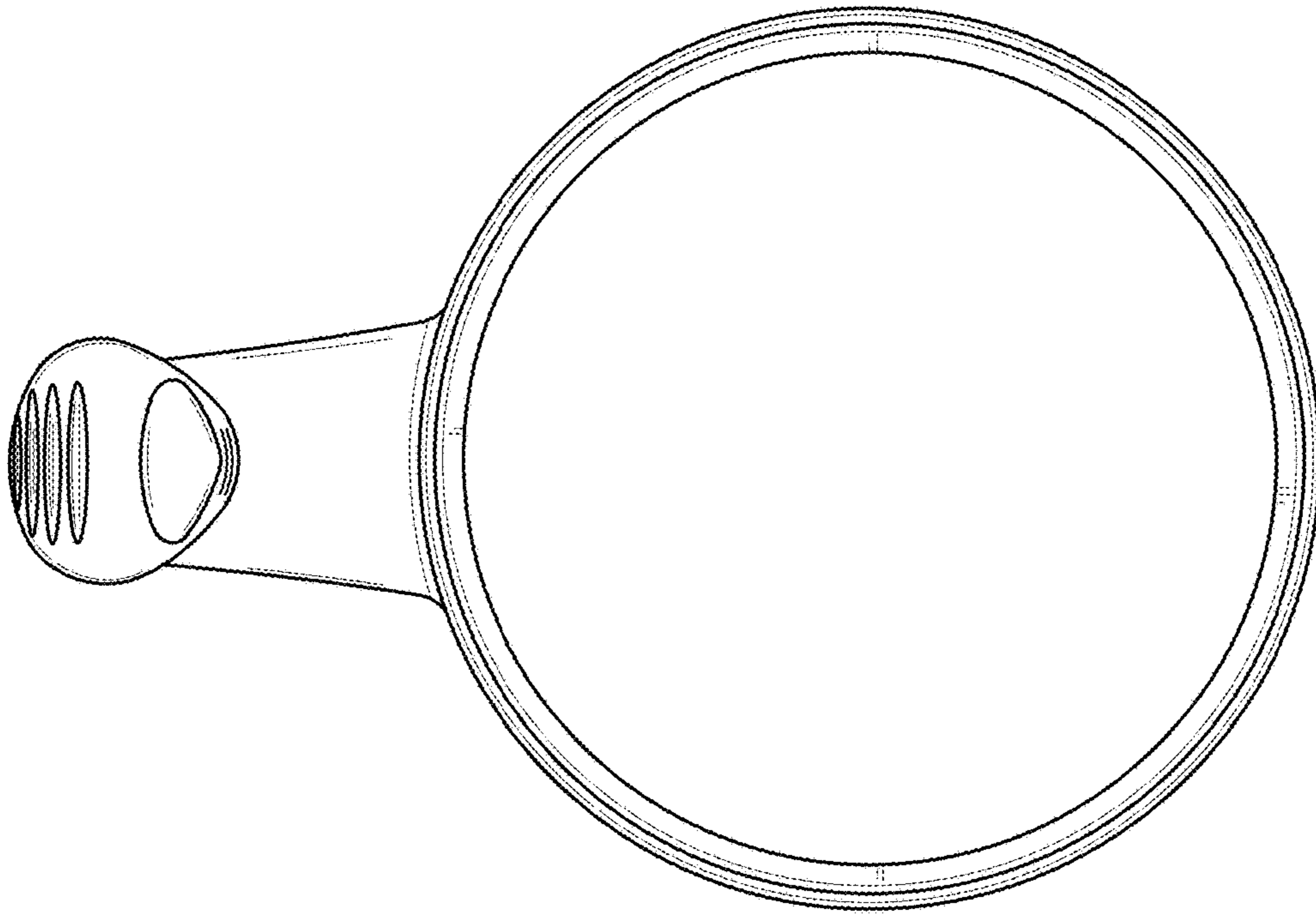
