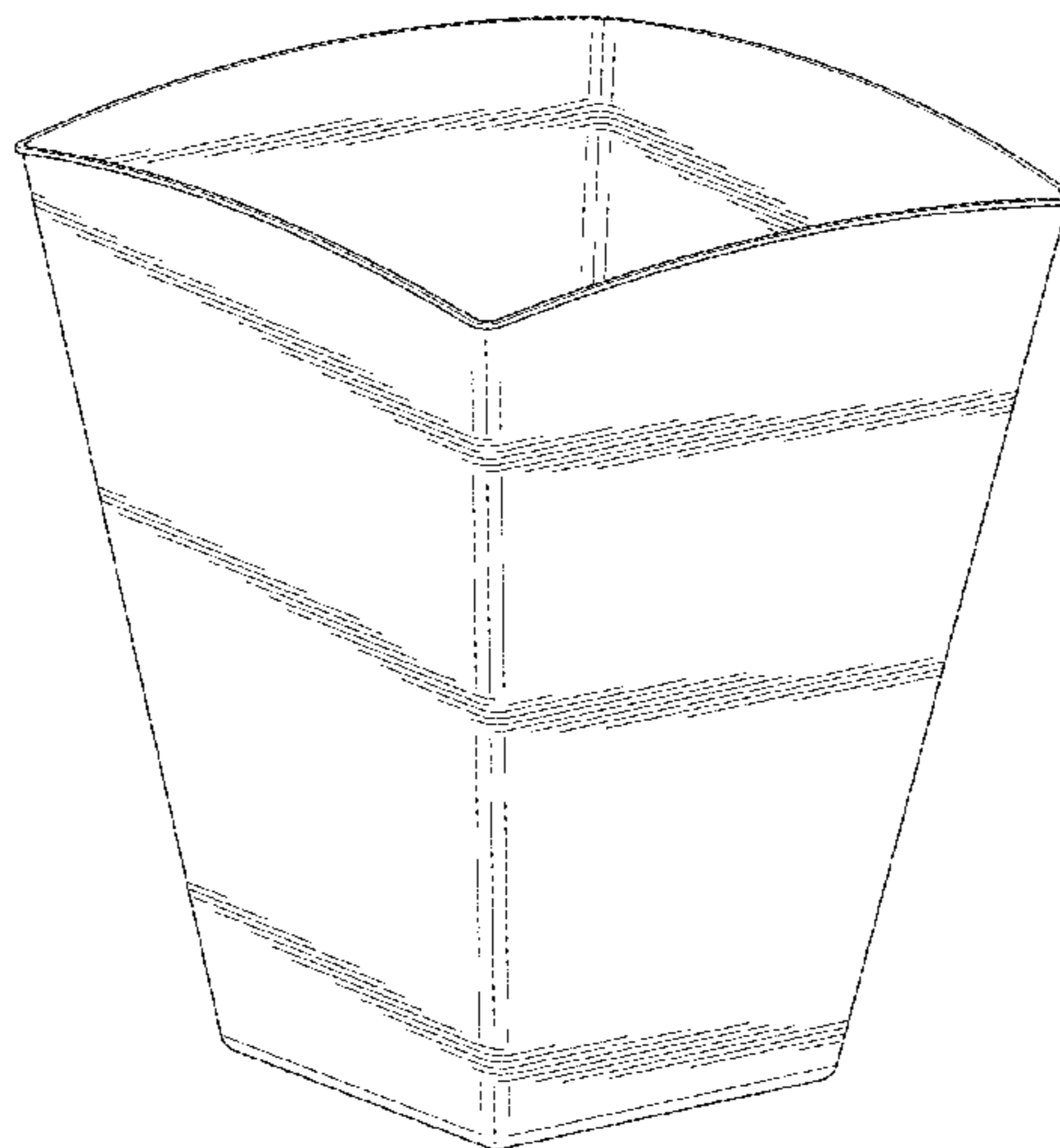

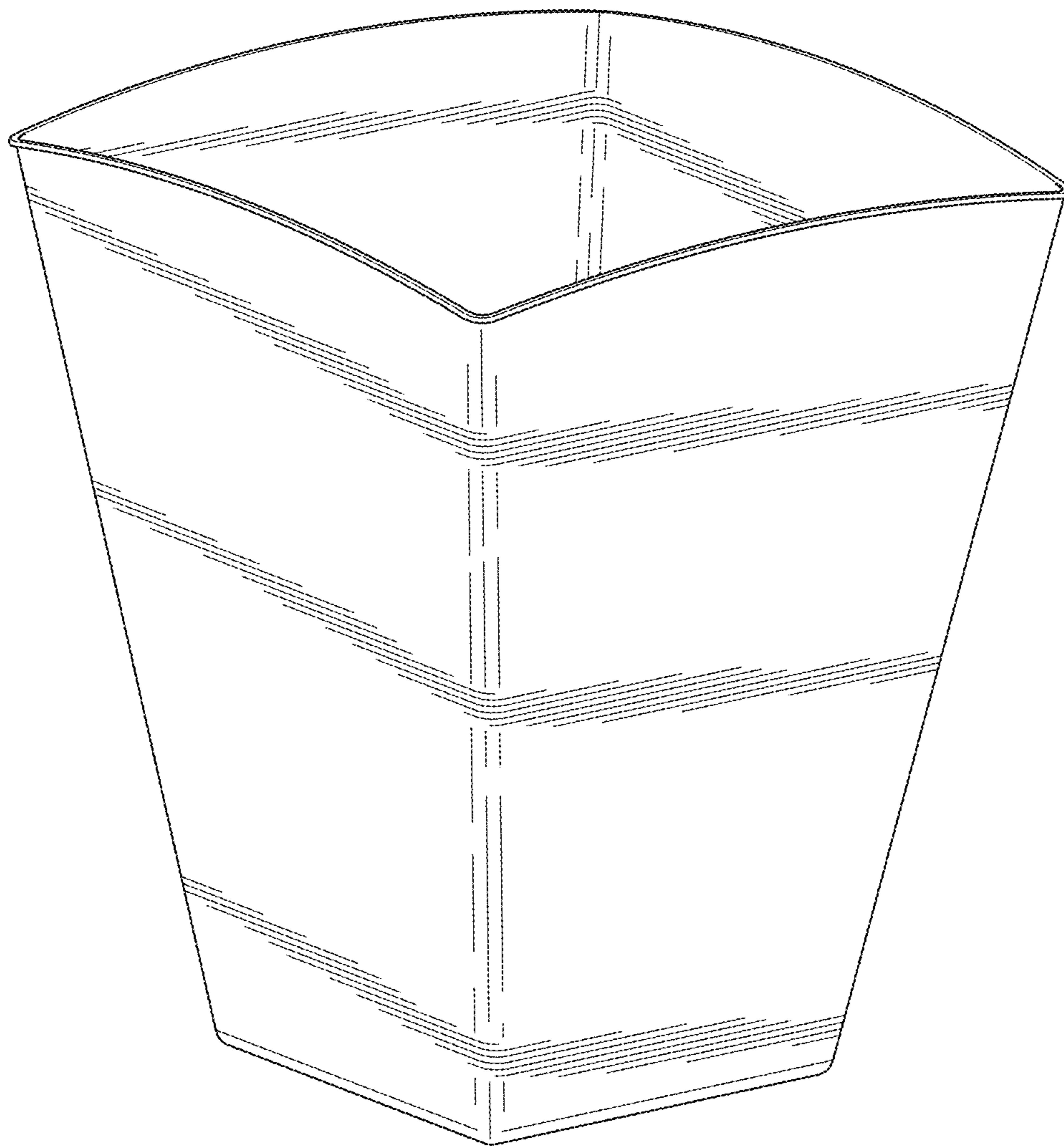
The ornamental design for a plastic container, as shown and described.

**DESCRIPTION**

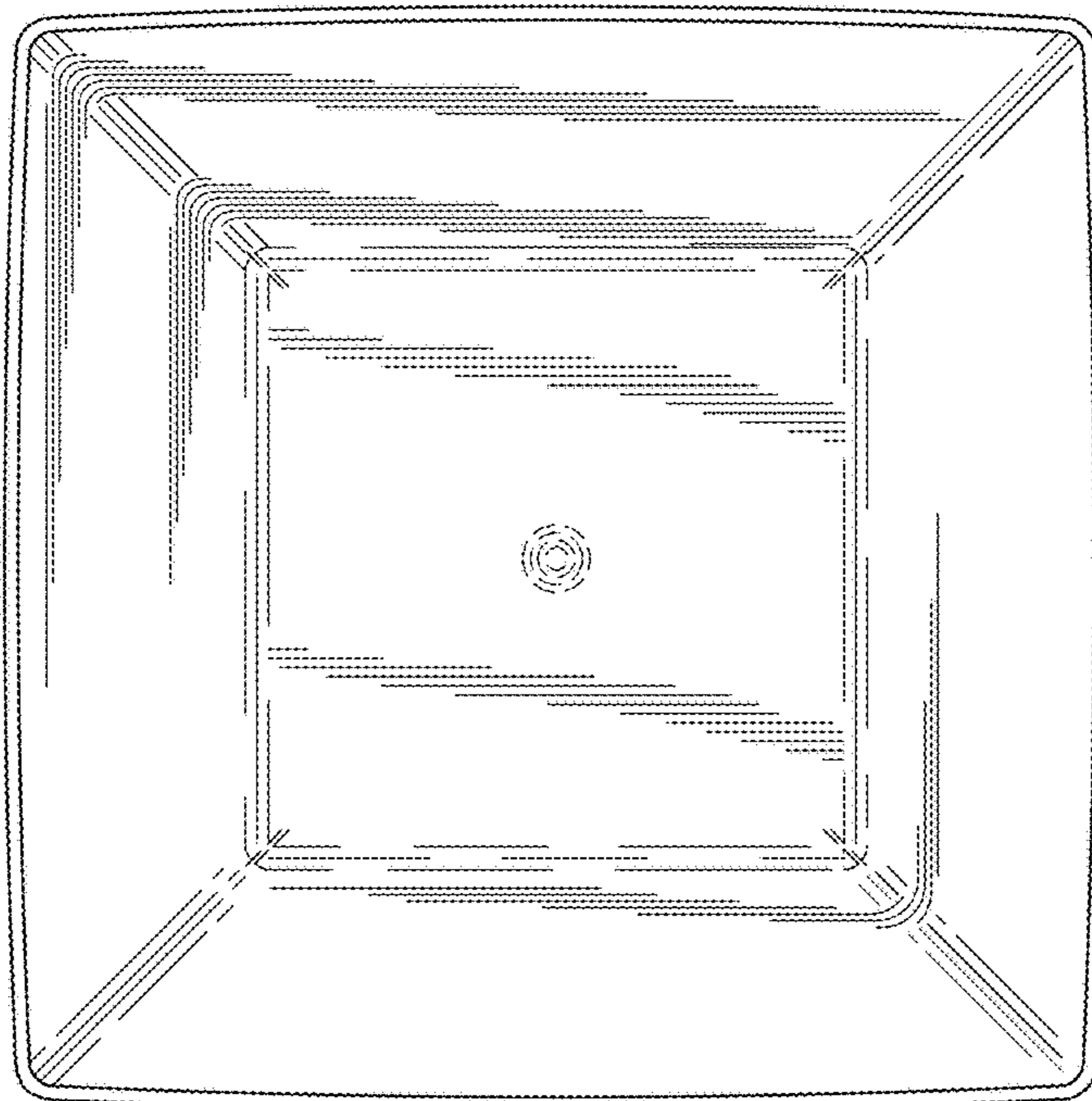
FIG. 1 is a front perspective view of a plastic container showing my new design;

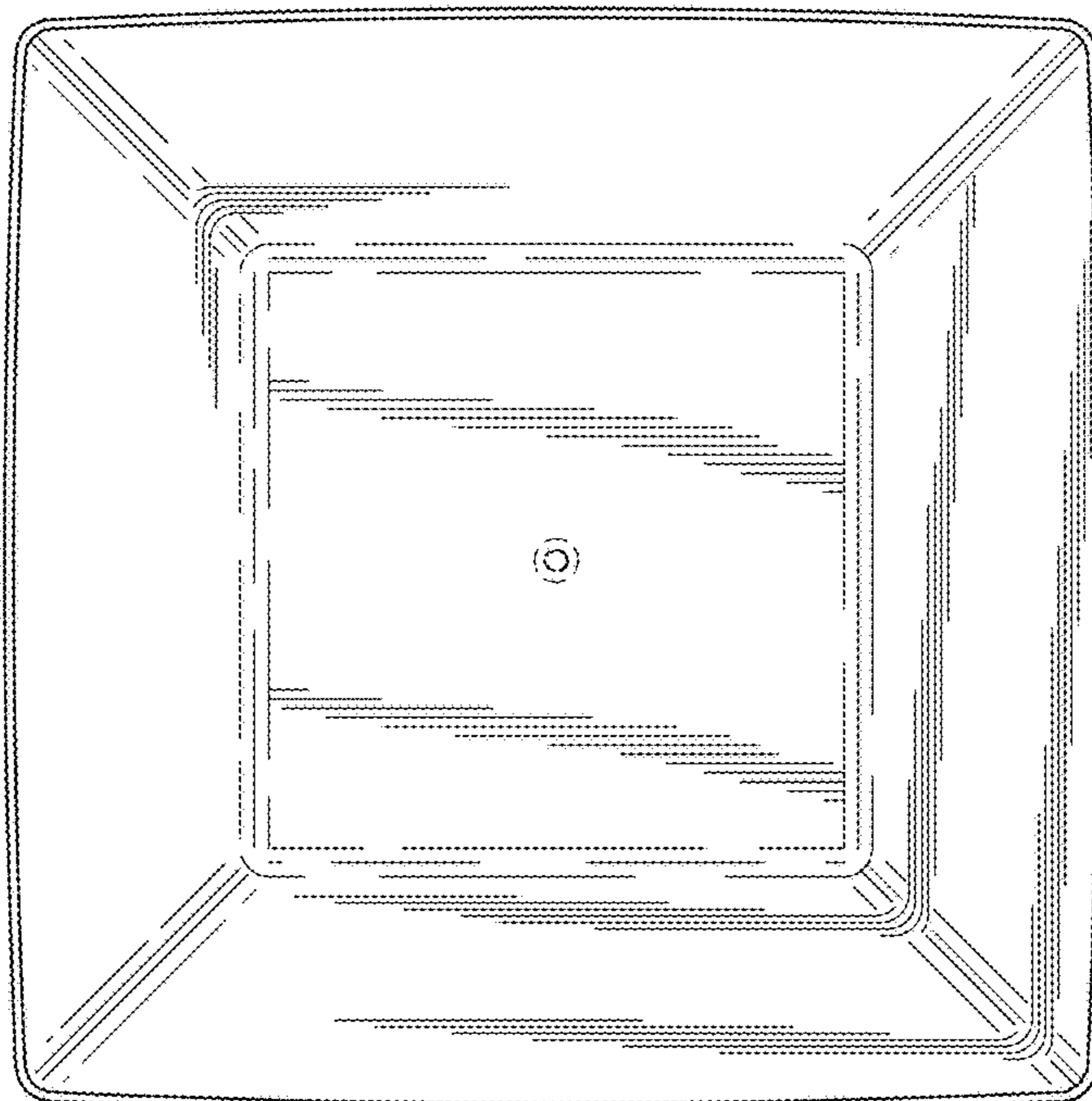




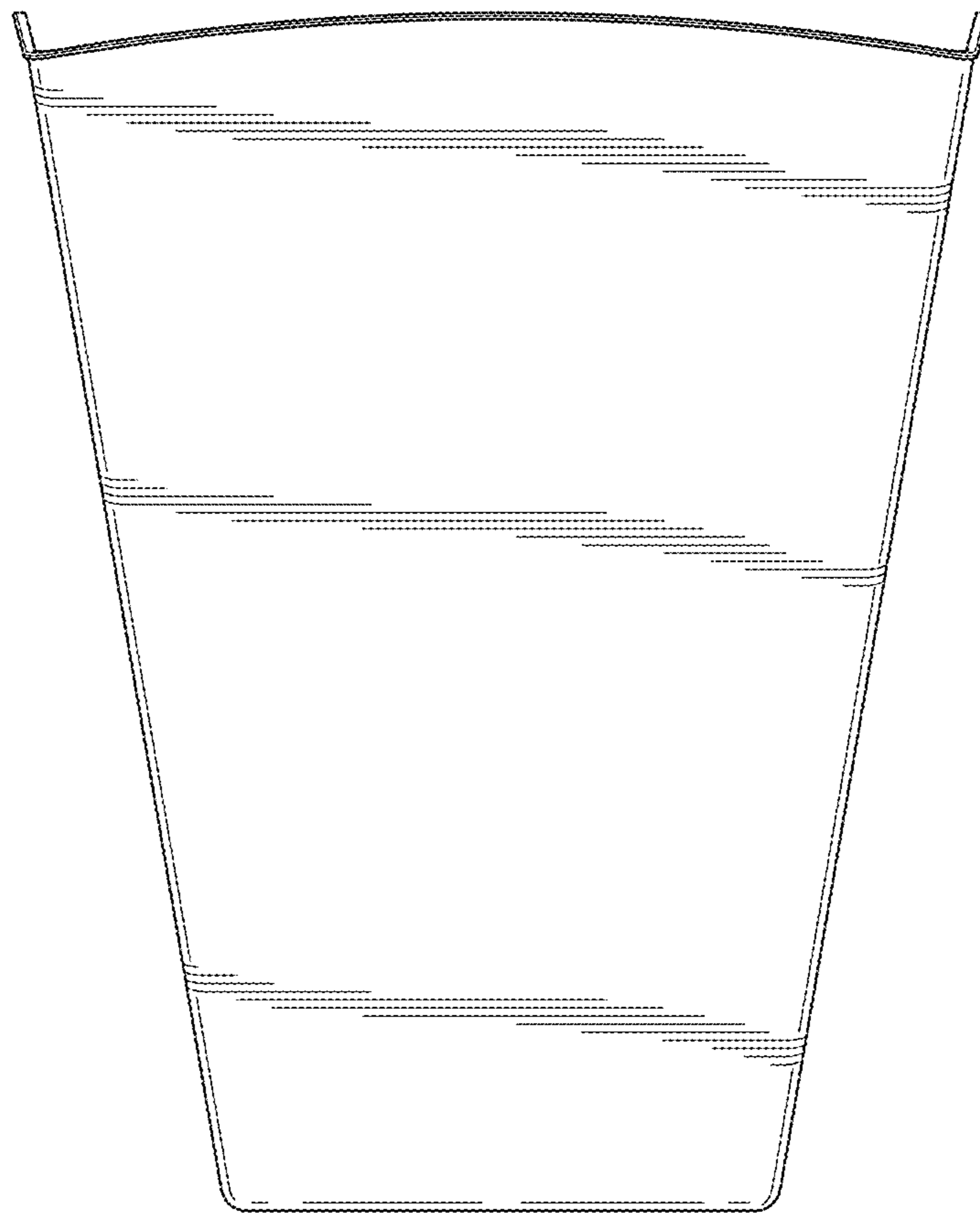
