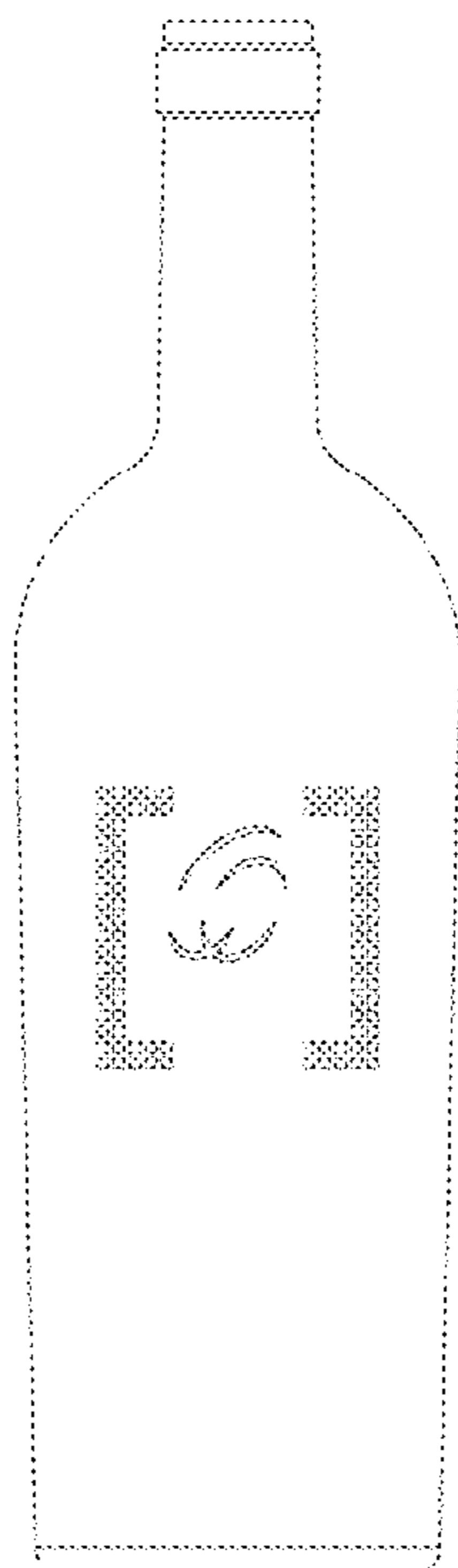

The ornamental design for a bottle, as shown and described.

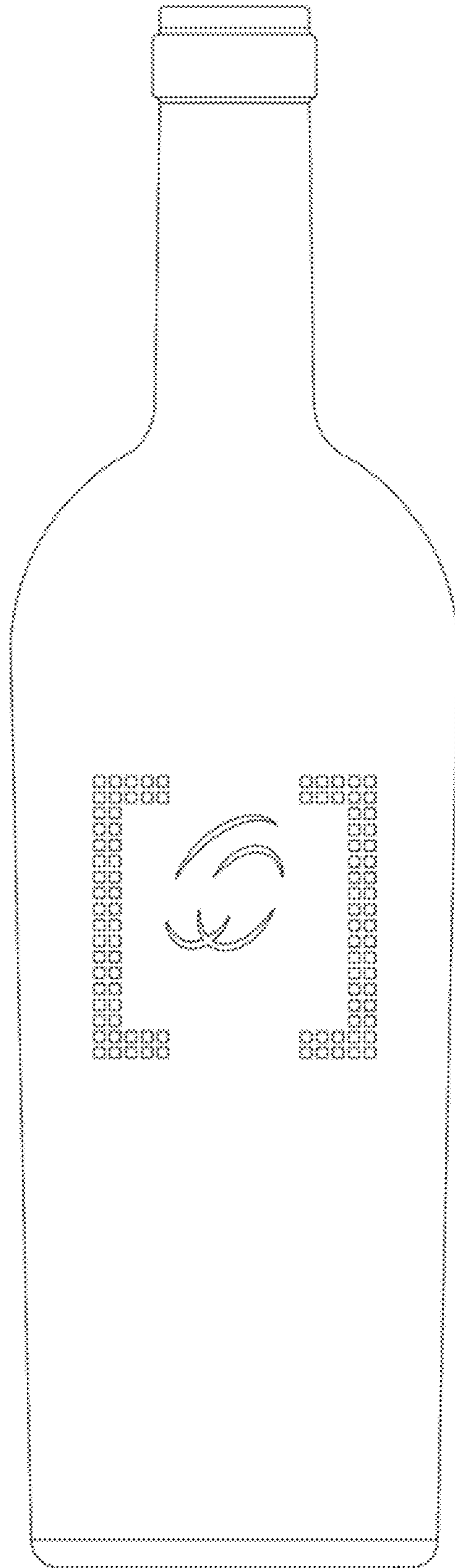
**DESCRIPTION**

- 1.7 is a cross sectional view taken from the center of the top.

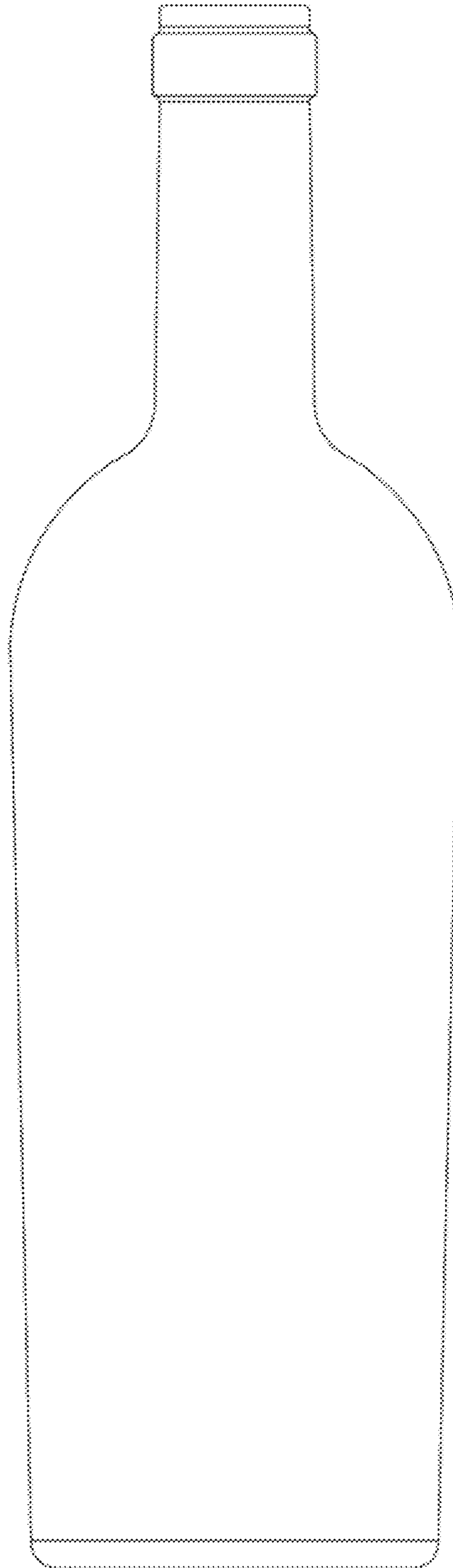

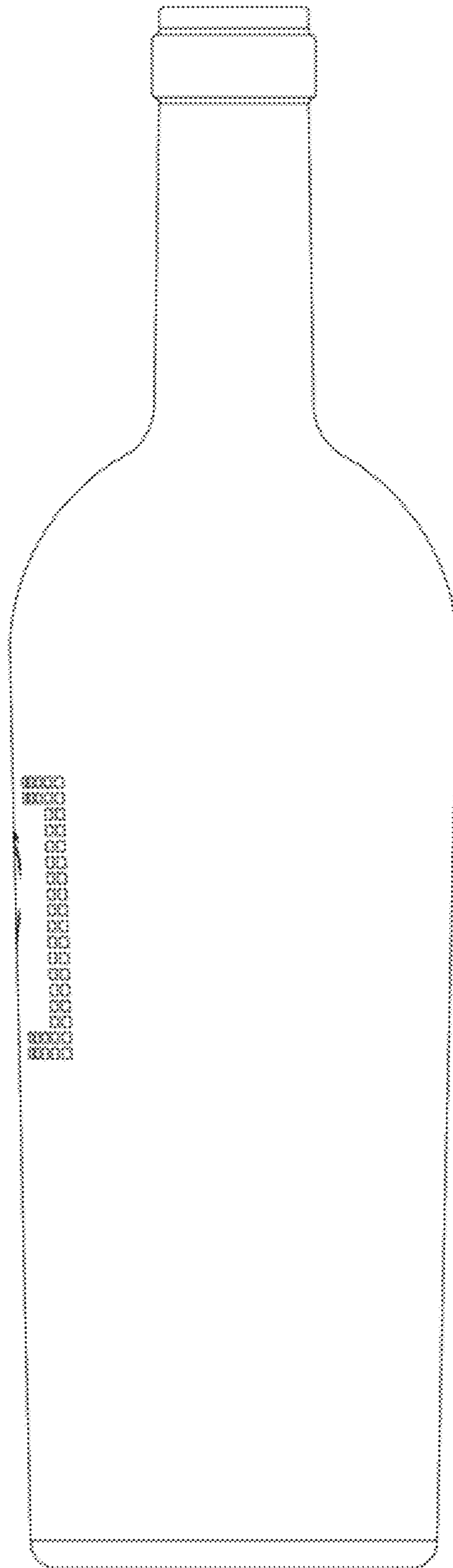

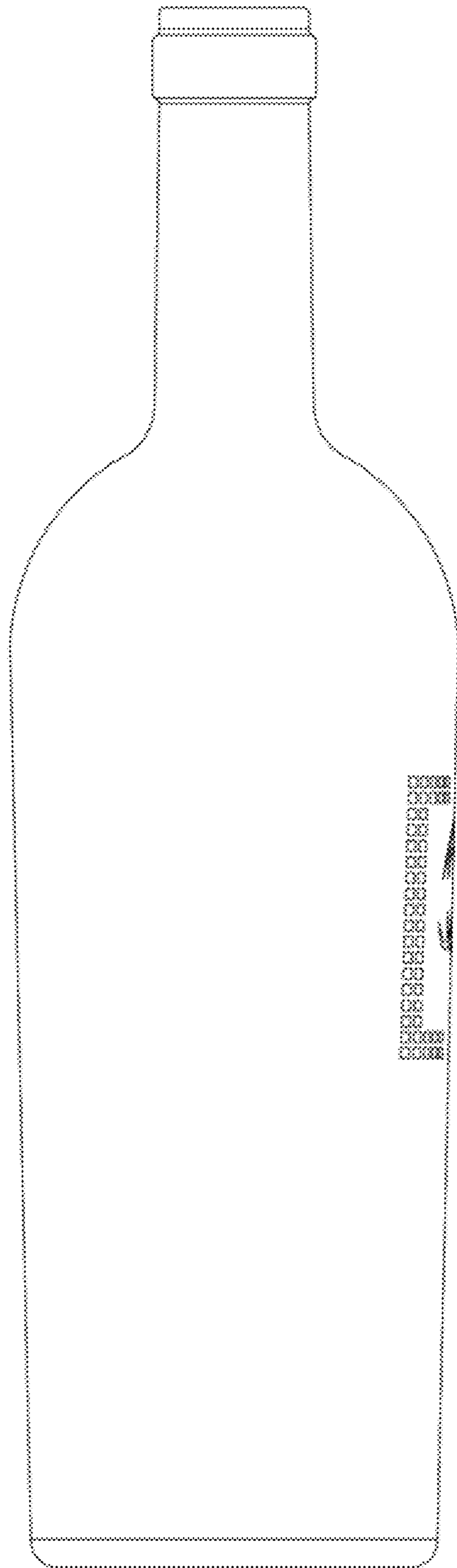

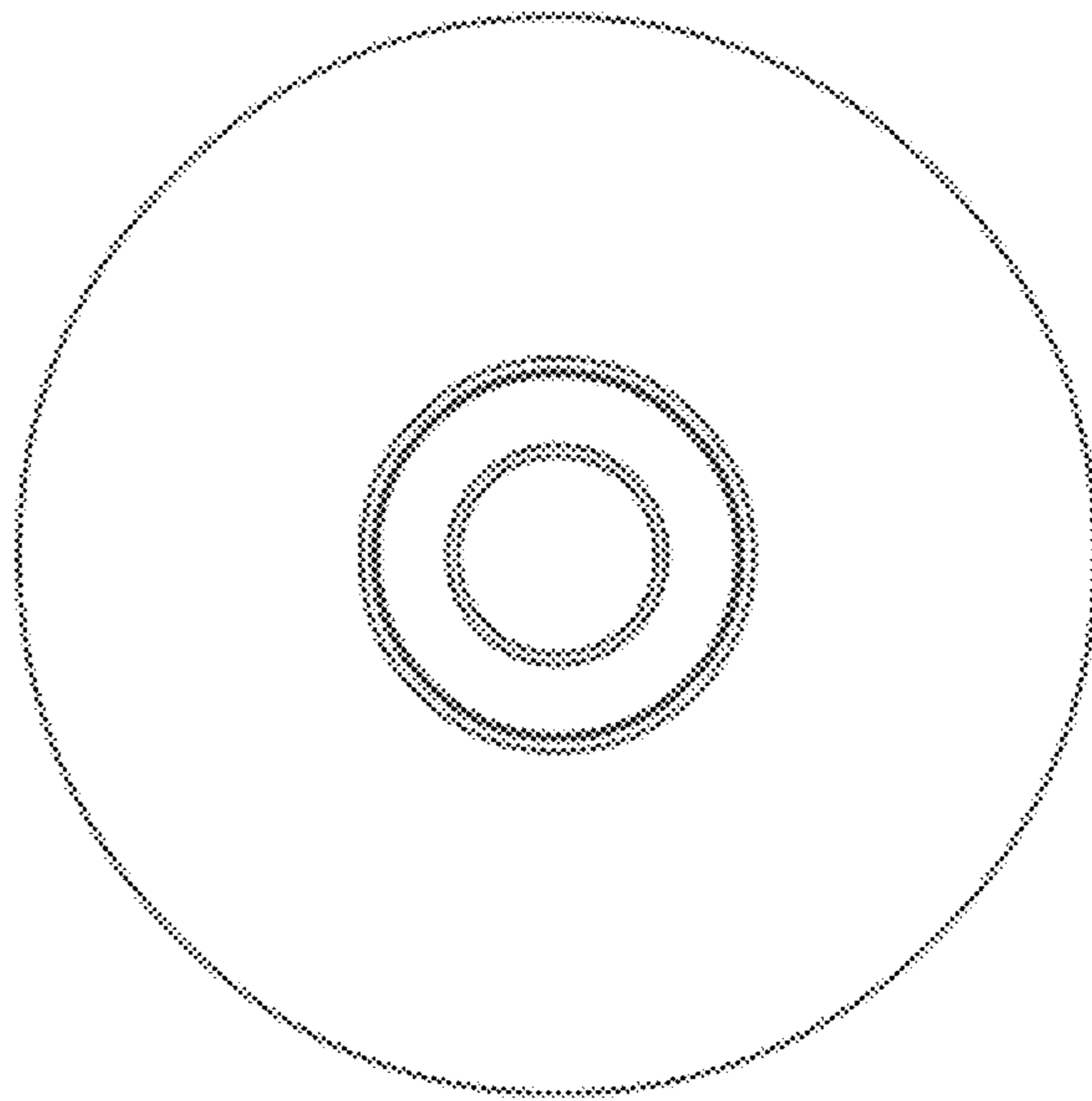

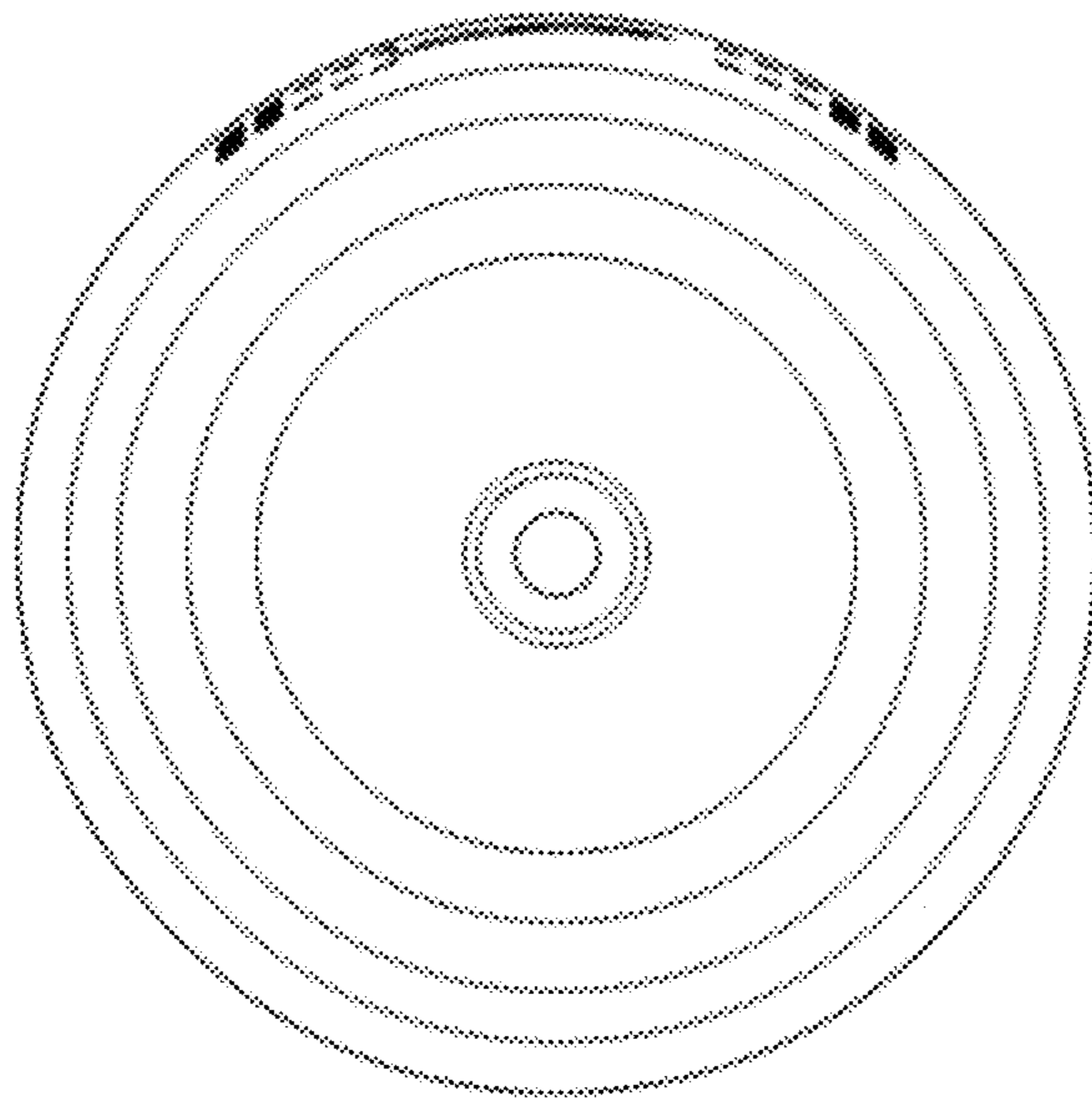
