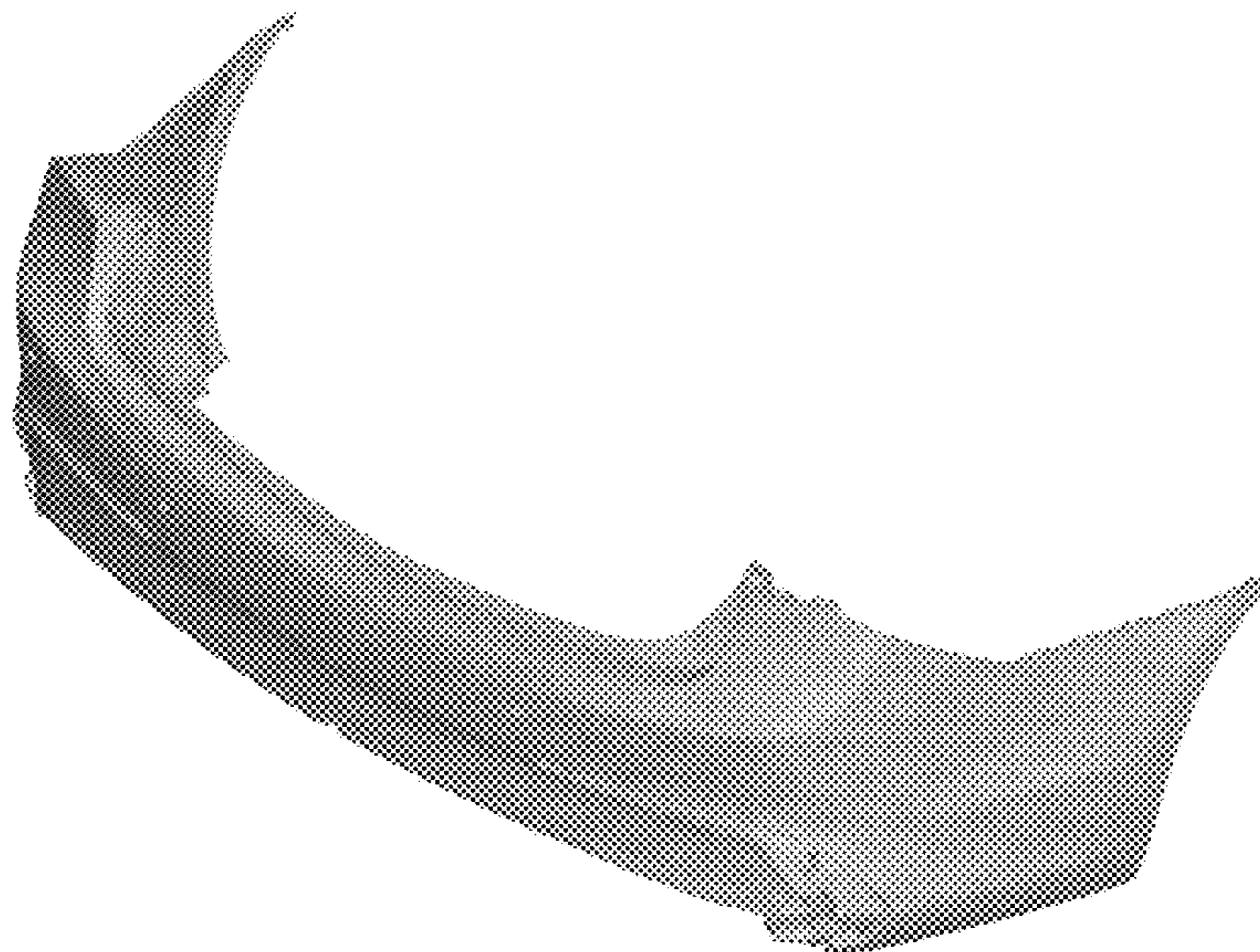
(57) **CLAIM**

The ornamental design for an automobile rear bumper, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and right-side perspective view of an automobile rear bumper showing my new design;
FIG. 2 is a top, front, and left-side perspective view thereof;
FIG. 3 is a top, rear, and left-side perspective view thereof;

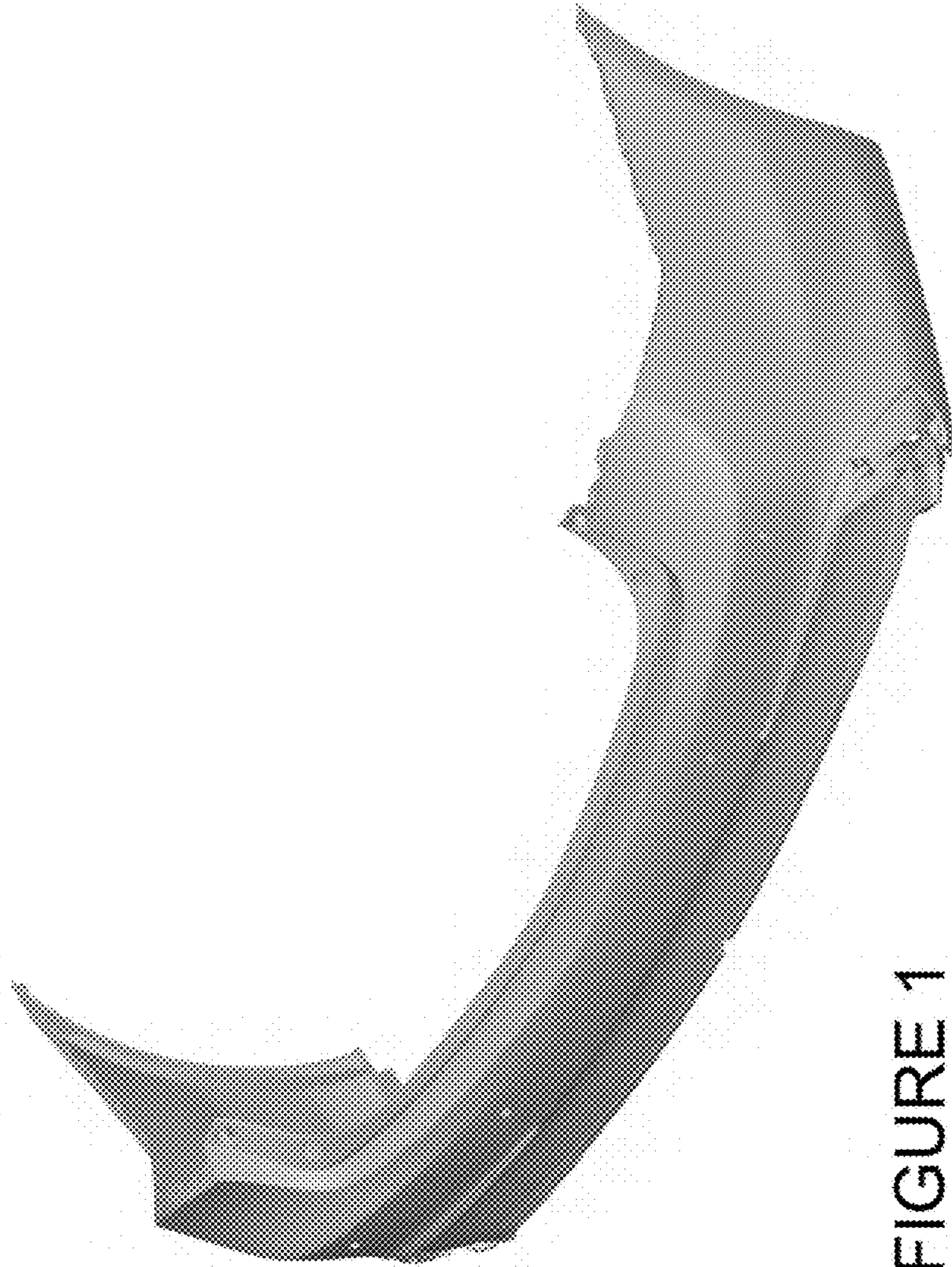

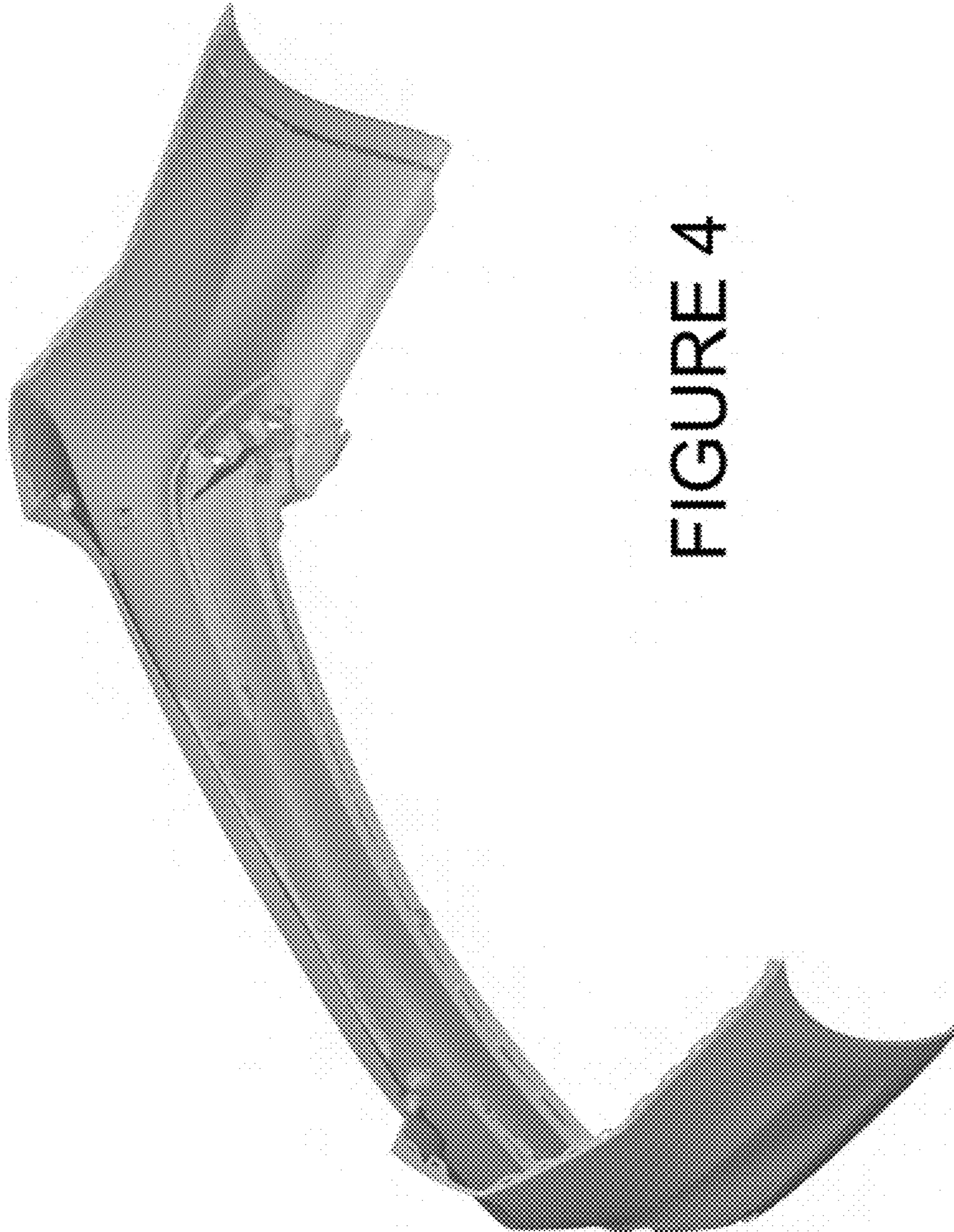

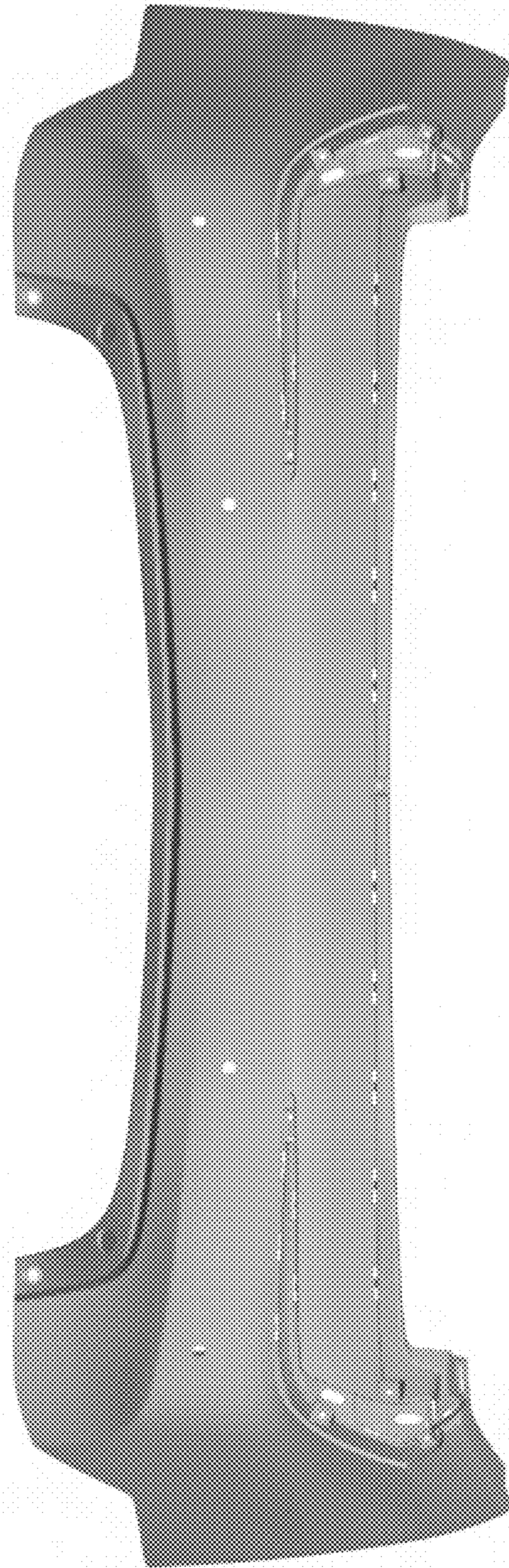

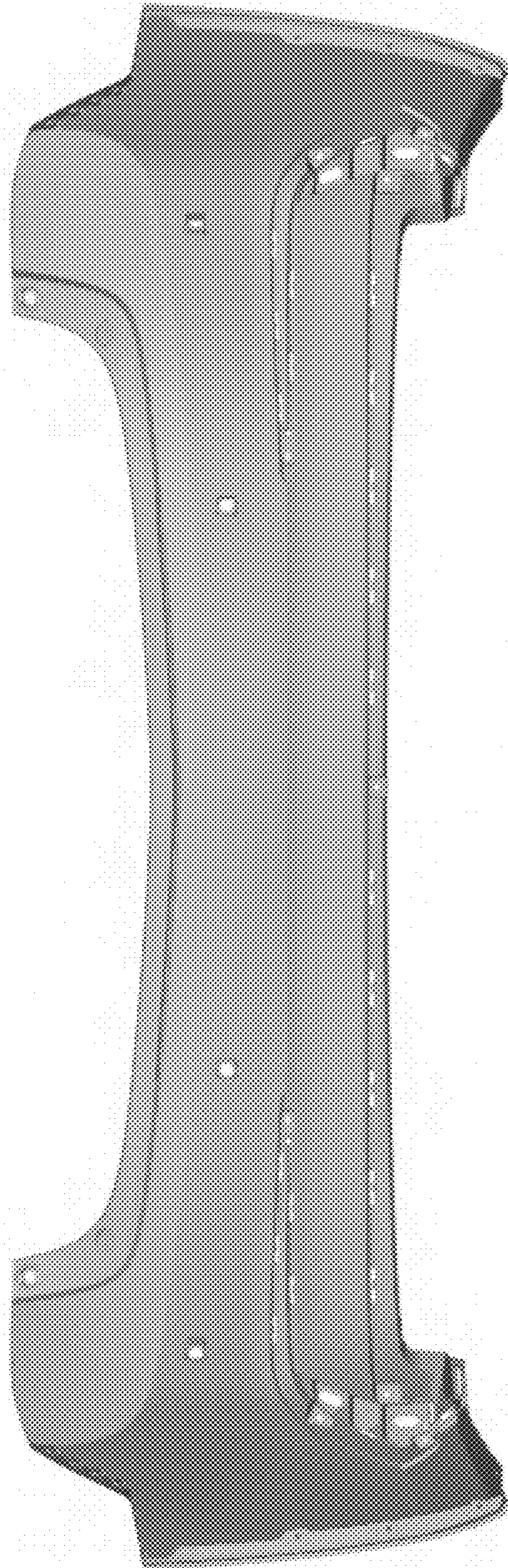

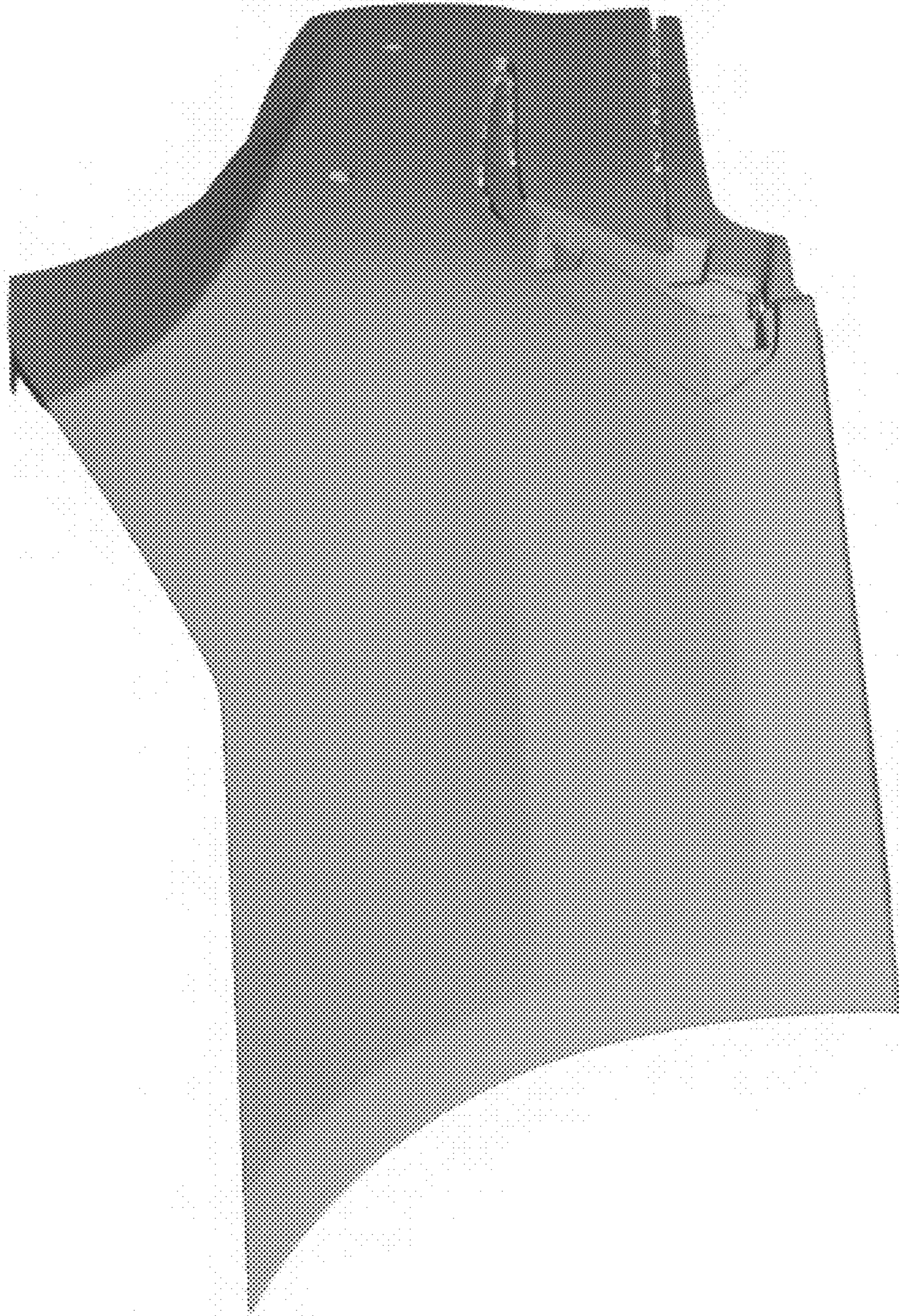

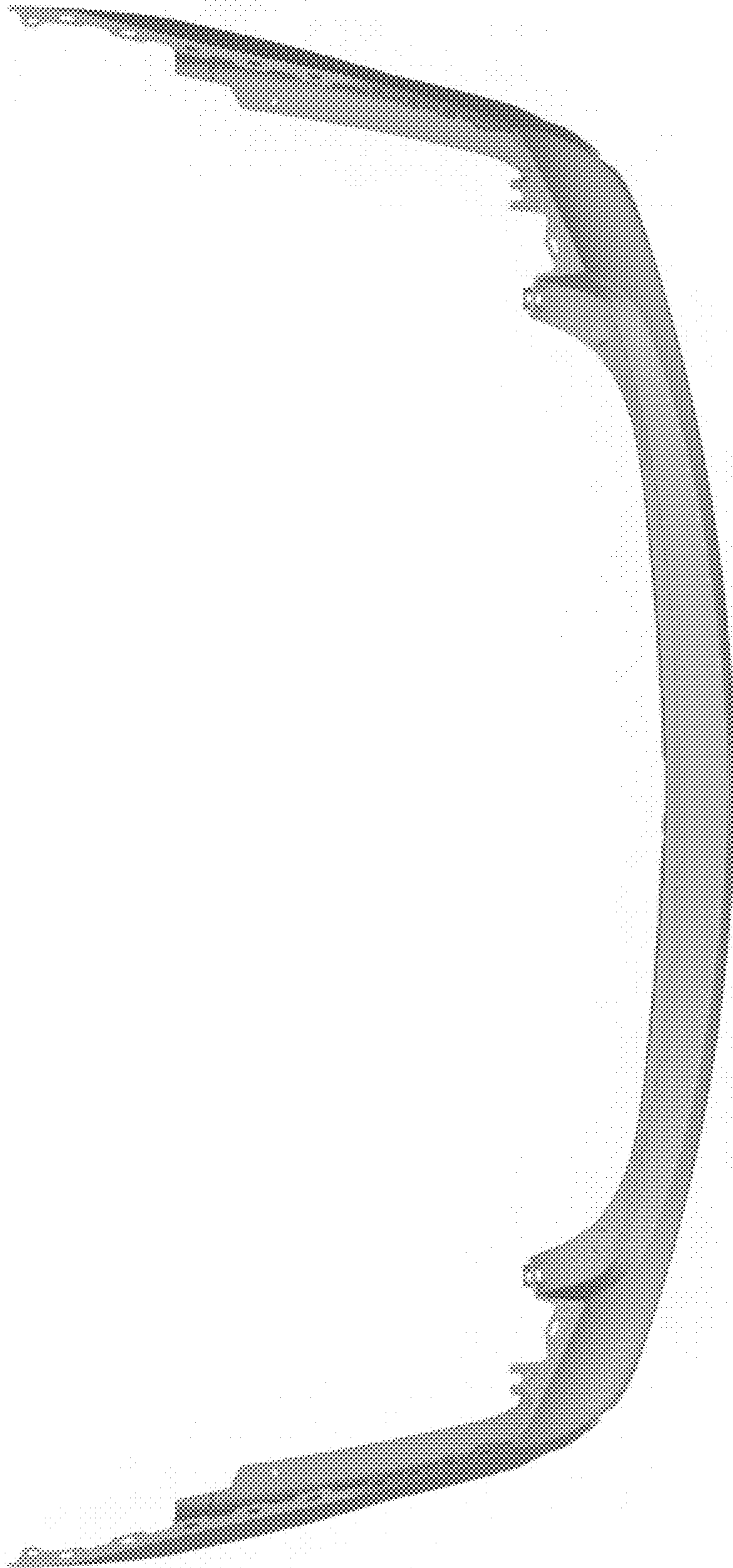

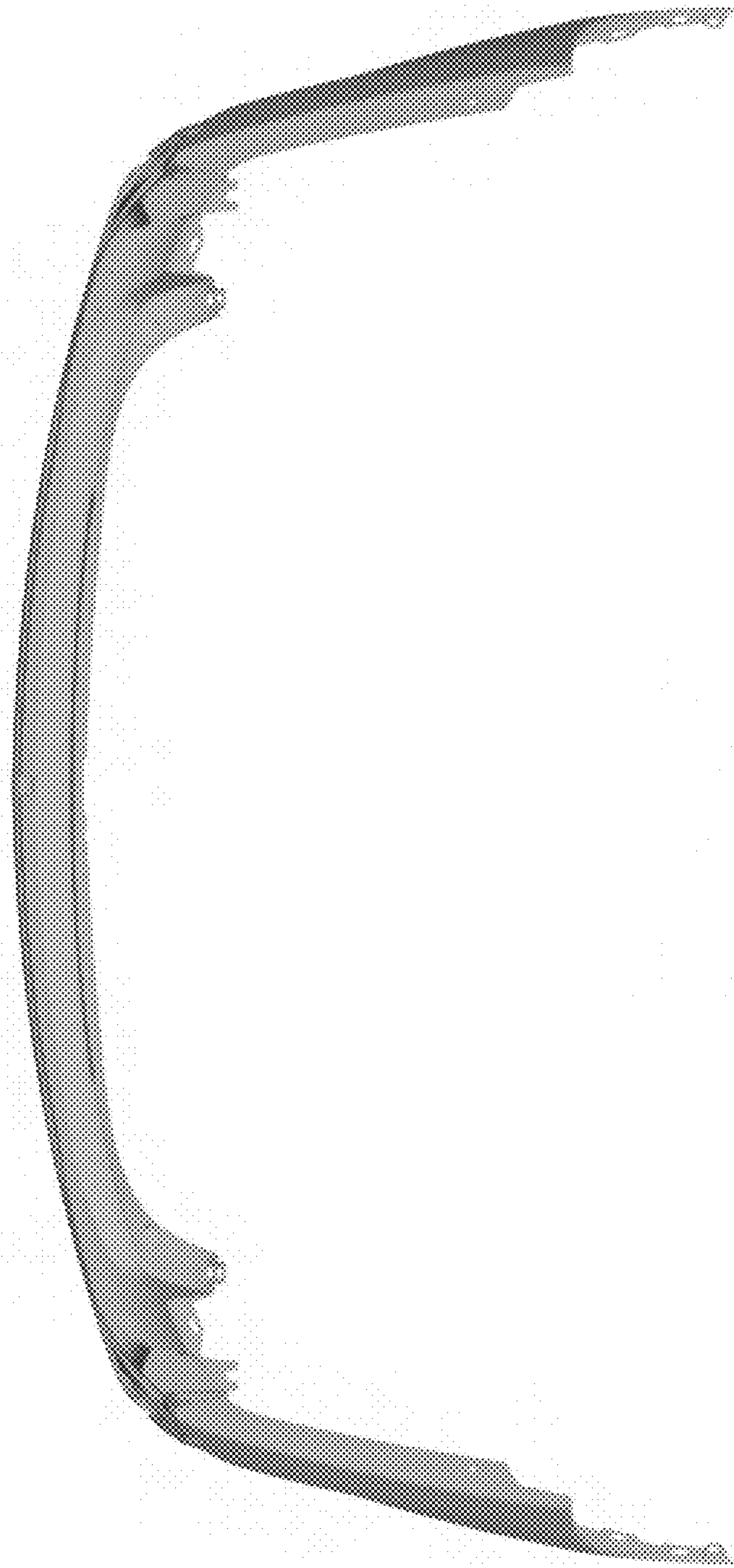
