(57) **CLAIM**

We claim the ornamental design for a display screen or portion thereof with transitional graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with transitional graphical user interface showing our new design in a first state;

FIG. 2 is a front view thereof shown in a second state; and, FIG. 3 is a front view thereof shown in a third state.

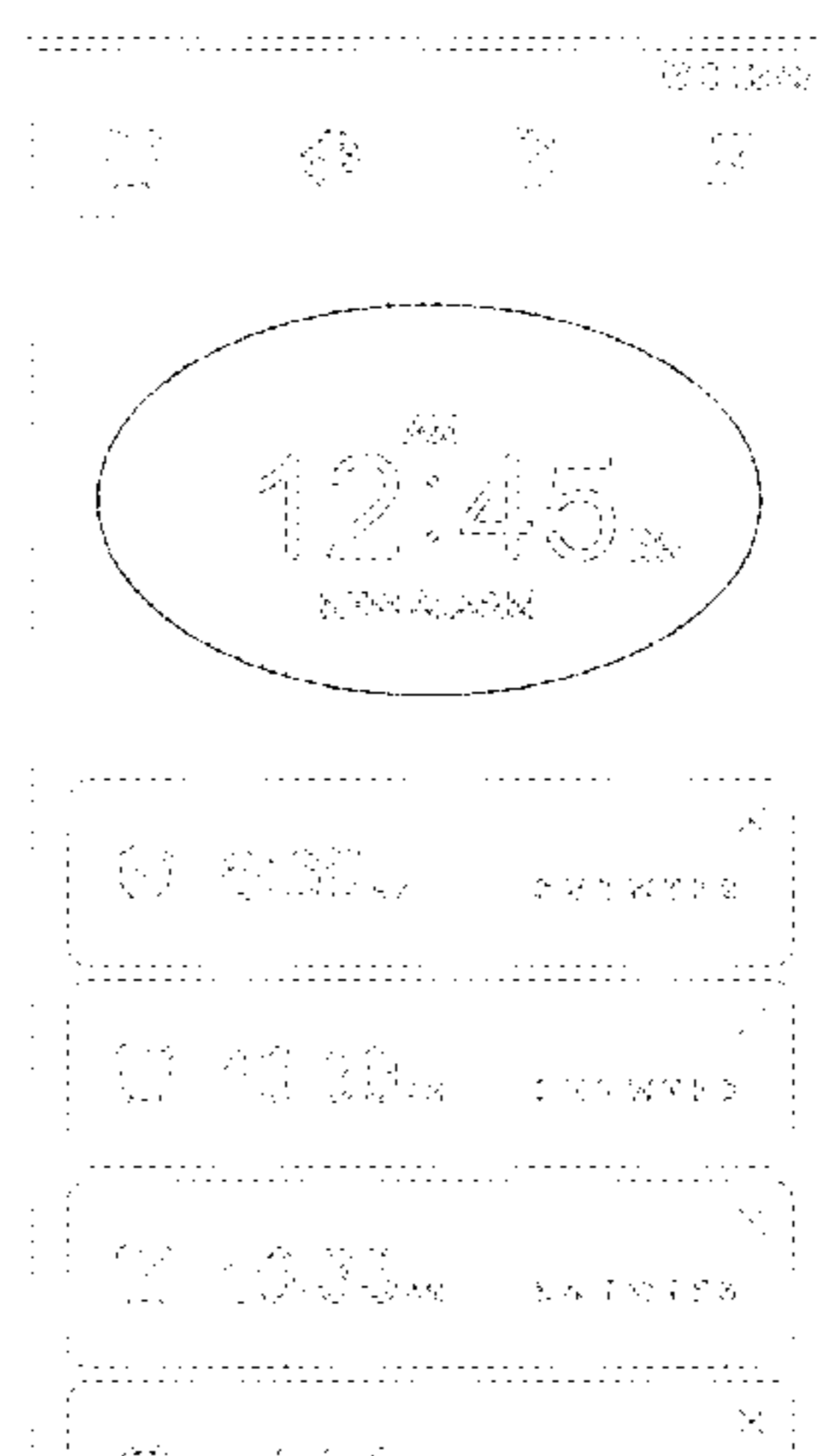
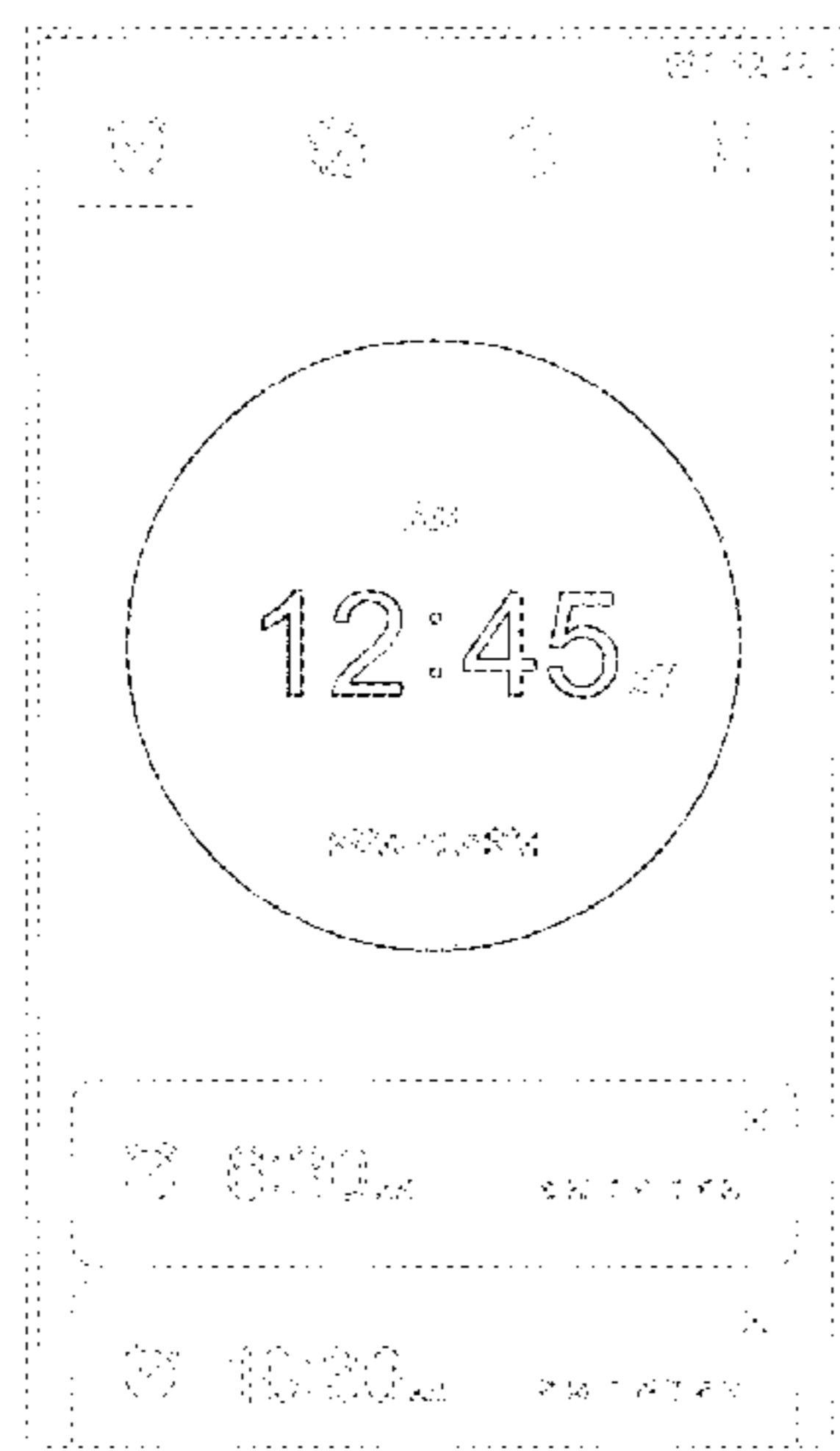
The numbers (12:45) shown in light gray solid lines in FIG. 2 form part of the claimed design.

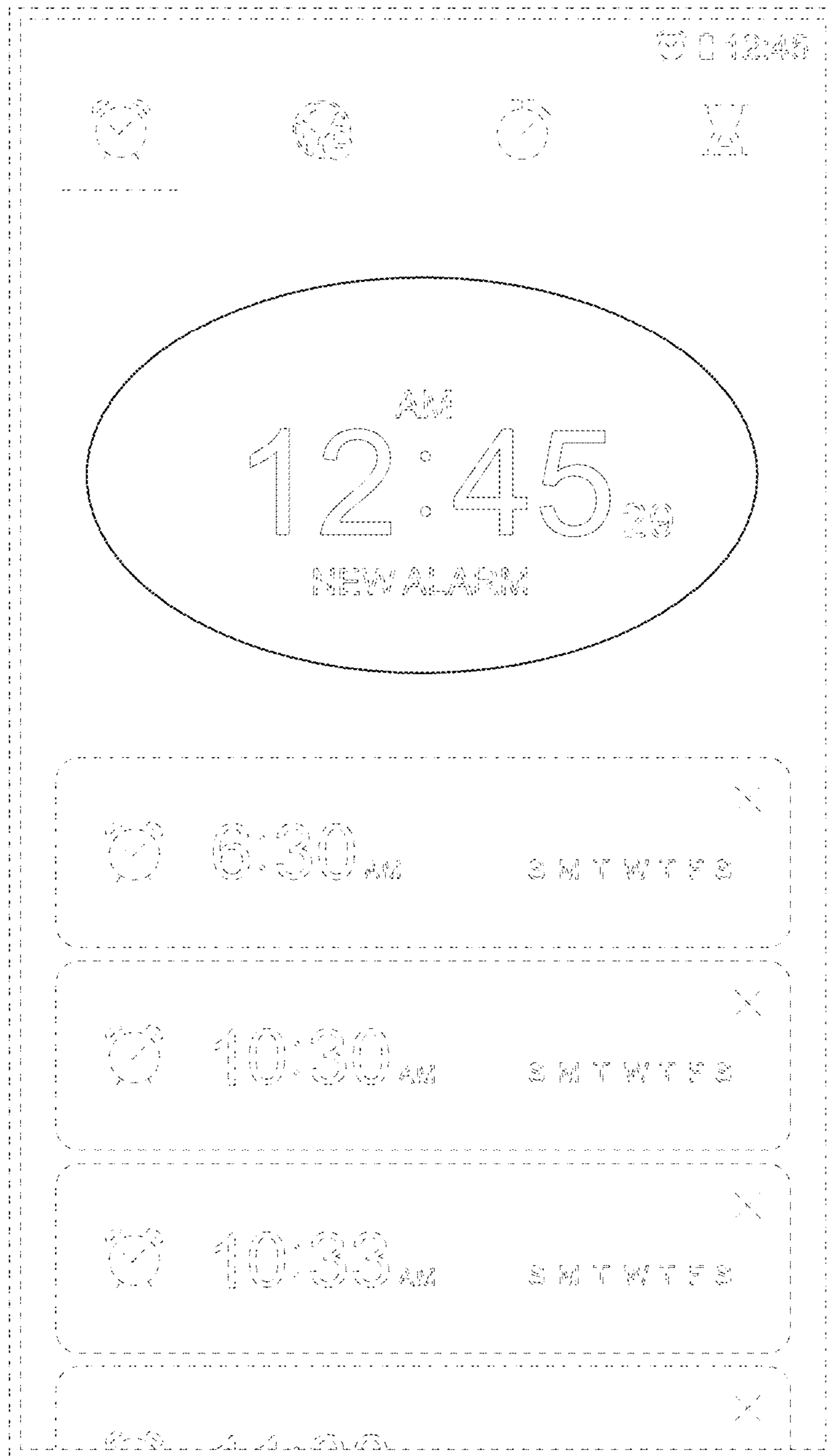
