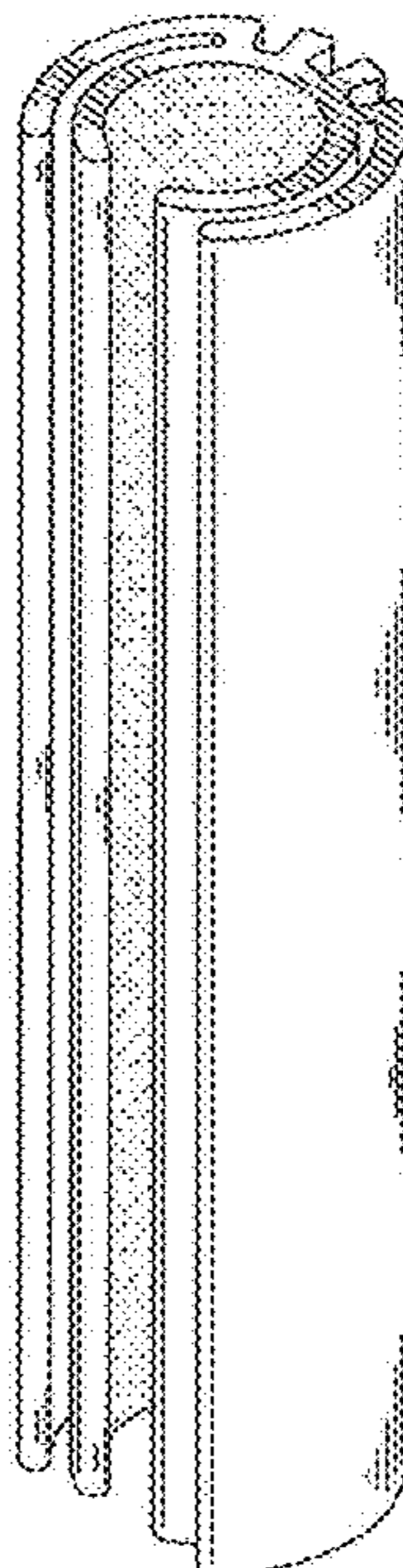
(57) **CLAIM**

The ornamental design for a sanding apparatus for billiard cue sticks, as shown and described.

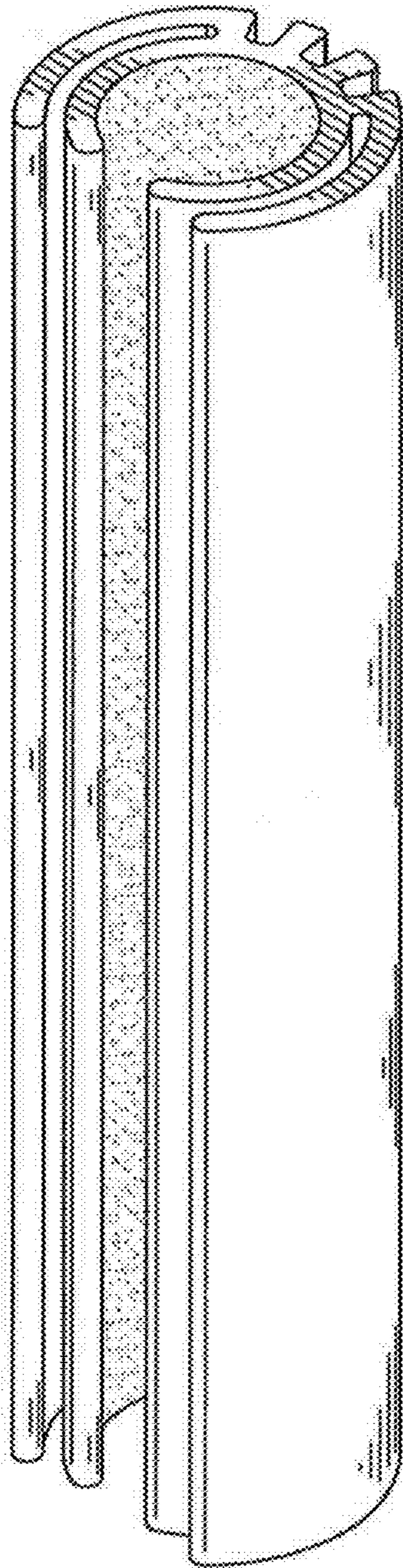

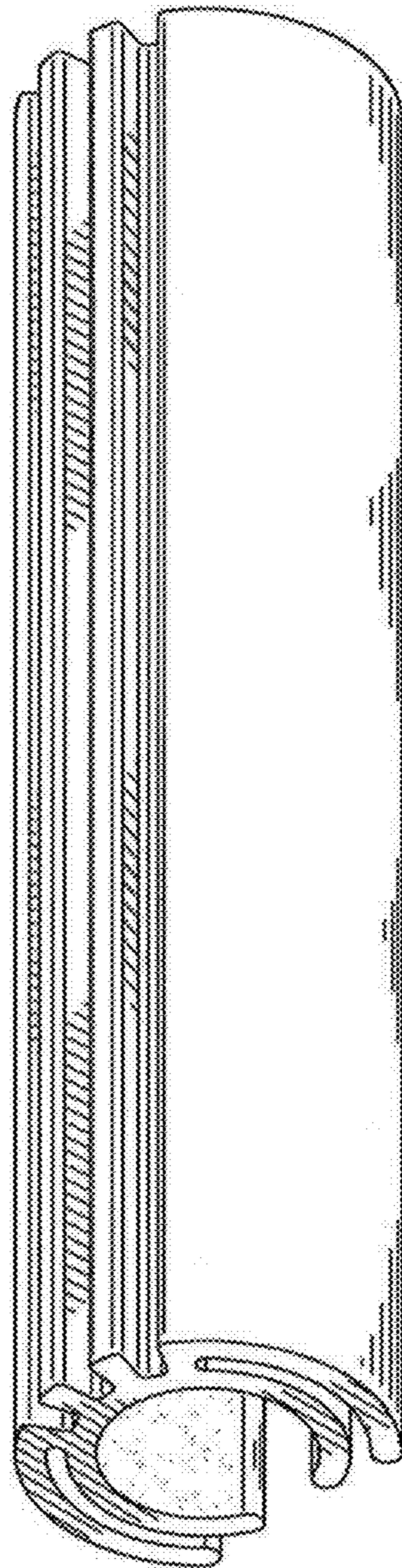

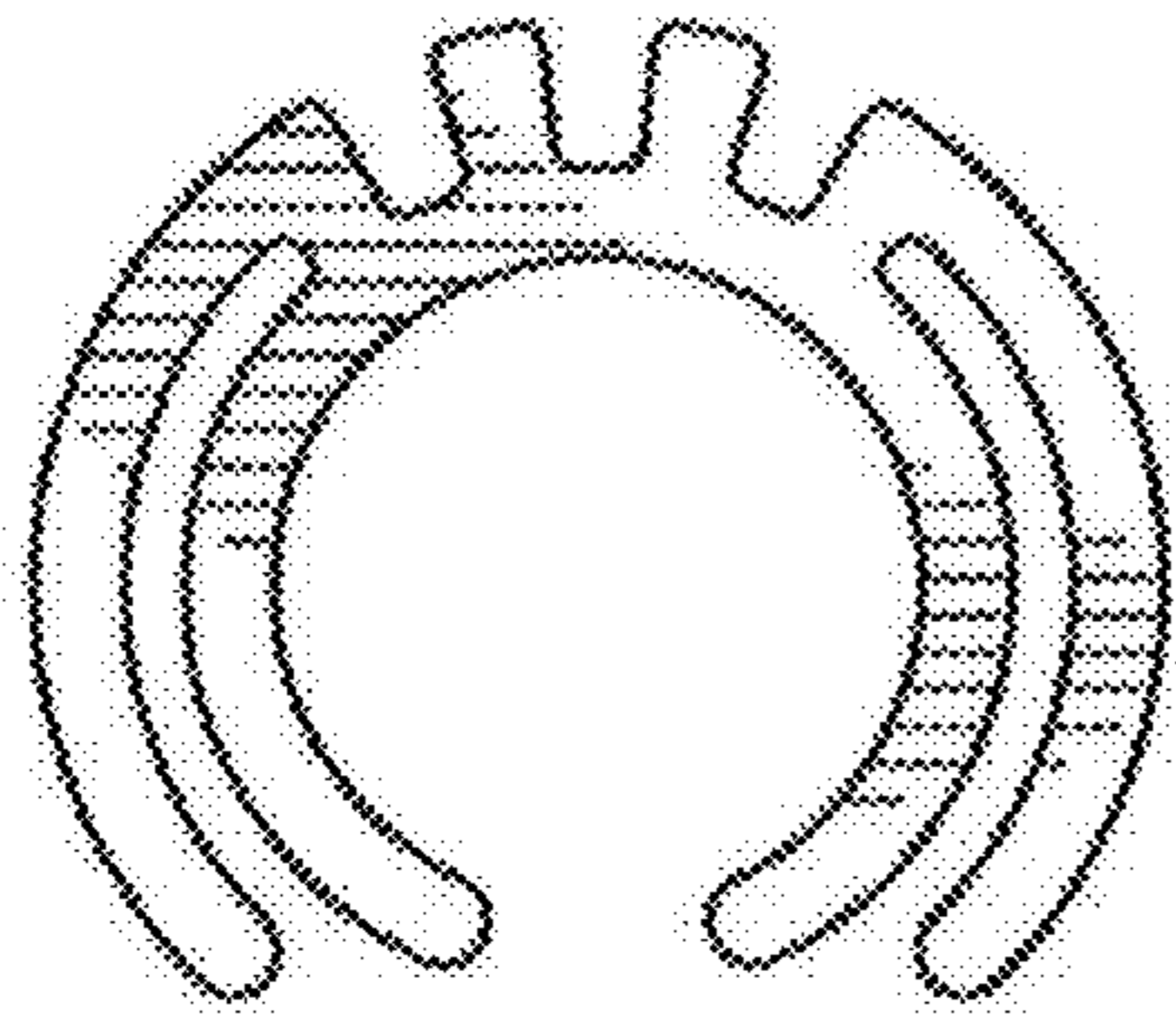

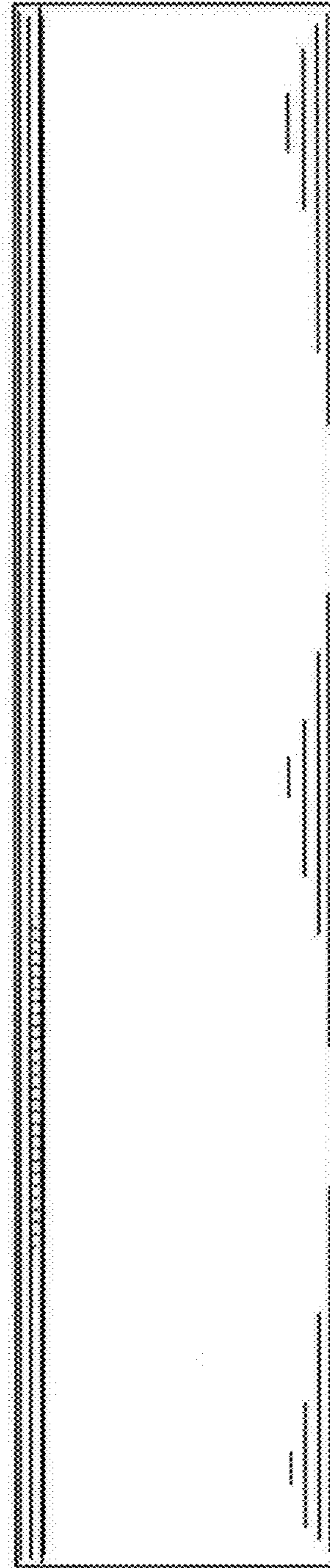

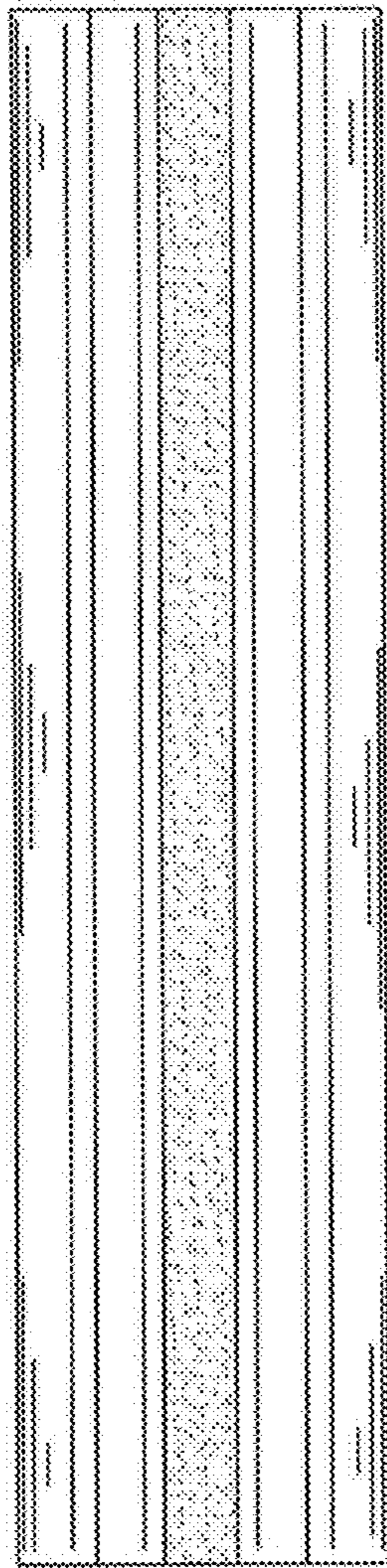

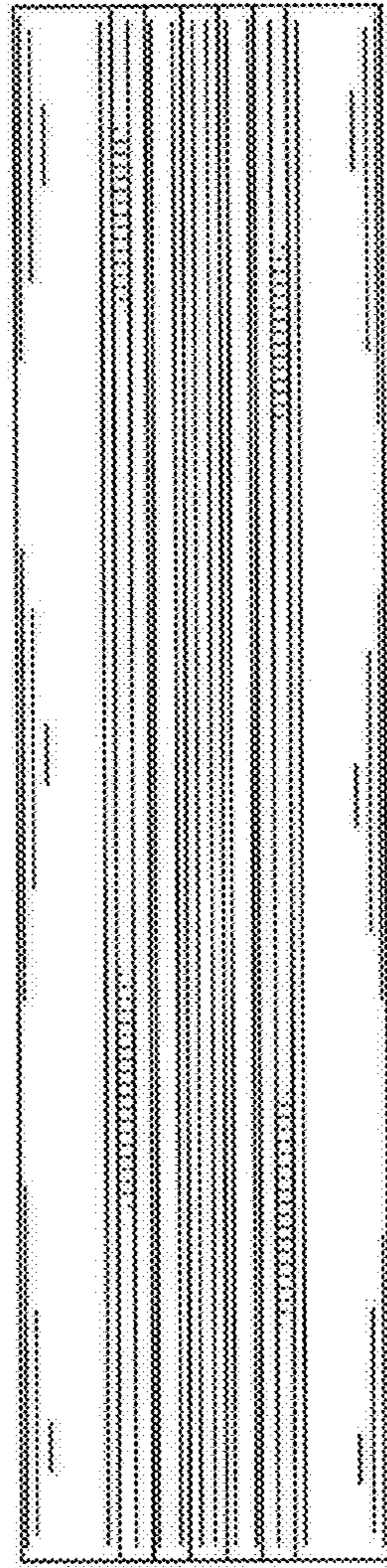
