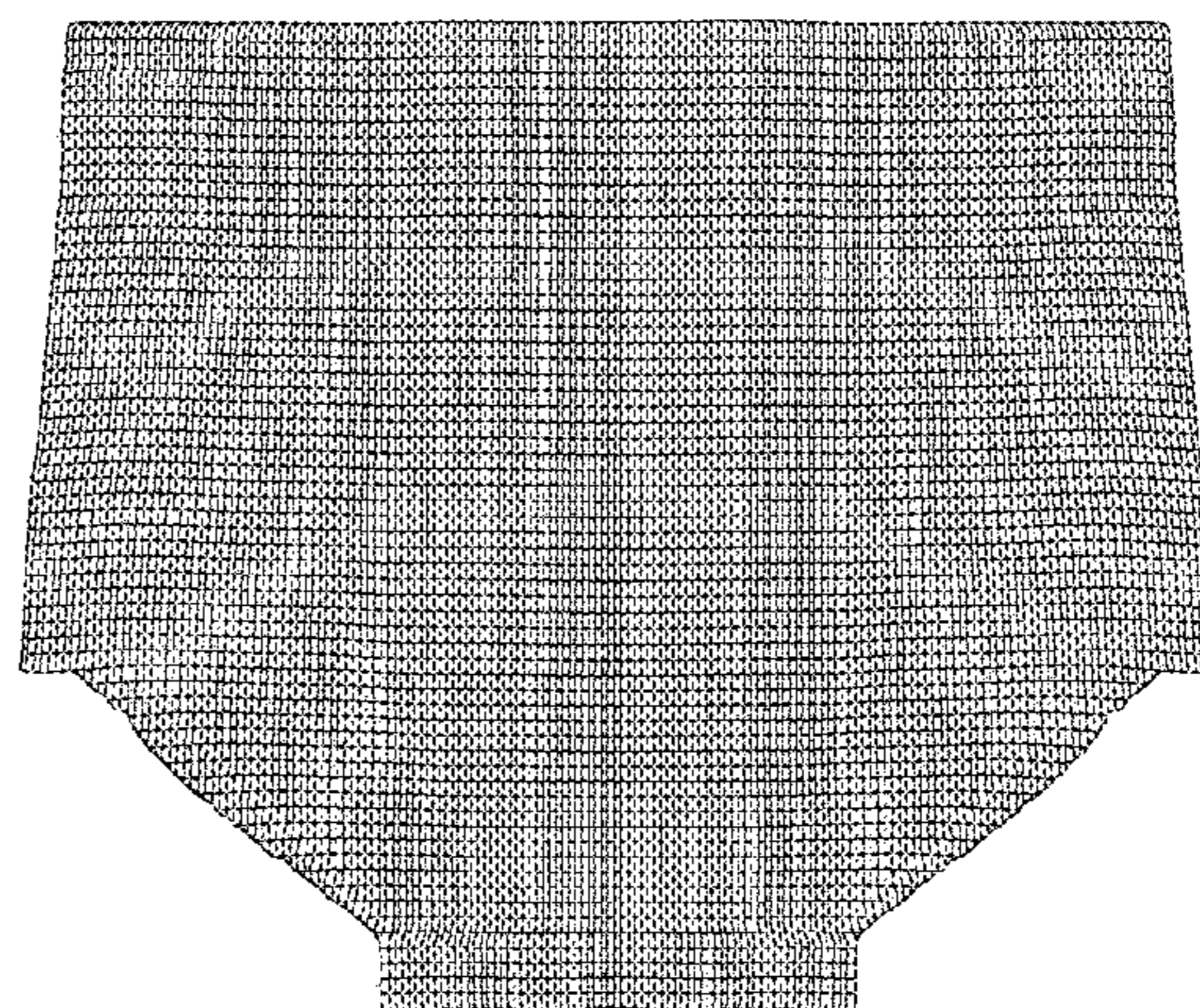
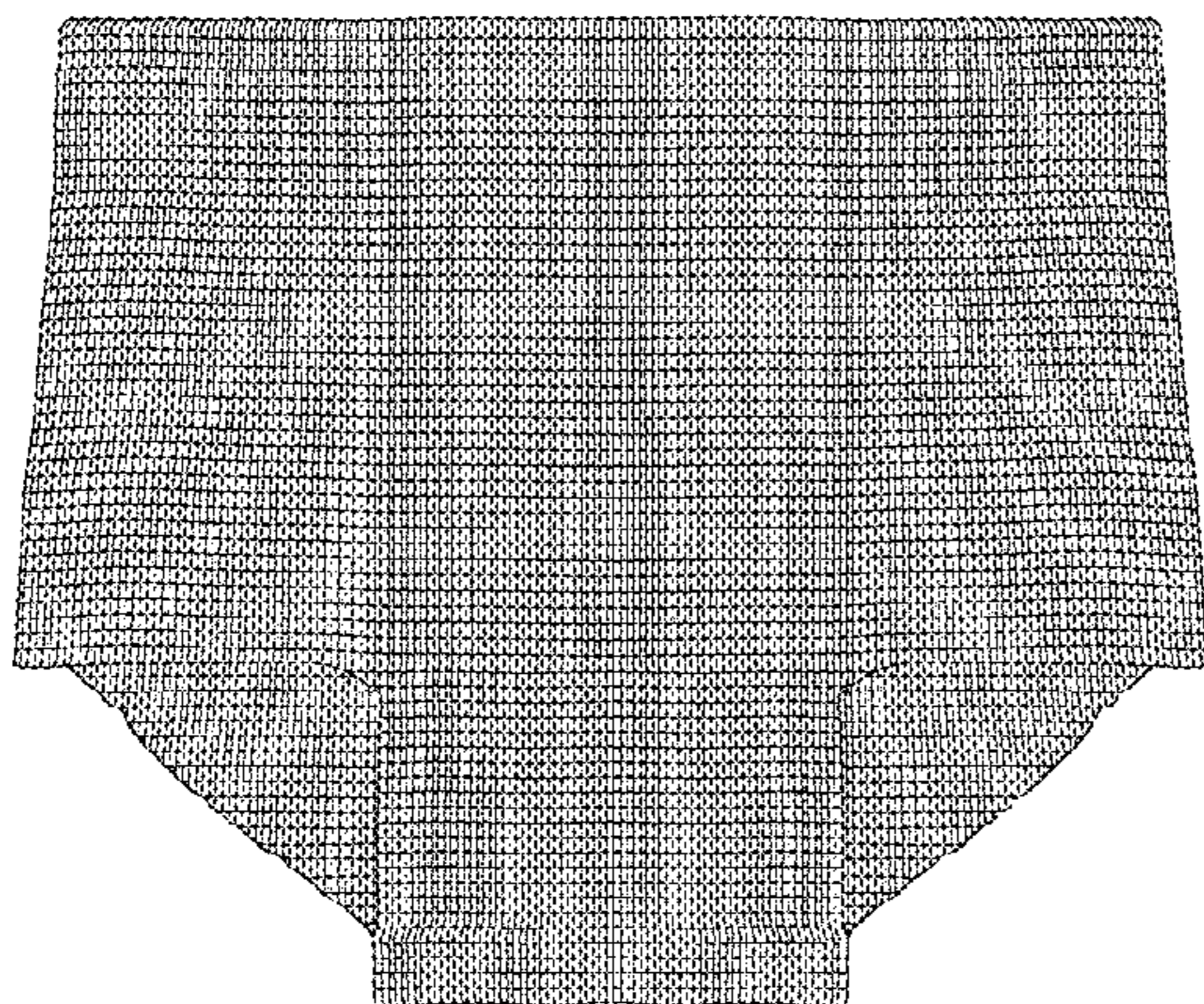
The ornamental design for disposable pants, as shown and described.

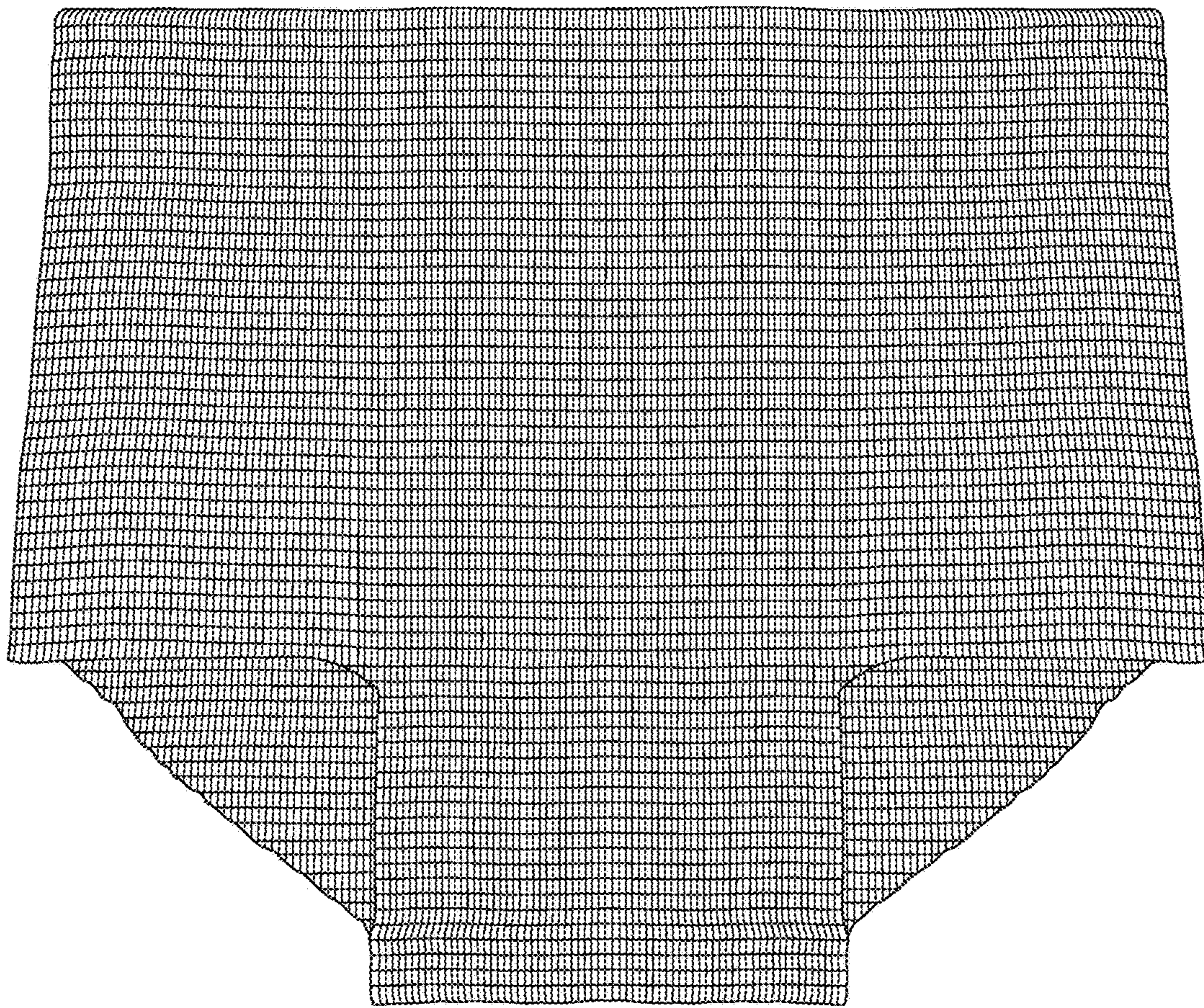

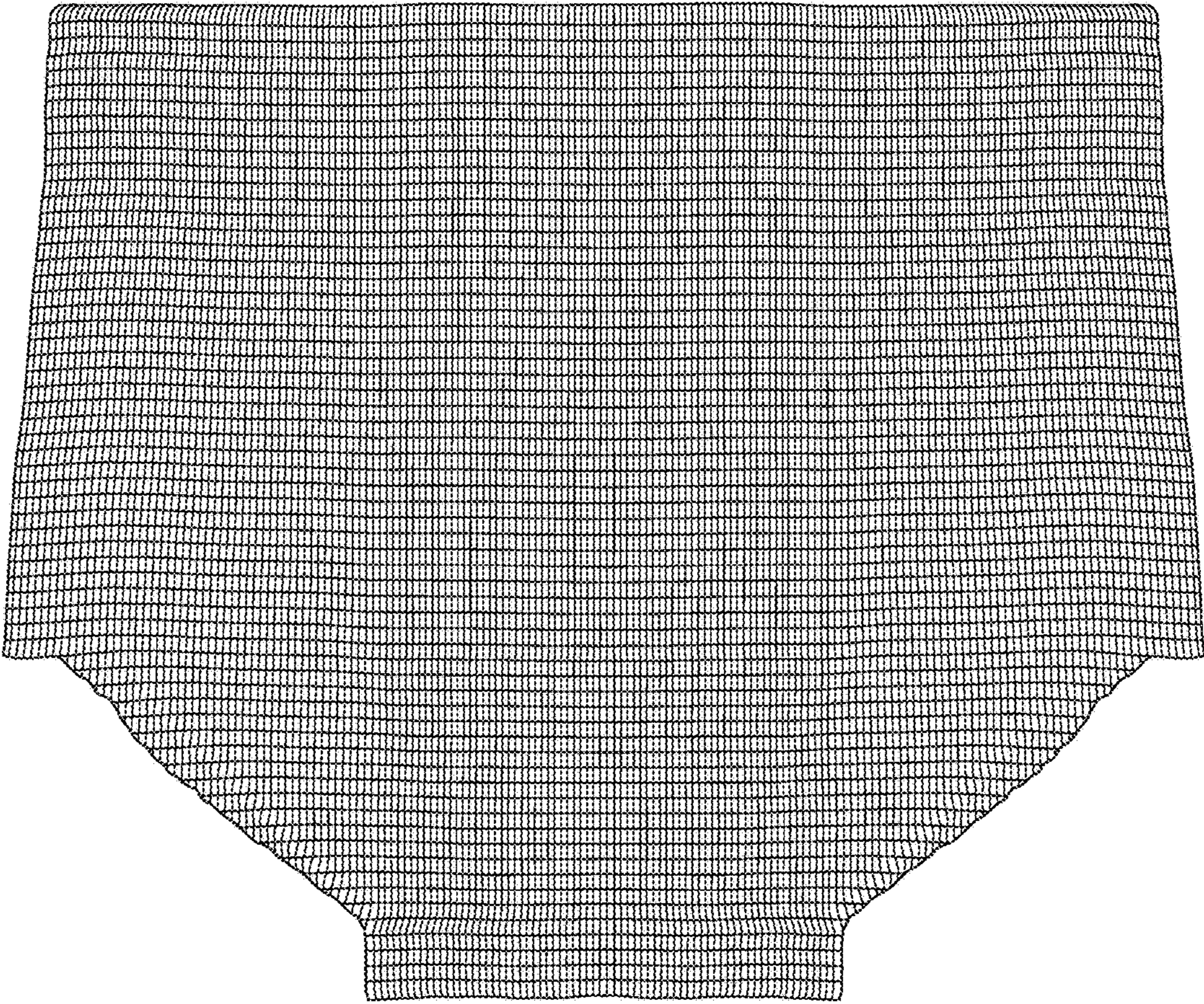

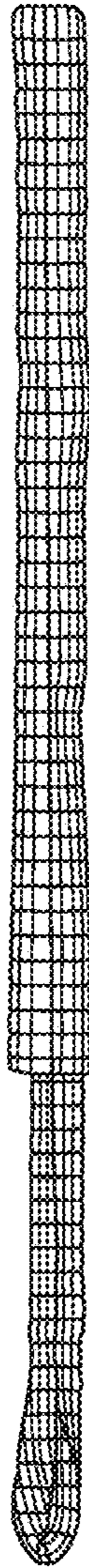

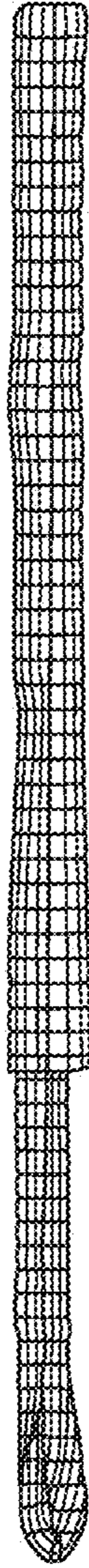

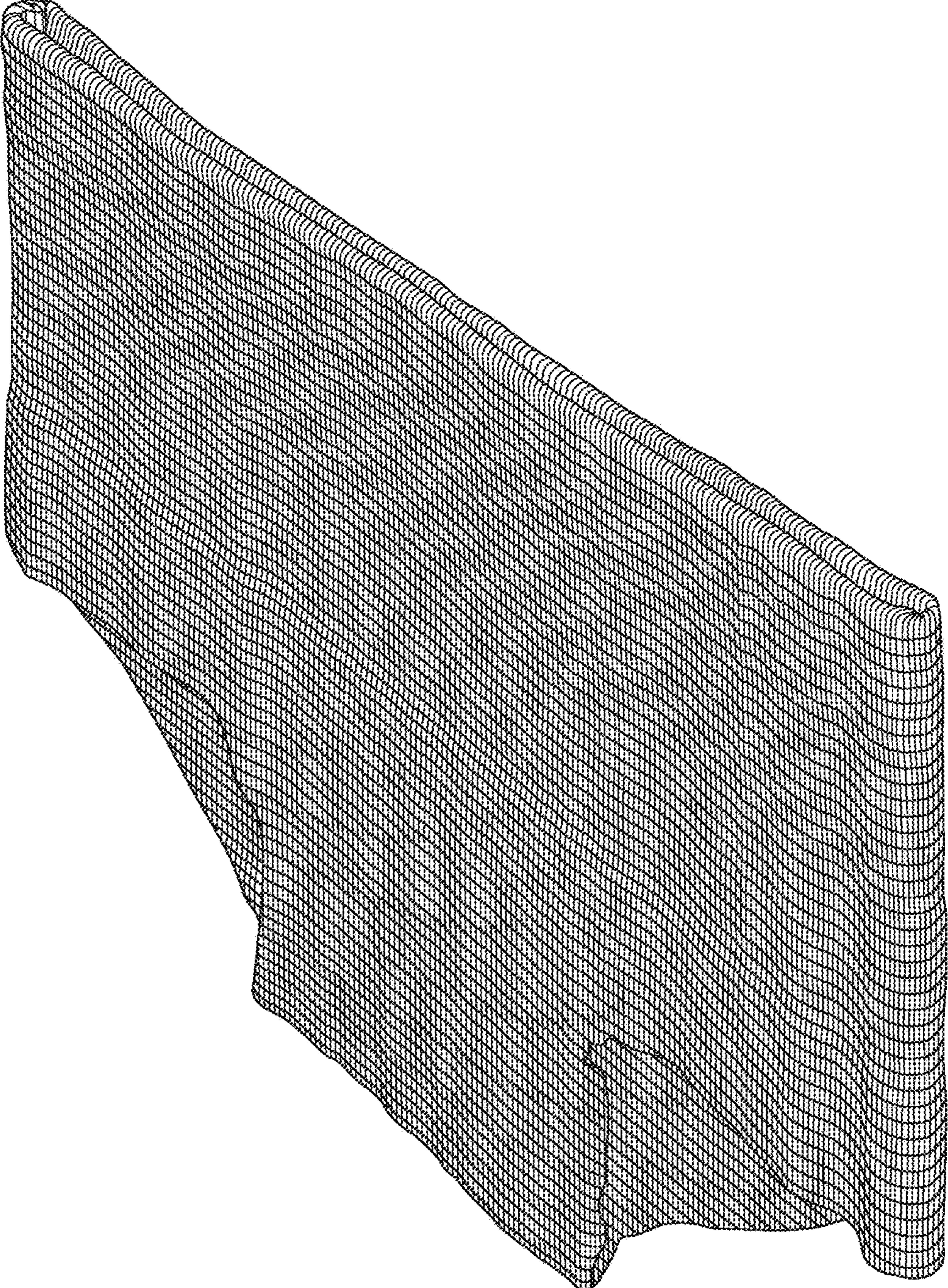

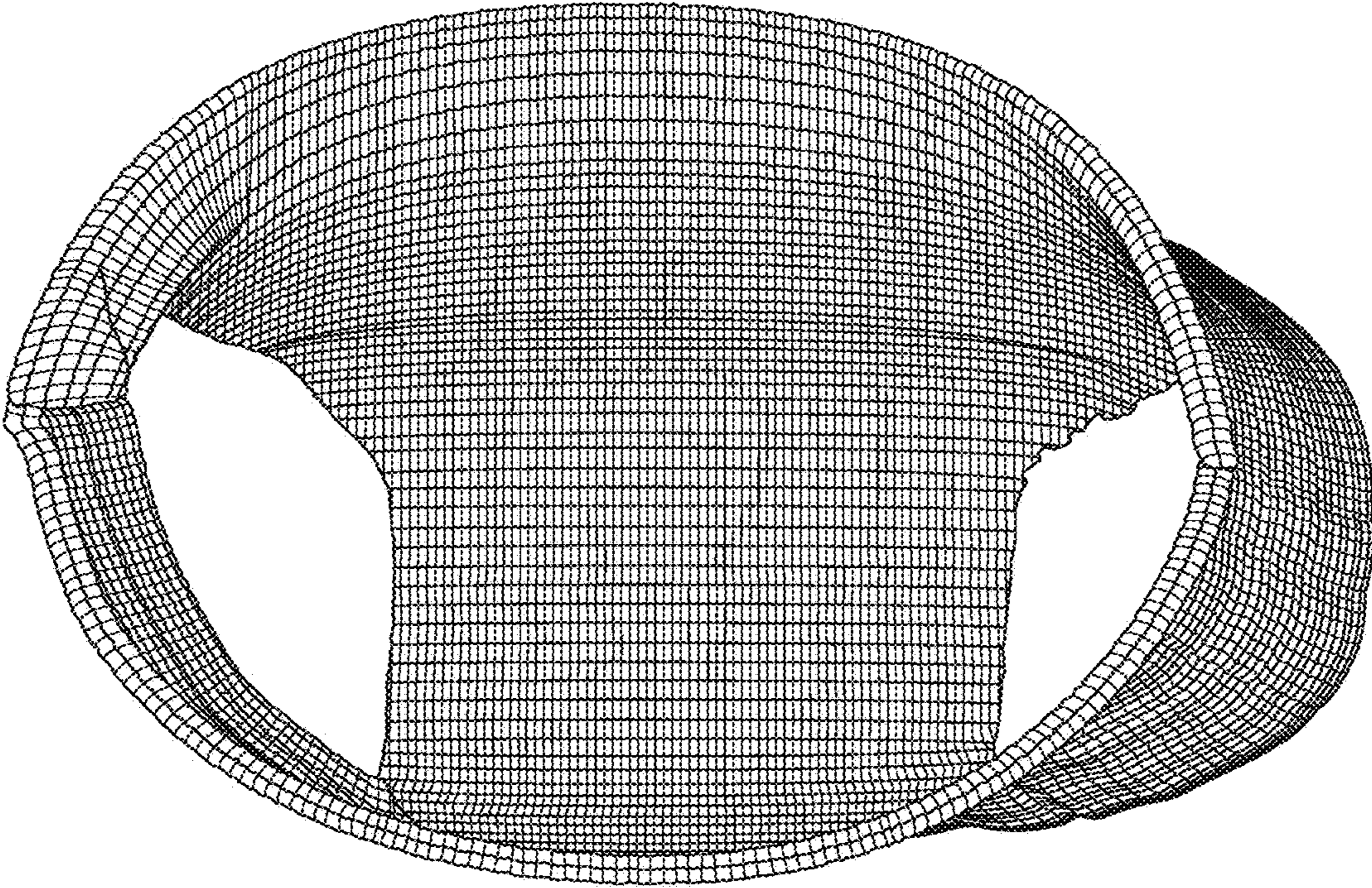

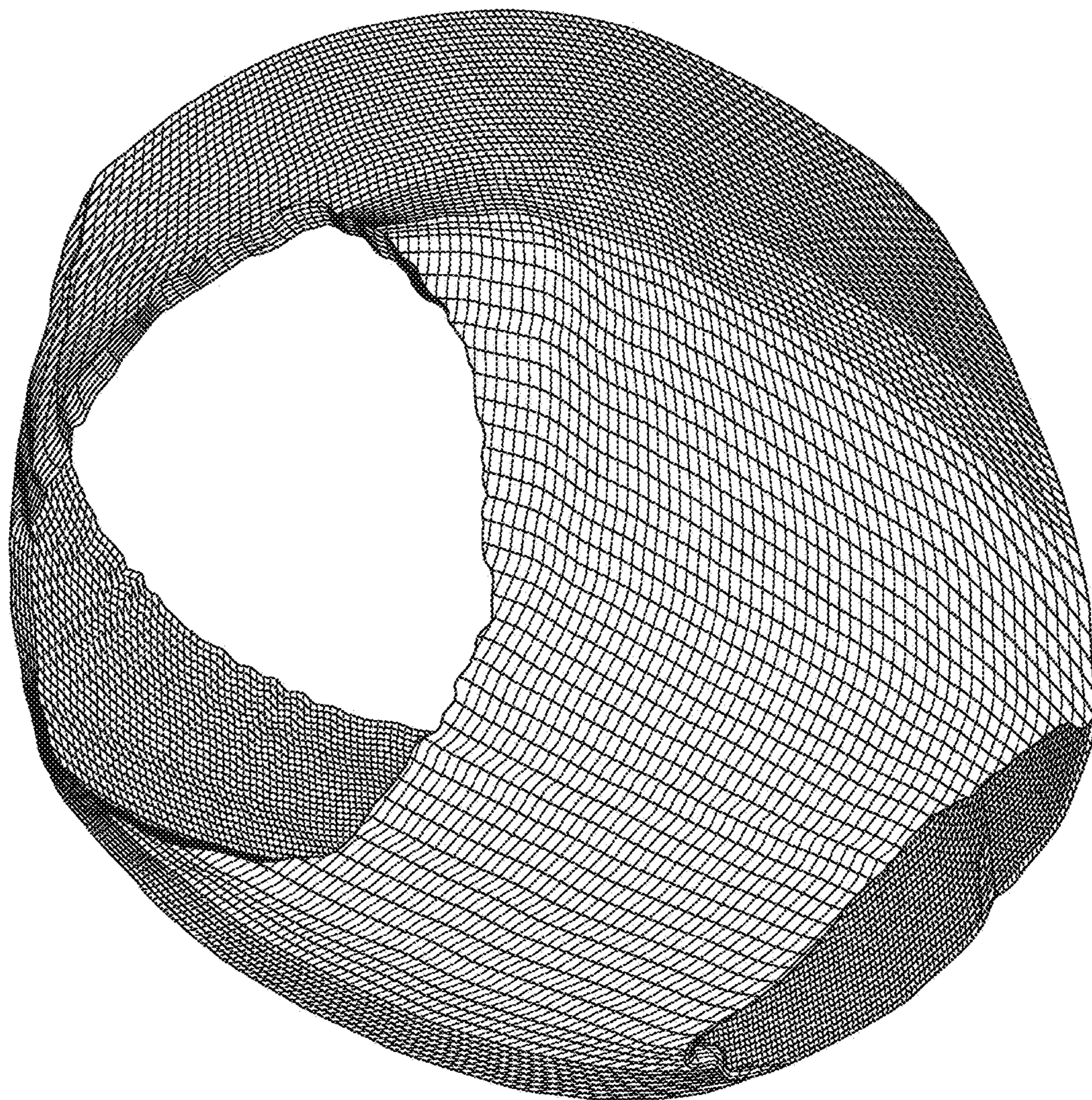

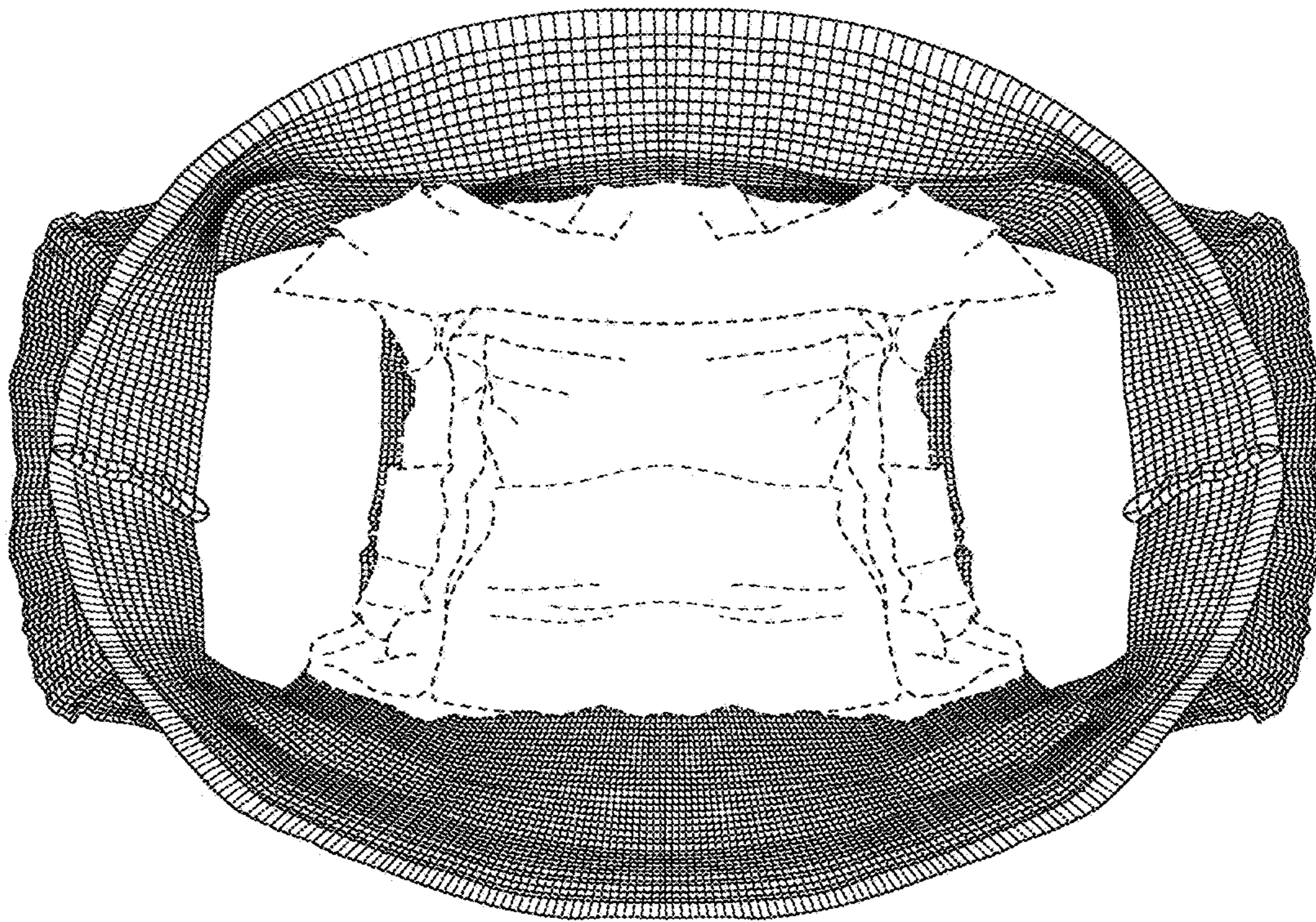

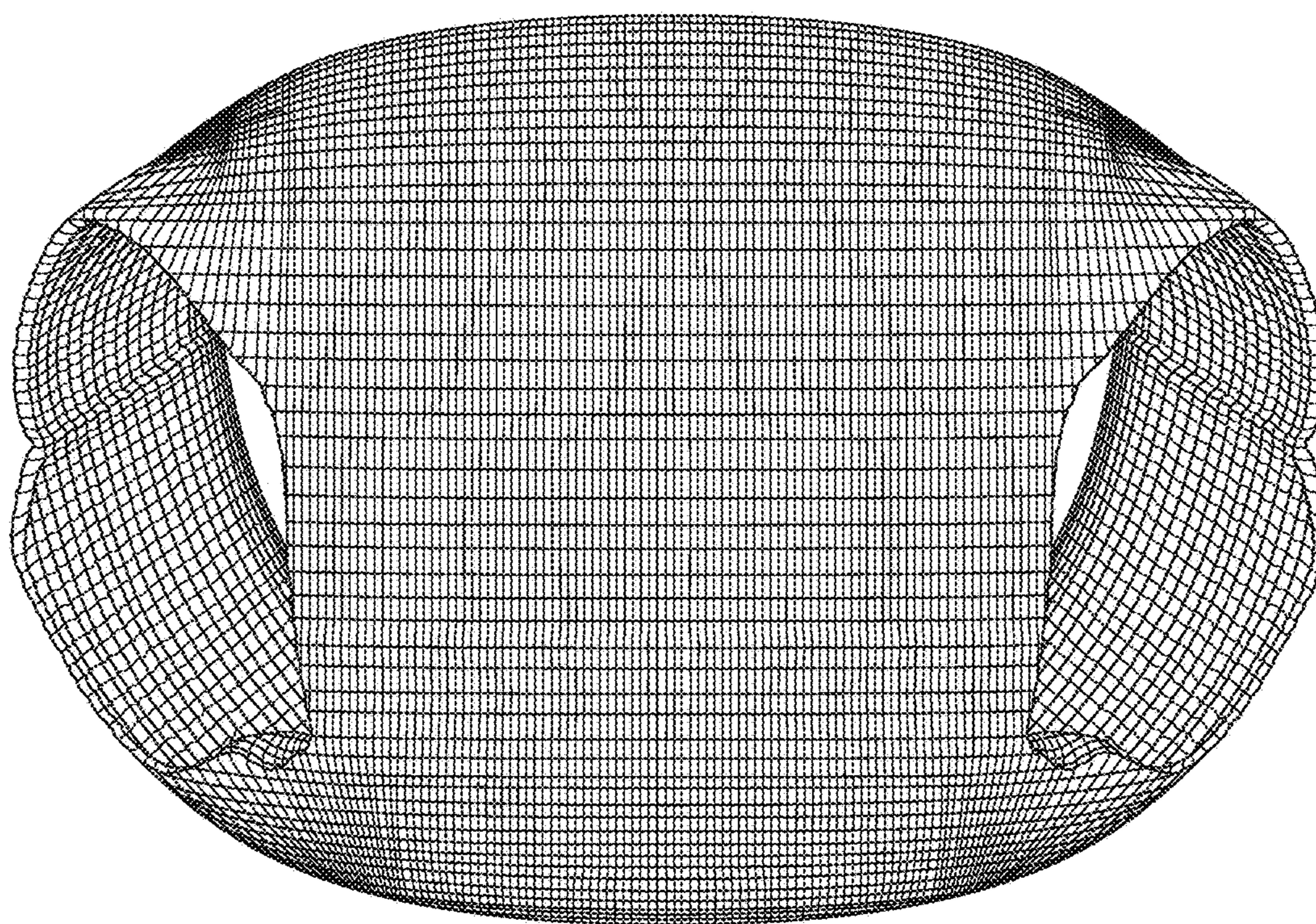

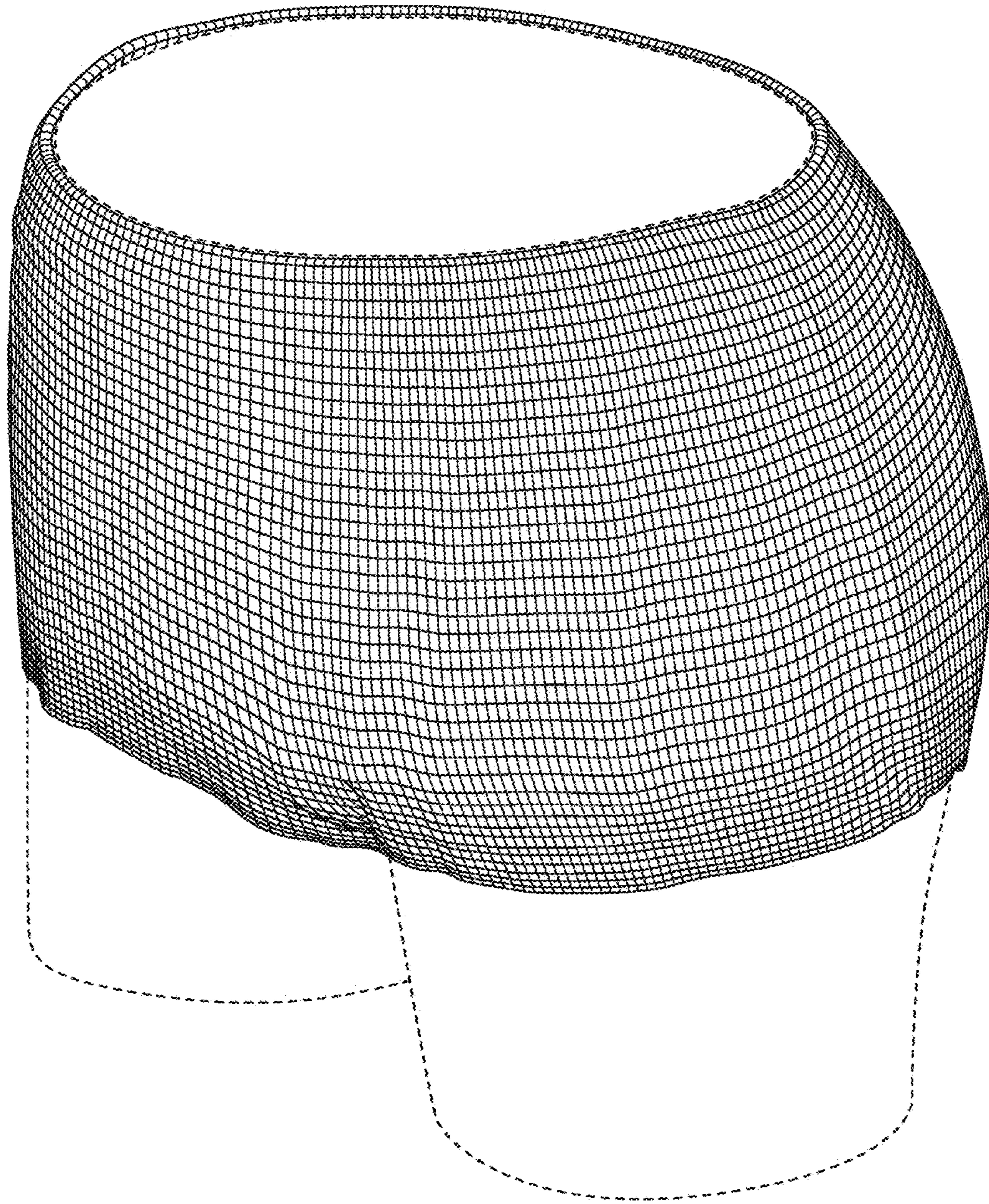

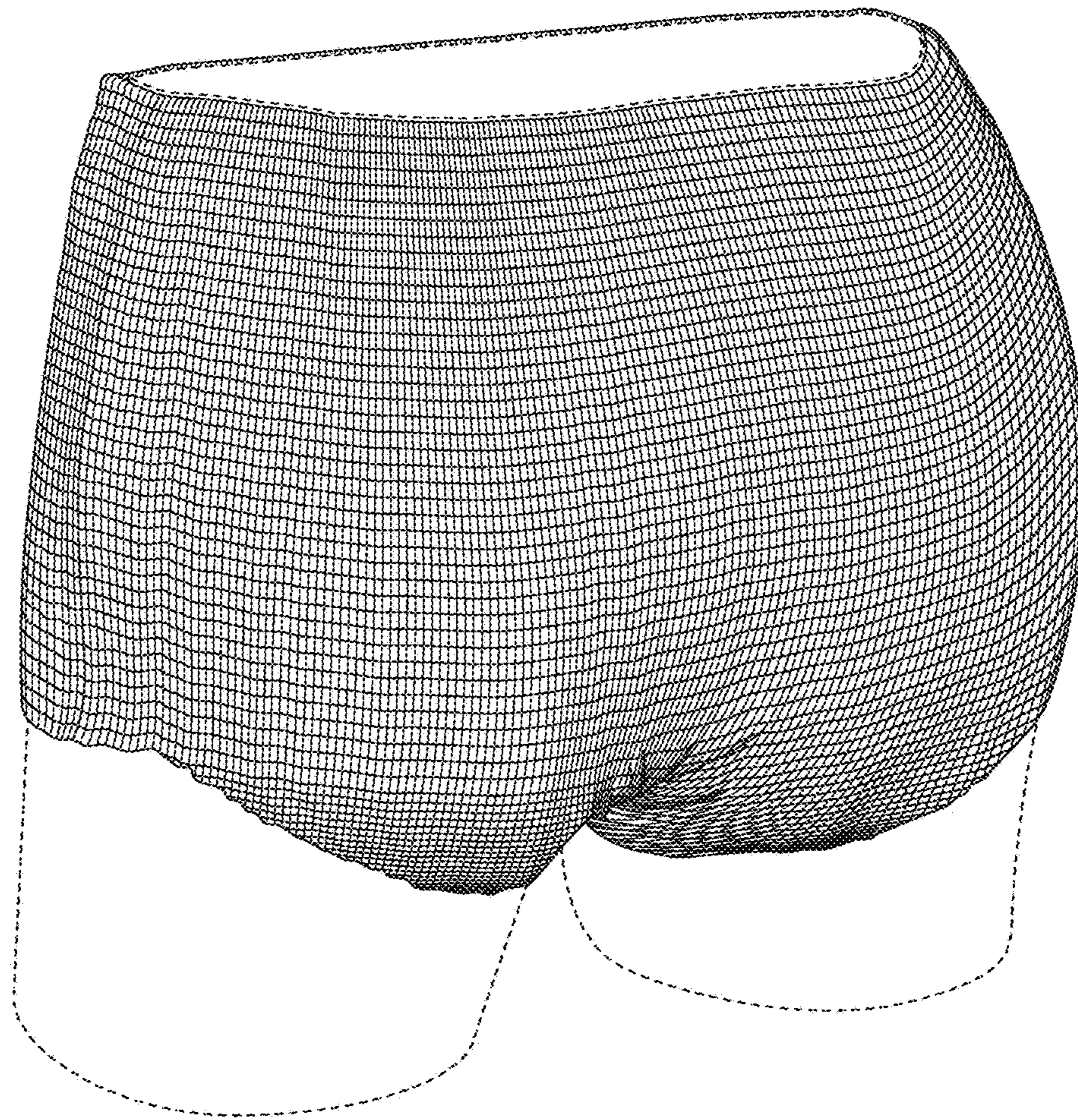
