The ornamental design for a tissue dying machine for adding contrast material to tissue to improve examination for doctors, hospitals and laboratories, as shown and described.

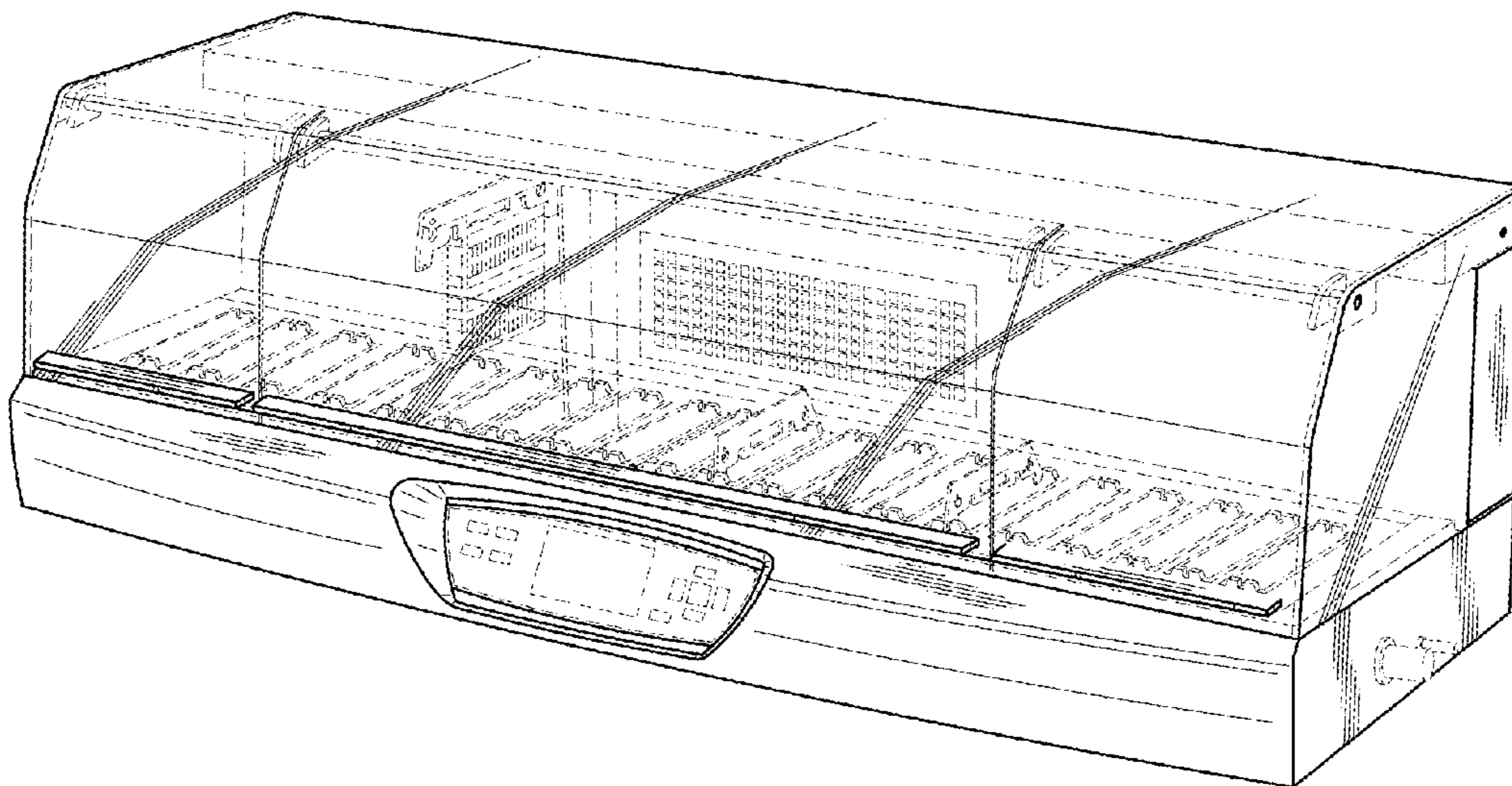
**DESCRIPTION**

FIG. 1 is a front and top perspective view of a tissue dying machine for adding contrast material to tissue to improve examination for doctors, hospitals and laboratories, showing my new design;

FIG. 2 is a front, top and right side perspective view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; and, FIG. 7 is a rear elevational view thereof.

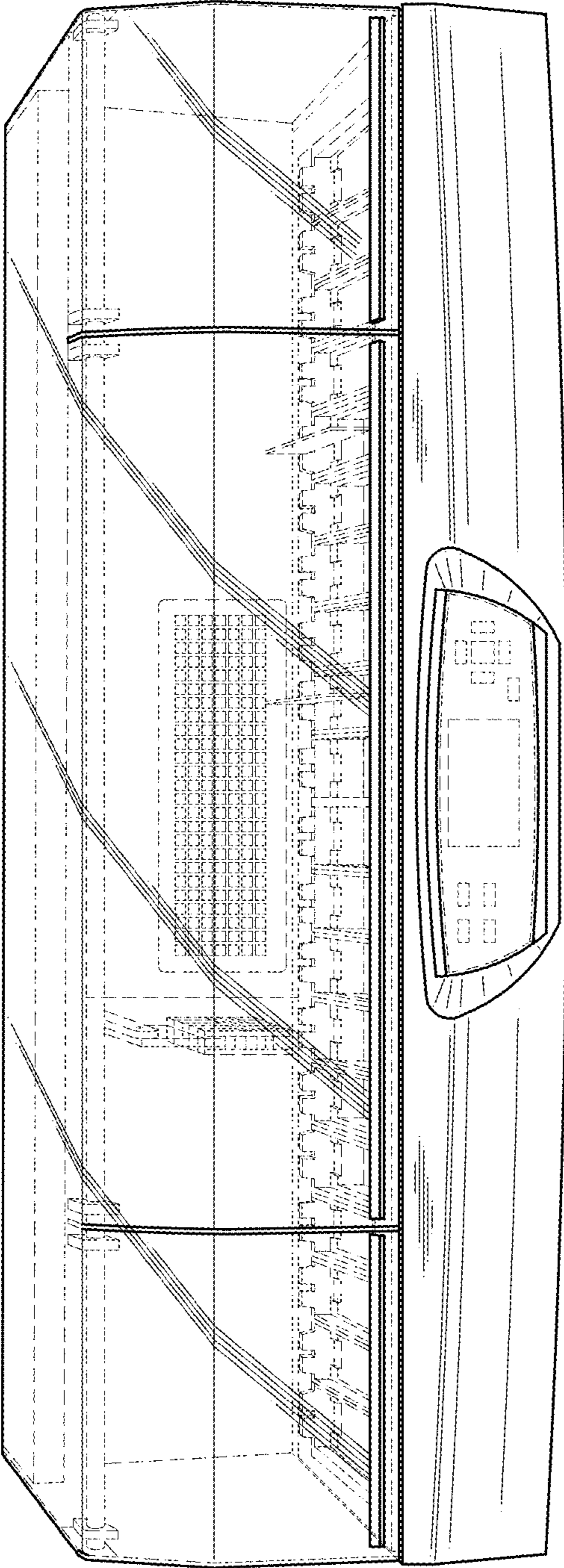
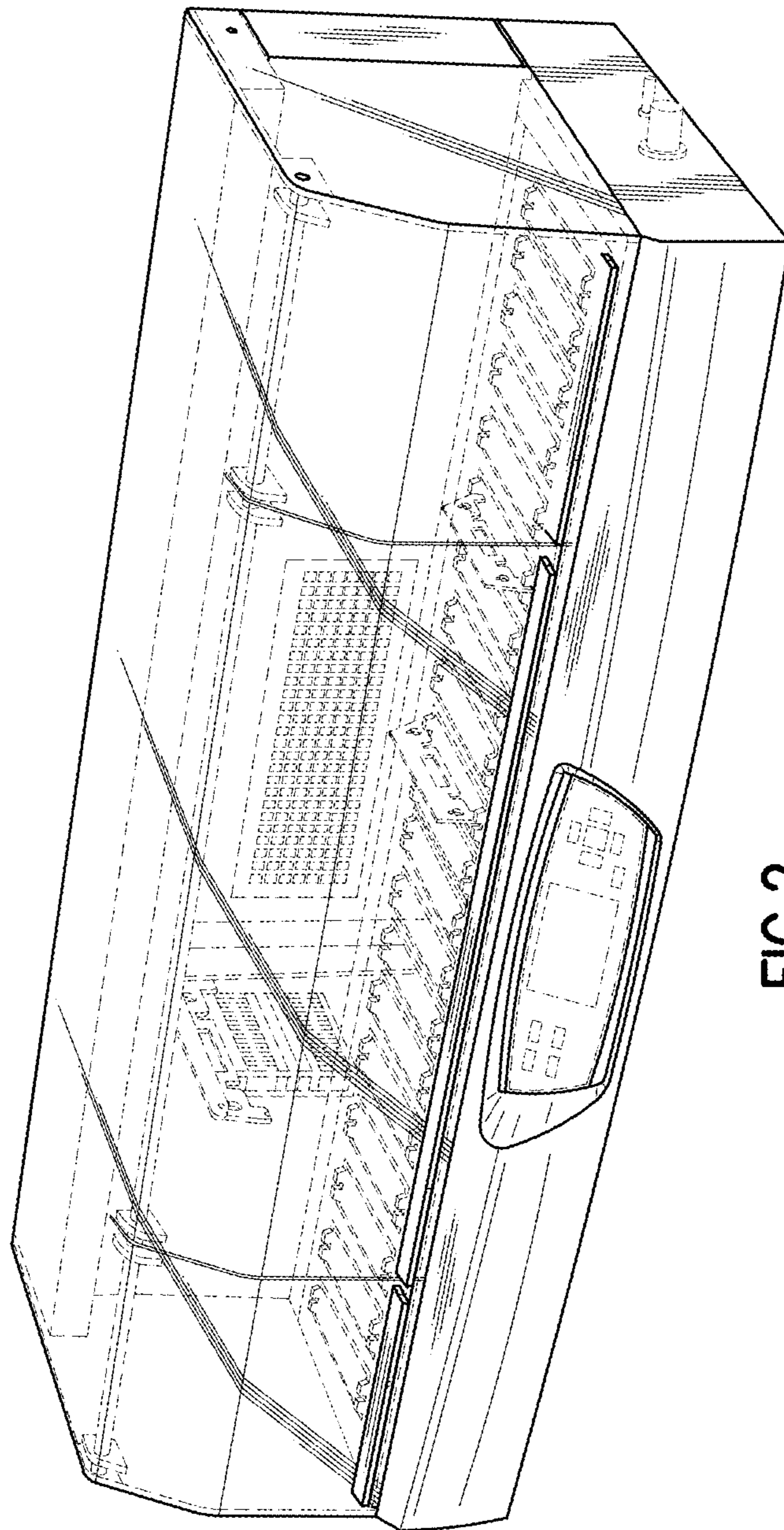

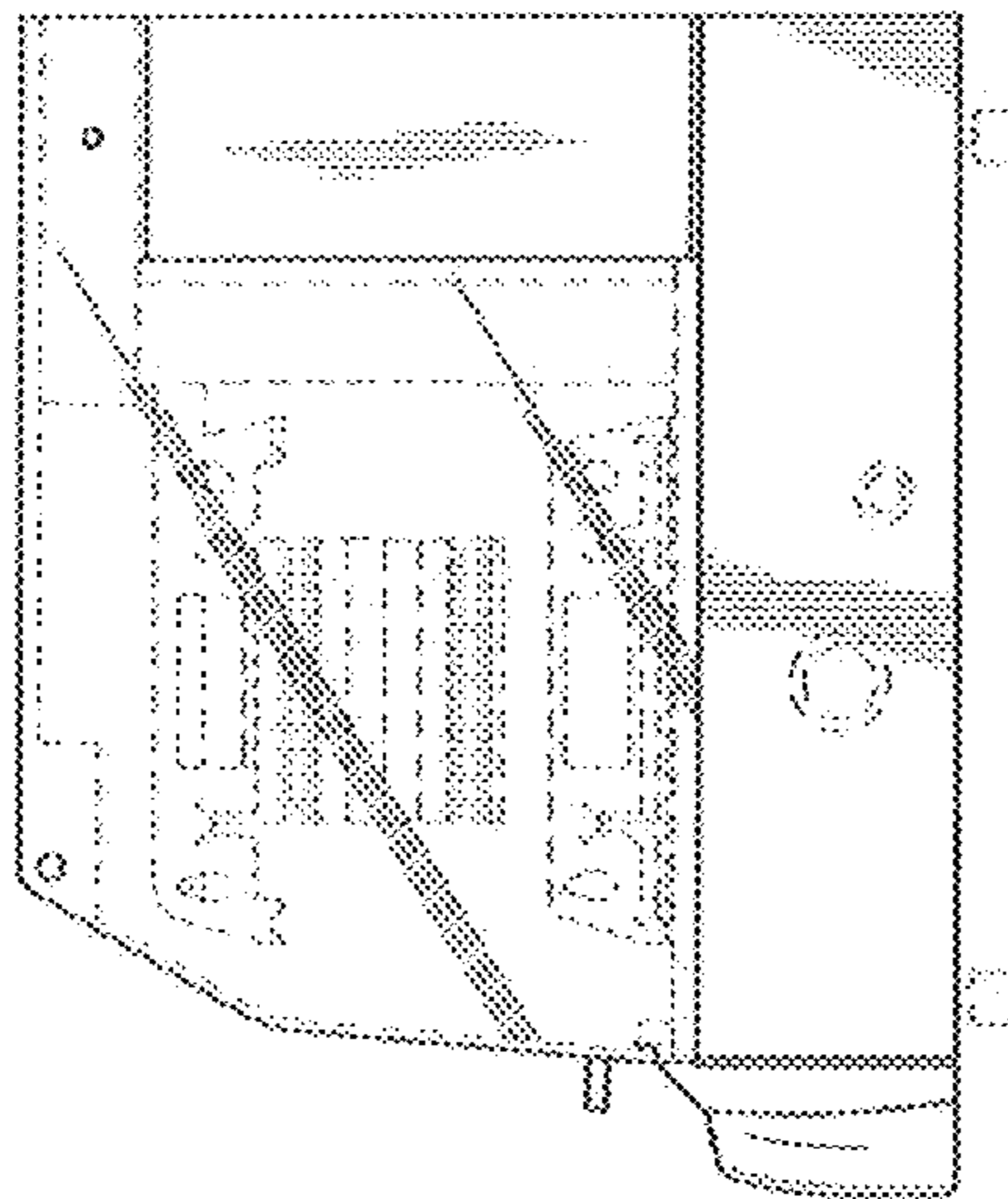
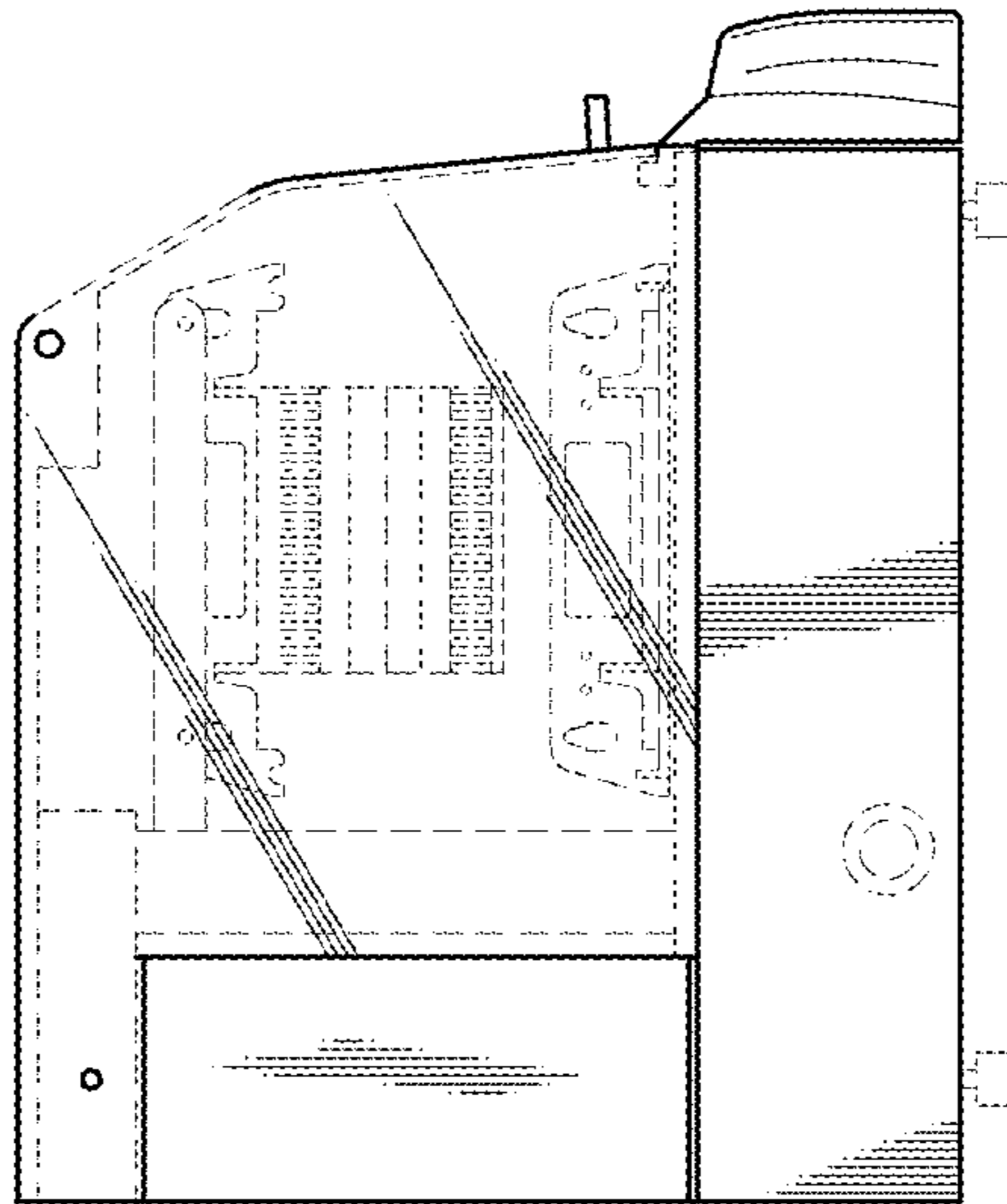
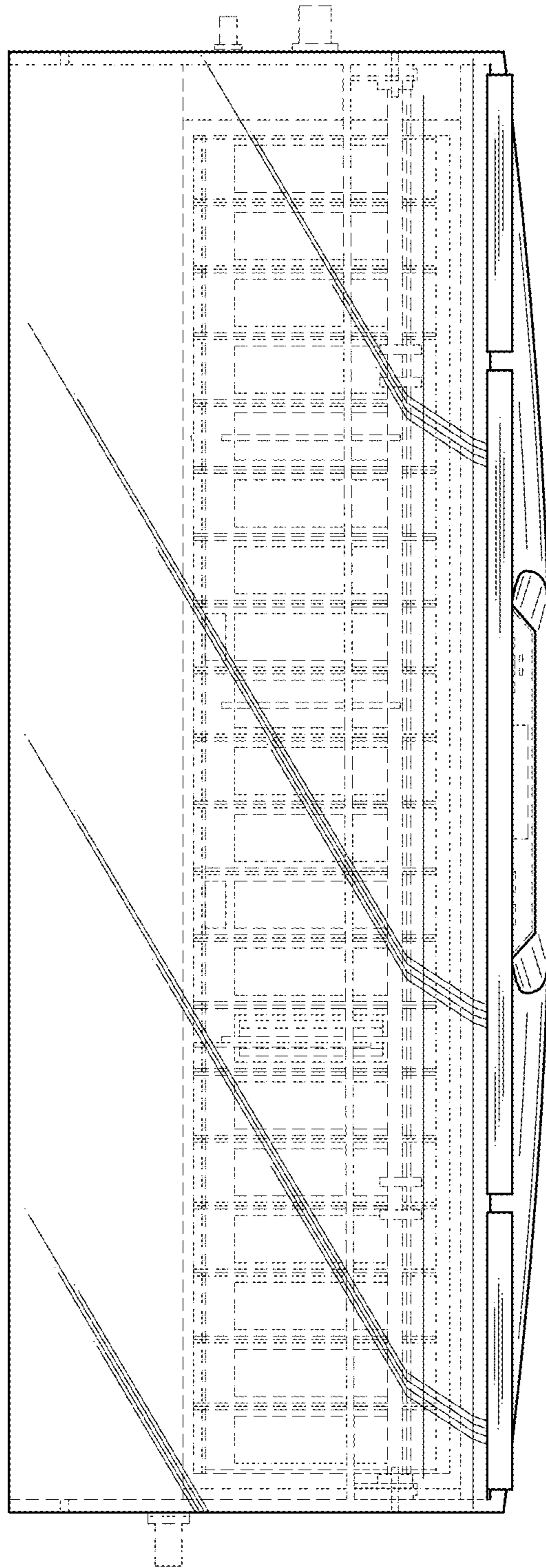

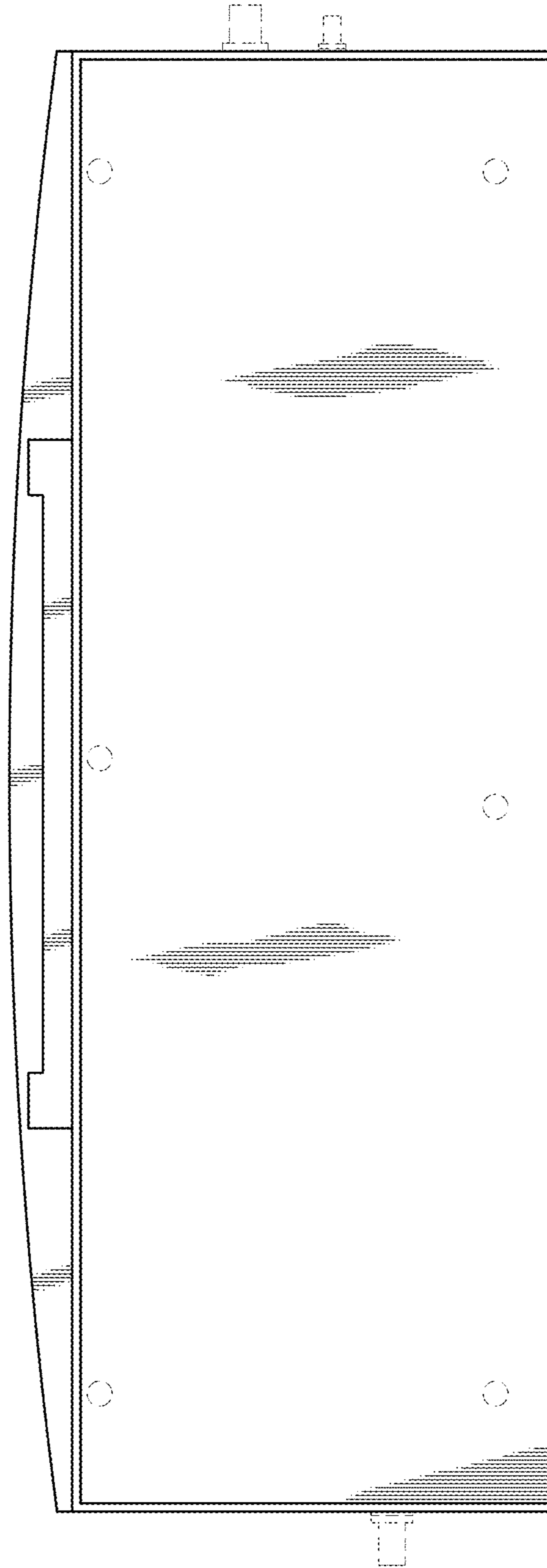
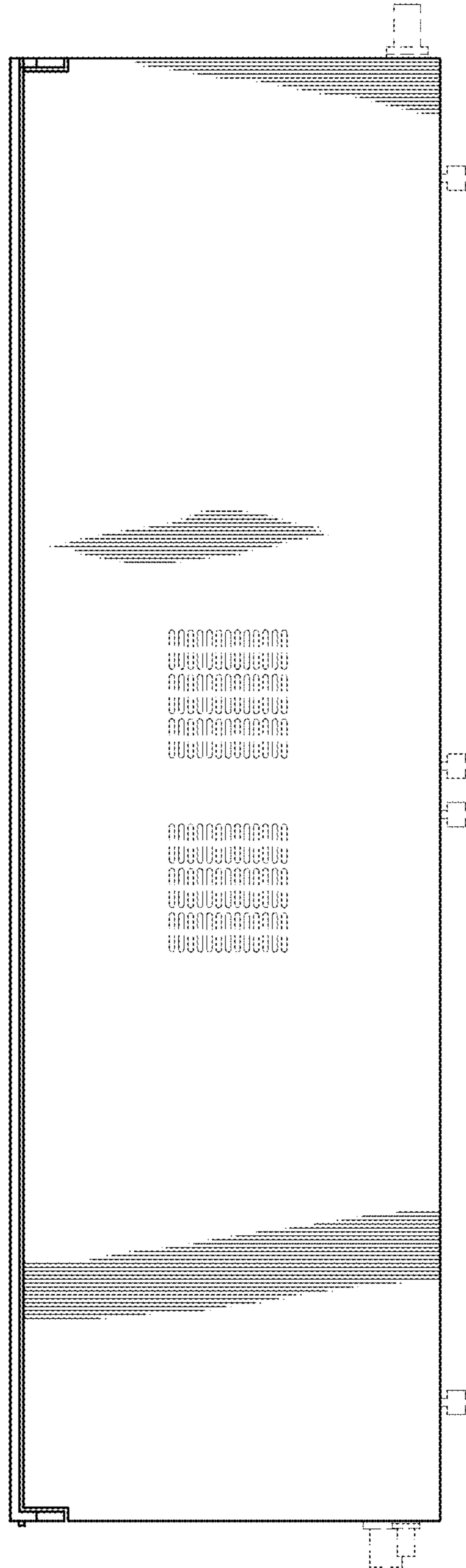
