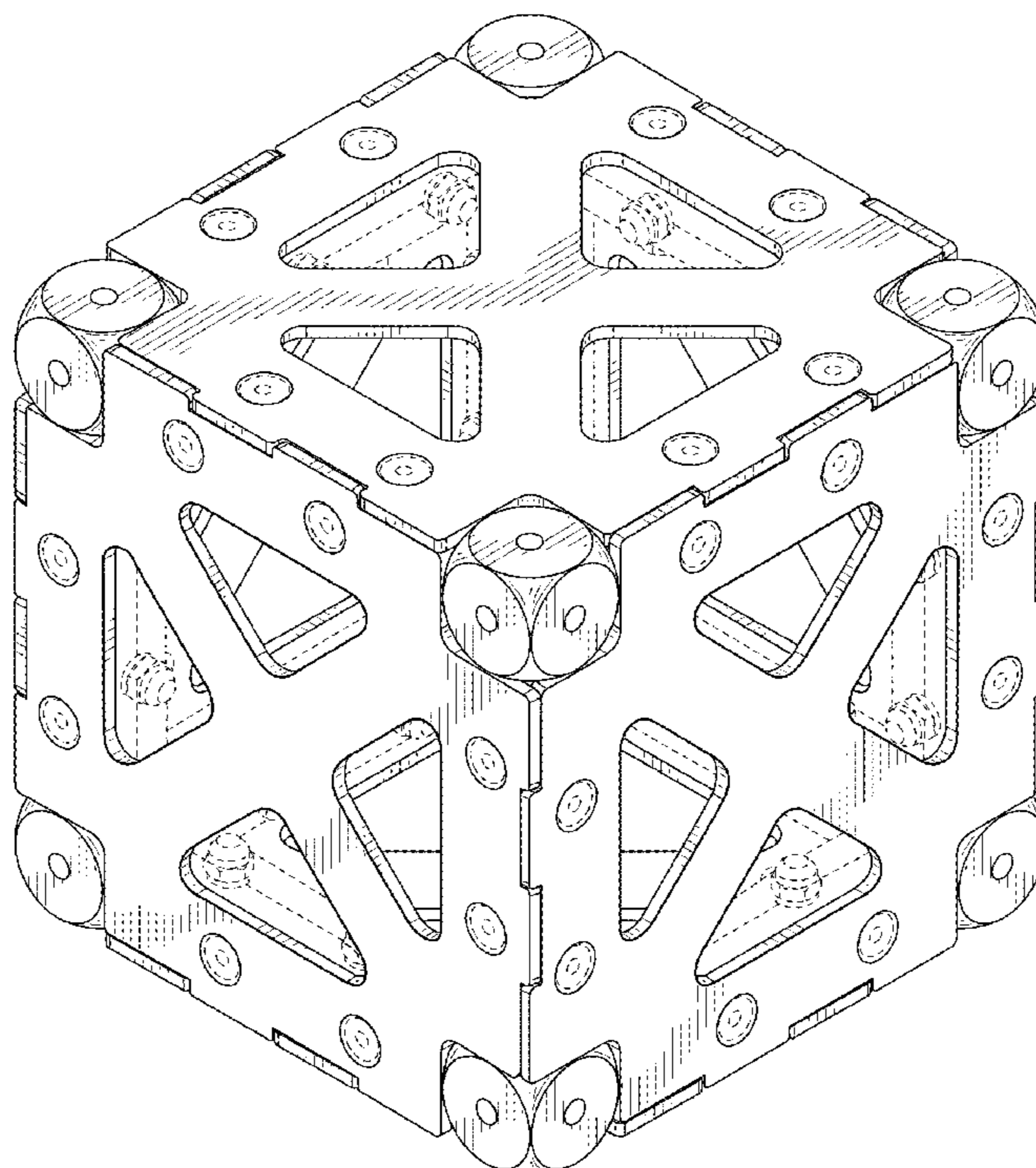

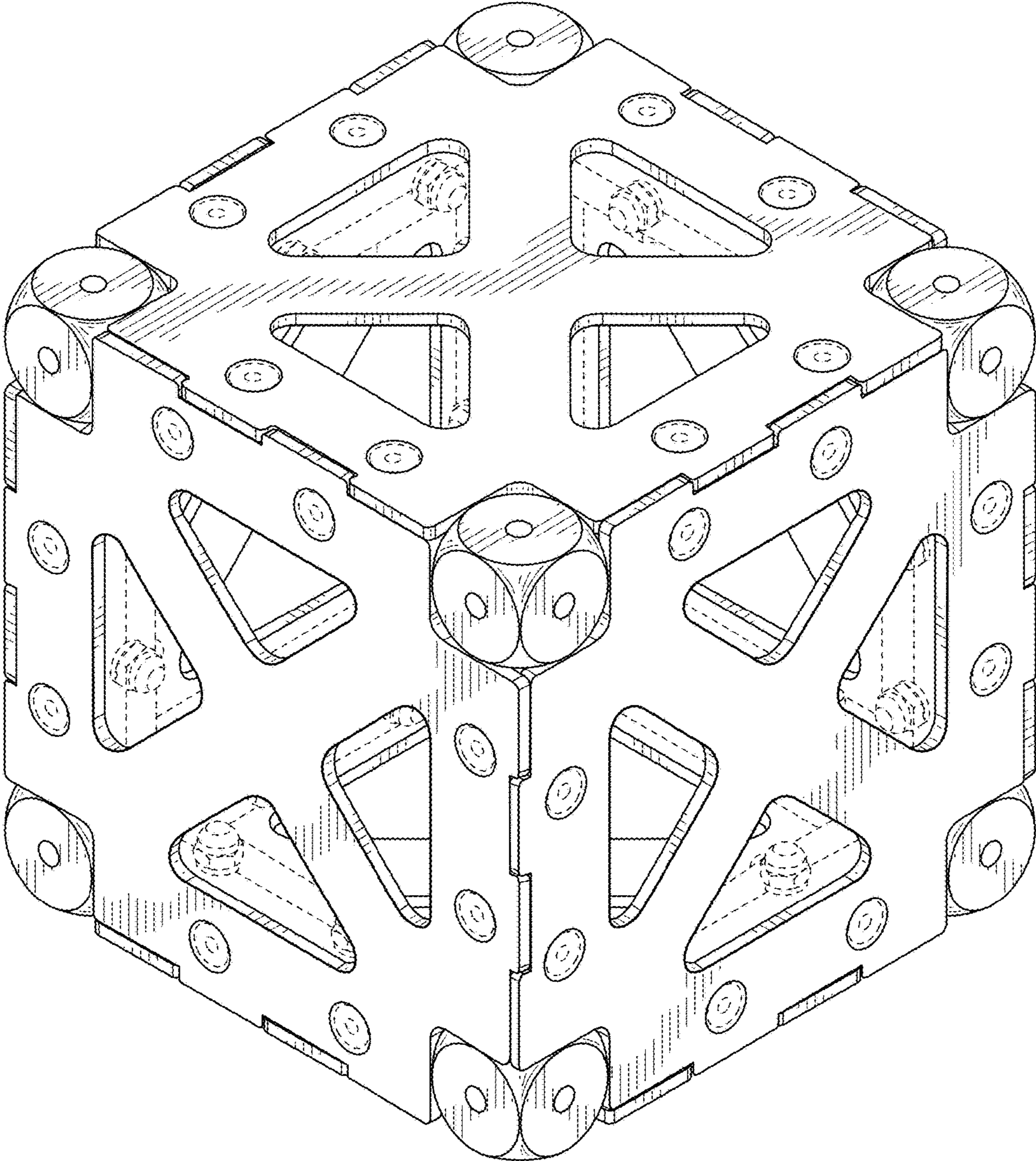
I claim, the ornamental design for a box corner for structural truss, as shown and described.

DESCRIPTION

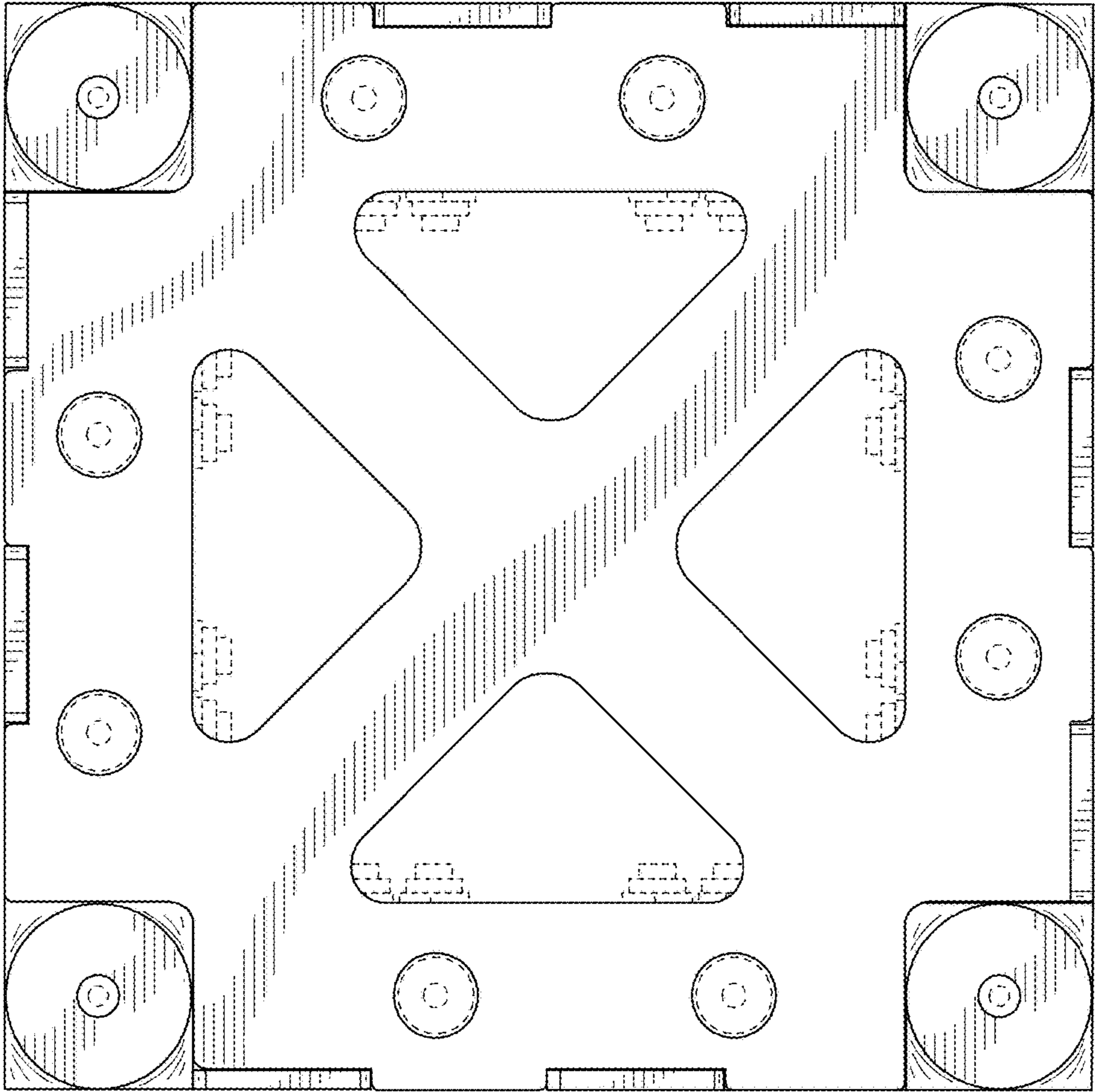
1.1 is a perspective view of a box corner for structural truss showing my new design; and
