(57) **CLAIM**

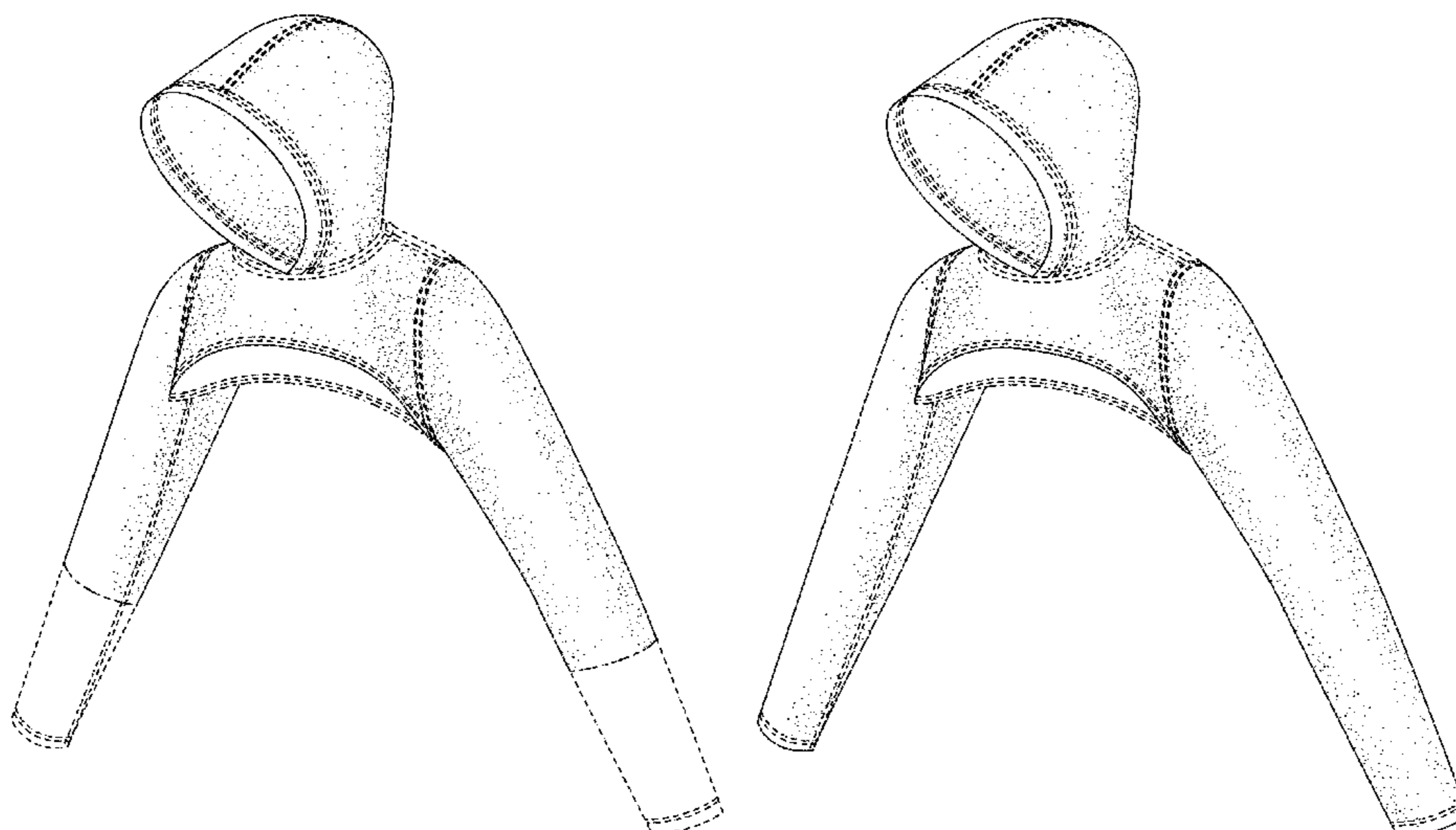
The ornamental design of a hooded and sleeved partial undershirt garment, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front perspective (elevational) view of a hooded and sleeved partial undershirt garment in accordance with the present invention.
 FIG. 2 is a front view of the garment of FIG. 1.
 FIG. 3 is a back view thereof.
 FIG. 4 is a right side view thereof.
 FIG. 5 is a left side view thereof.
 FIG. 6 is a top view thereof.
 FIG. 7 is a bottom view thereof.
 FIG. 8 is an alternative front perspective (elevational) view of a hooded and sleeved partial undershirt garment in accordance with the present invention.
 FIG. 9 is a front view of the garment of FIG. 8.
 FIG. 10 is a back view thereof.
 FIG. 11 is a right side view thereof.
 FIG. 12 is a left side view thereof.
 FIG. 13 is a top view thereof; and,
 FIG. 14 is a bottom view thereof.

The dashed lines illustrate portions of the garment that form no part of the claimed design. The dash-dot-dash lines immediately adjacent the solid-line portions of the design form the boundary of the design and form no part of the claimed design.

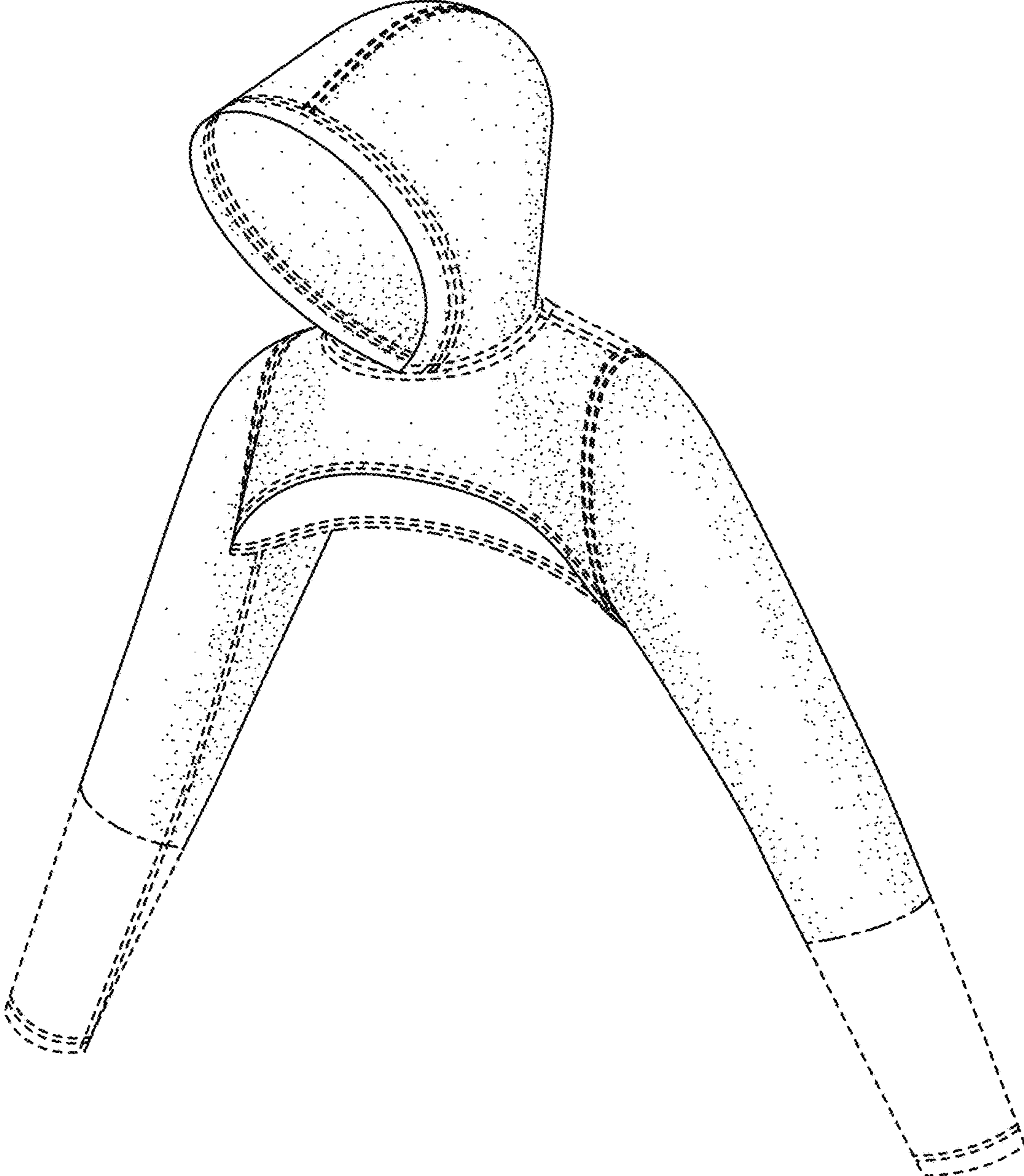

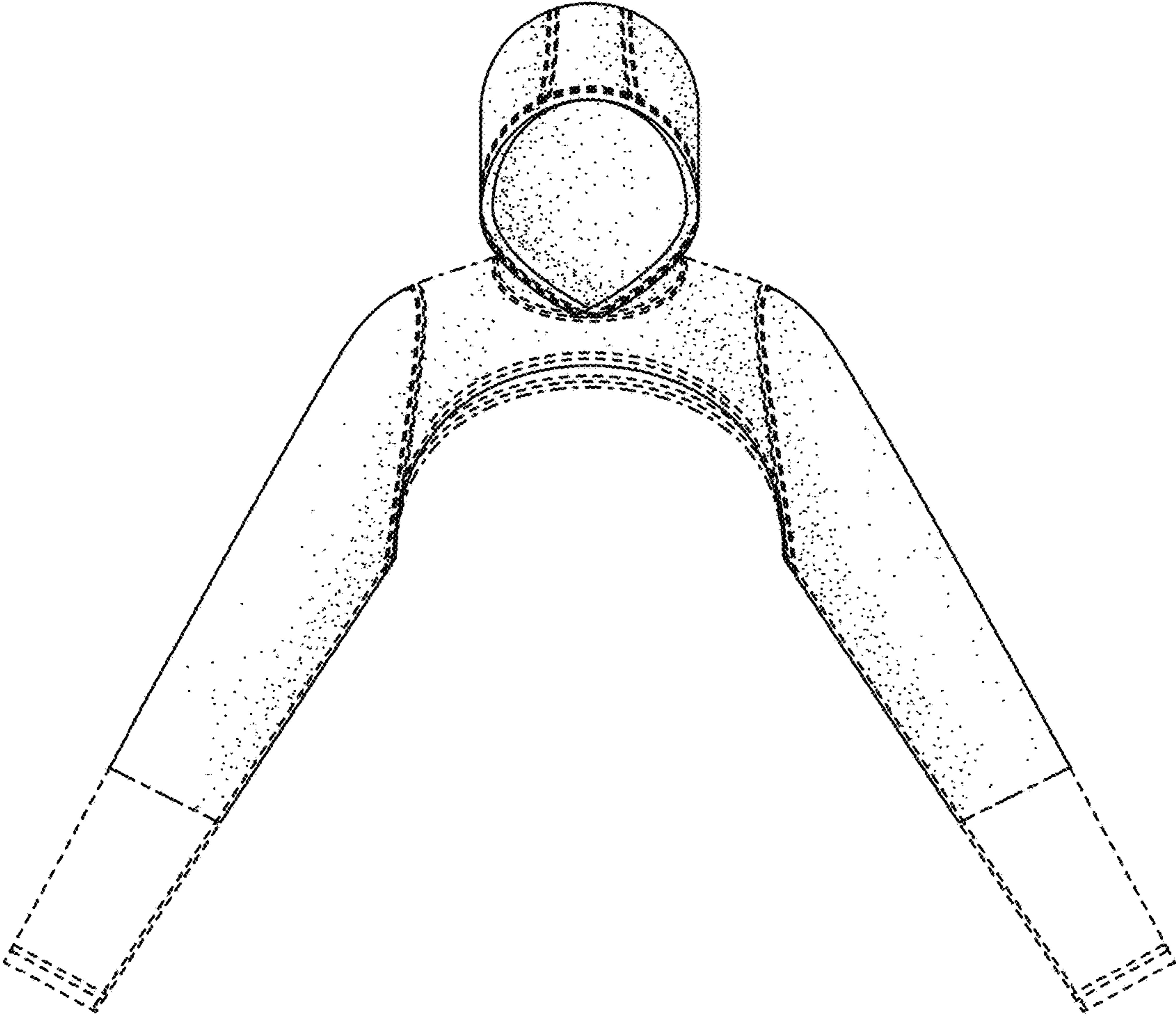

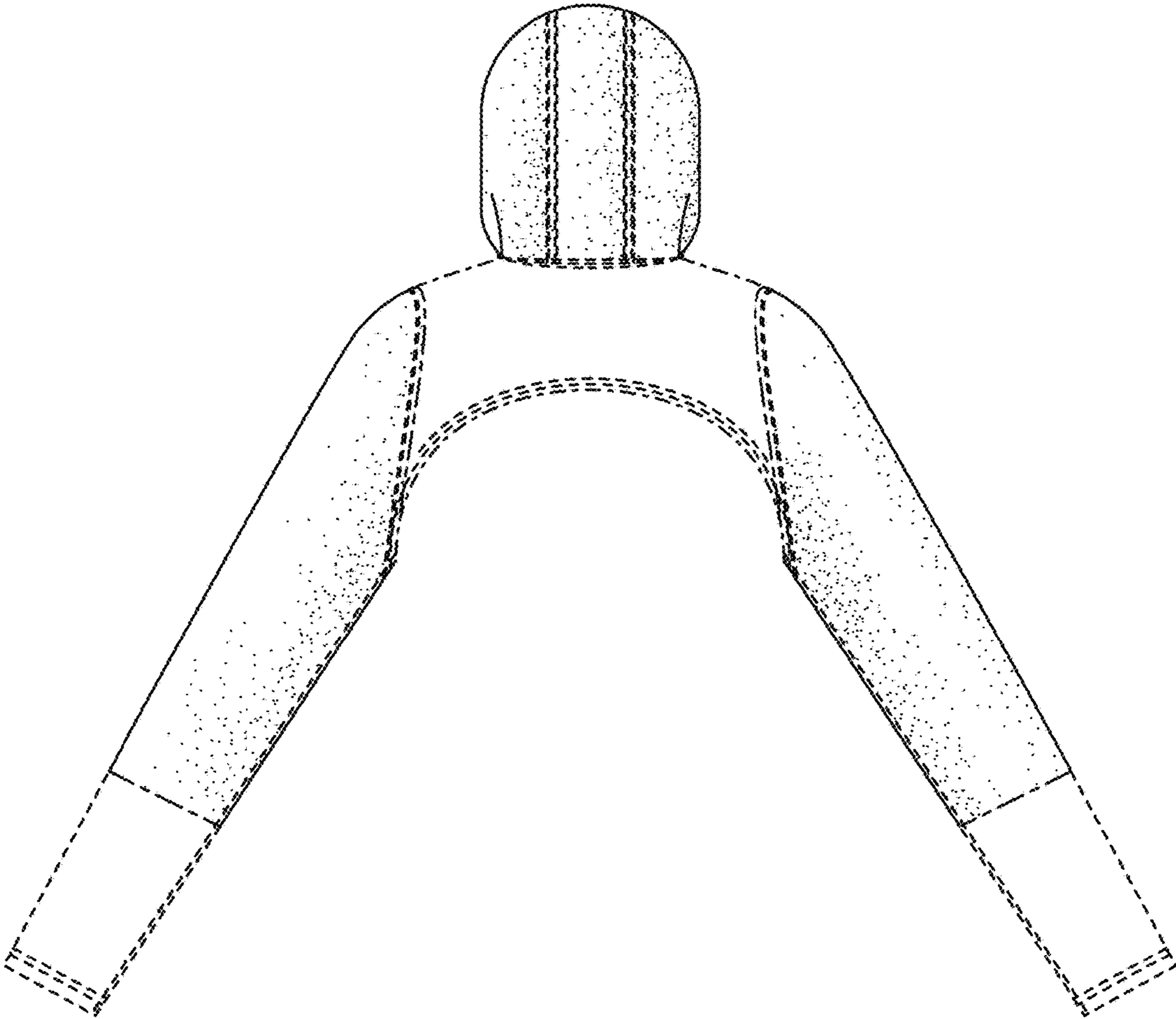

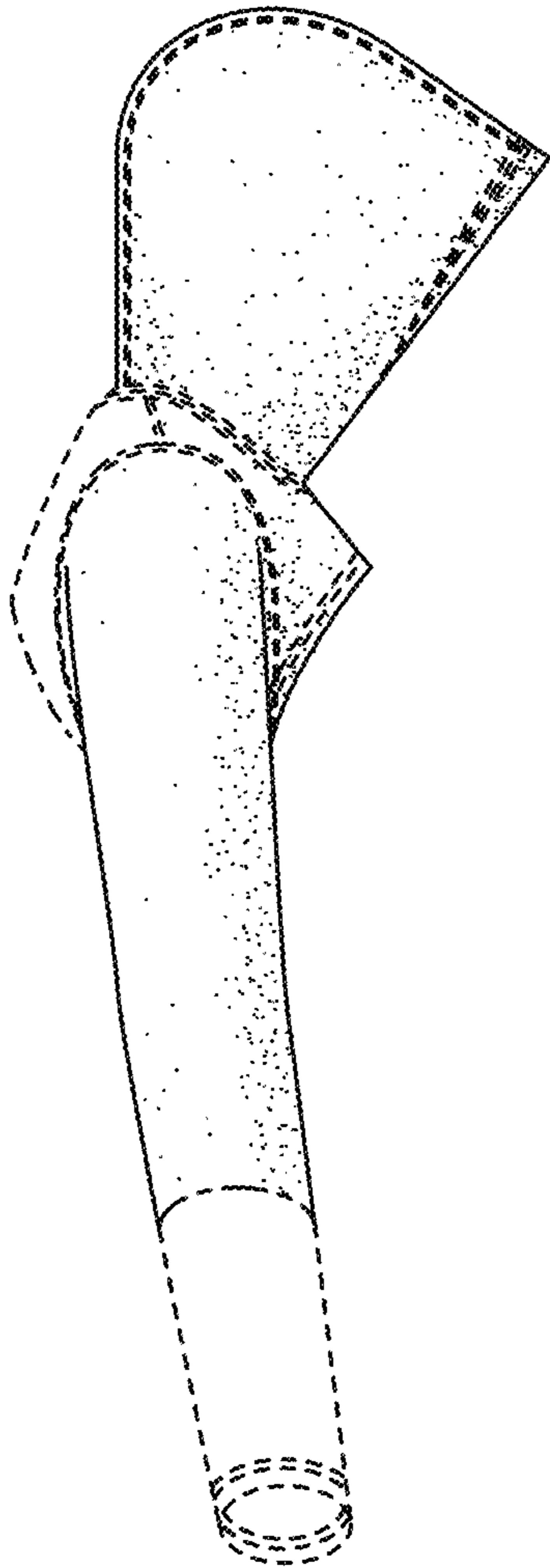

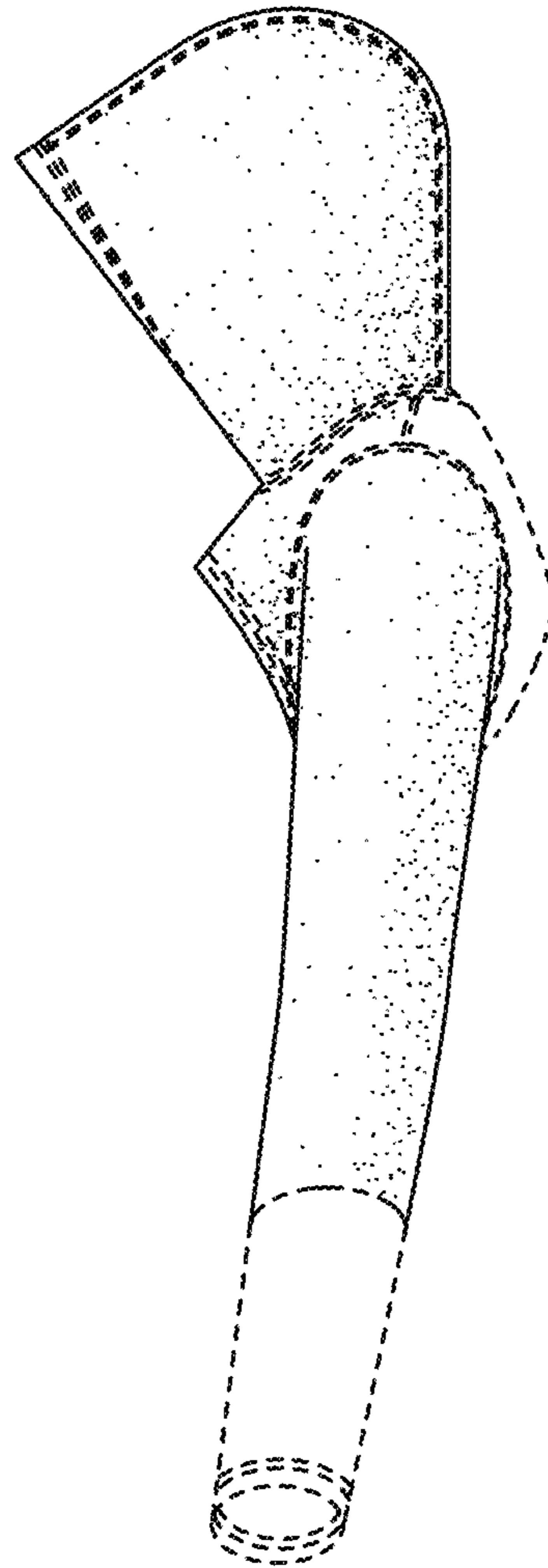

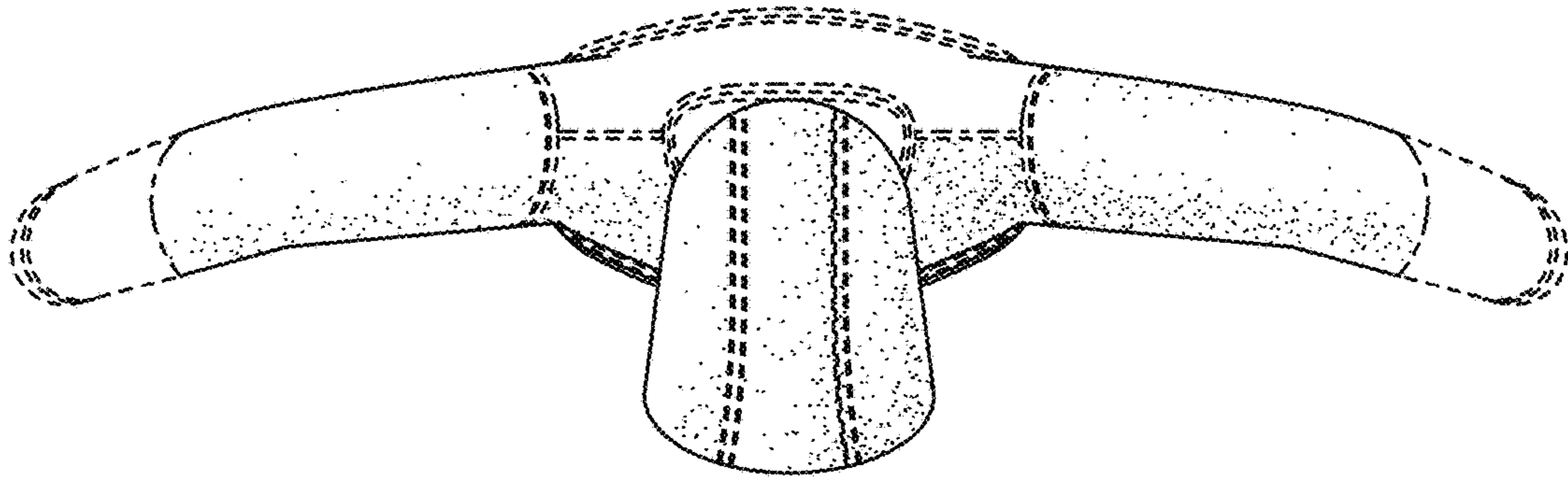

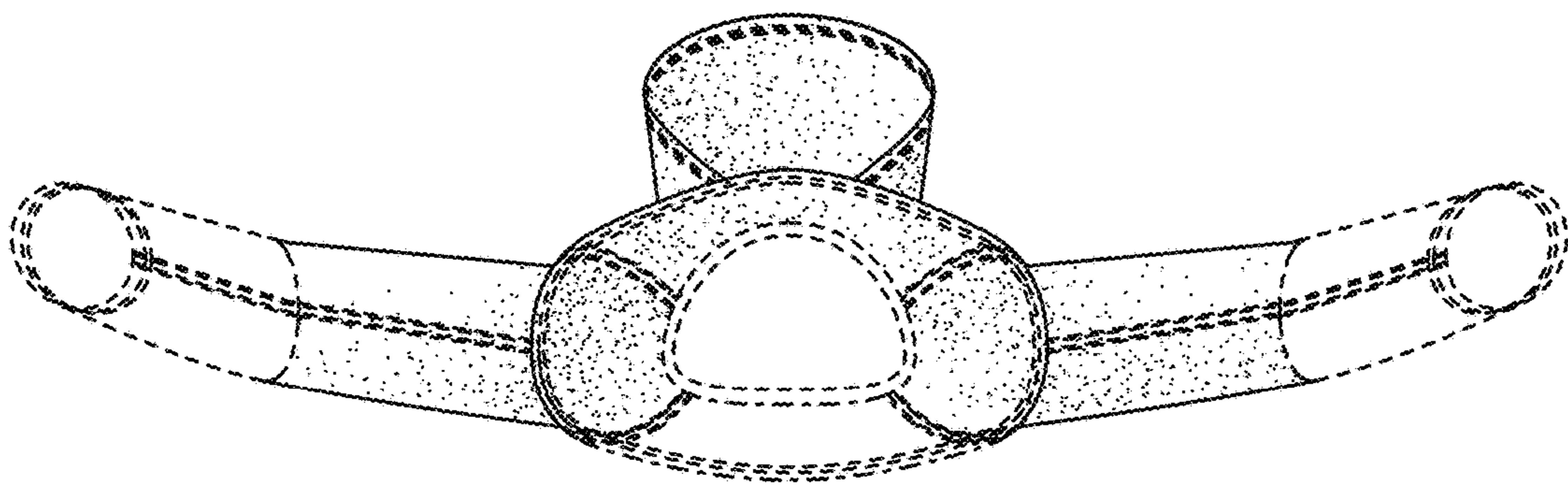

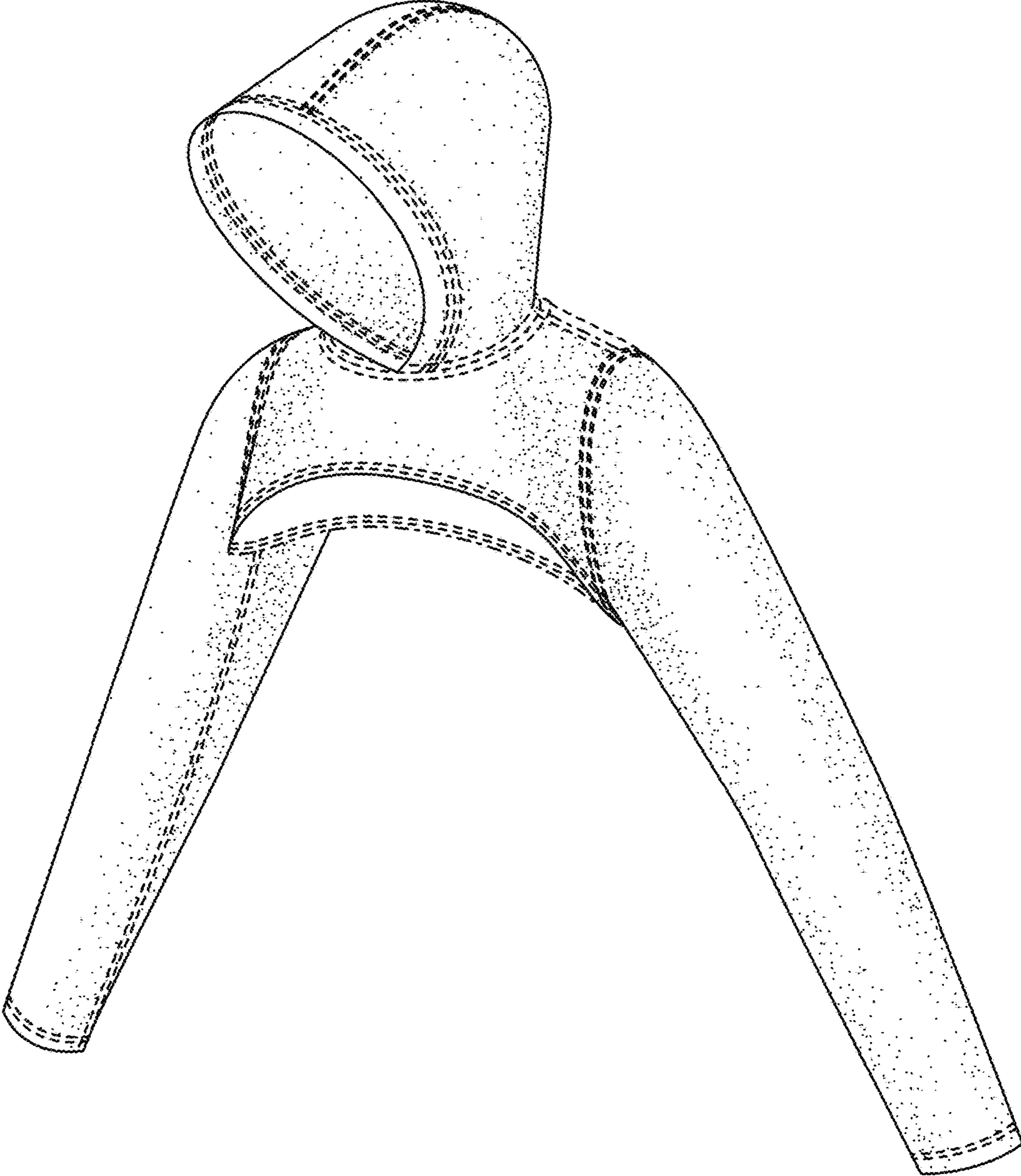

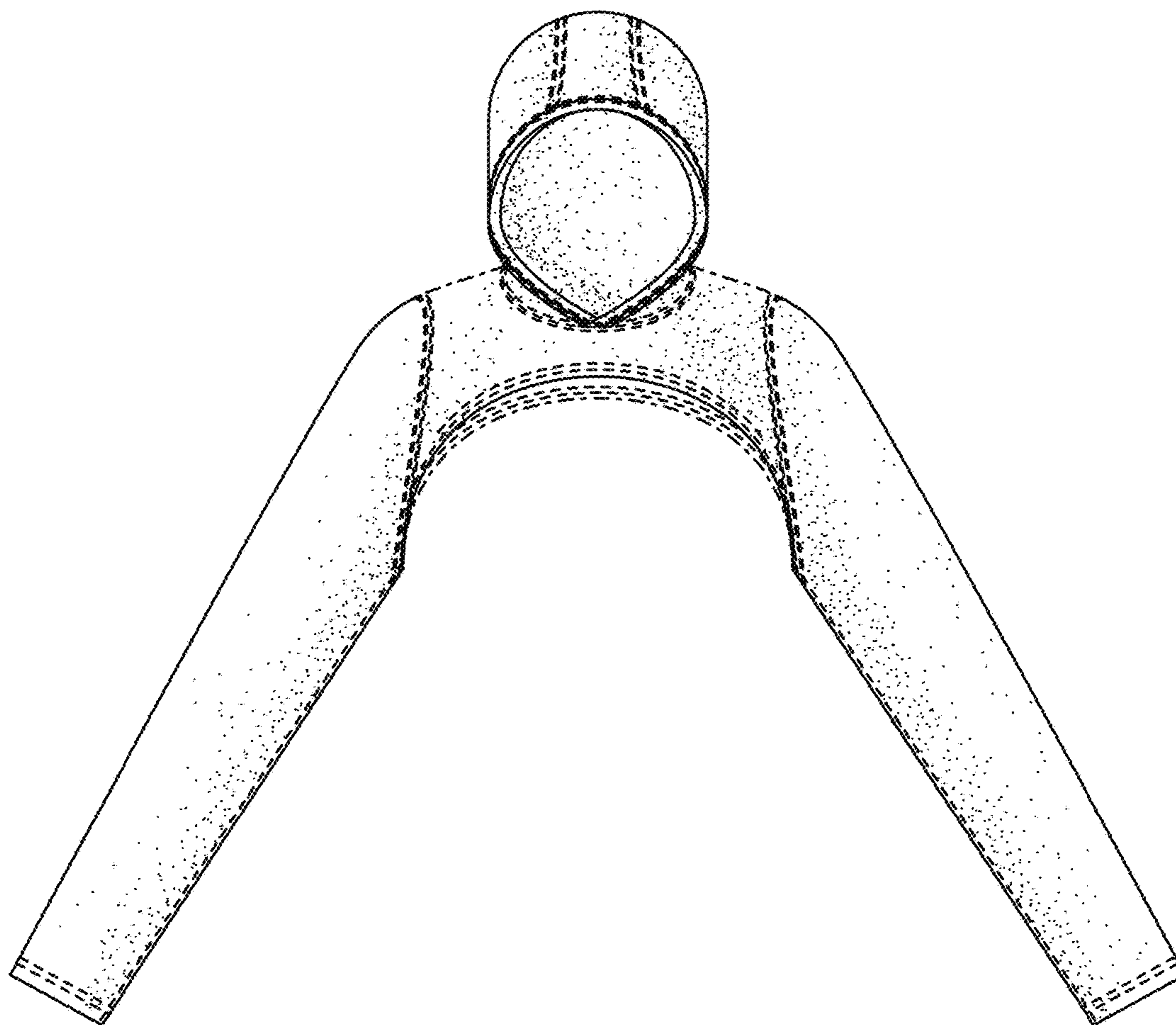

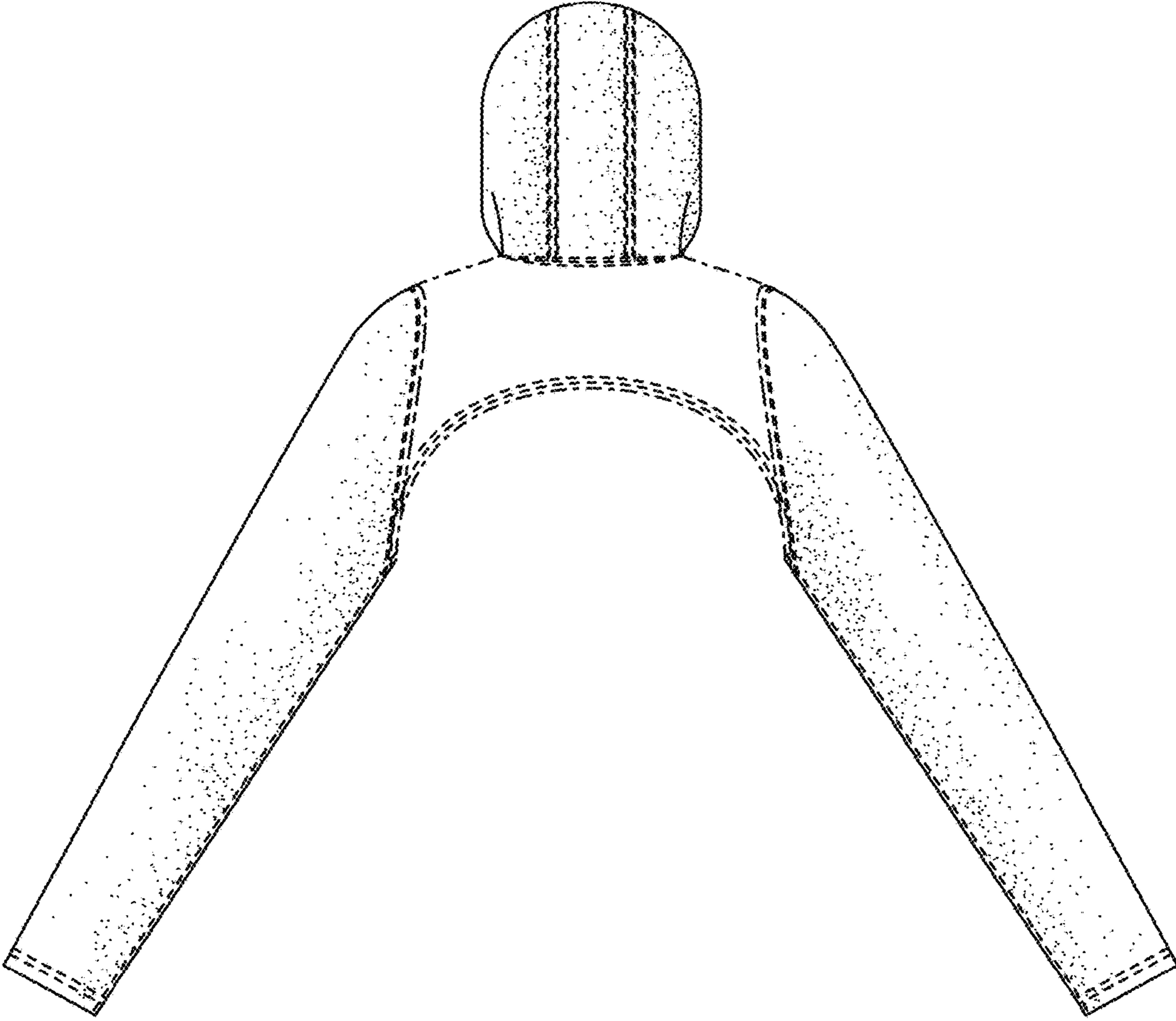

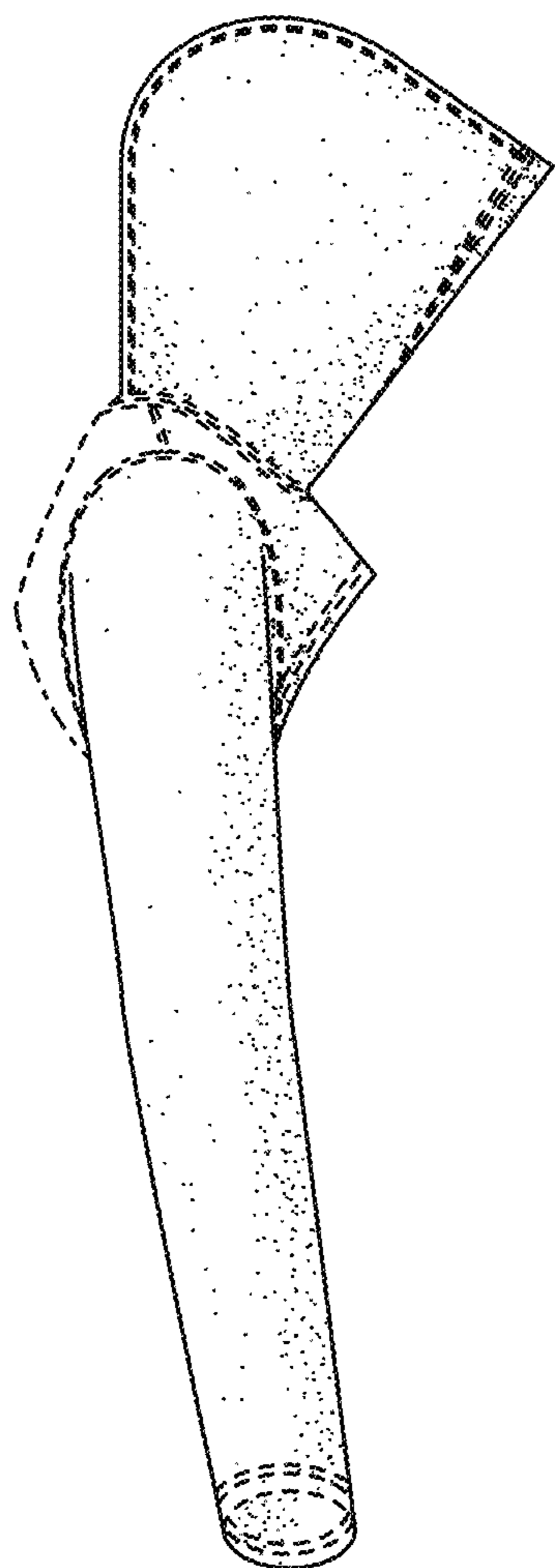

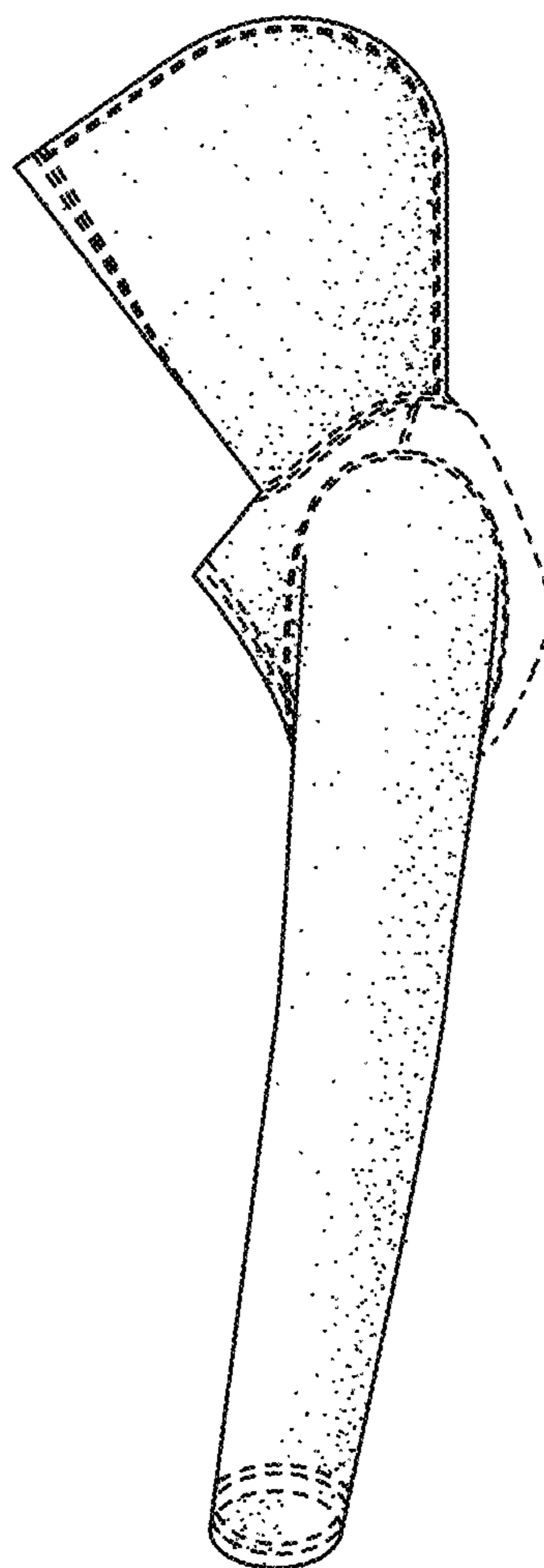

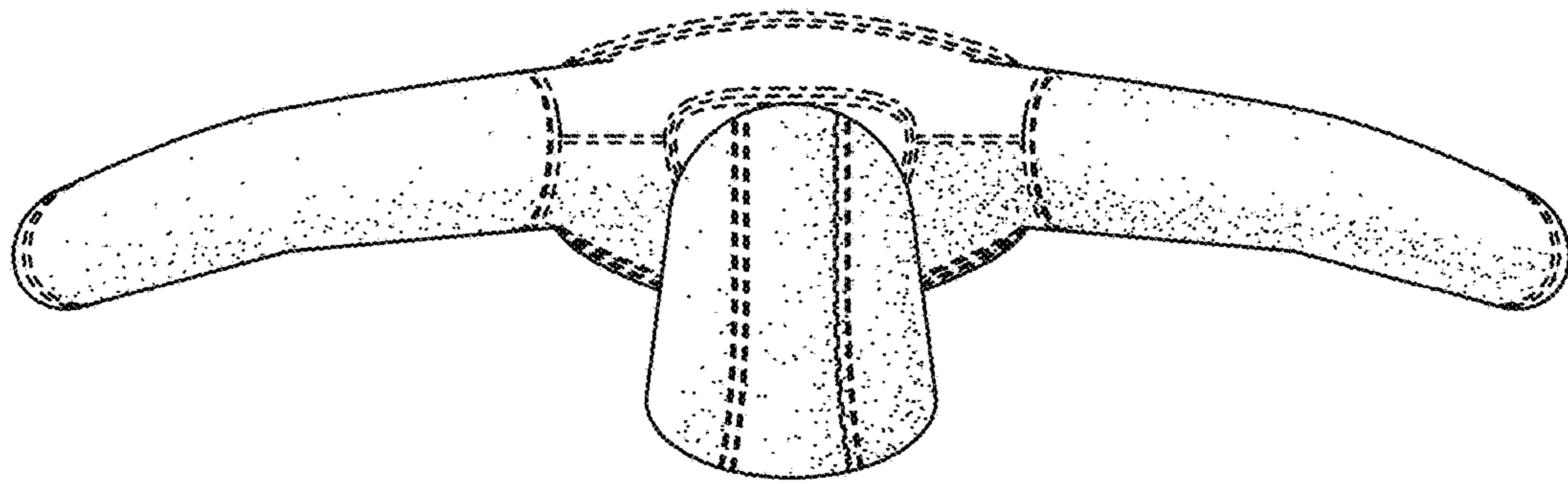

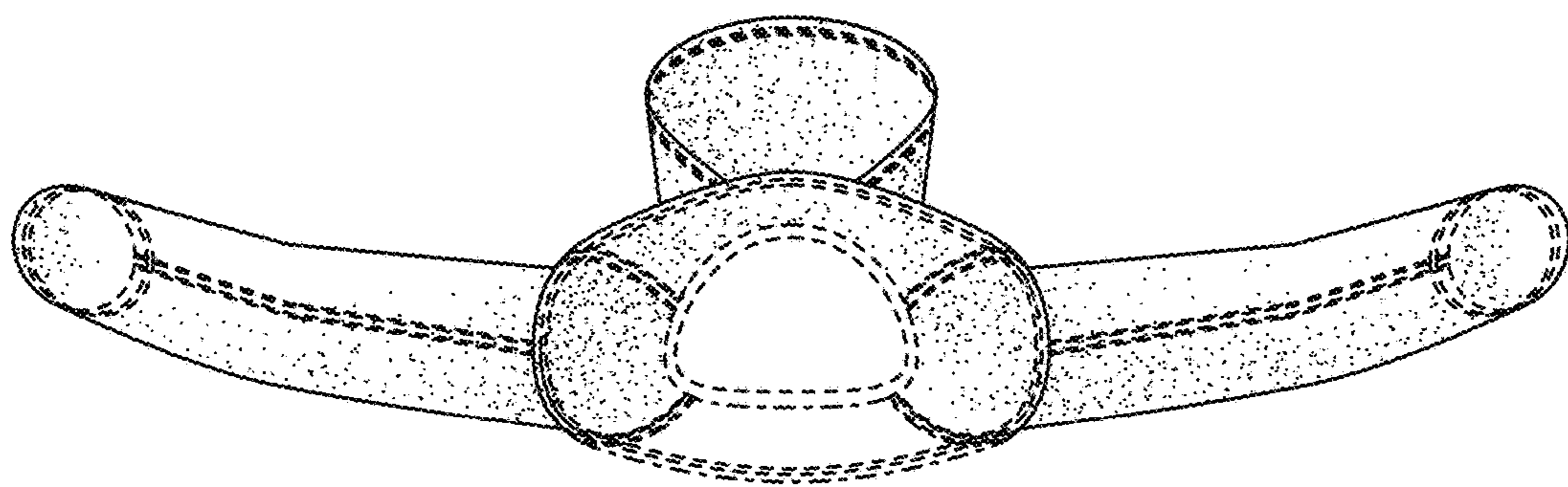
