(57) **CLAIM**

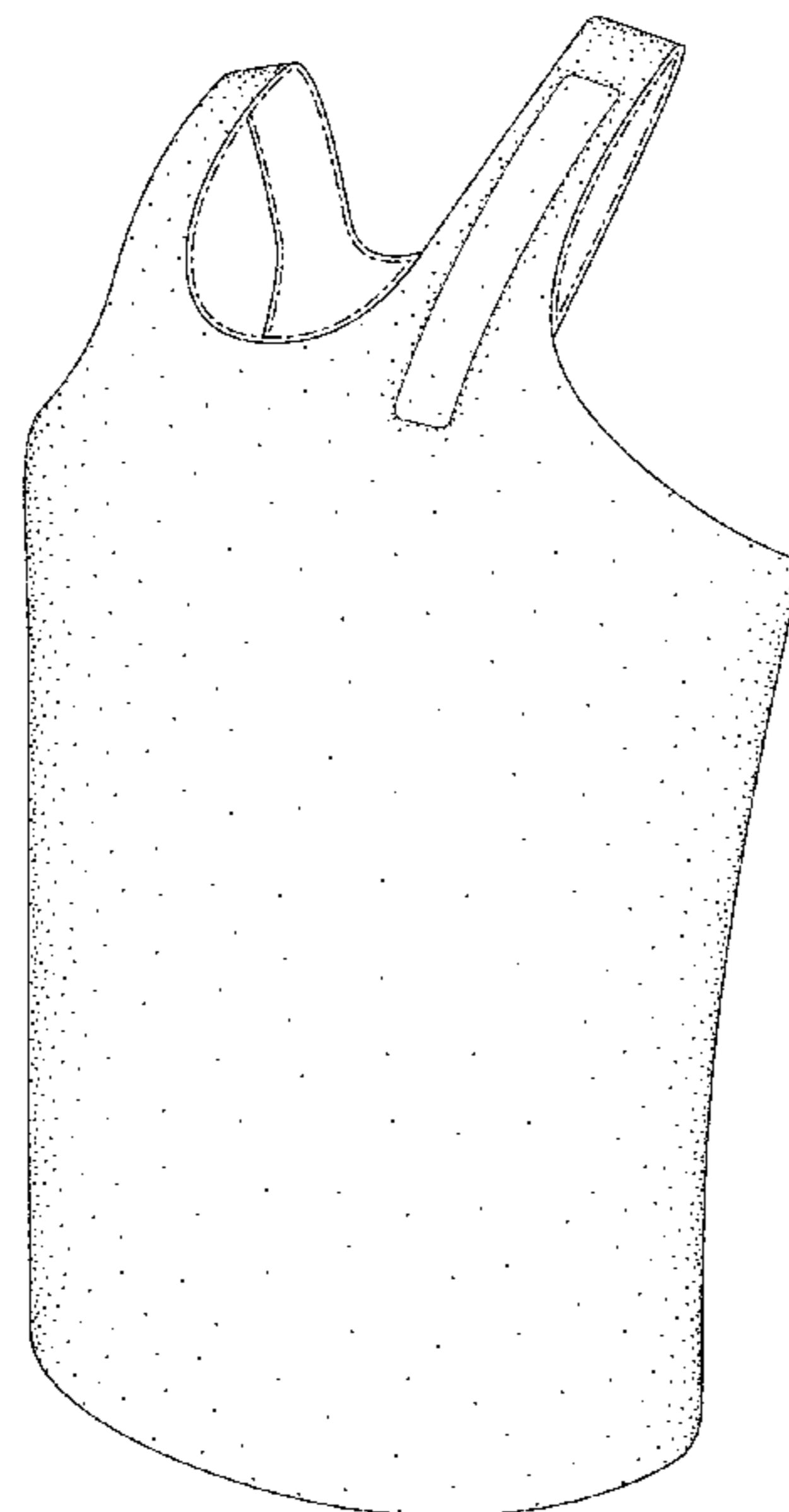
The ornamental design for a shirt, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shirt showing the new design in a first in-use non-illuminated state;
FIG. 2 is a front view thereof;
FIG. 3 is a side view thereof;
FIG. 4 is a second side view thereof;
FIG. 5 is a top view thereof;
FIG. 6 is a front perspective view of the shirt of FIG. 1-5 showing the new design in a second in-use illuminated state;
FIG. 7 is a front view thereof;
FIG. 8 is a side view thereof;
FIG. 9 is a second side view thereof; and,
FIG. 10 is a top view thereof.

The grayscale shading in FIGS. 6-10 depict an illuminated state of a rectangular illuminable element on the front of the shirt. The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof.

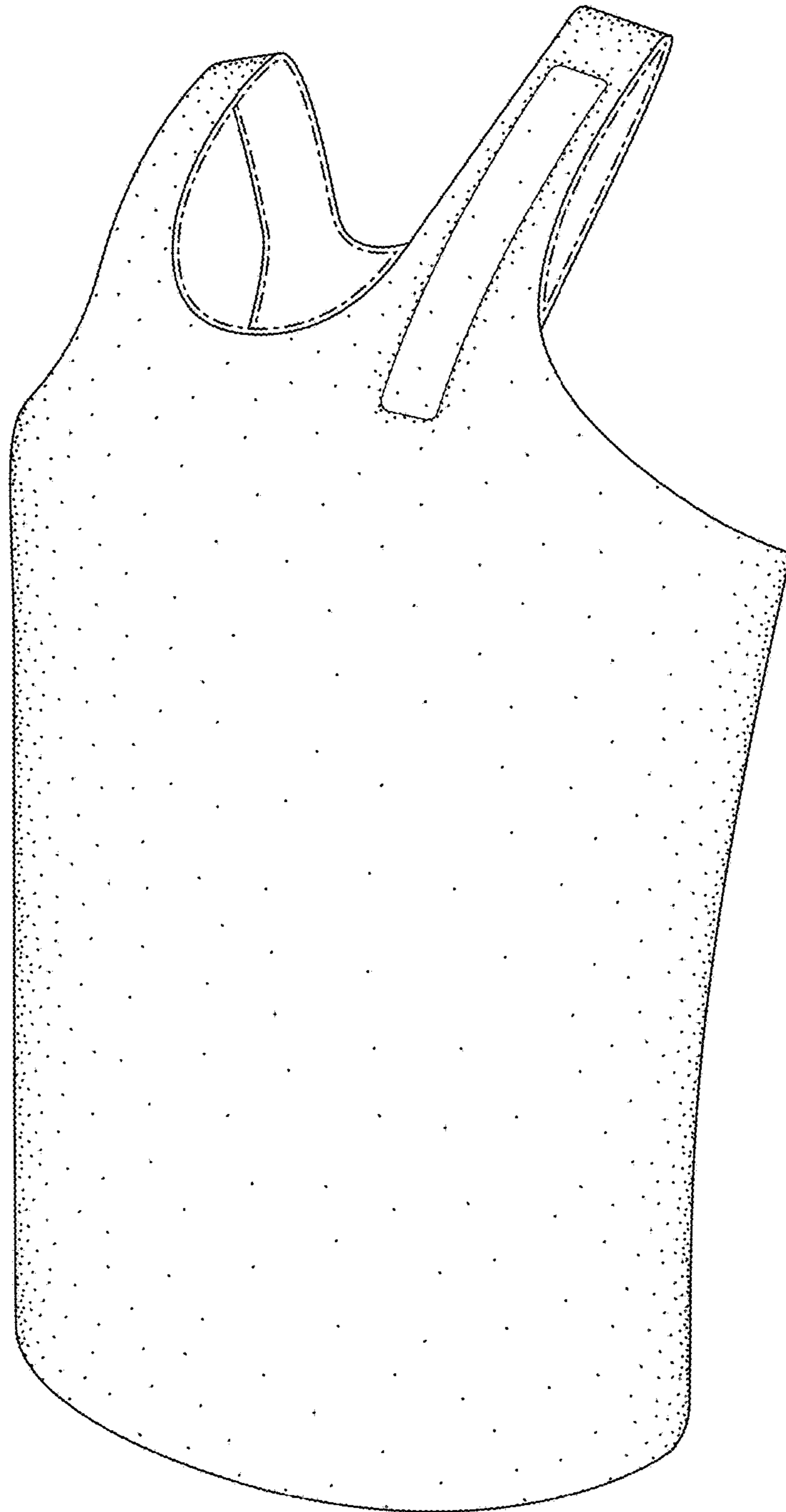

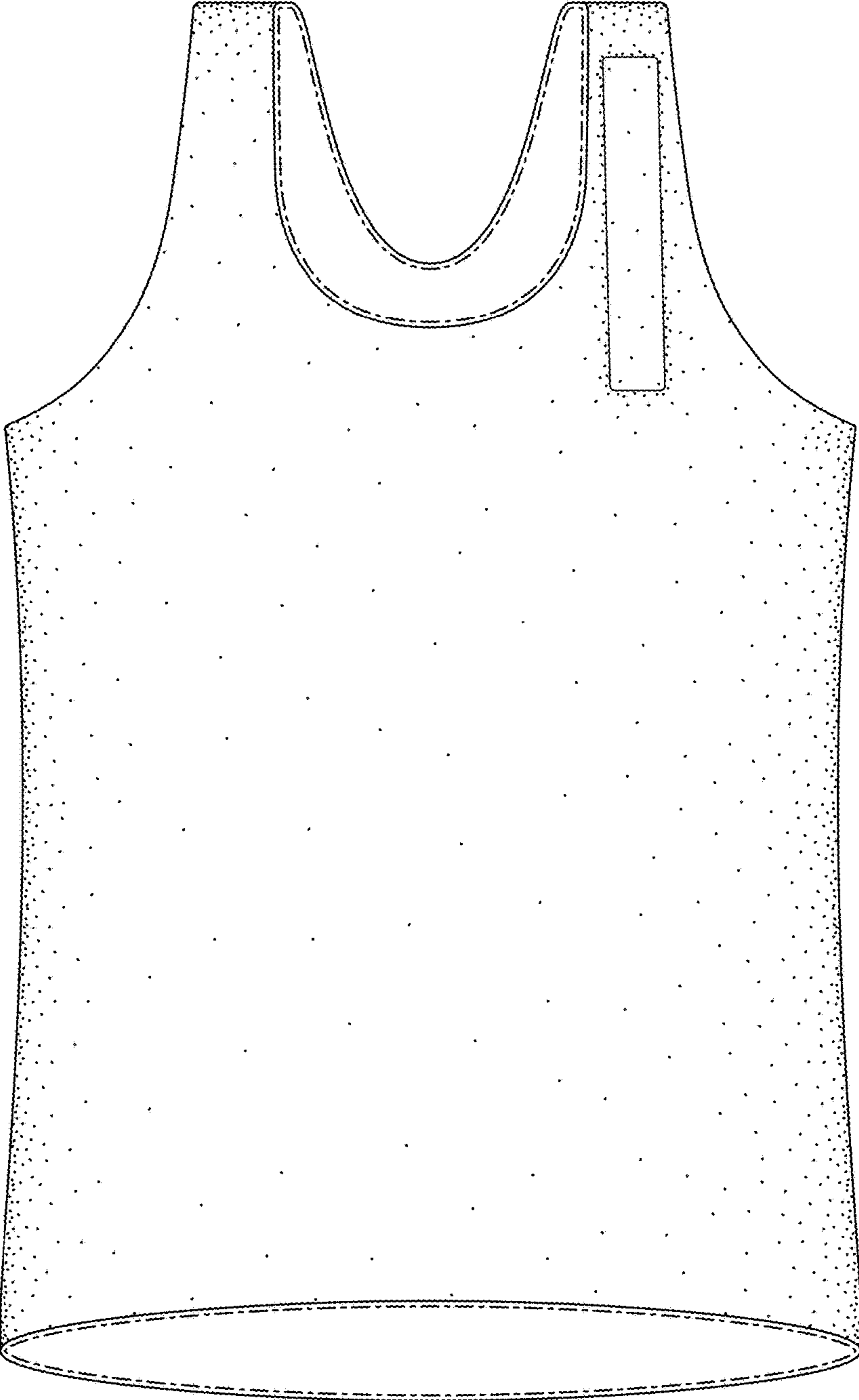

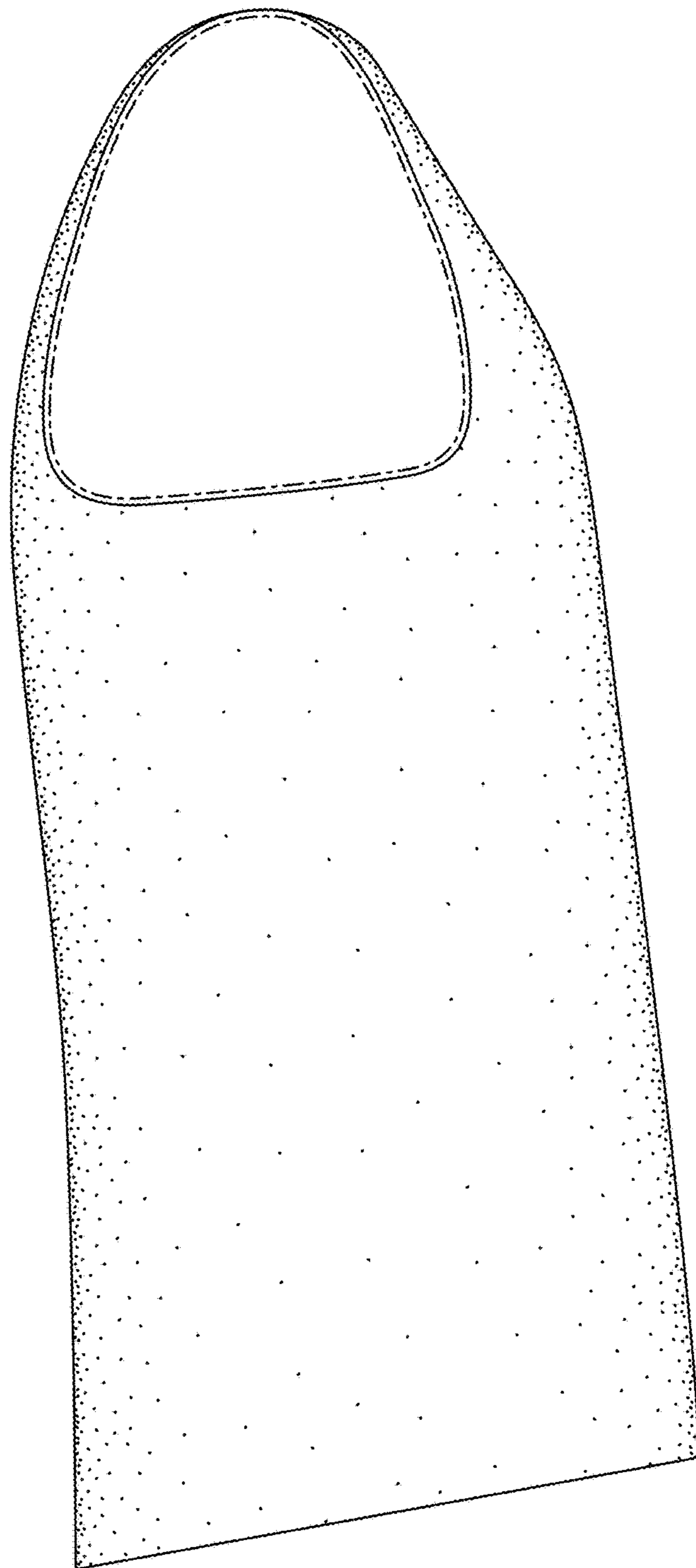

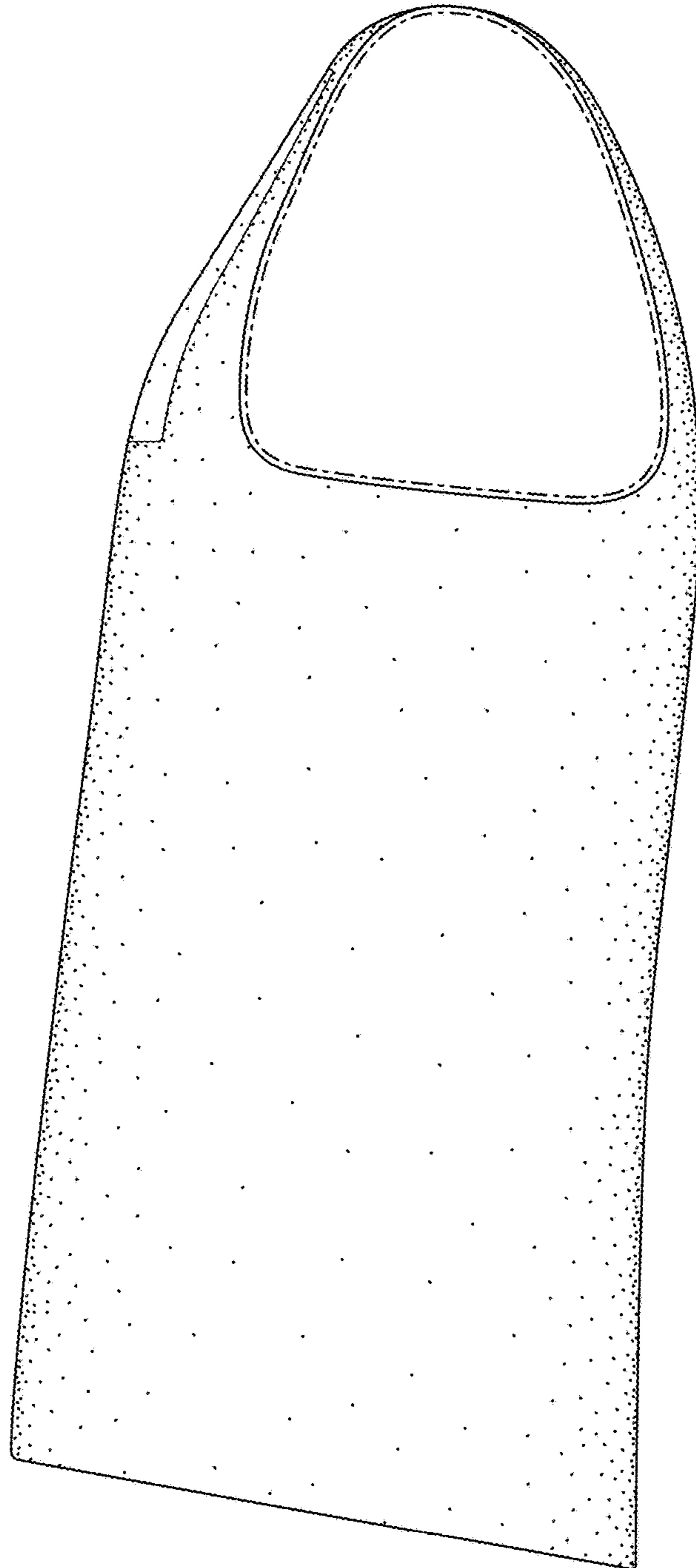

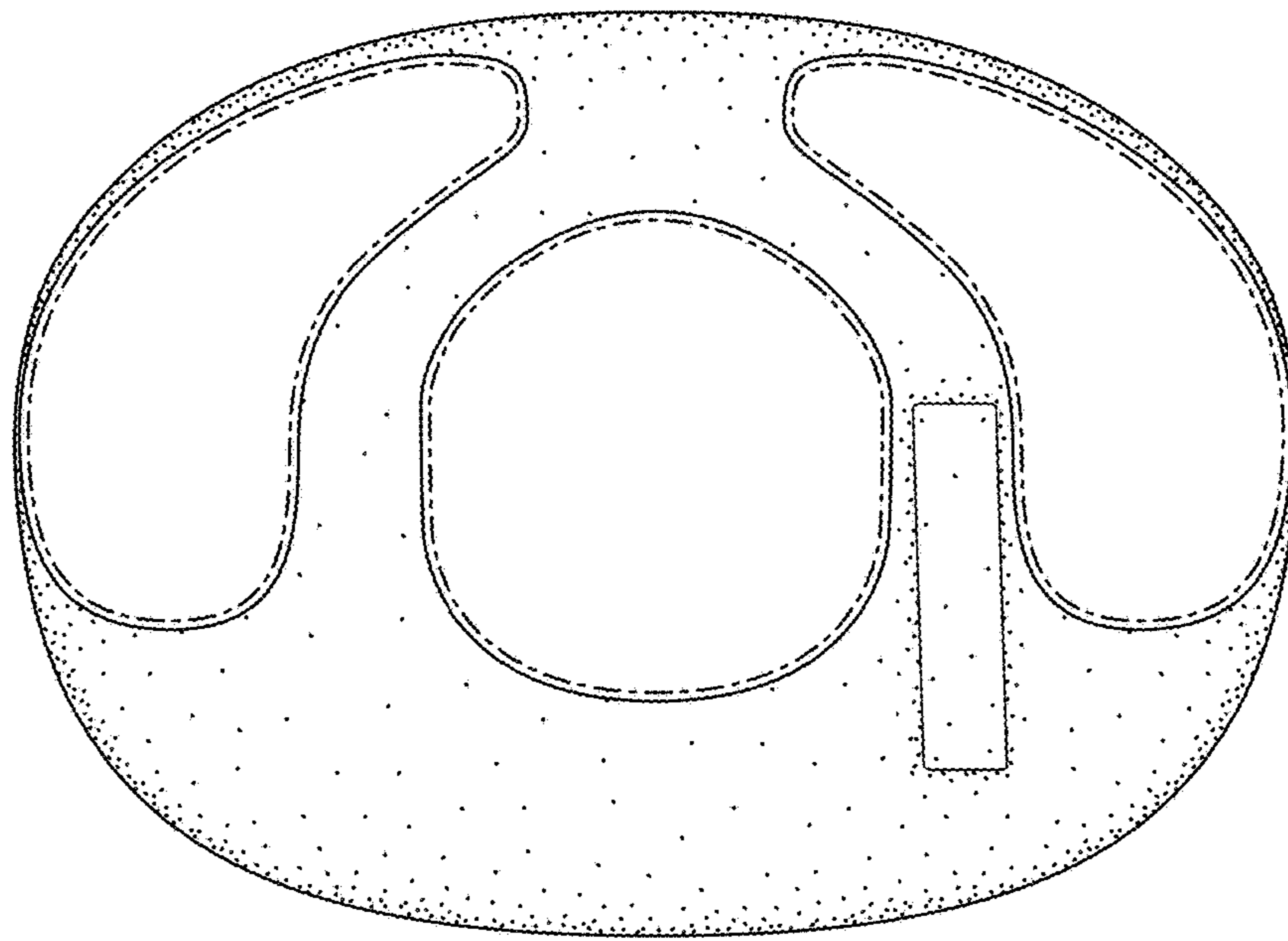

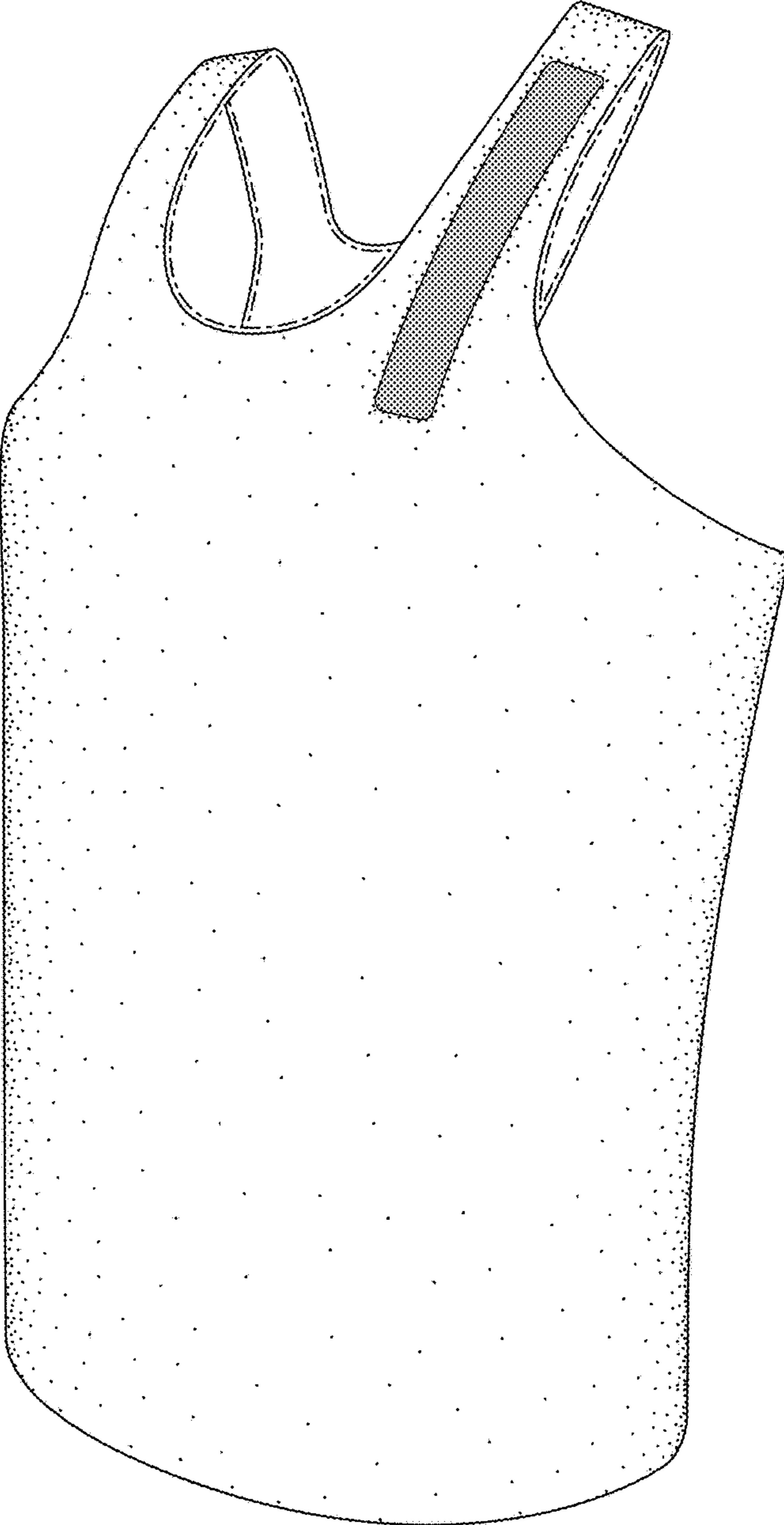

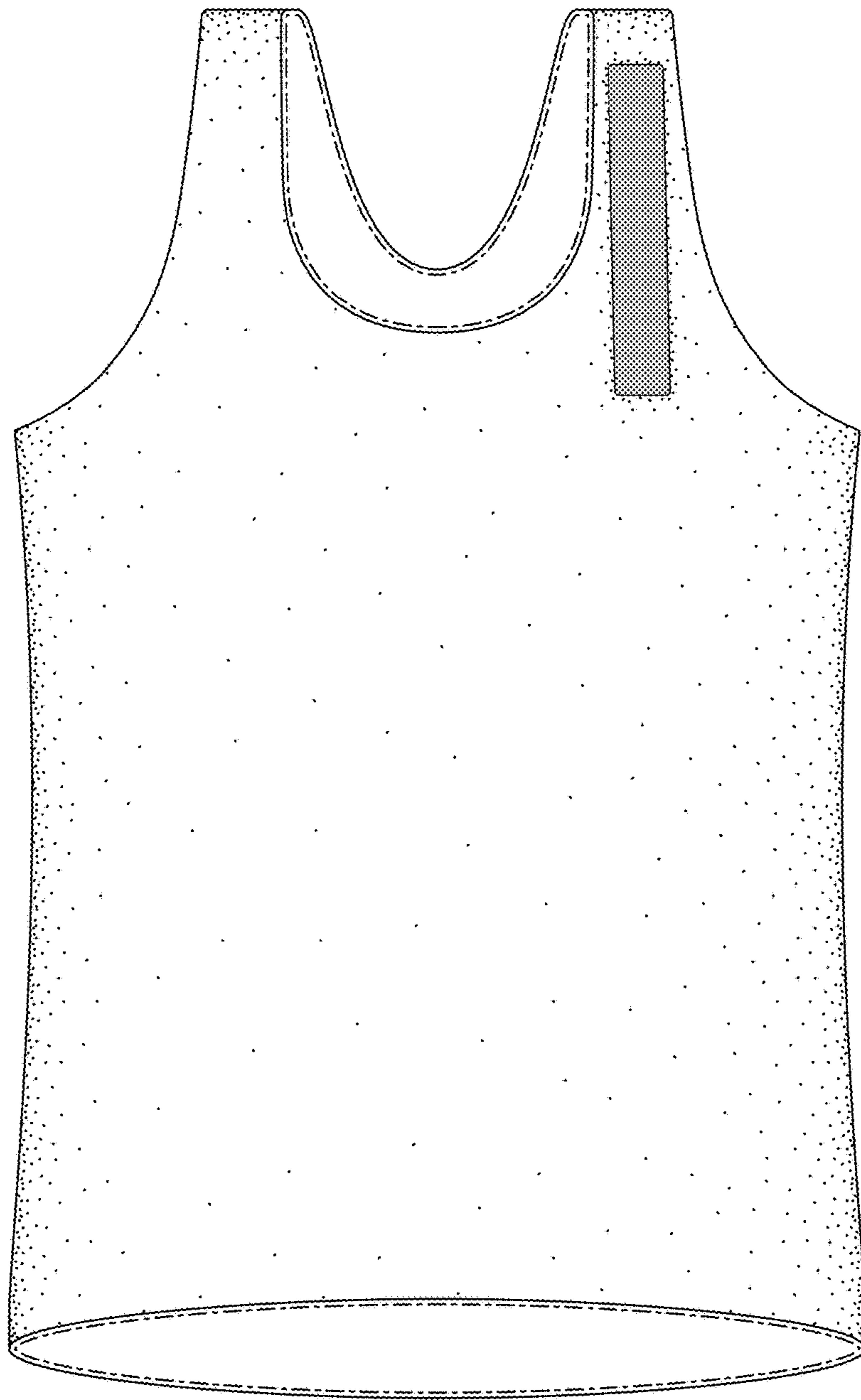

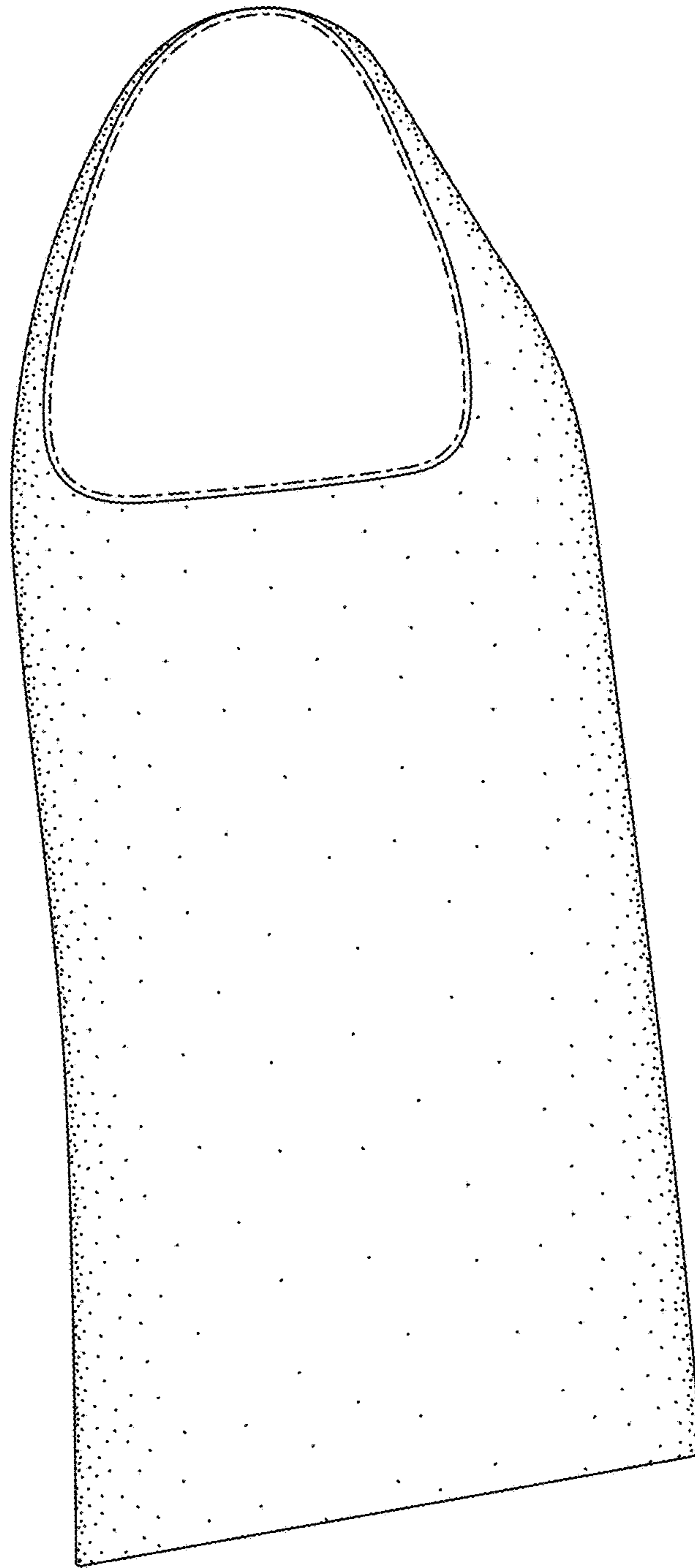

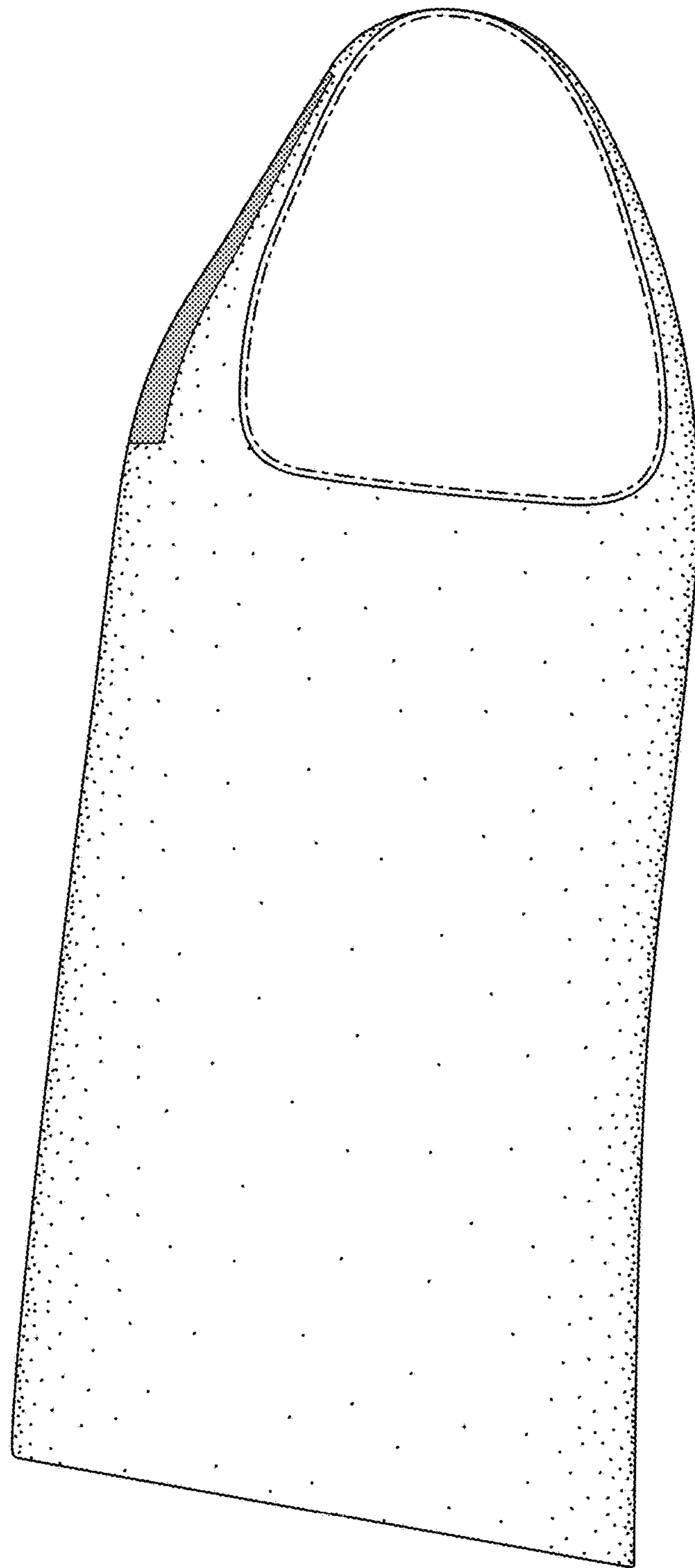

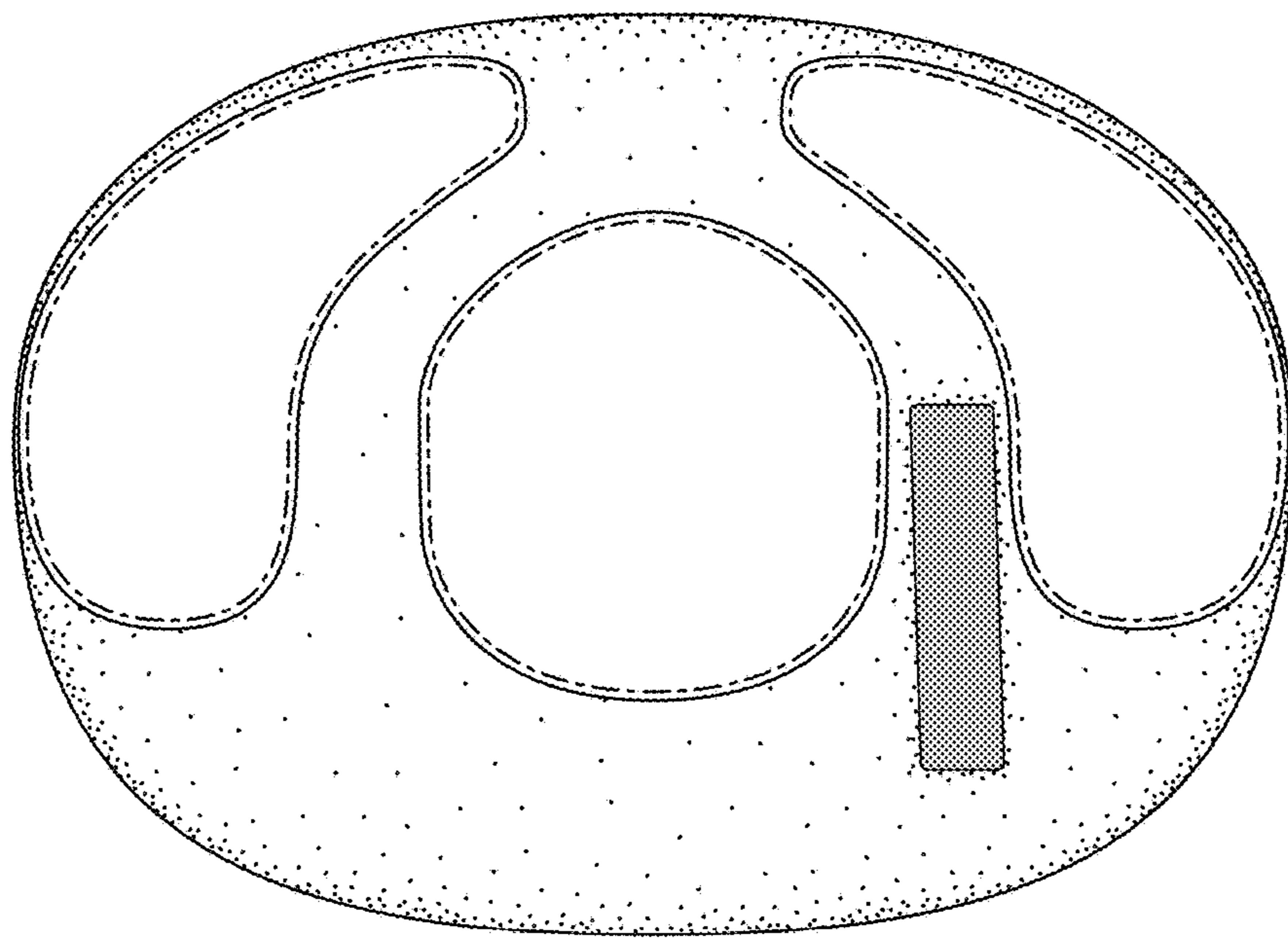
