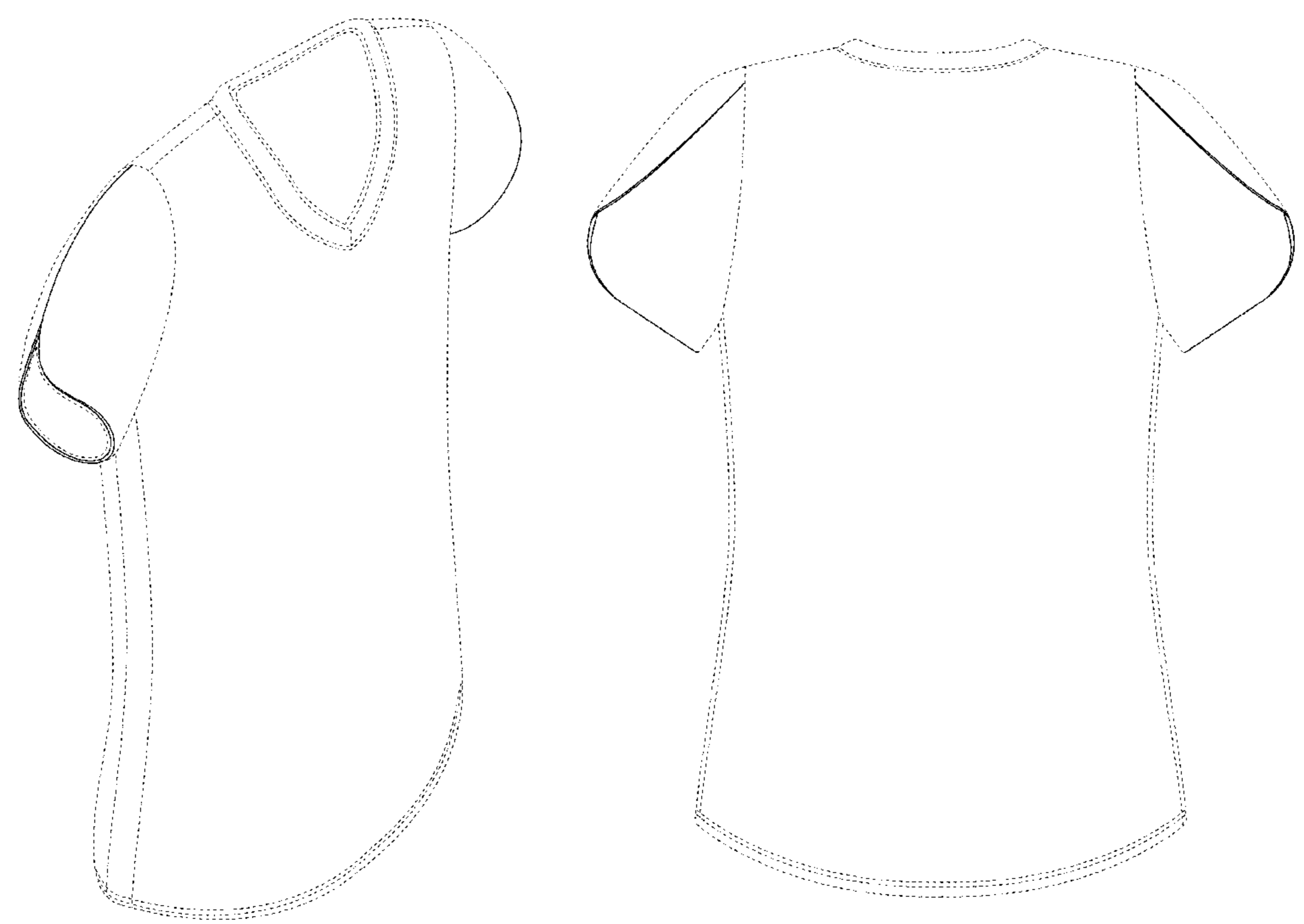

(57) **CLAIM**
The ornamental design for a jersey sleeve, as shown and described.

DESCRIPTION
FIG. 1 is a front perspective view in a fully assembled configuration according to the present design.
FIG. 2 is a front view in a fully assembled configuration of the design of FIG. 1.
FIG. 3 is a rear view in a fully assembled configuration of the design of FIG. 1.
FIG. 4 is a right side view in a fully assembled configuration of the design of FIG. 1.
FIG. 5 is a left side view in a fully assembled configuration of the design of FIG. 1.
FIG. 6 is a top view in a fully assembled configuration of the design of FIG. 1; and,
FIG. 7 is a bottom view in a fully assembled configuration of the design of FIG. 1.
The claimed design comprises the elements shown in solid lines. The broken lines showing the jersey form no part of the claimed design.

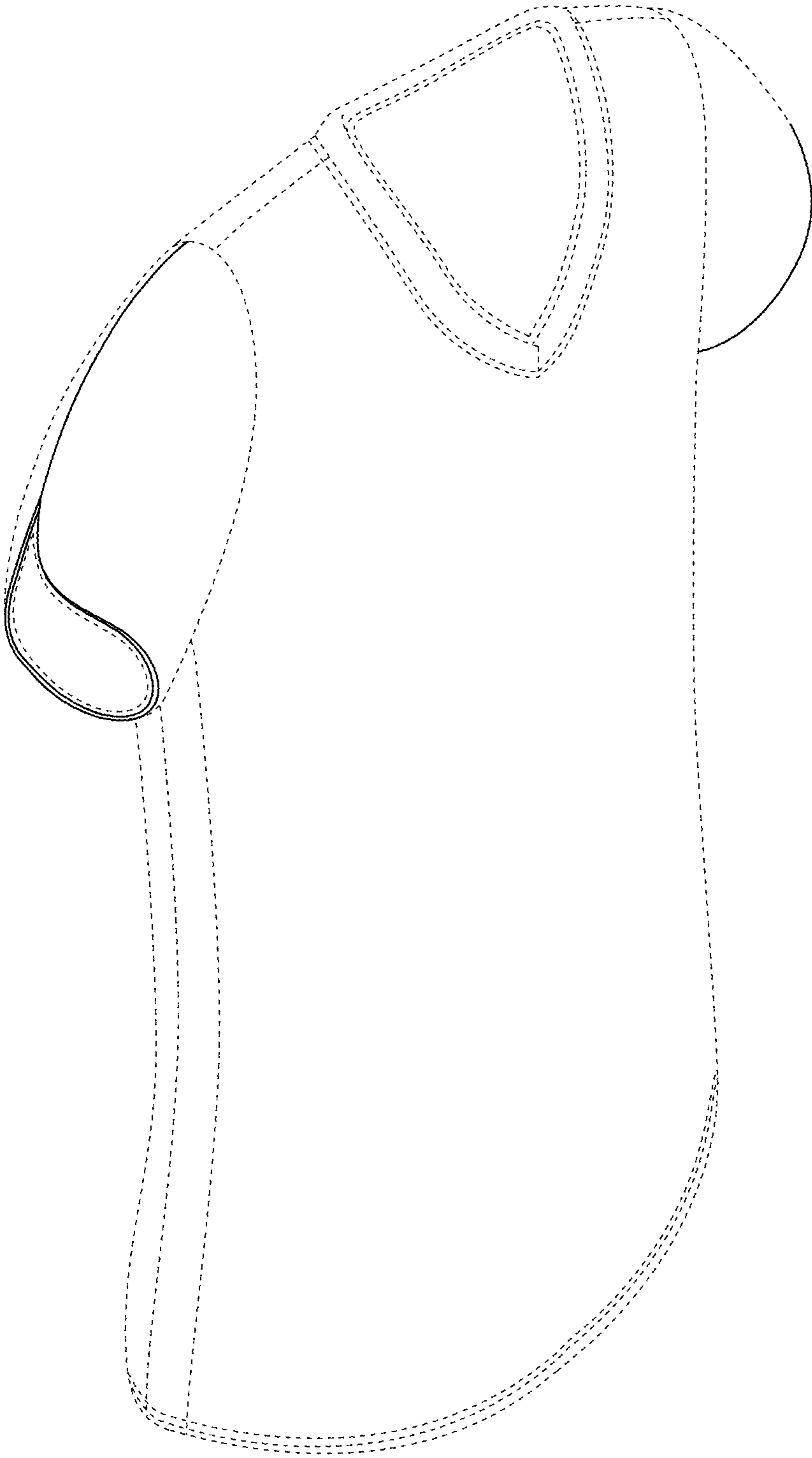

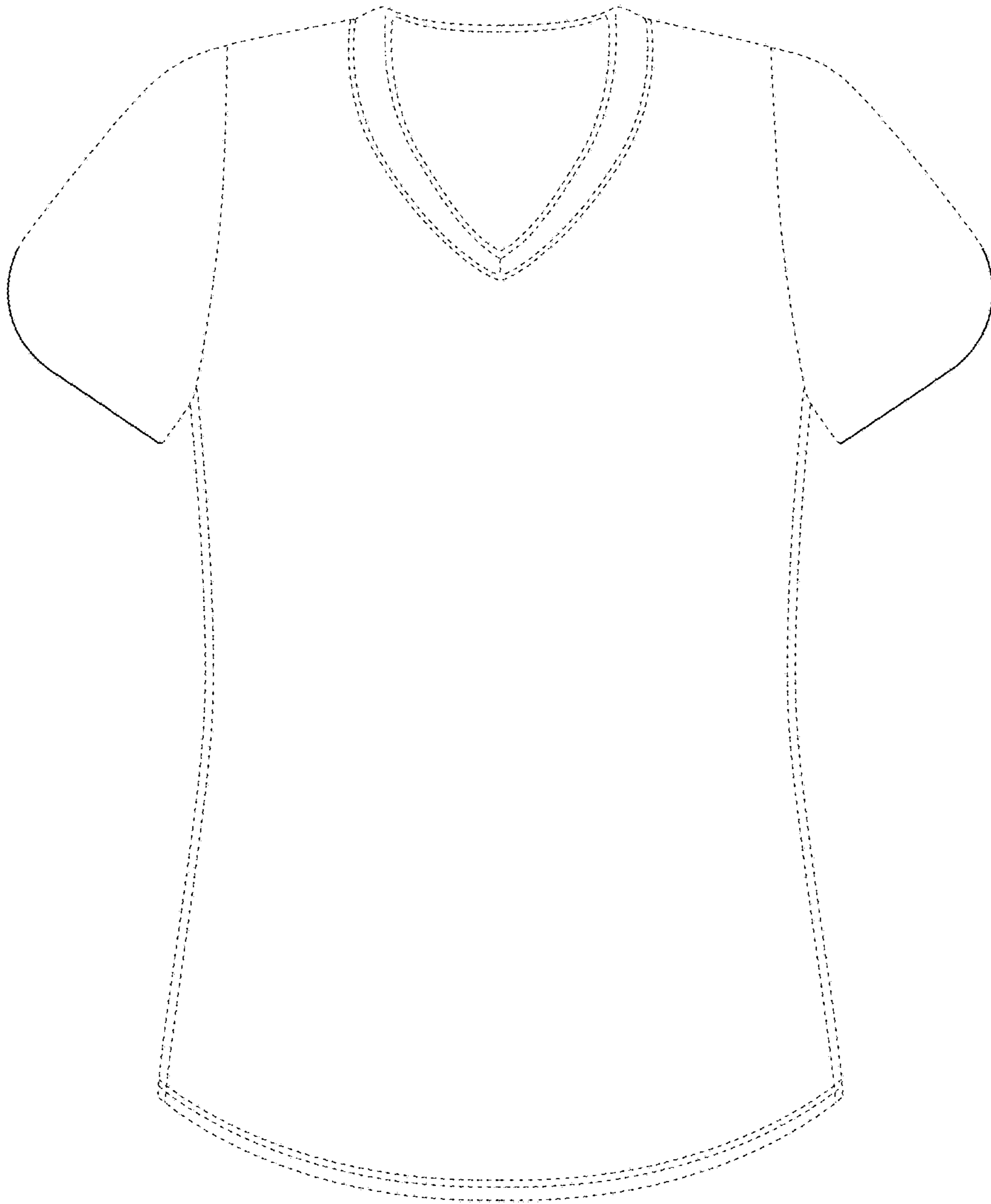

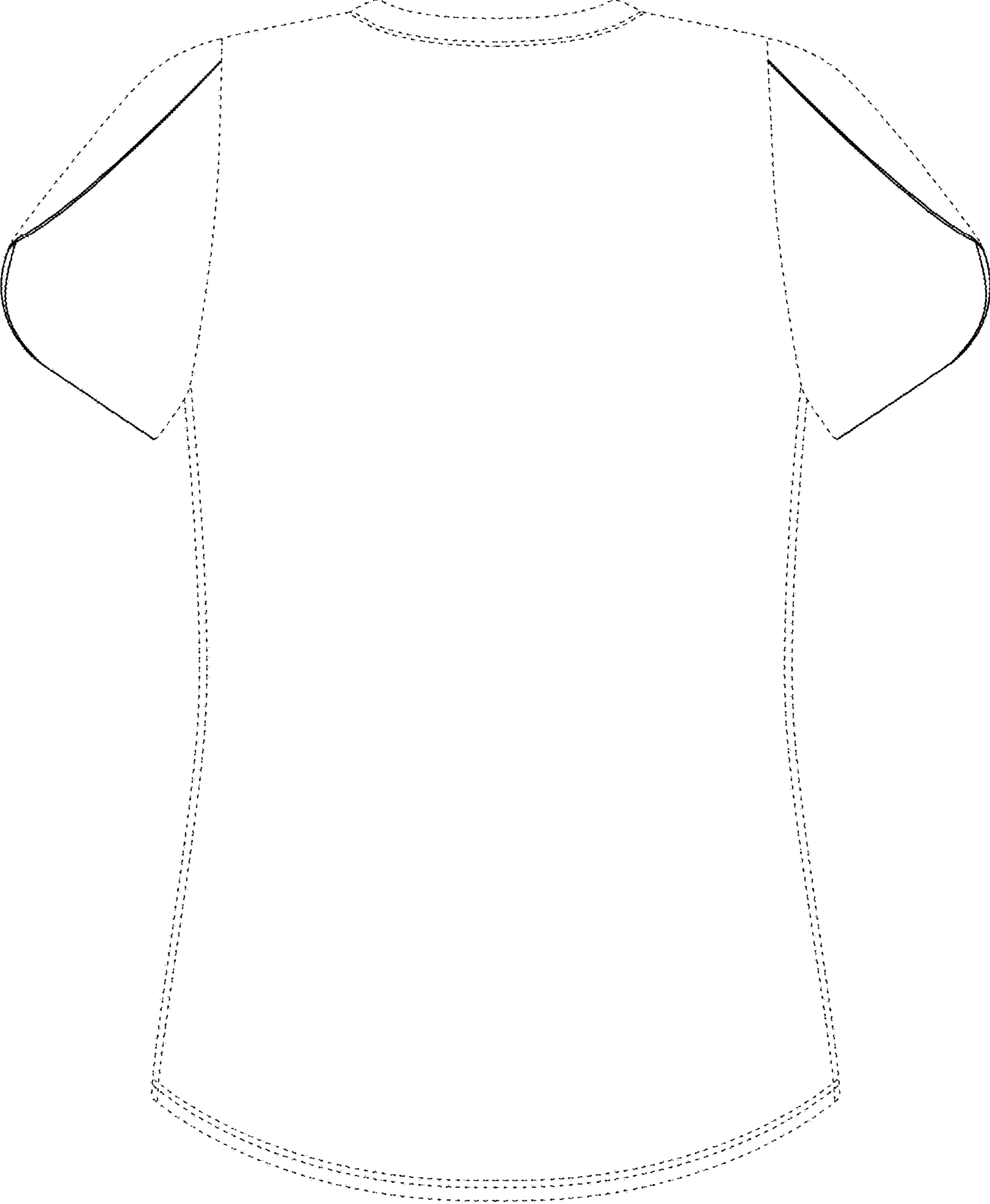

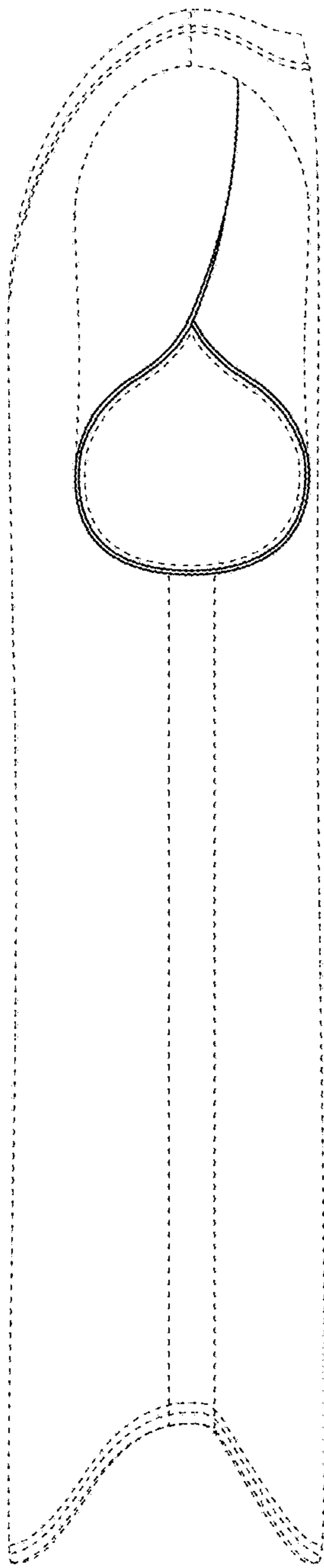

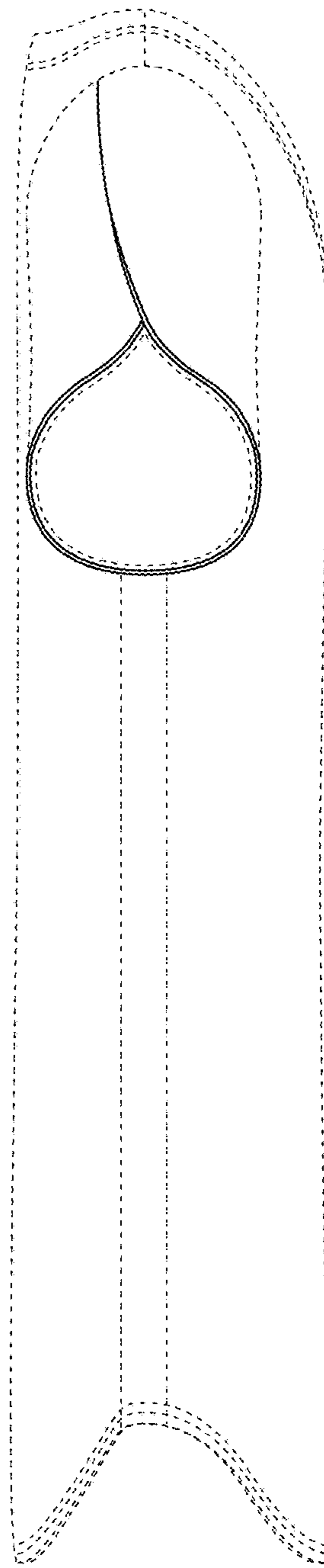

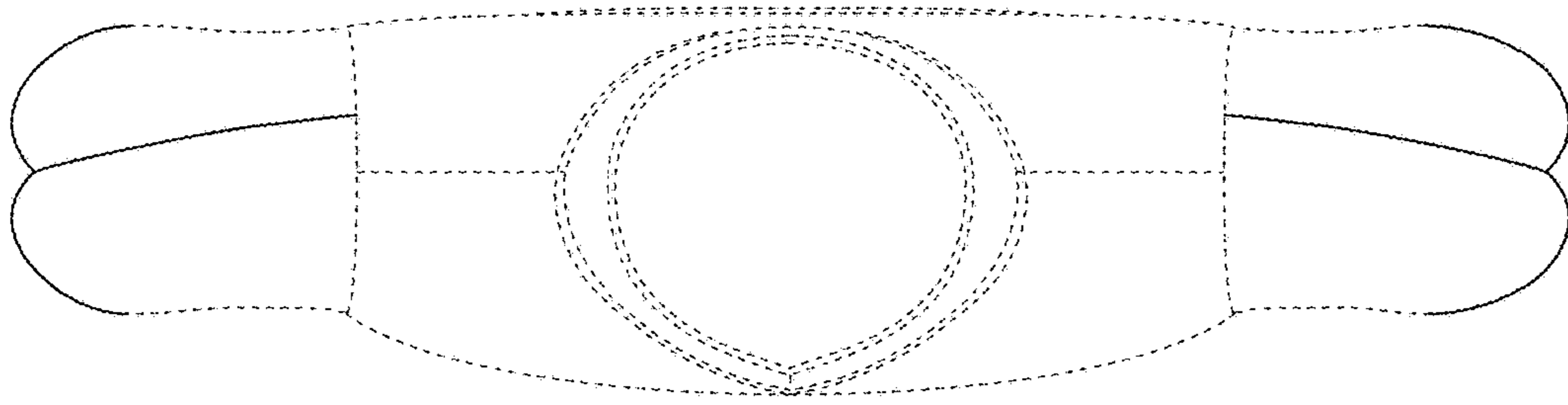

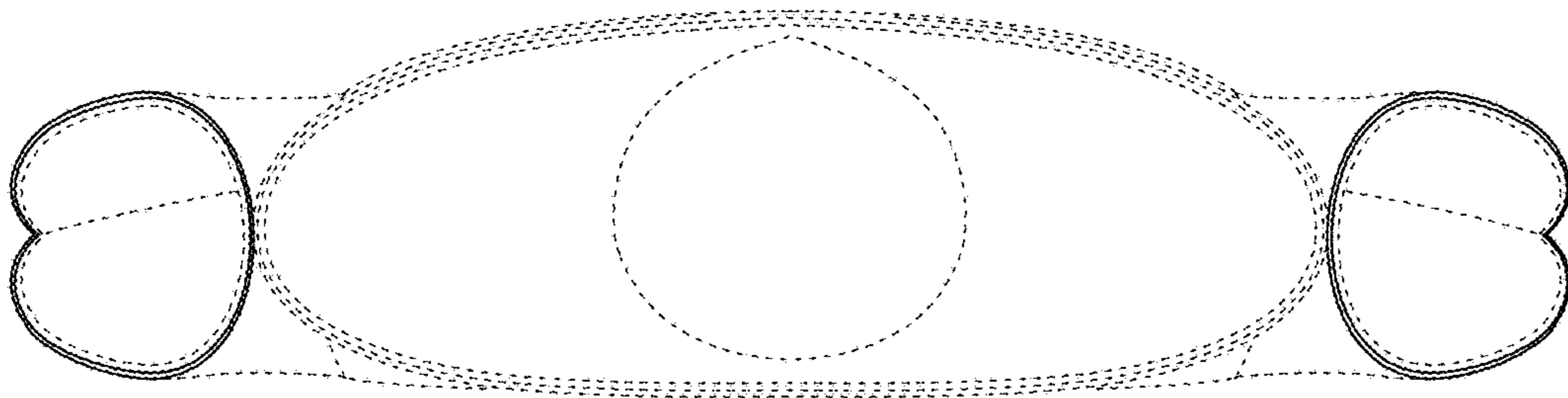
