(57) **CLAIM**

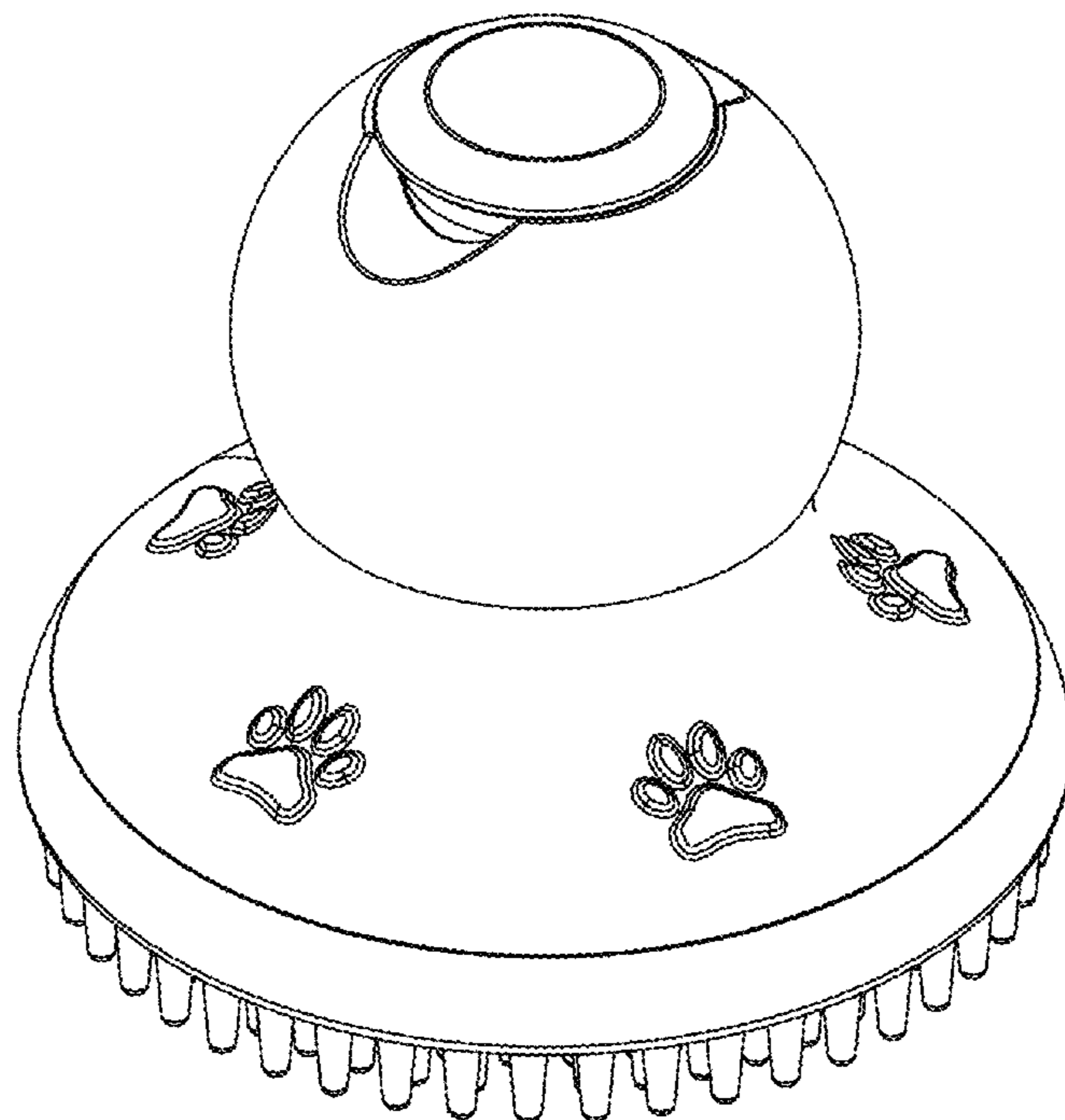
The ornamental design for a soap dispensing brush, as shown and described.

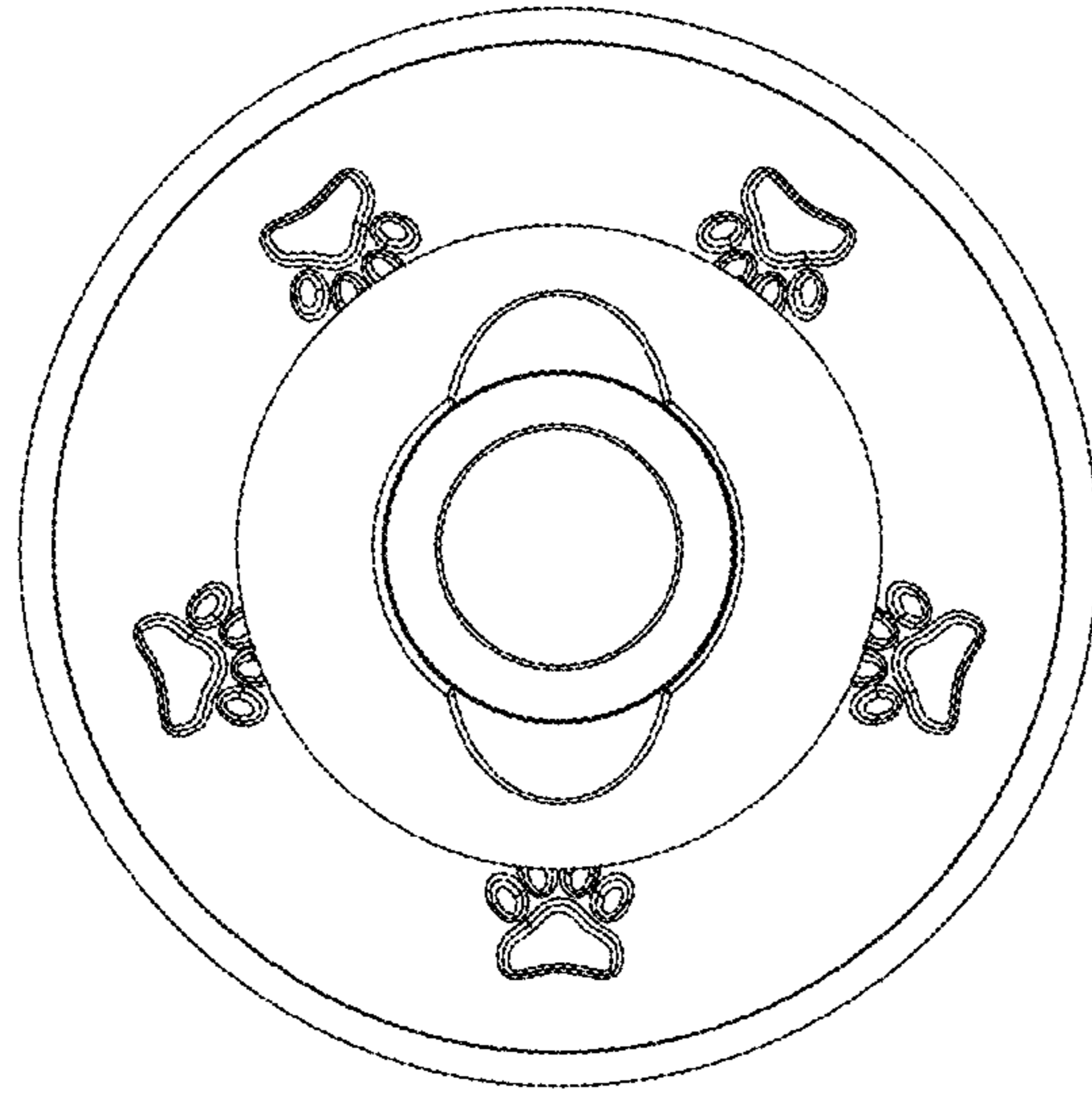

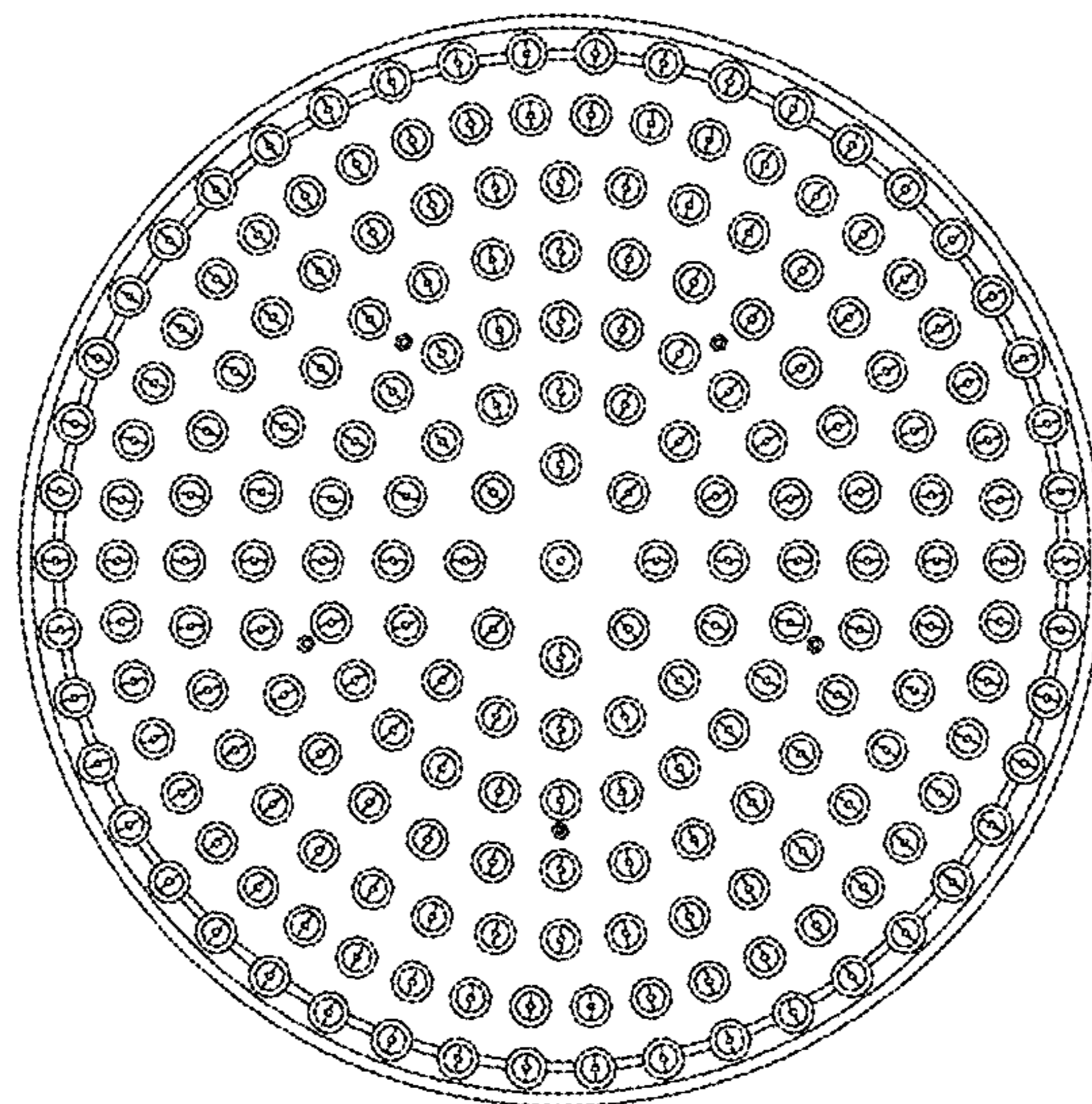

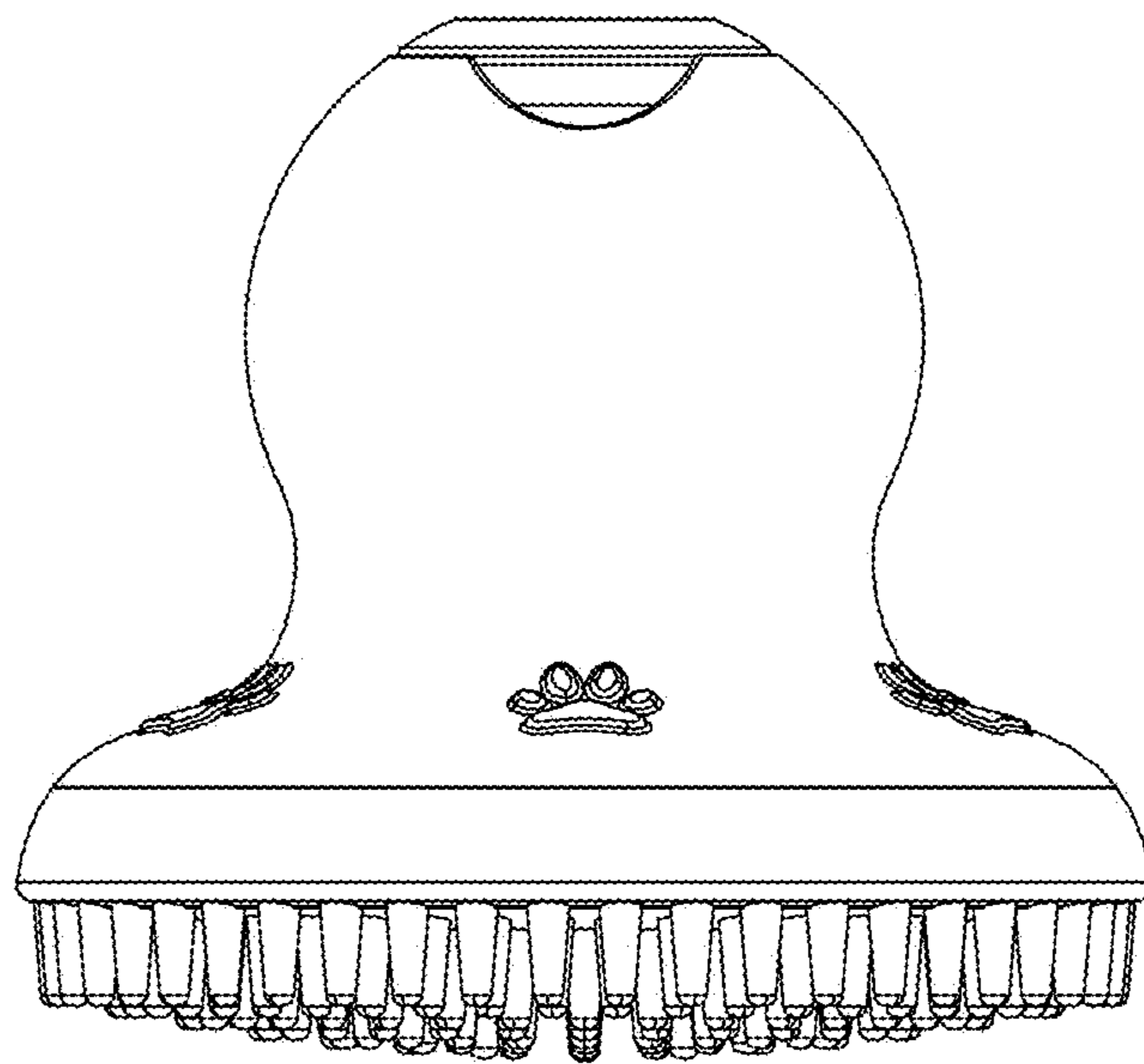

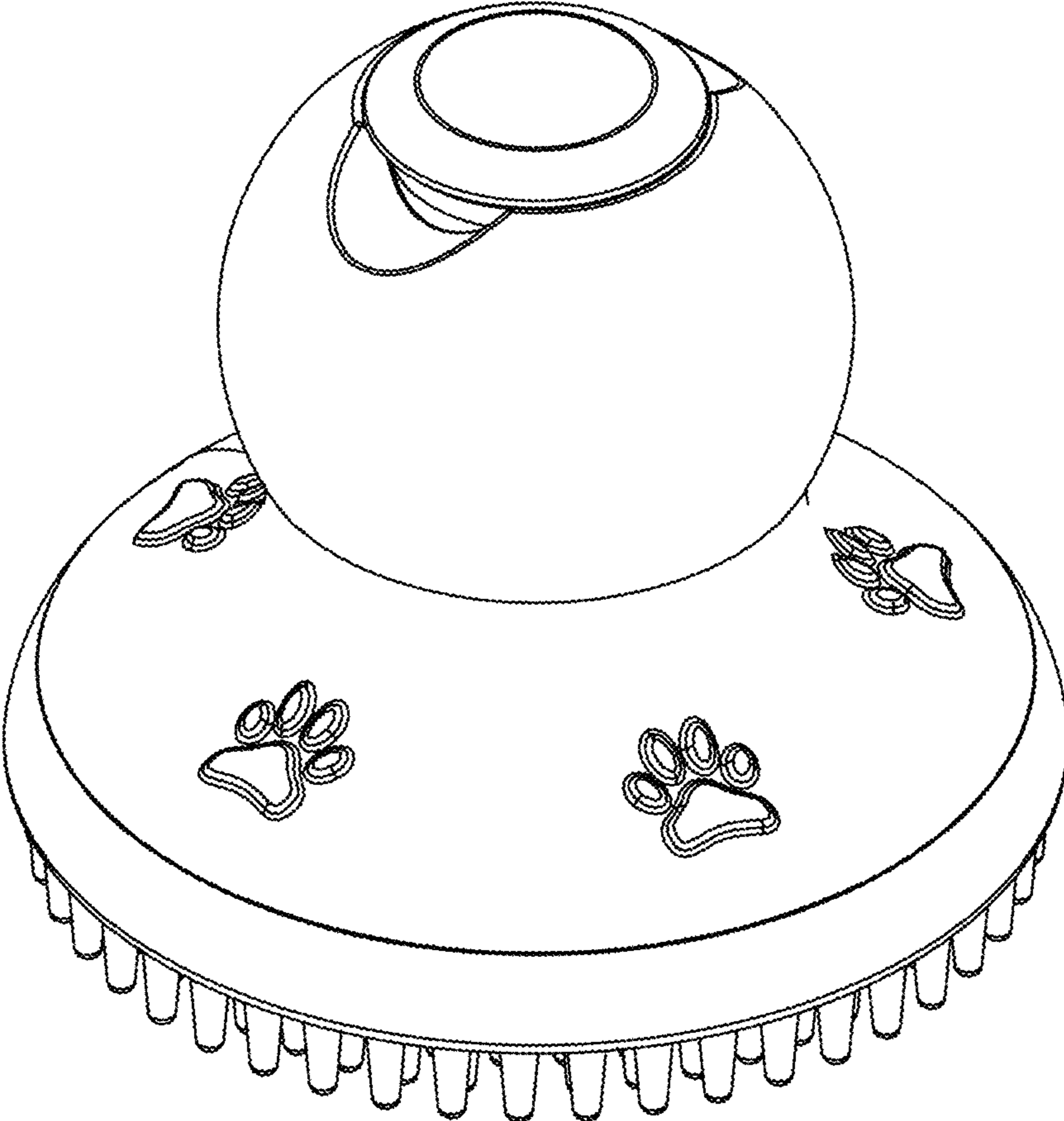

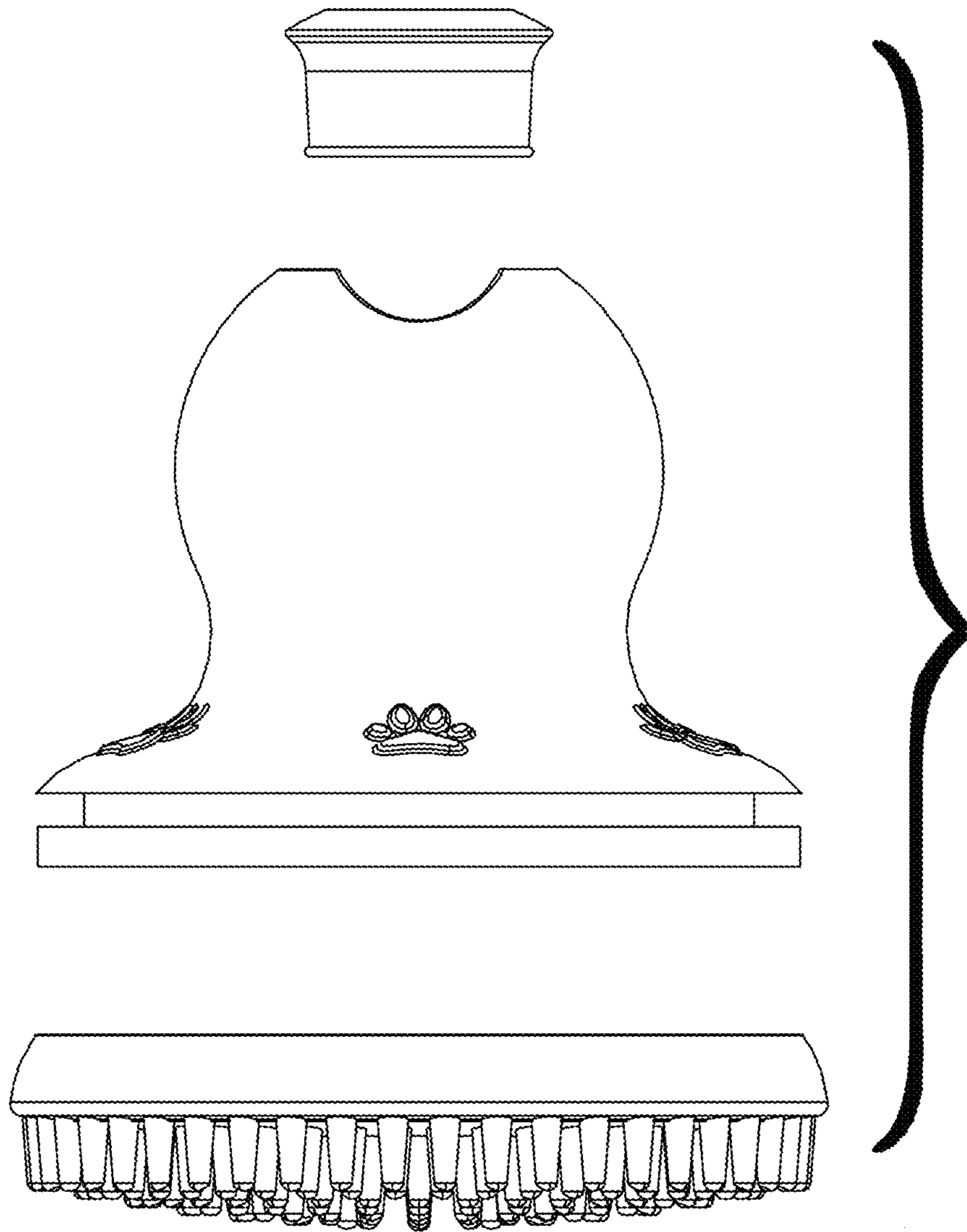

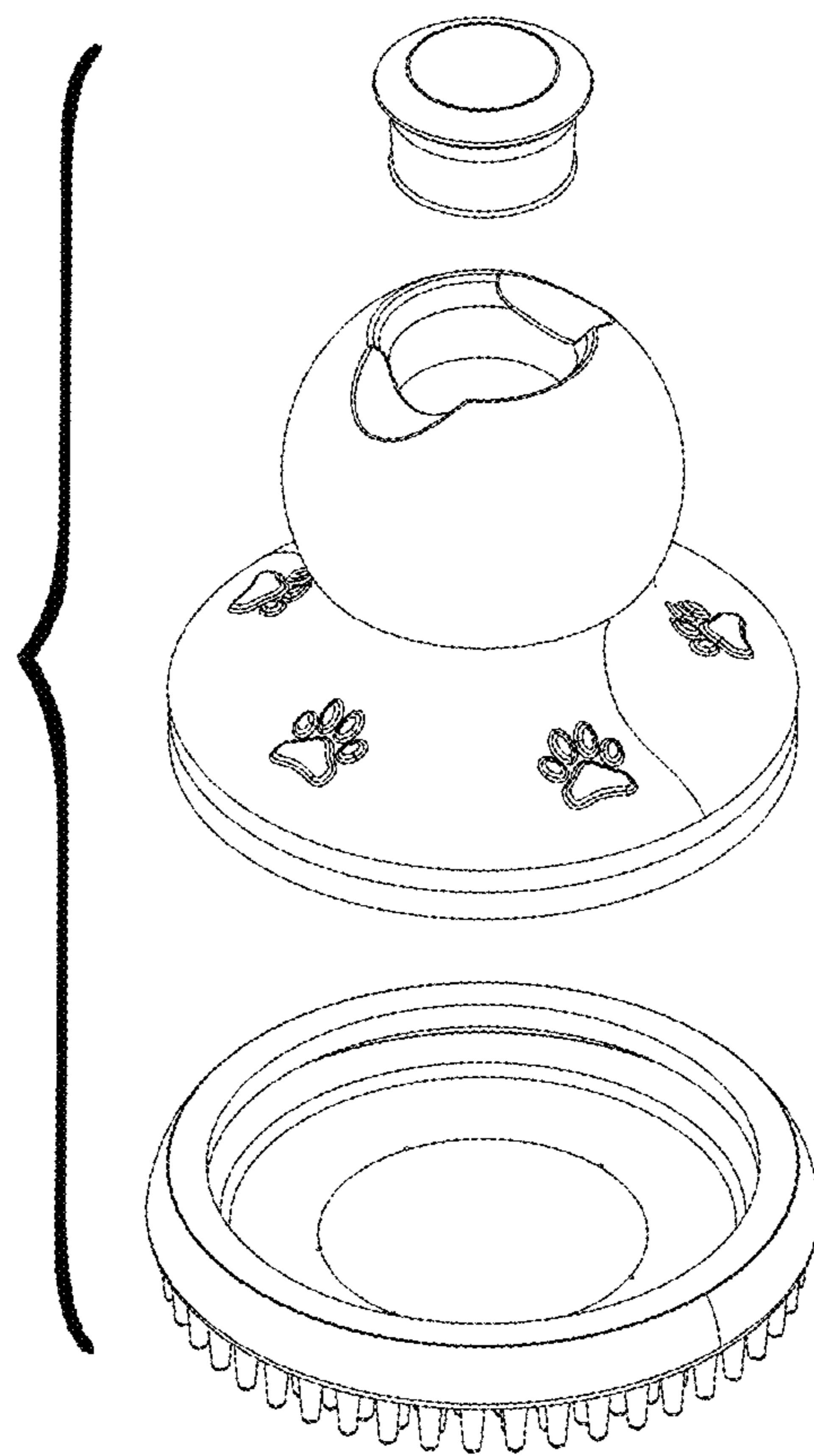
