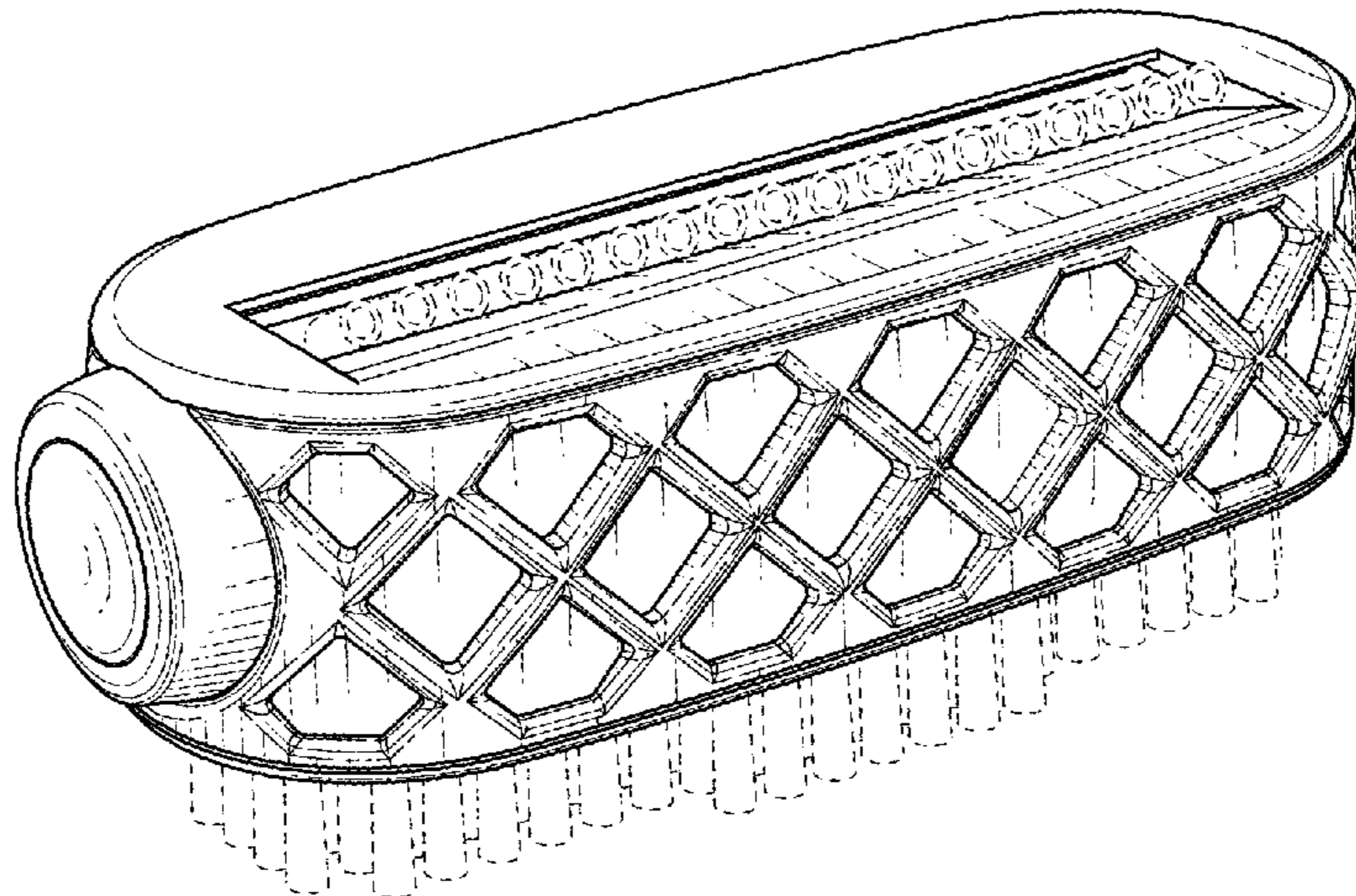
(57) **CLAIM**

The ornamental design for a nail brush base, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a nail brush base showing my new design;  
FIG. 2 is a side elevation view thereof;  
FIG. 3 is another side elevation view thereof;  
FIG. 4 is an end elevation view thereof;  
FIG. 5 is another end elevation view thereof;  
FIG. 6 is a top plan view thereof; and,

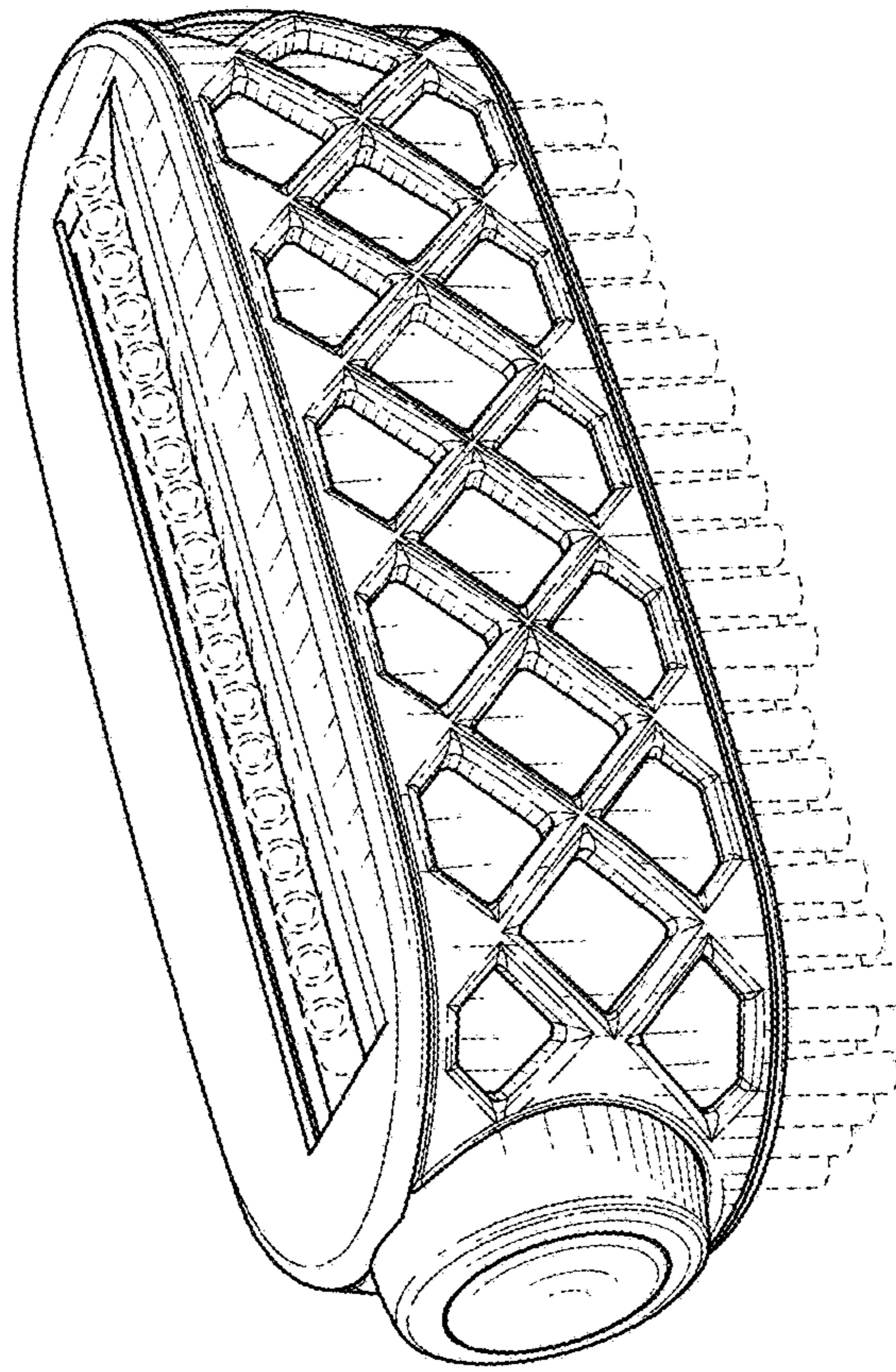

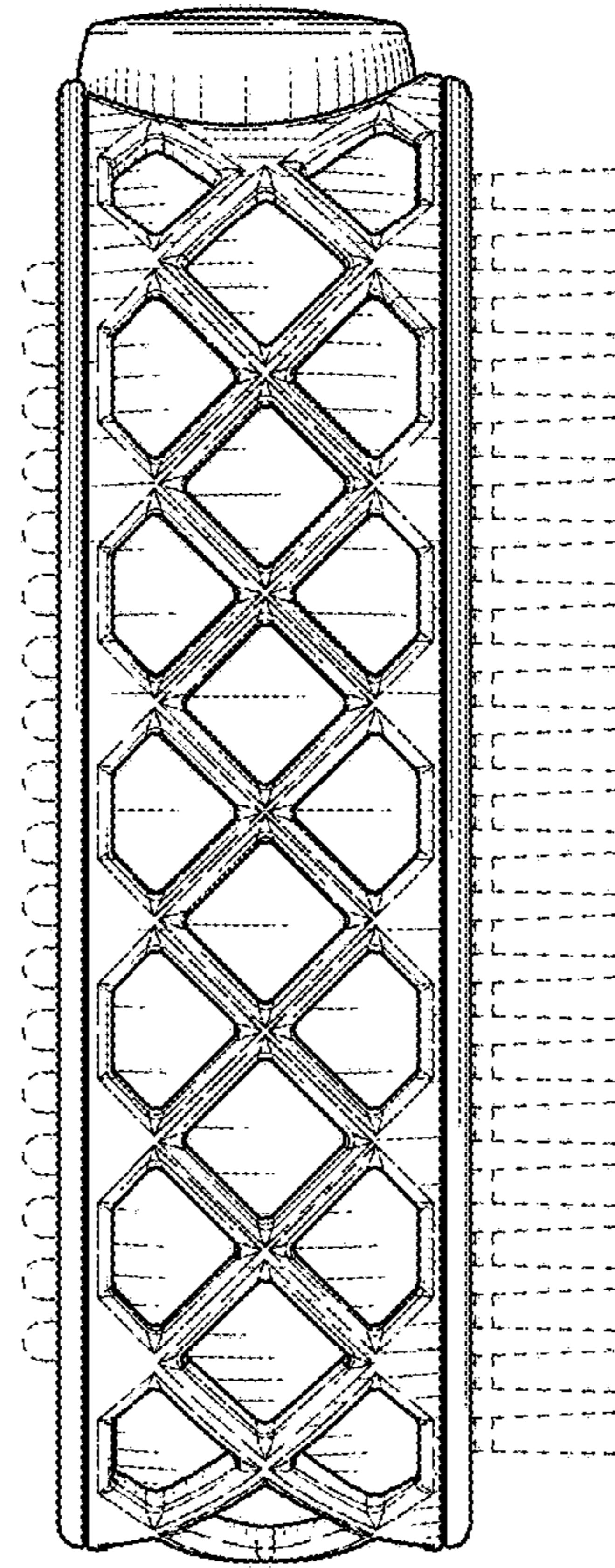

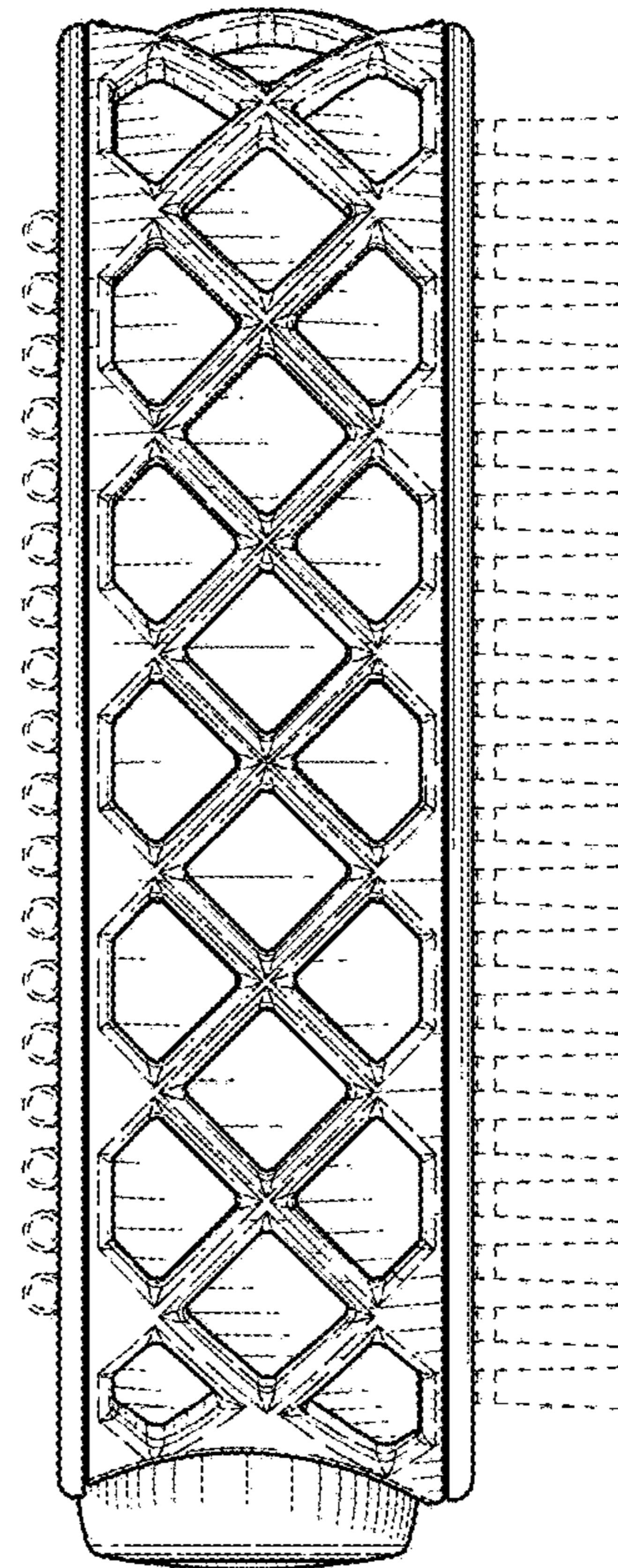

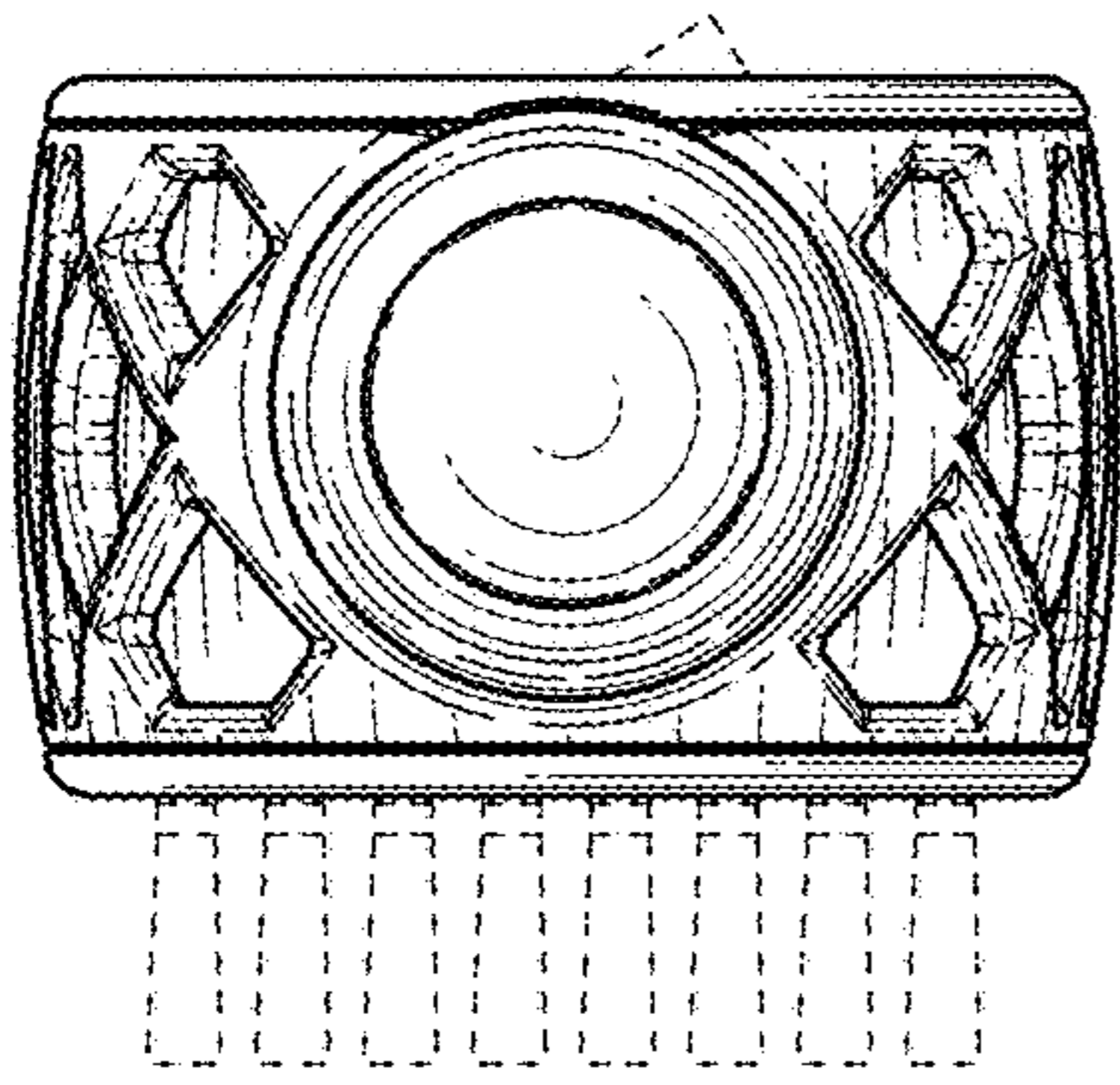

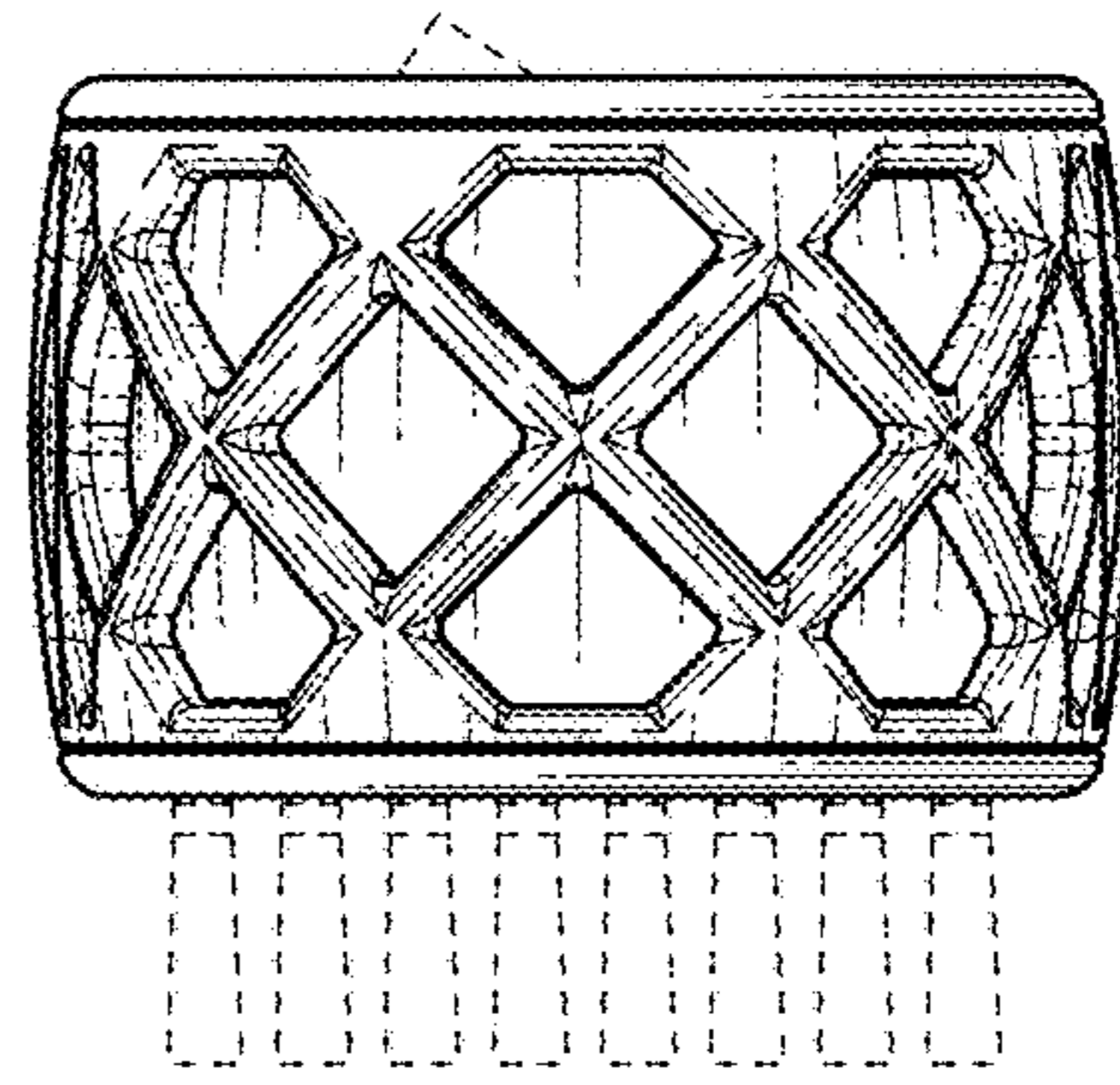

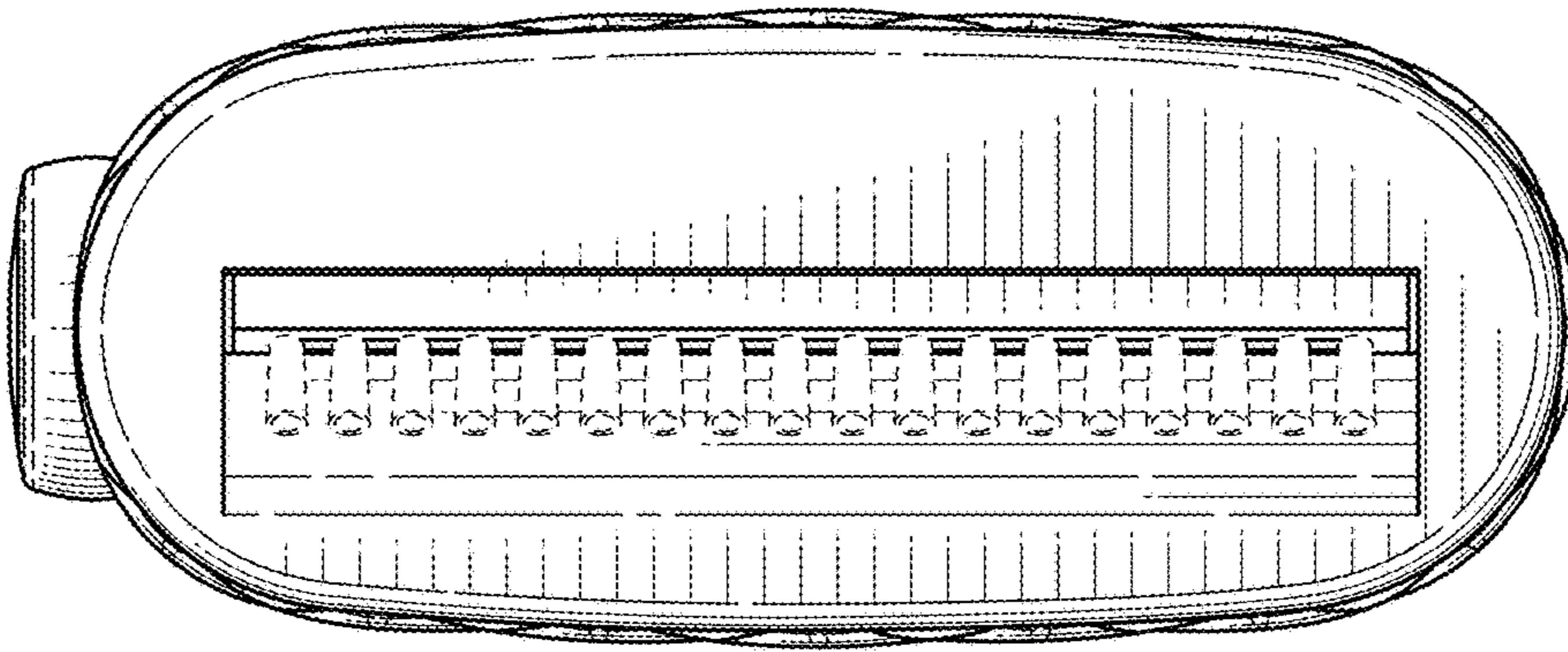

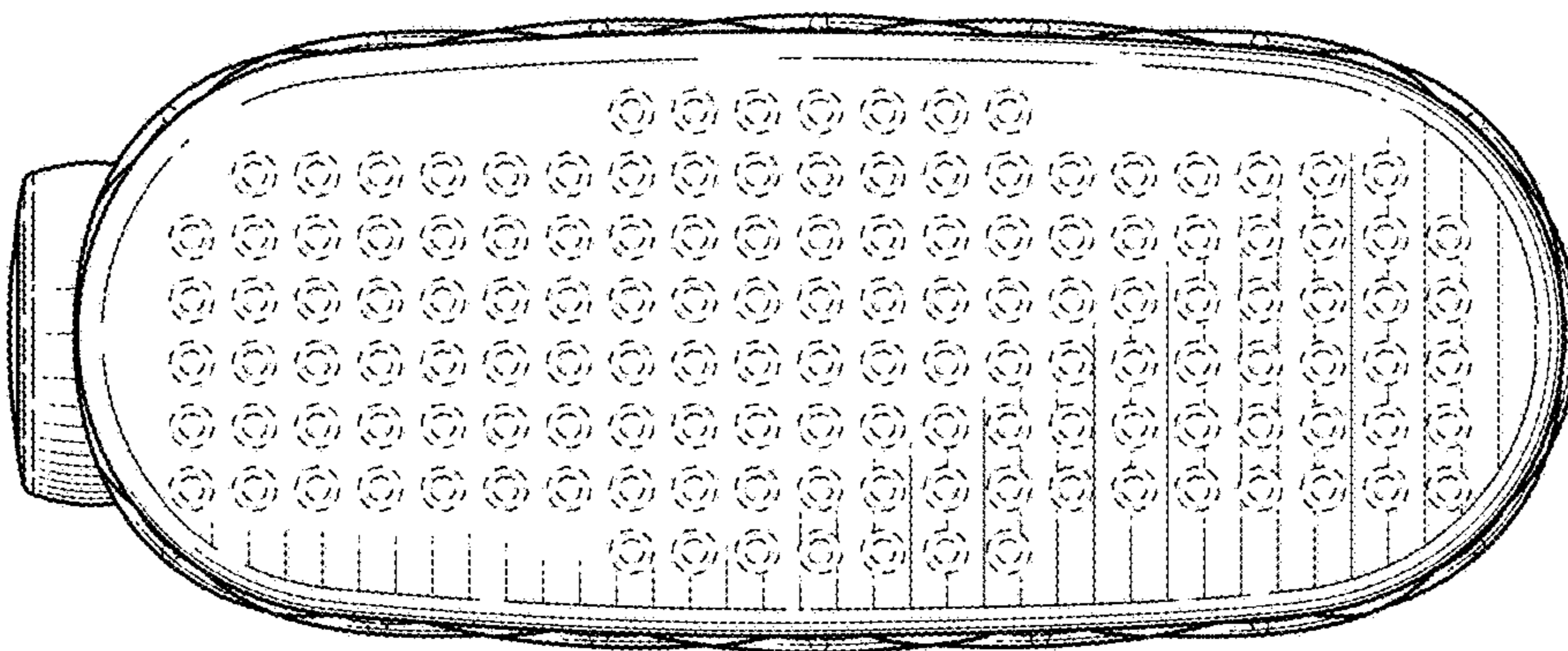
