FIG. 3 is a front view of the chair, as shown in FIG. 1;

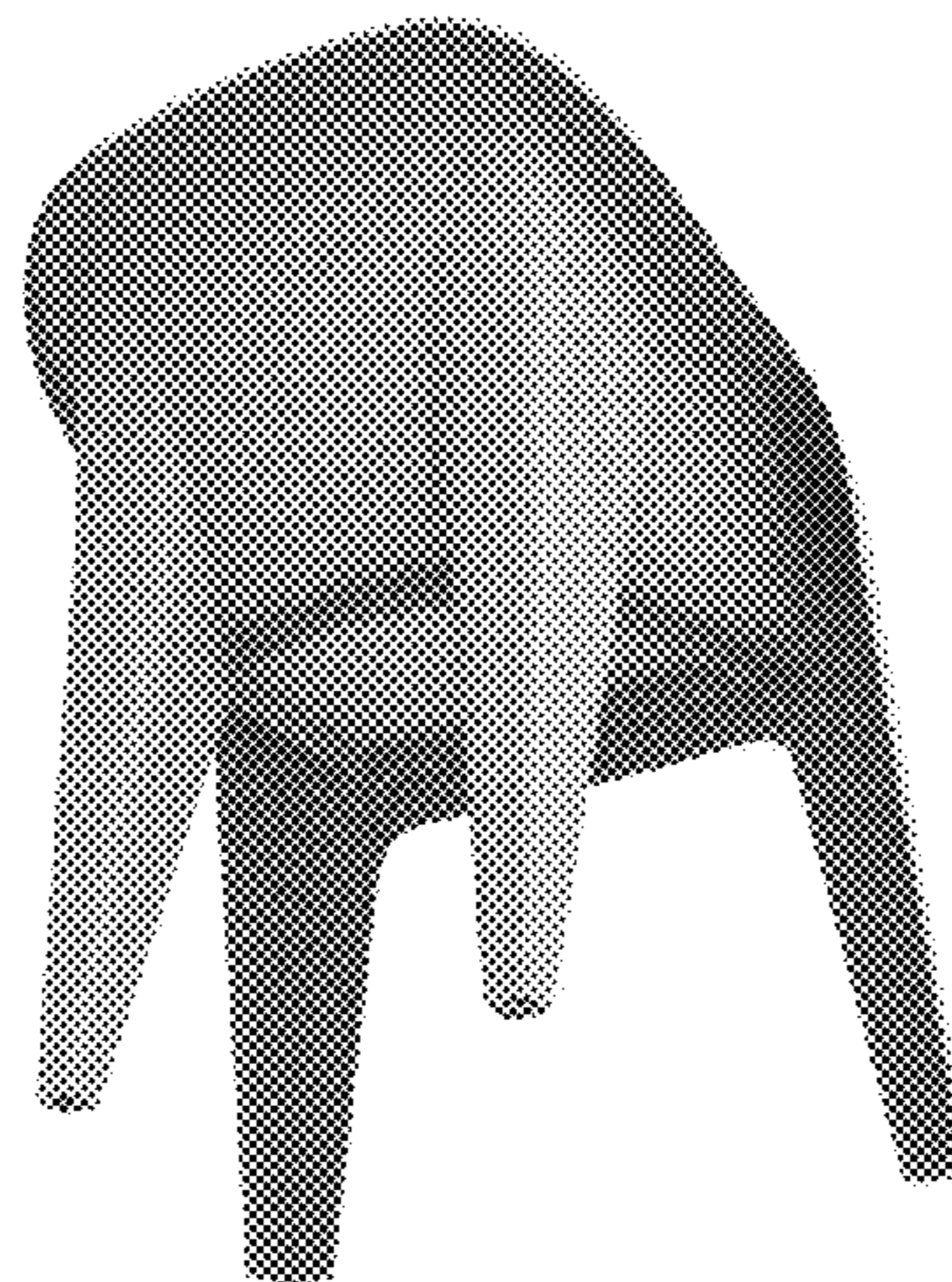
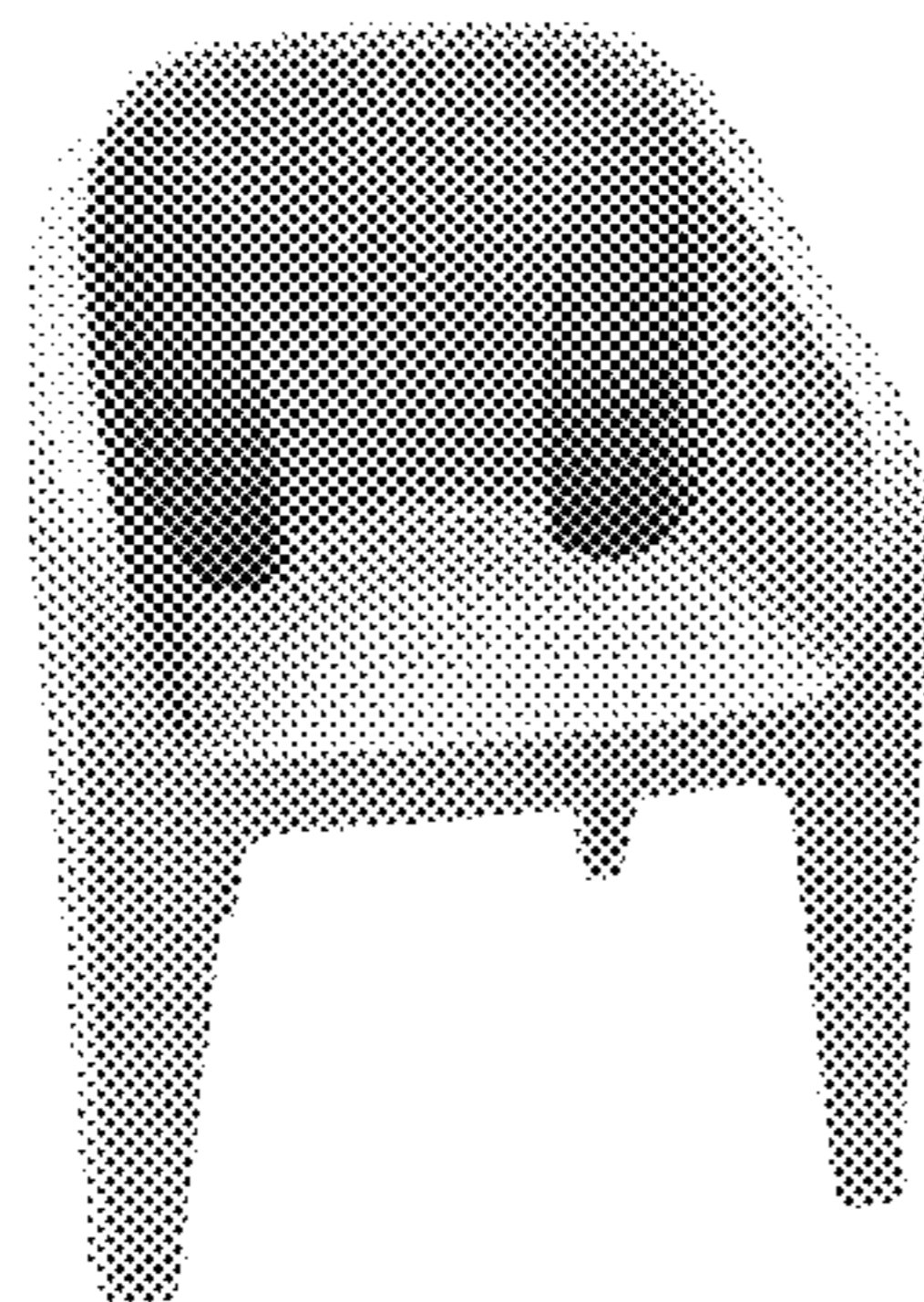
FIG. 4 is a rear view of the chair as shown in FIG. 1;

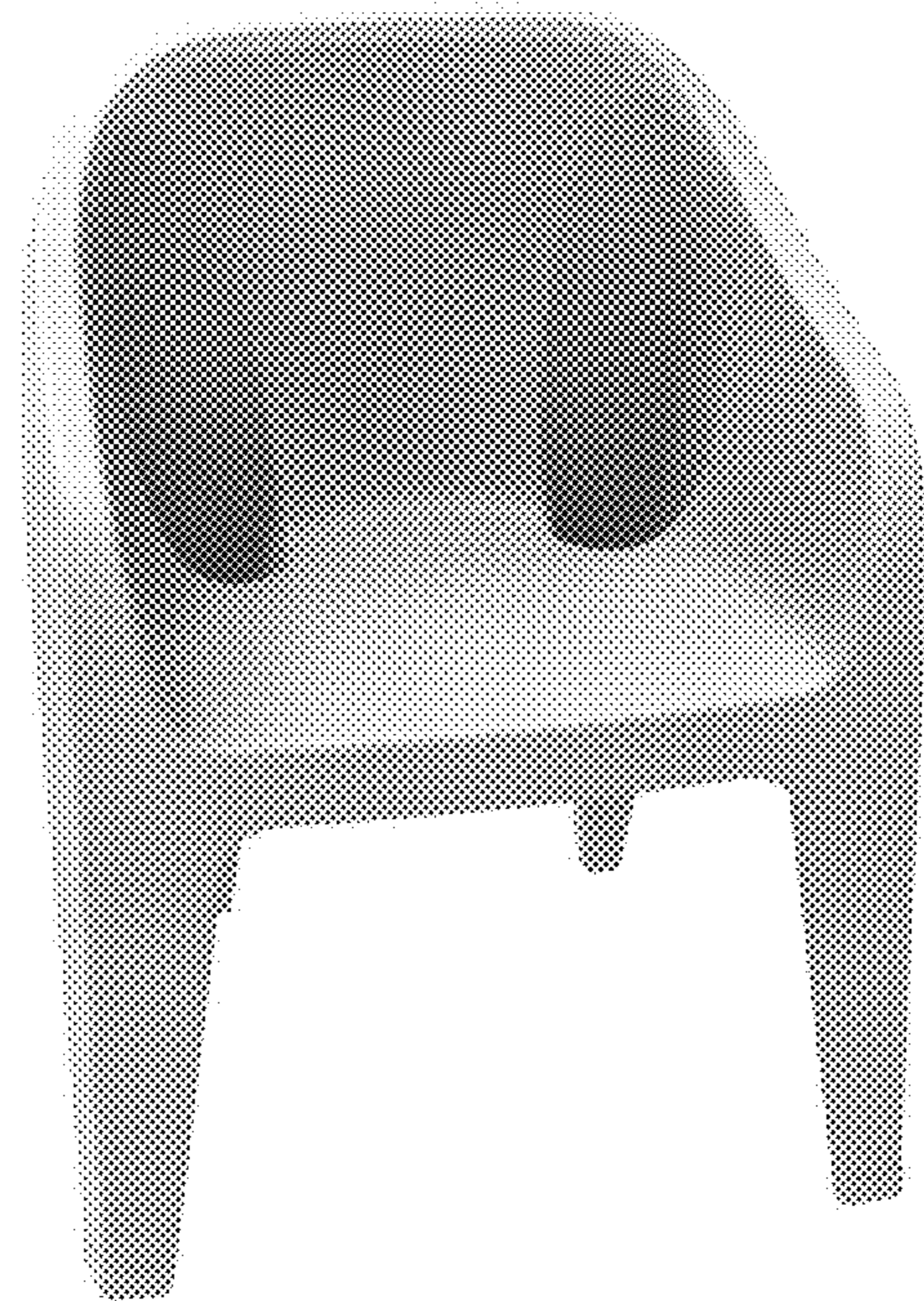

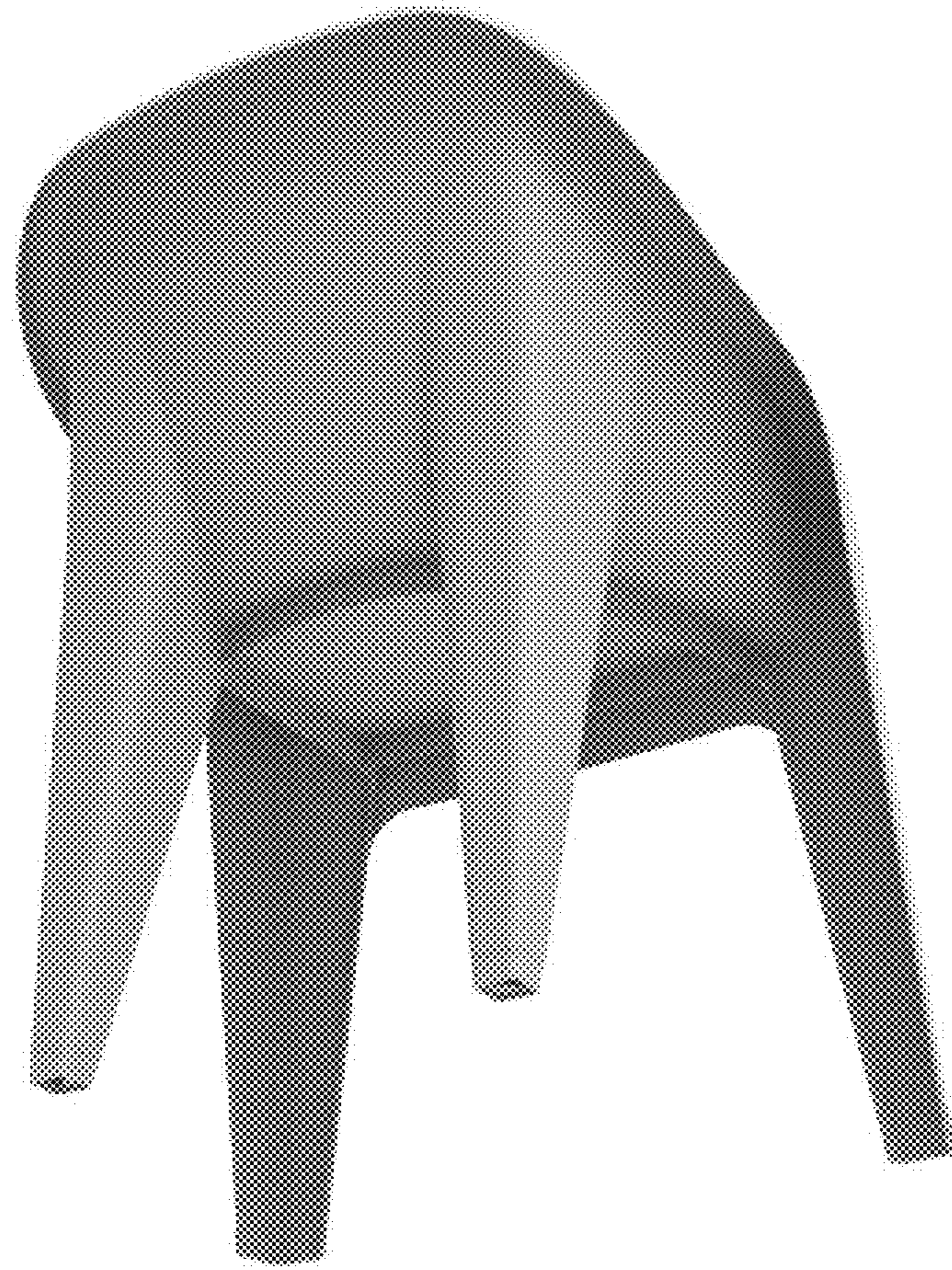

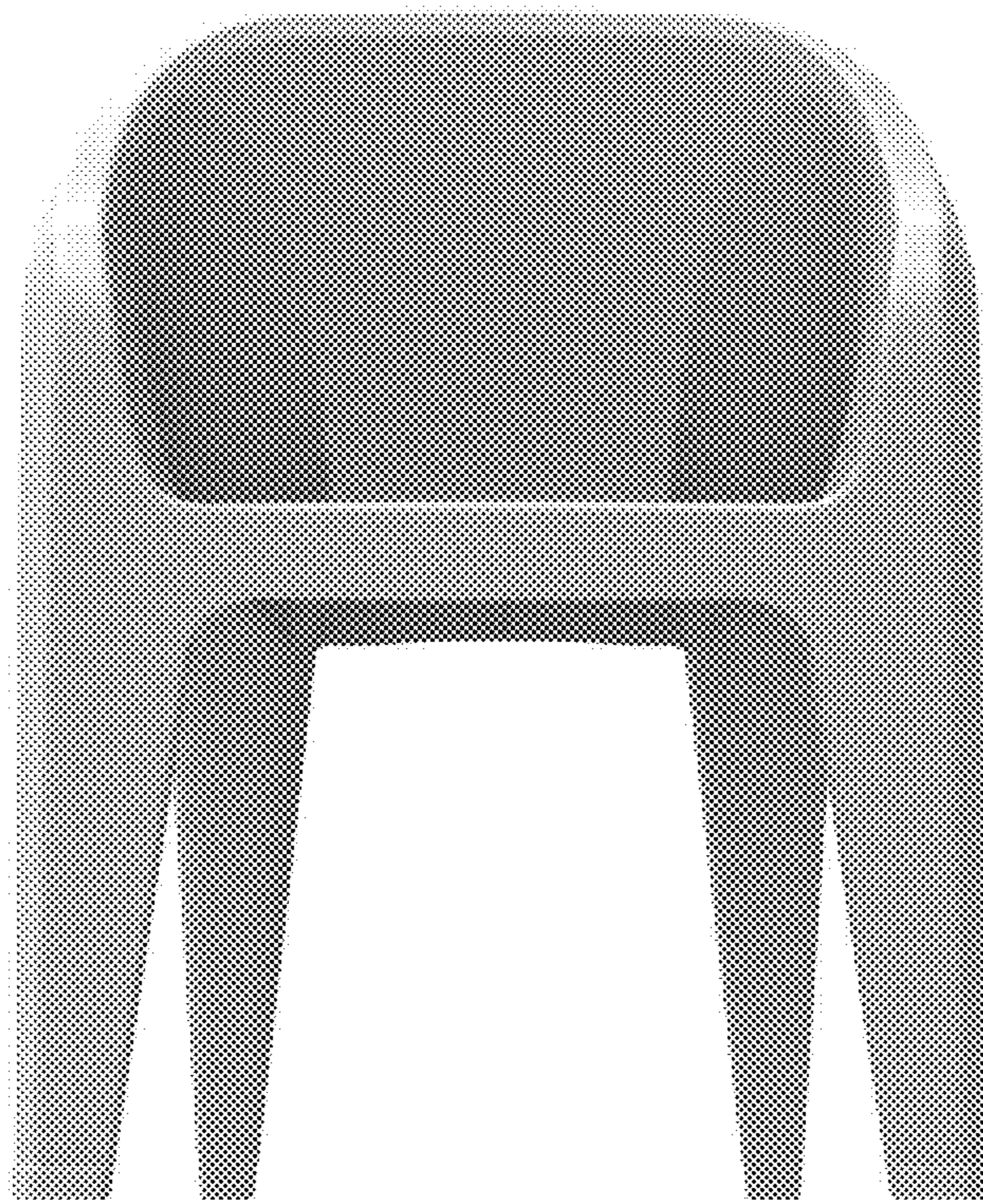

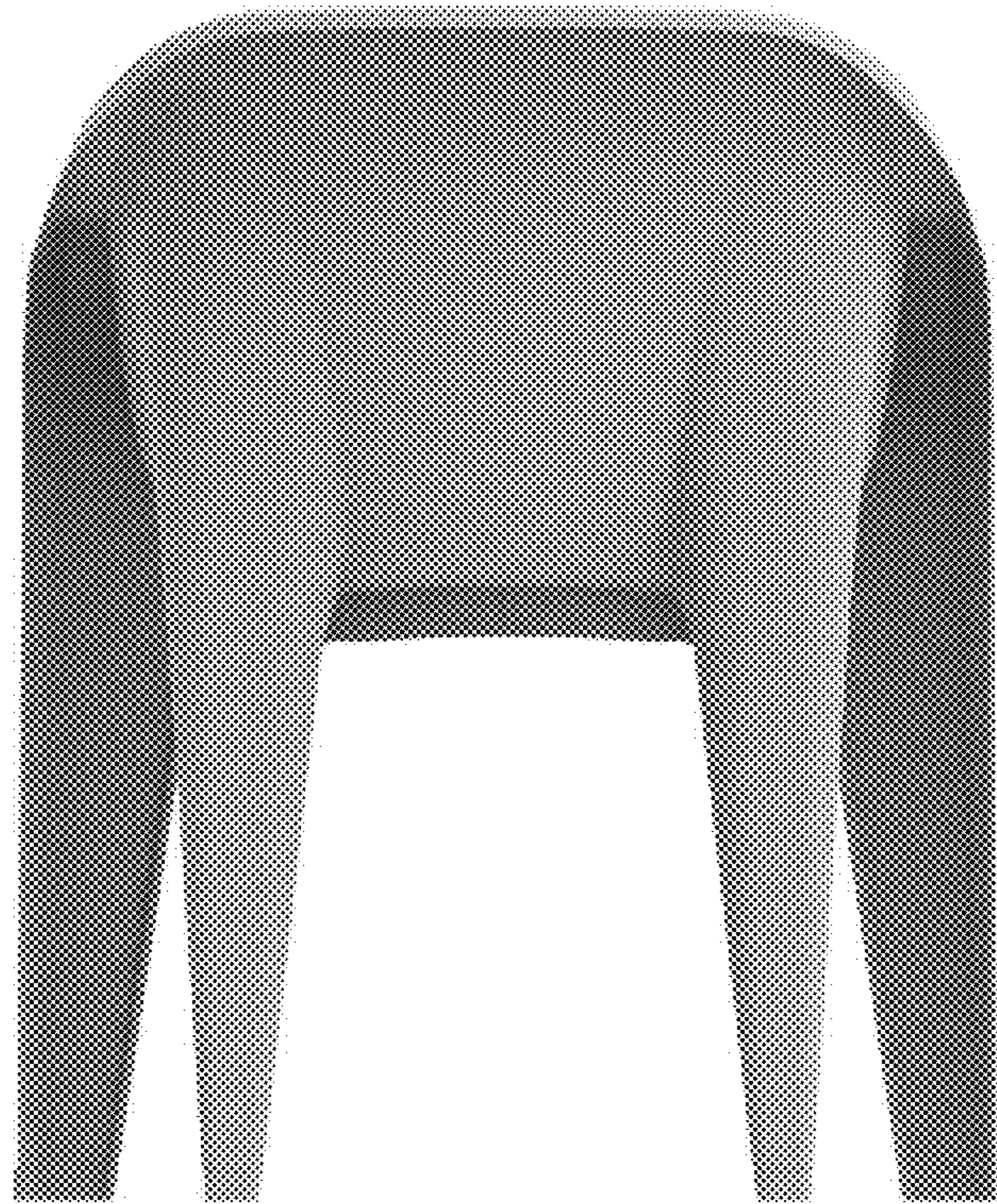

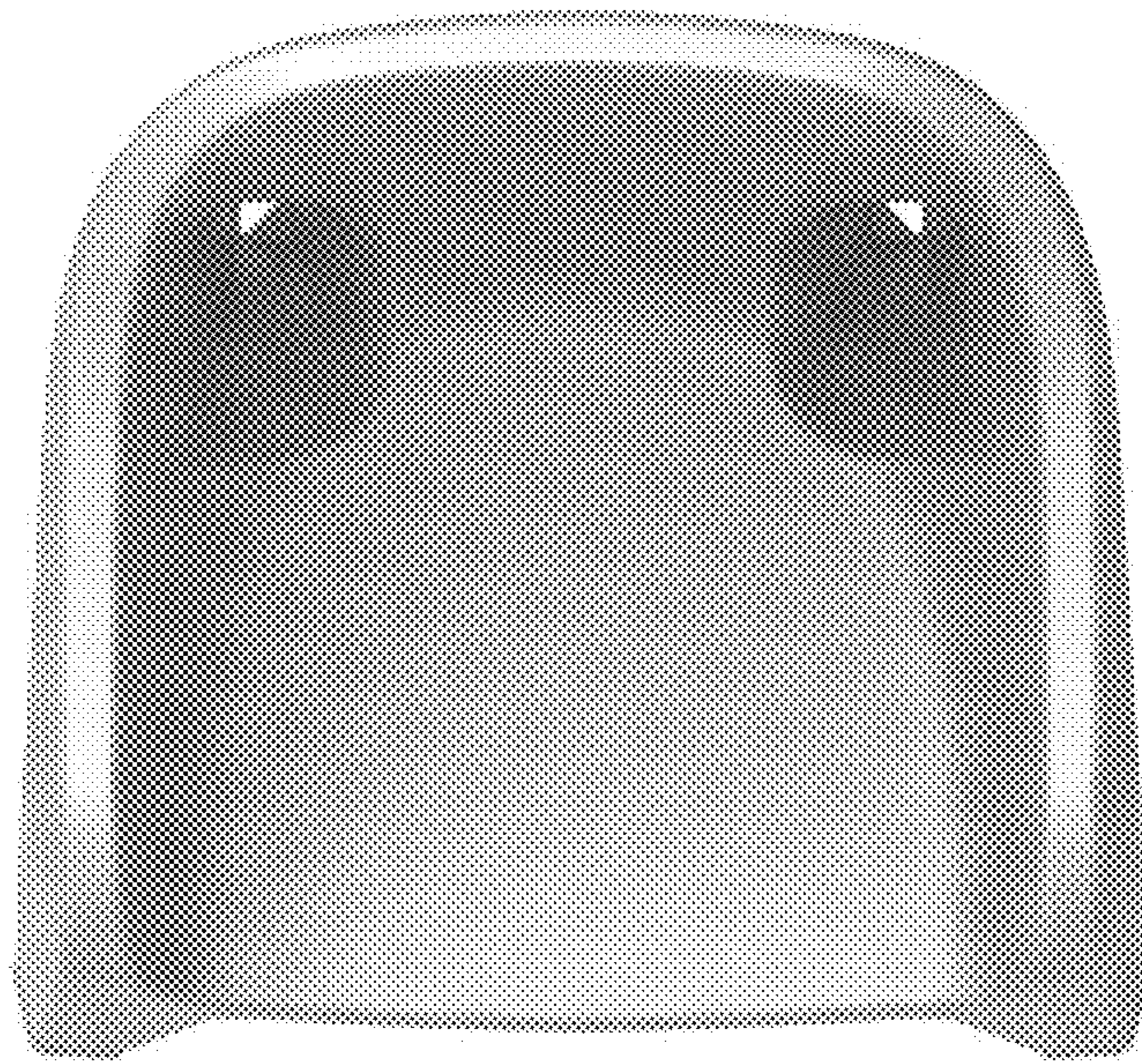
