The ornamental design for a toilet brush holder, as shown and described.

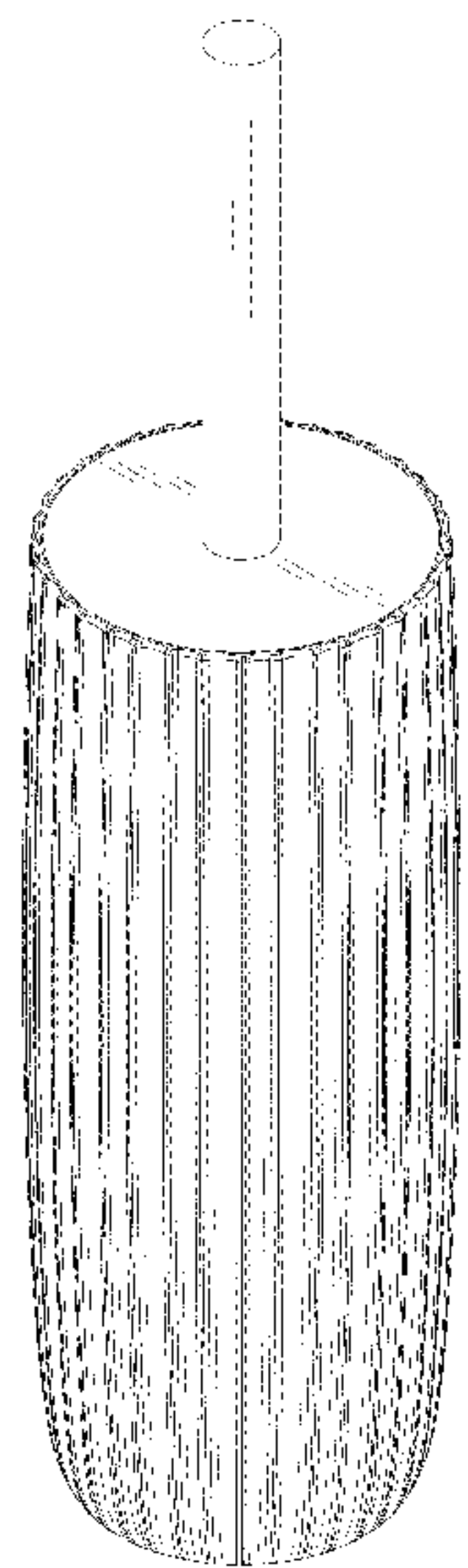
DESCRIPTION

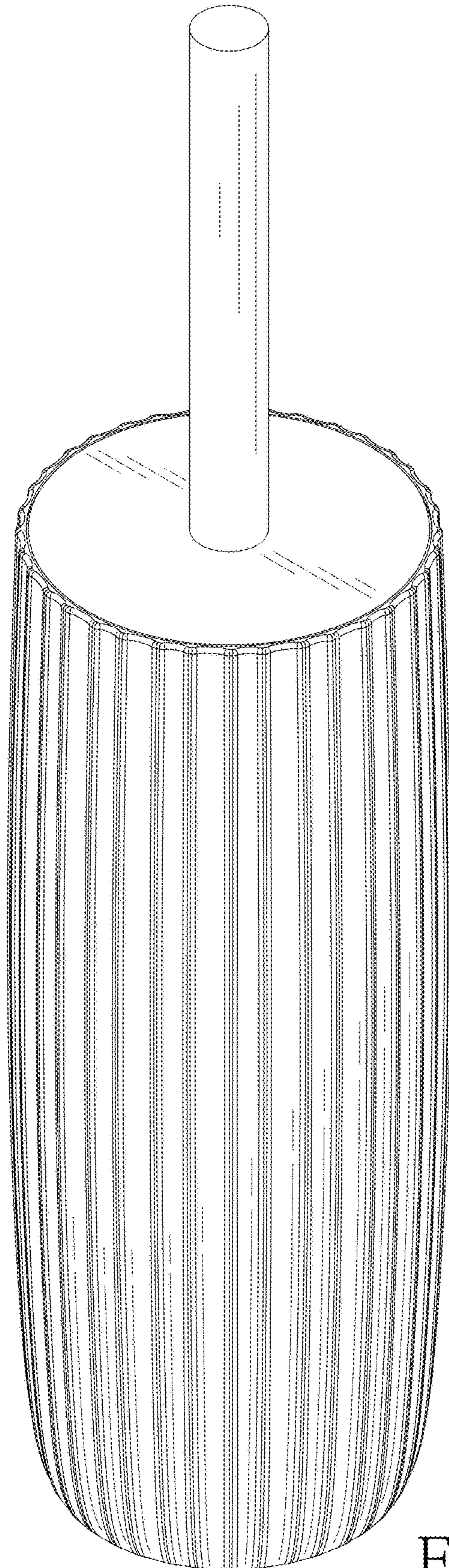

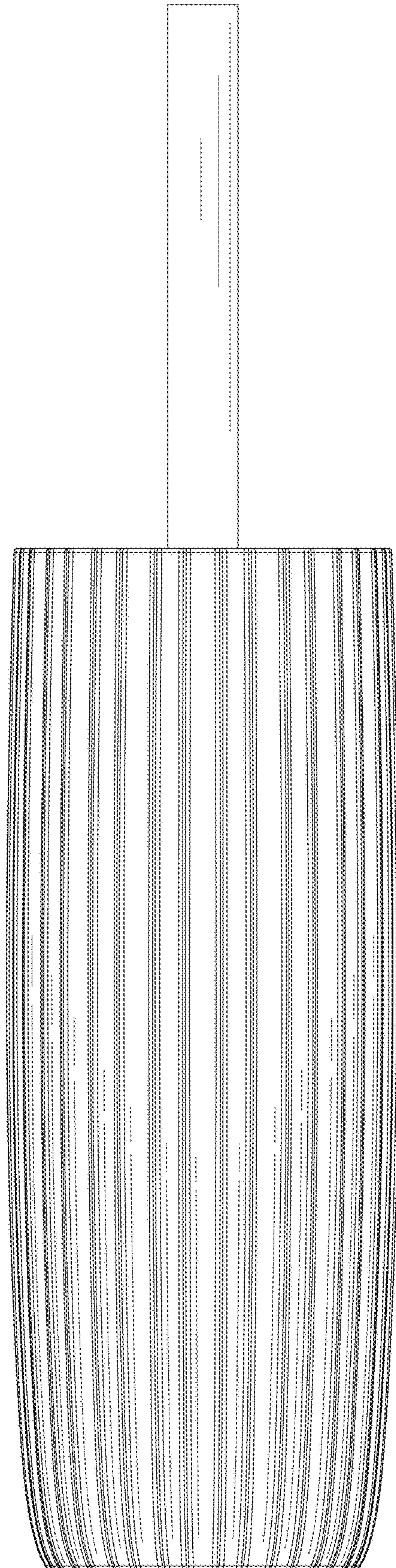

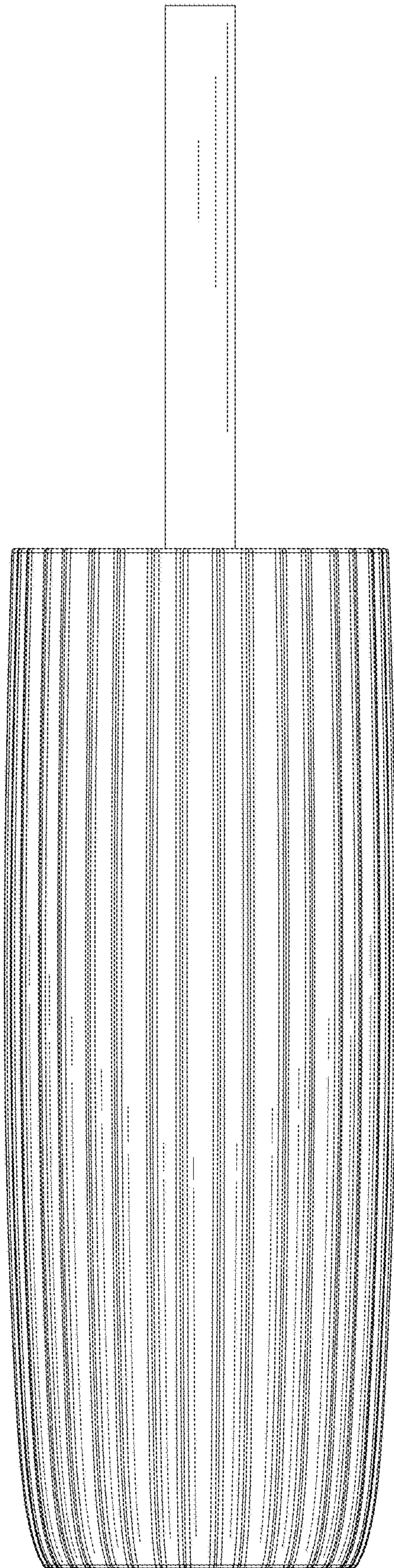

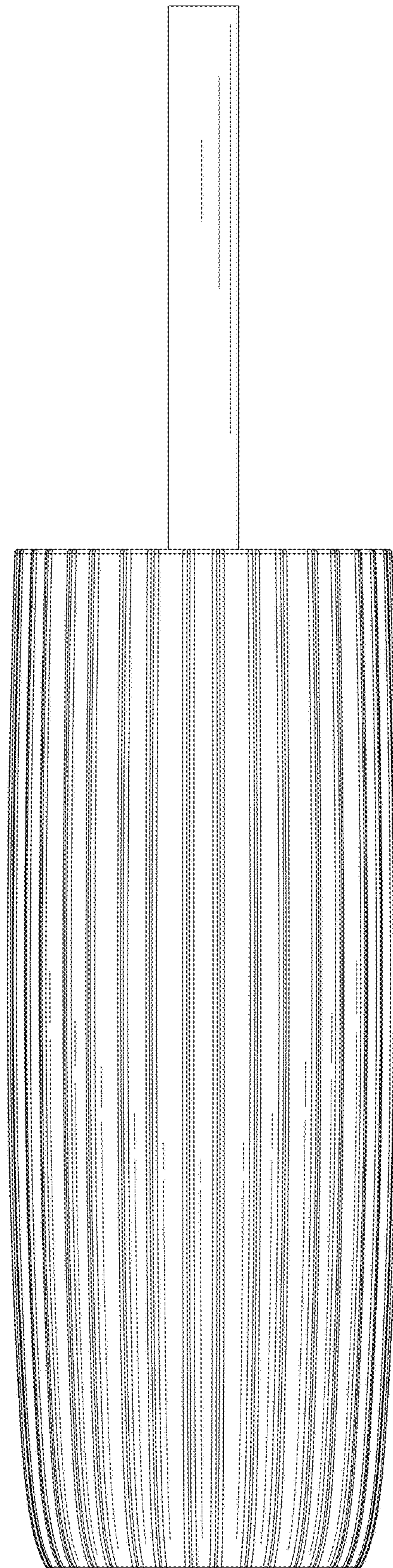

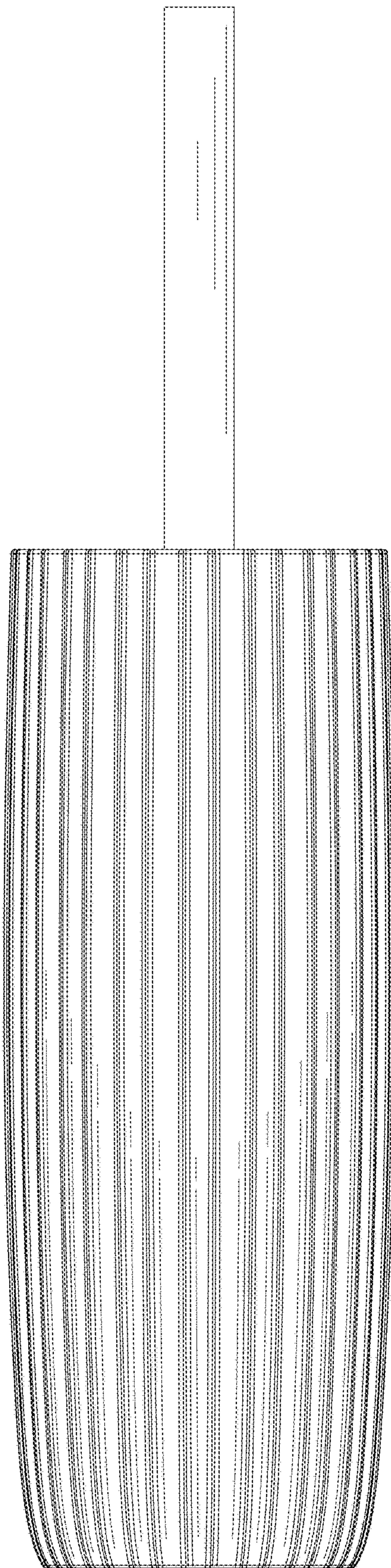

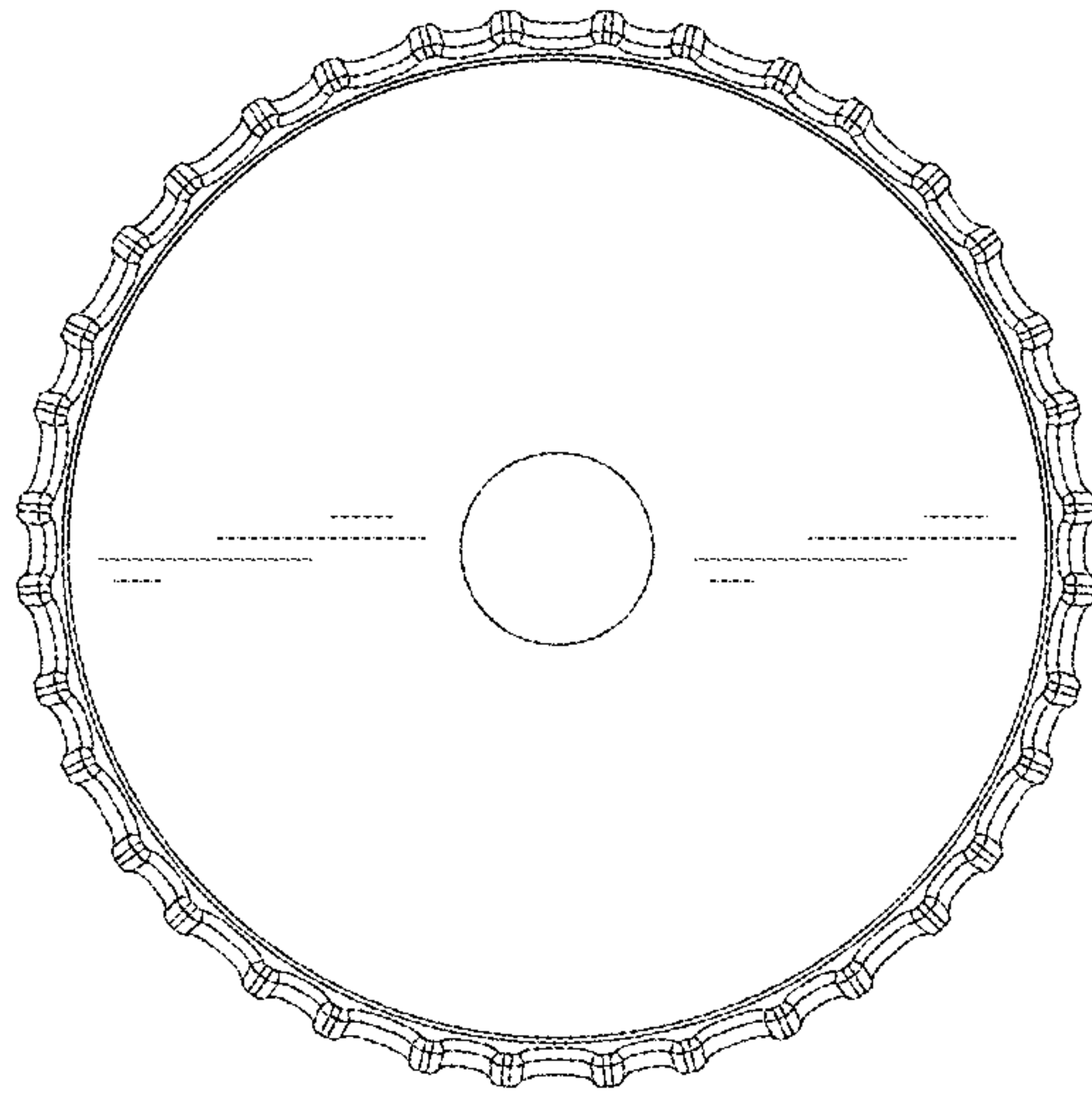

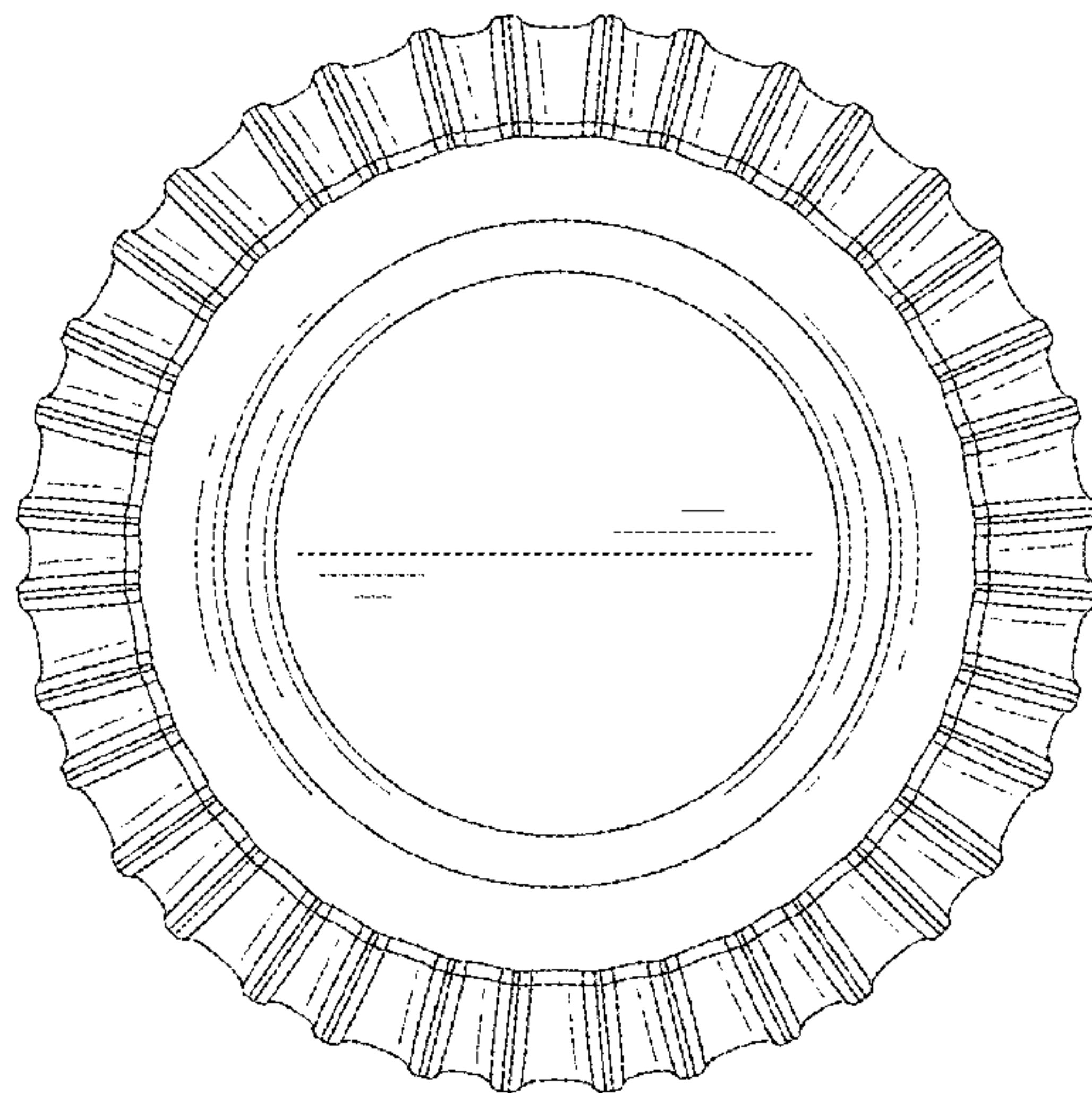

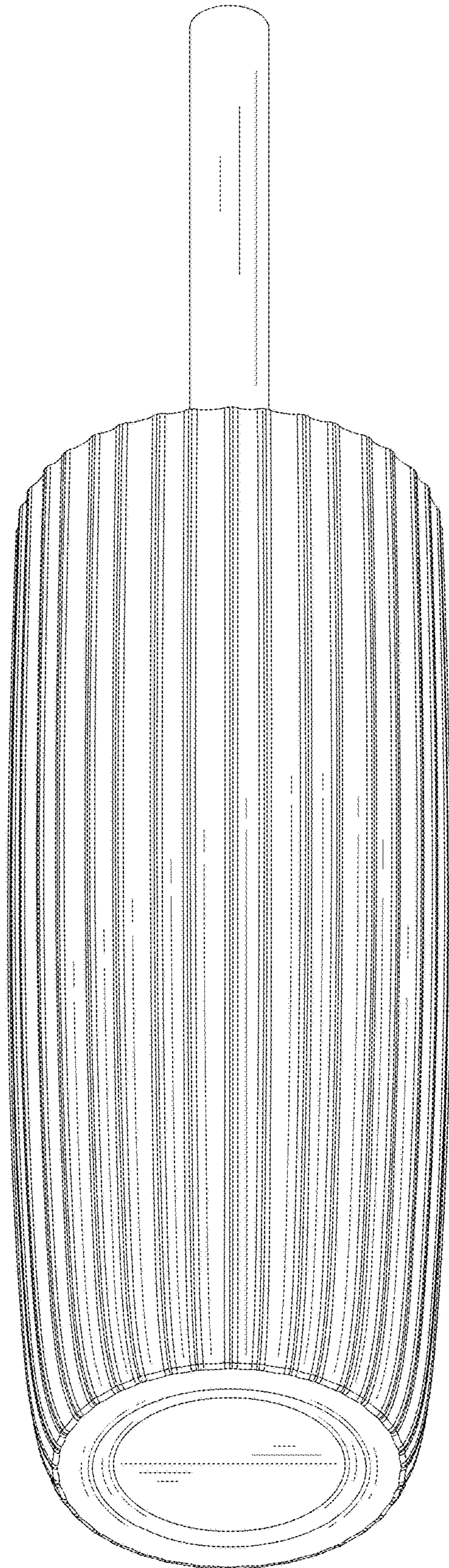
