The ornamental design for a cover for a food container, as shown and described.

DESCRIPTION

FIG. 12 is a rear elevation view thereof;

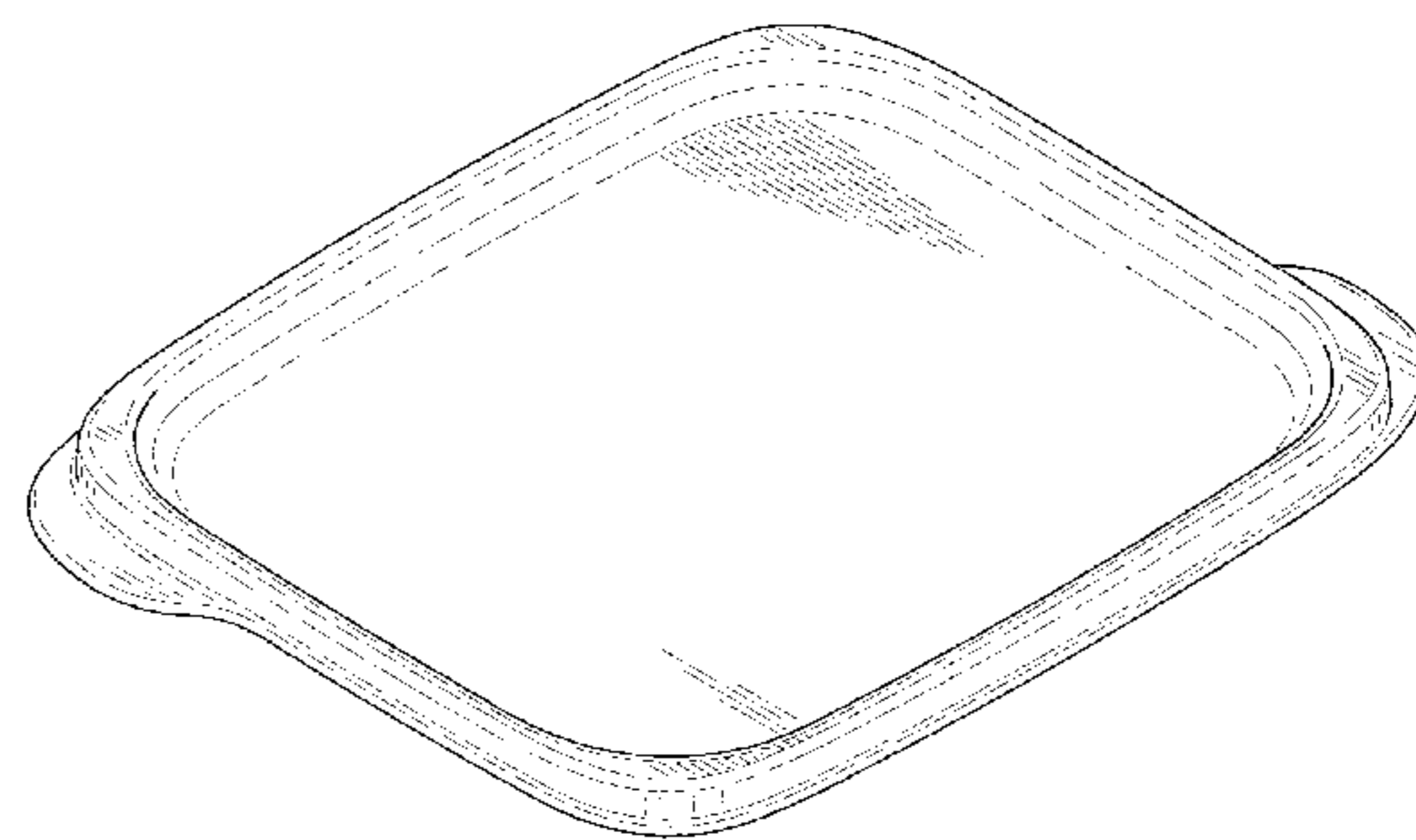
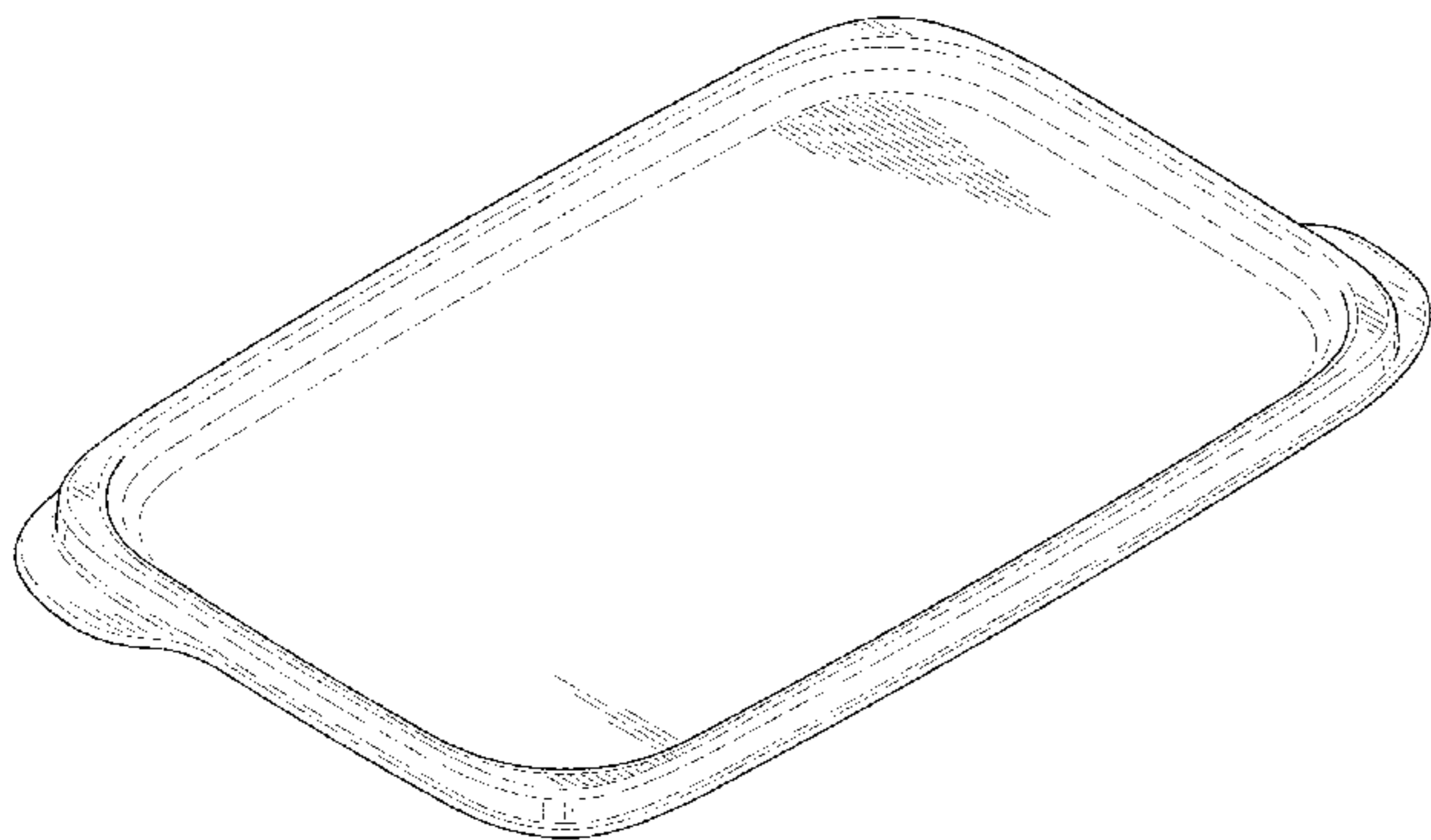
FIG. 13 is a right side elevation view thereof;

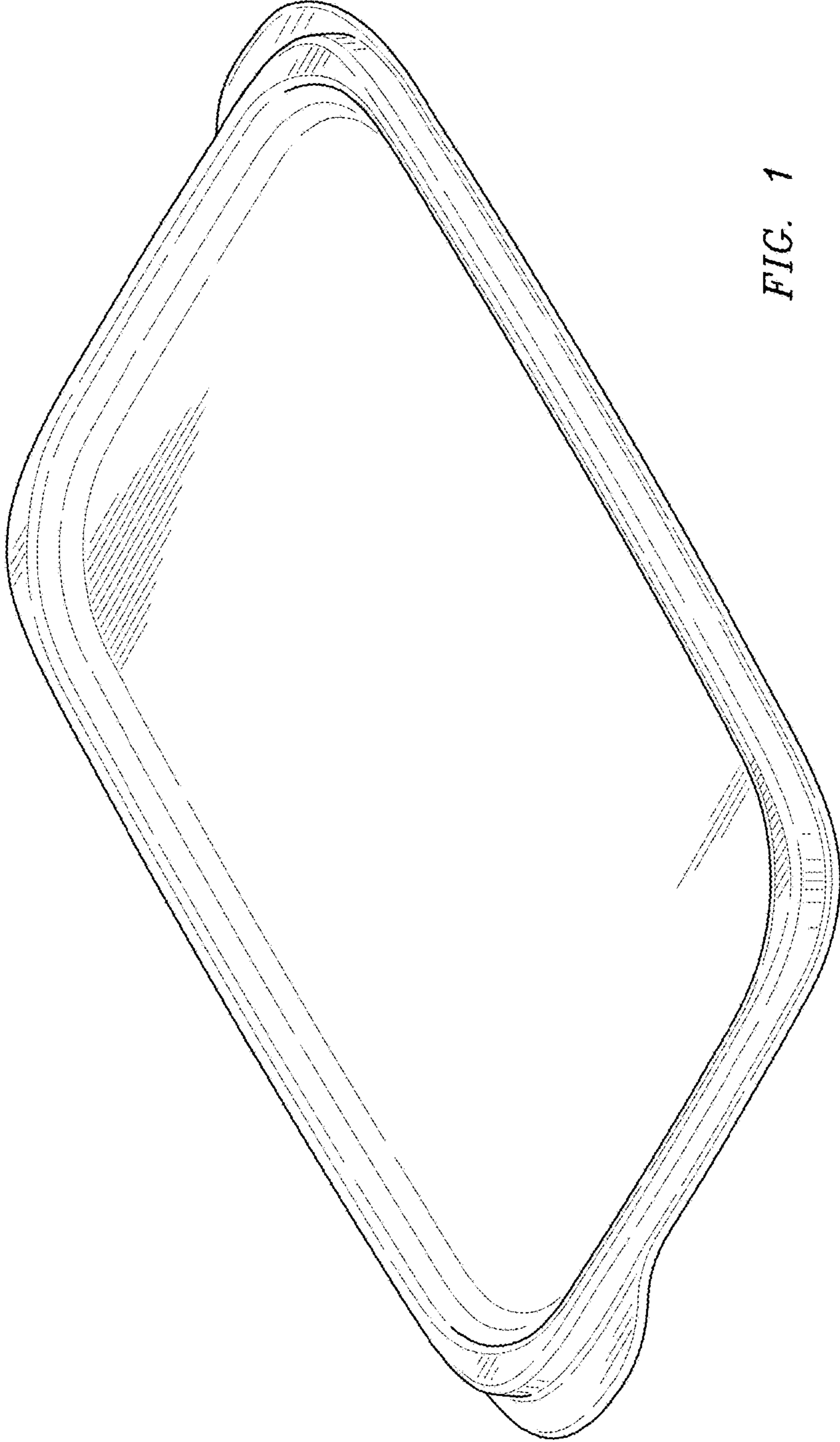

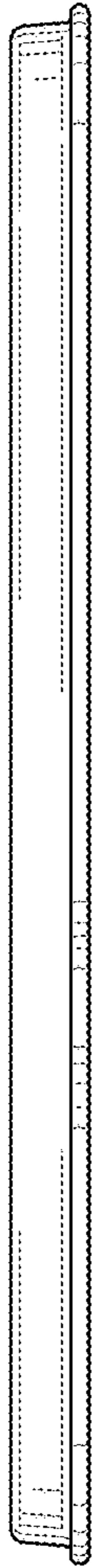

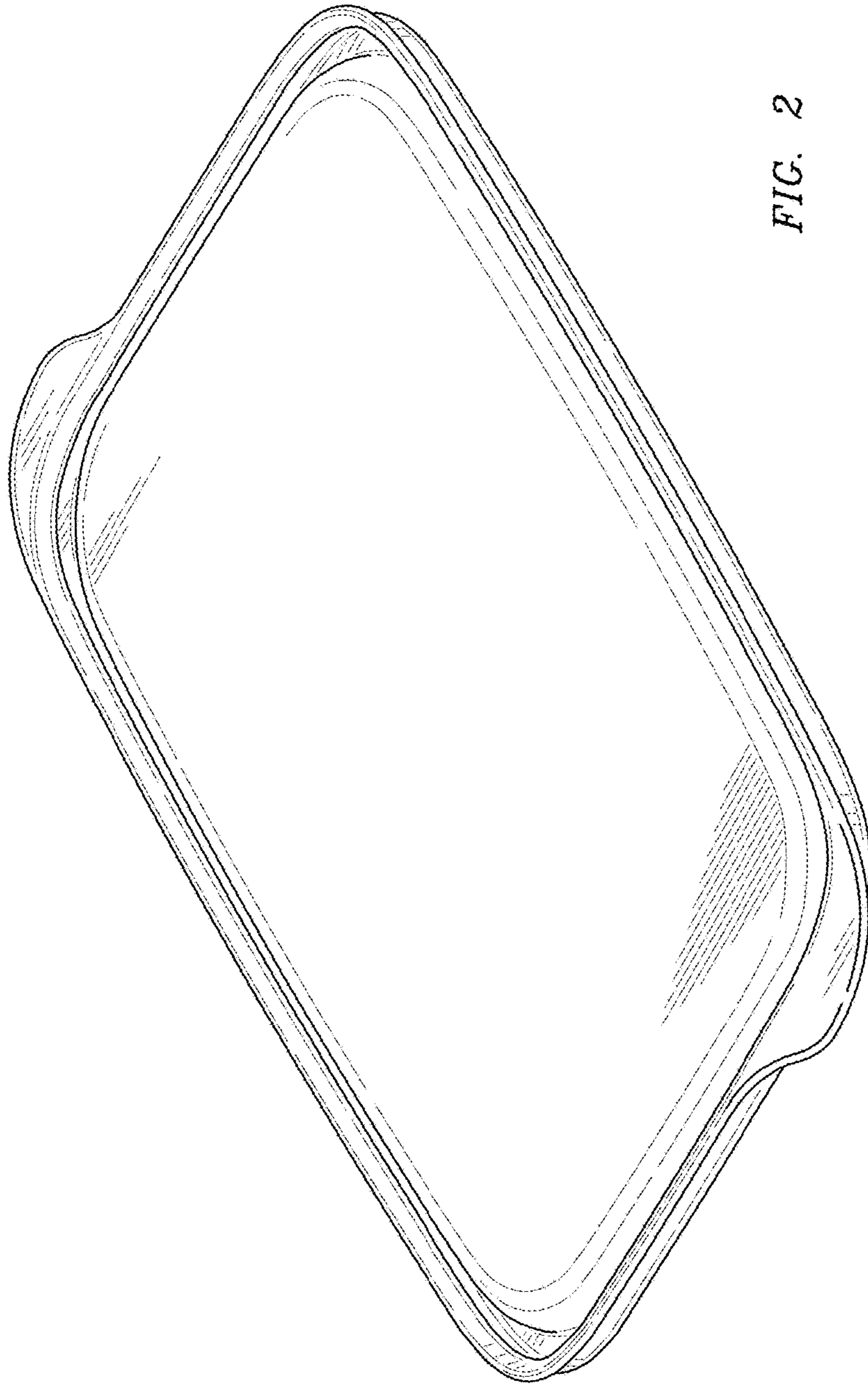

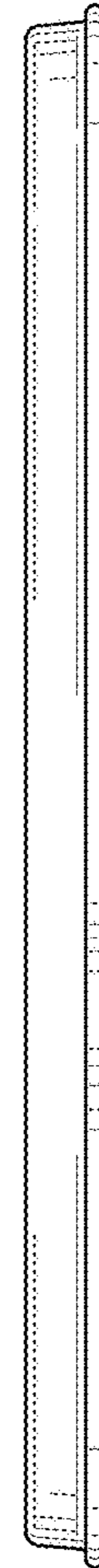

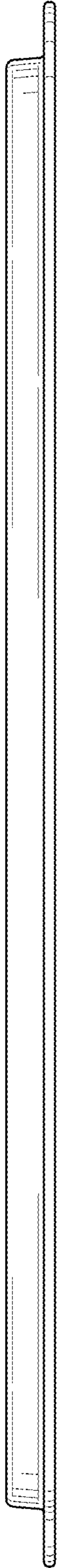

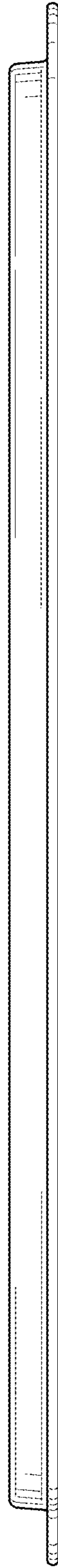

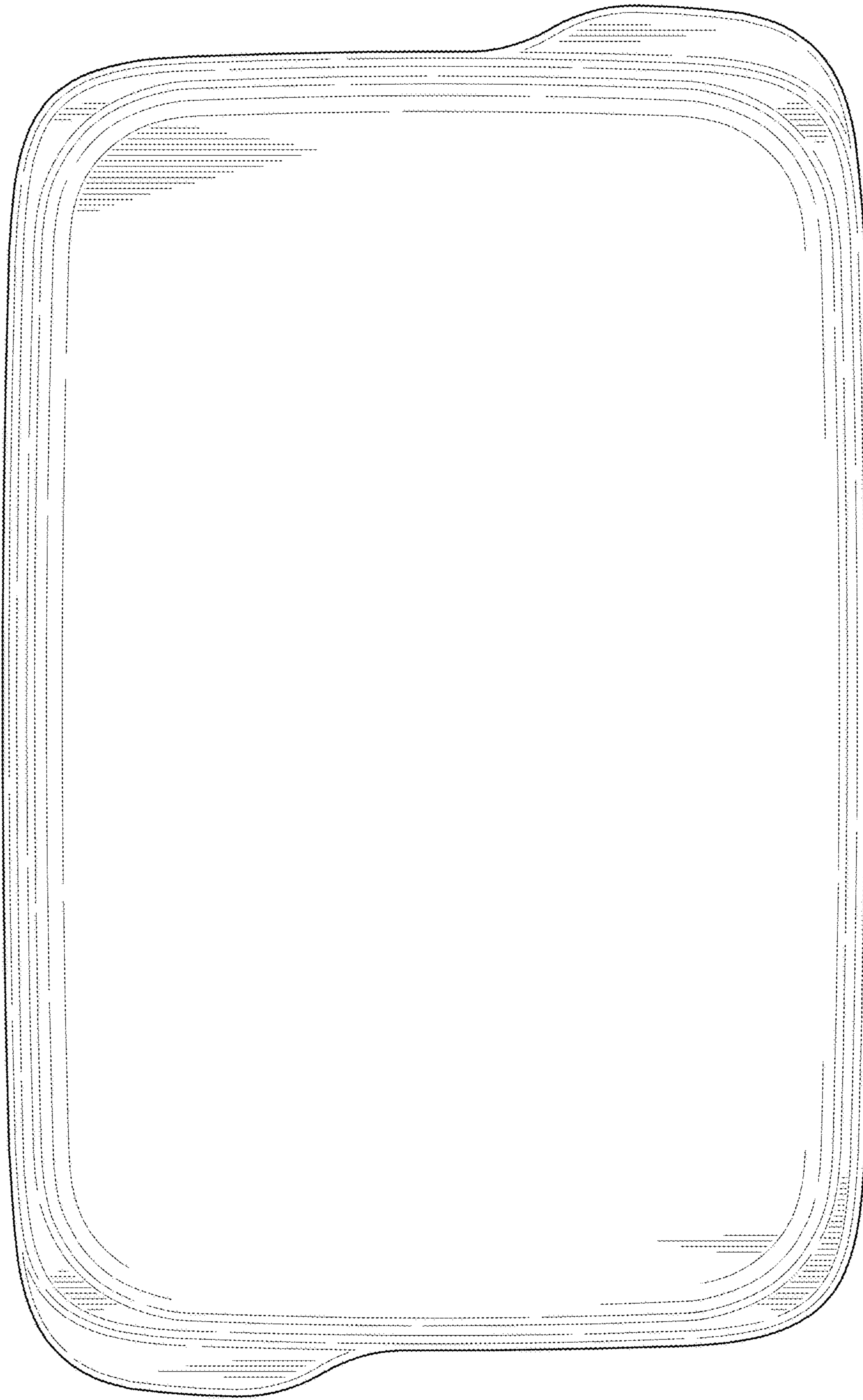

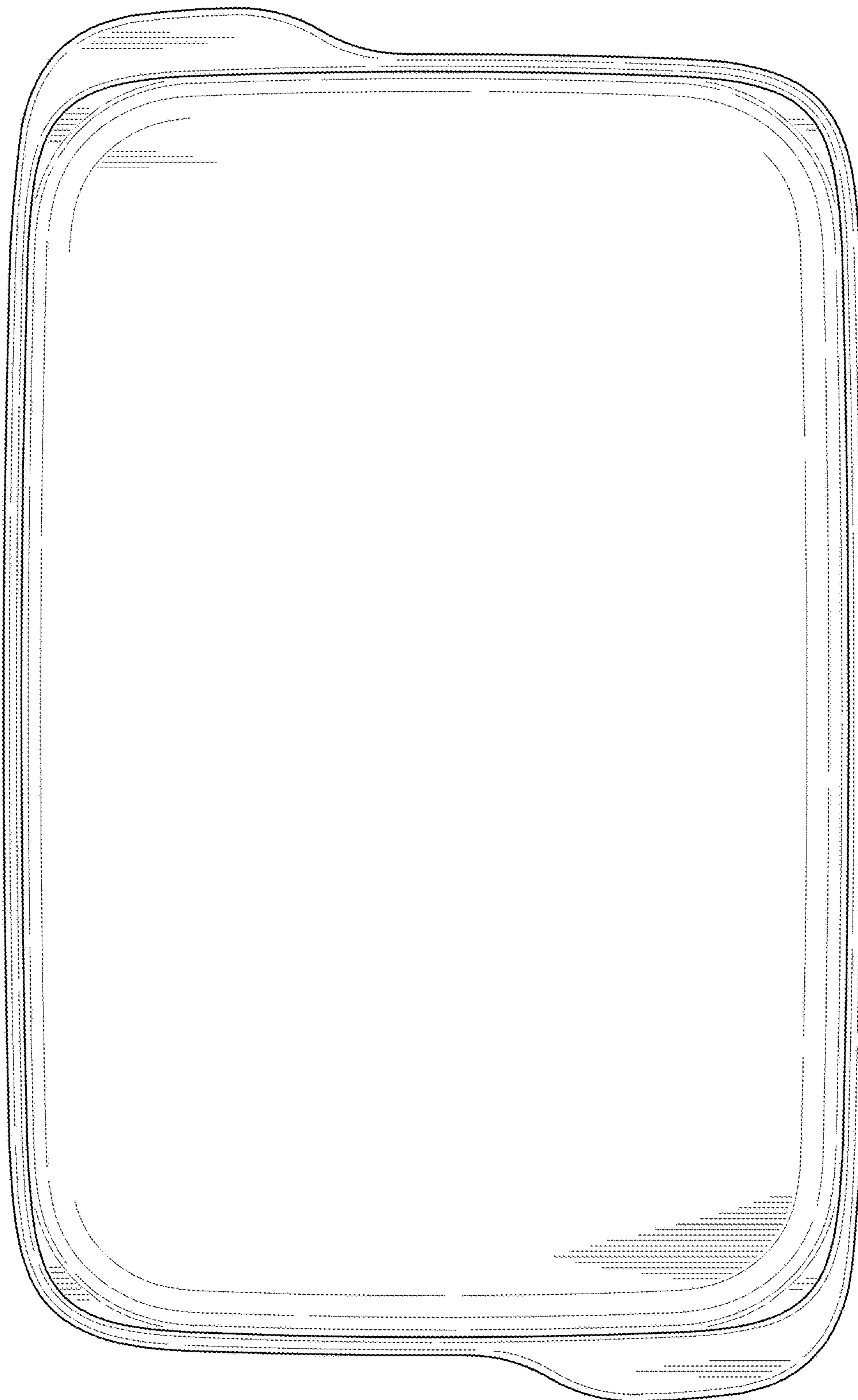

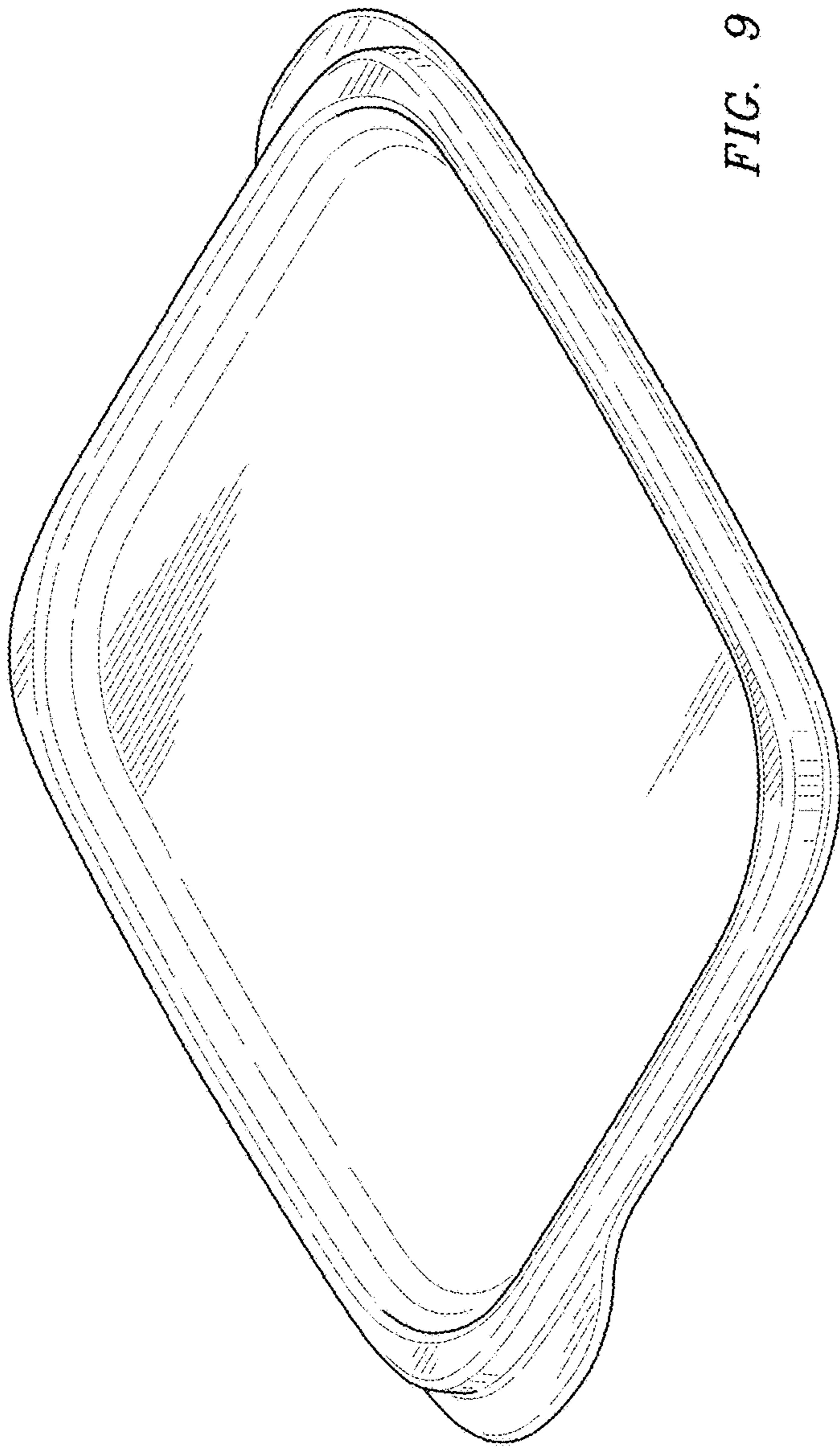

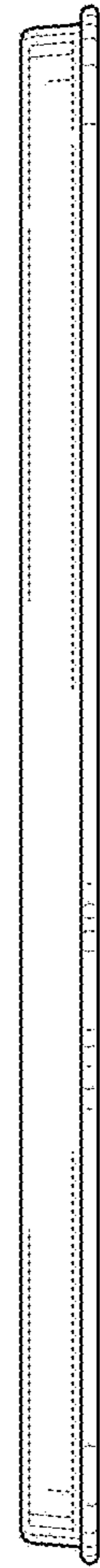

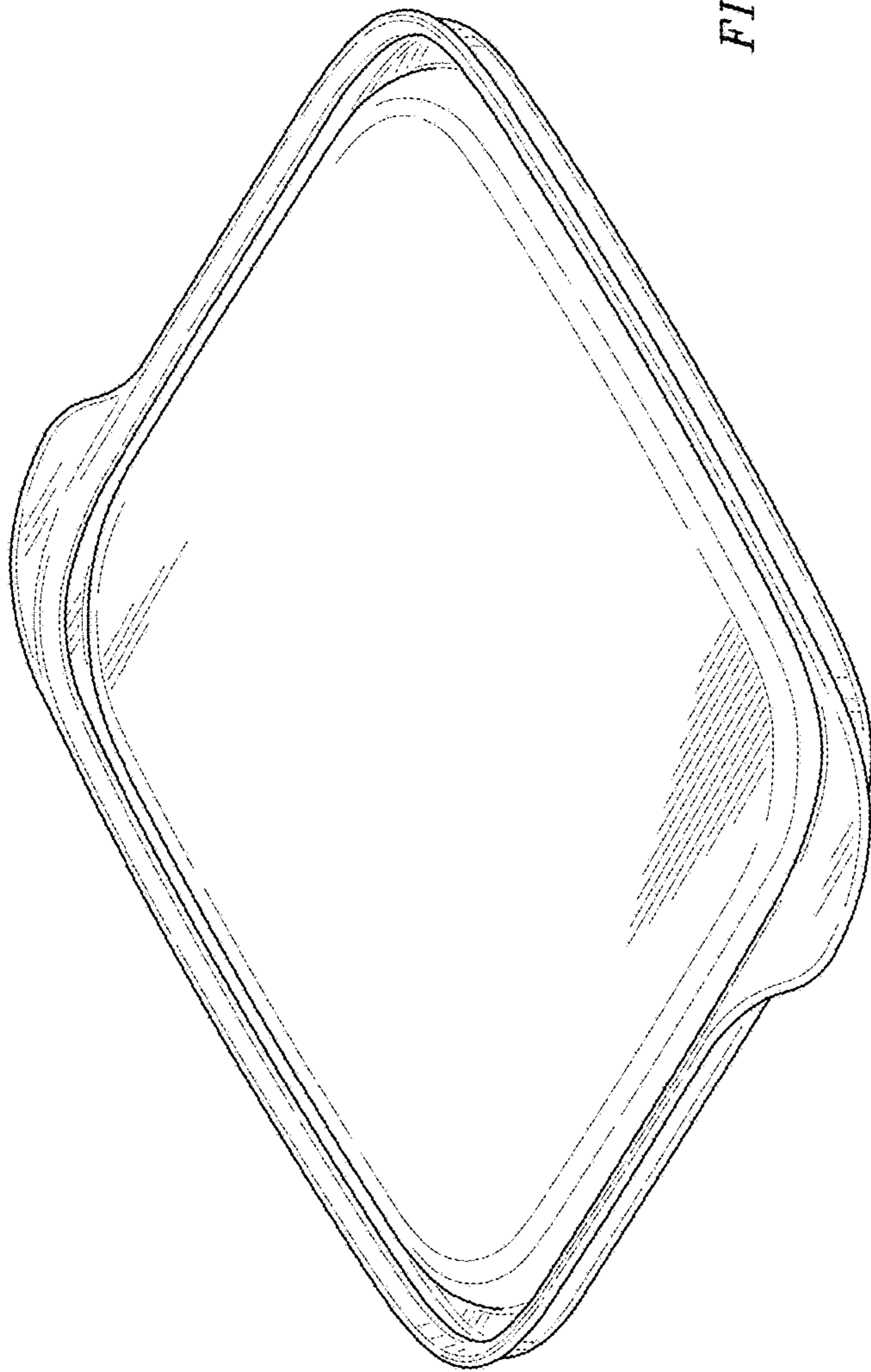

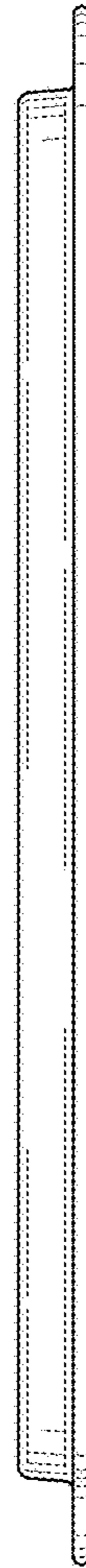

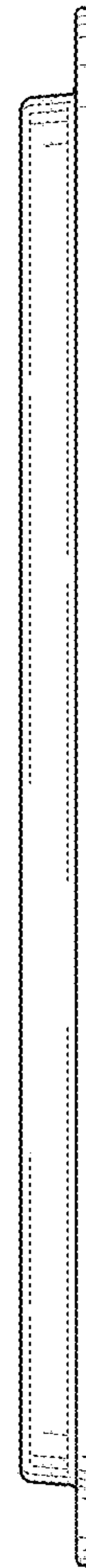

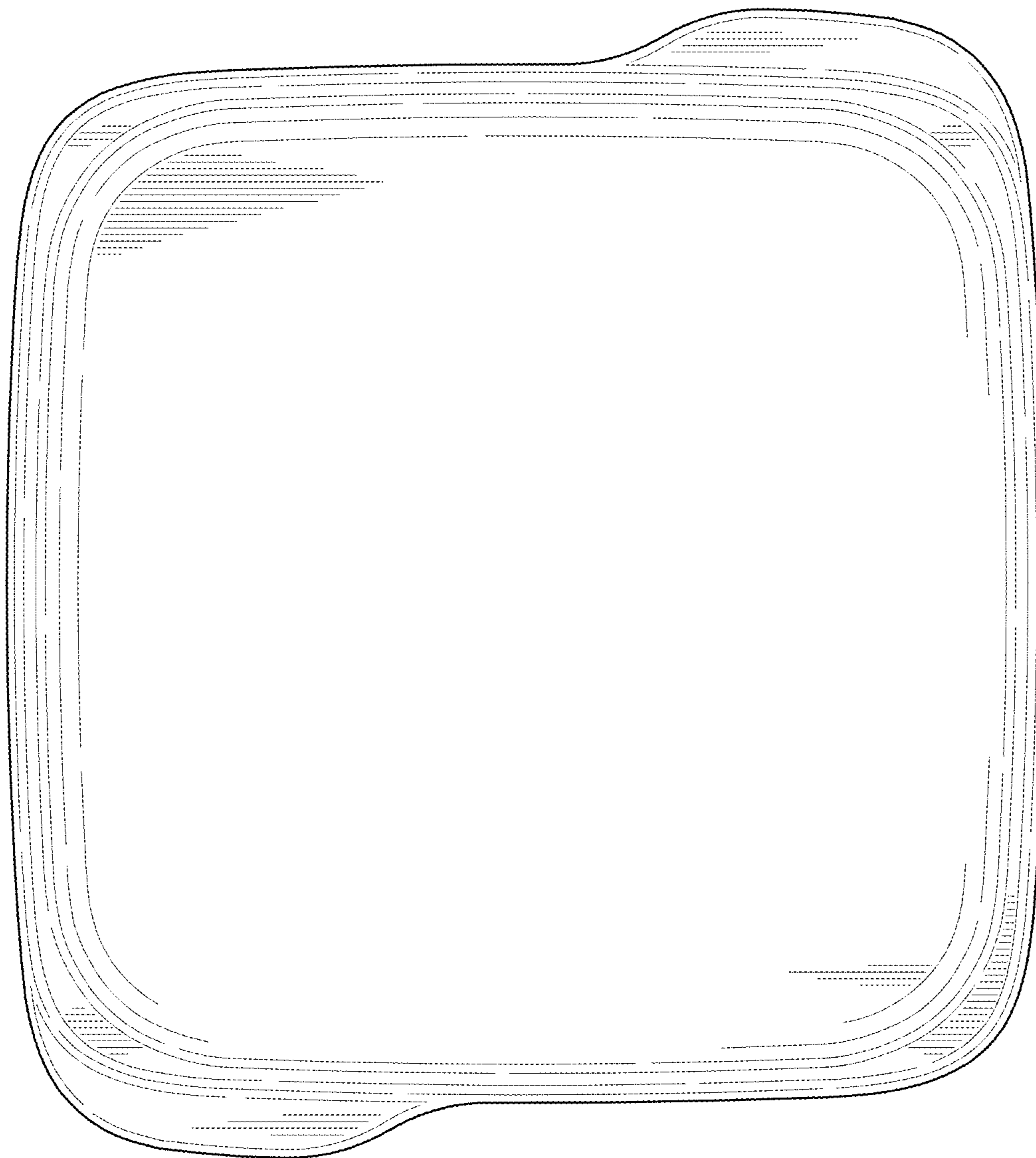

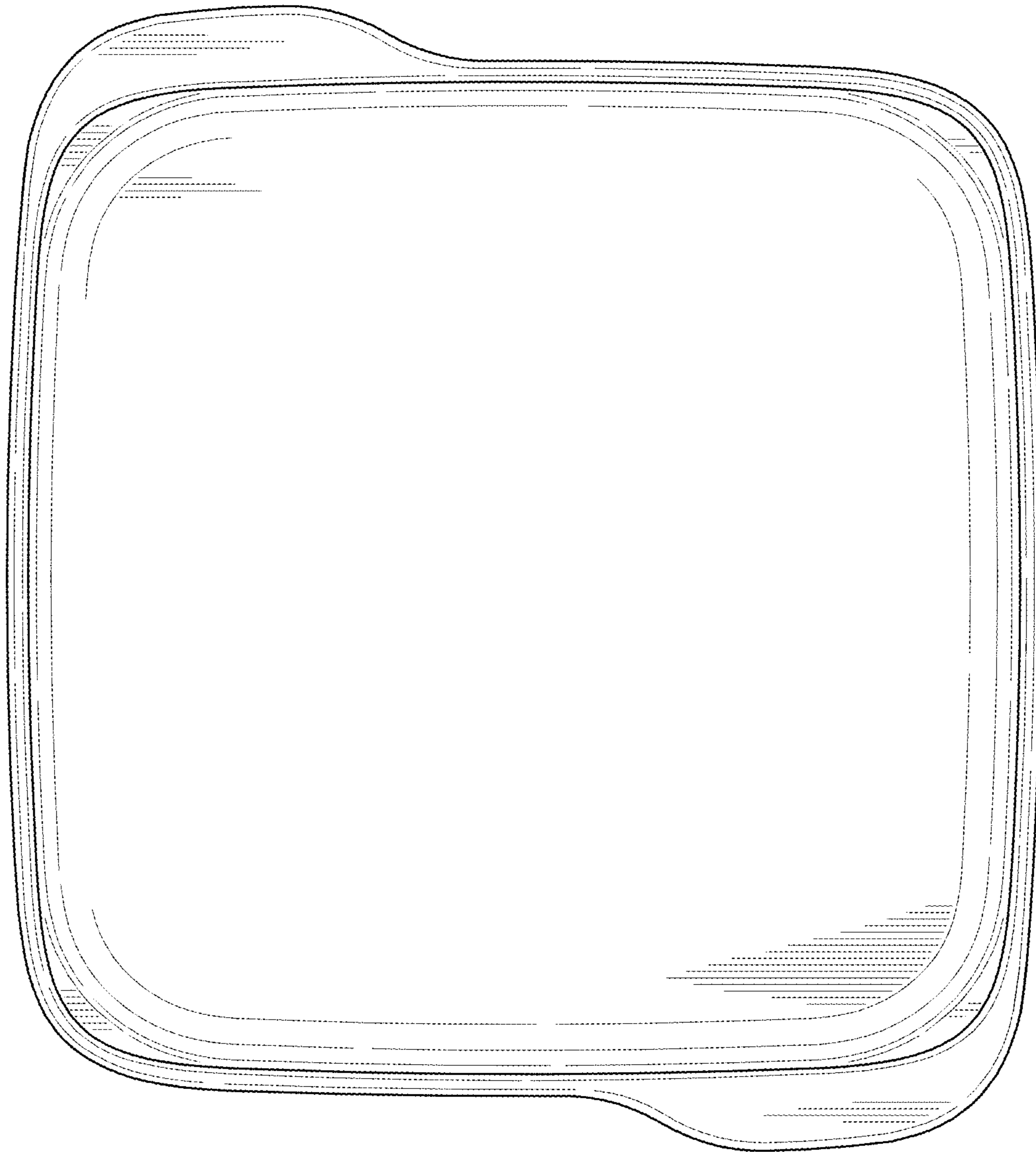
