The ornamental design for an ice bucket, as shown and described.

**DESCRIPTION**

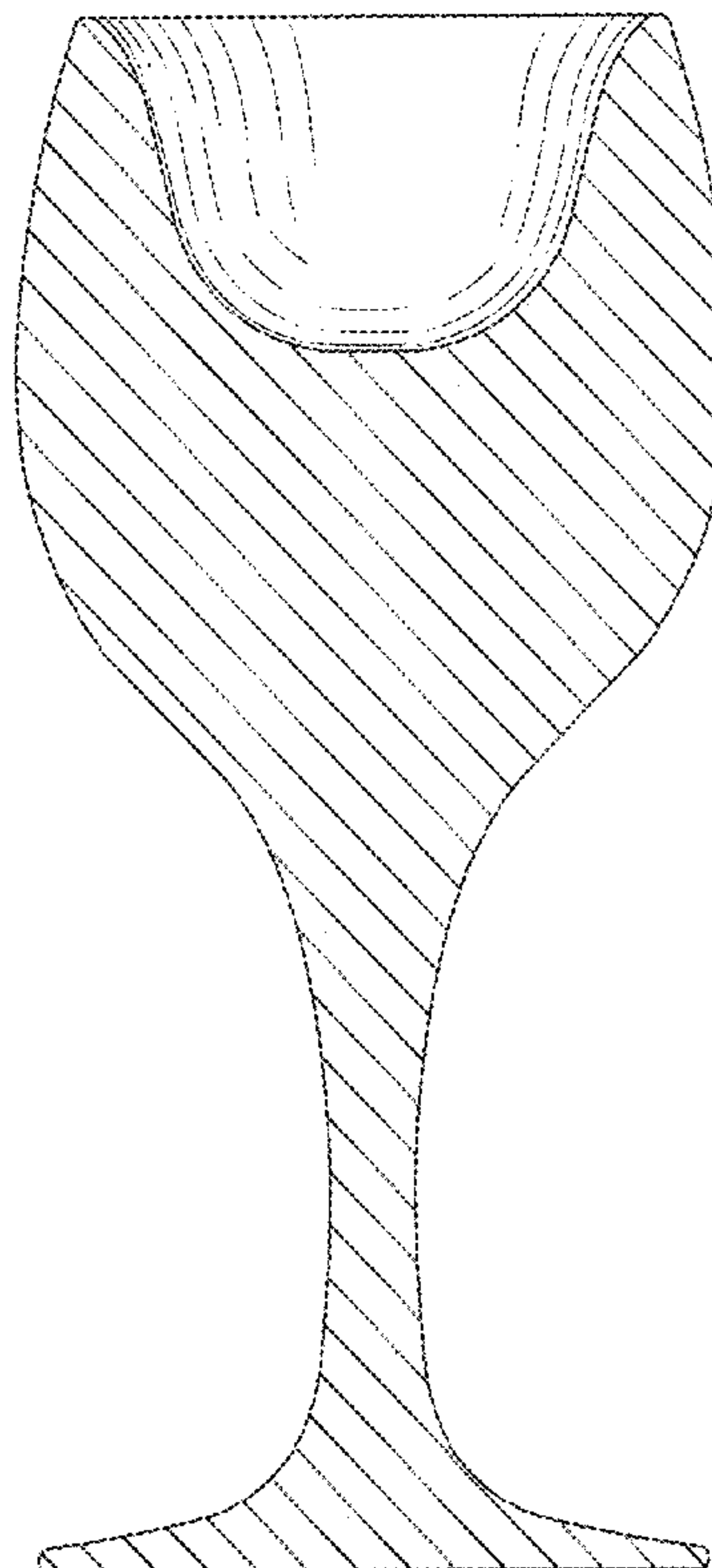
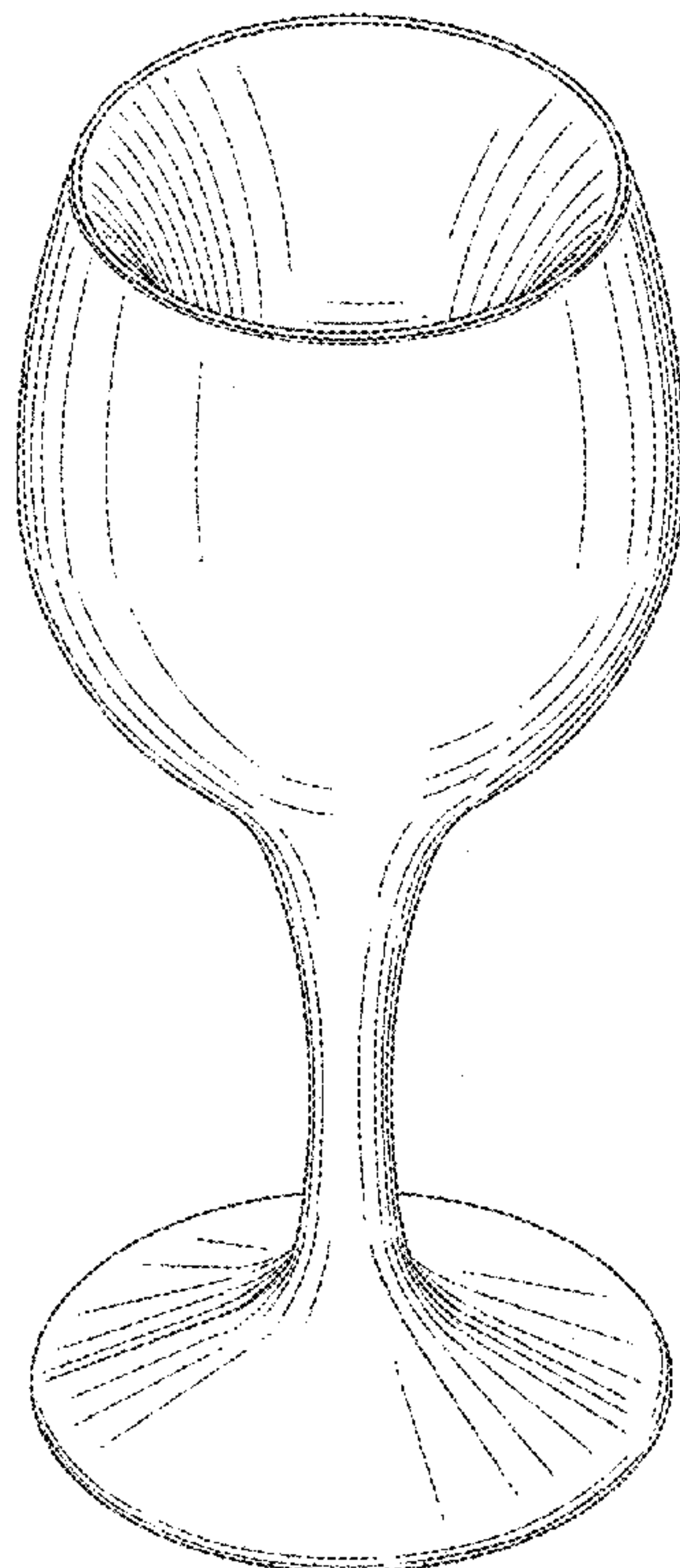
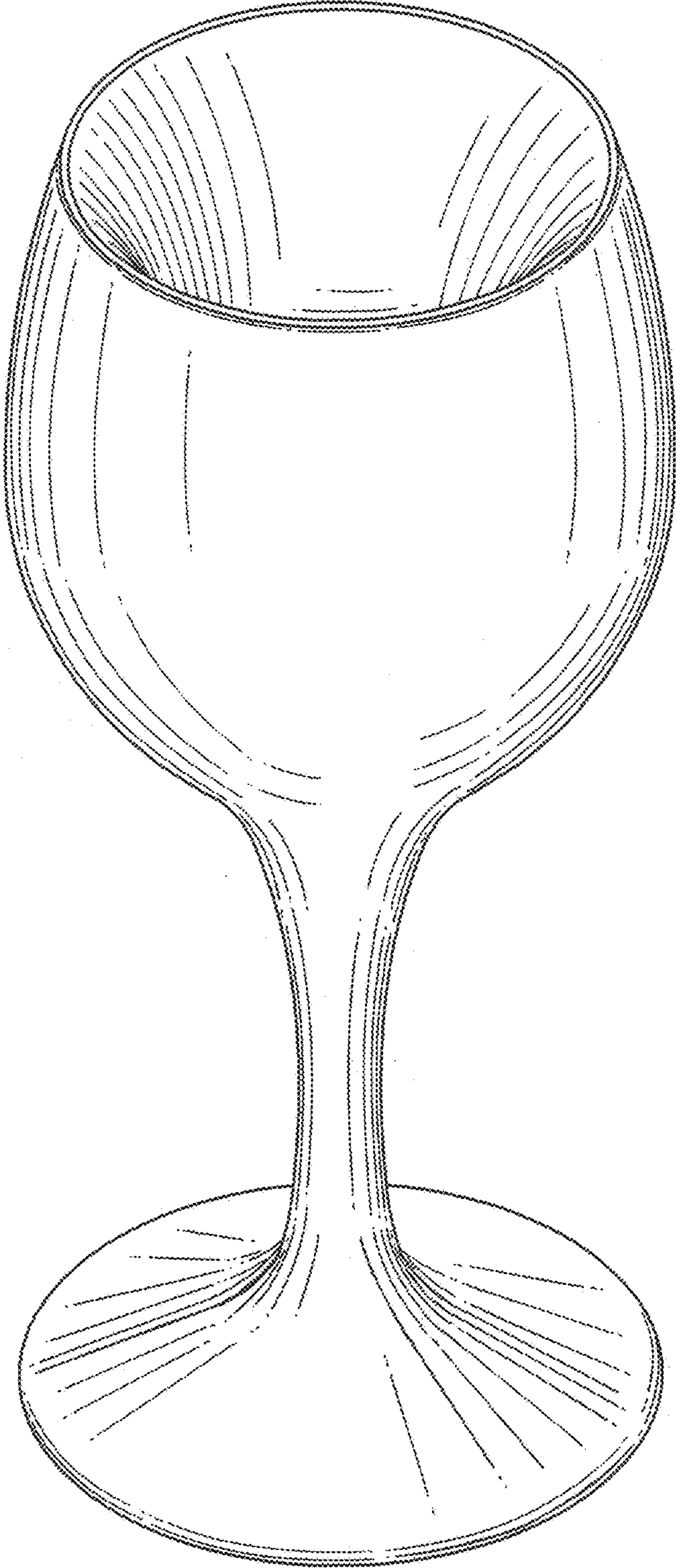

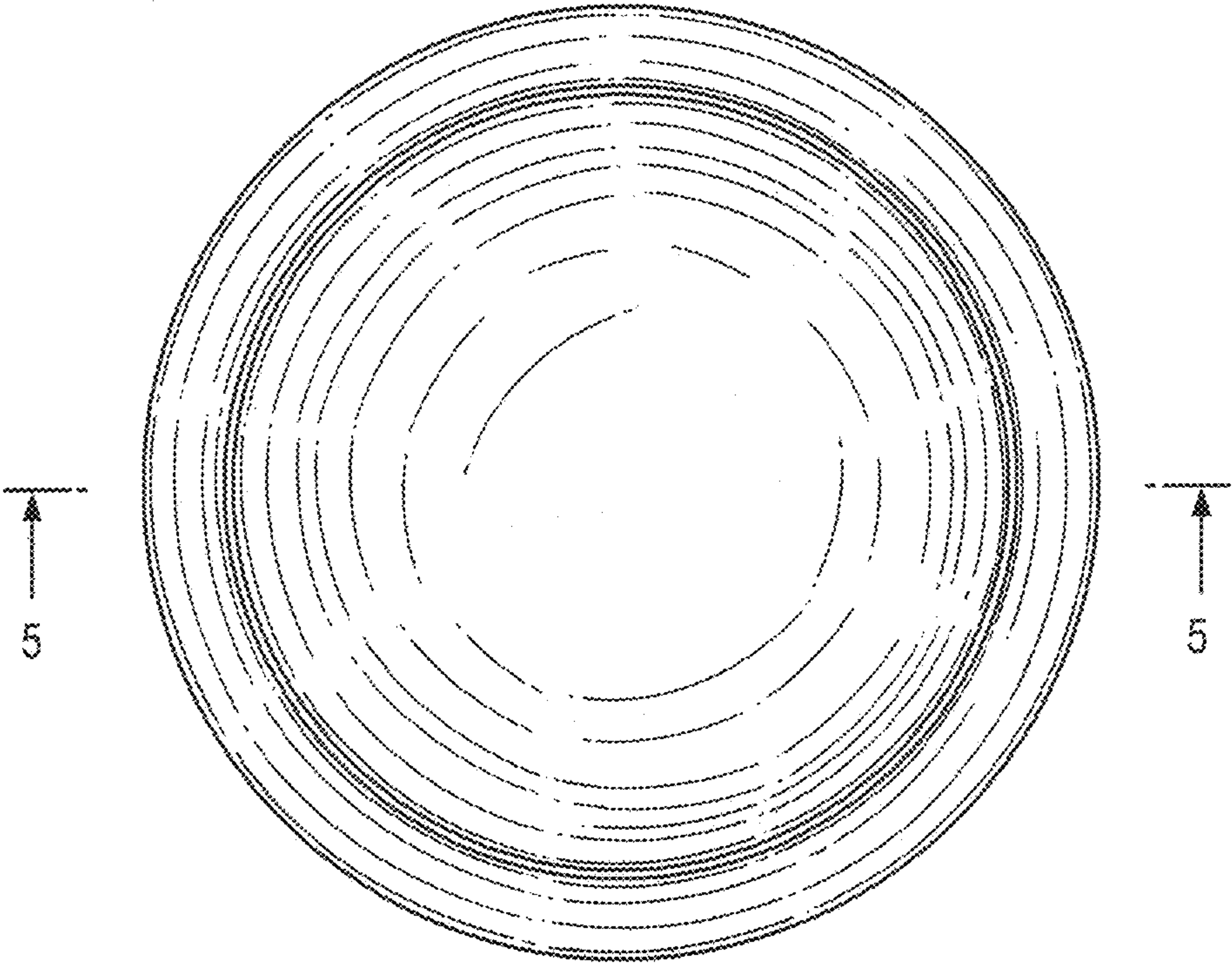

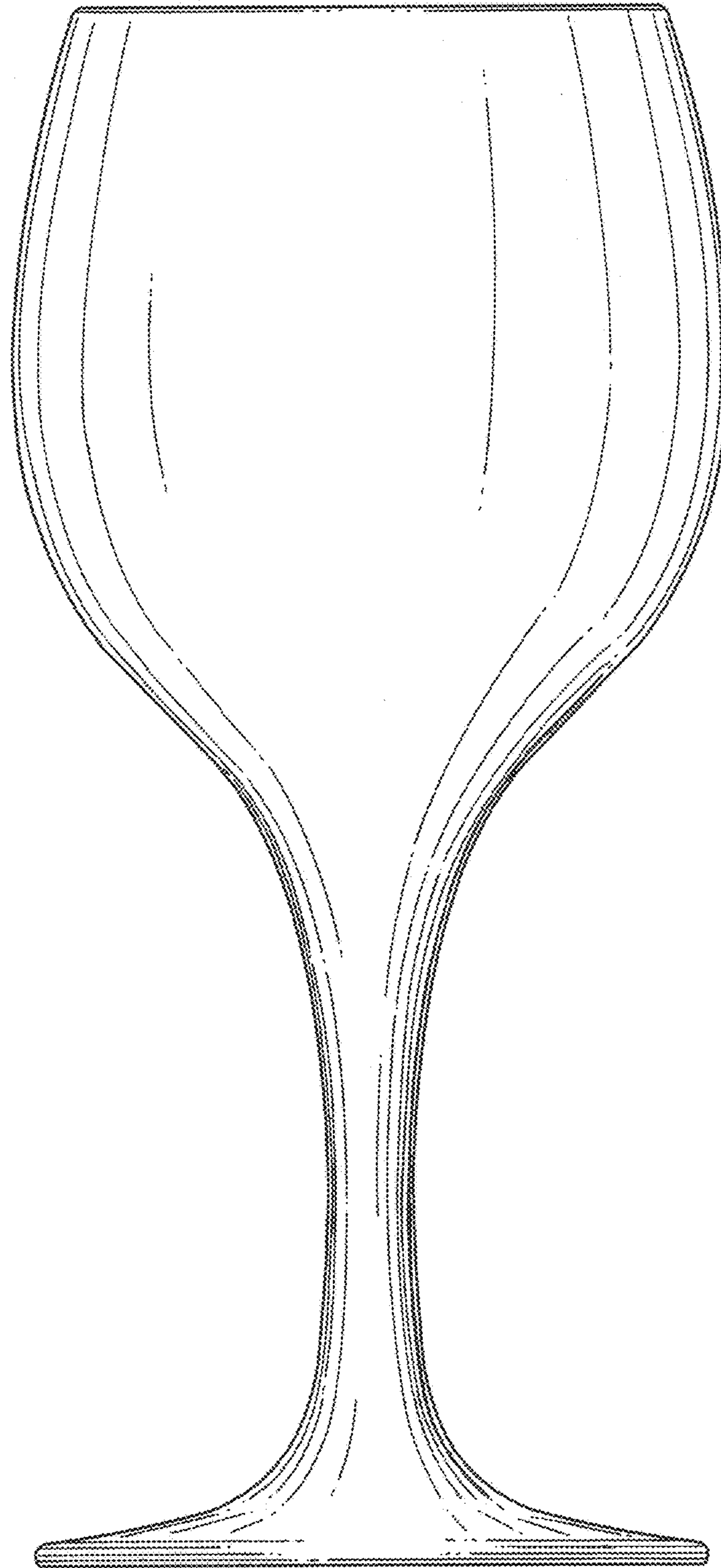

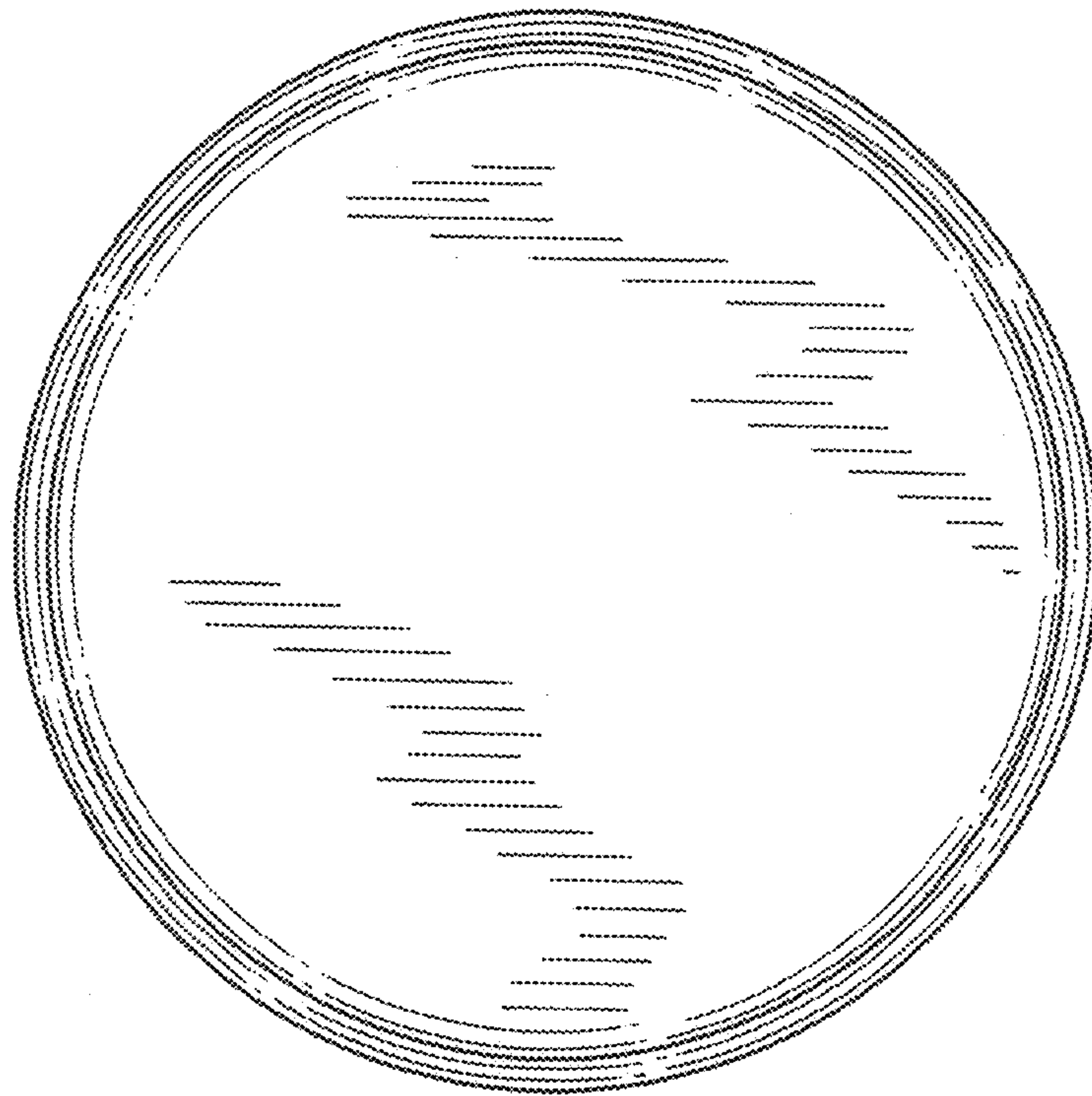

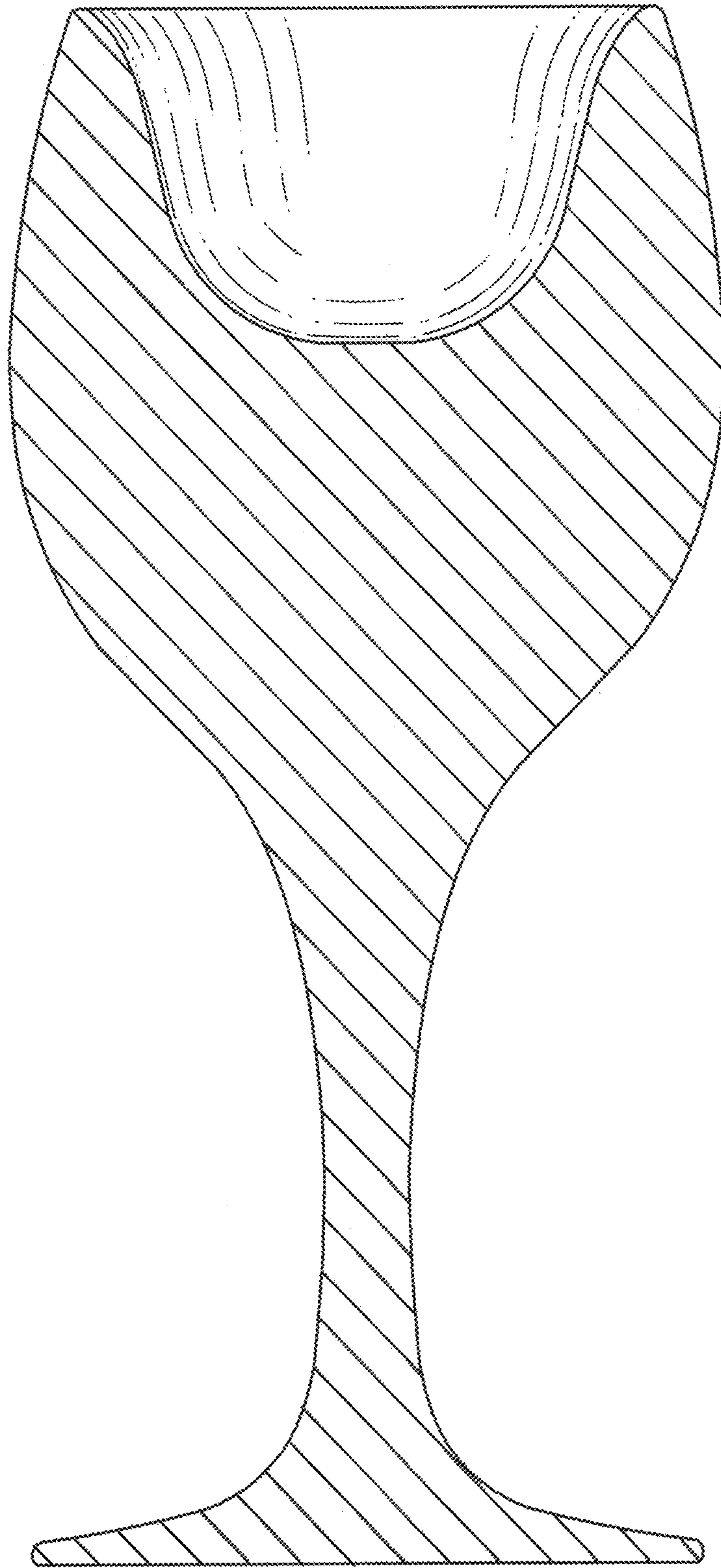
