DESCRIPTION

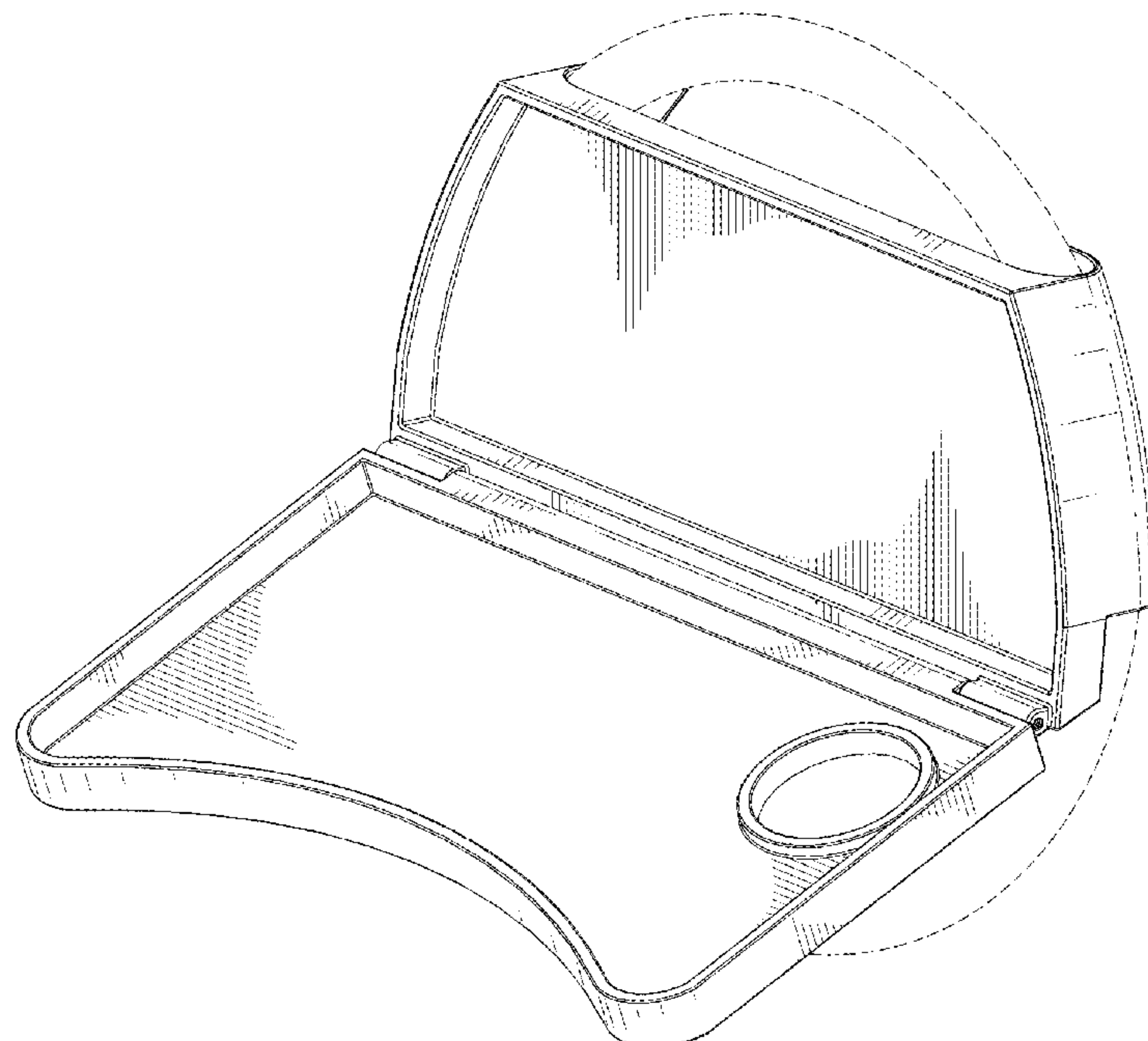
FIG. 1 is a perspective view of the steering wheel attachable table showing my new design;

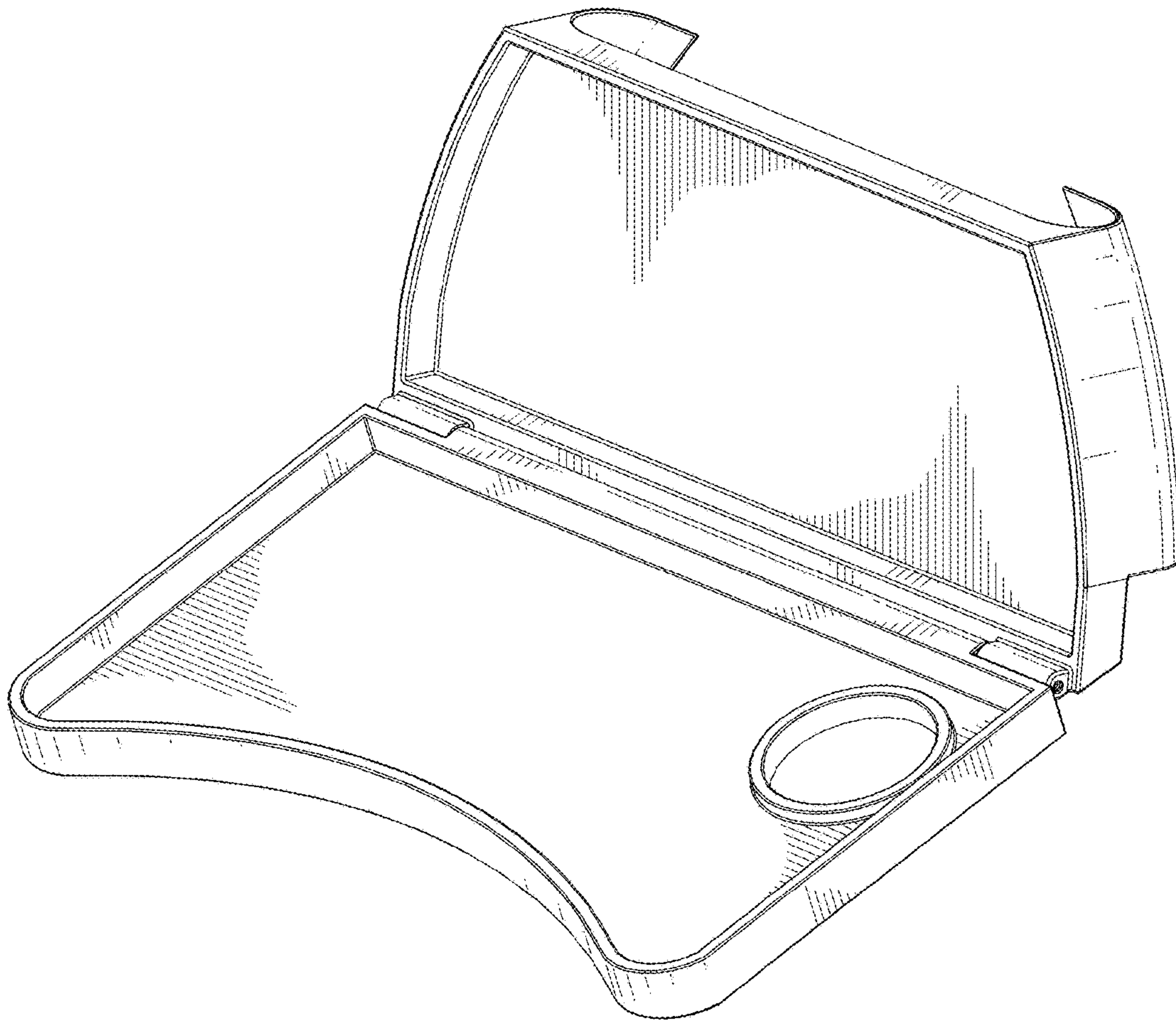

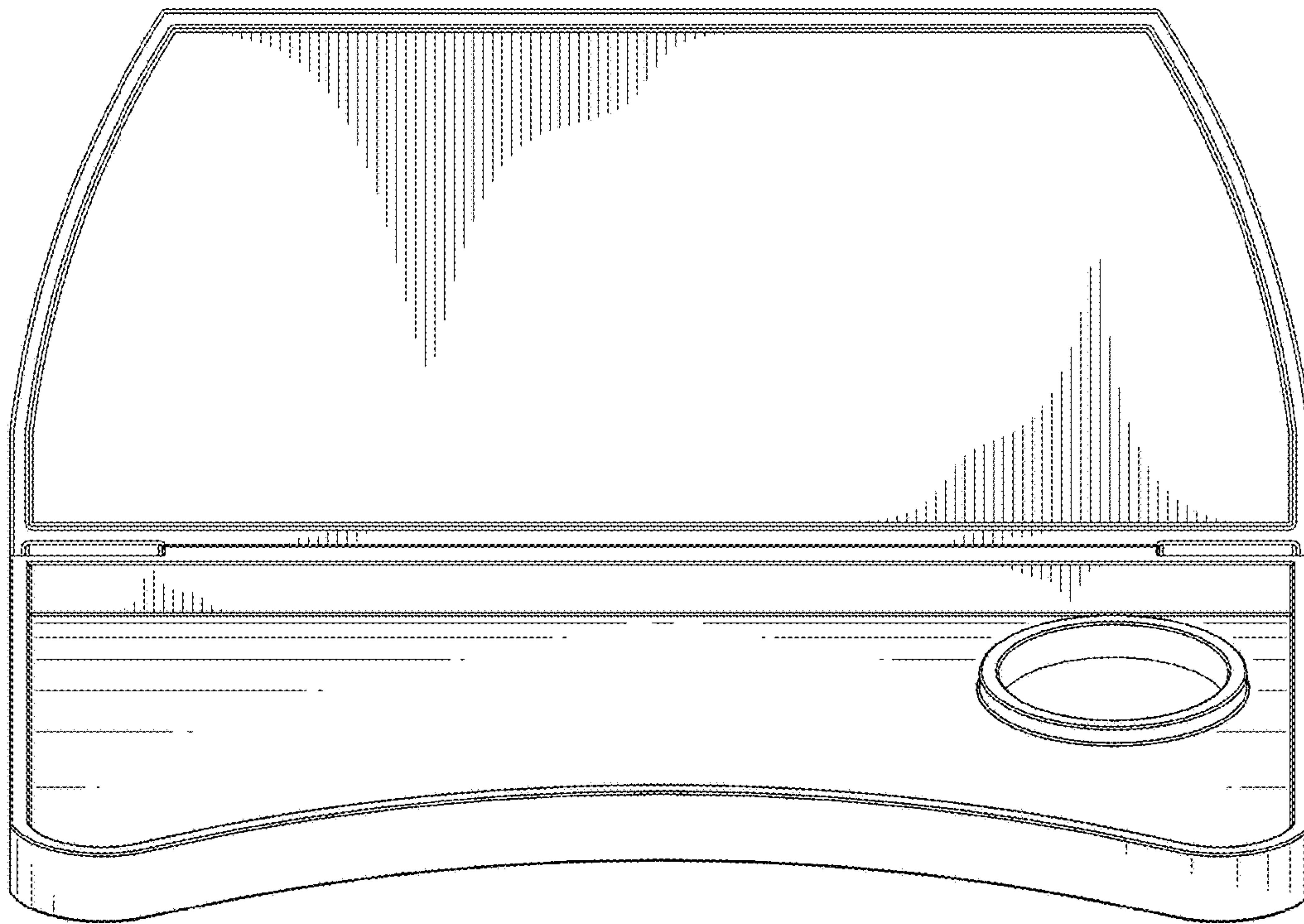

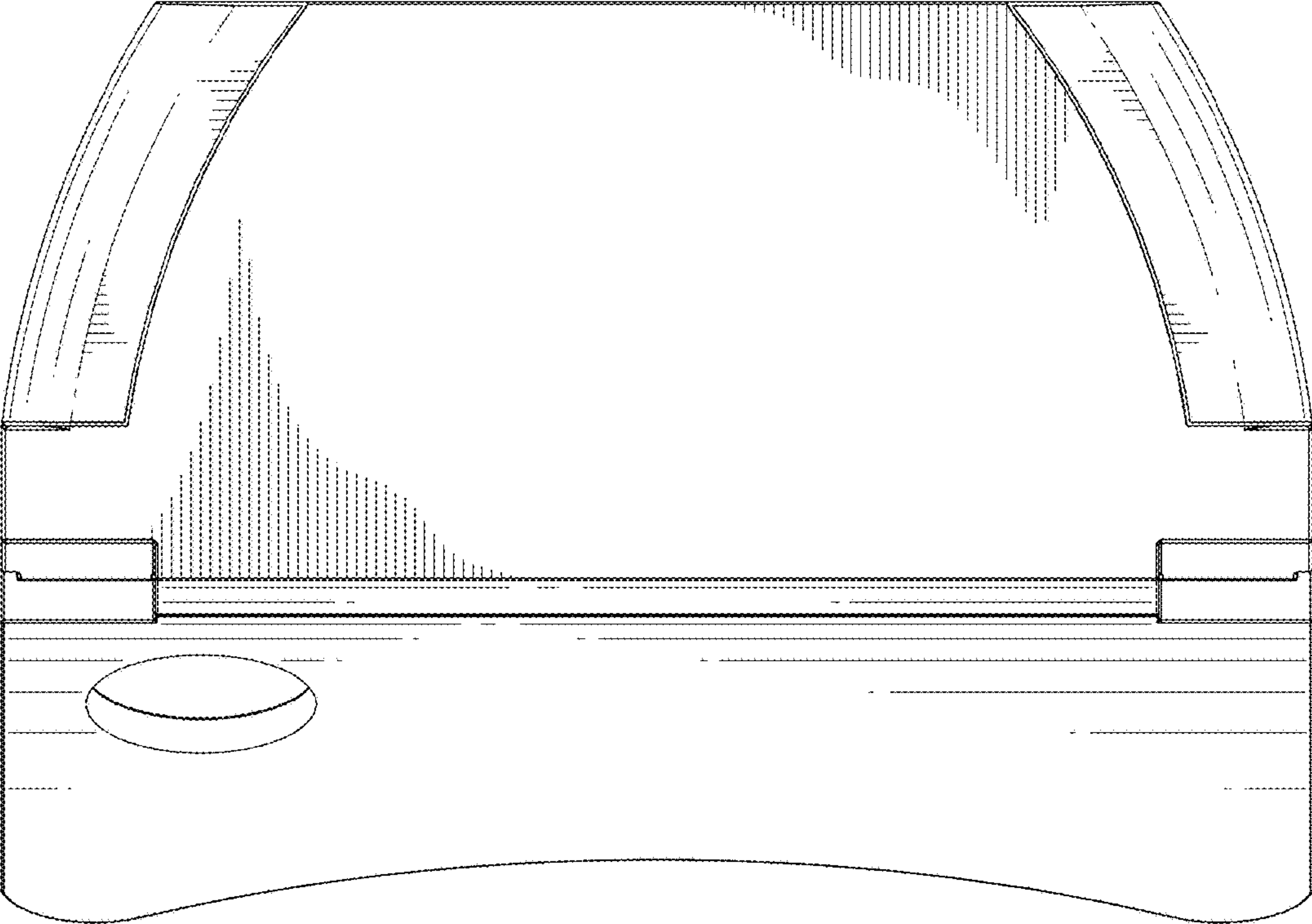

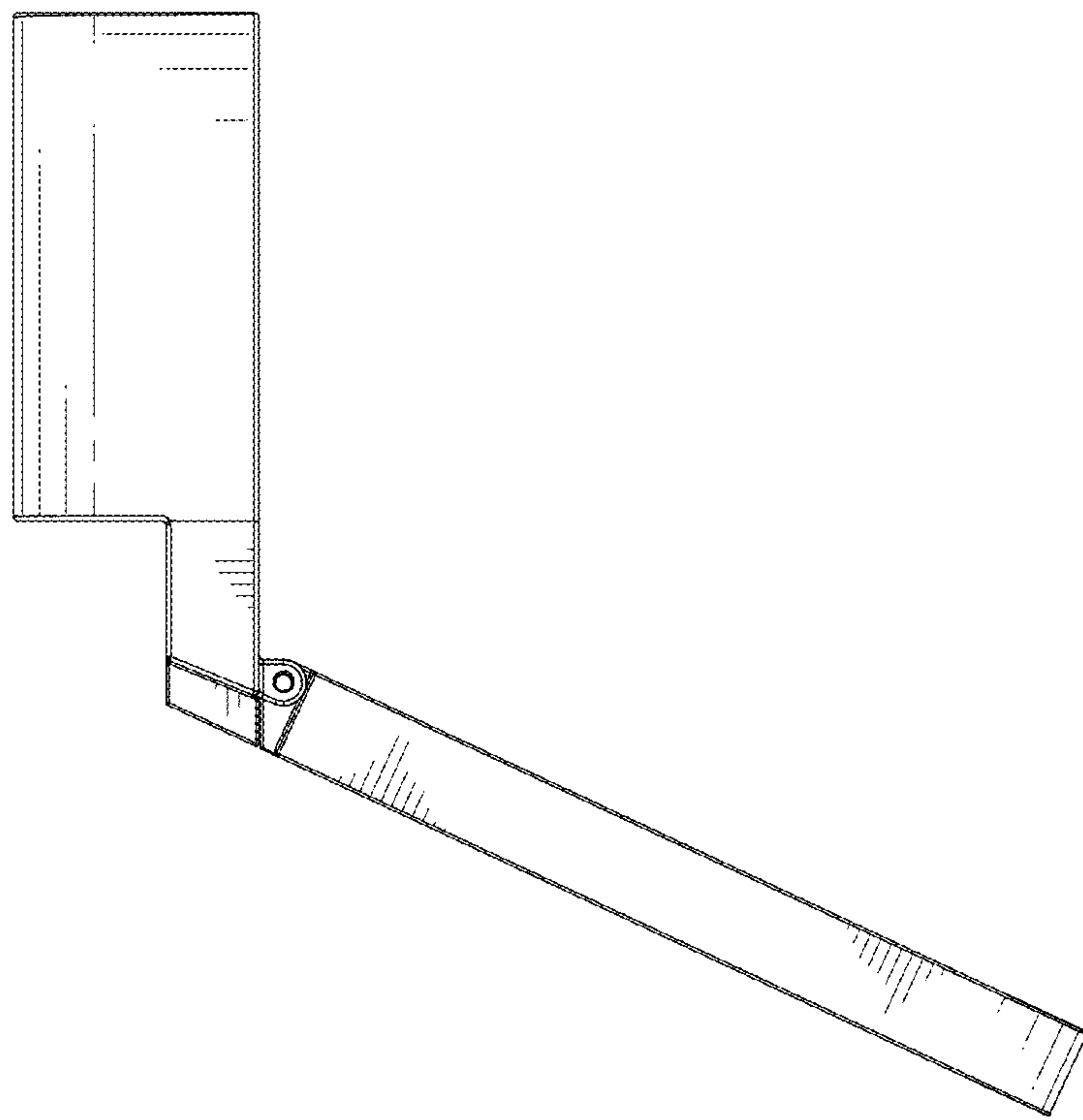

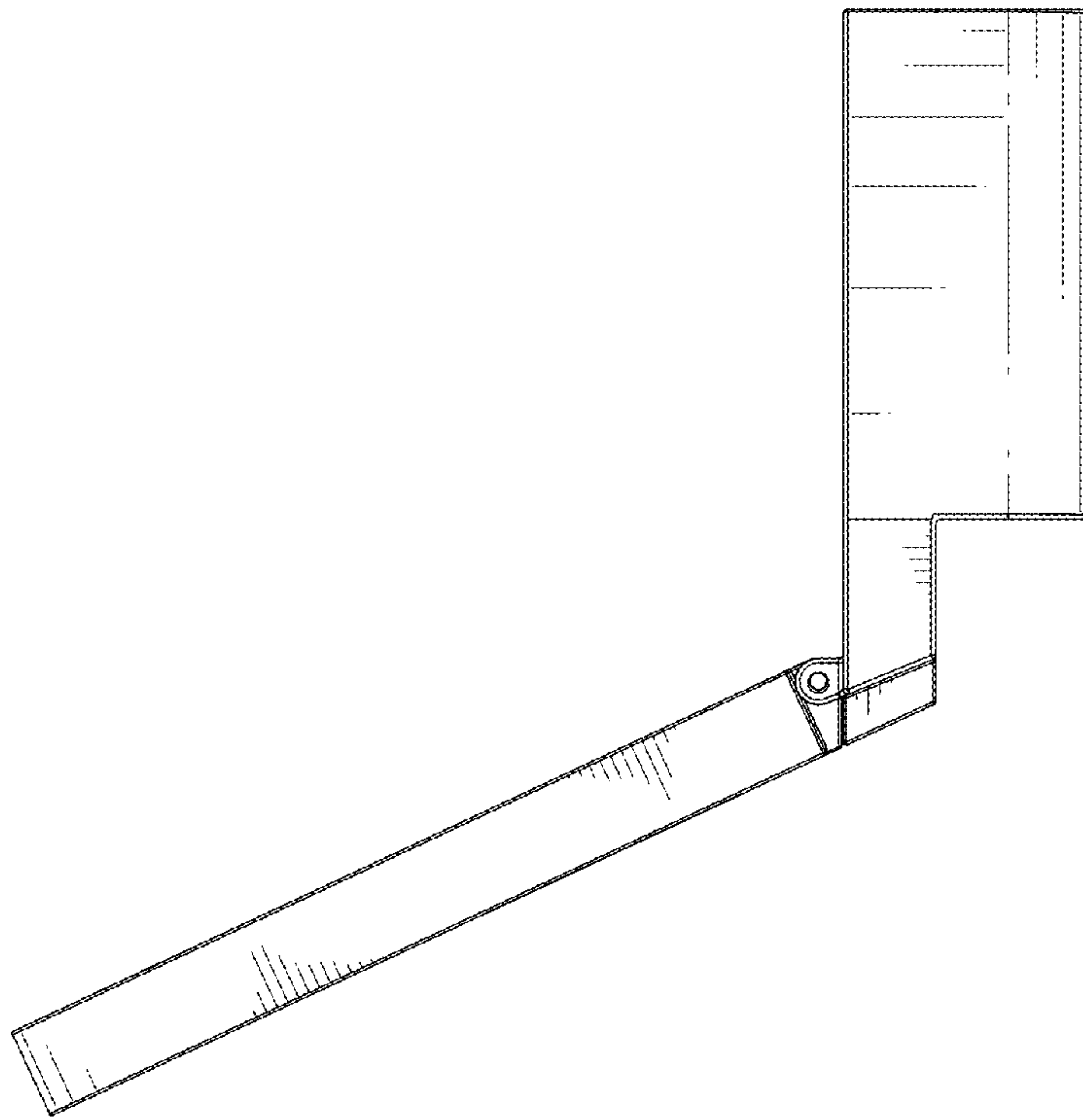

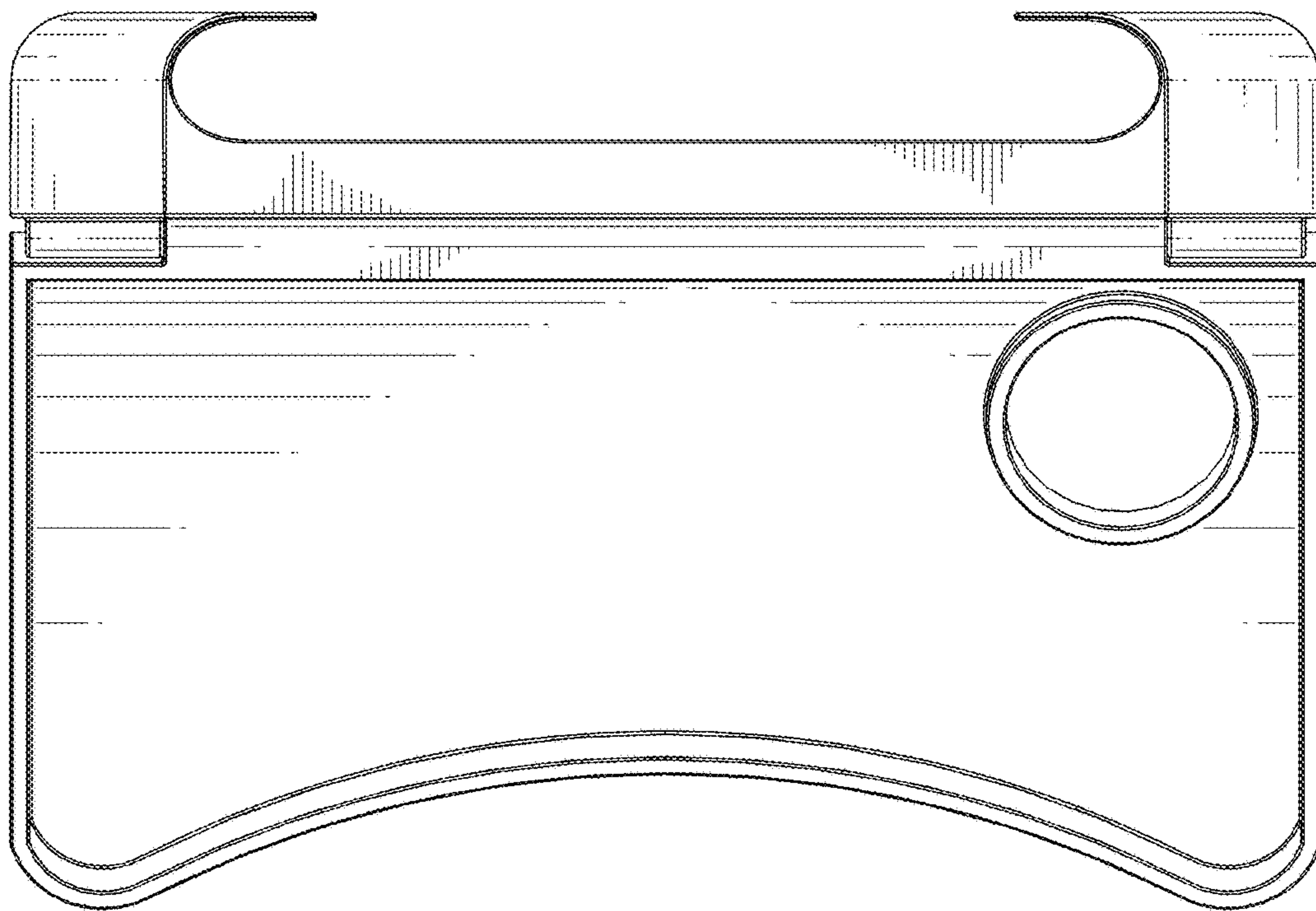

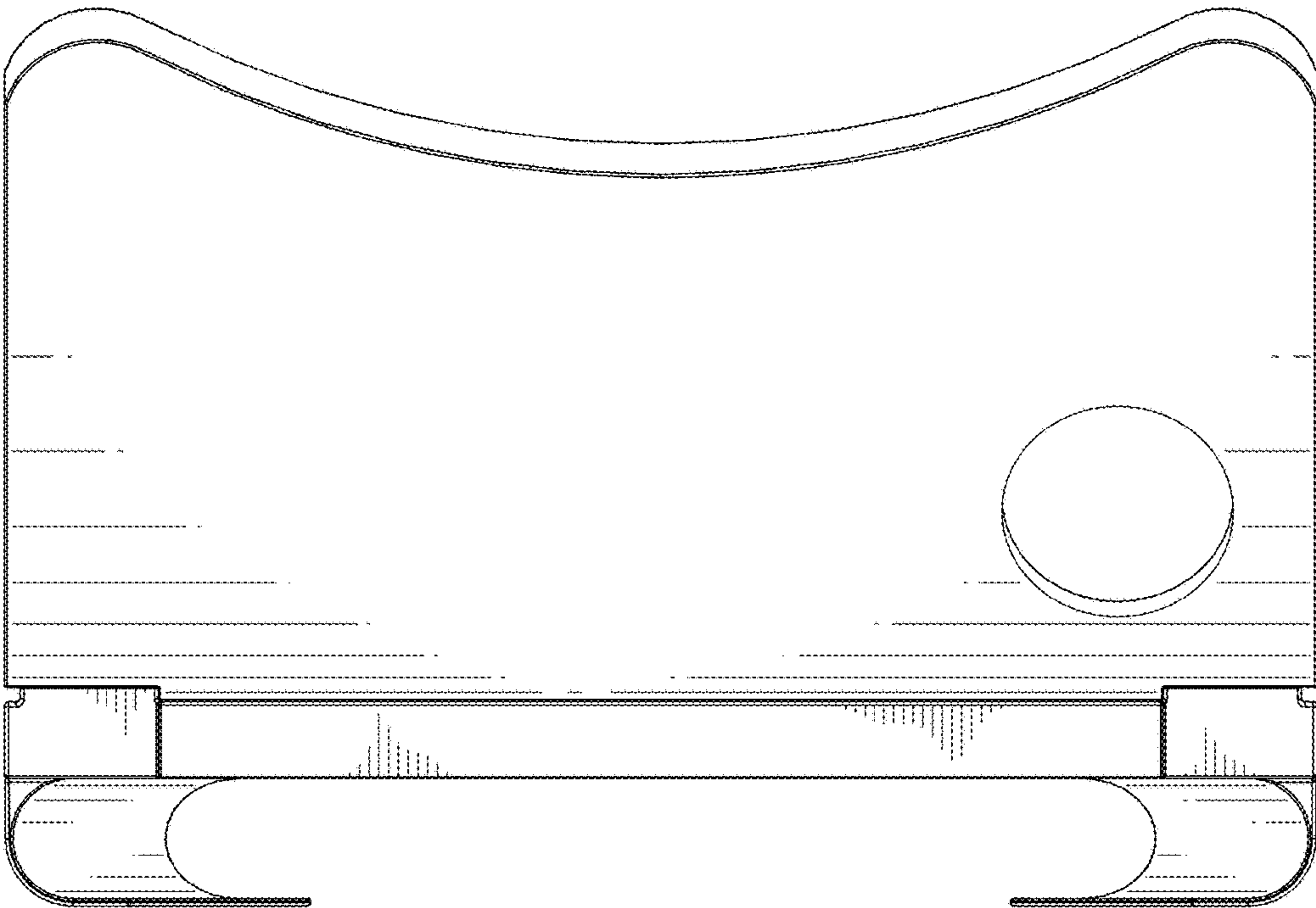

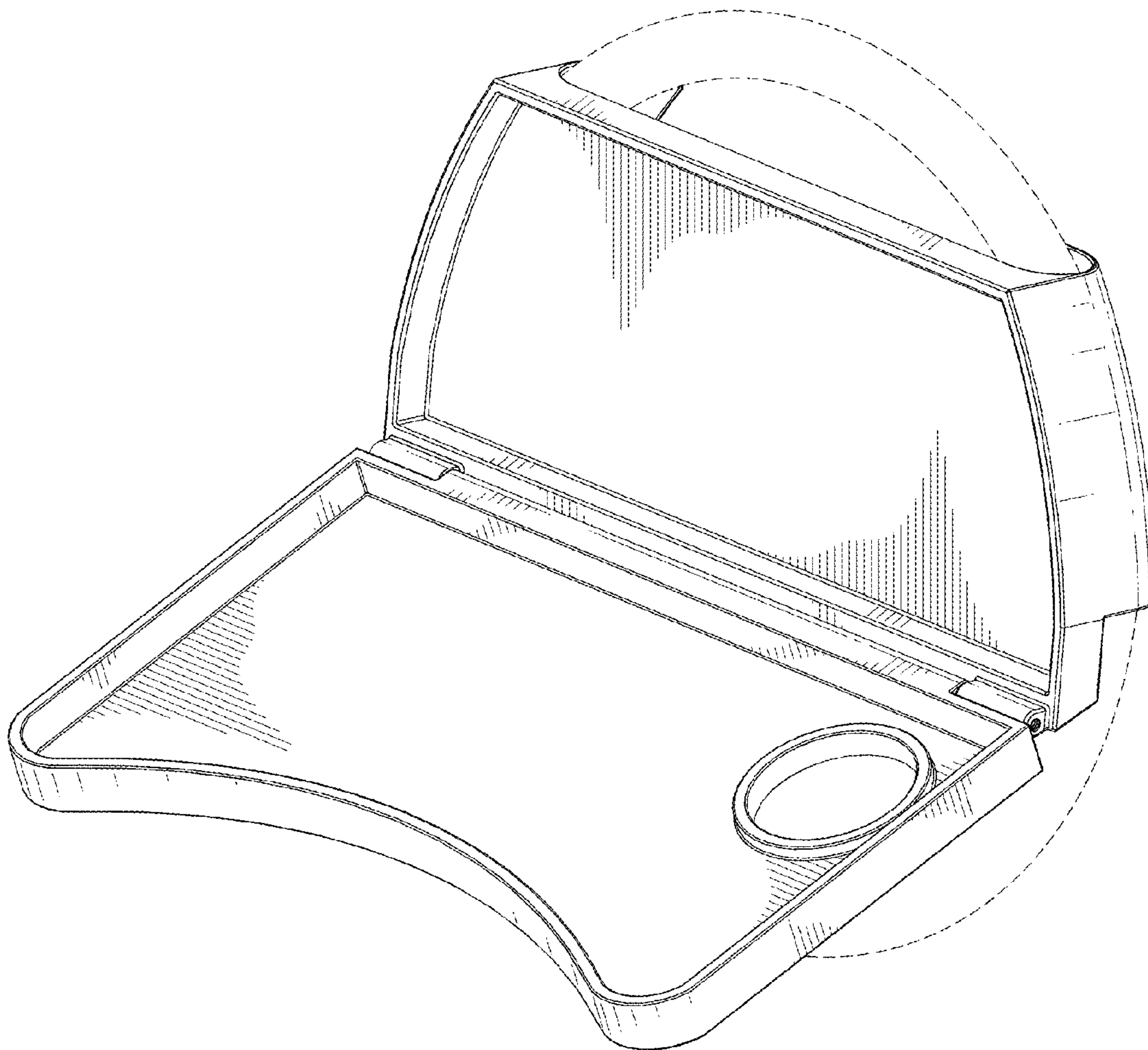
