(57) **CLAIM**

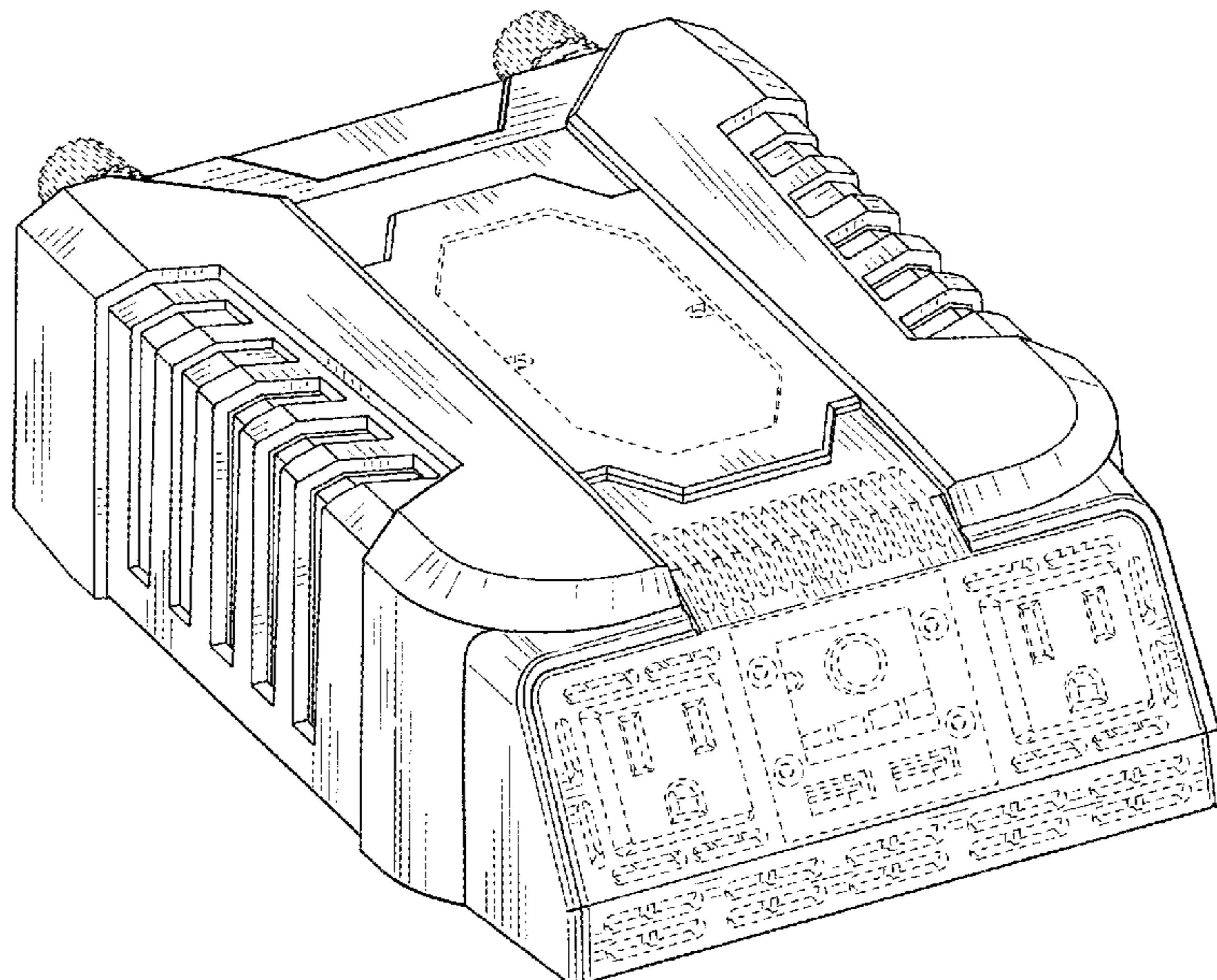
The ornamental design for a power inverter, as shown and described.

DESCRIPTION

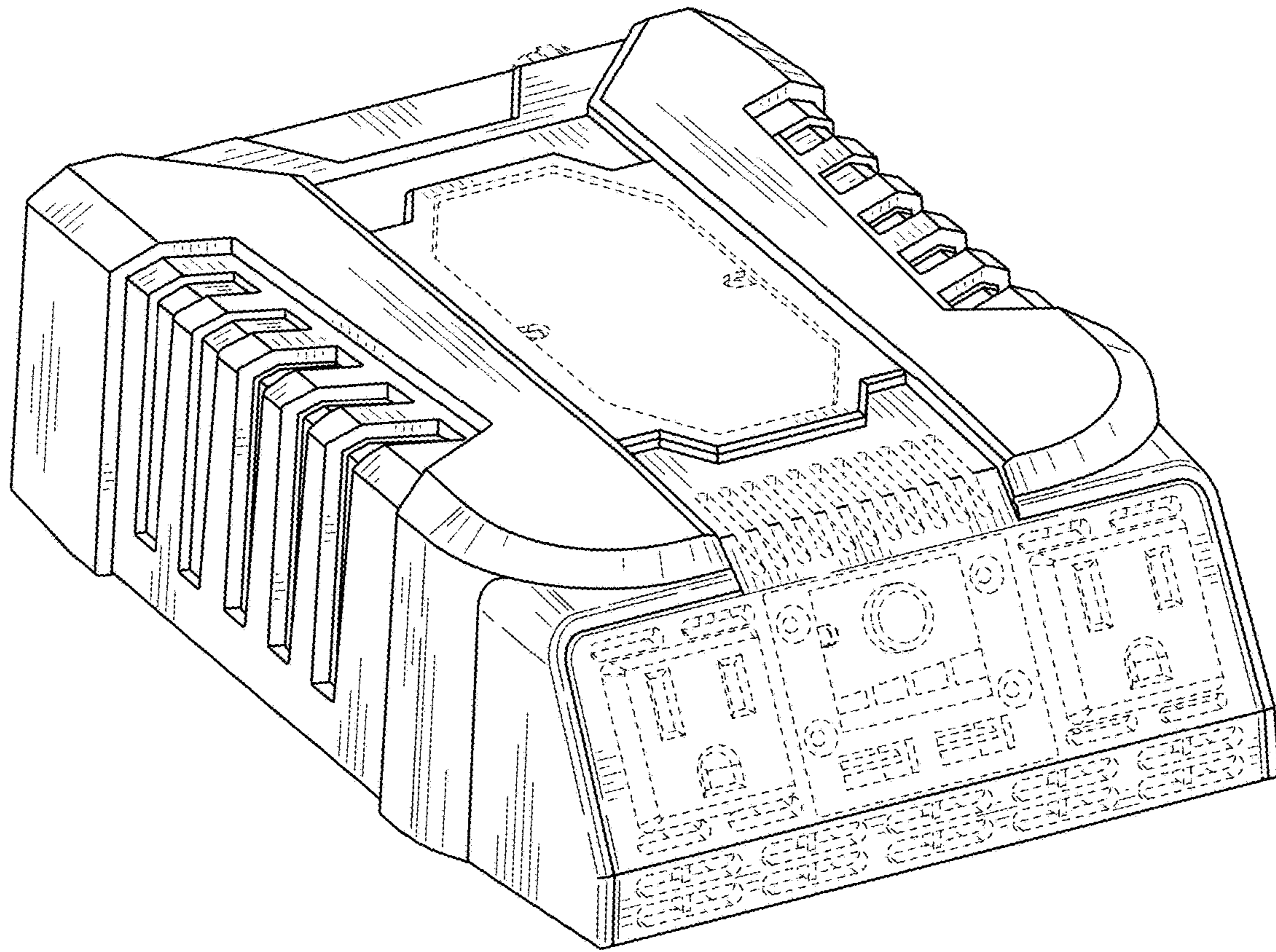

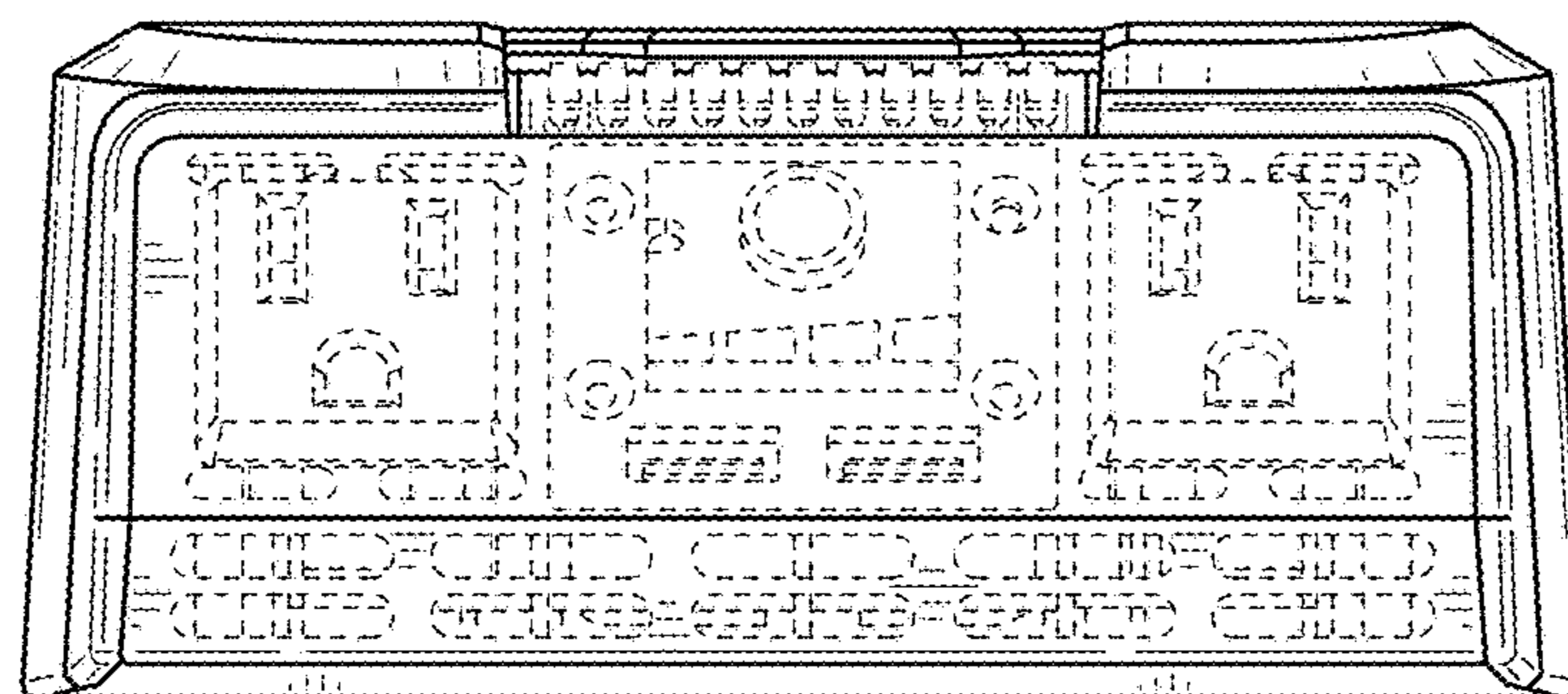

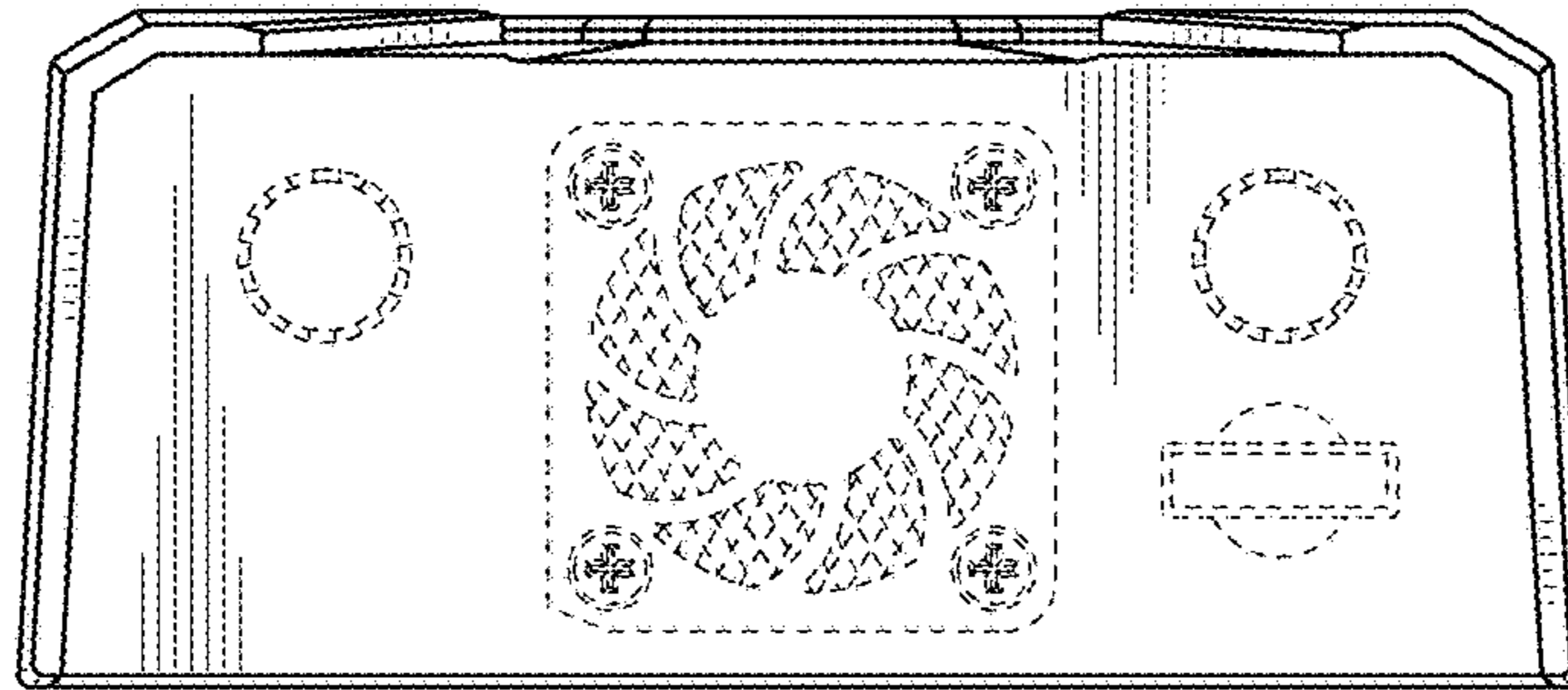

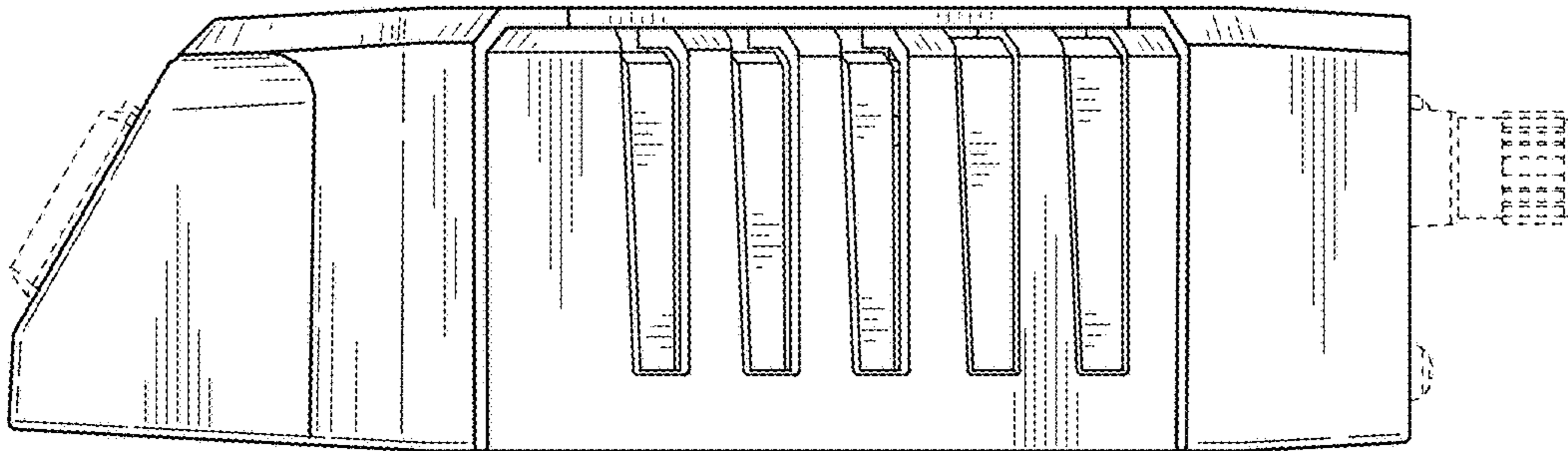

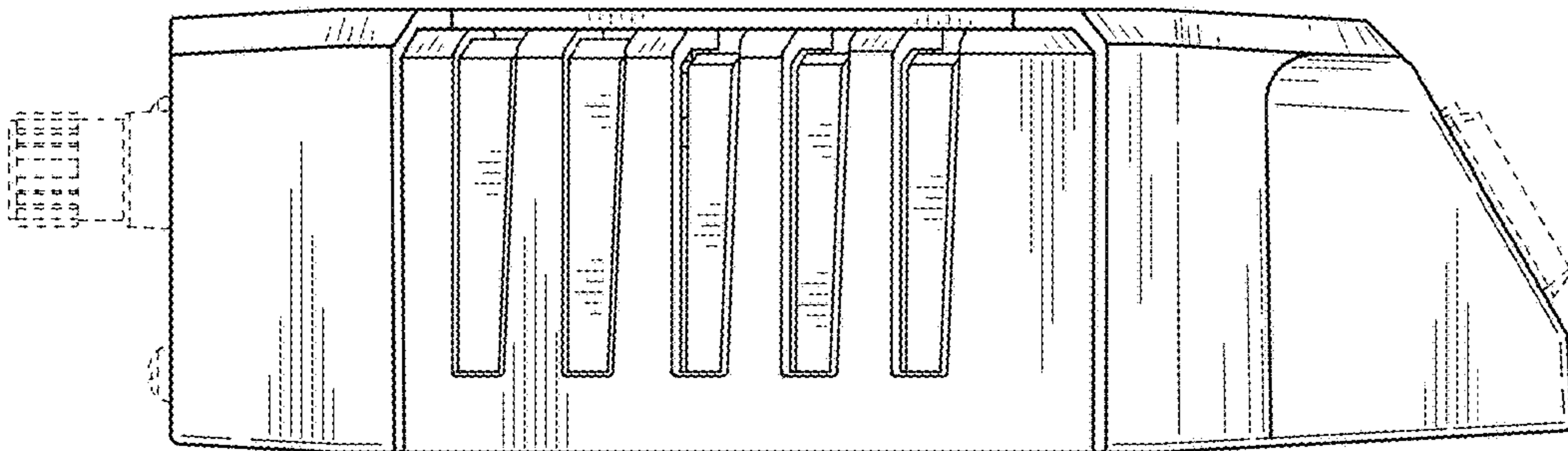

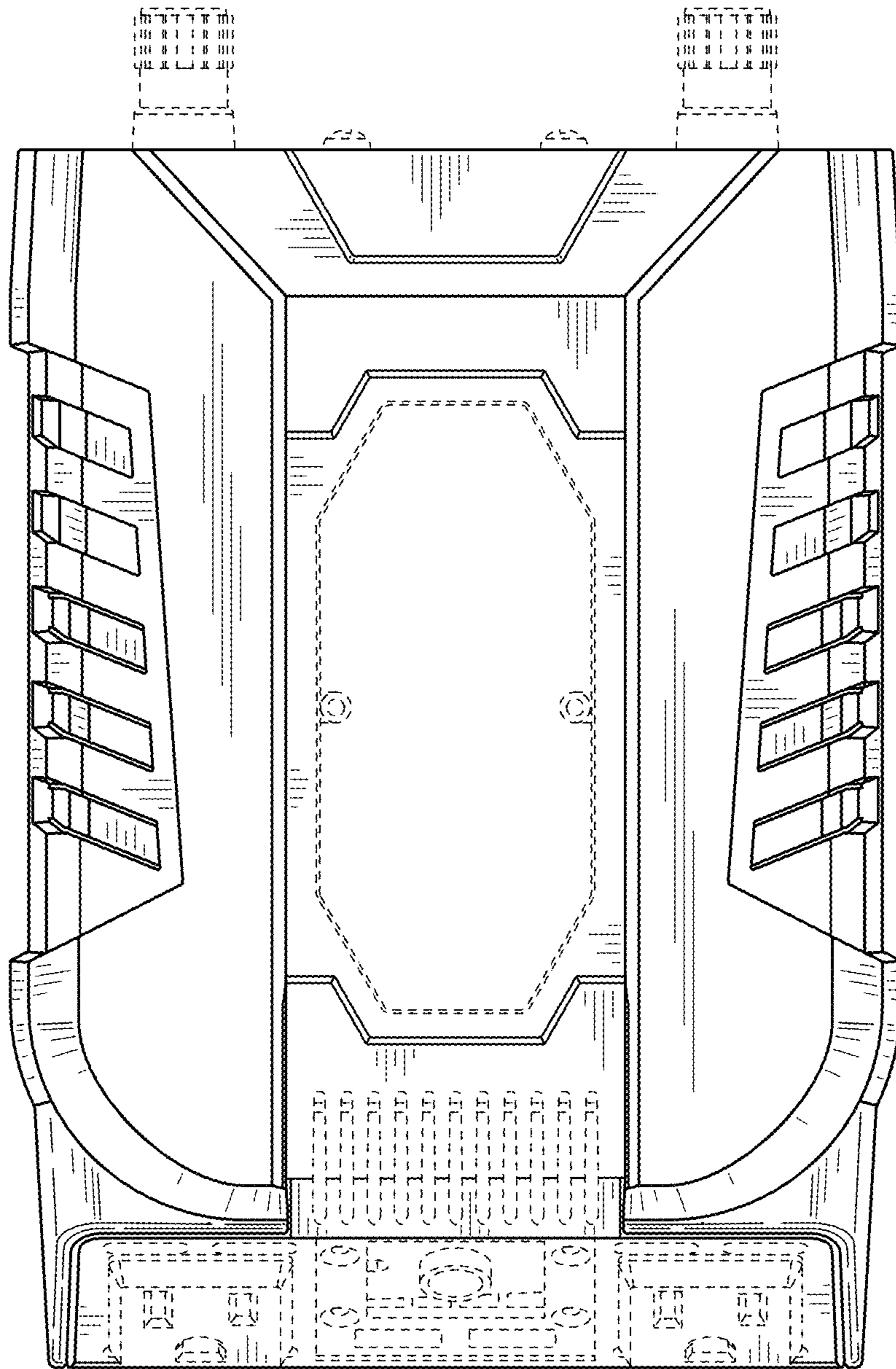

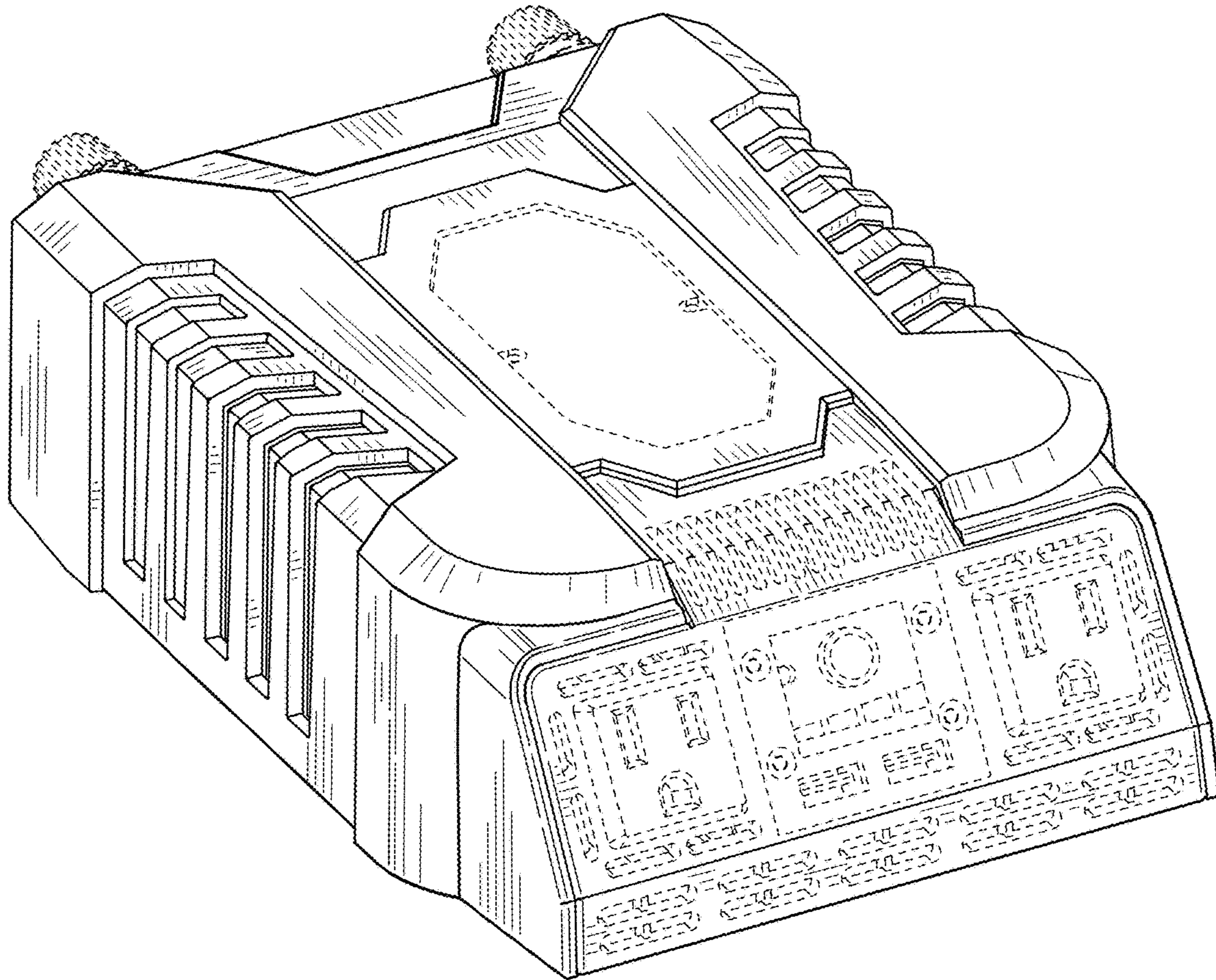

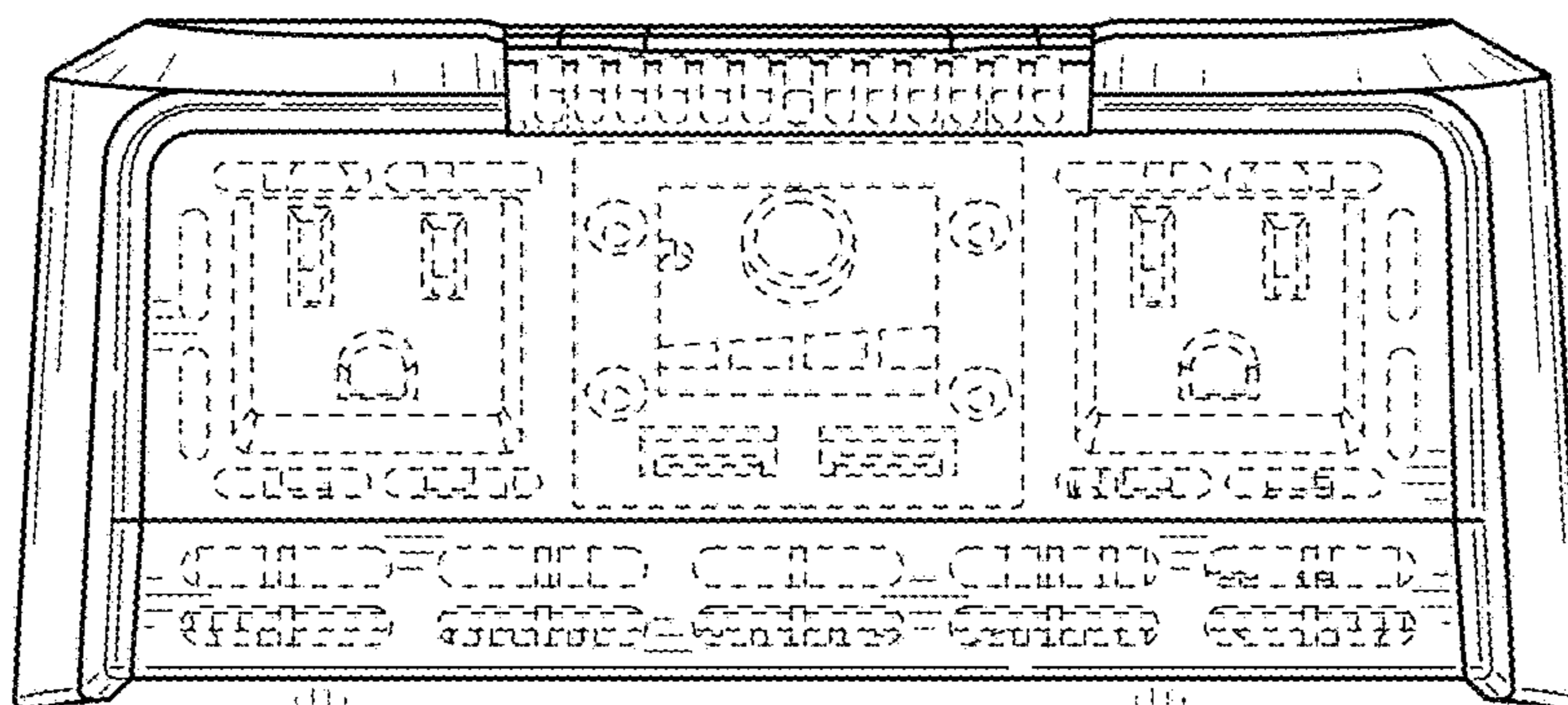

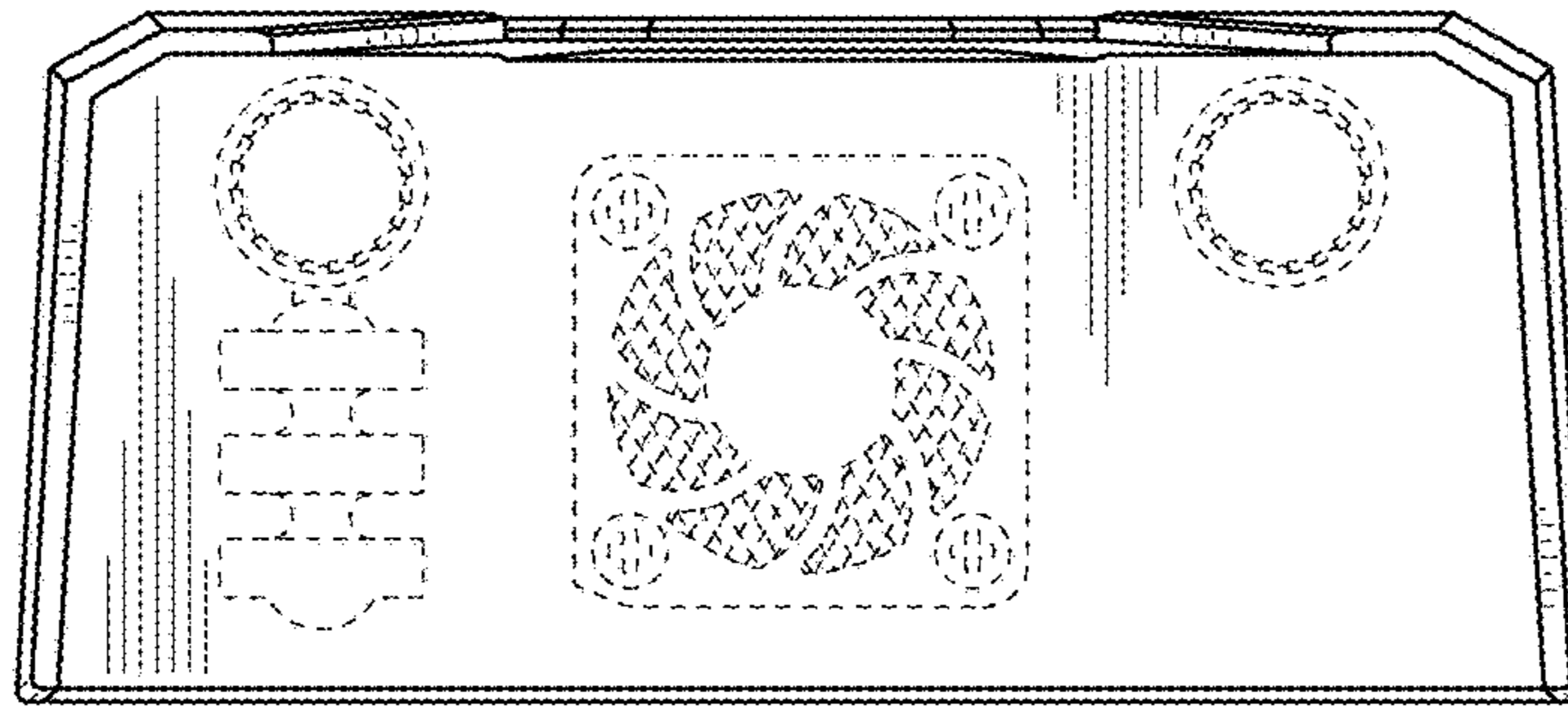

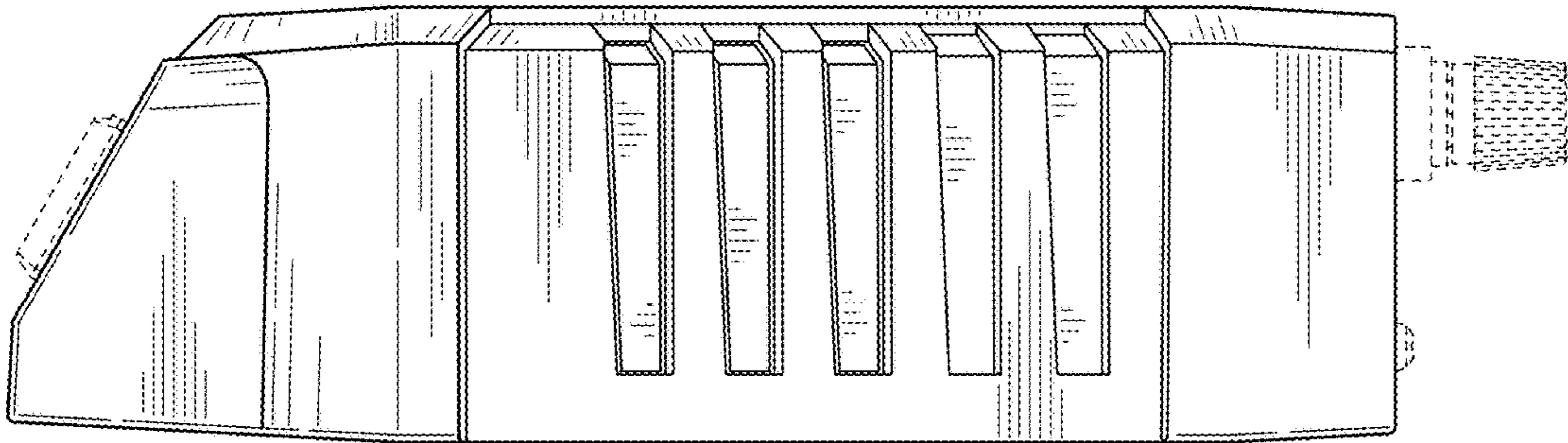

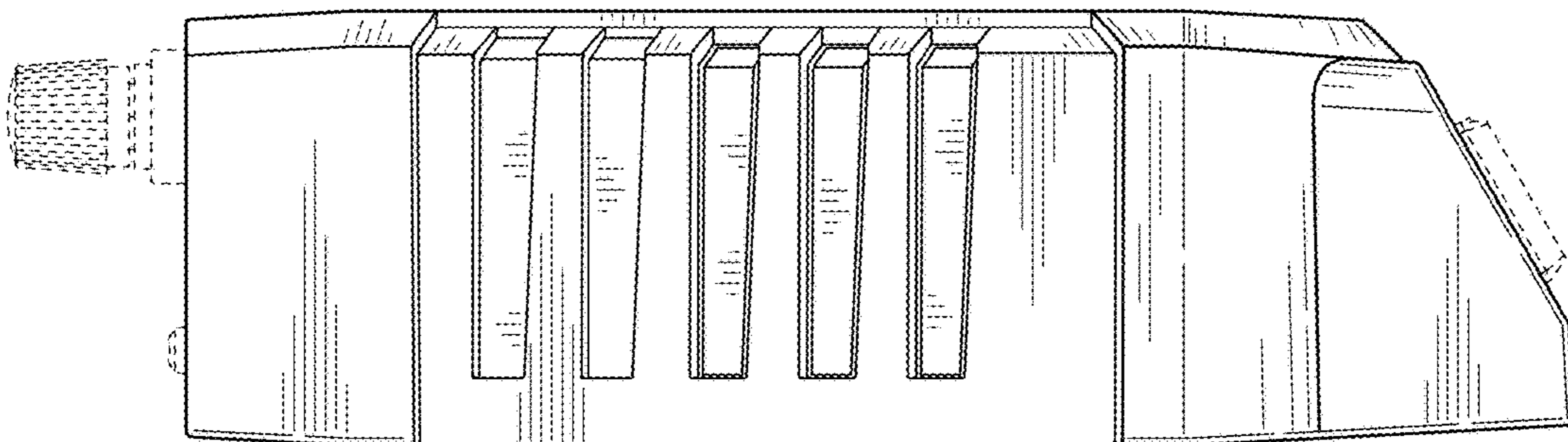

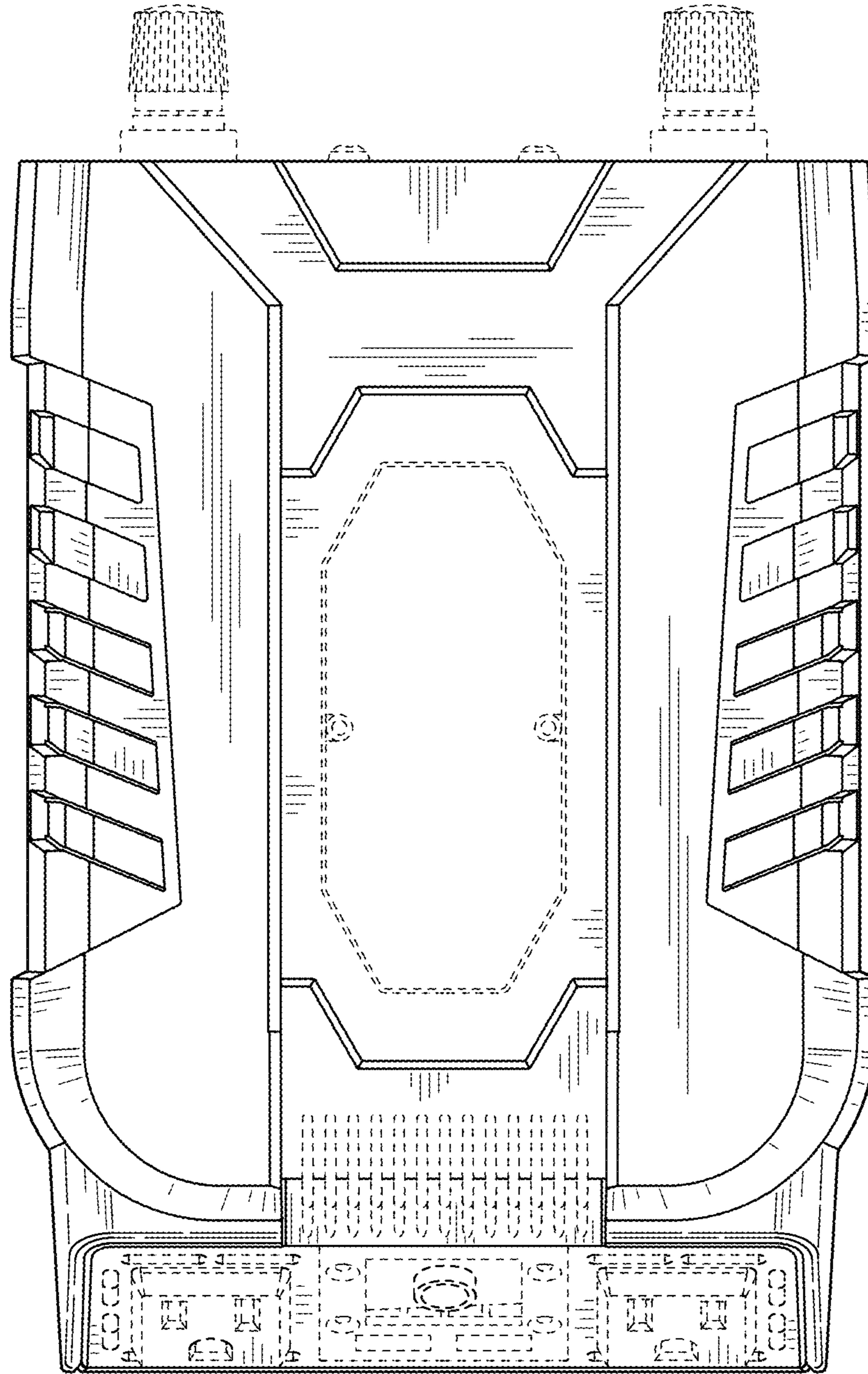
