FIG. 3. A first side perspective view of the standup paddle-board skateboard.

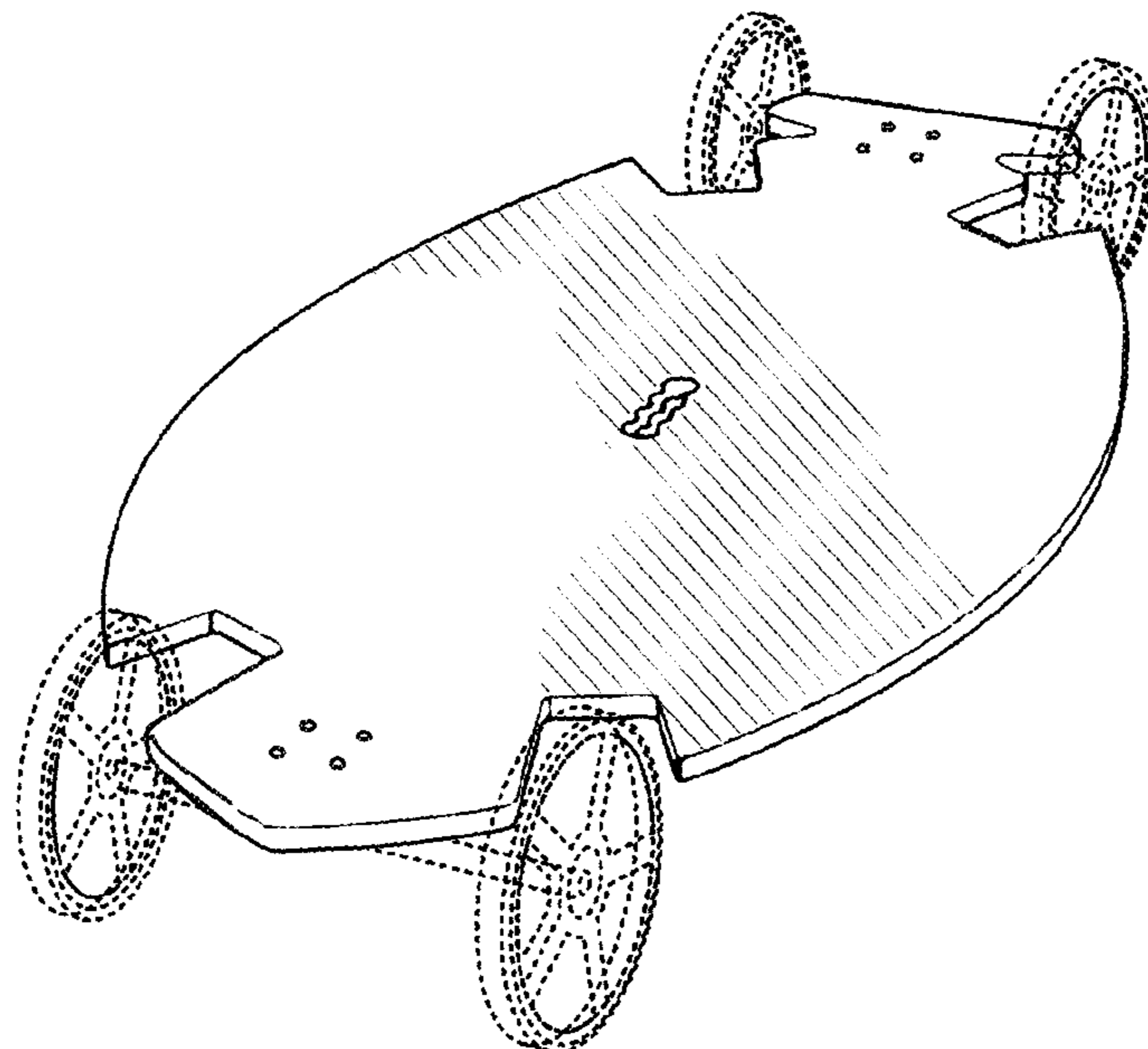
FIG. 4. A second side perspective view of the standup paddle-board skateboard.

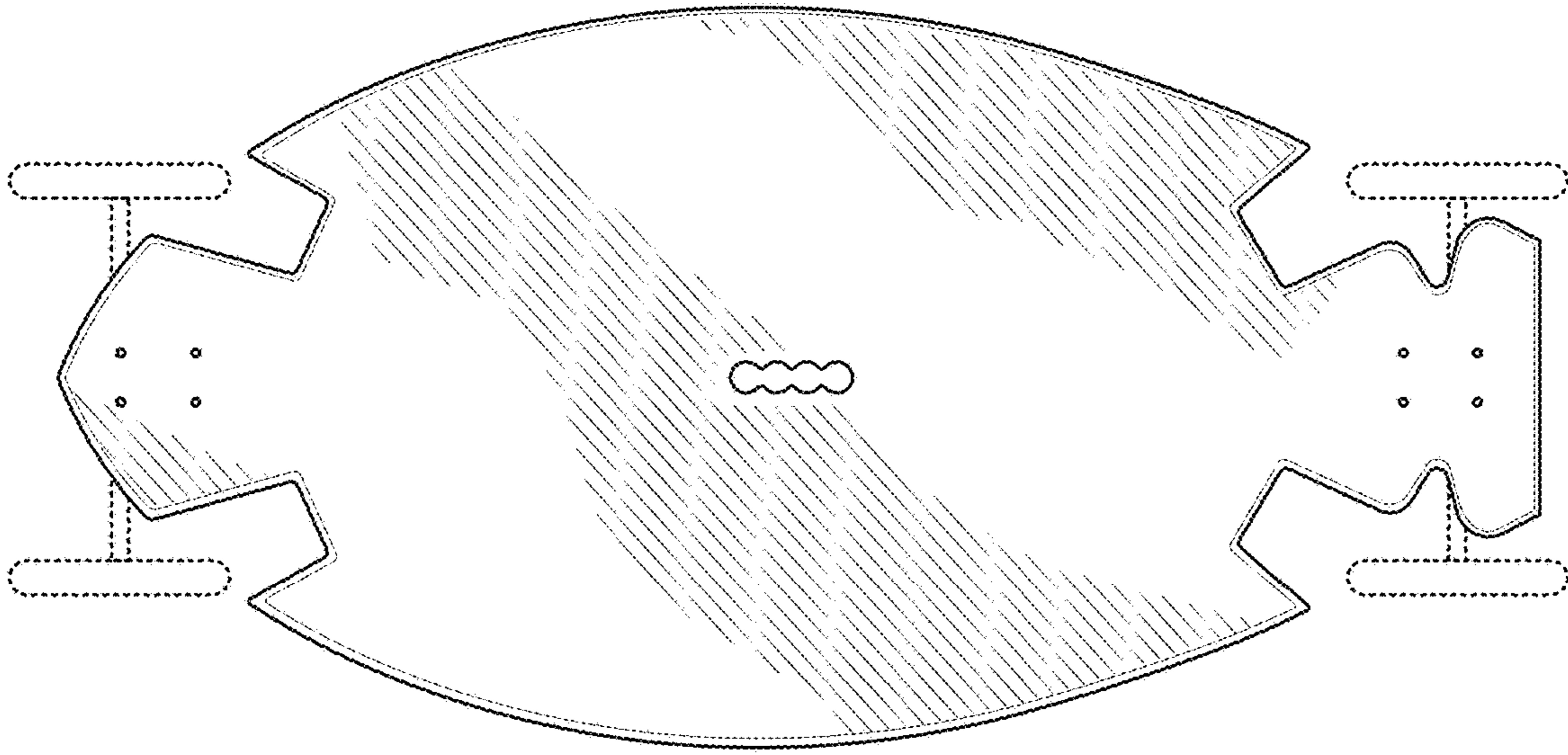

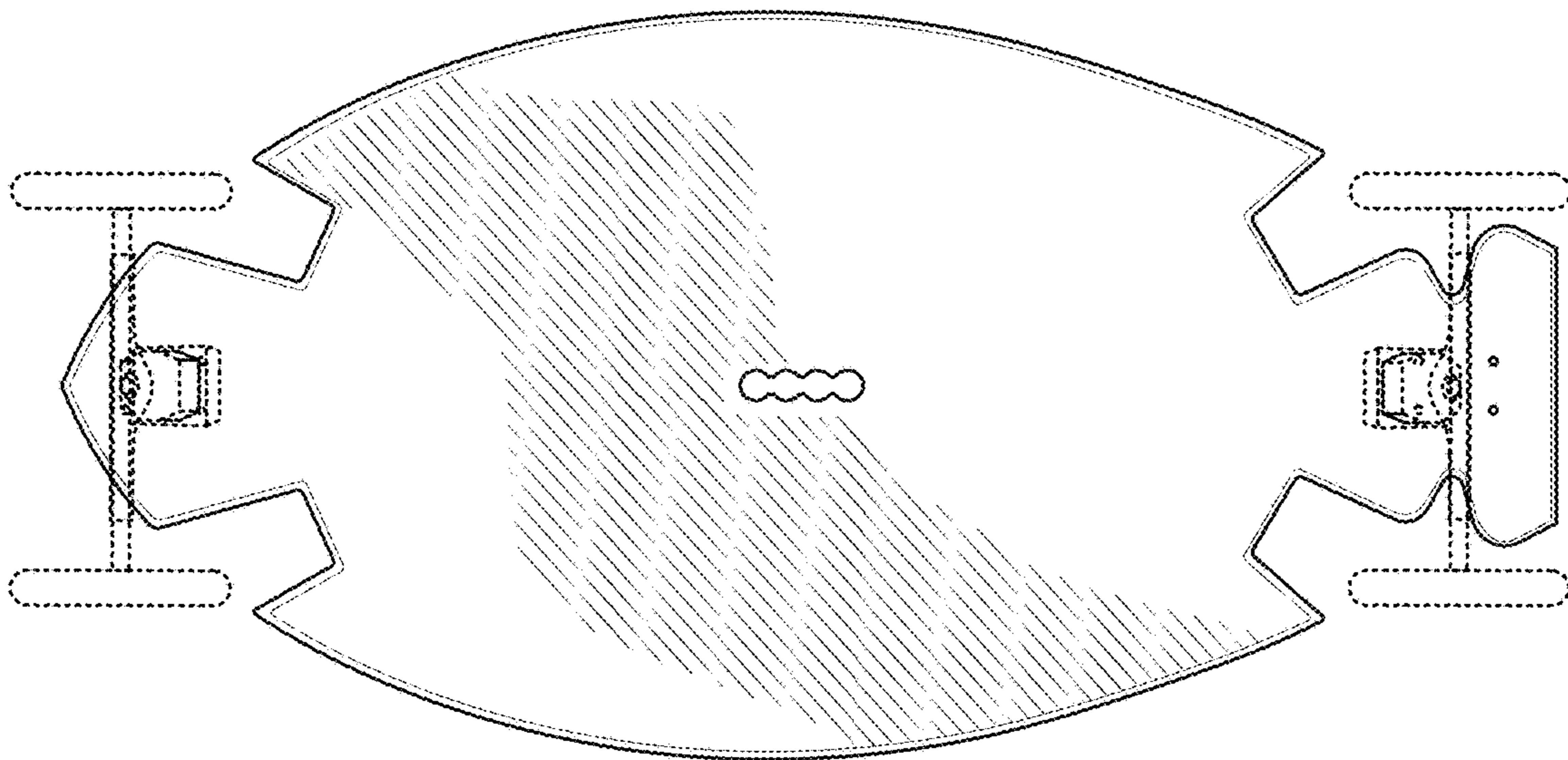

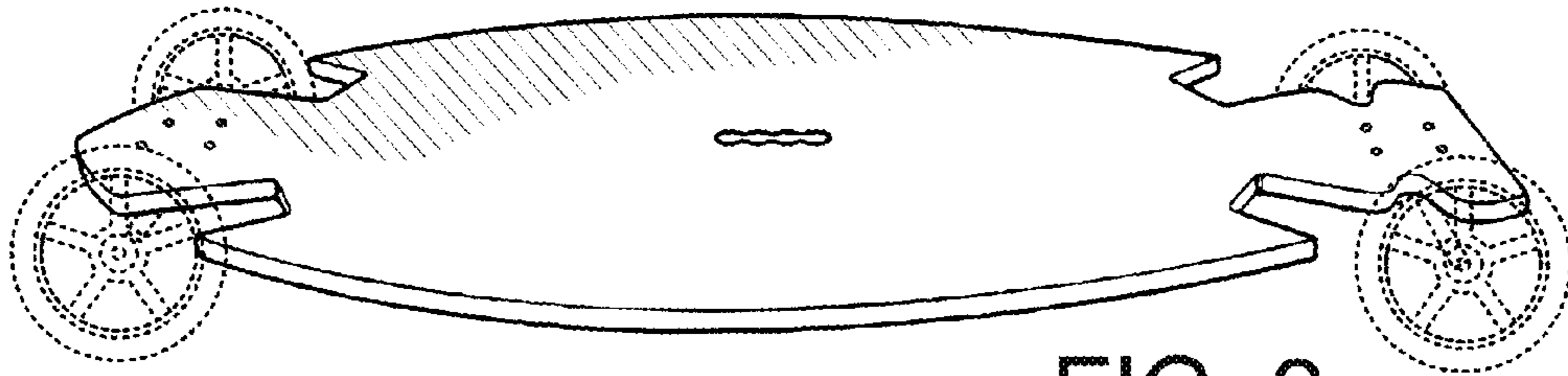

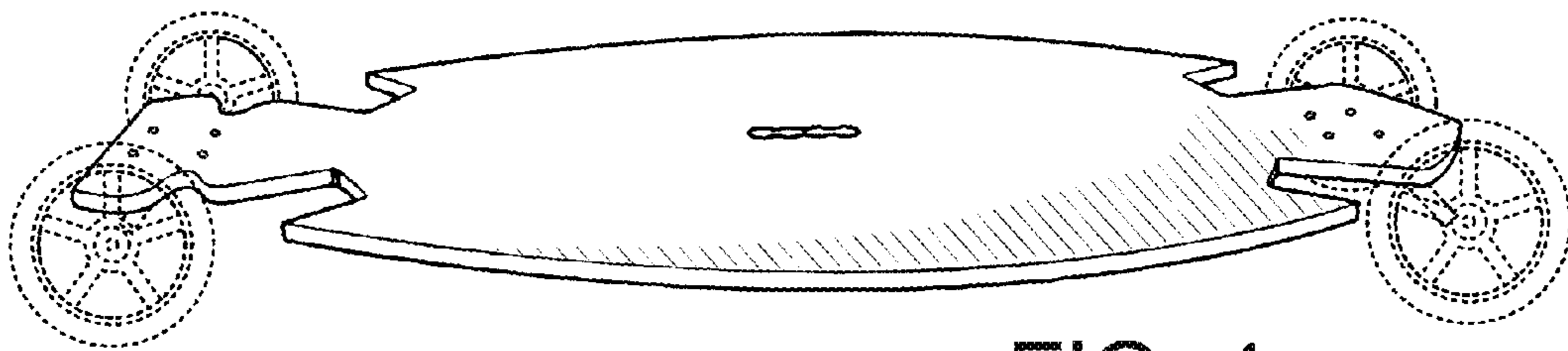

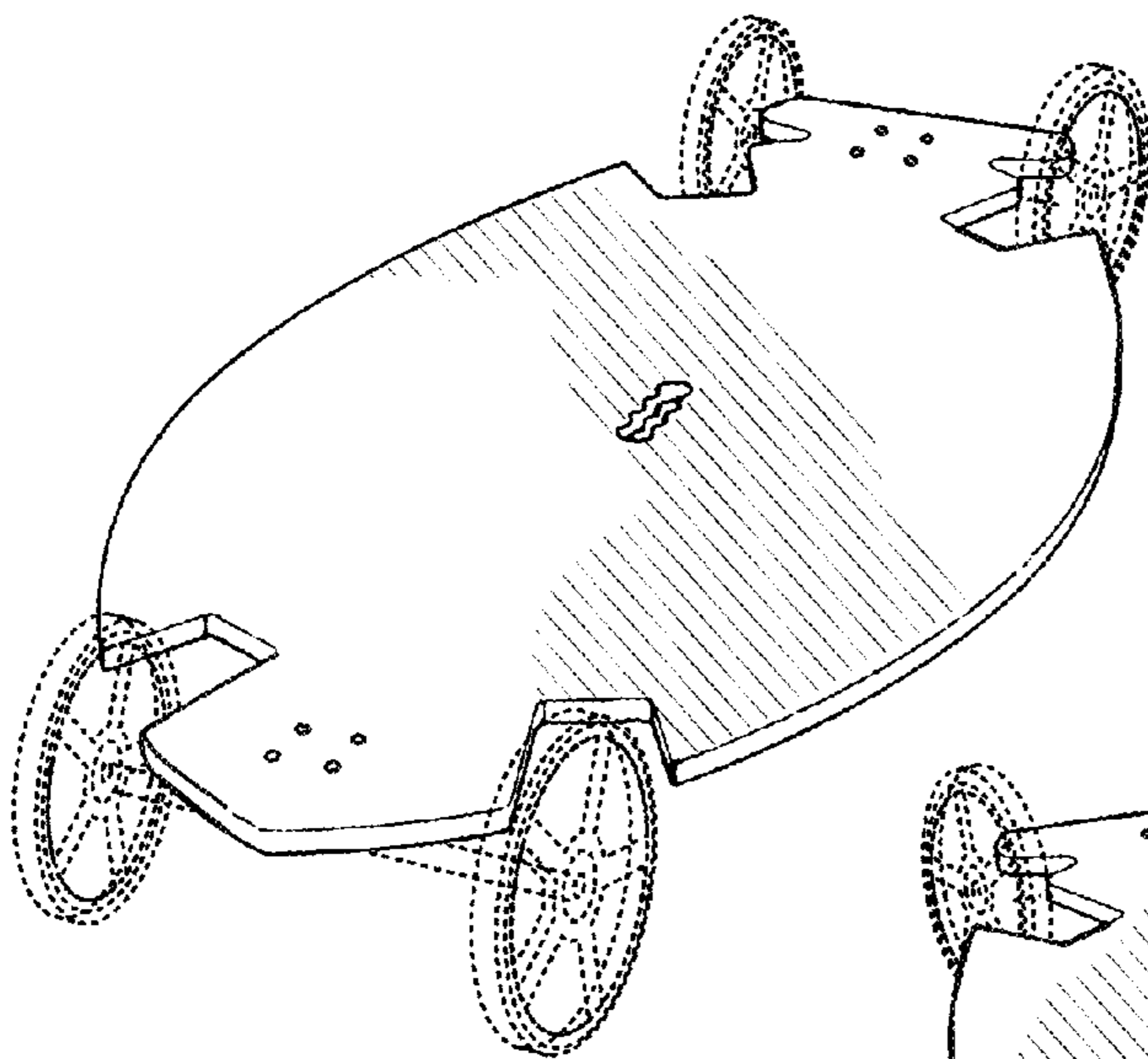

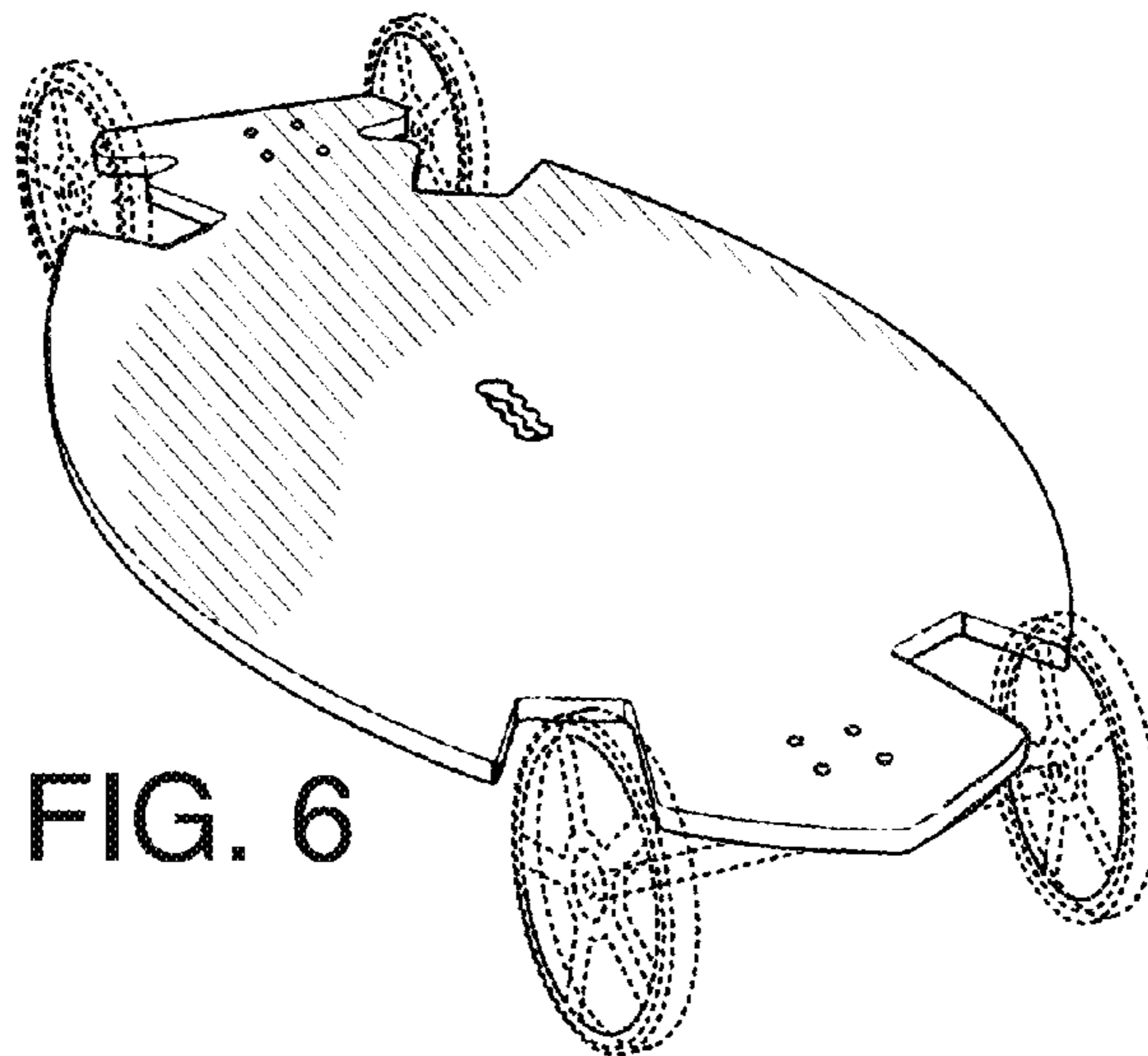
