(57) **CLAIM**

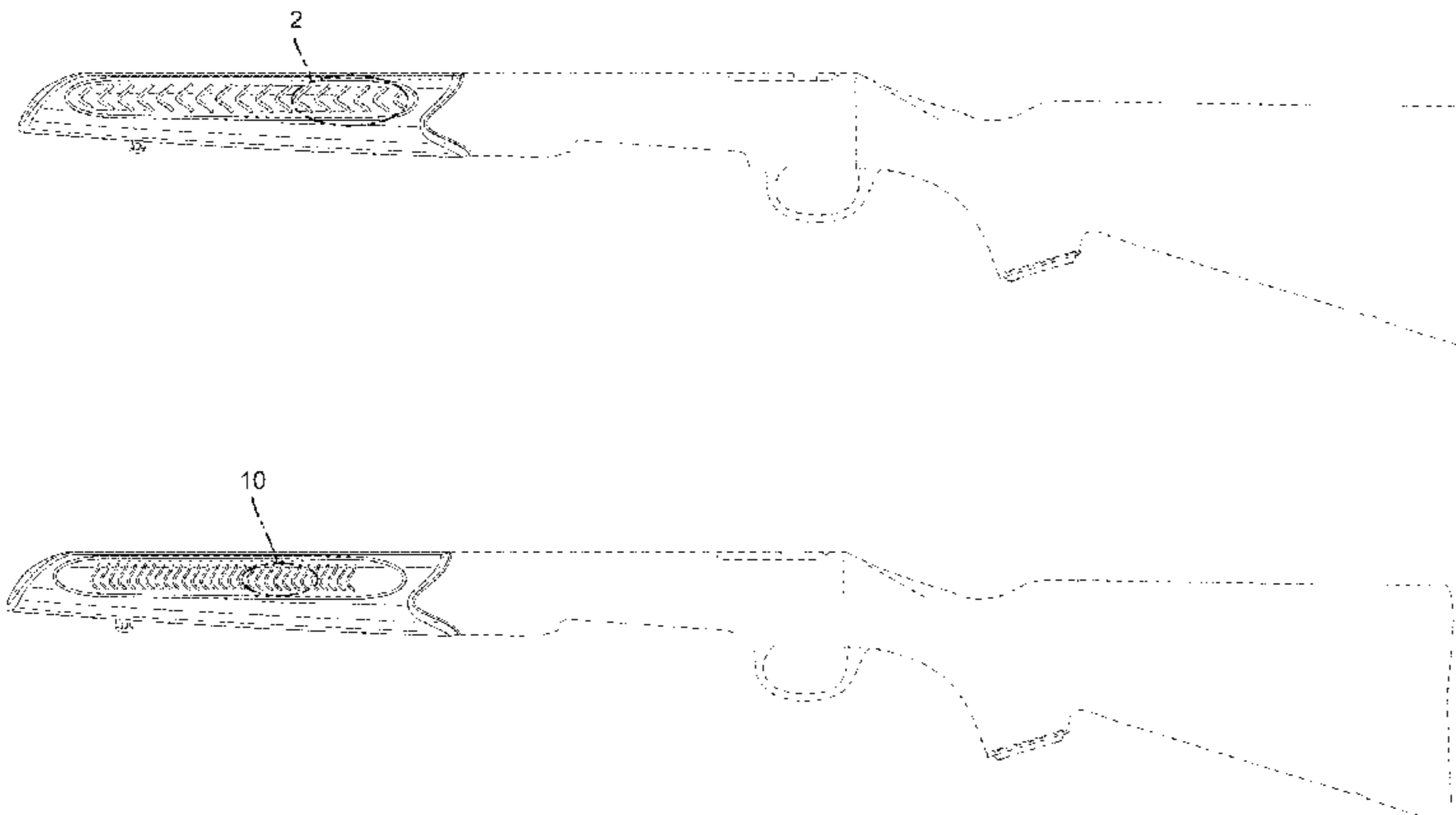
We claim the ornamental design for a rifle stock, as shown and described.

DESCRIPTION

FIG. 1 is left side view of an embodiment of our design for a rifle stock having gripping grooves;
 FIG. 2 is a magnified view thereof of area 2 circumscribed within FIG. 1;
 FIG. 3 is a right side view of the rifle stock shown in FIG. 1;
 FIG. 4 is a magnified view thereof of area 4 circumscribed within FIG. 3;
 FIG. 5 is a top view of the rifle stock shown in FIG. 1;
 FIG. 6 is a bottom view thereof;
 FIG. 7 is a back view thereof;
 FIG. 8 is a front view thereof;
 FIG. 9 is a left side view of a second embodiment of our design for a rifle stock having gripping grooves;
 FIG. 10 is a magnified view thereof of area 10 circumscribed within FIG. 9;
 FIG. 11 is a right side view of the rifle stock shown in FIG. 9;
 FIG. 12 is a magnified view thereof of area 12 circumscribed within FIG. 11;
 FIG. 13 is a top view of the rifle stock shown in FIG. 9;
 FIG. 14 is a bottom view thereof;
 FIG. 15 is a back view thereof; and,
 FIG. 16 is a front view thereof.

The broken lines illustrate portions of the rifle stock that form no part of the claimed design. The dot-dash-dot broken lines depict the boundaries of the magnified views and form no part of the claimed design.

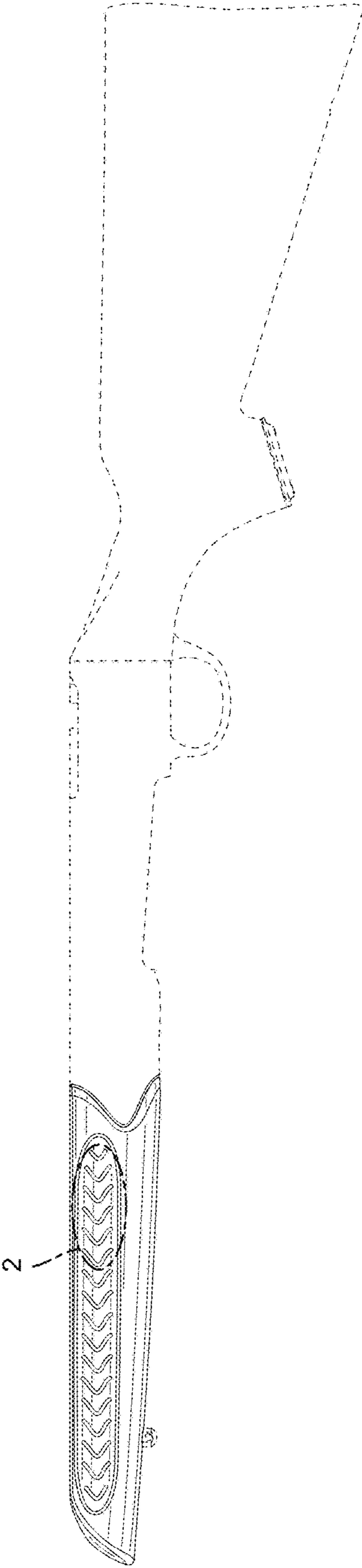

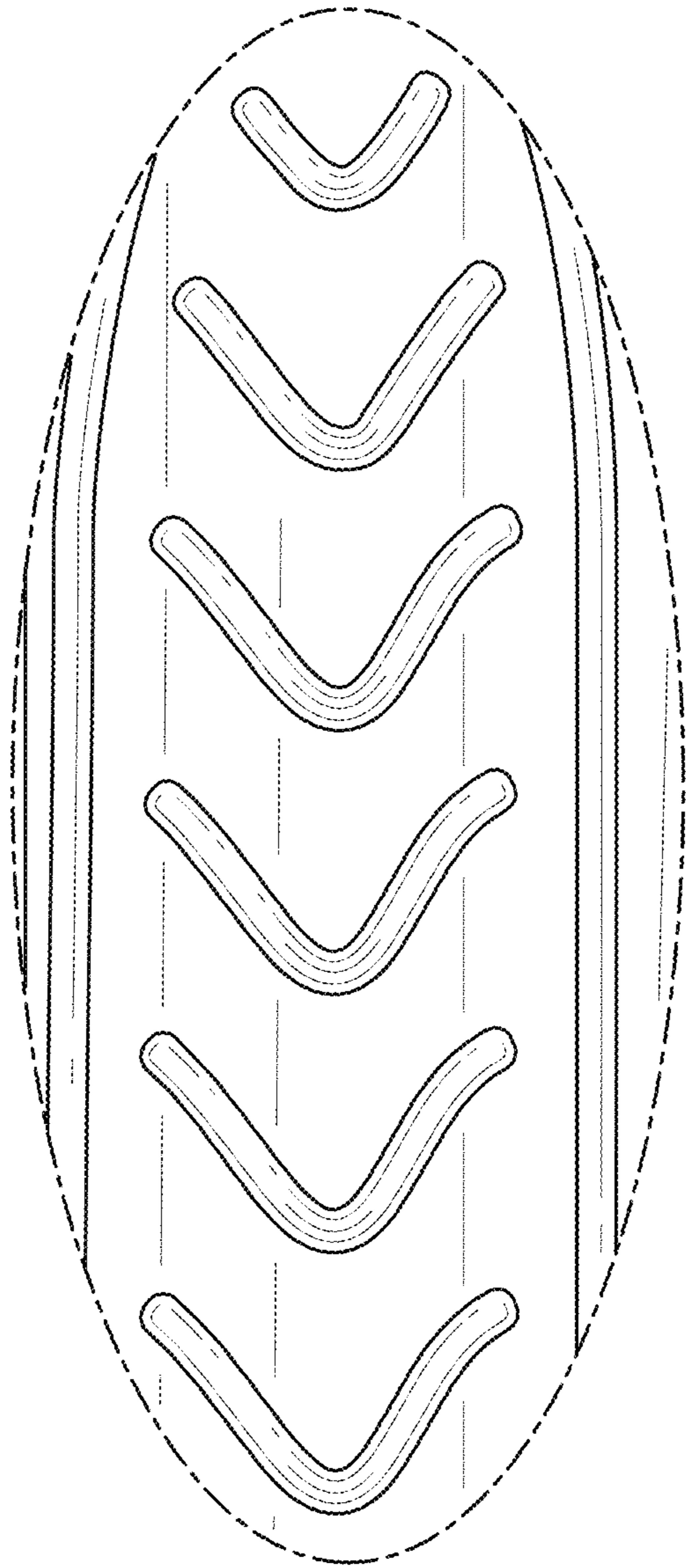

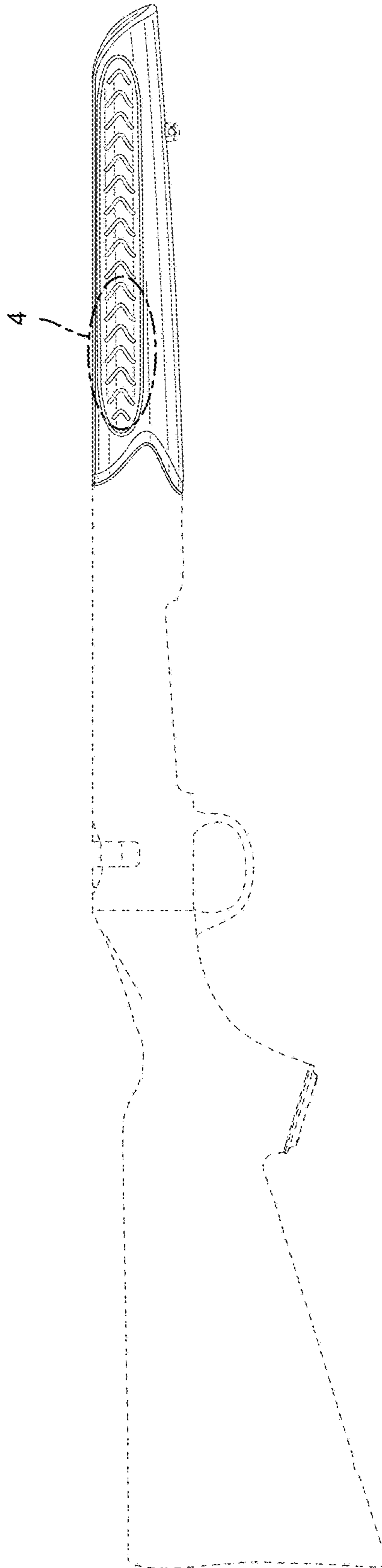

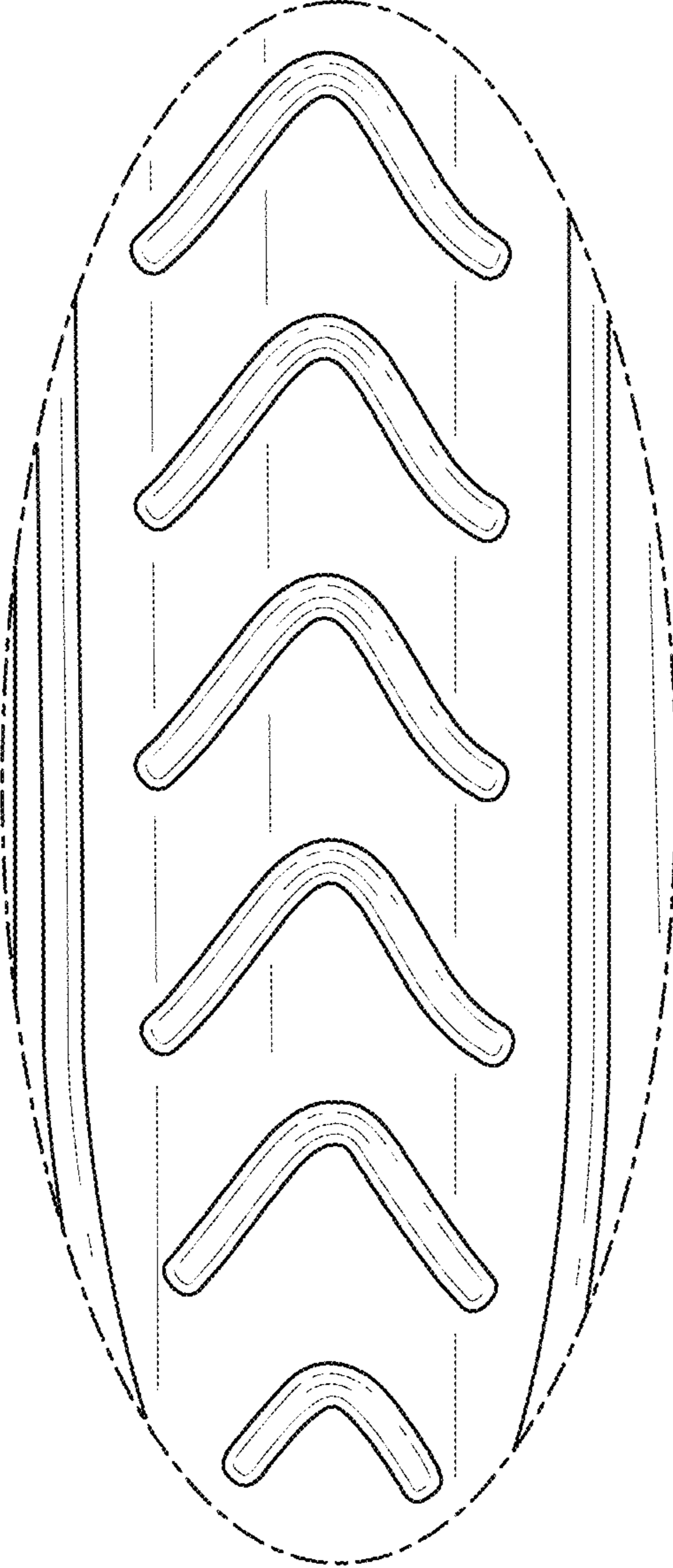

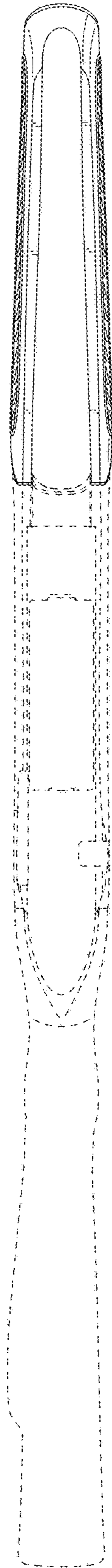

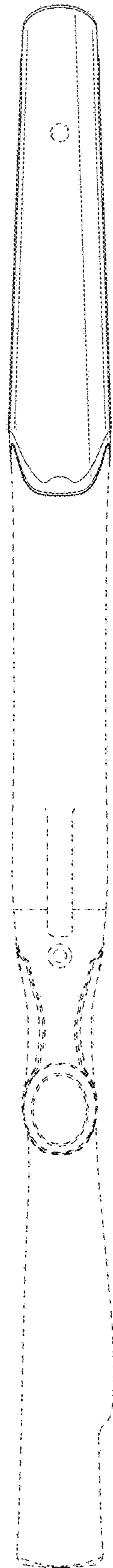

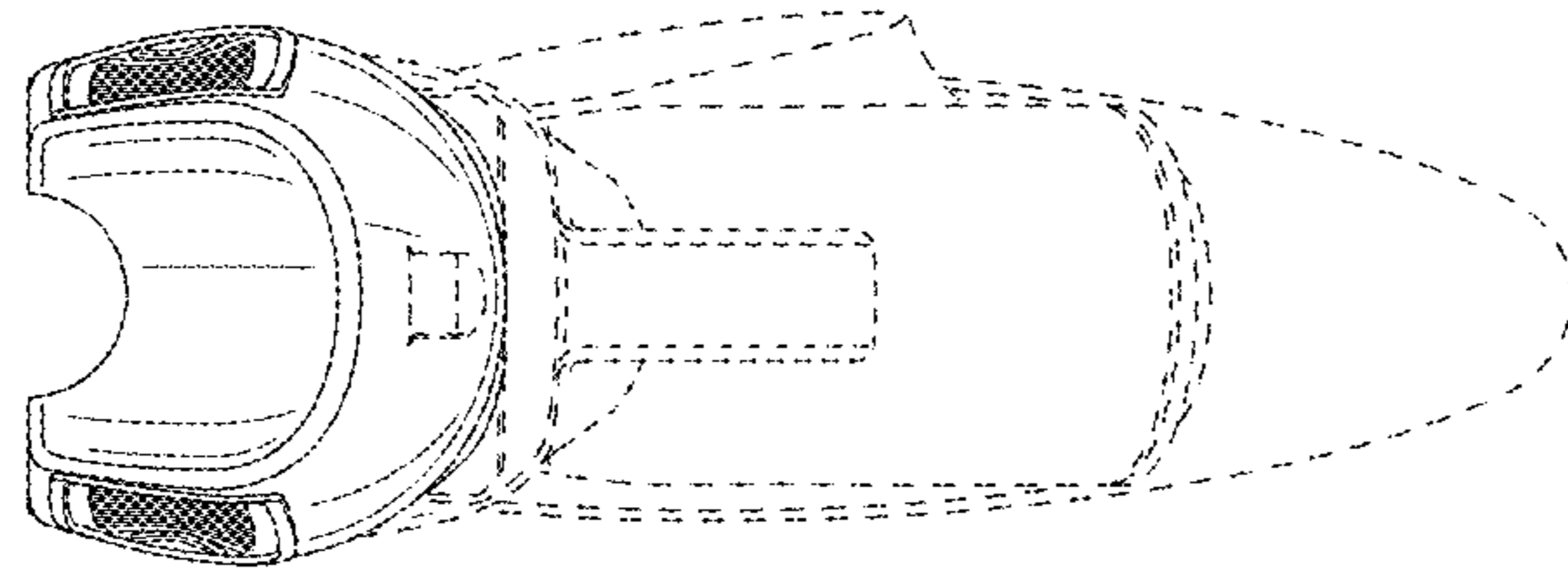

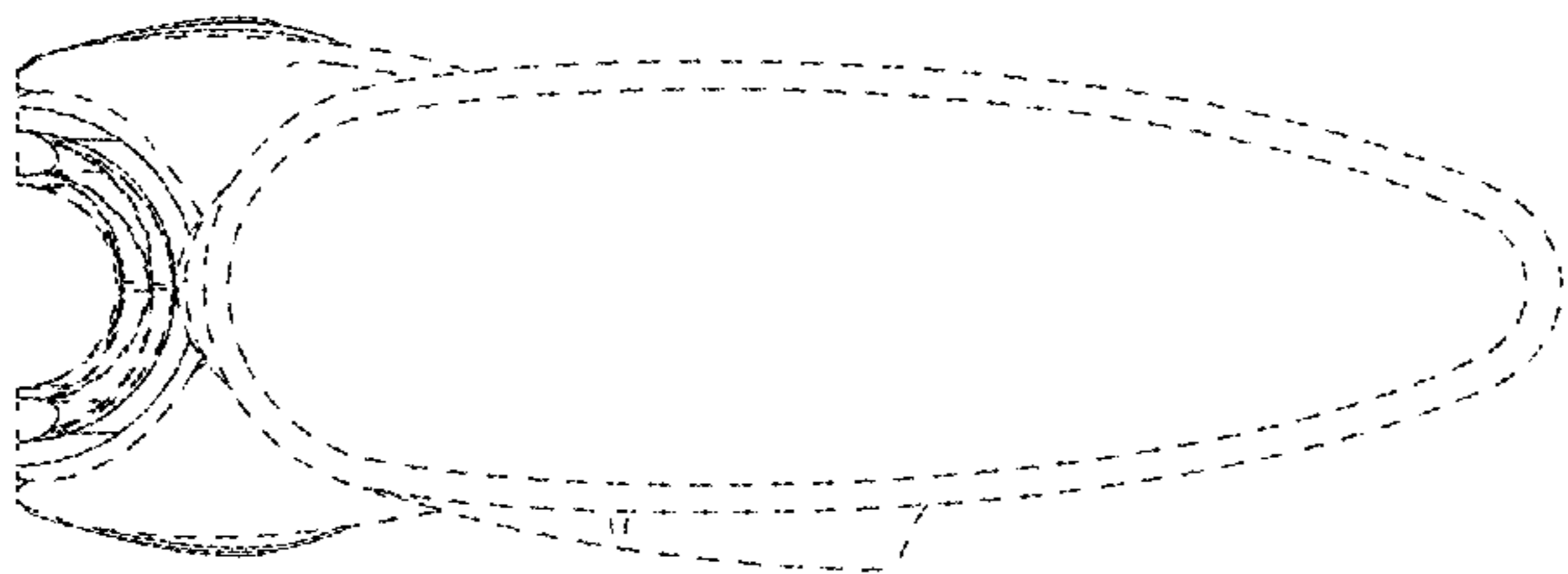

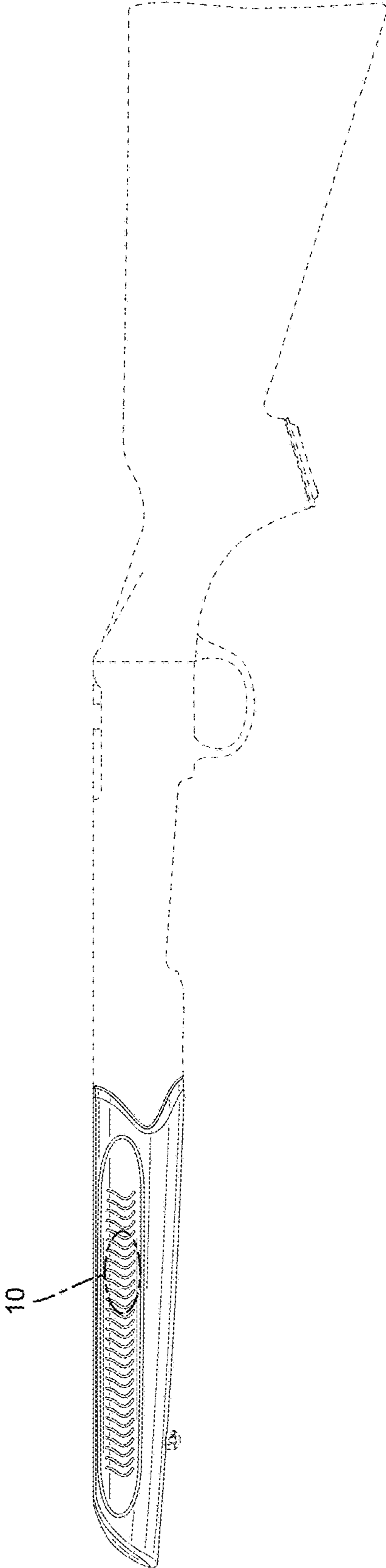

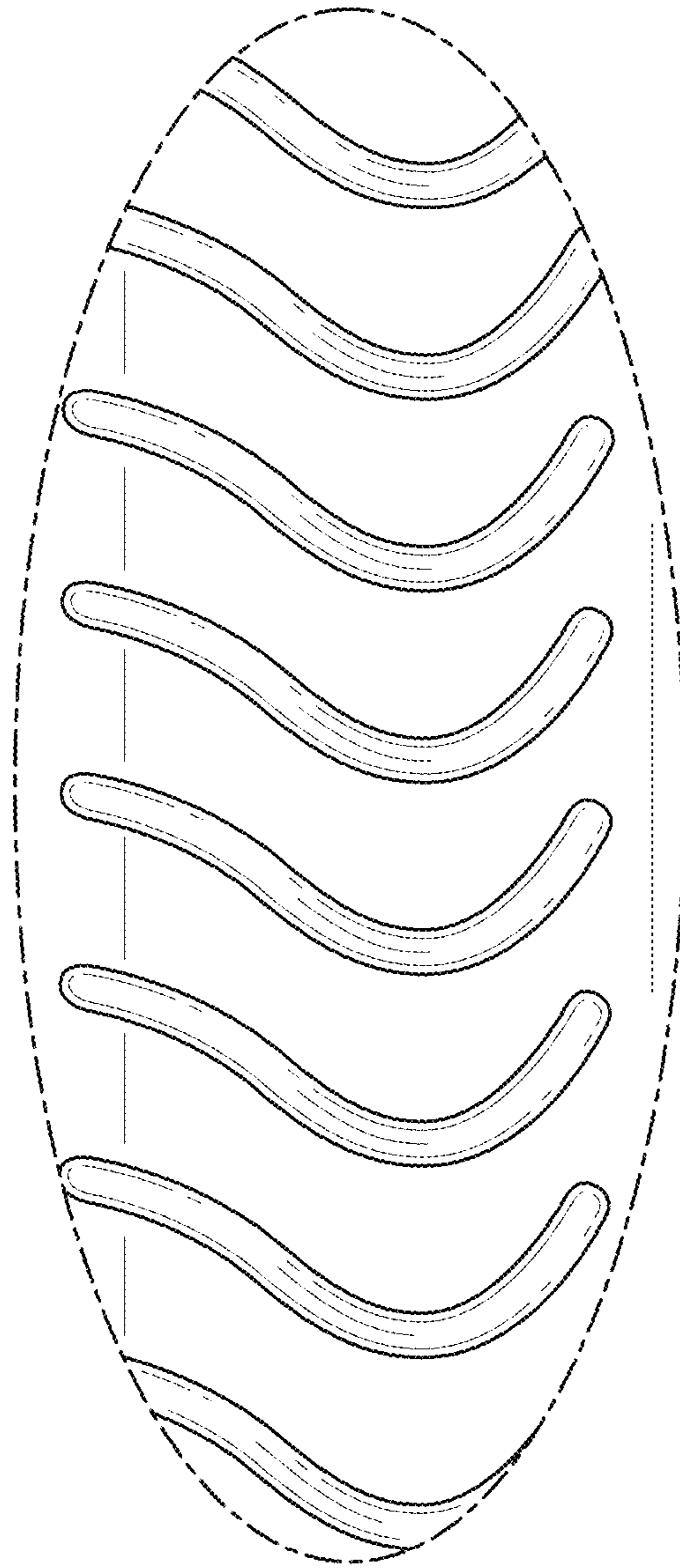

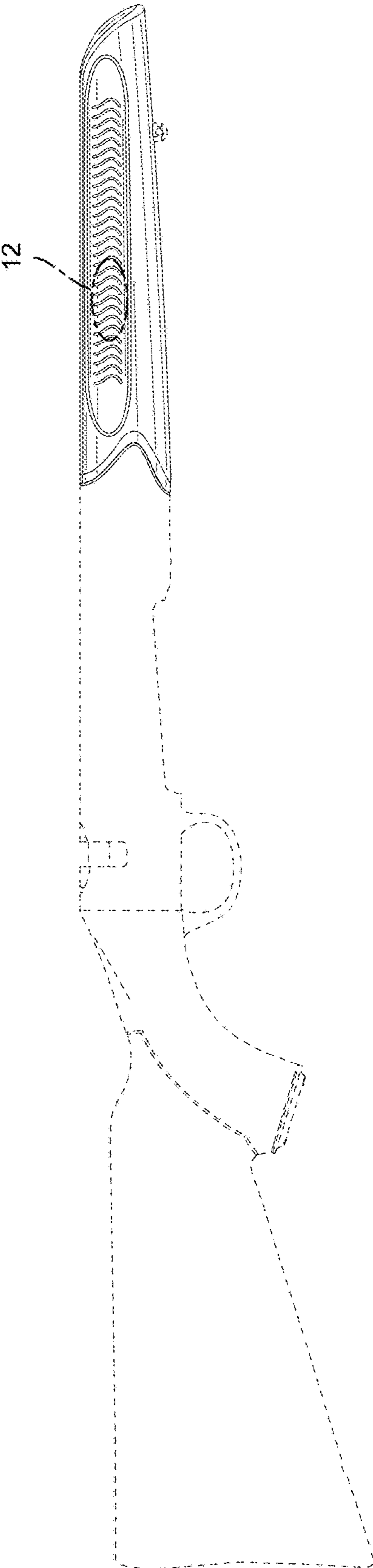

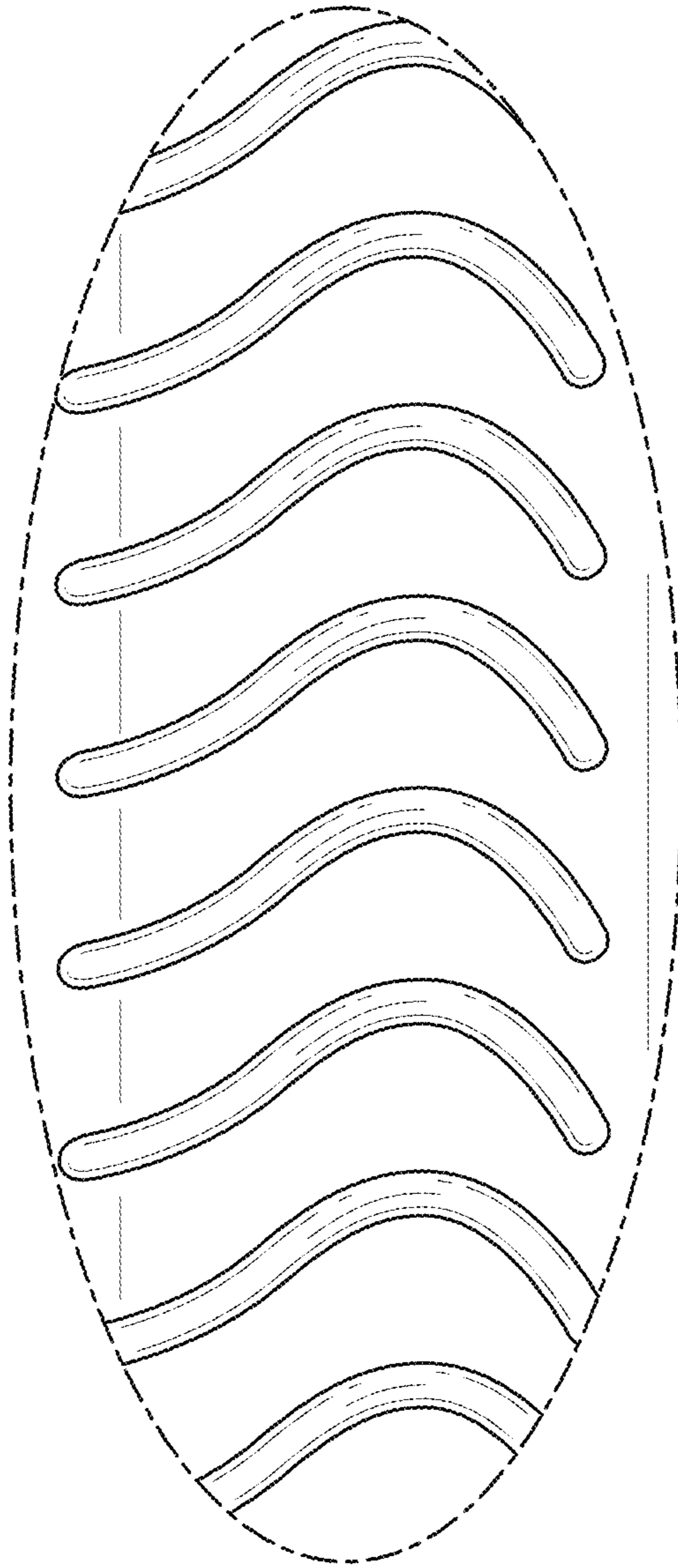

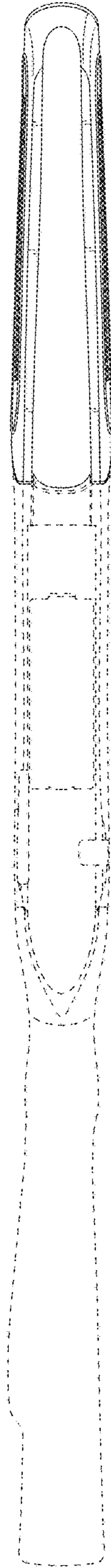

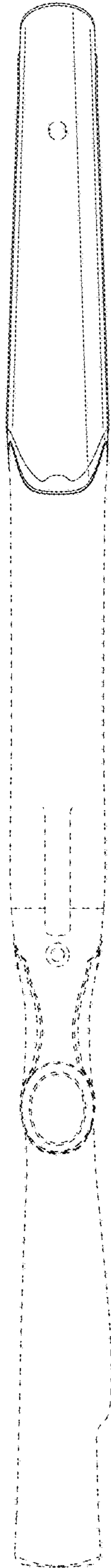

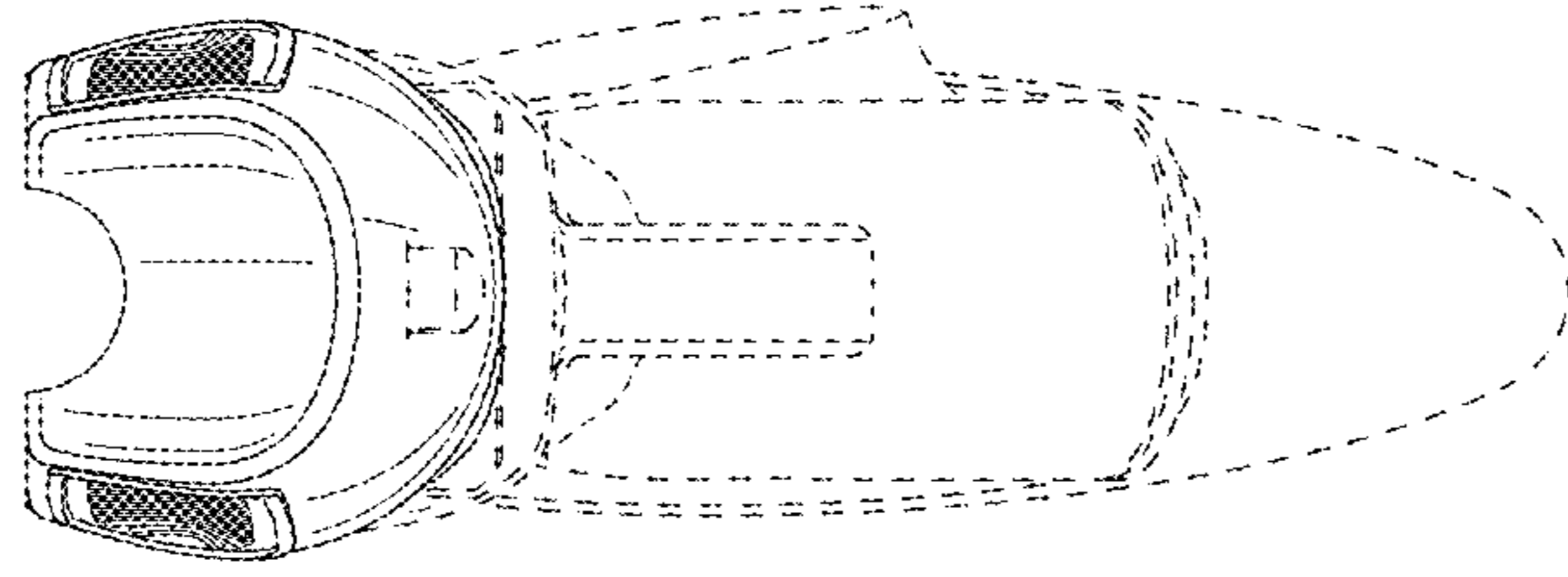

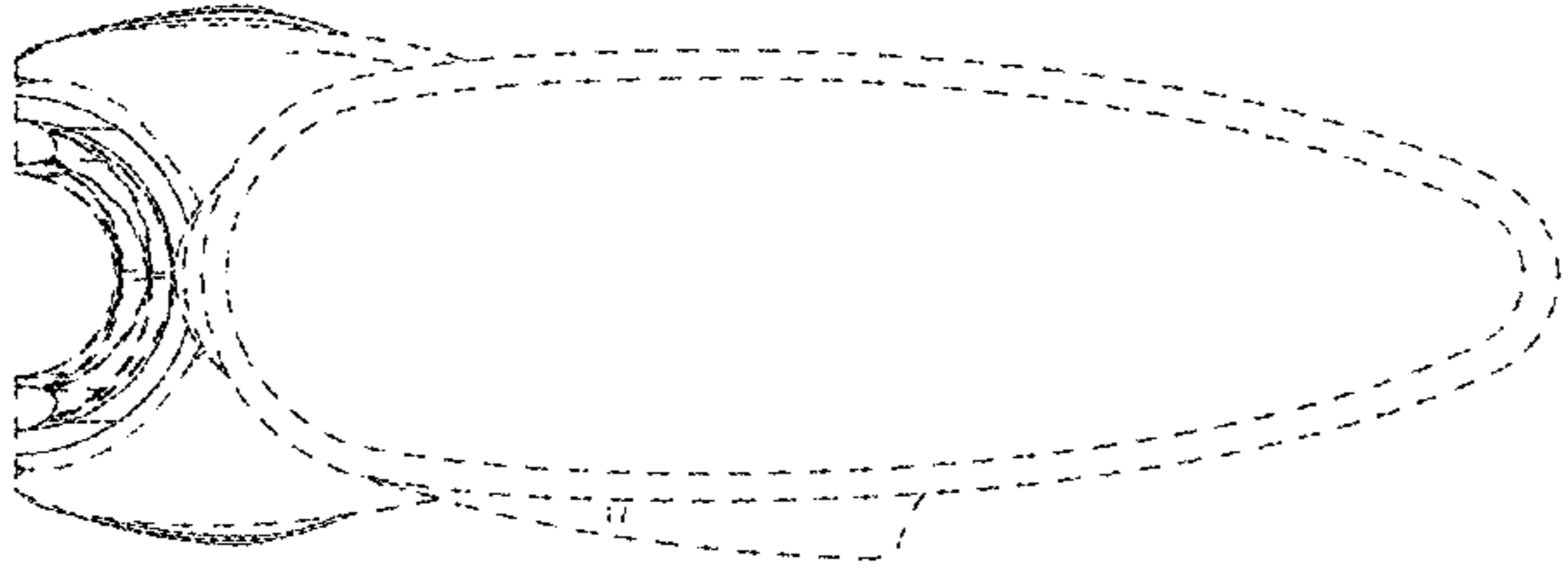
