DESCRIPTION

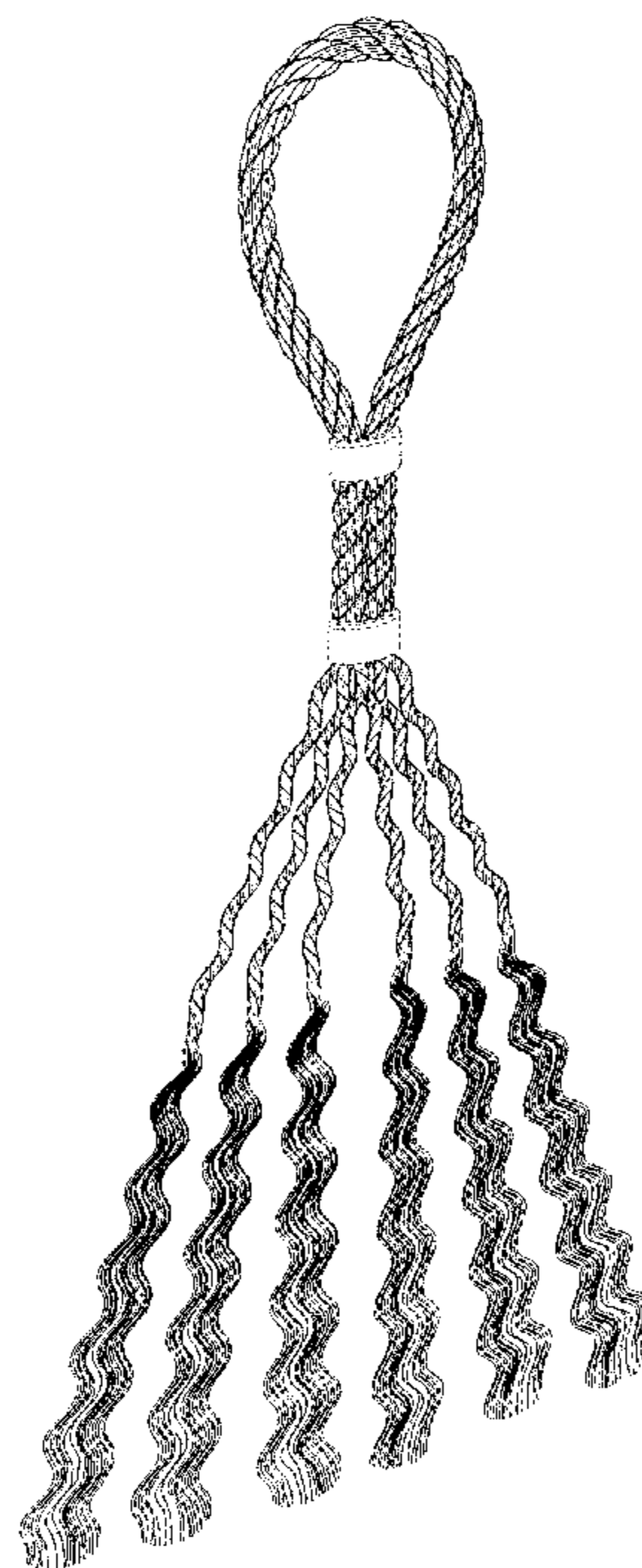
FIG. 1 is a perspective view of a fly swatter of the present invention;

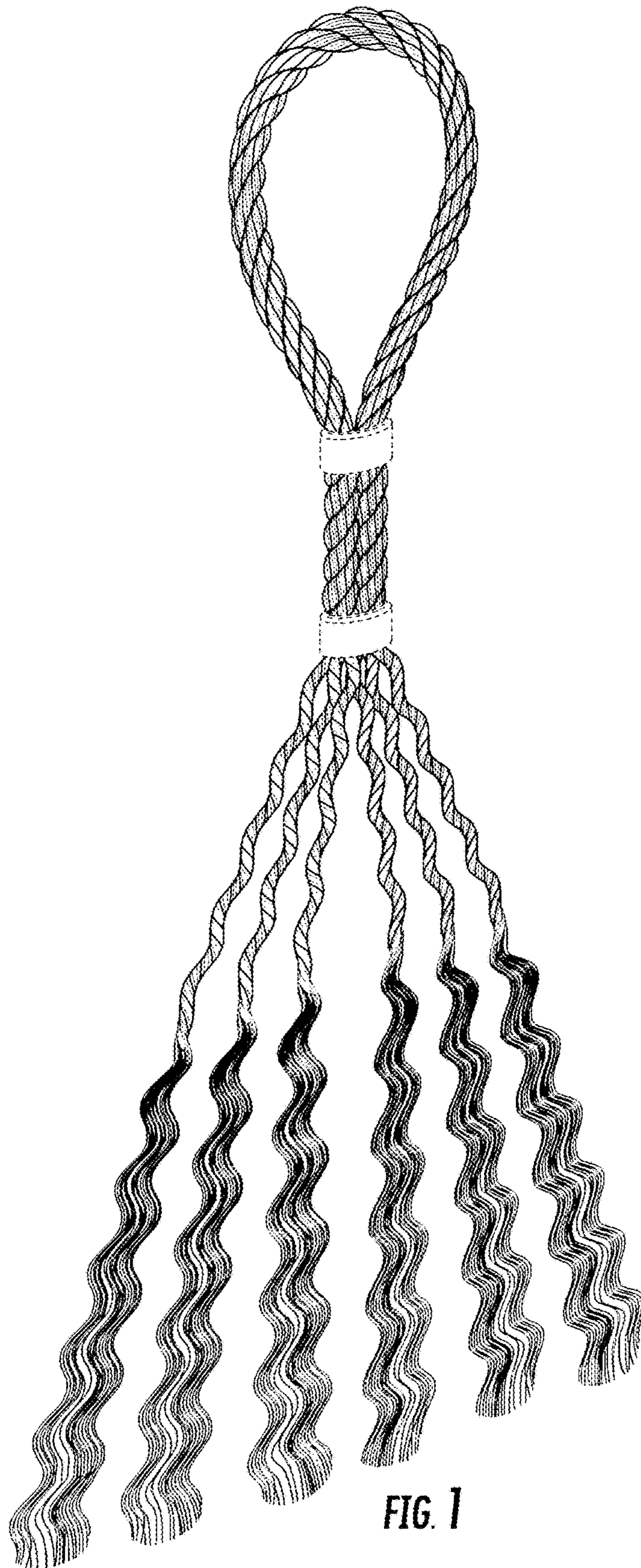

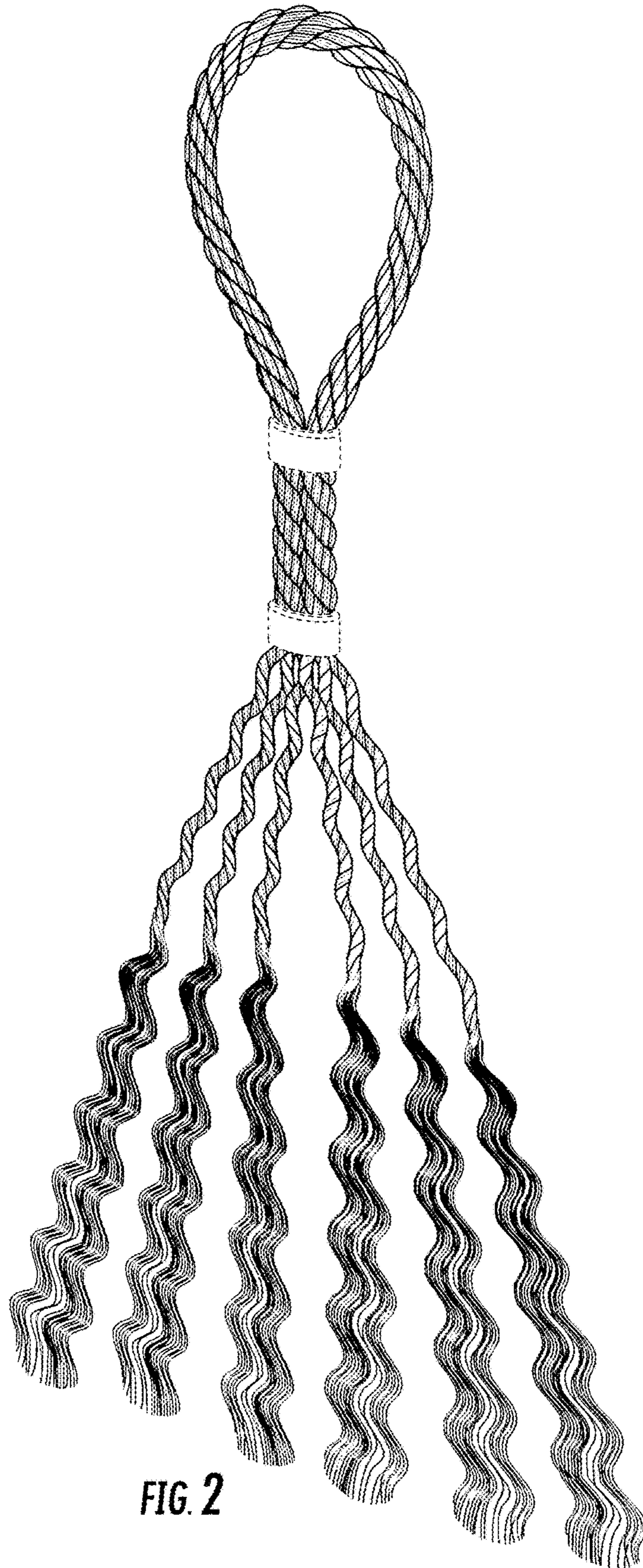

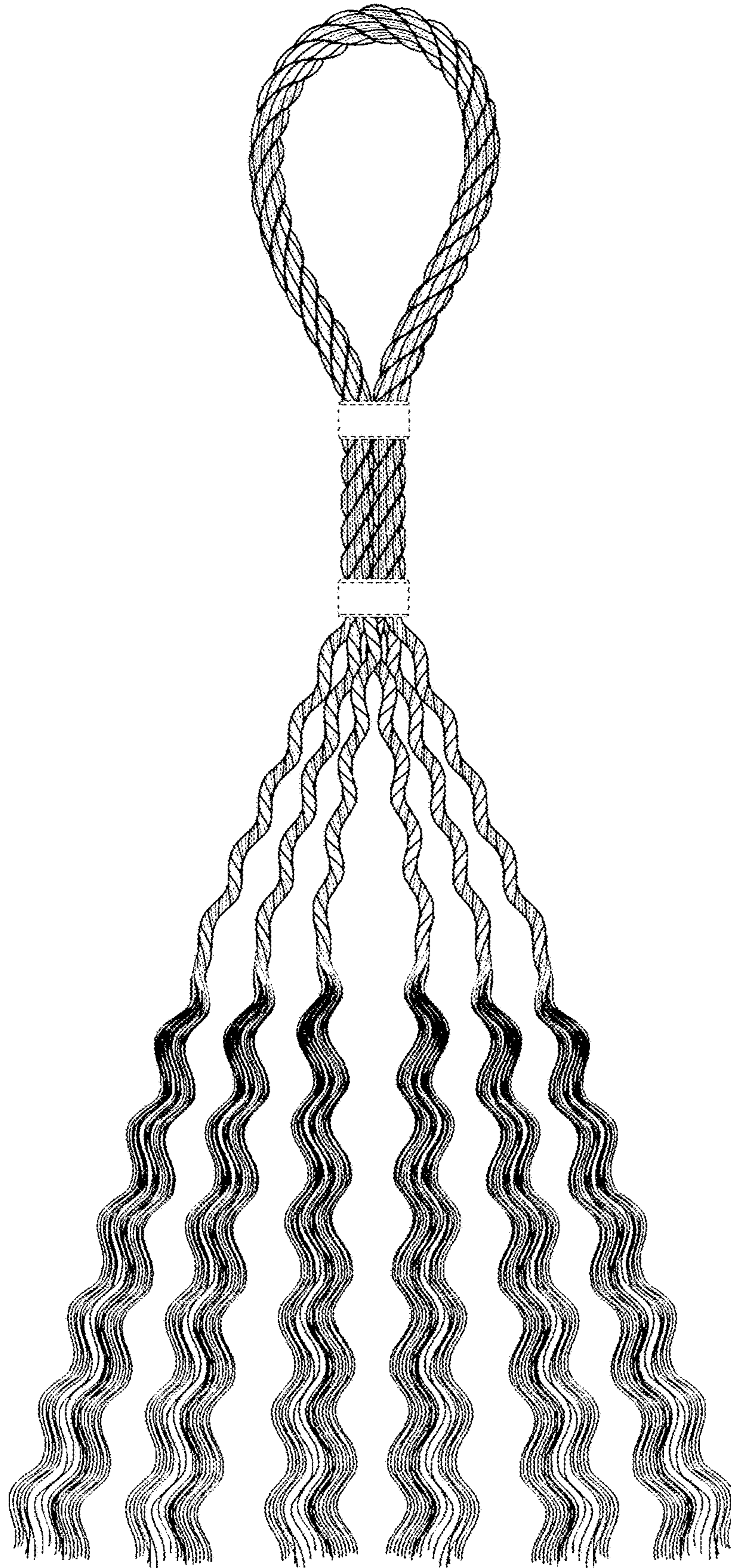

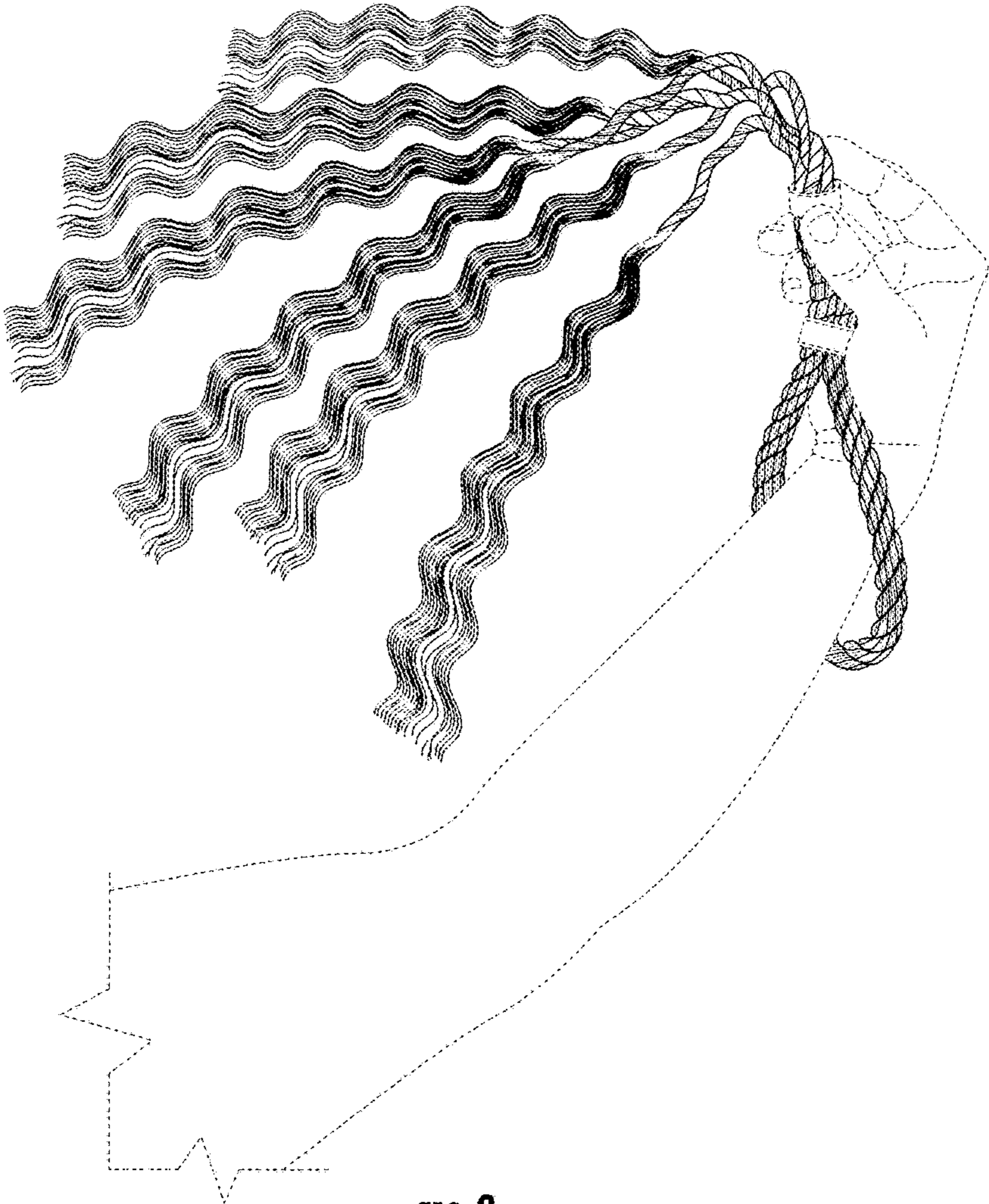
