DESCRIPTION

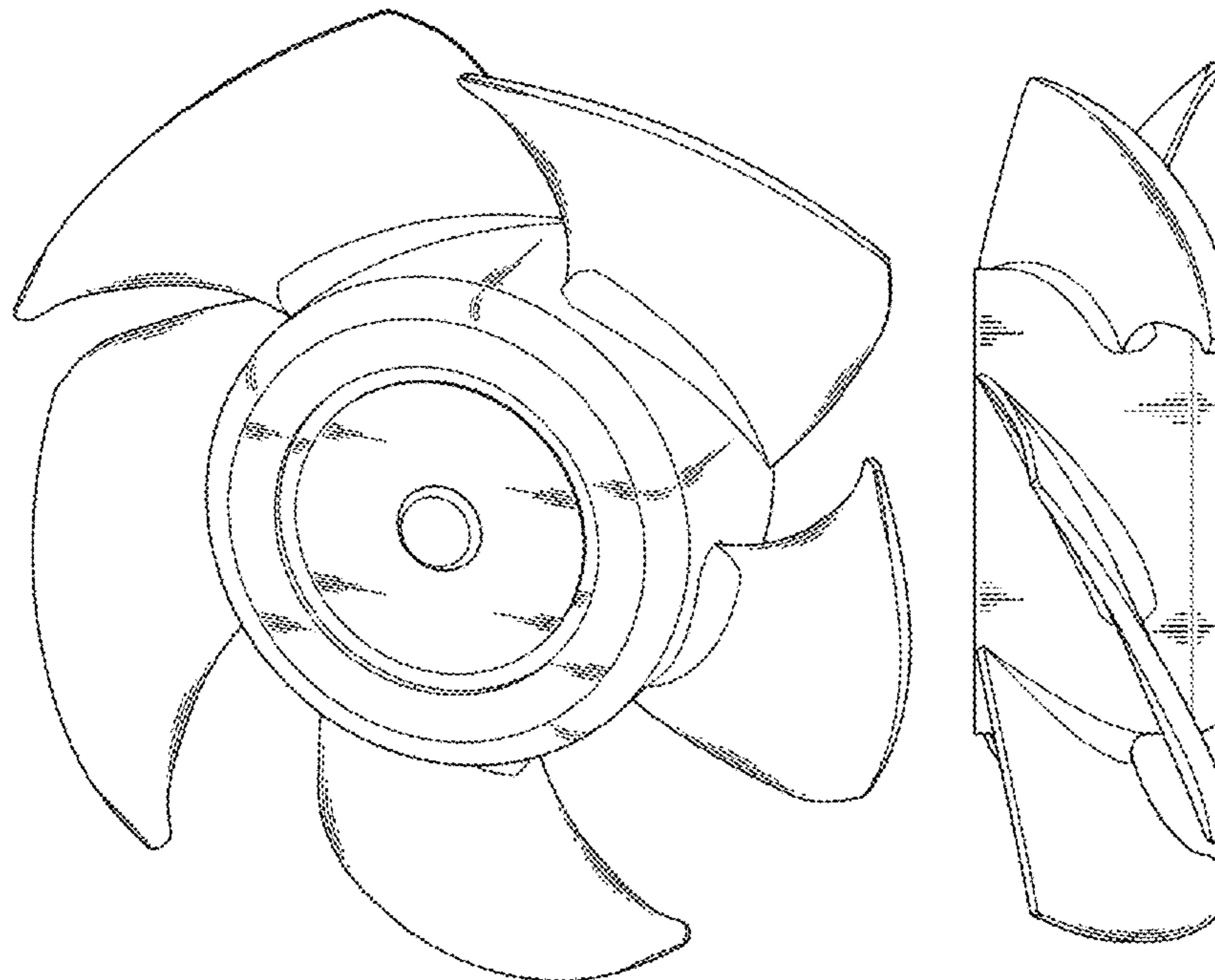
FIG. 1 is a top perspective view of the fan showing my new design;

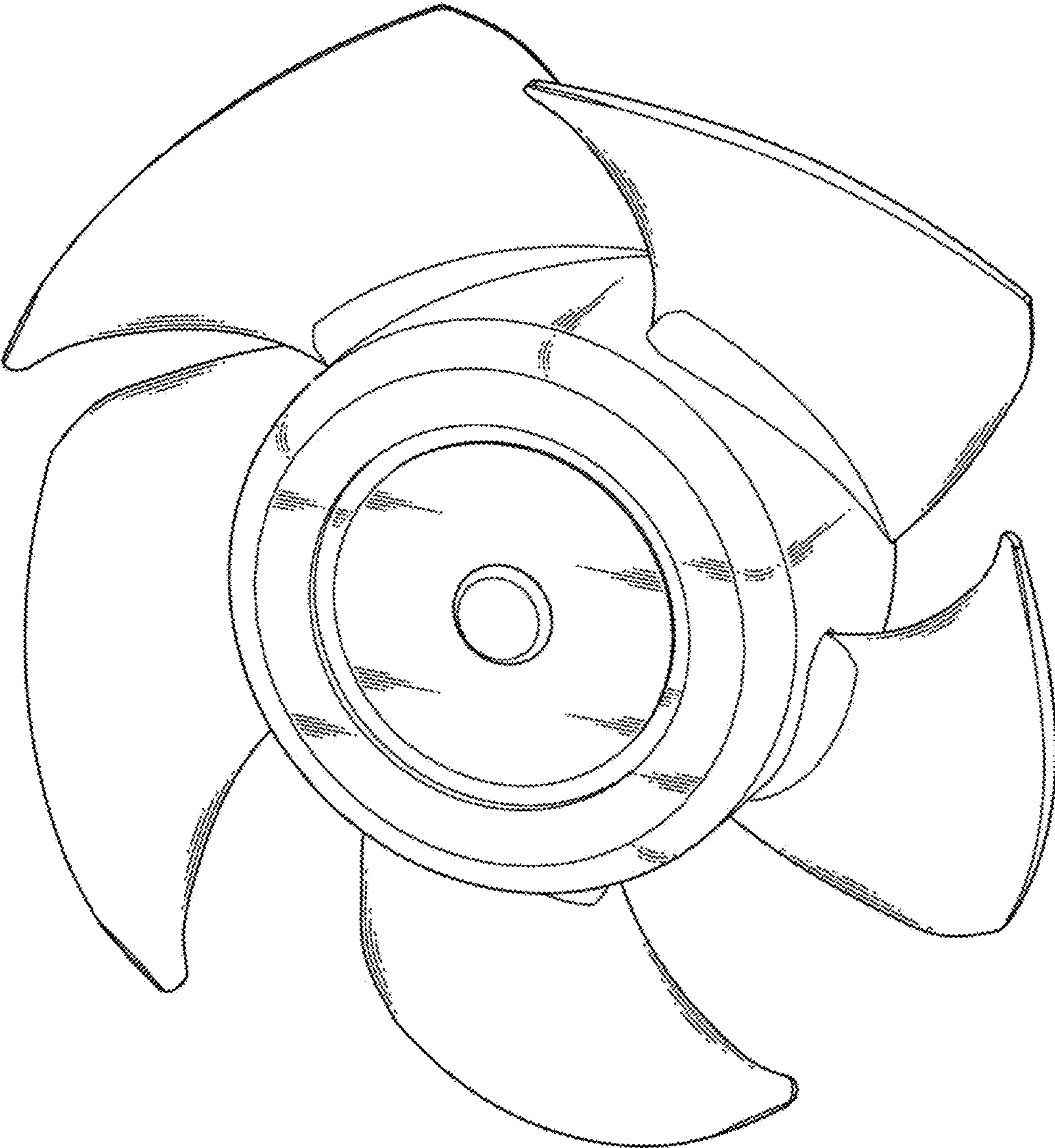

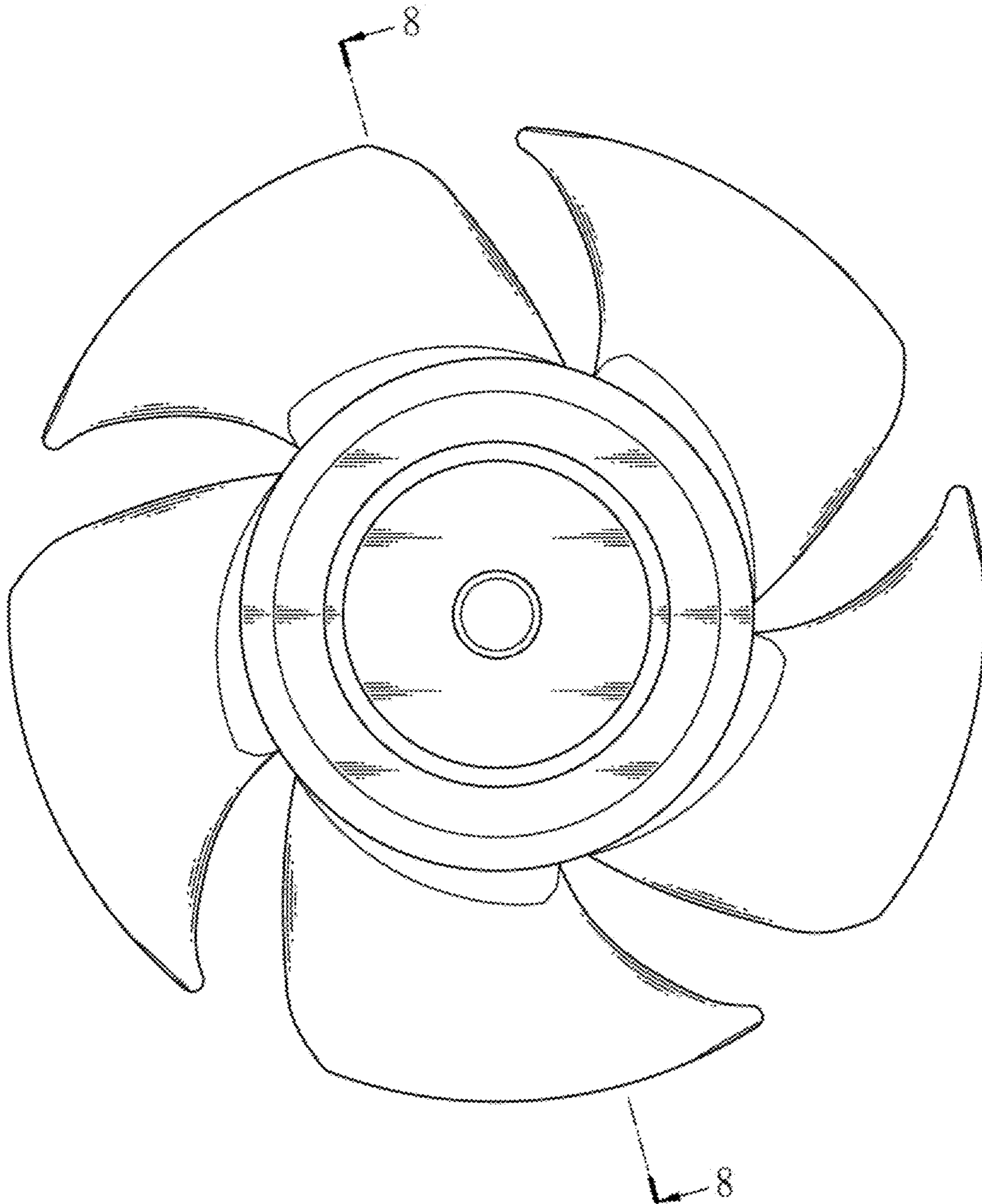

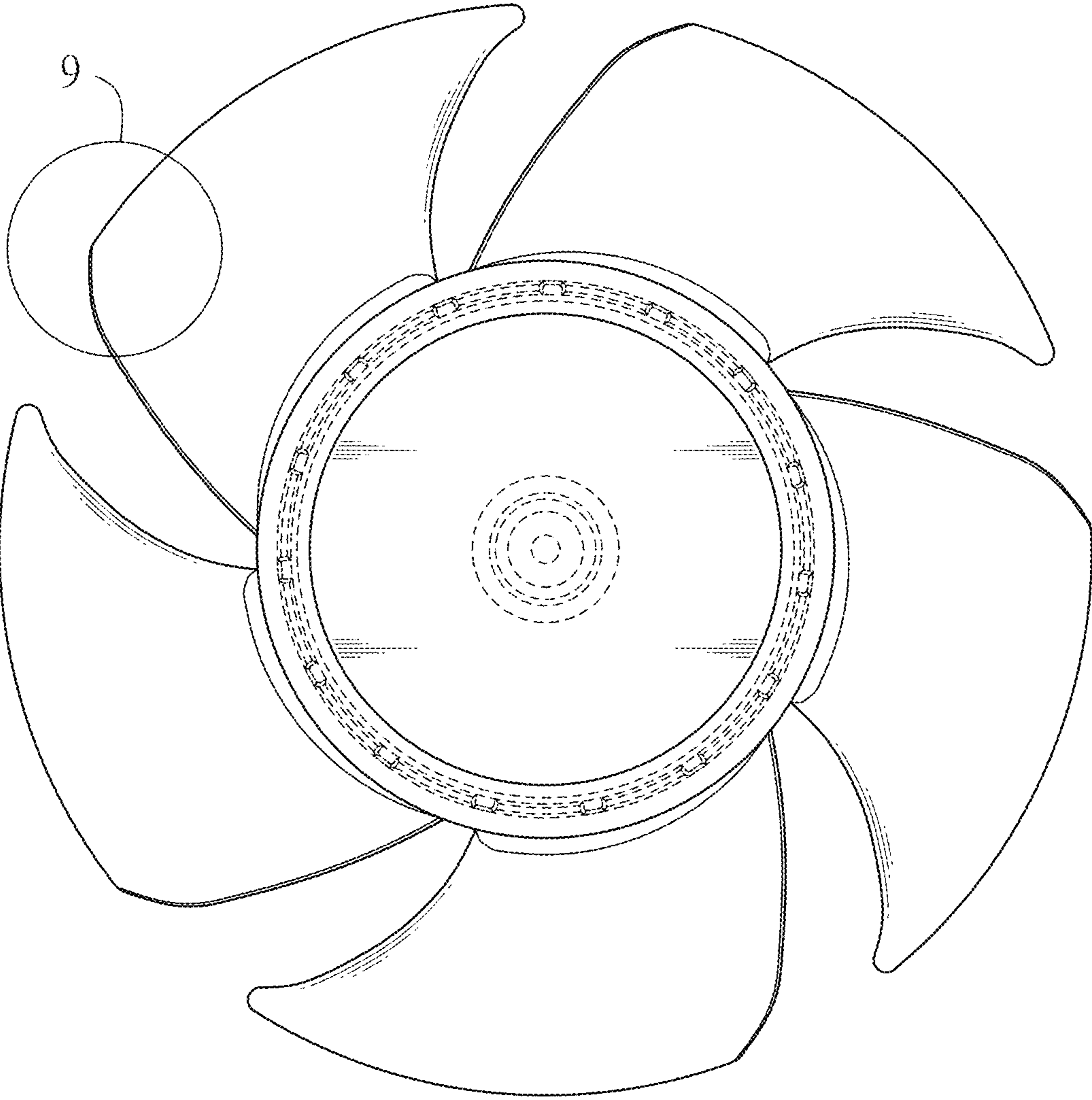

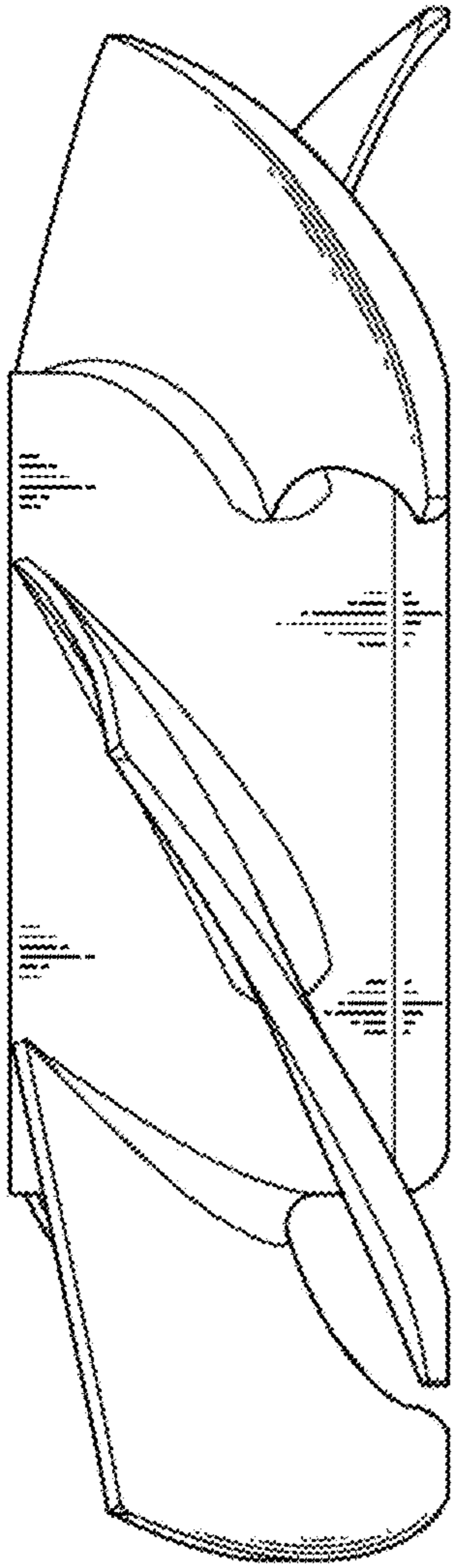

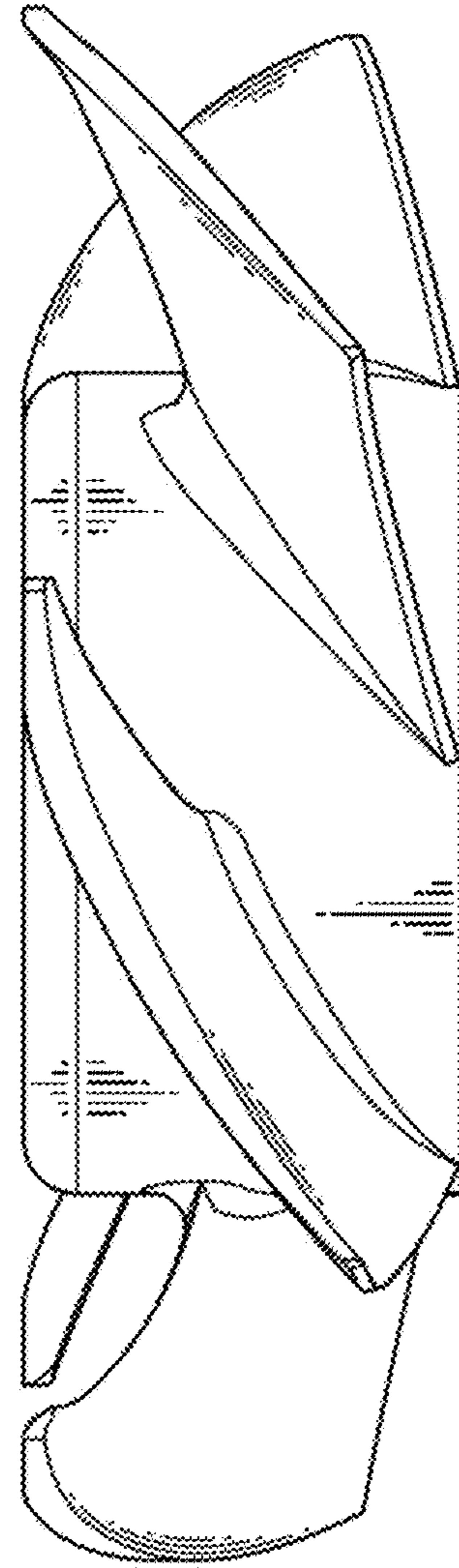

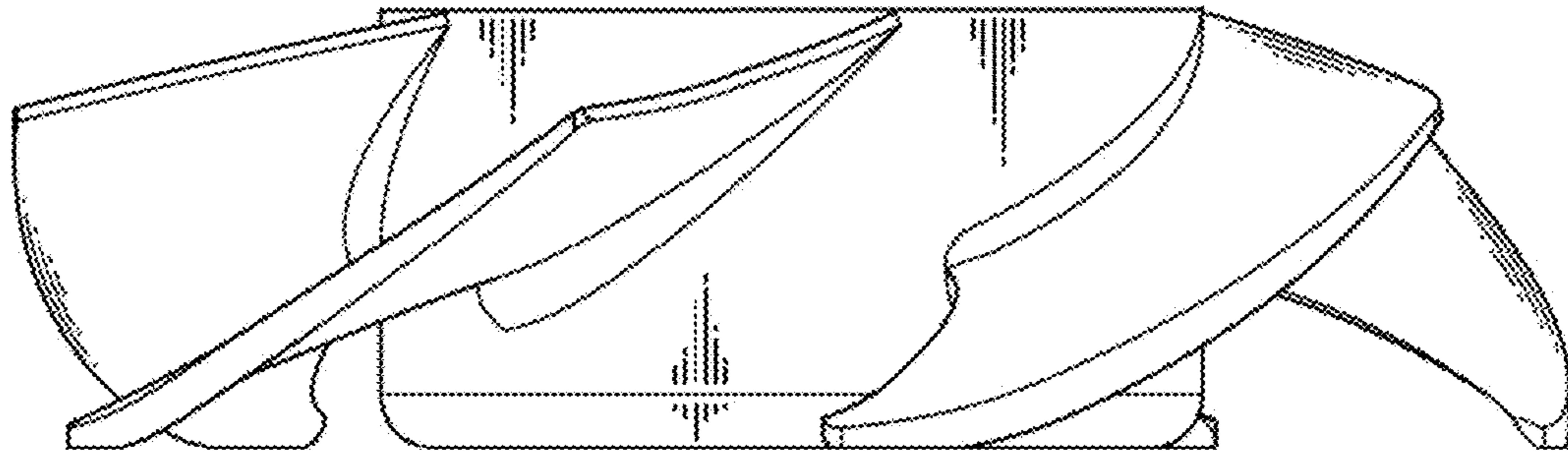

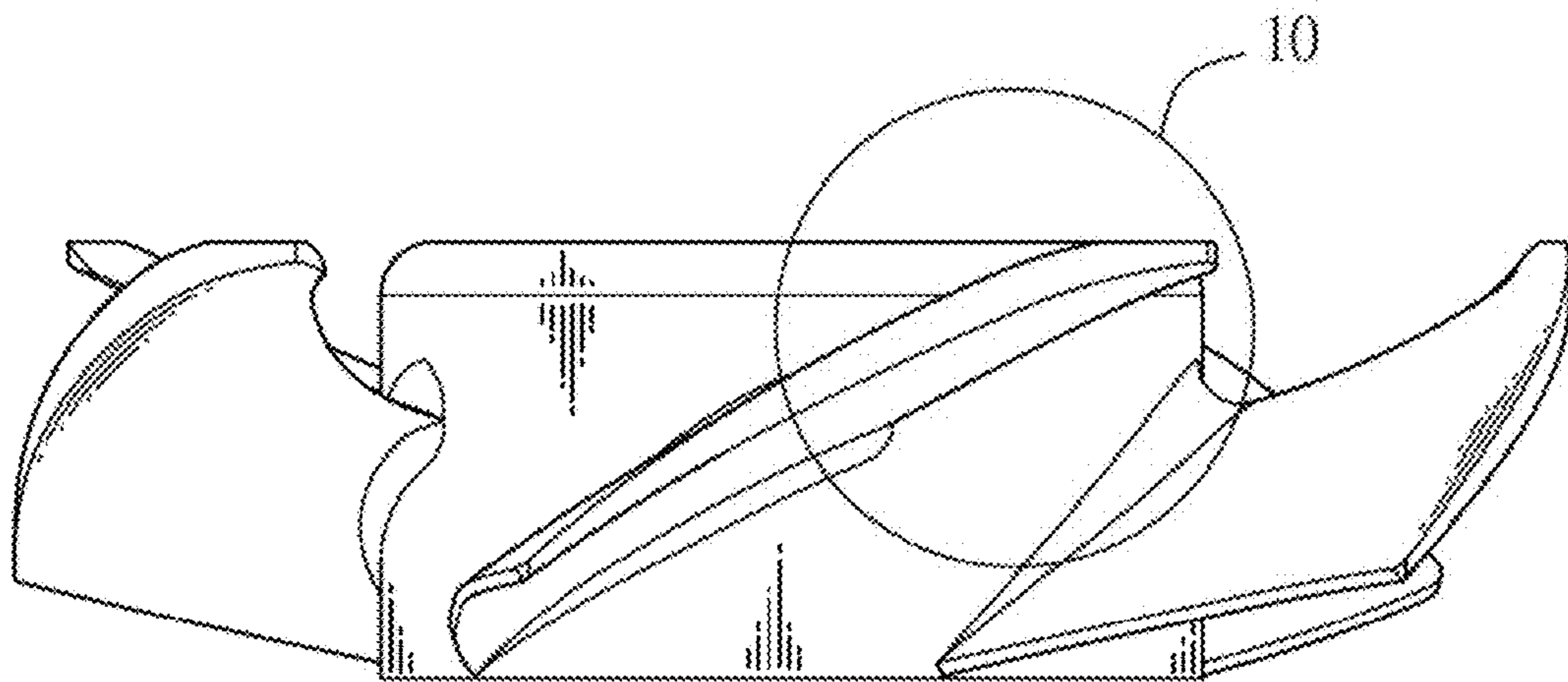

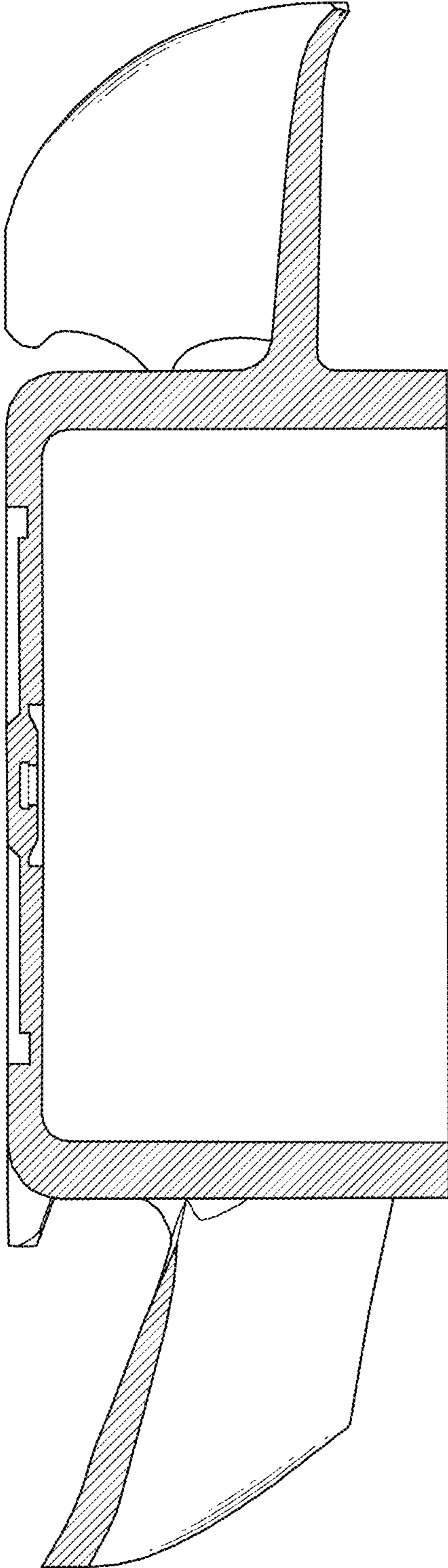

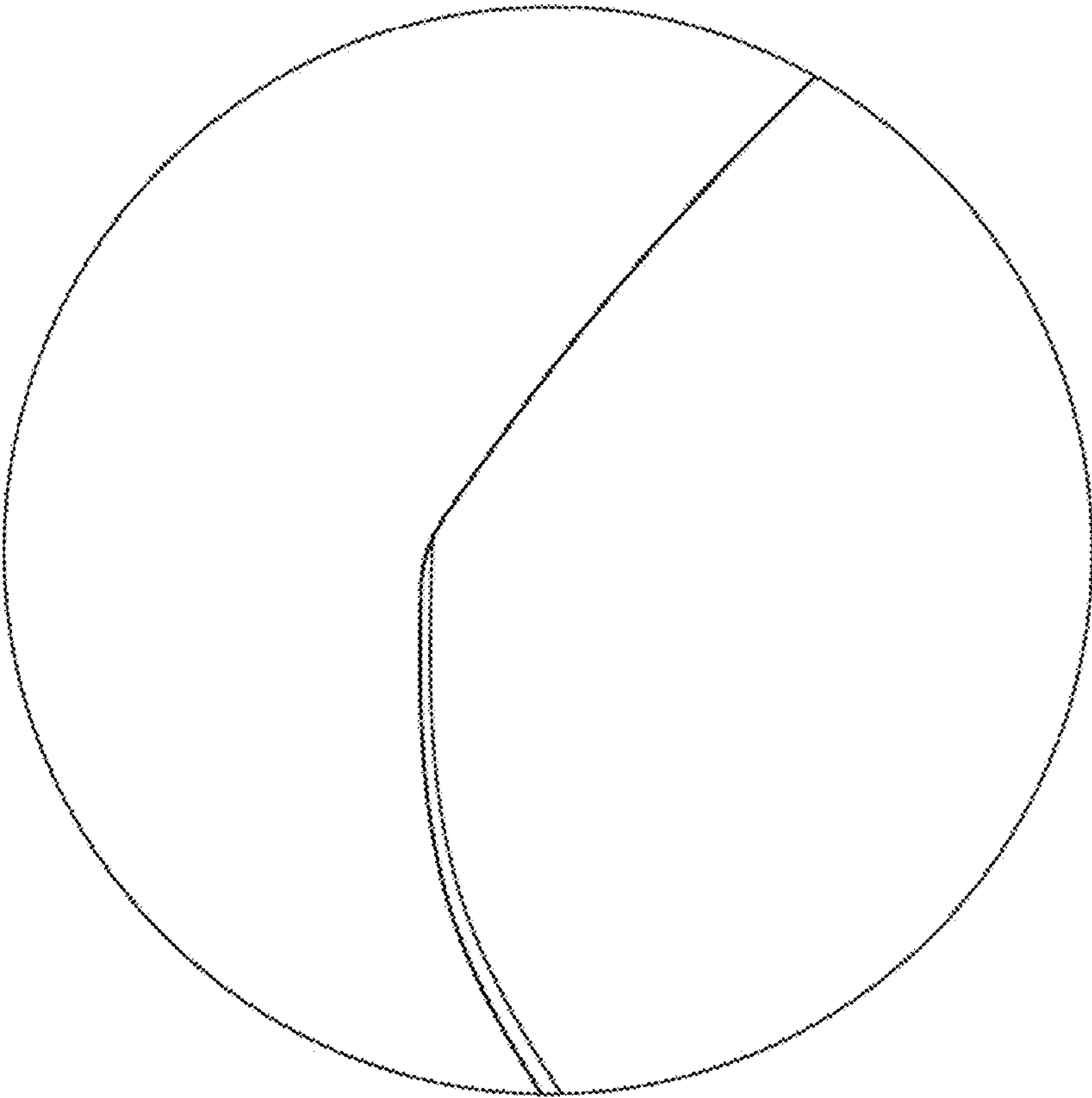

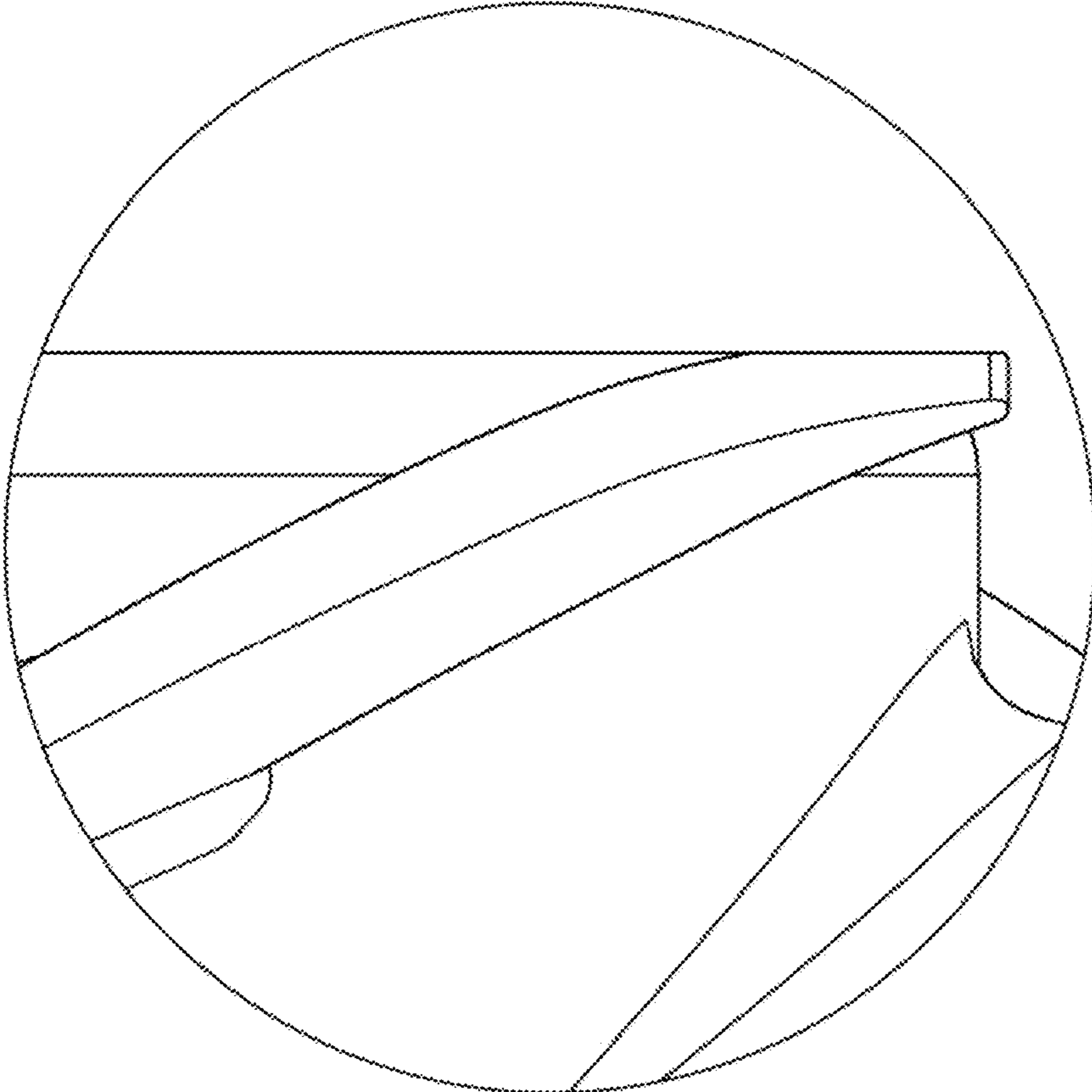
