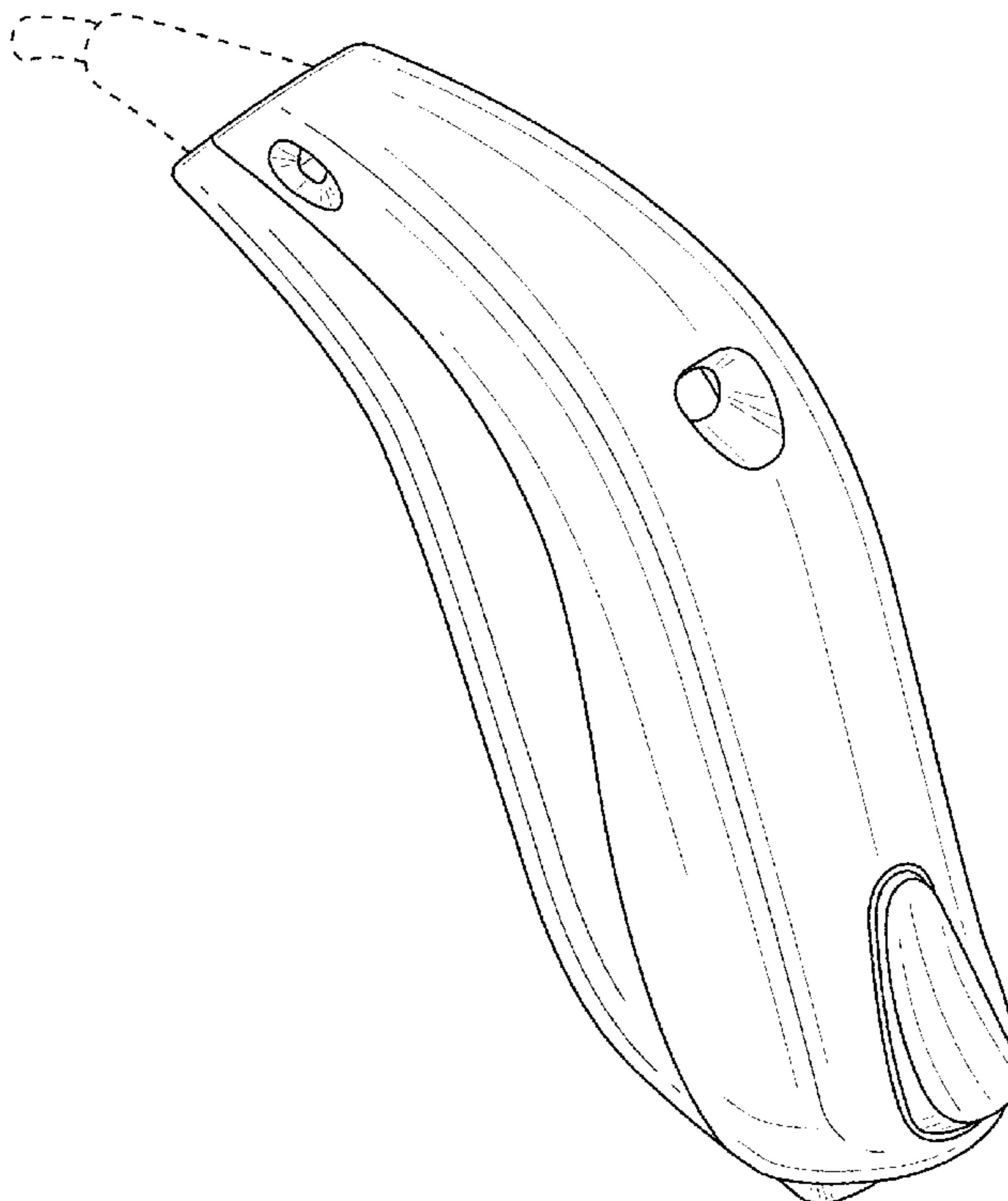

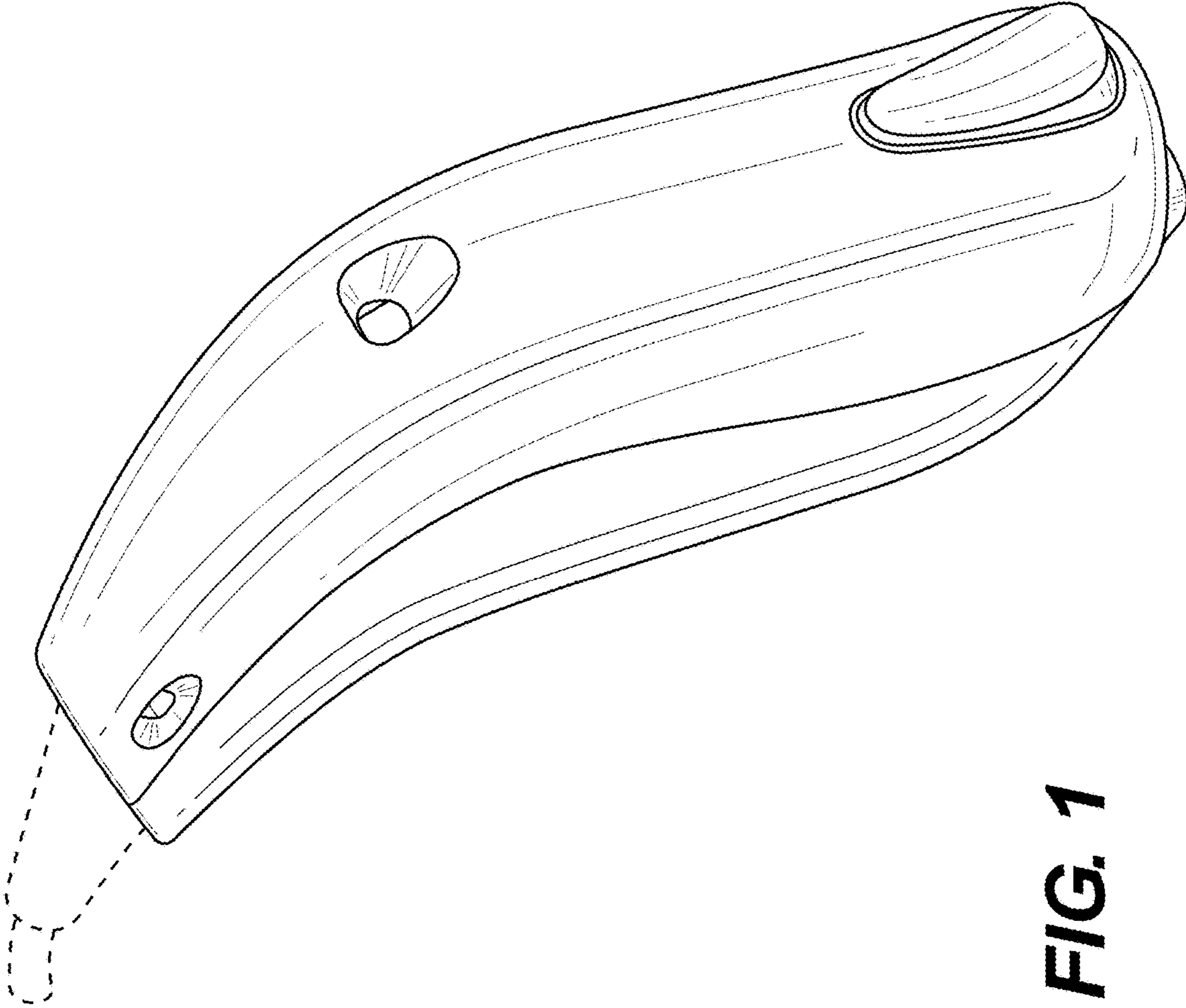
The ornamental design for a hearing aid, as shown and described.

**DESCRIPTION**

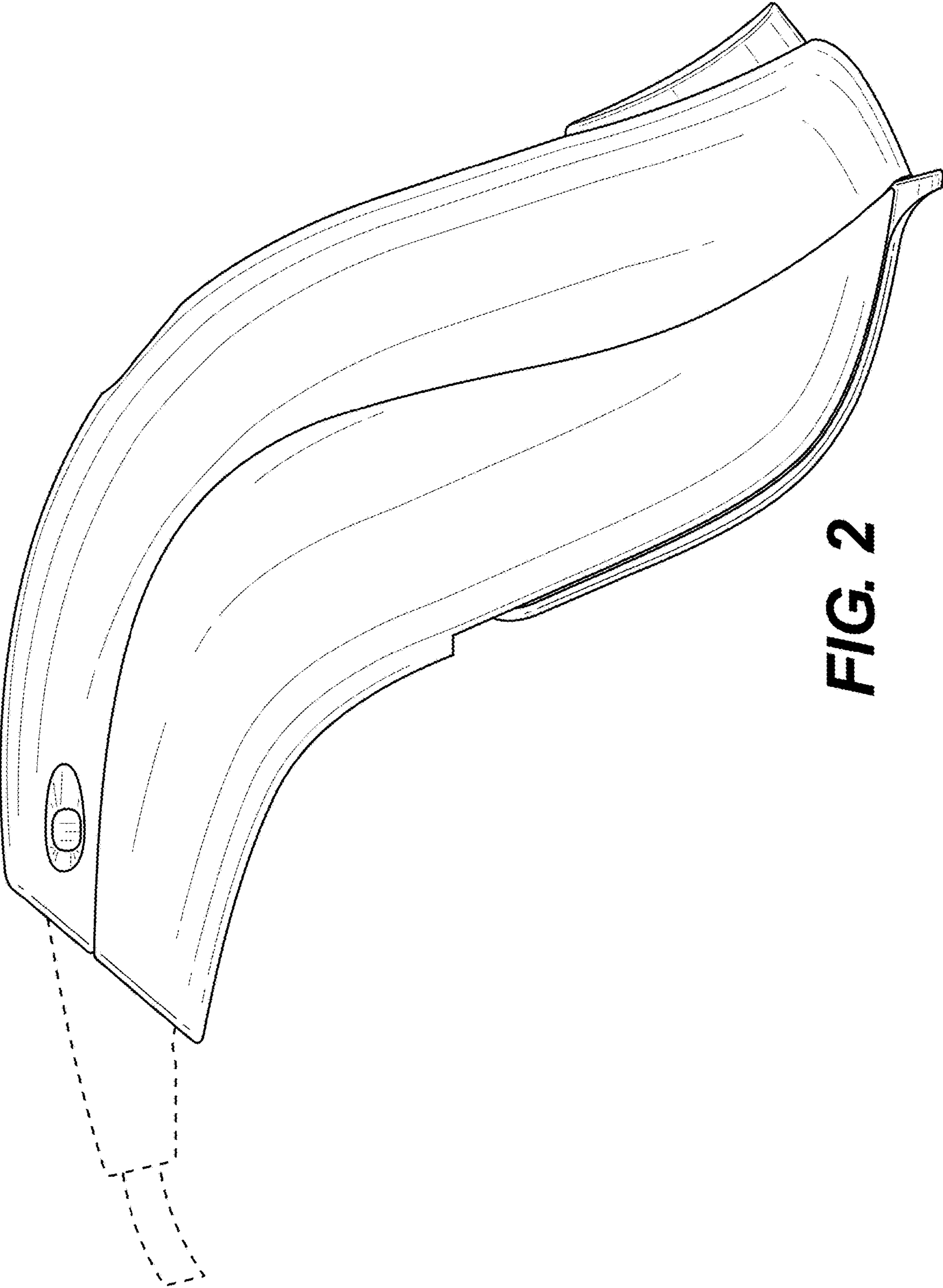
FIG. 1 is a perspective view of the hearing aid;

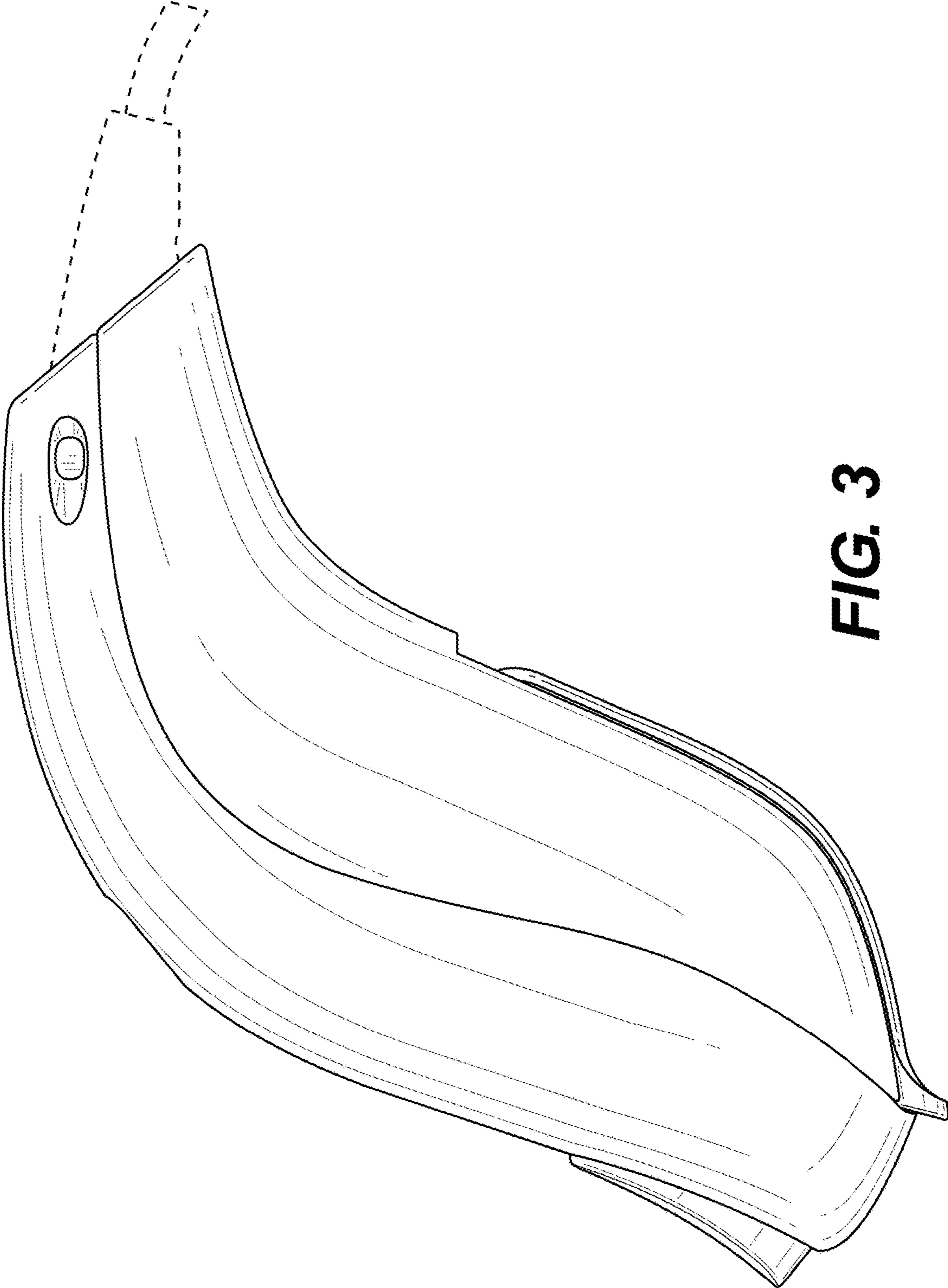




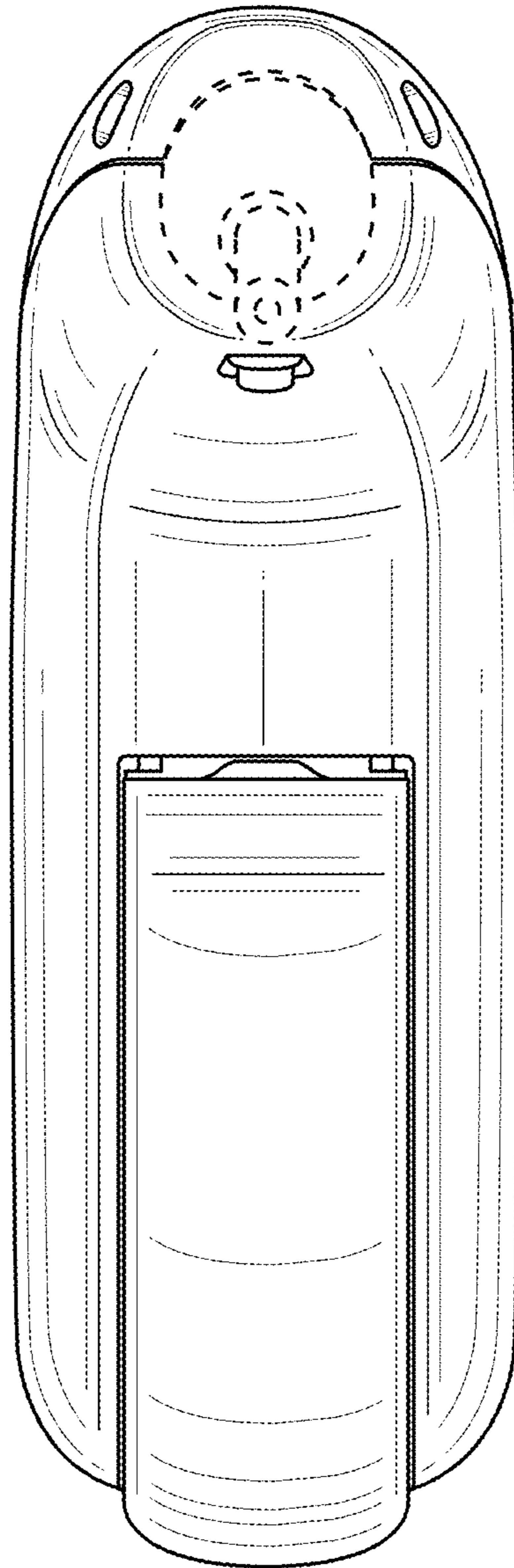

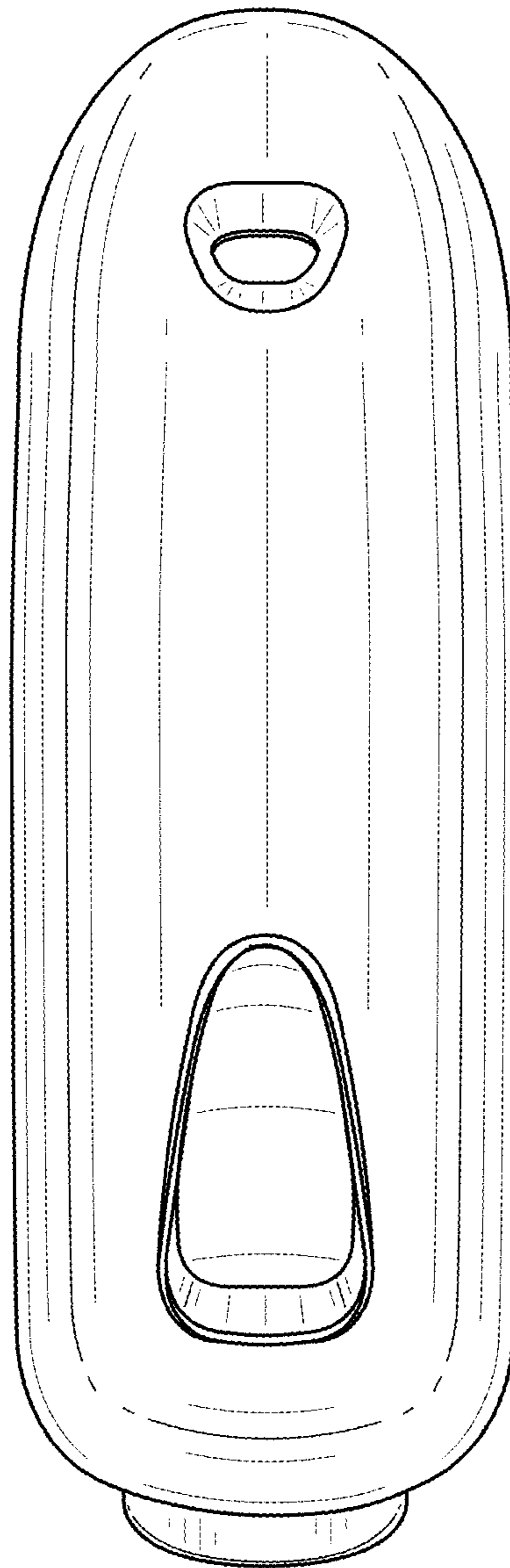

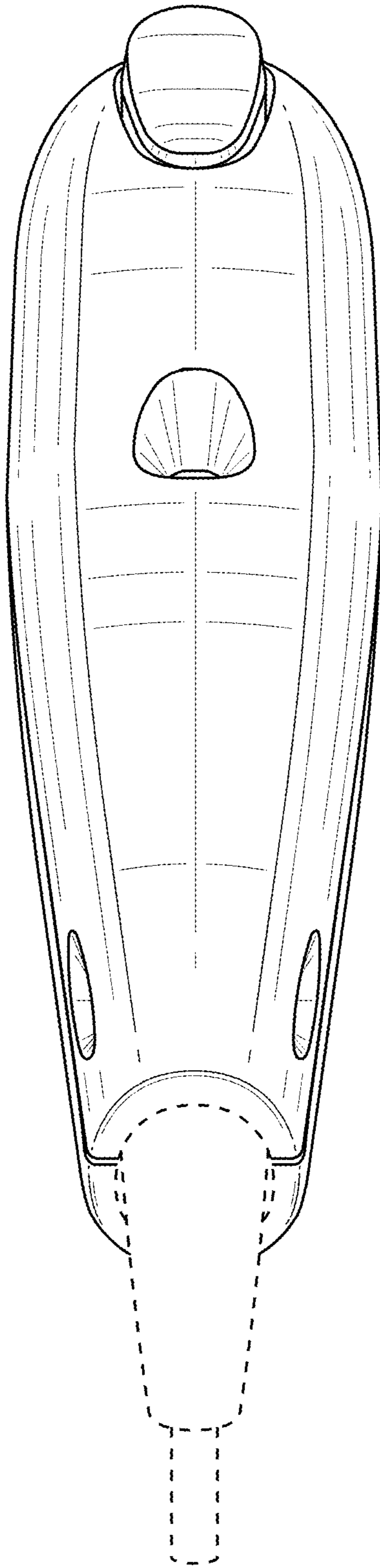

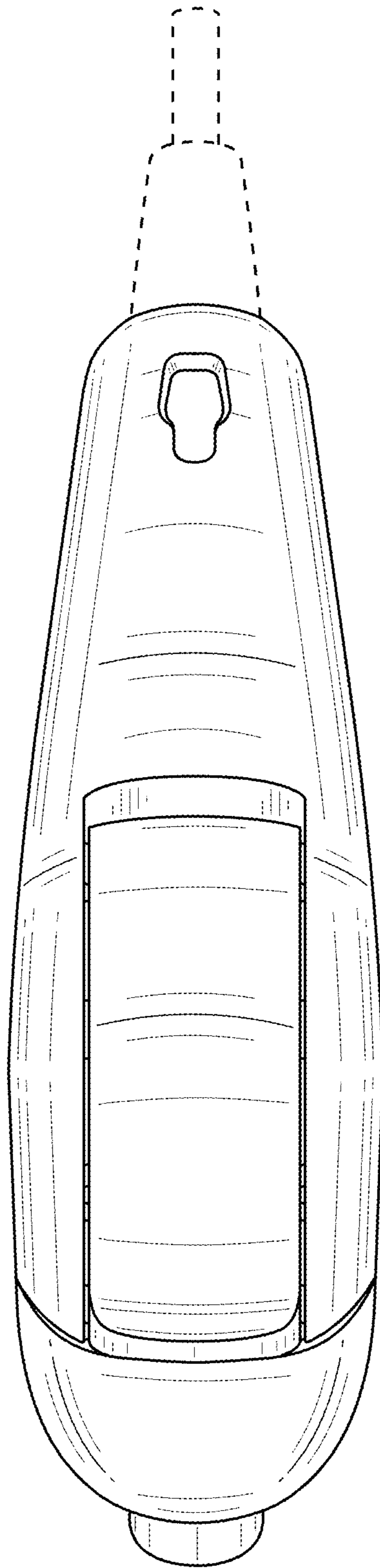
