(57) **CLAIM**

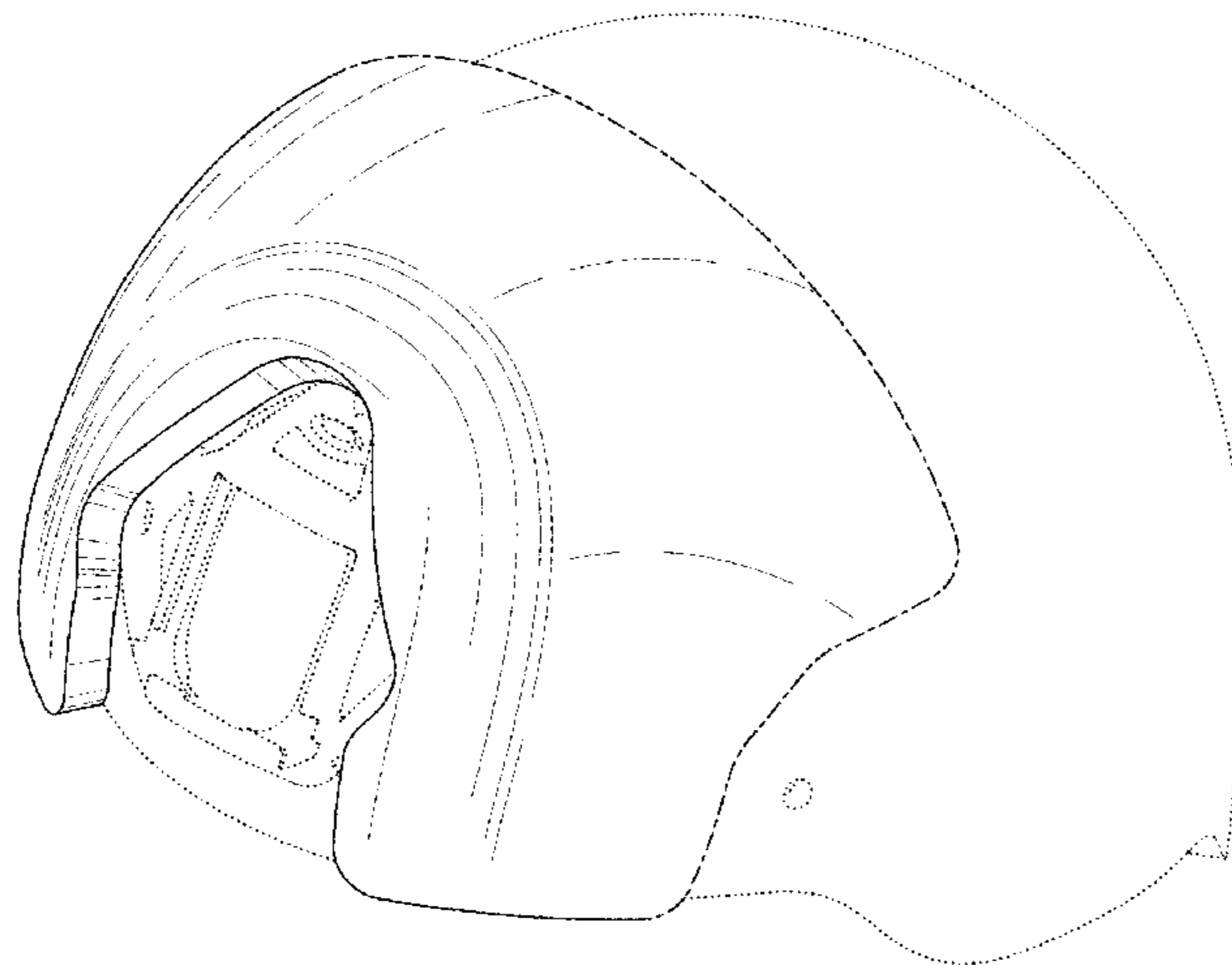
The ornamental design for a helmet applique, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, left-side, top, perspective view of a helmet applique showing our new design shown attached to an optional helmet;  
FIG. 2 is a front, left-side, top, perspective view of the helmet applique shown in FIG. 1 without the optional helmet;  
FIG. 3 is a rear, right-side, bottom, perspective view of the helmet applique shown in FIG. 2;  
FIG. 4 is a front elevational view of the helmet applique shown in FIG. 2;  
FIG. 5 is a rear elevational view of the helmet applique shown in FIG. 2;  
FIG. 6 is a left-side elevational view of the helmet applique shown in FIG. 2;  
FIG. 7 is a right-side elevational view of the helmet applique shown in FIG. 2;  
FIG. 8 is a top plan view of the helmet applique shown in FIG. 2; and,  
FIG. 9 is a bottom plan view of the helmet applique shown in FIG. 2.

The dot-dash broken lines represent the bounds of the claimed design while the dot-dot broken lines are directed to environment and are for illustrative purposes only; the broken lines shown in the drawings represent portions of the helmet applique that form no part of the claimed design.

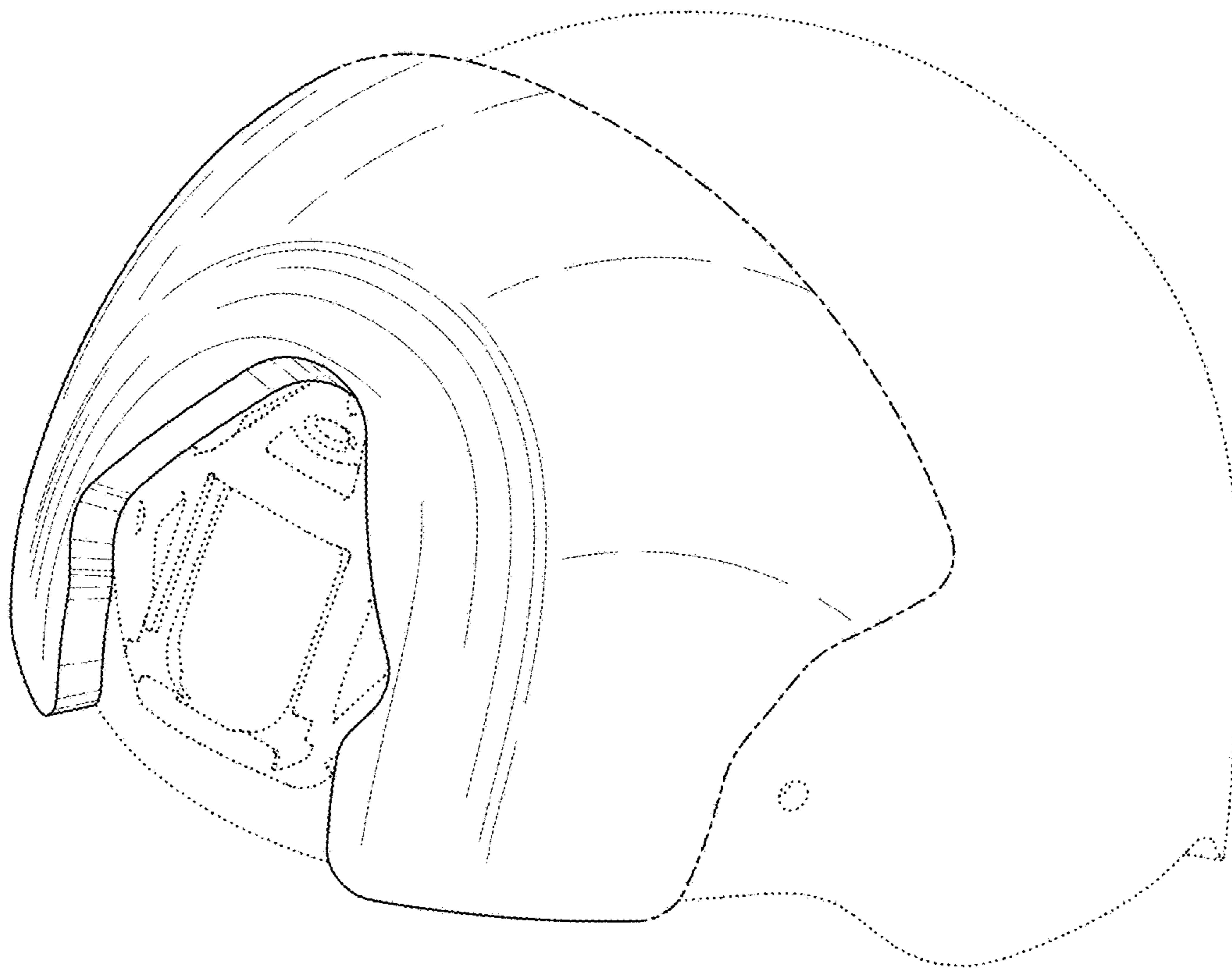

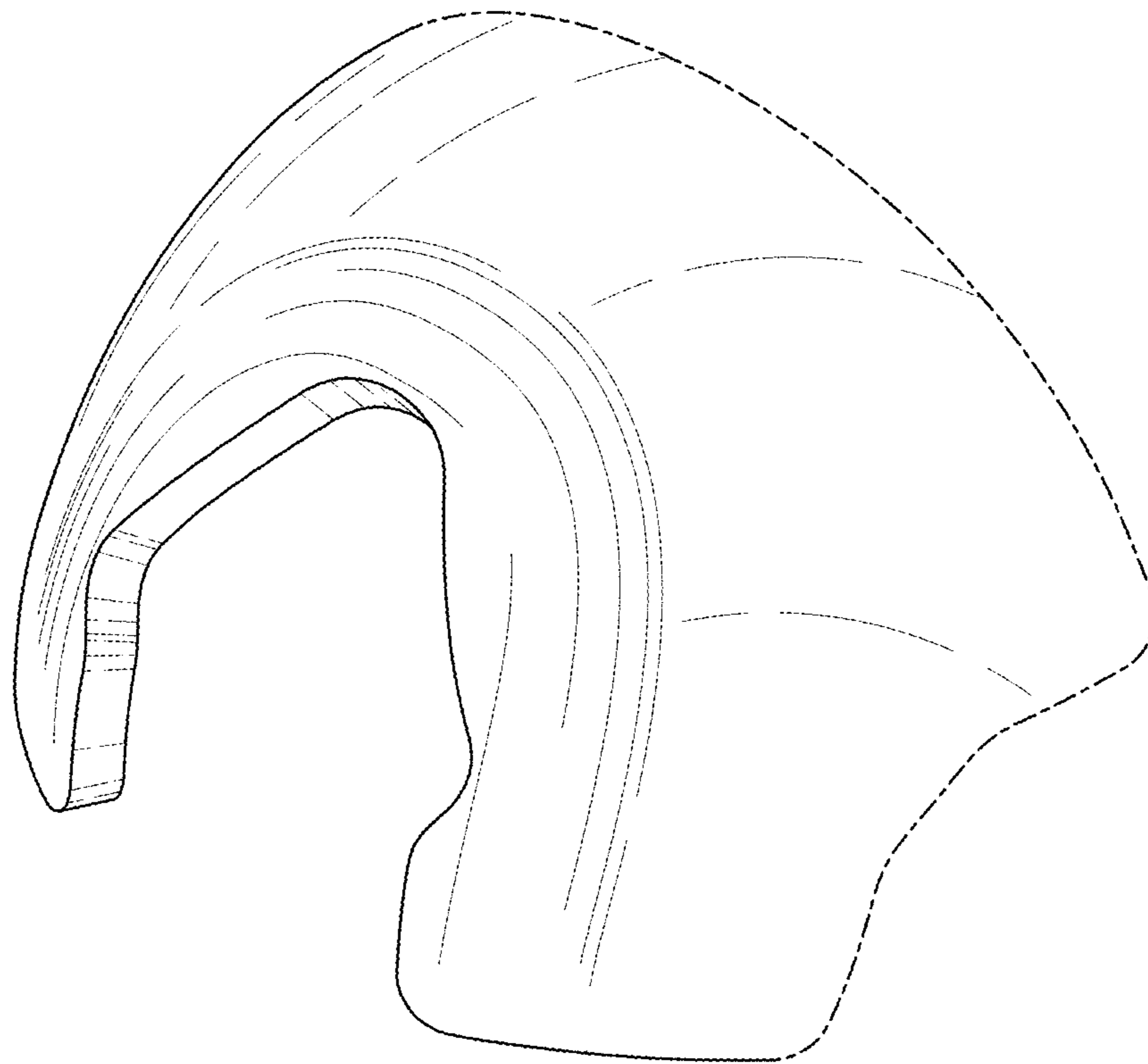

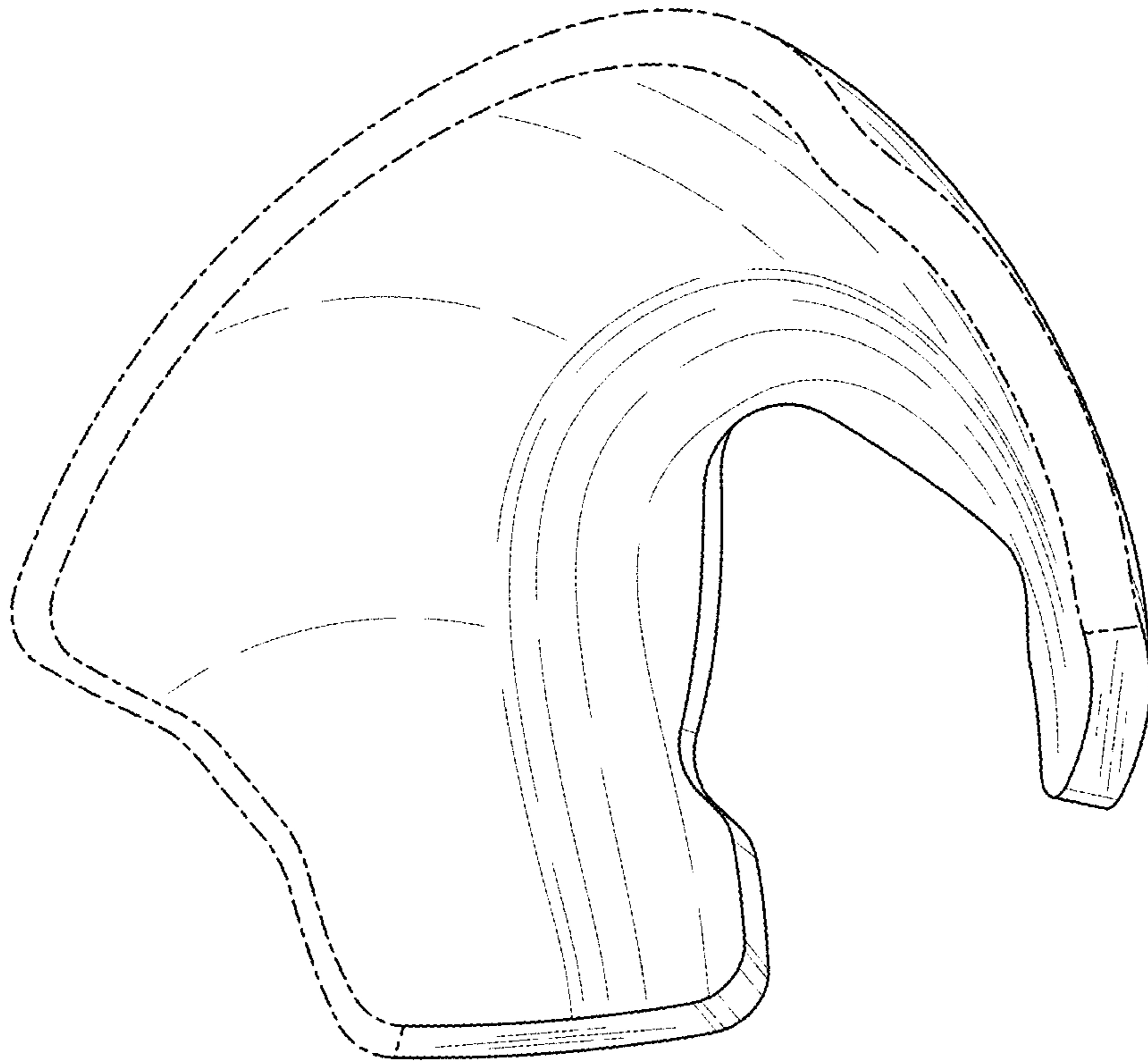

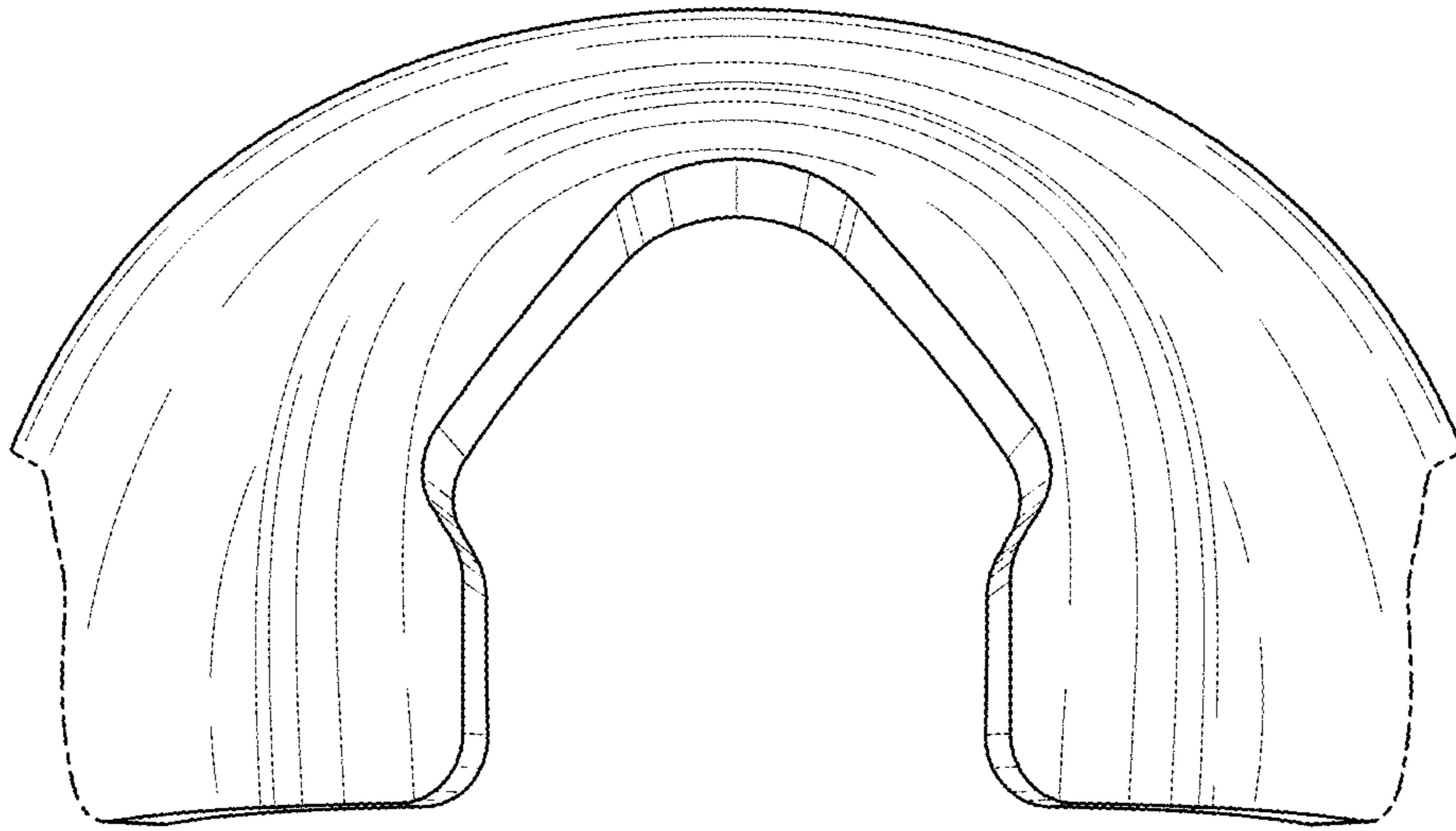

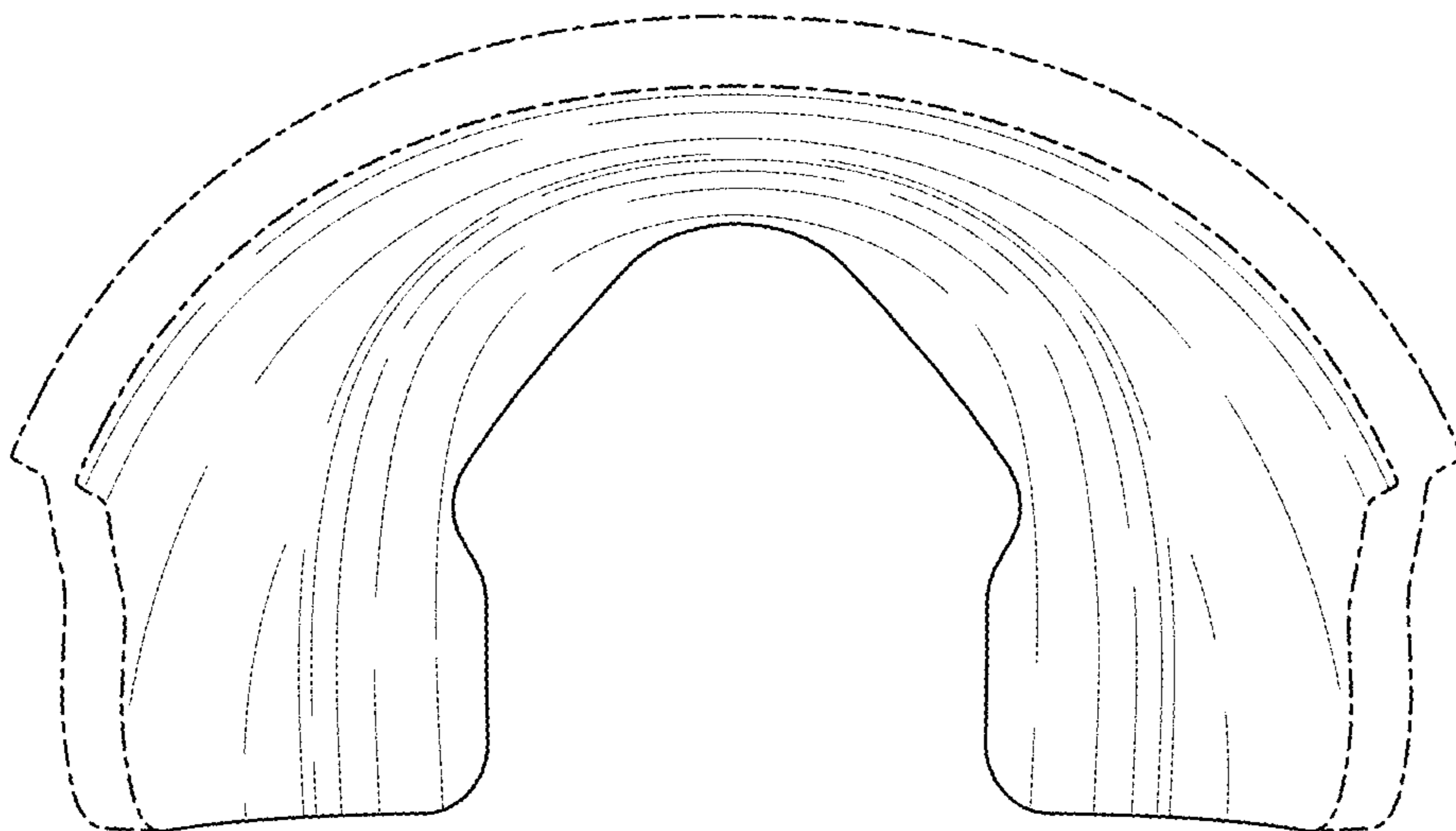

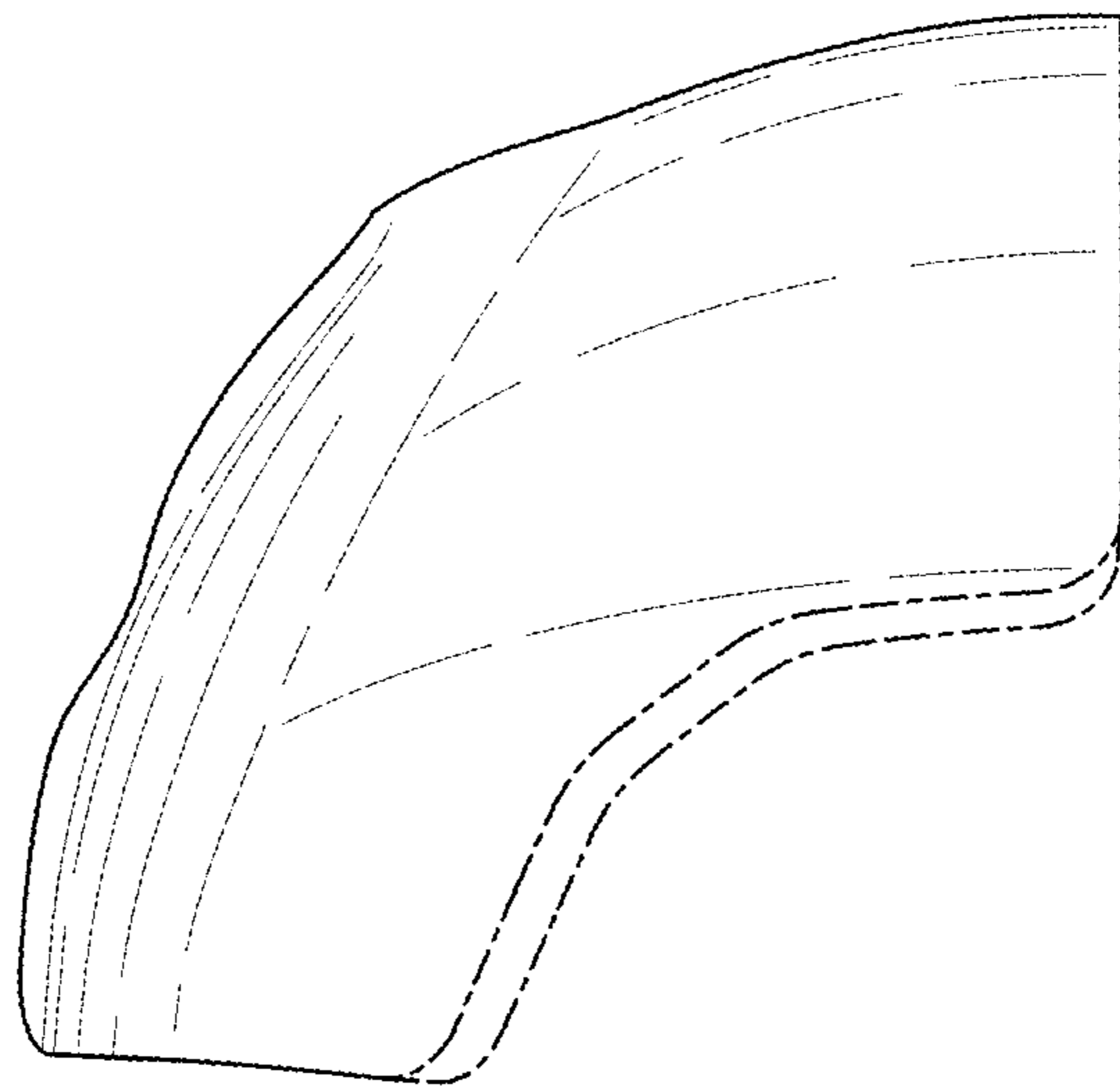

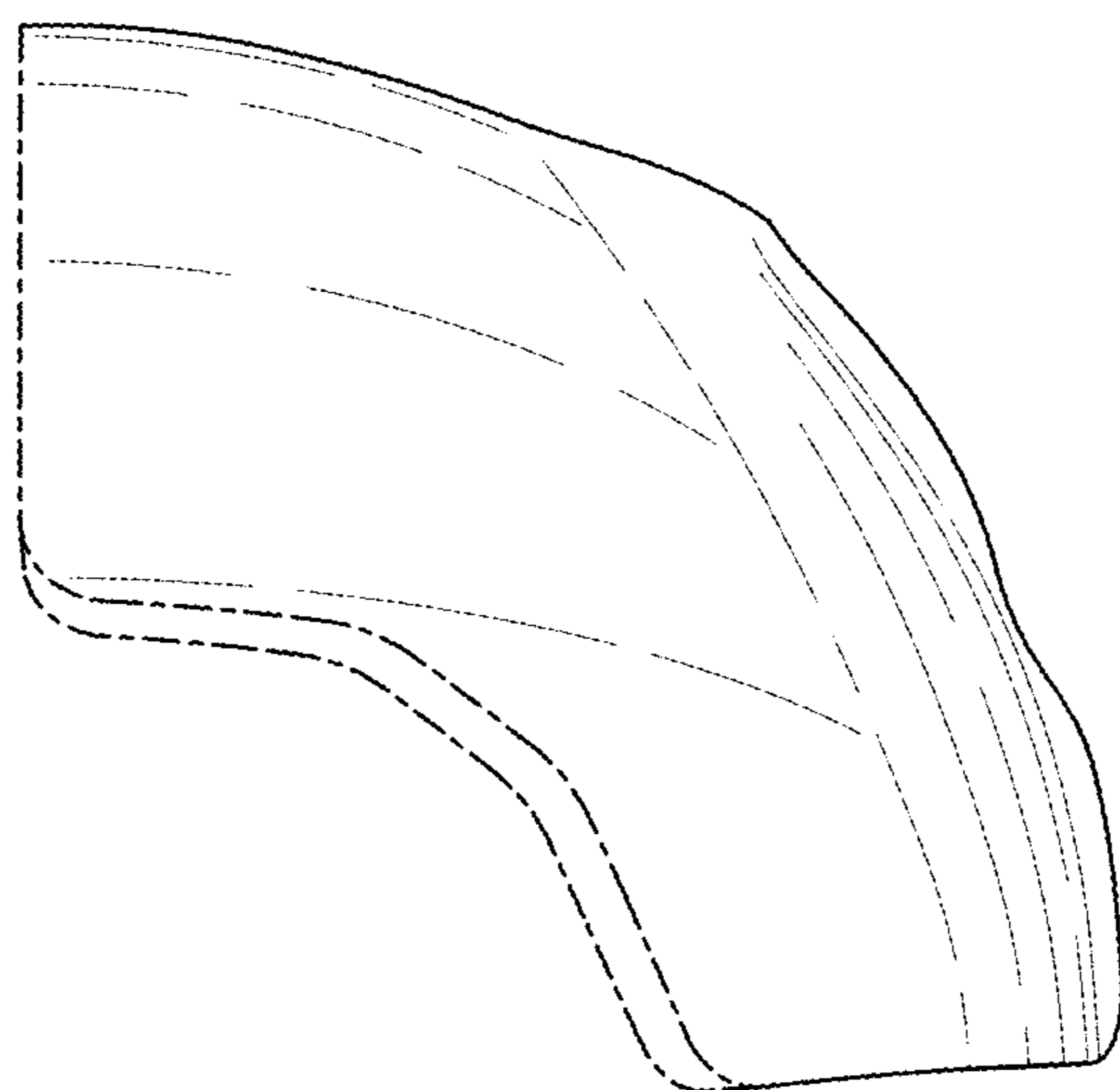

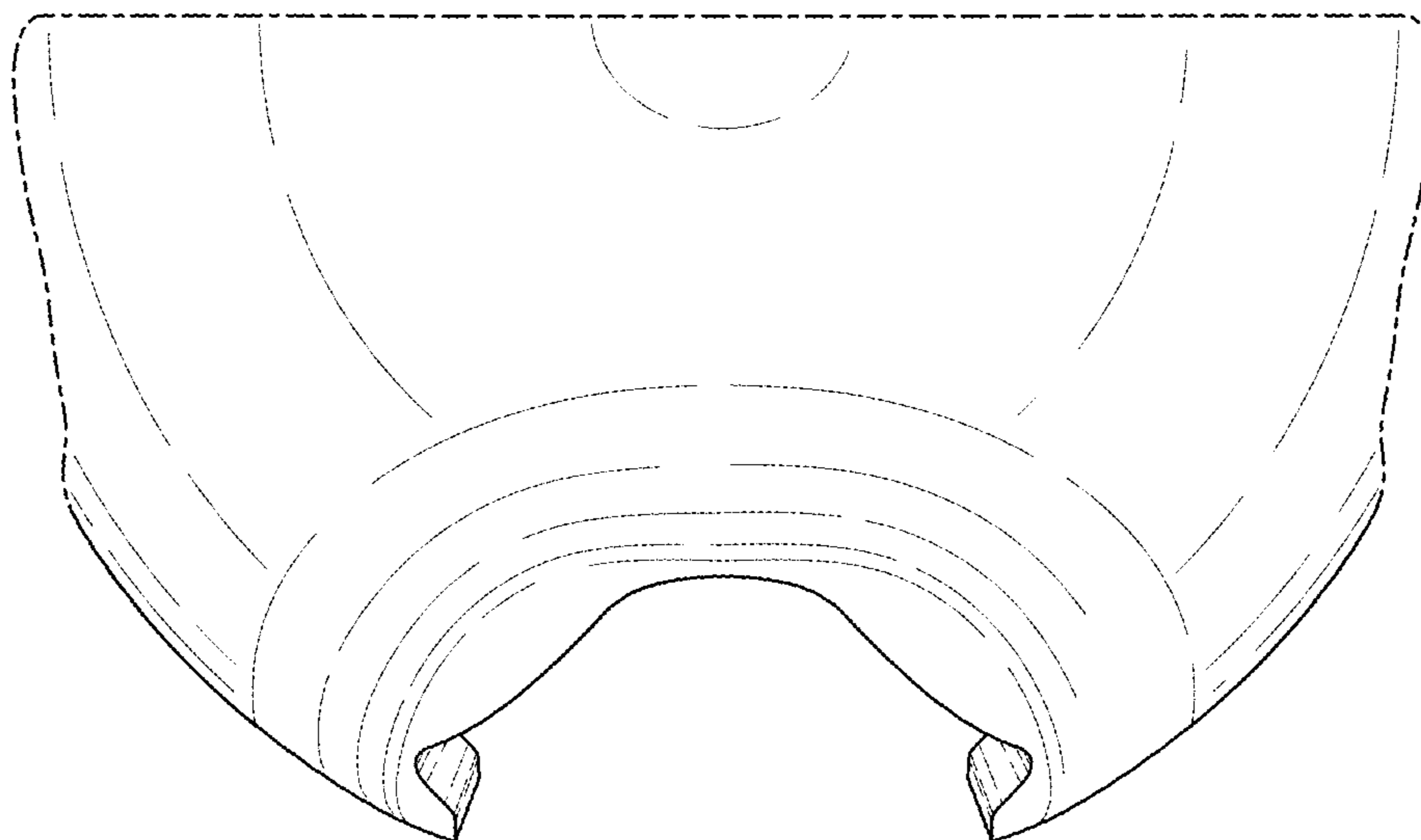

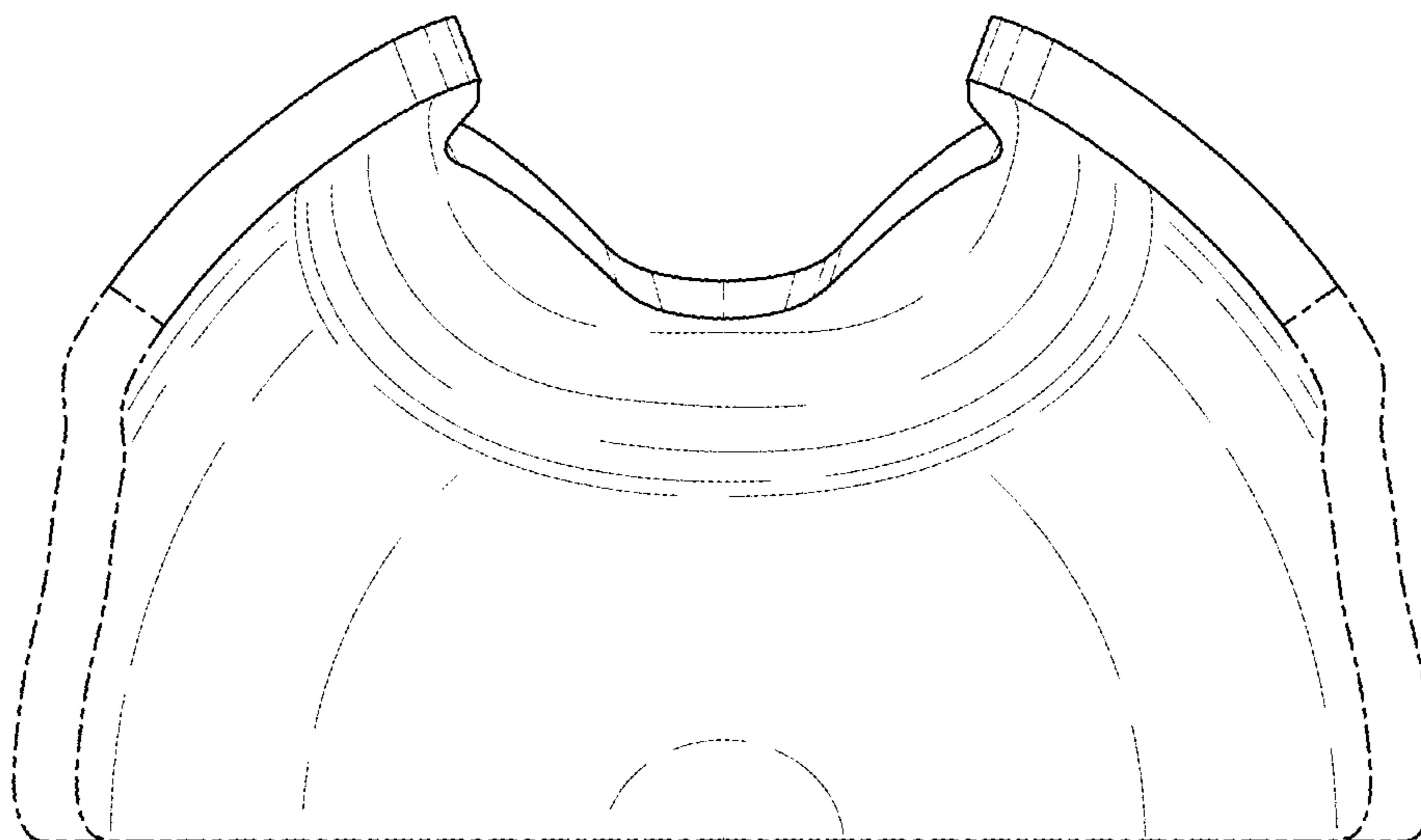
