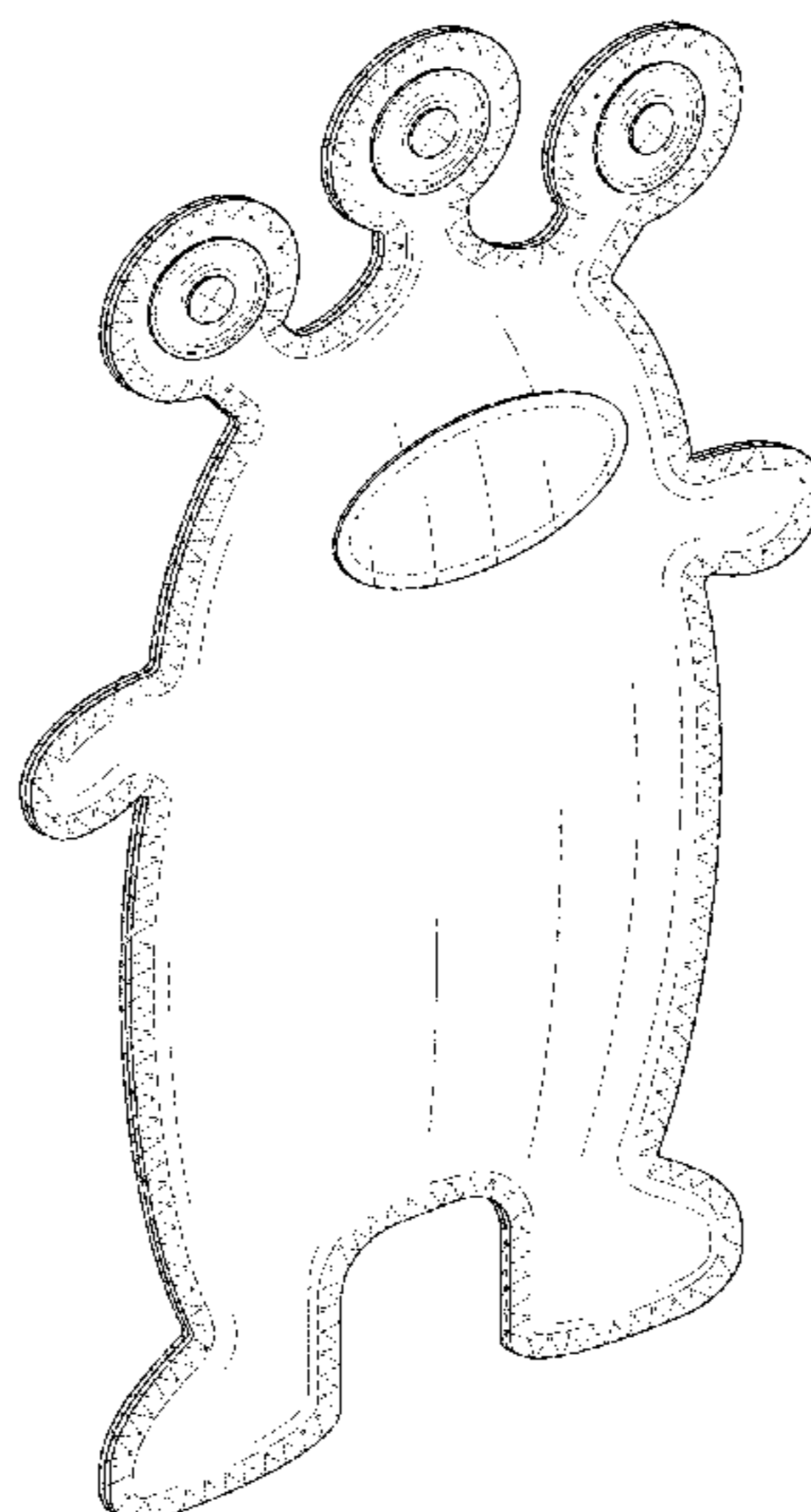
(57) **CLAIM**

The ornamental design for an animal toy, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective of an animal toy of the present invention;
FIG. 2 is a front view of the animal toy of FIG. 1, the back view being a mirror image thereof;
FIG. 3 is a first side view of the animal toy of FIG. 1, the second side view being a mirror images thereof;
FIG. 4 is a top view of the animal toy of FIG. 1; and,
FIG. 5 is a bottom view of the animal toy of FIG. 1.
The broken lines are shown for the purpose of illustrating parts of the animal toy that form no part of the claim.

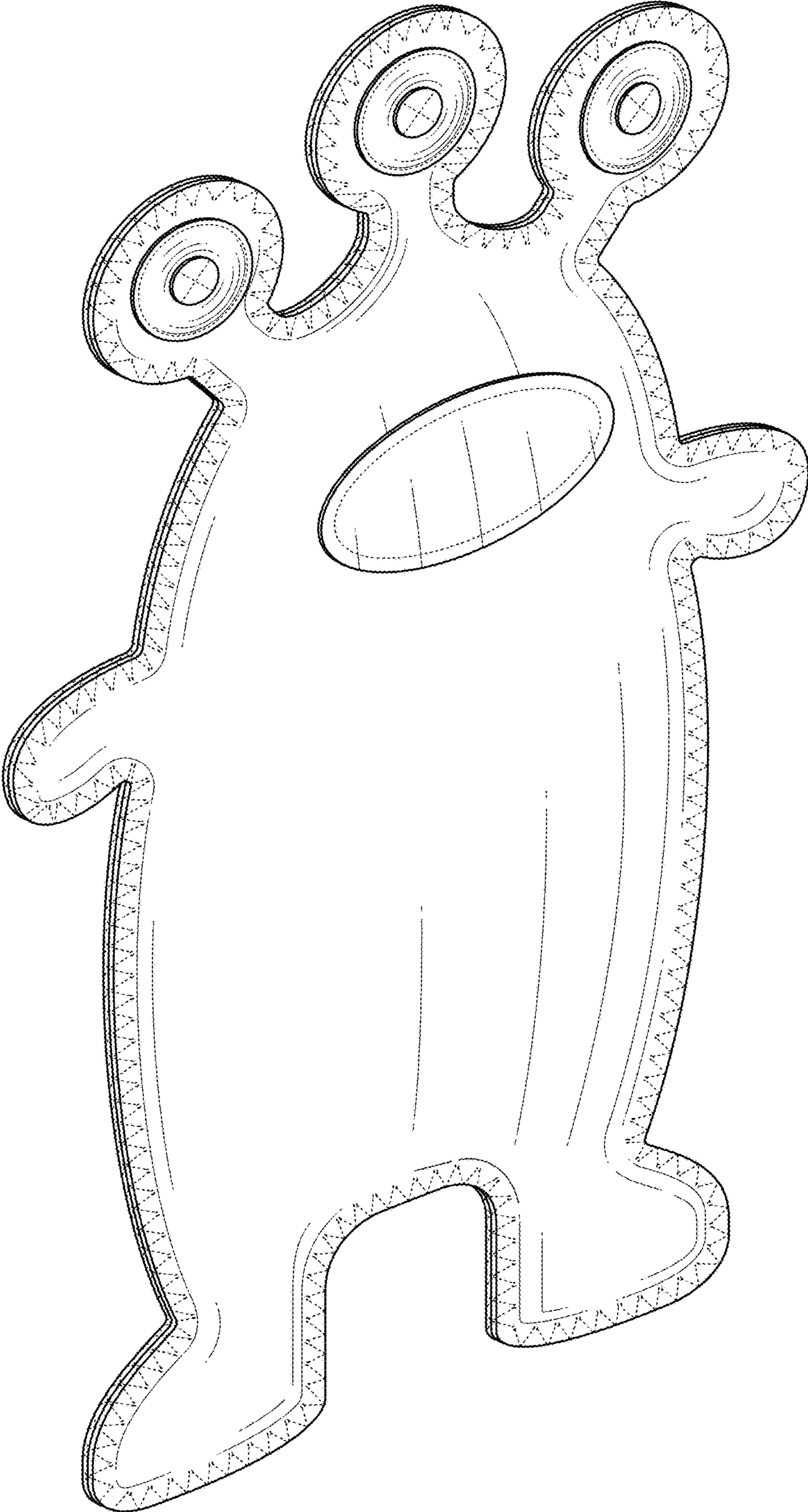

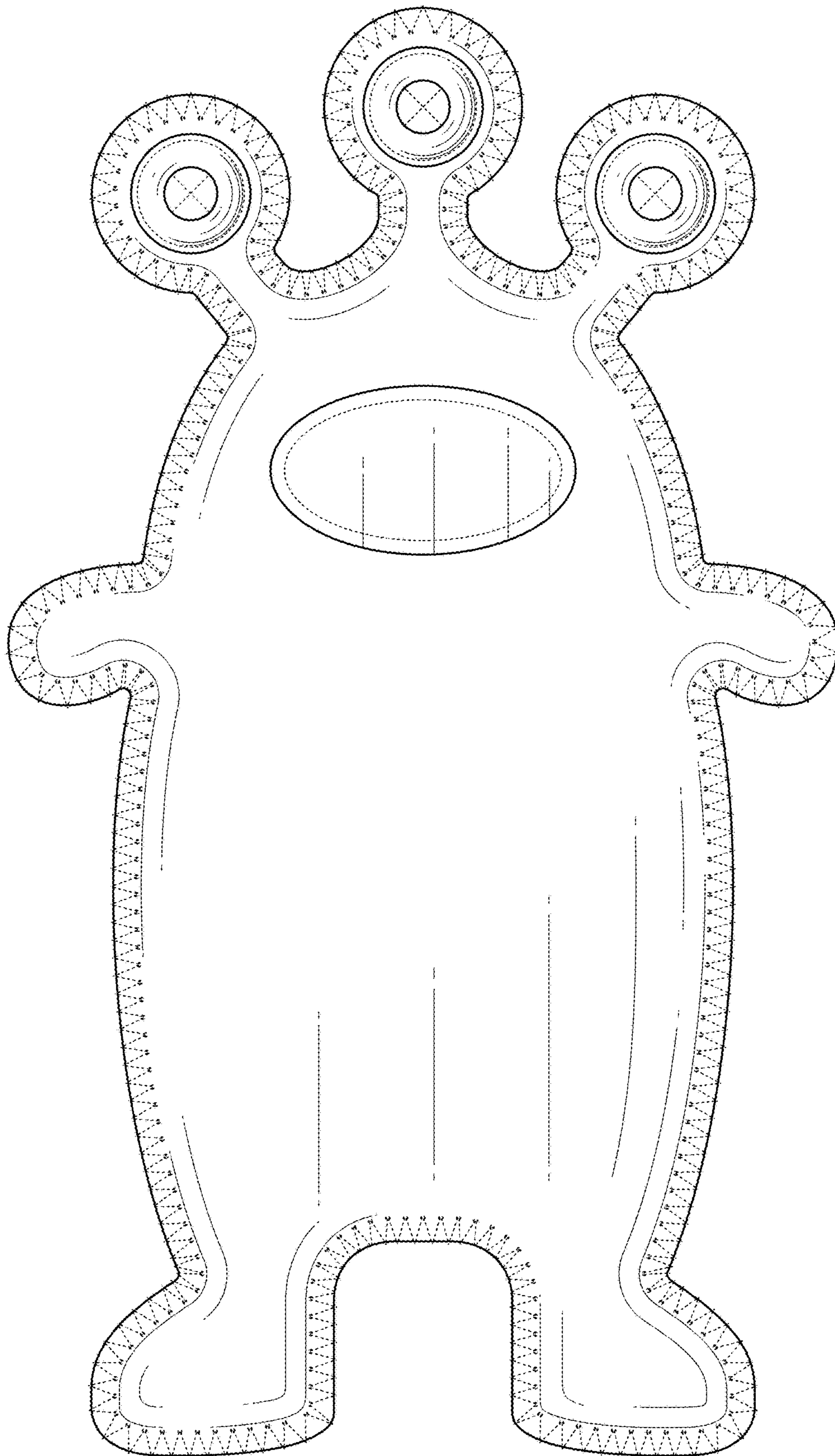

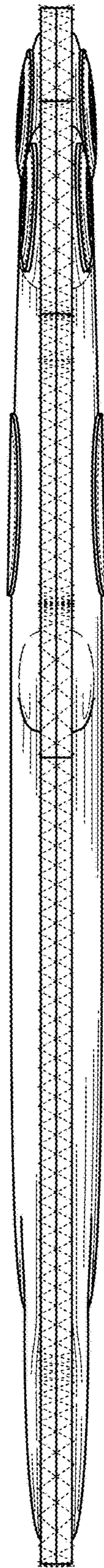

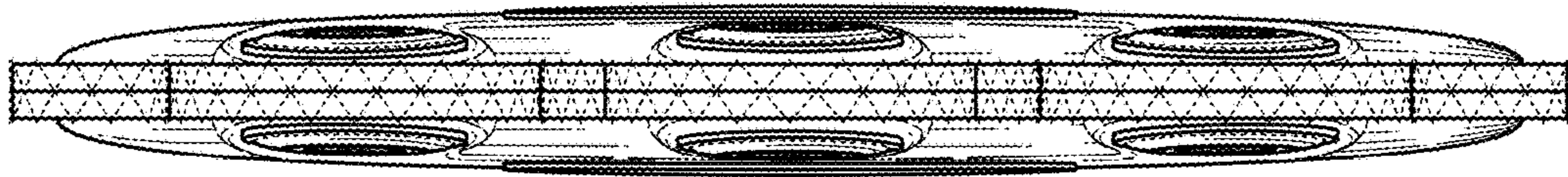

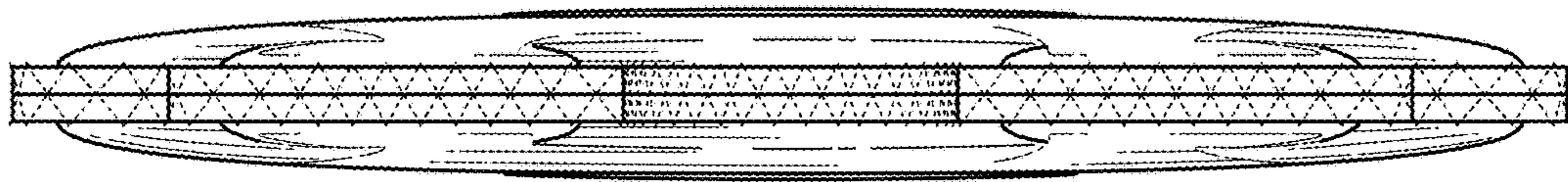
