(57) **CLAIM**

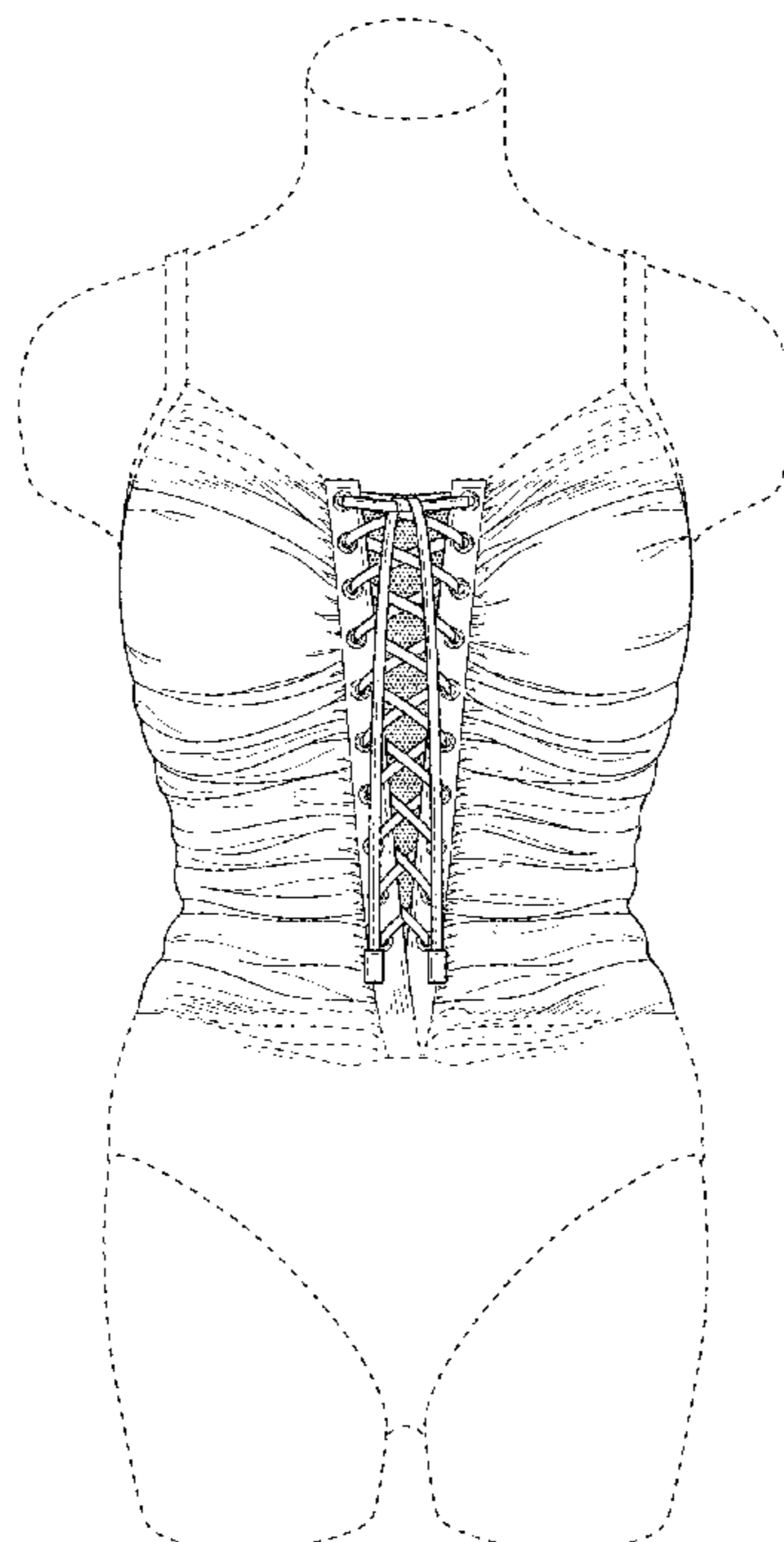
I claim the ornamental design for a swimsuit, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a swimsuit on a model showing my new design according to the present invention.
FIG. 2 is a rear view of the swimsuit of FIG. 1.
FIG. 3 is a left-side view of the swimsuit of FIG. 1; and, FIG. 4 is a right-side view of the swimsuit of FIG. 1.
The broken lines in the figures are provided for environment only and form no part of the claimed design. The stippling in FIG. 1 represents a fabric including but not limited to a sheer fabric.

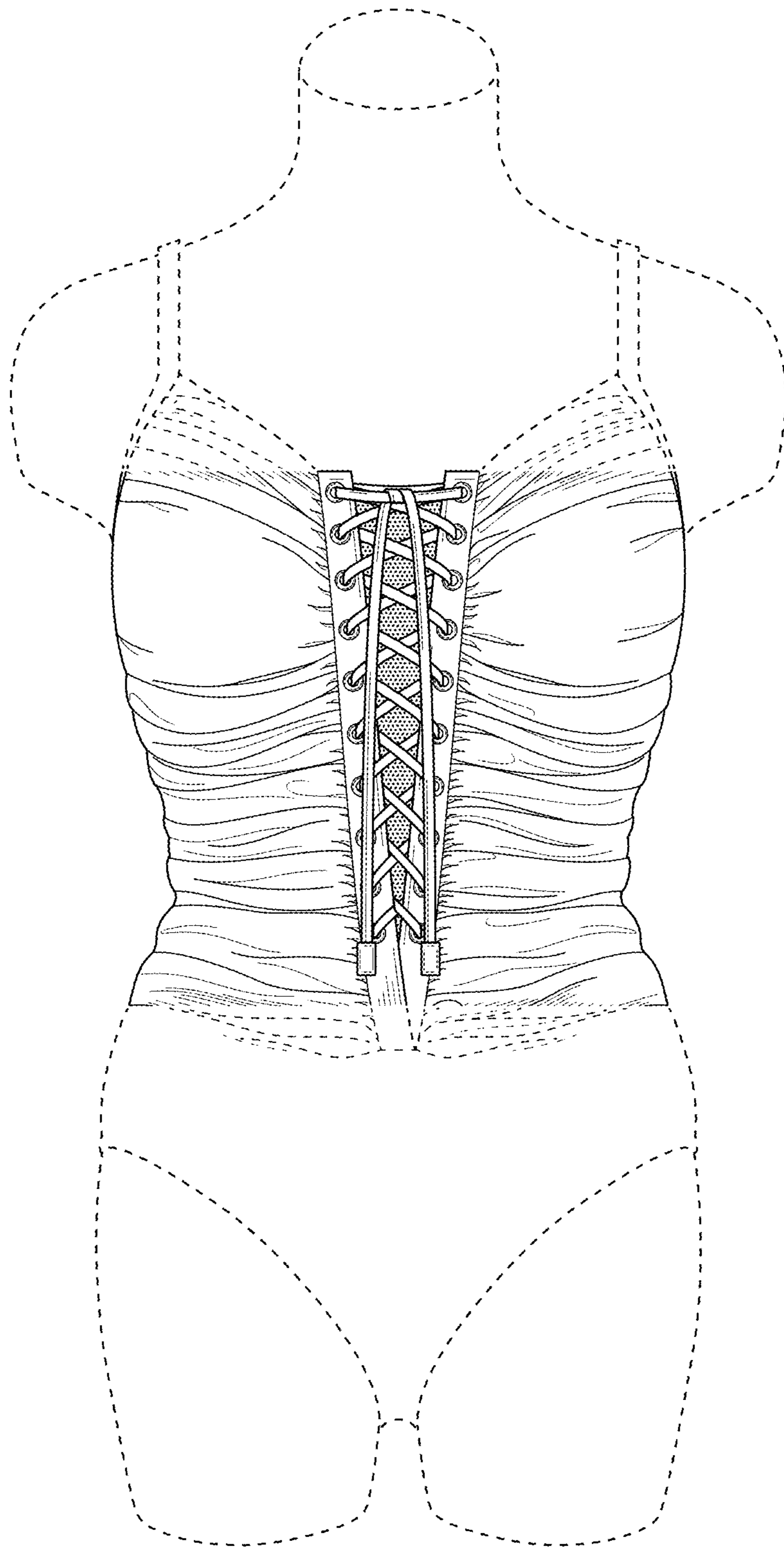

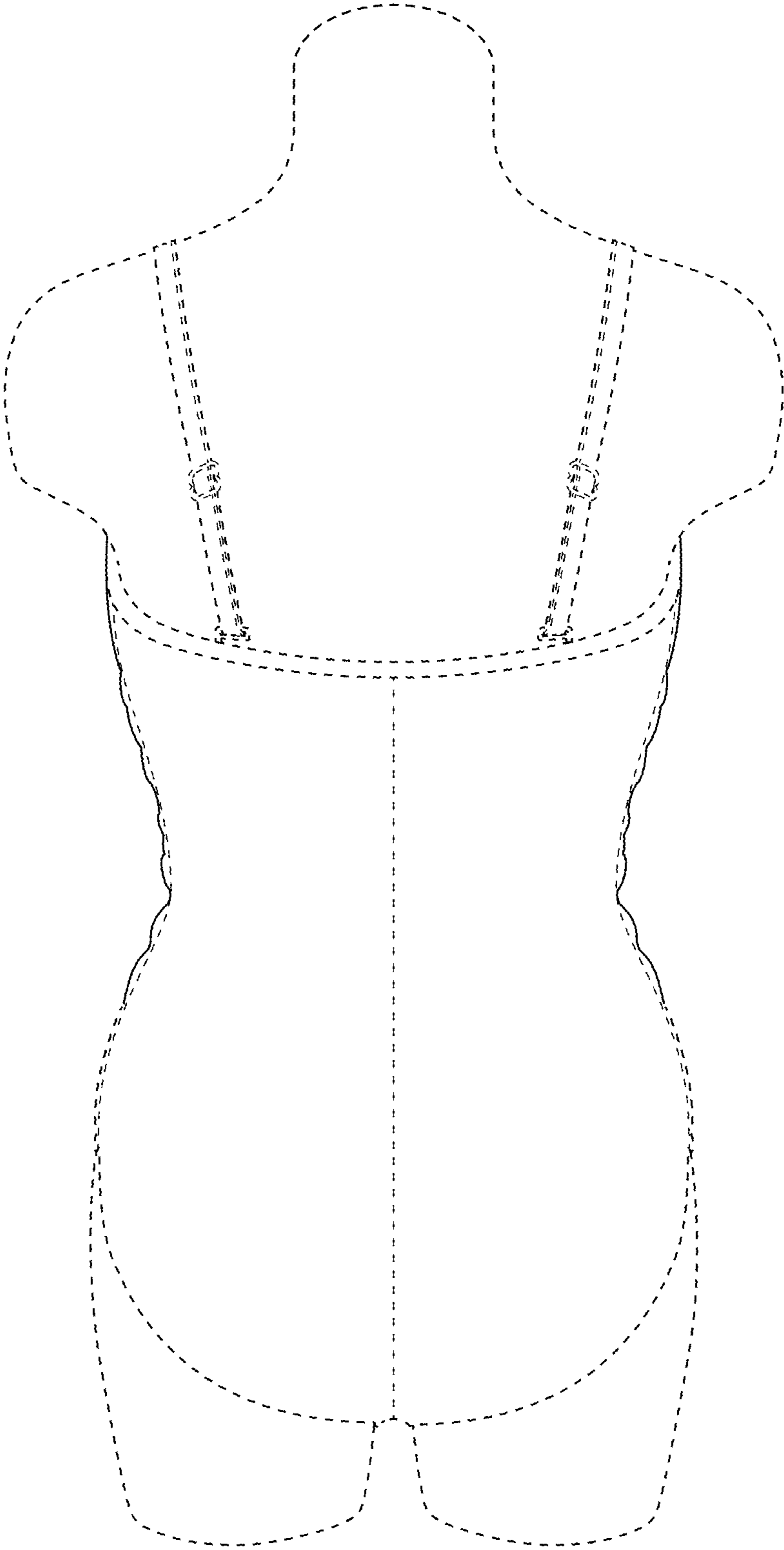

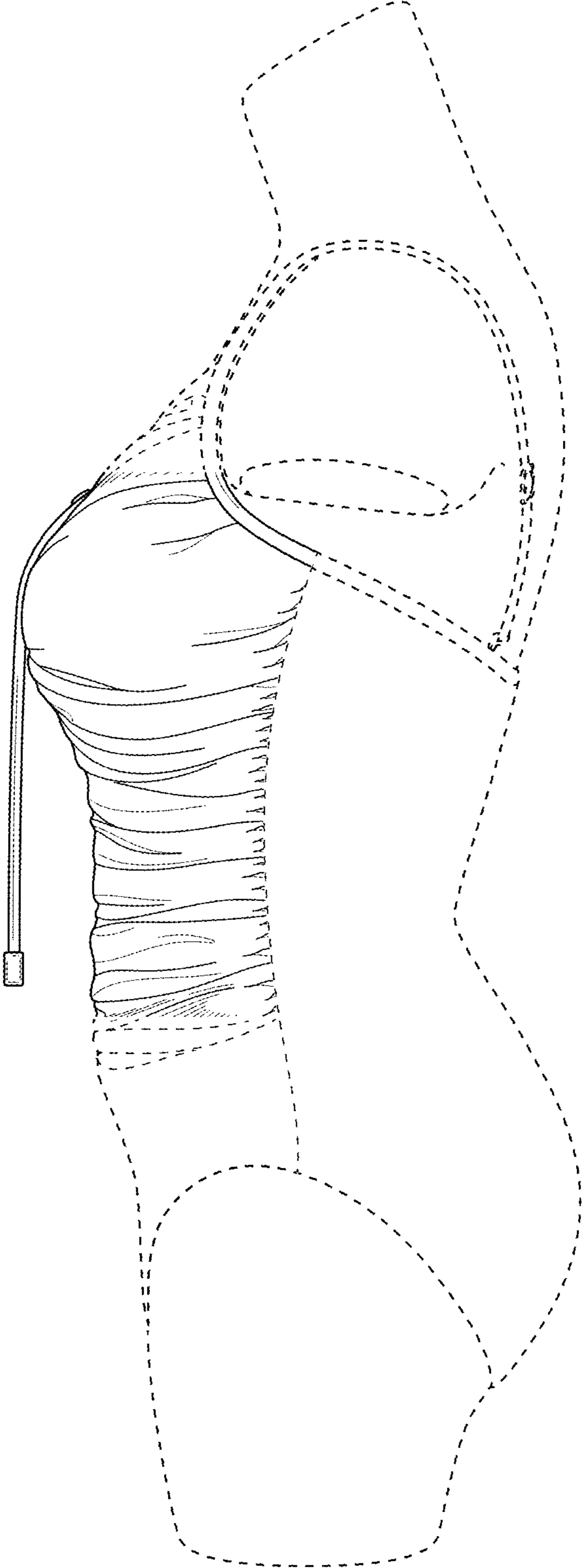

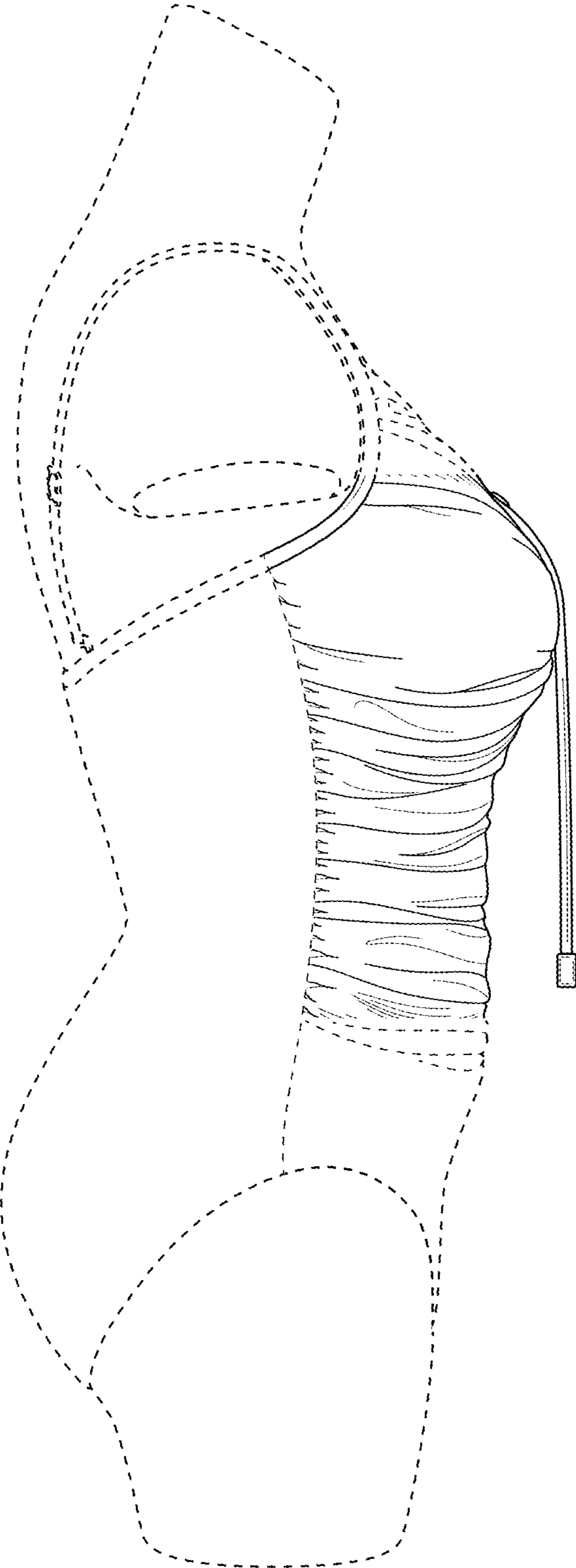
