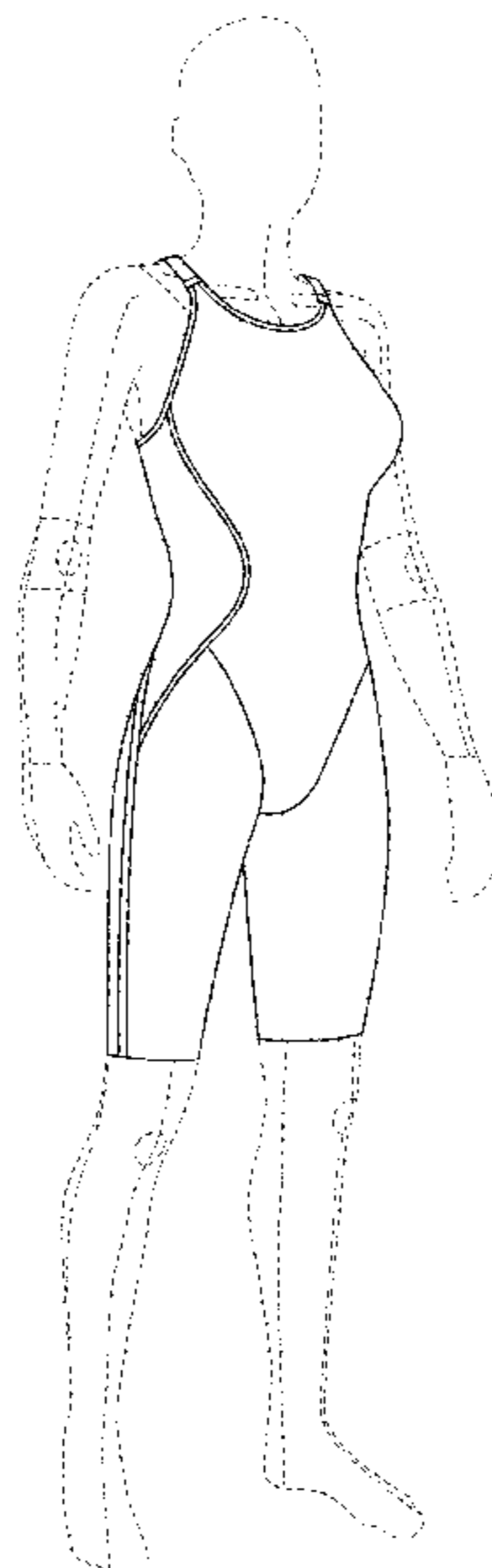
(57) **CLAIM**

The ornamental design for a swimsuit, as shown and described.

**DESCRIPTION**

FIG. 1 is a front right perspective view of a swimsuit design; FIG. 2 is a front left perspective view thereof; FIG. 3 is a rear right perspective view thereof, with racerback; and, FIG. 4 is a rear left perspective view thereof, with racerback. The broken line shown in the drawings are included for the purpose of illustrating environmental structure and form no part of claimed design.

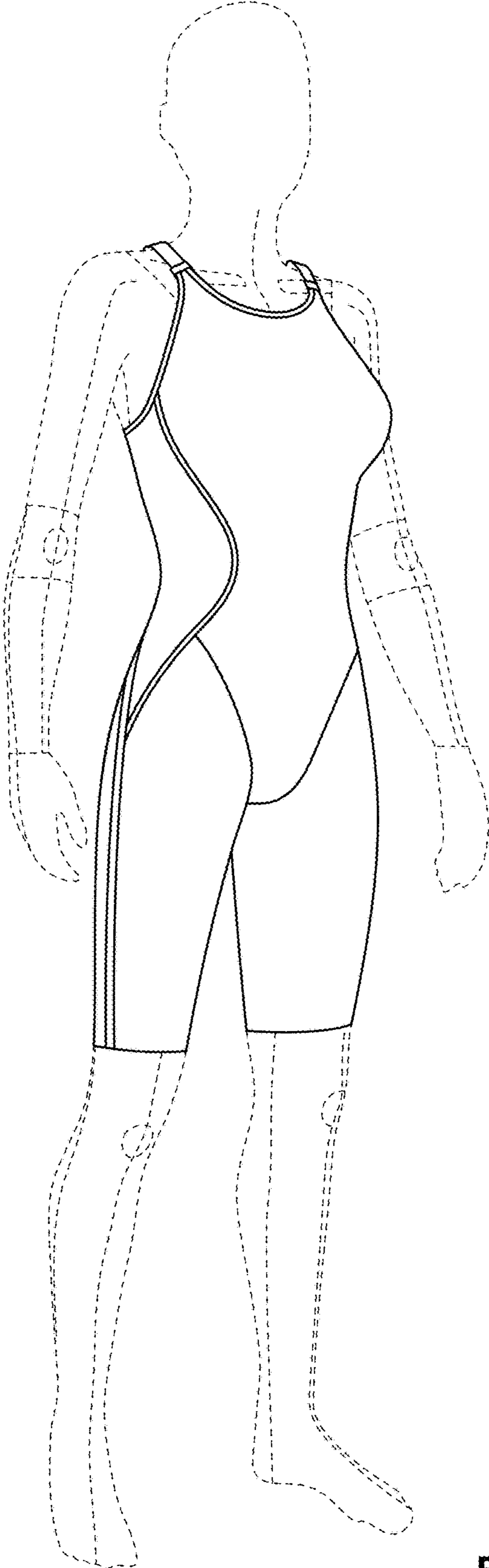

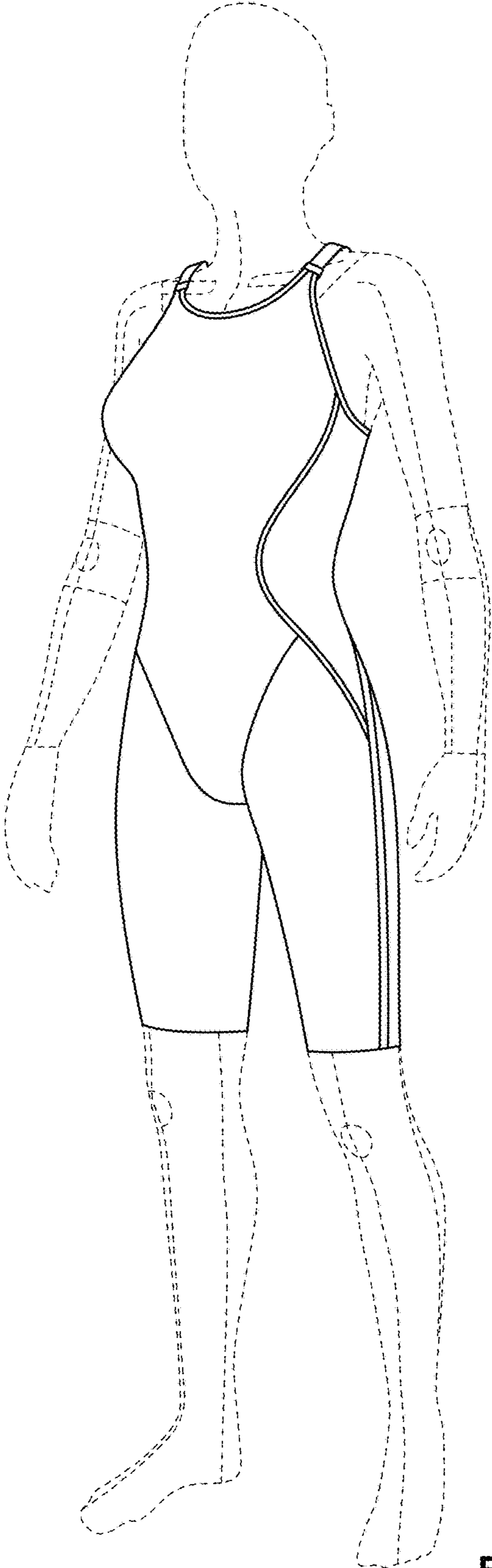

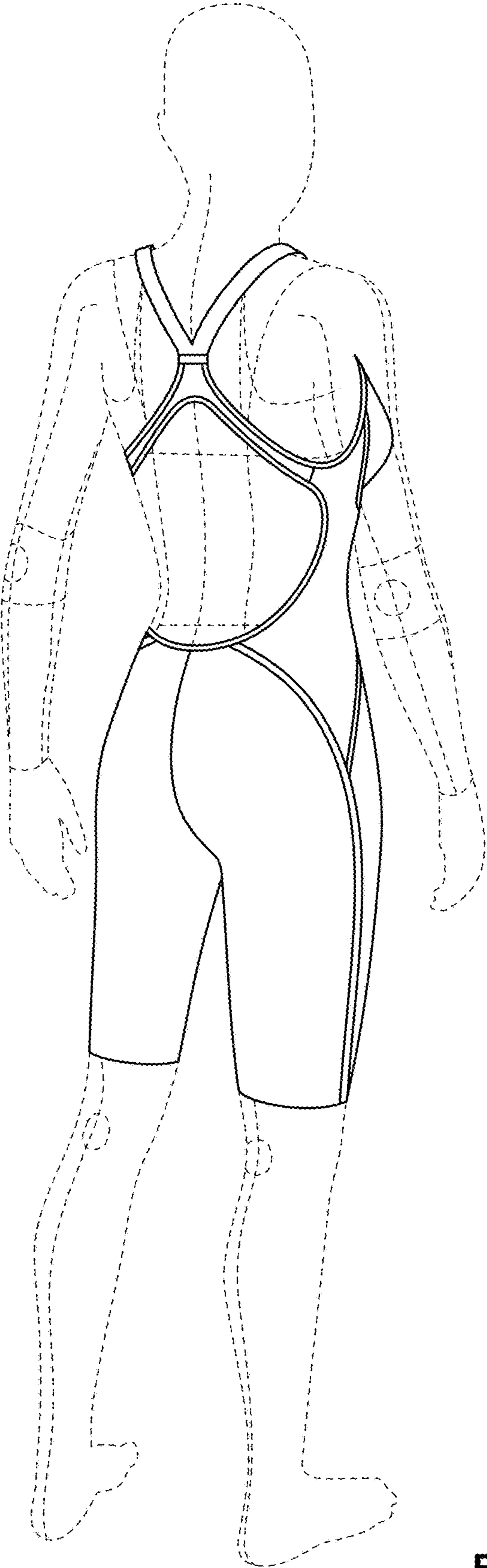

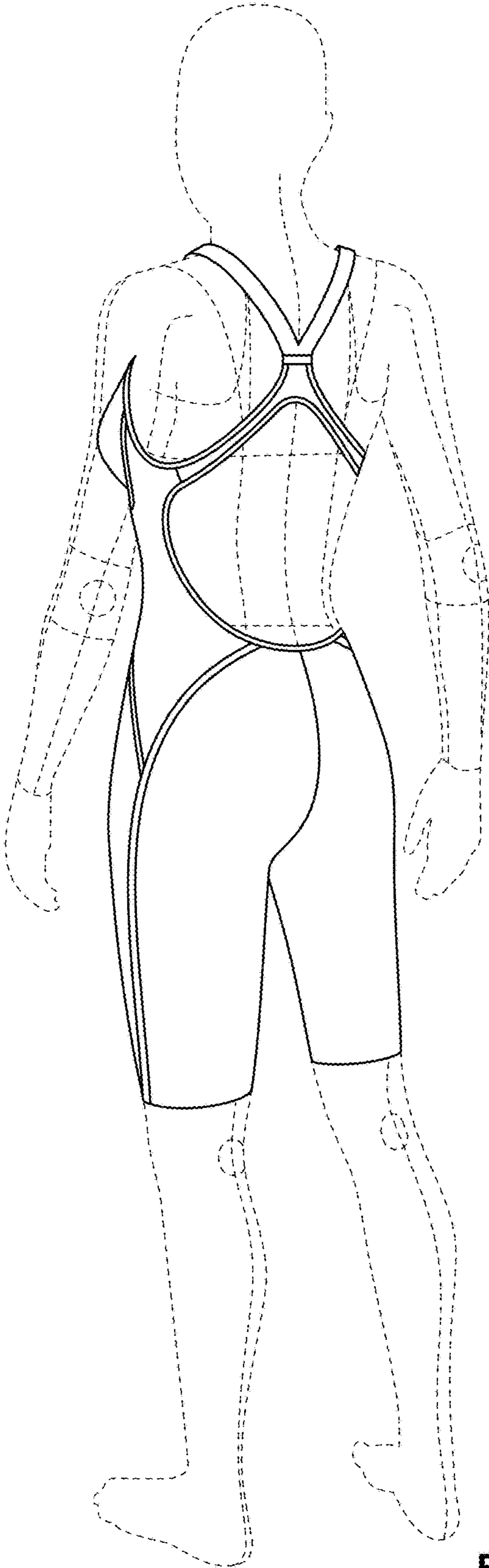
