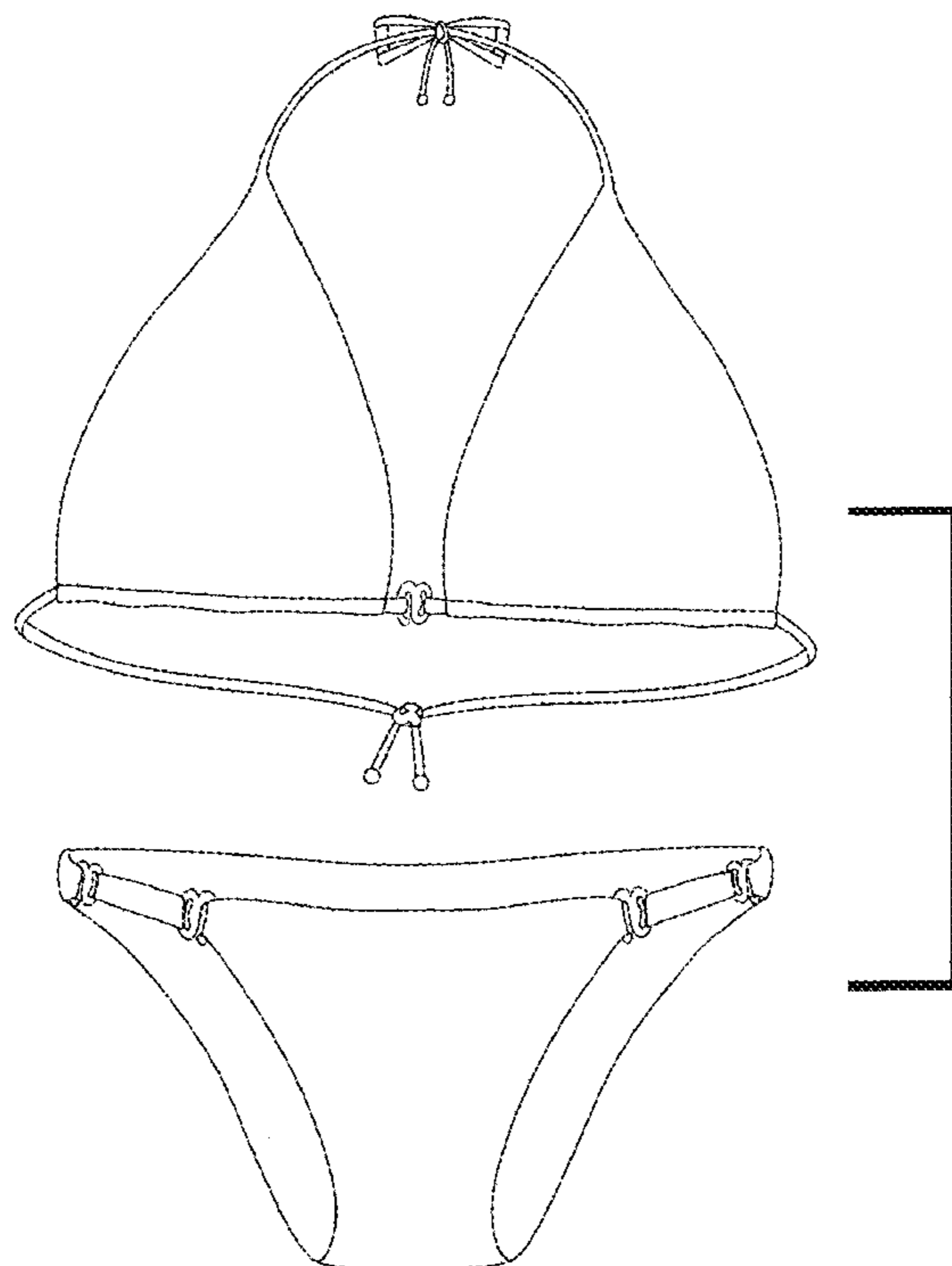
(57) **CLAIM**

The ornamental design for a modular interchanging bikini, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a modular interchanging bikini showing my new design;  
 FIG. 2 is a left side three-dimensional view of the top thereof, with the bottom removed for ease of illustration;  
 FIG. 3 is a right side three-dimensional view of the top thereof;  
 FIG. 4 is an enlarged fragmentary view of the top front fastener taken from FIG. 3 thereof;  
 FIG. 5 is a left side three-dimensional view of the bottom thereof, with the top removed for ease of illustration;  
 FIG. 6 is a right side three-dimensional view of the bottom thereof; and,  
 FIG. 7 is an enlarged fragmentary view of the bottom side band and fasteners taken from FIG. 6 thereof.

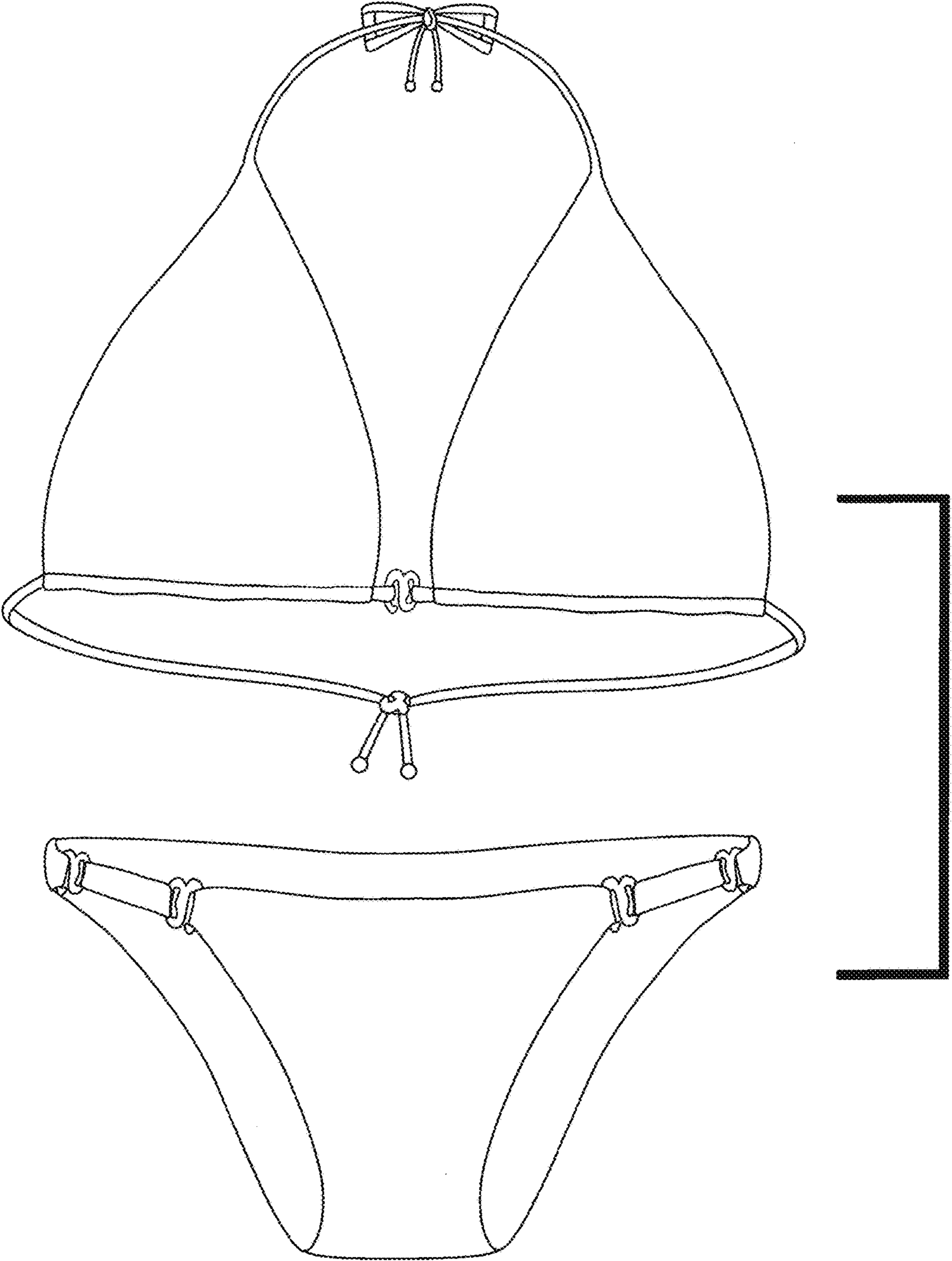

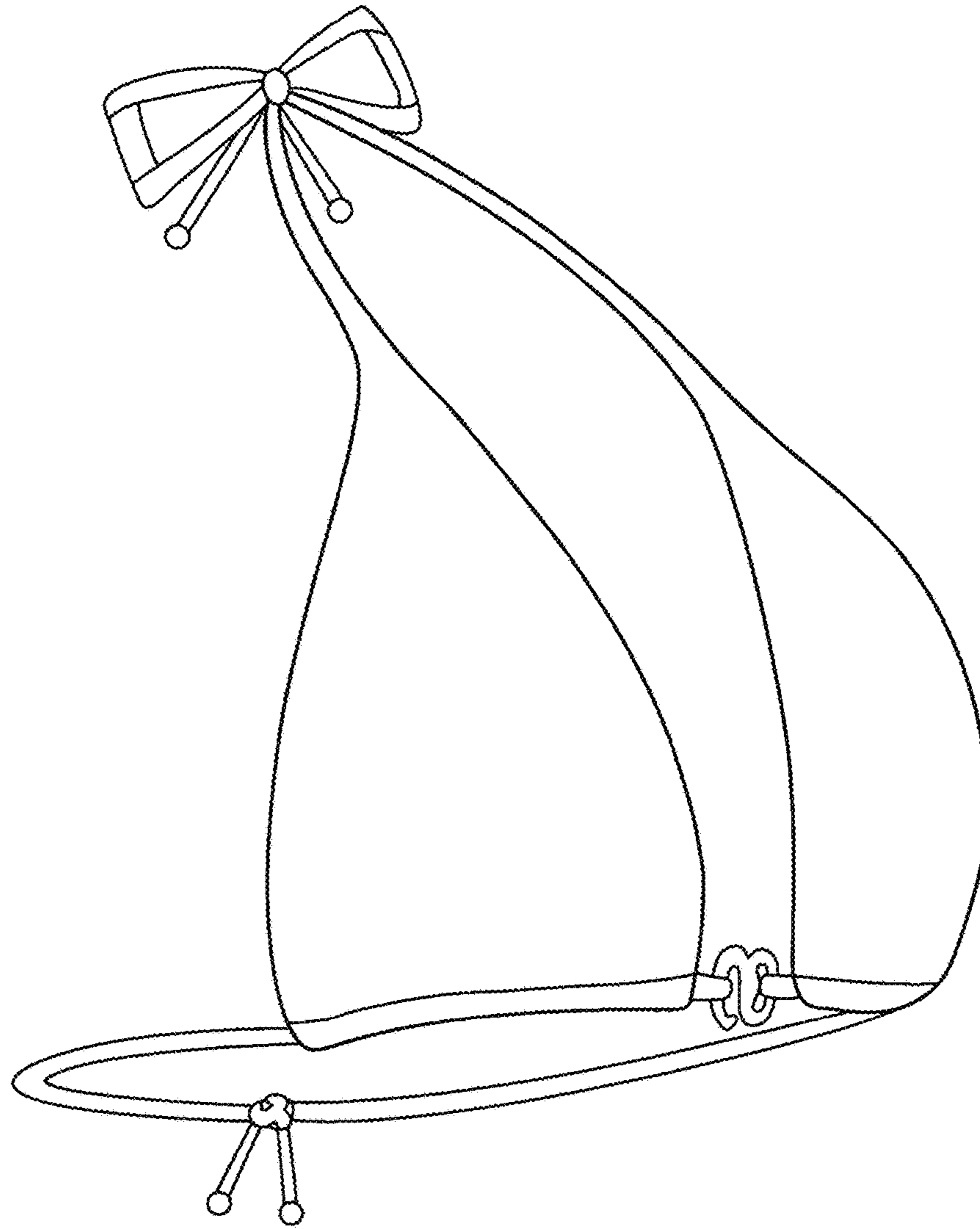

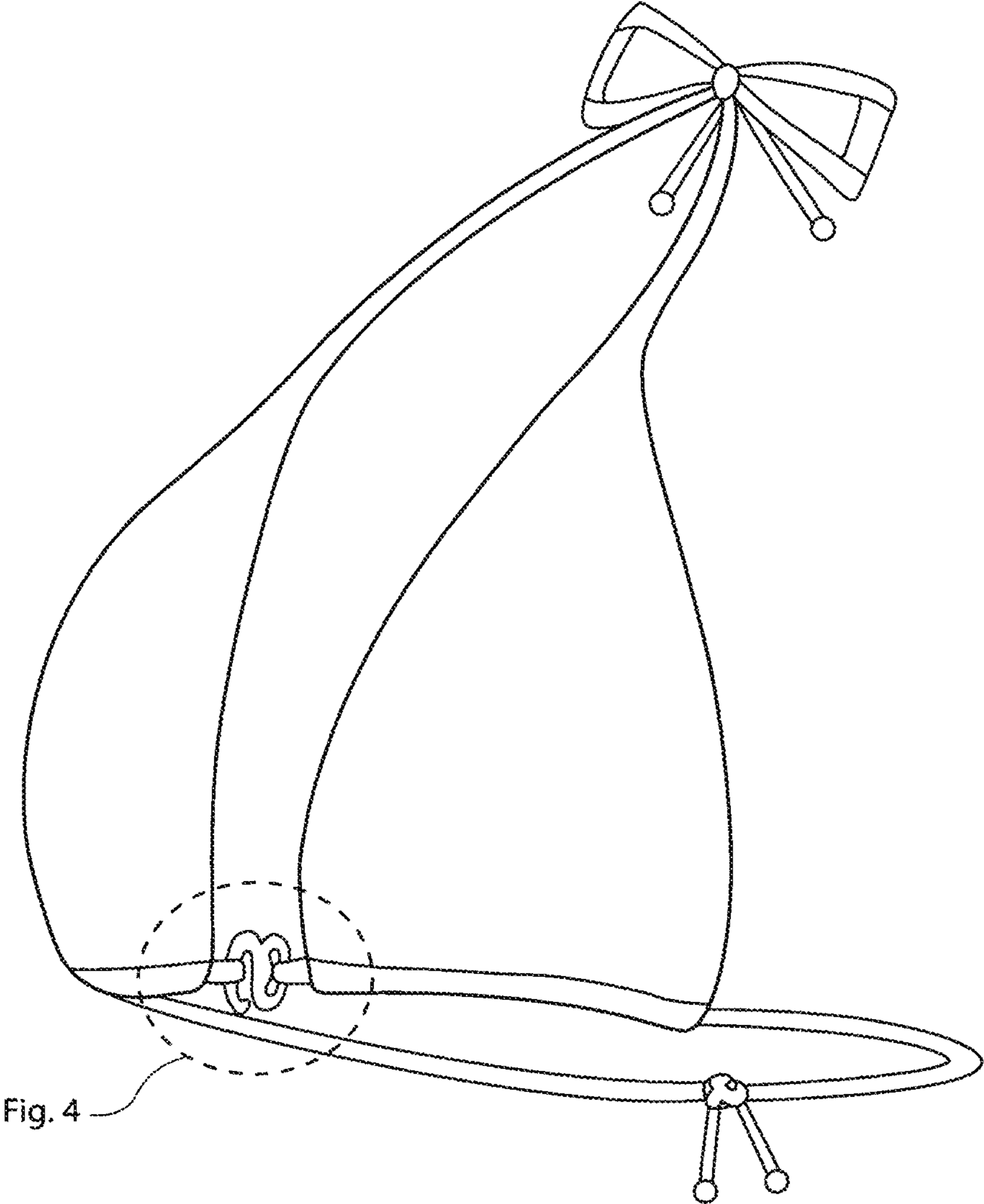

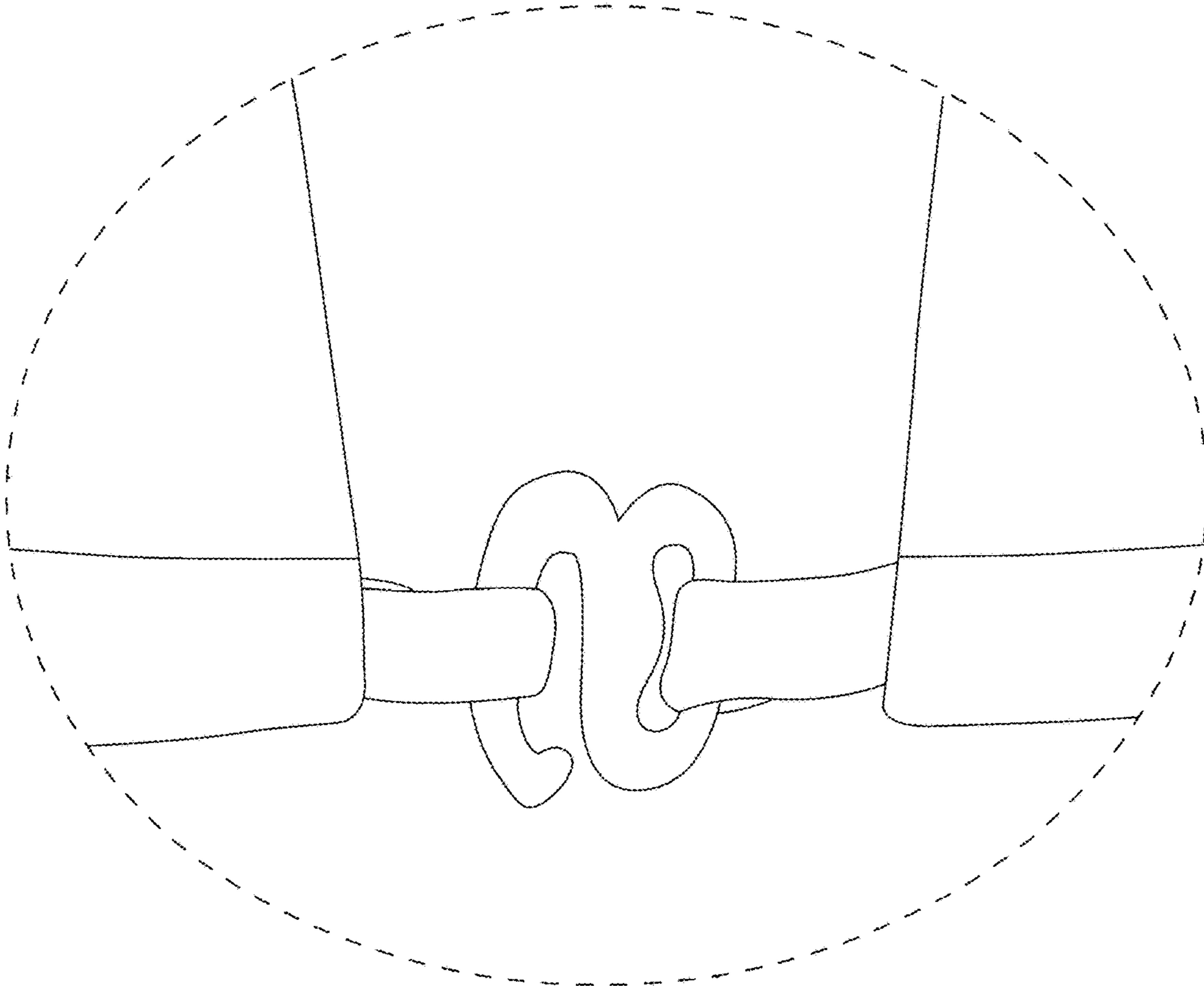

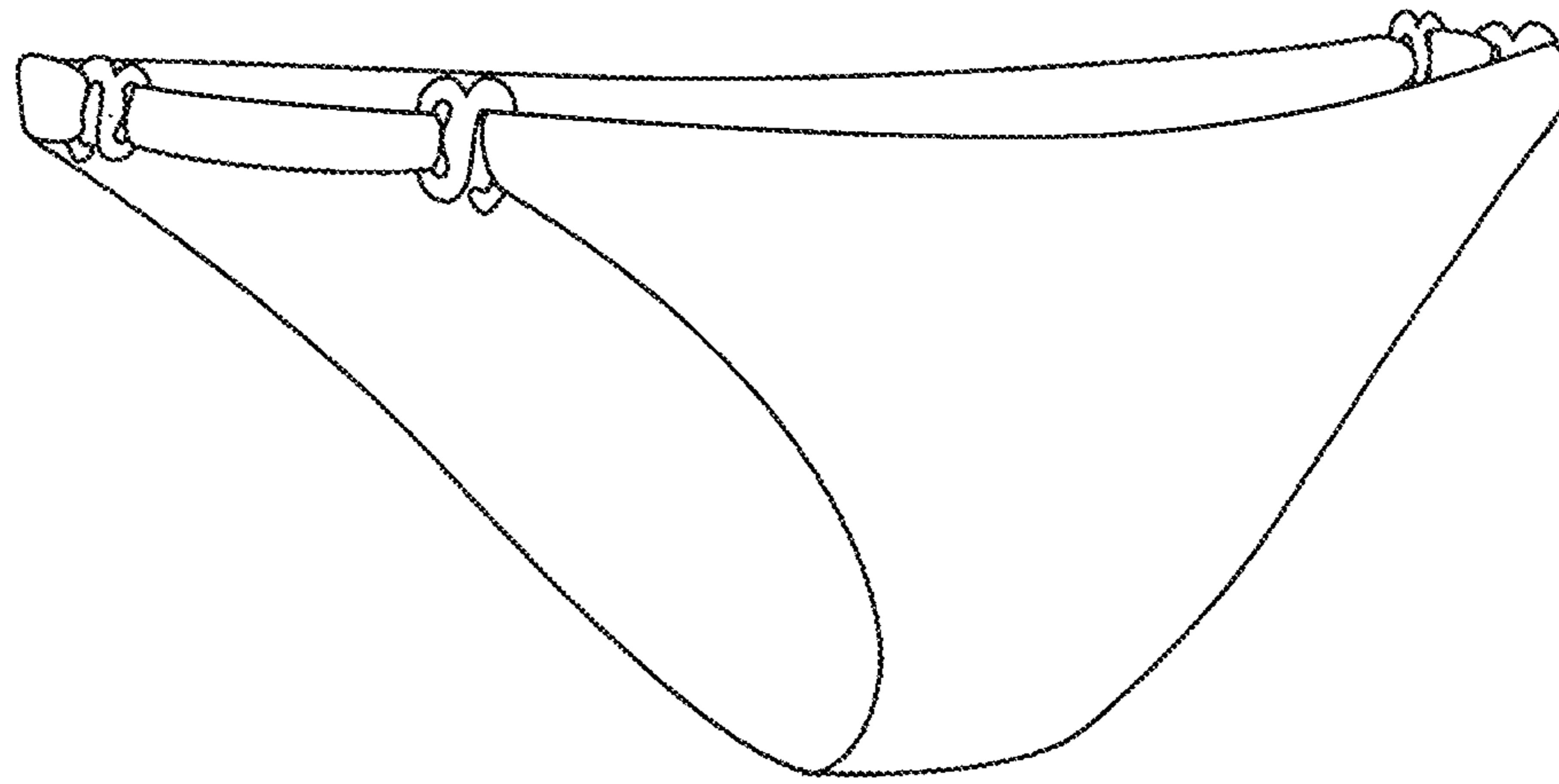

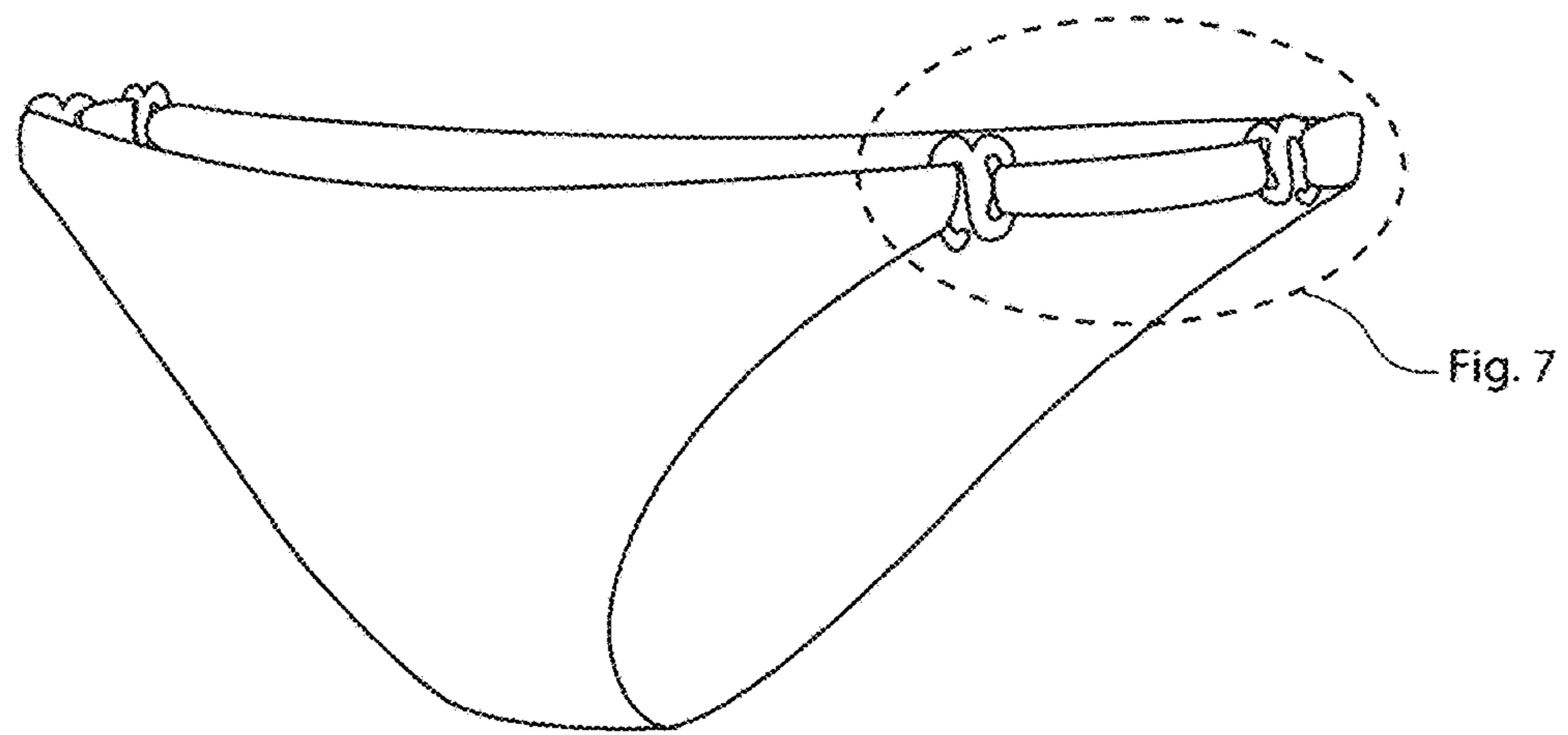

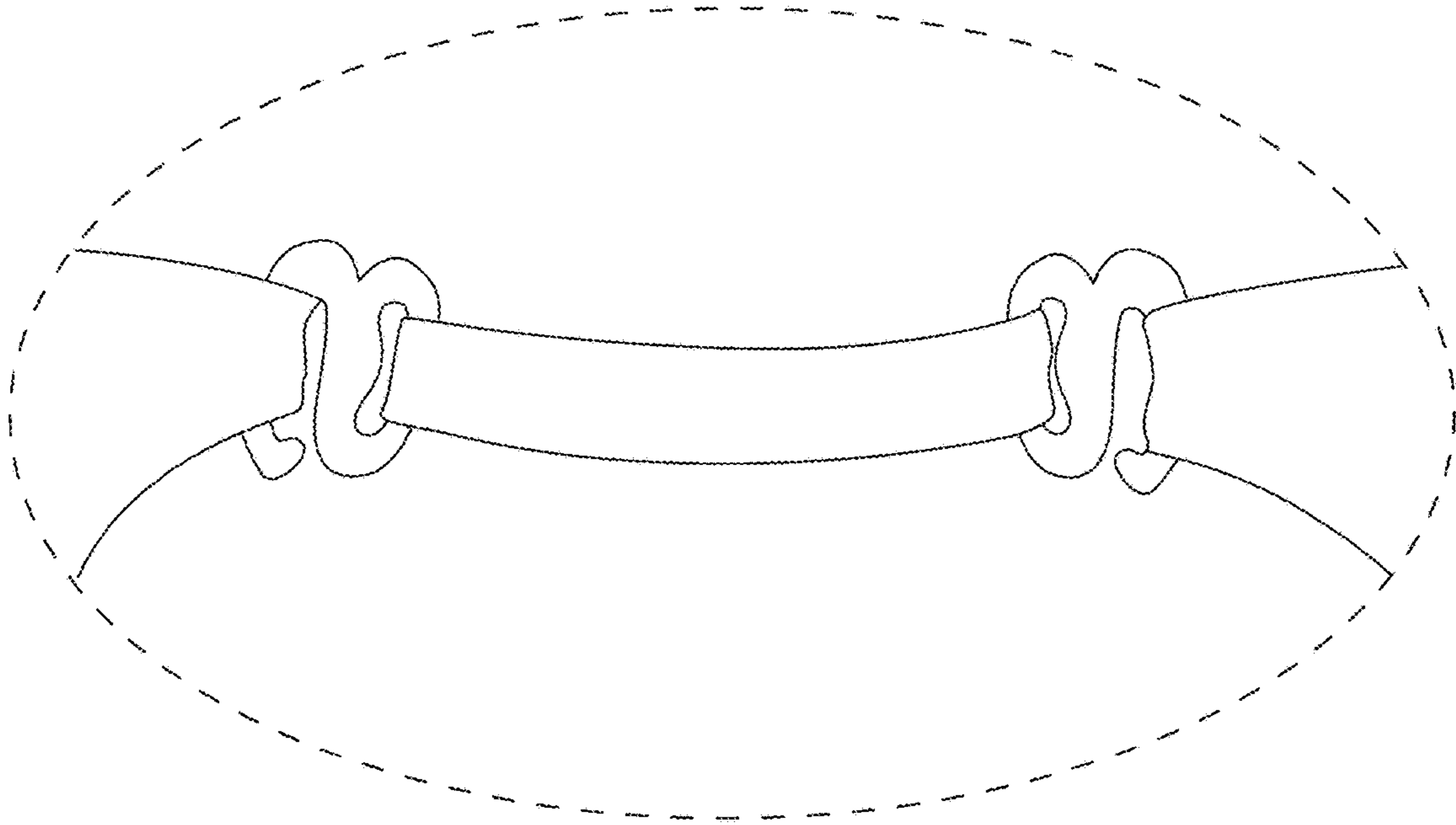
