FIG. 15 is a left side view thereof;

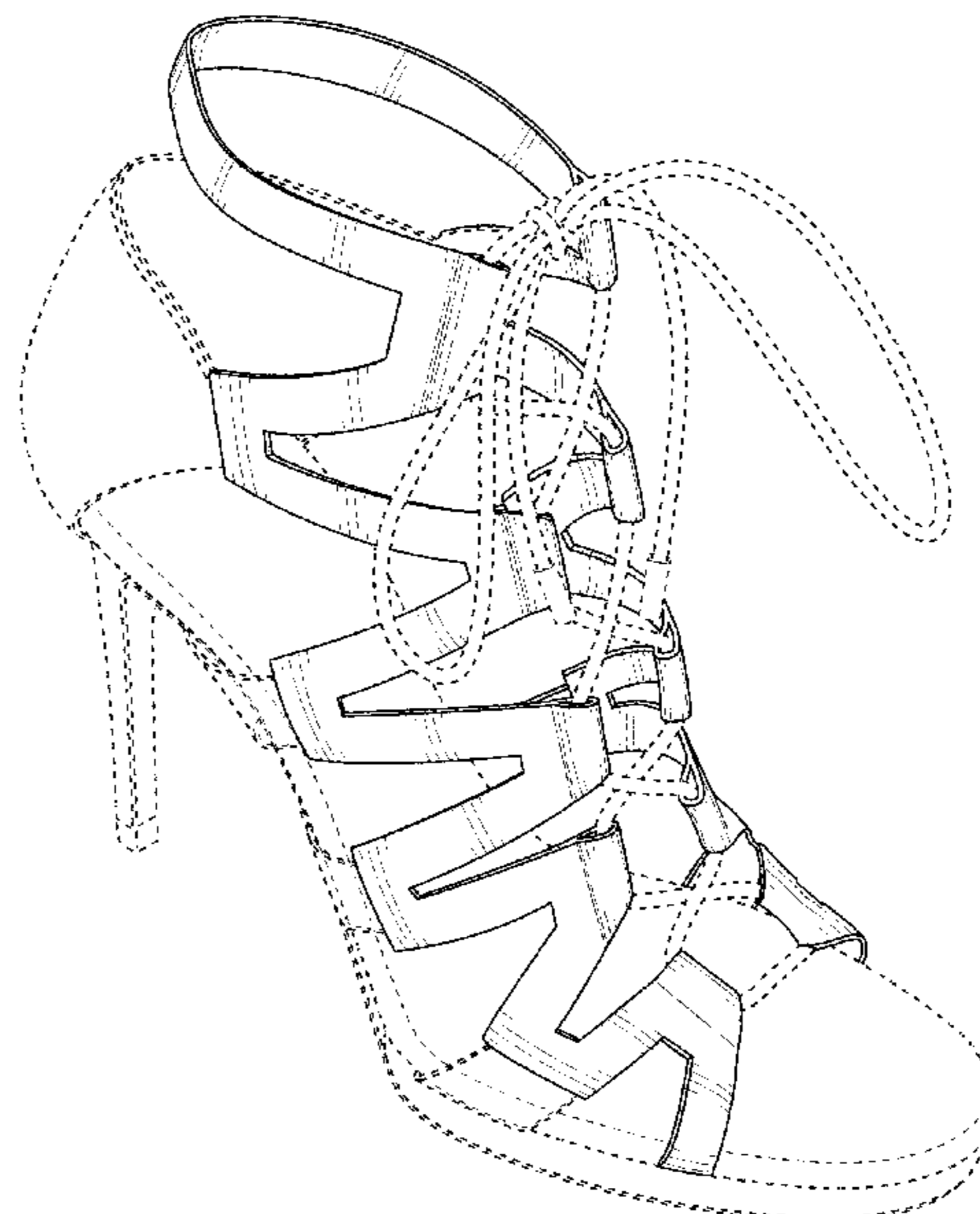
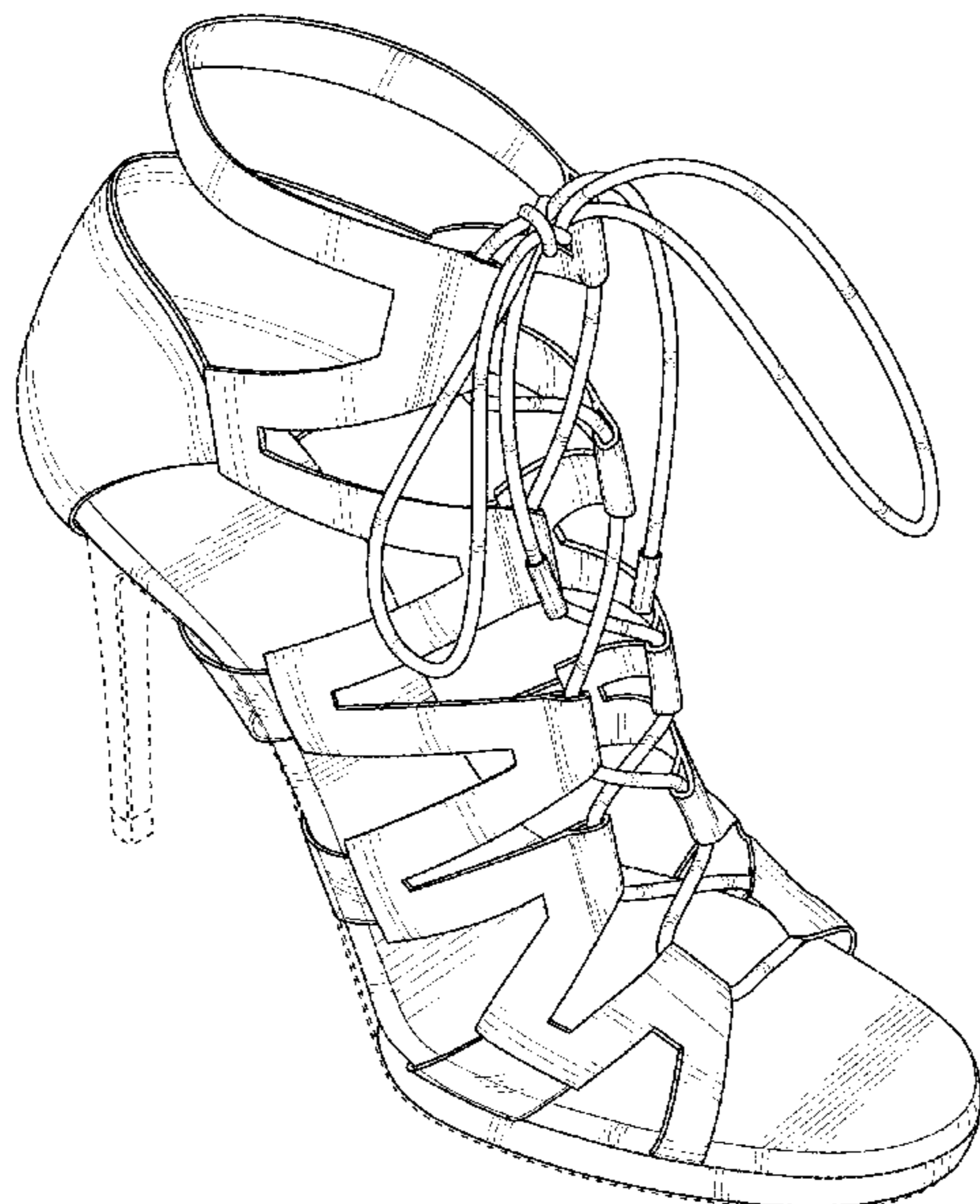
FIG. 16 is a front view thereof;

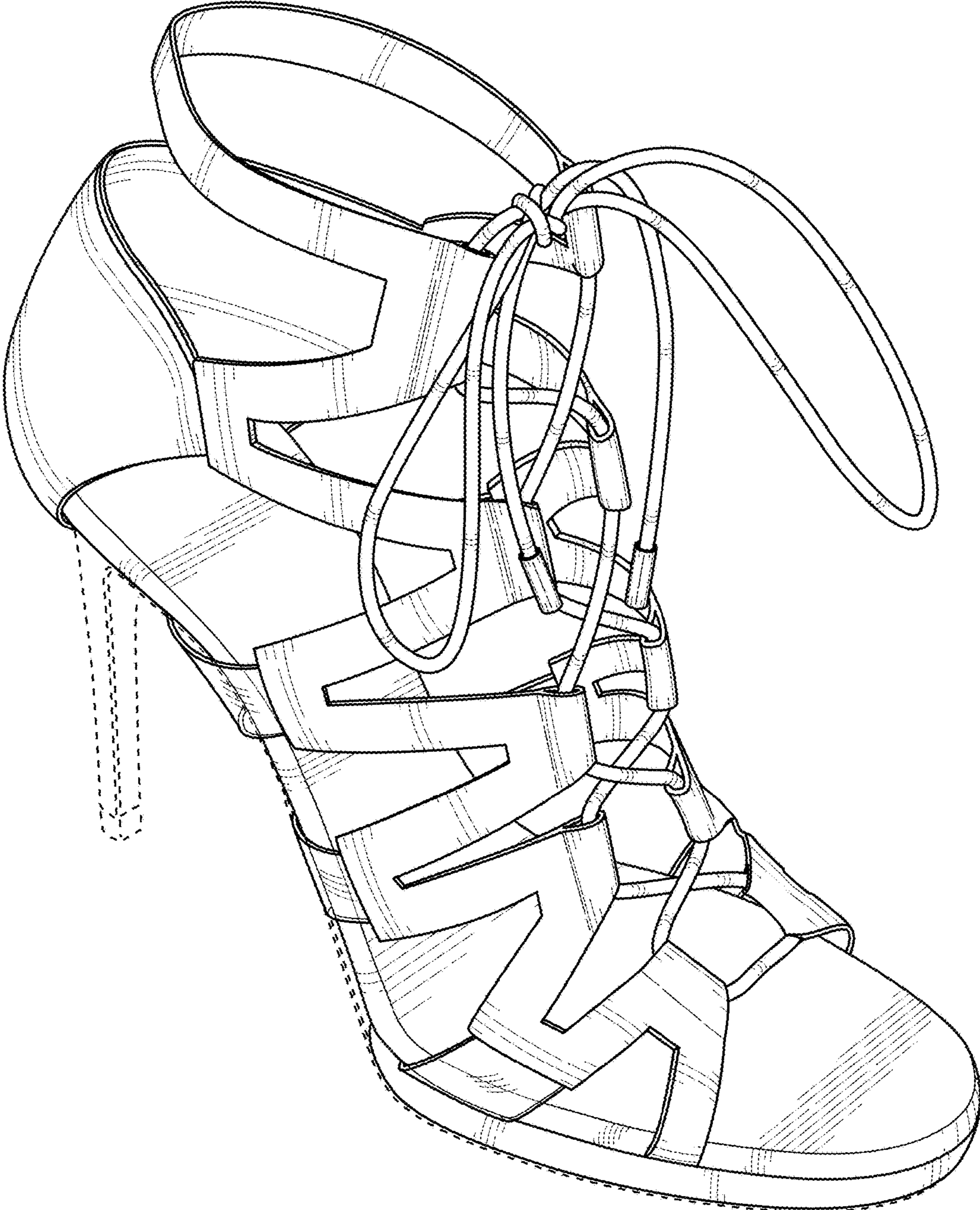

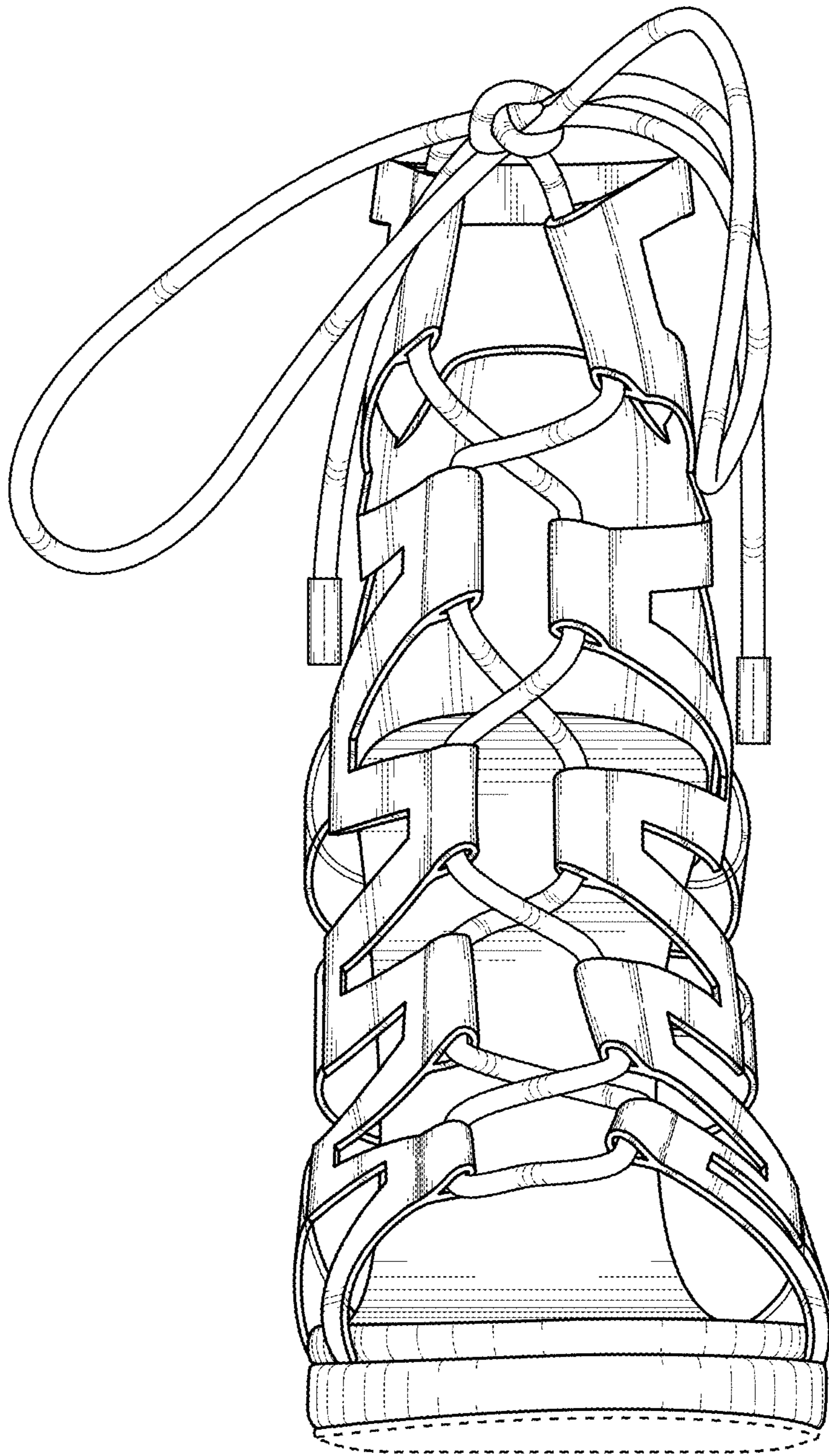

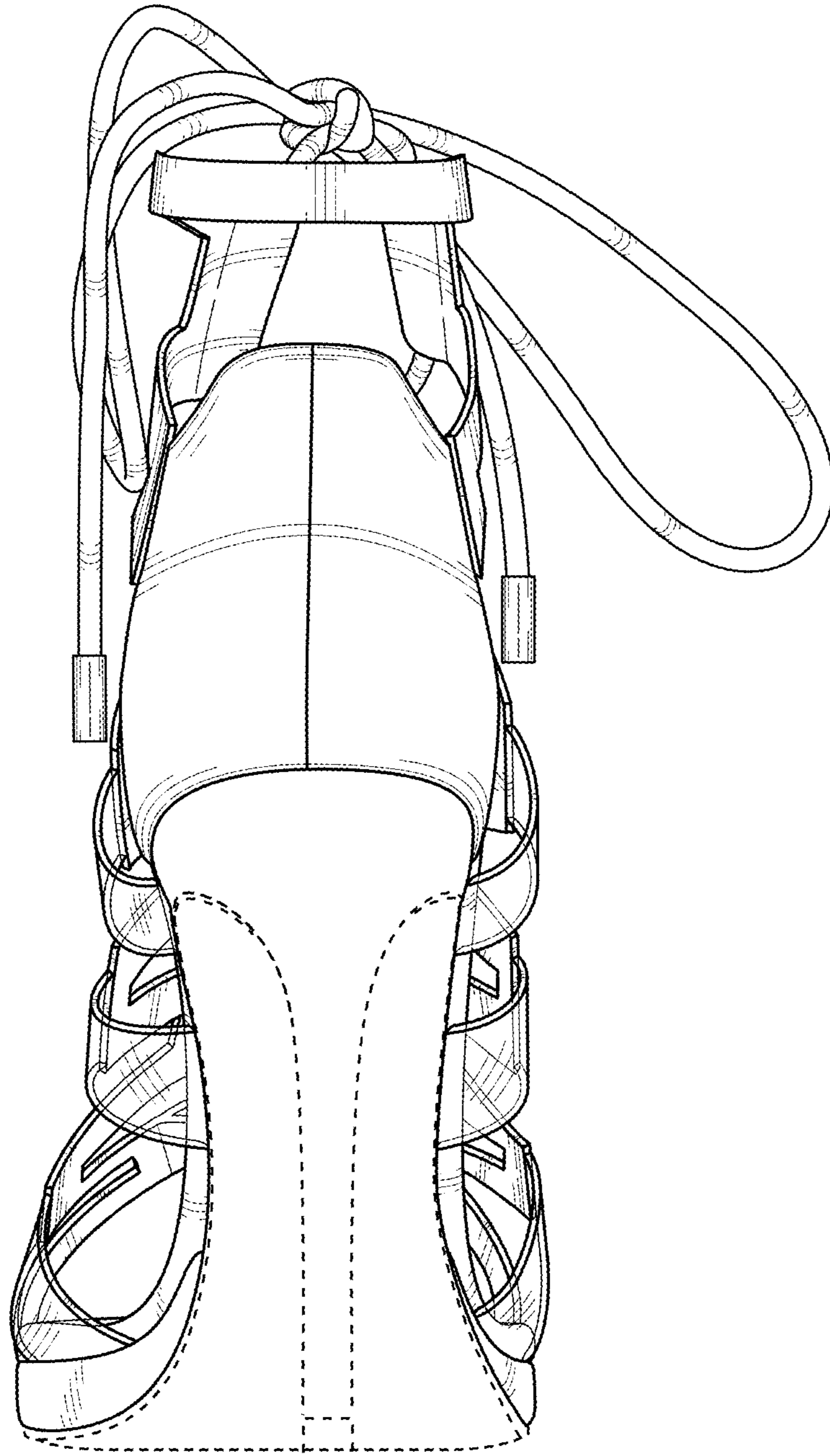

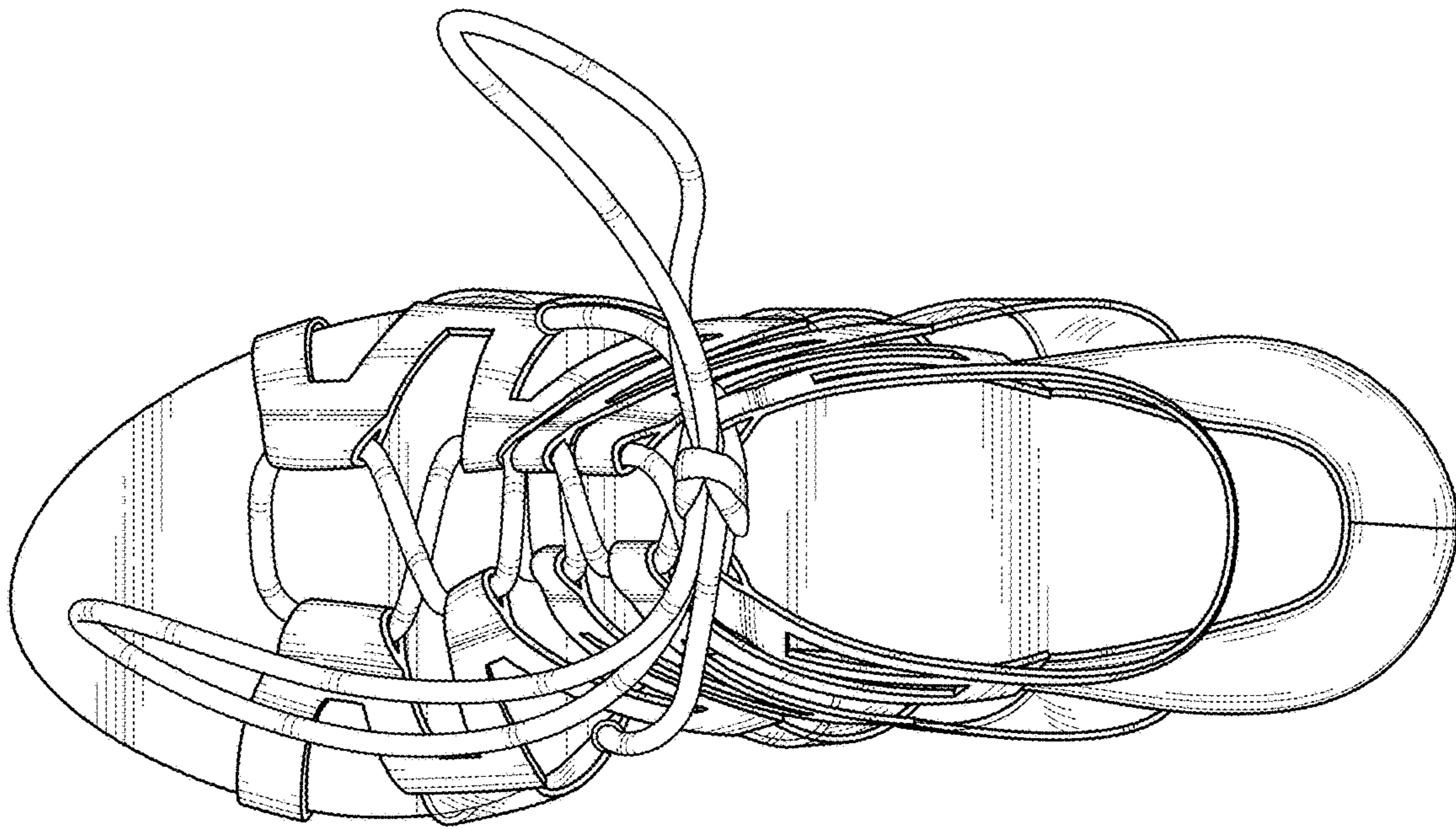

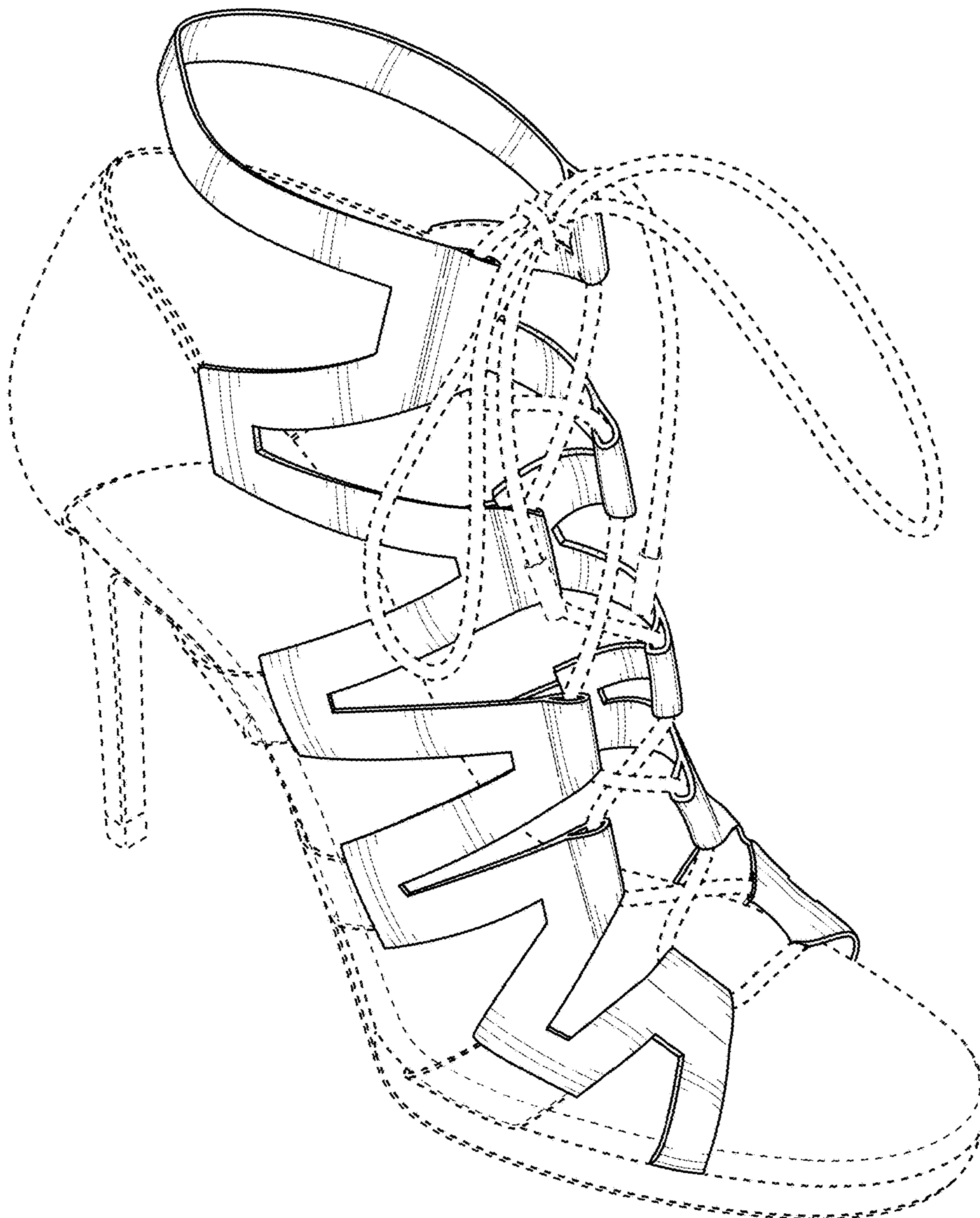

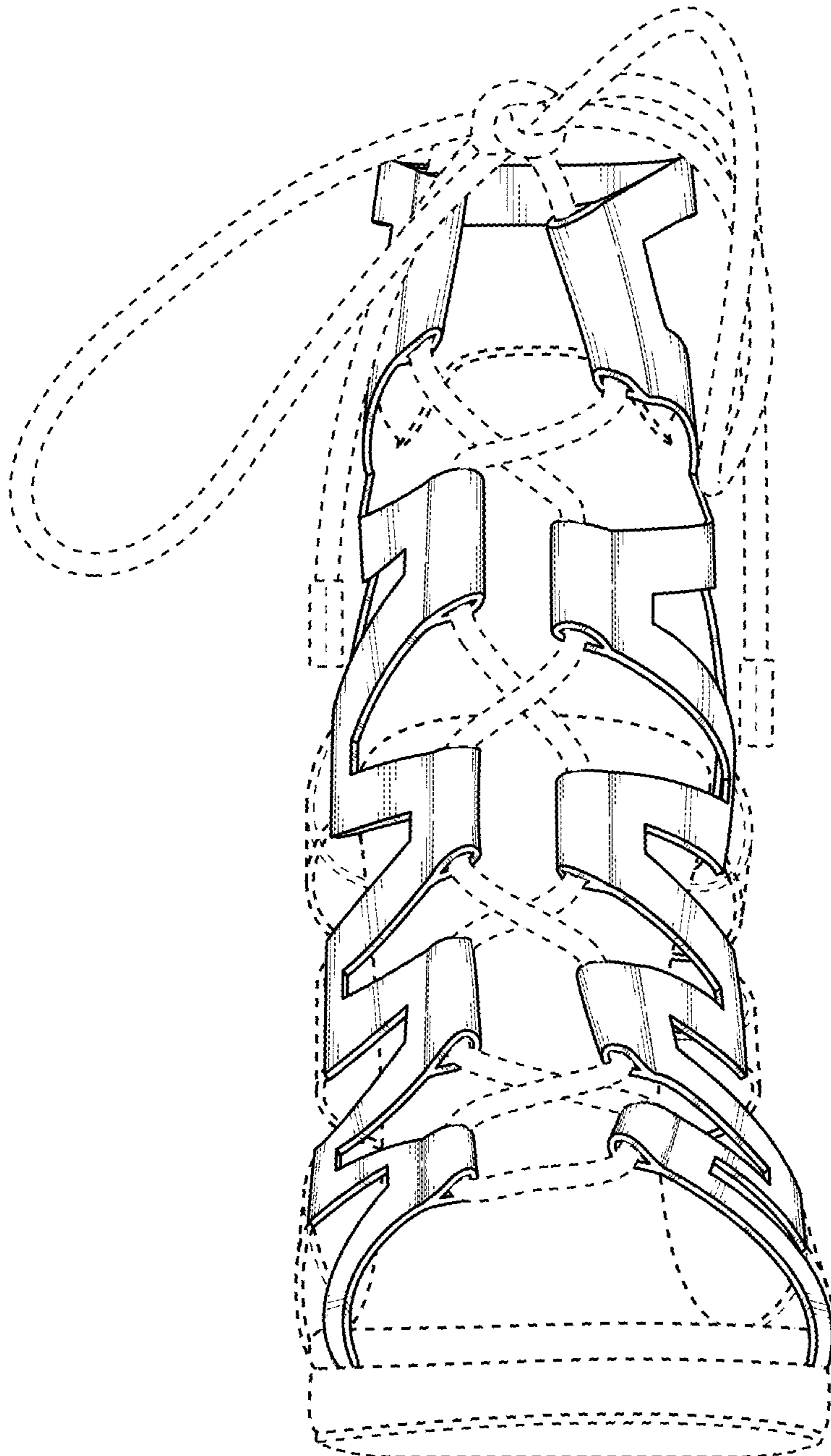

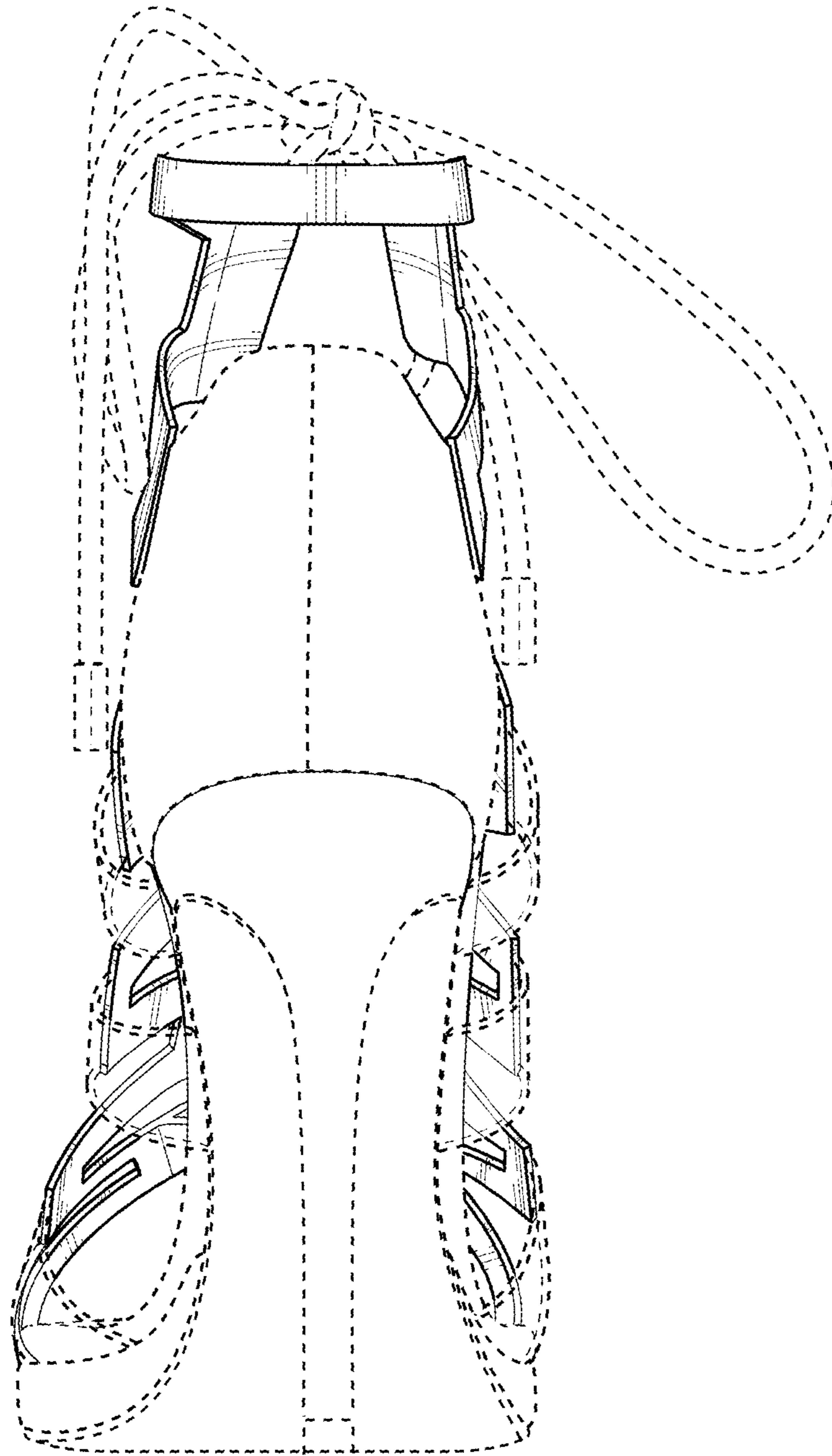

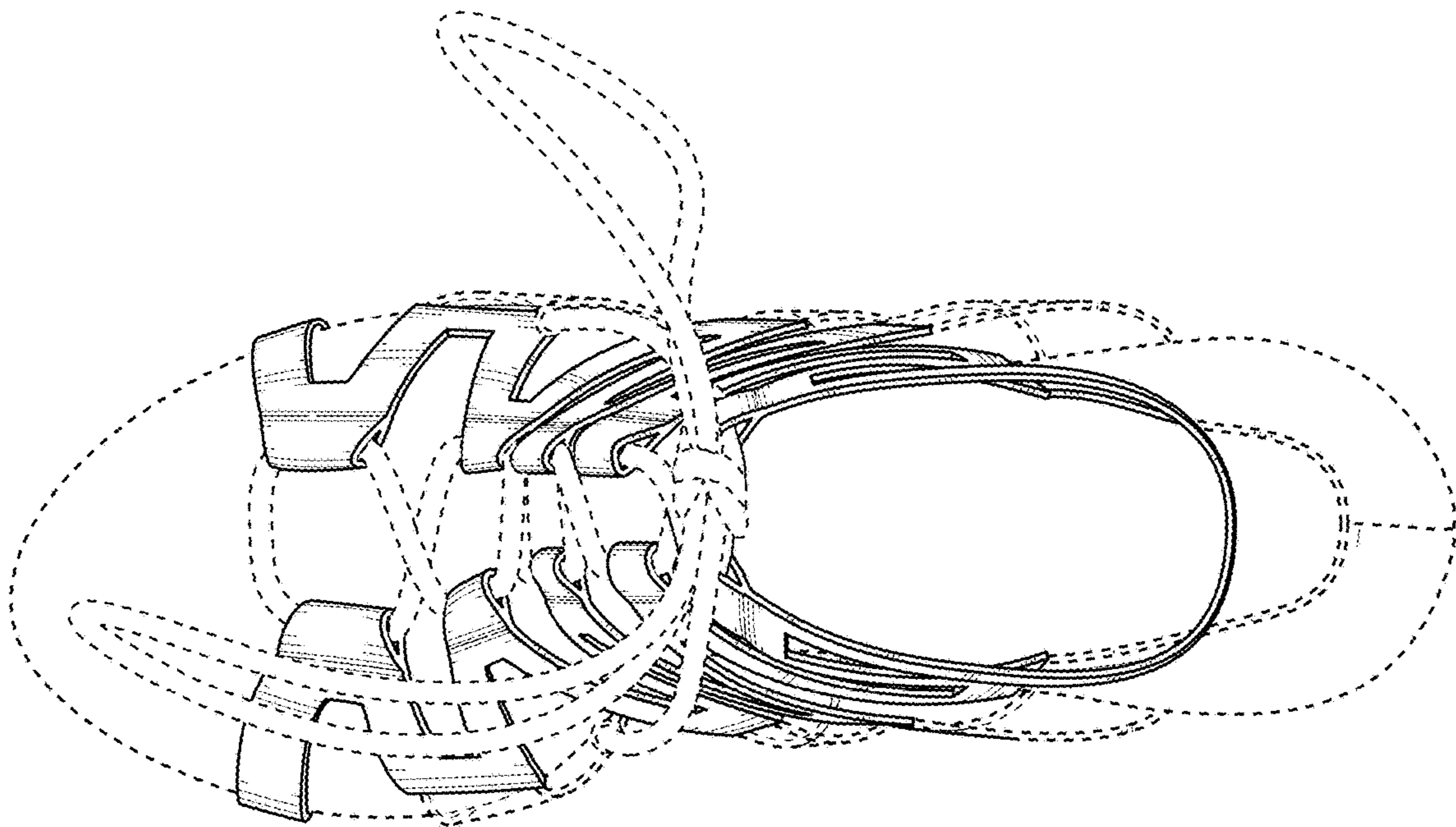

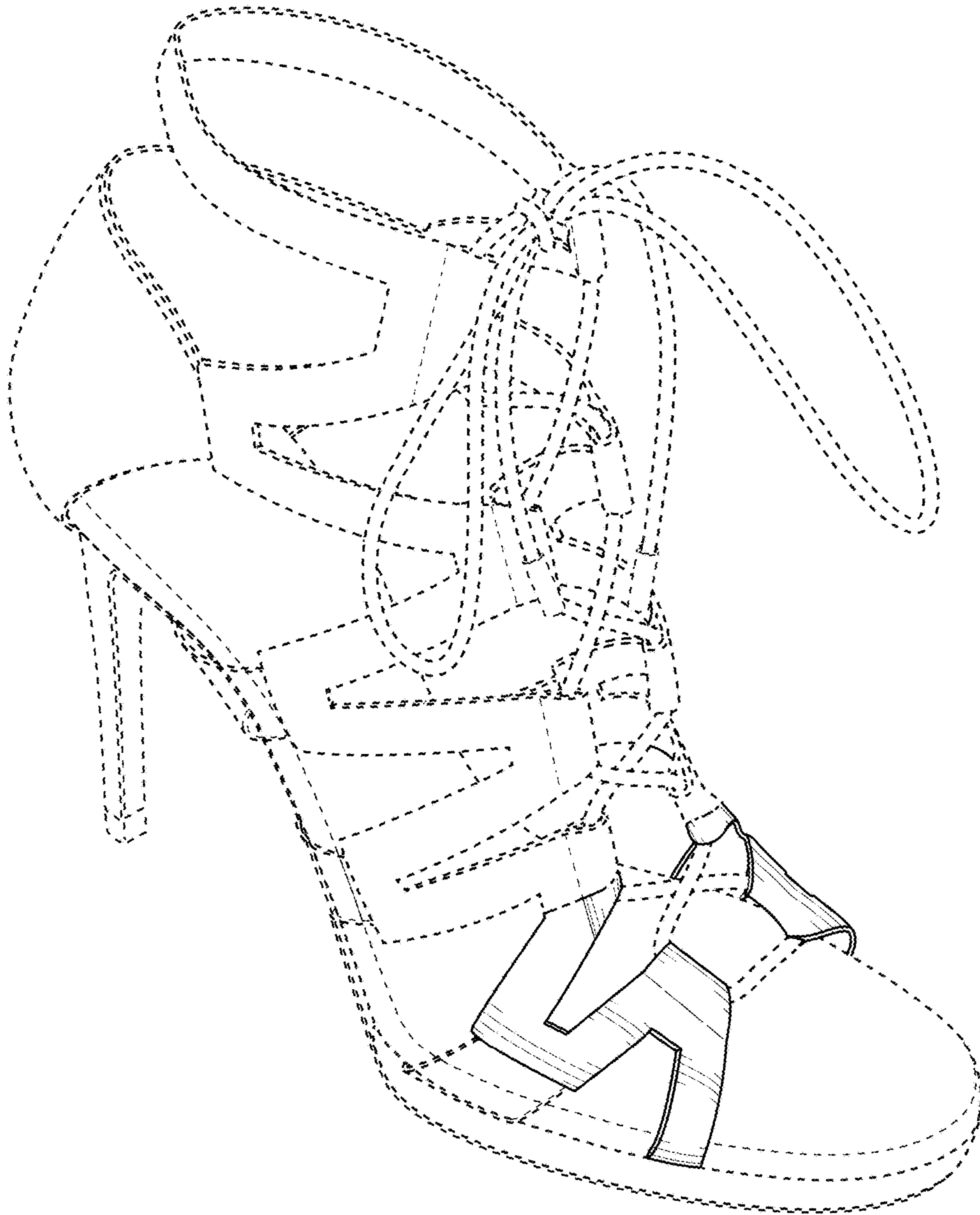

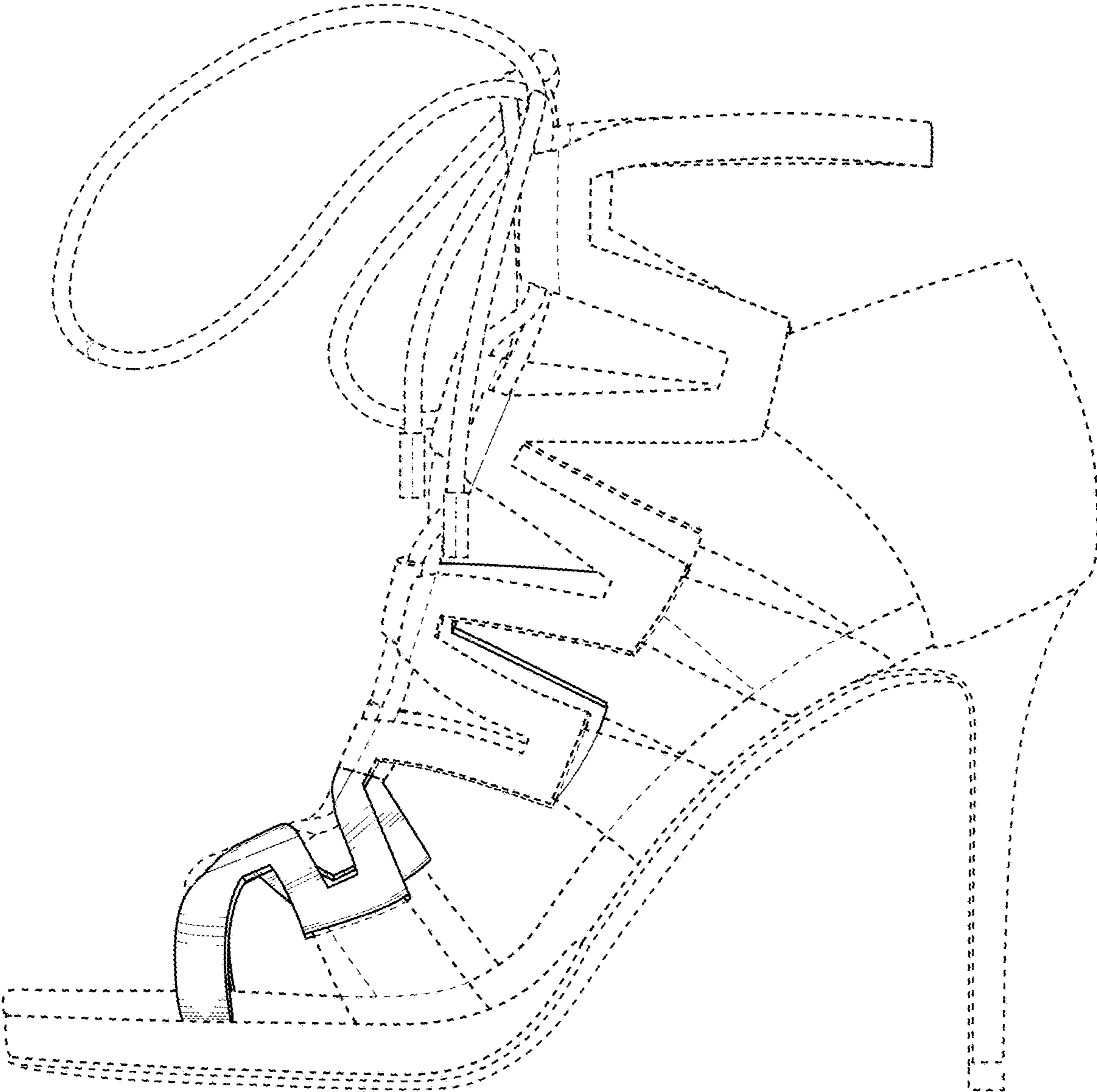

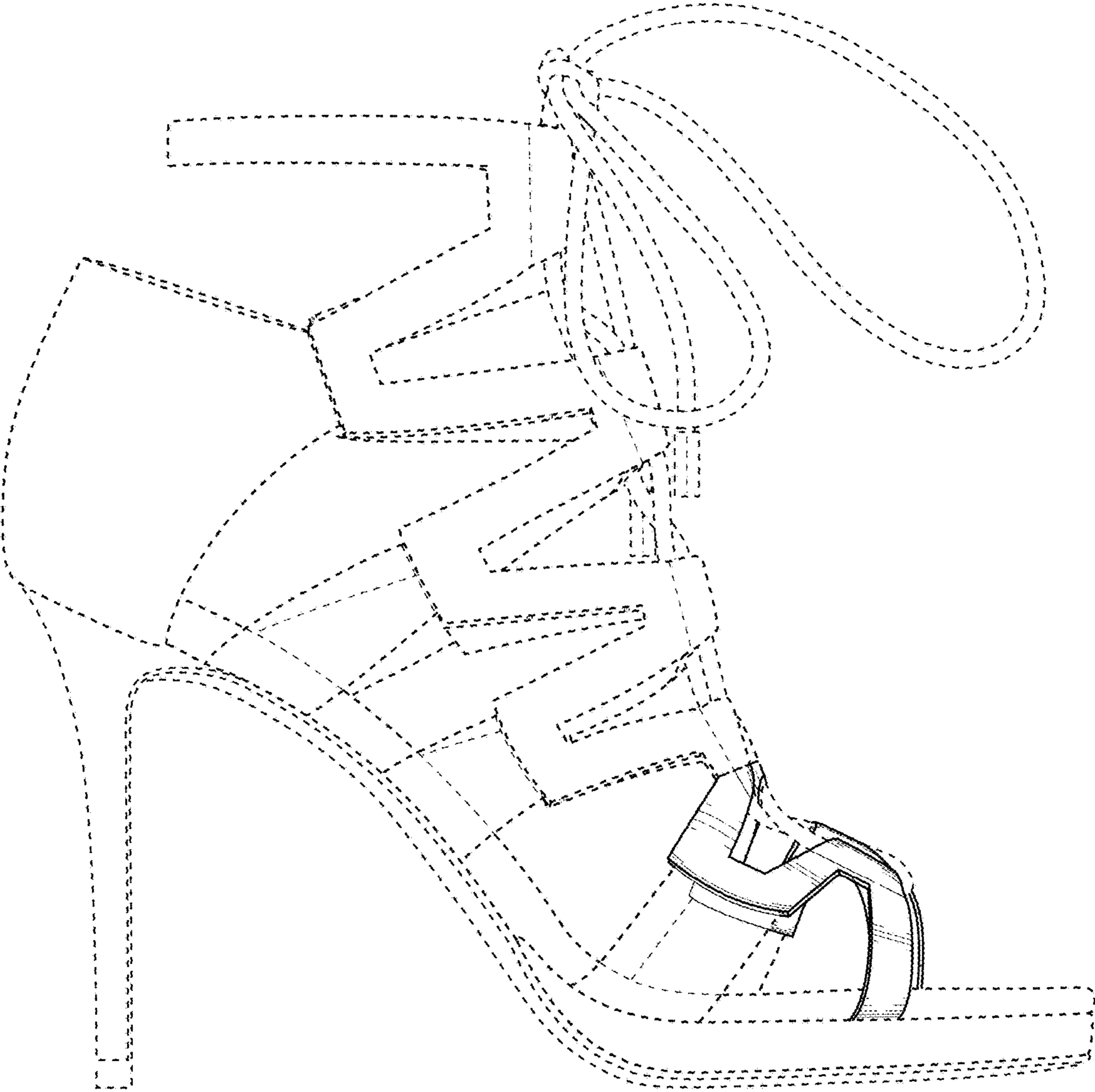

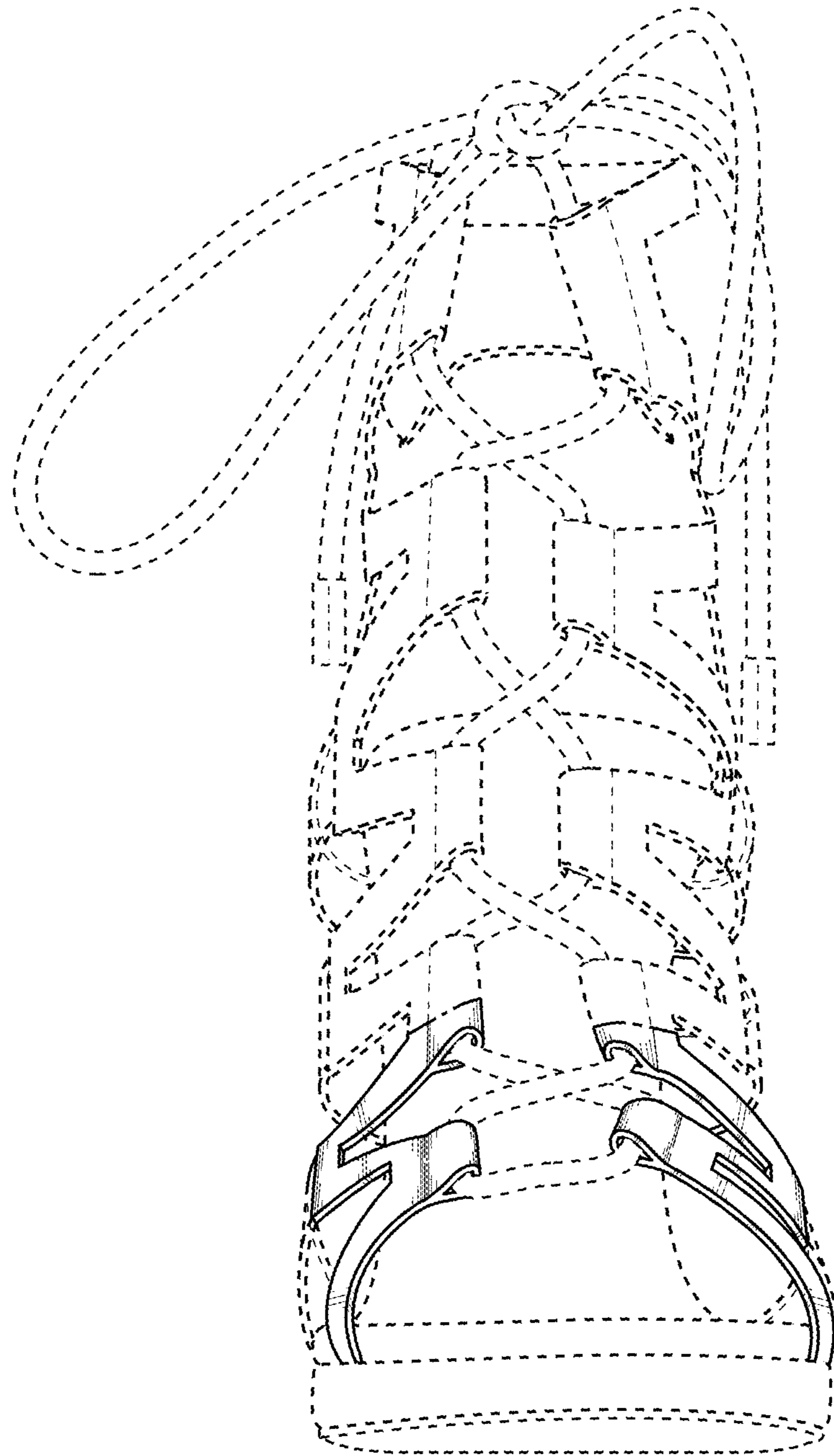

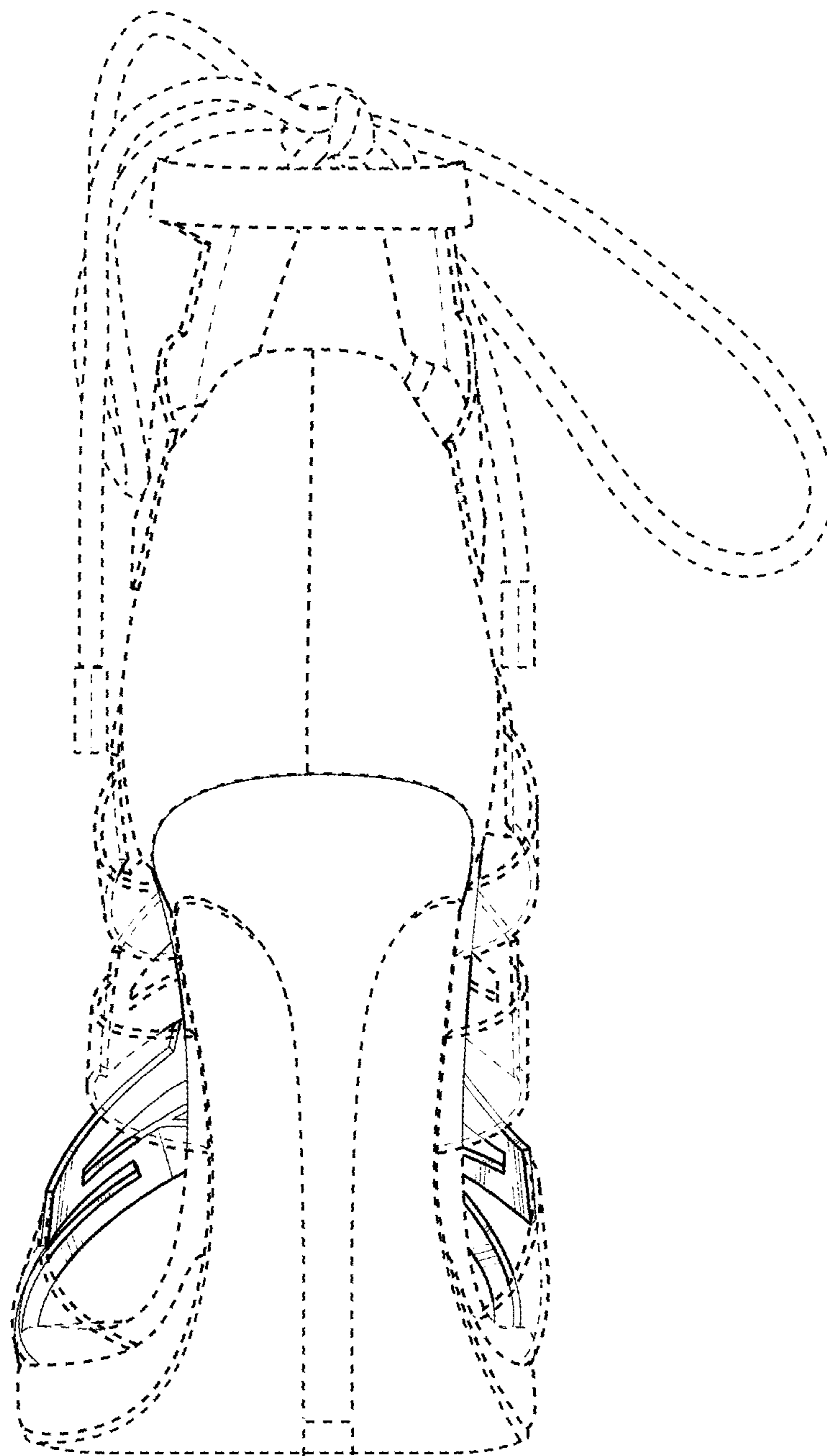

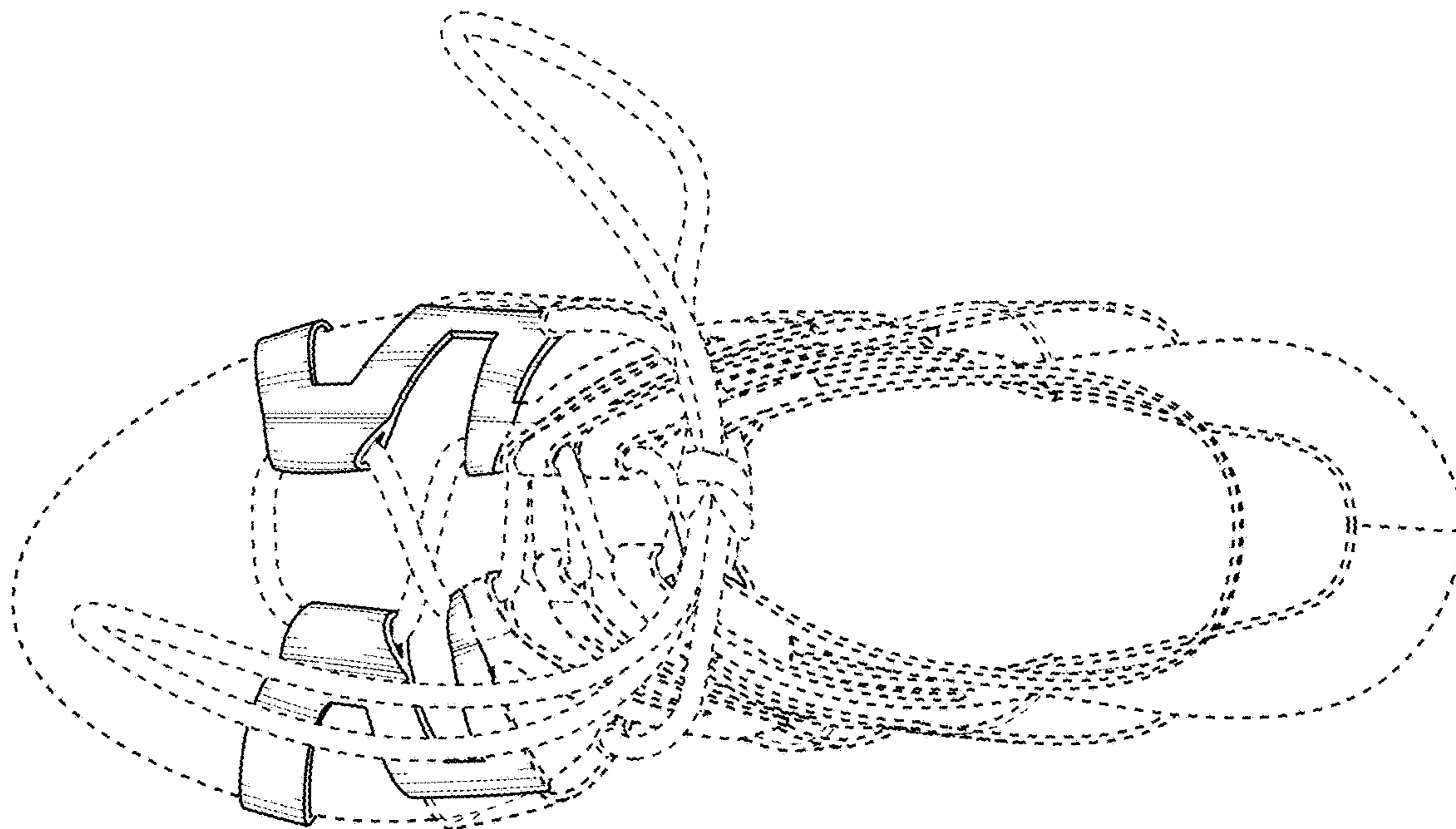
