(57) **CLAIM**

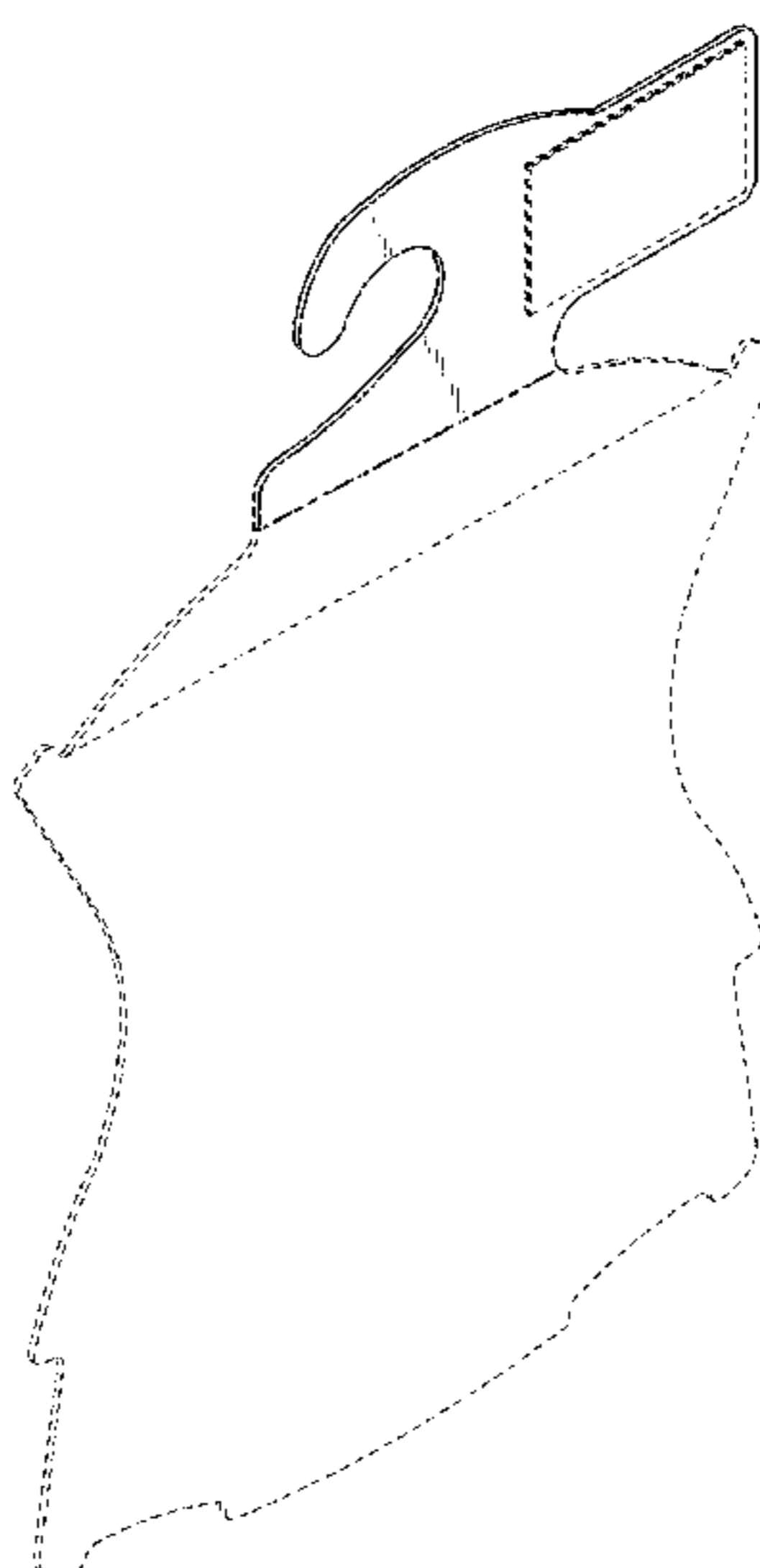
The ornamental design for a hanger, as shown and described.

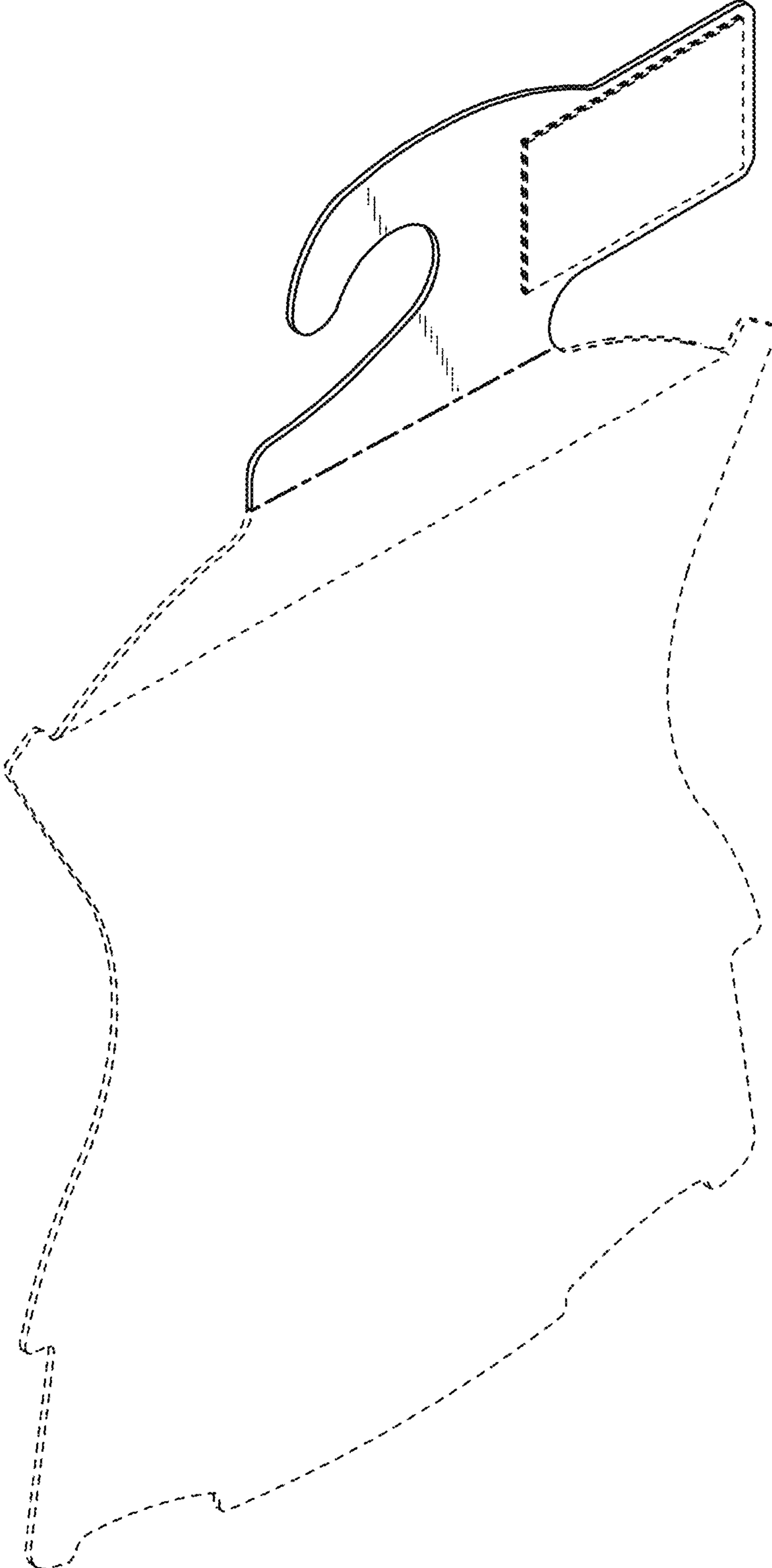

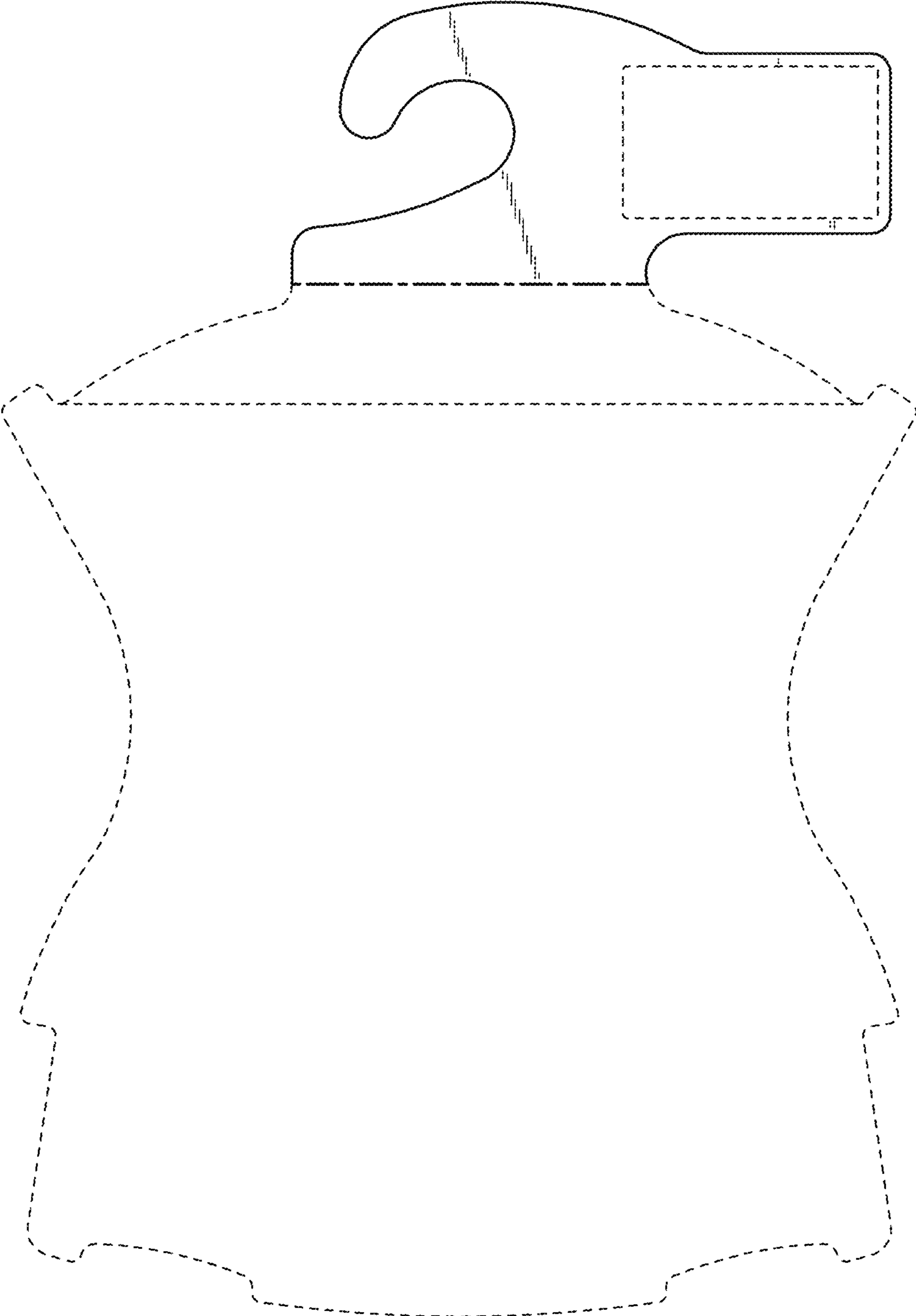
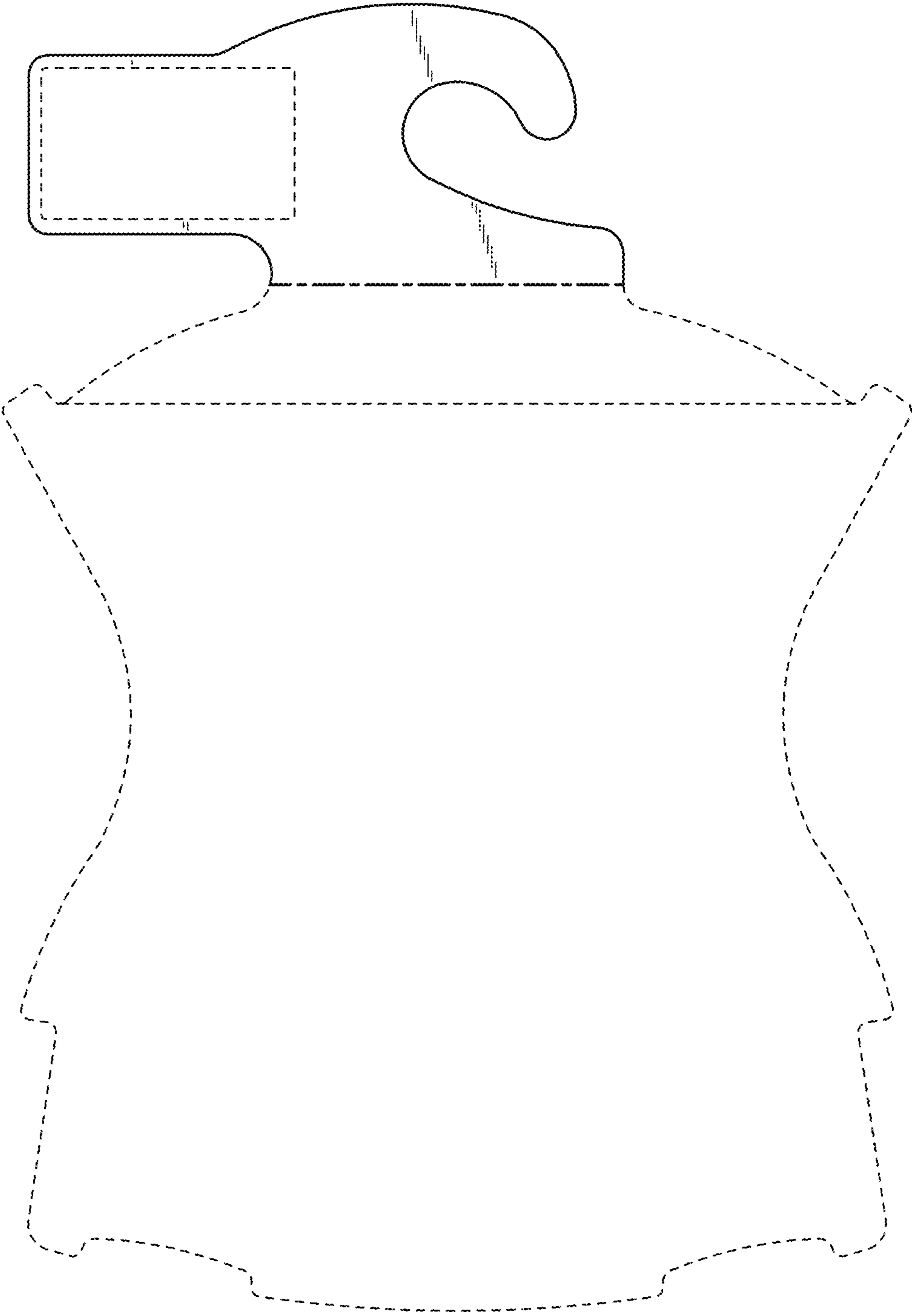

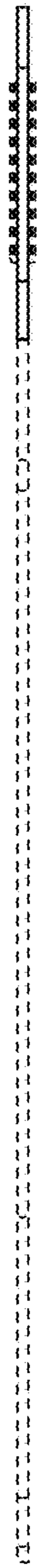

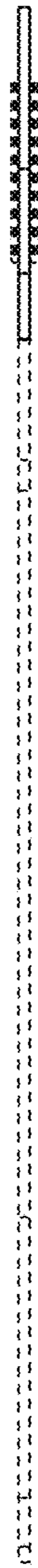

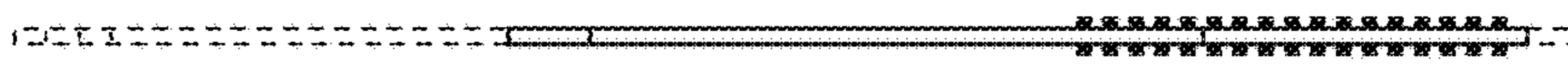
