The ornamental design for a golf cart seat cover, as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view of a golf cart seat cover on a golf
cart including a golf seat portion and golf seat-back portion;
FIG. 2 is a perspective view of a golf cart seat cover on a golf
cart;
FIG. 3 is a top view of a golf seat portion configured on a
golf seat support, shown separately from the golf seat-back
portion for ease of illustration;
FIG. 4 is a front view of a golf seat portion configured on a
golf seat support, shown separately from the golf seat-back
portion for ease of illustration;
FIG. 5 is a back view of a golf seat portion configured on a
golf seat support, shown separately from the golf seat-back
portion for ease of illustration;
FIG. 6 is a bottom view of a golf seat portion configured on
a golf seat support, shown separately from the golf seat-back
portion for ease of illustration;
FIG. 7 is a perspective left side view of a golf seat portion
configured on a golf seat support, shown separately from the
golf seat-back portion for ease of illustration;
FIG. 8 is a perspective right side view of a golf seat portion

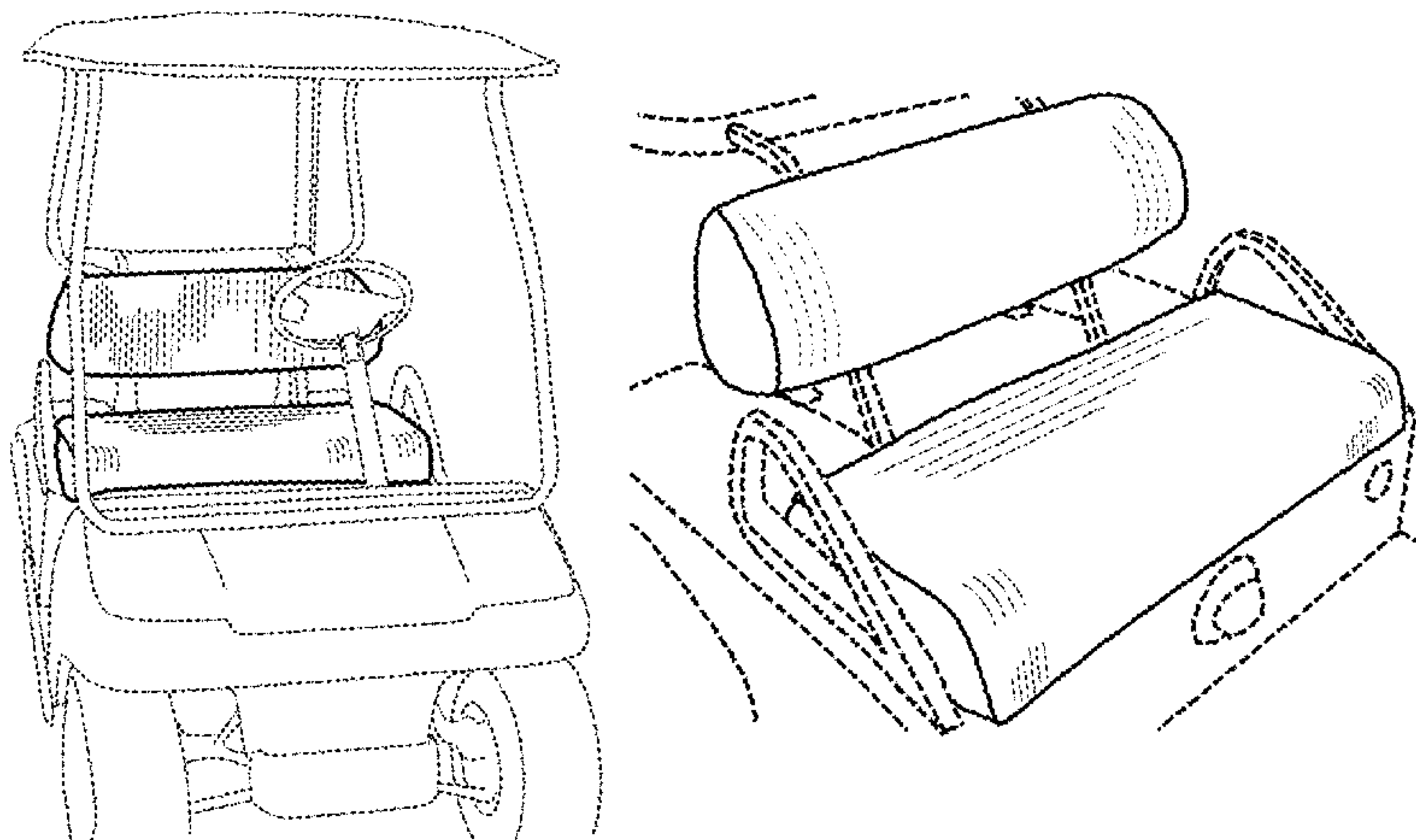

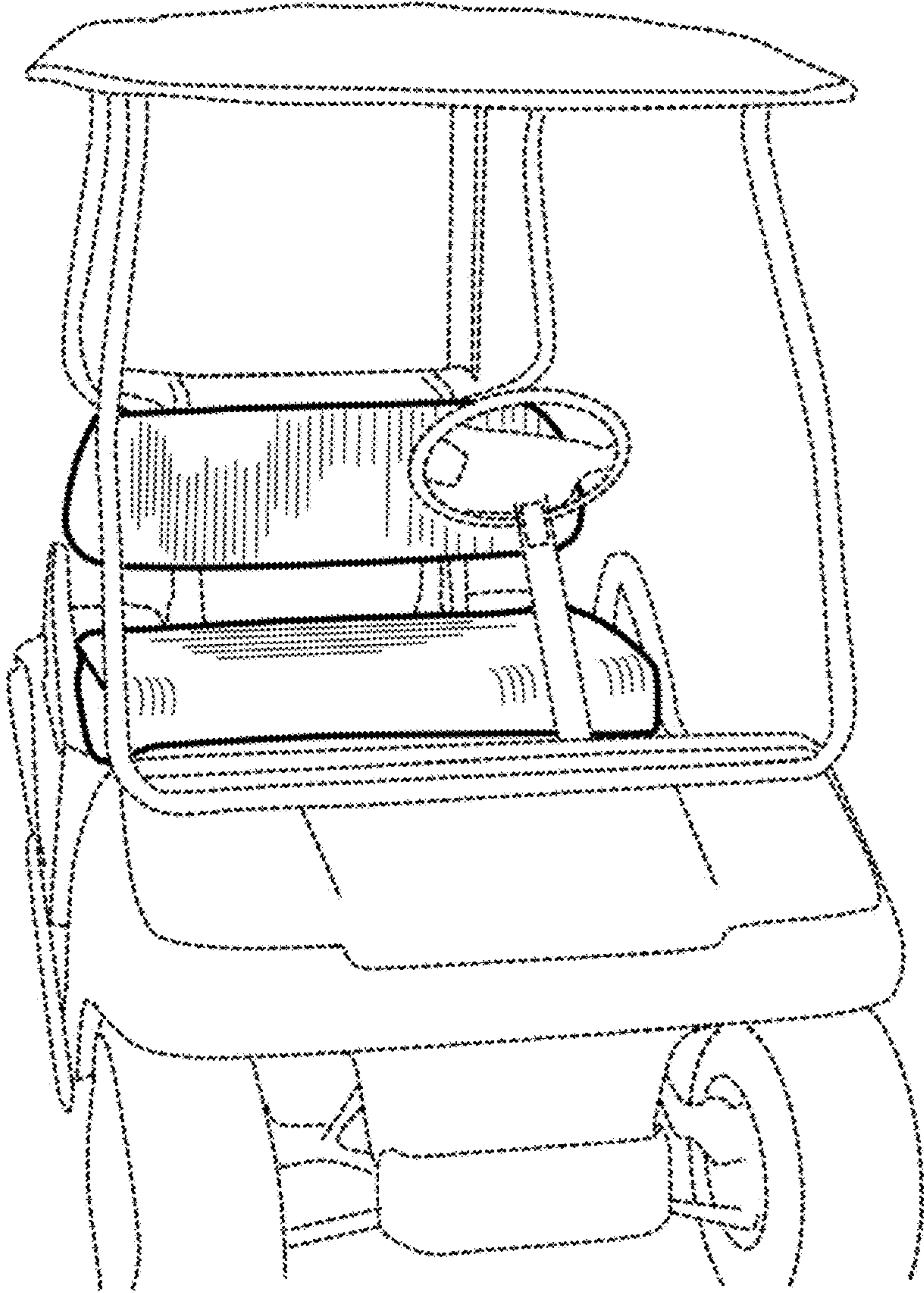

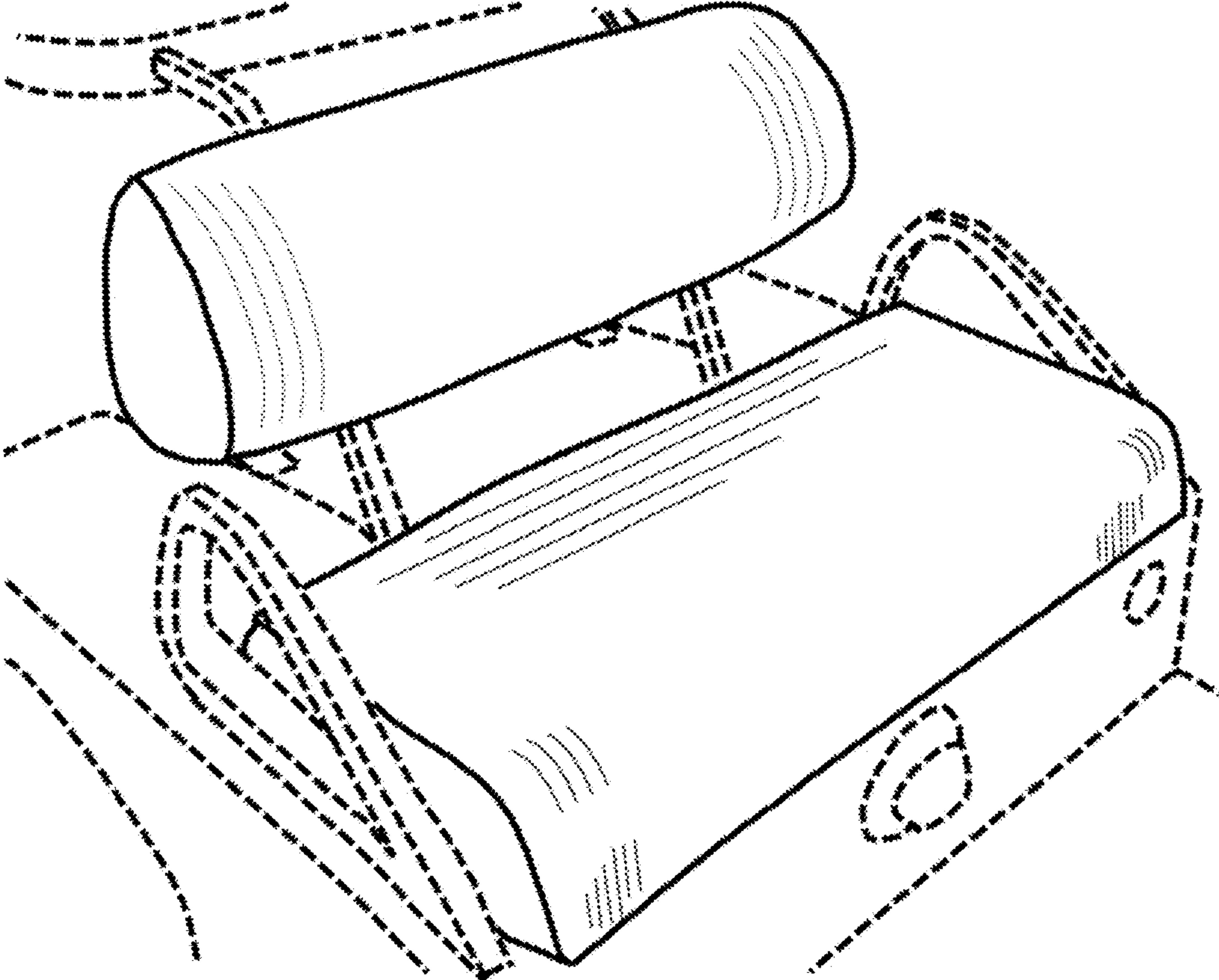

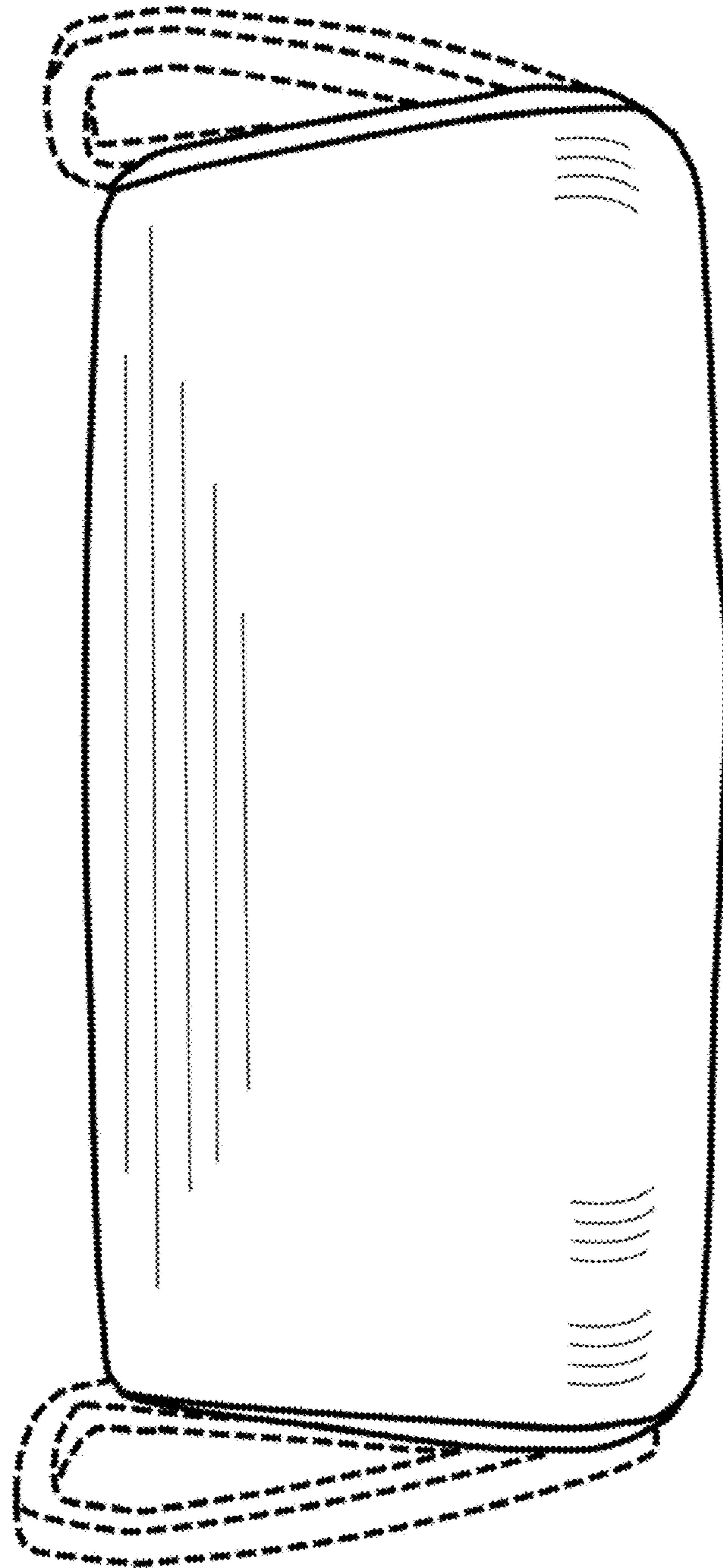

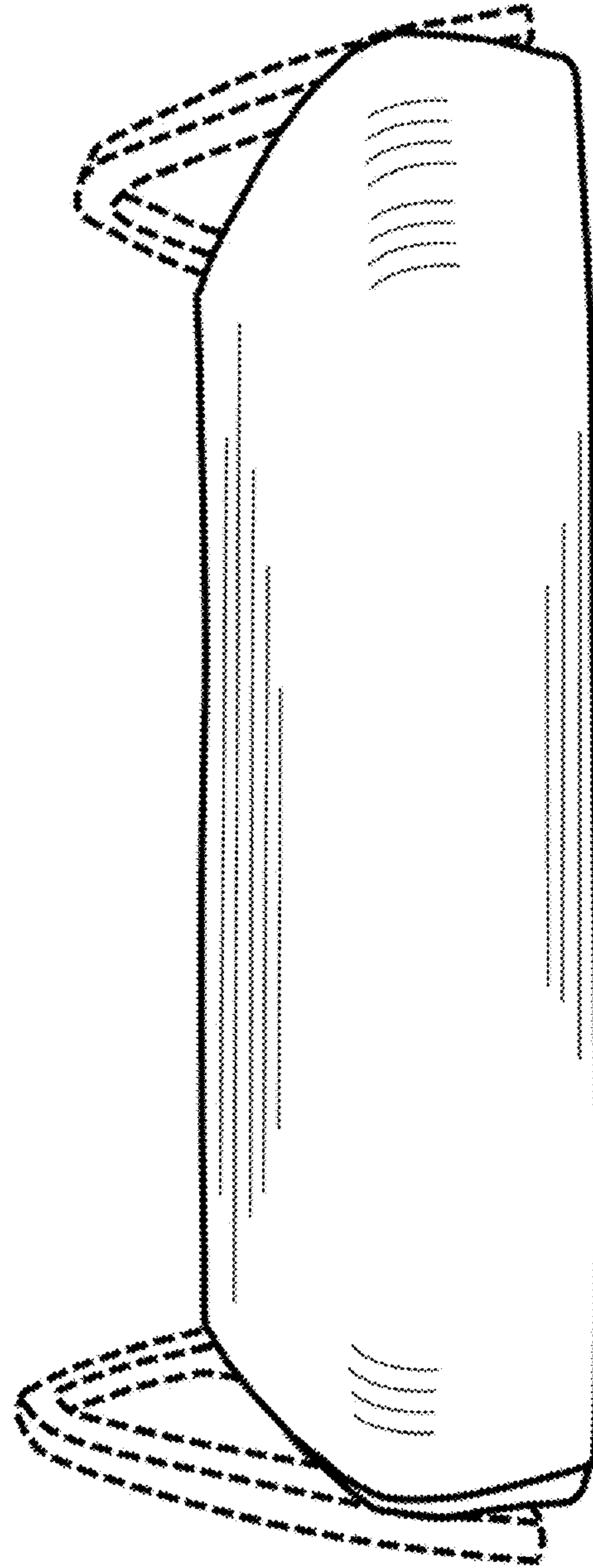

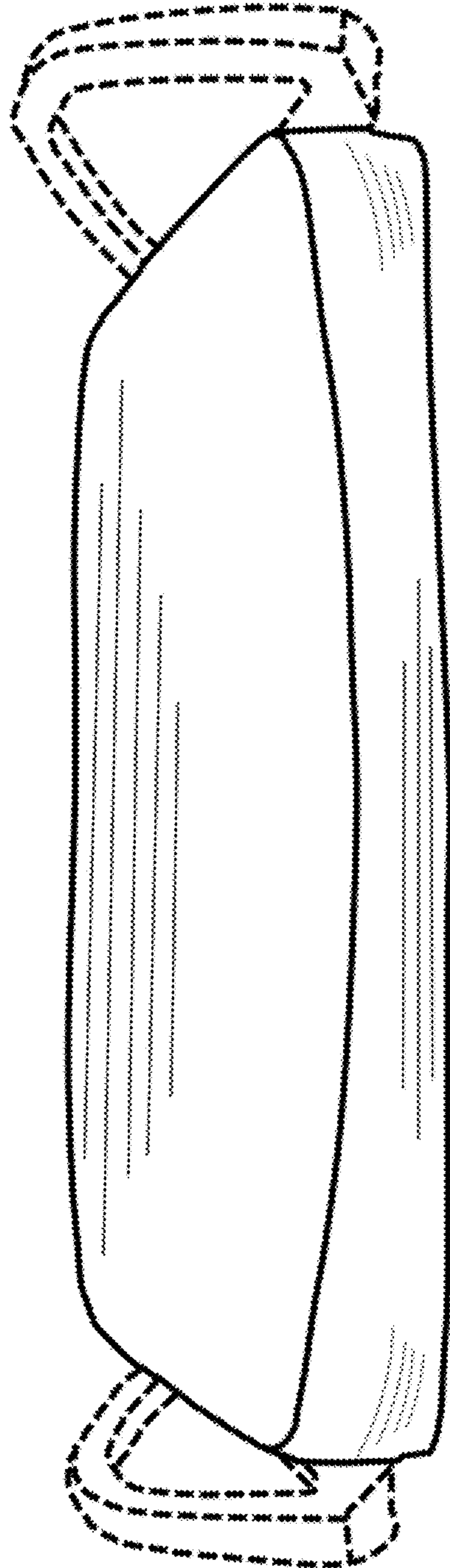

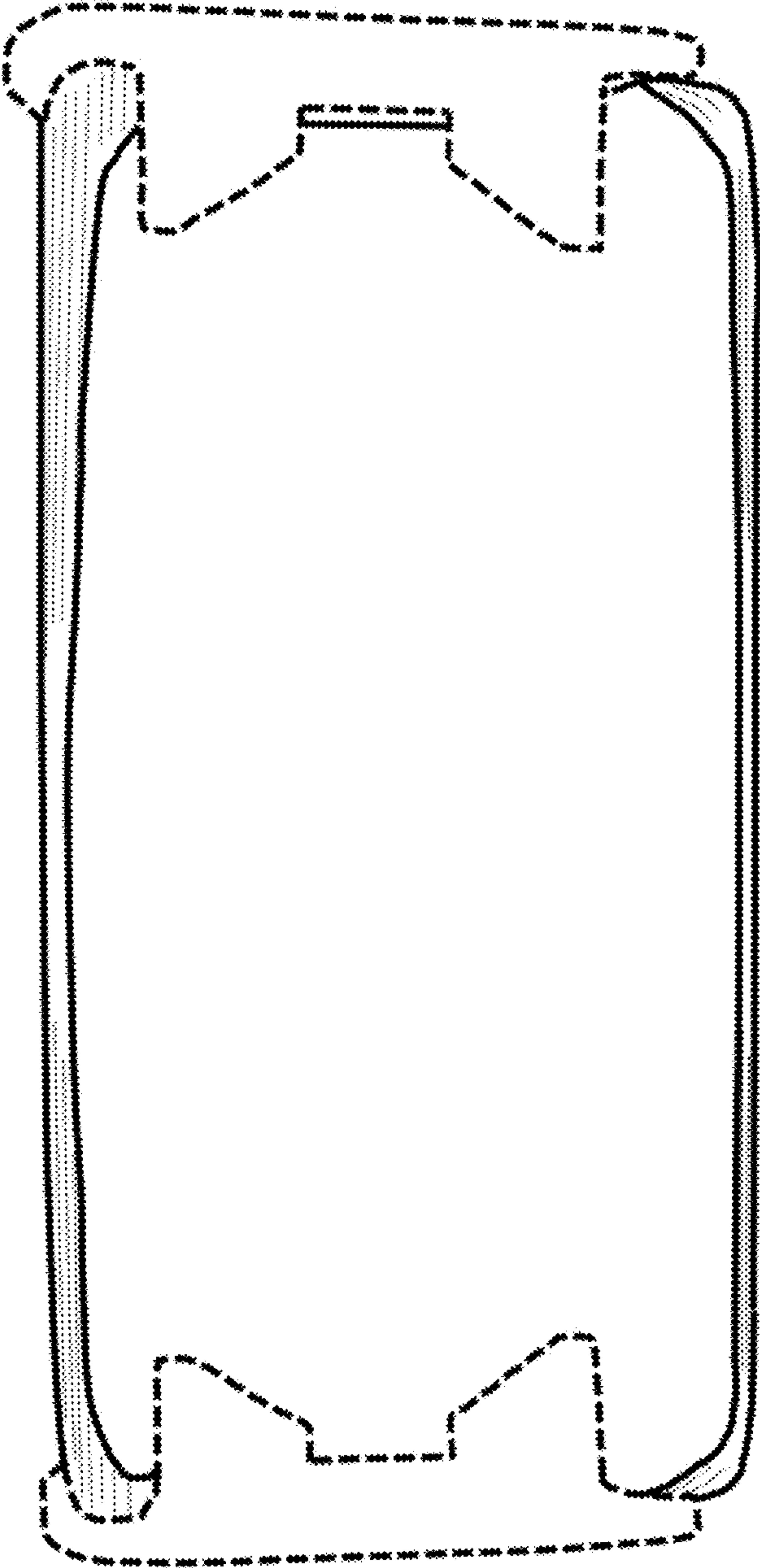

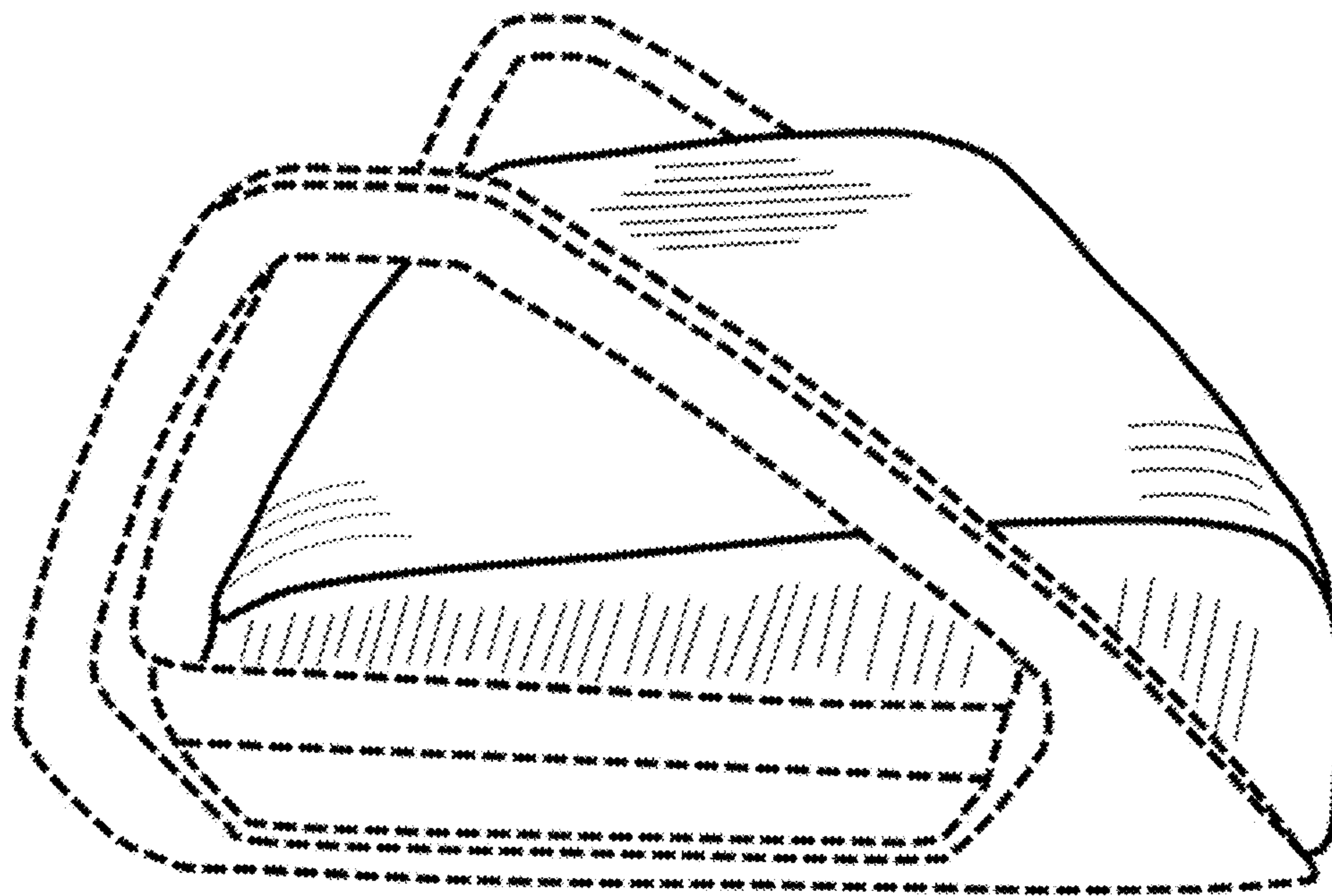

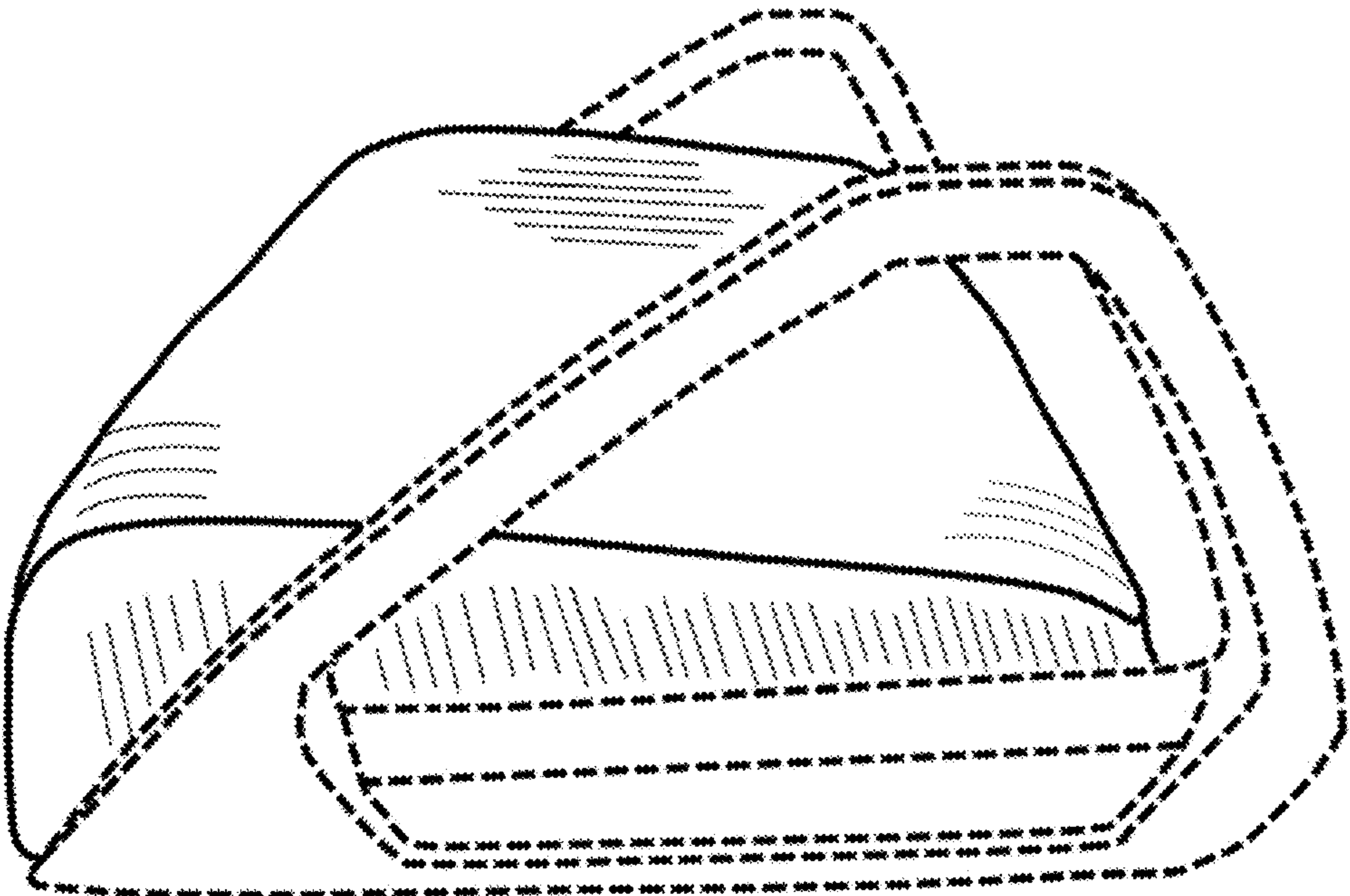

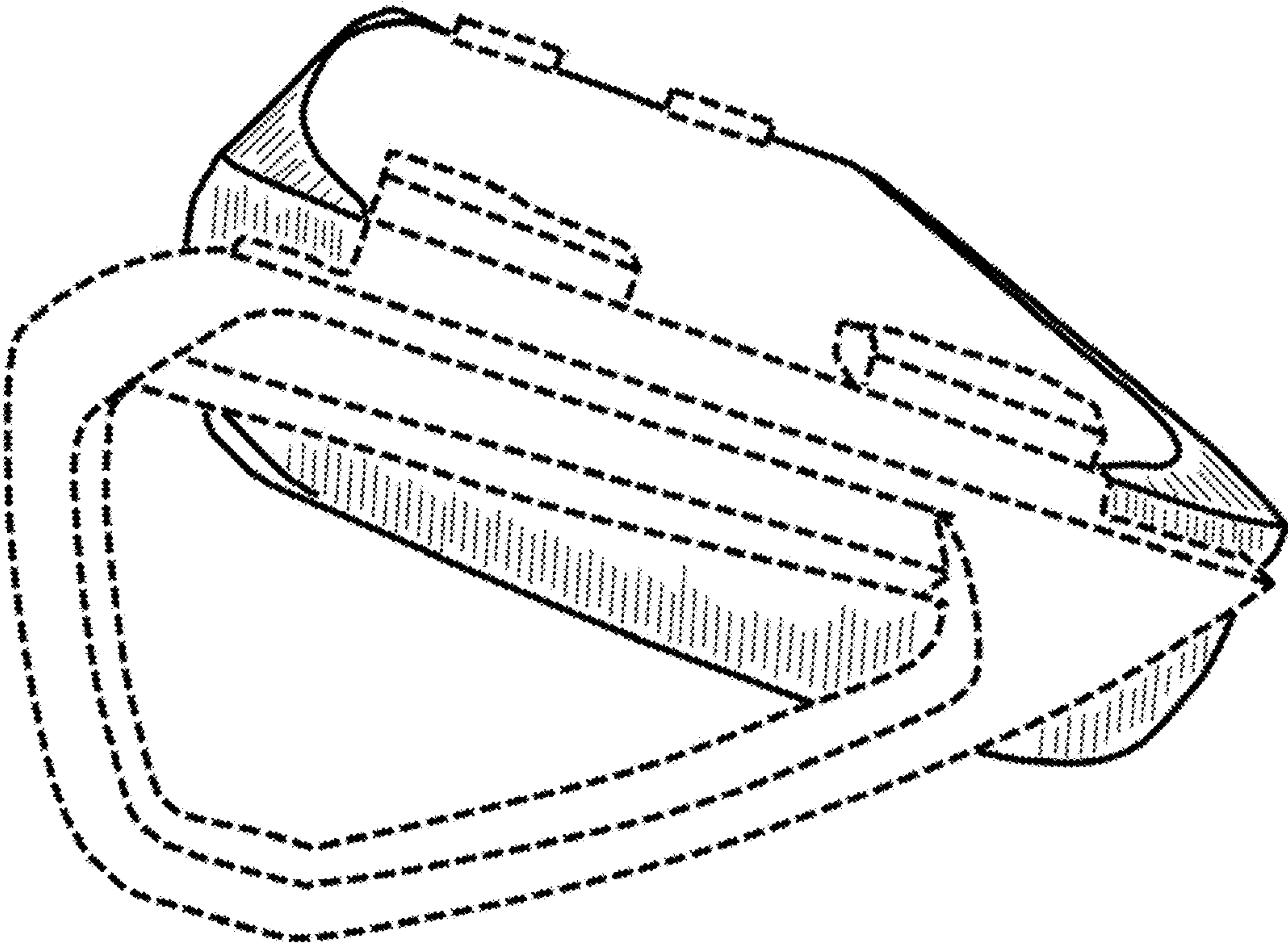

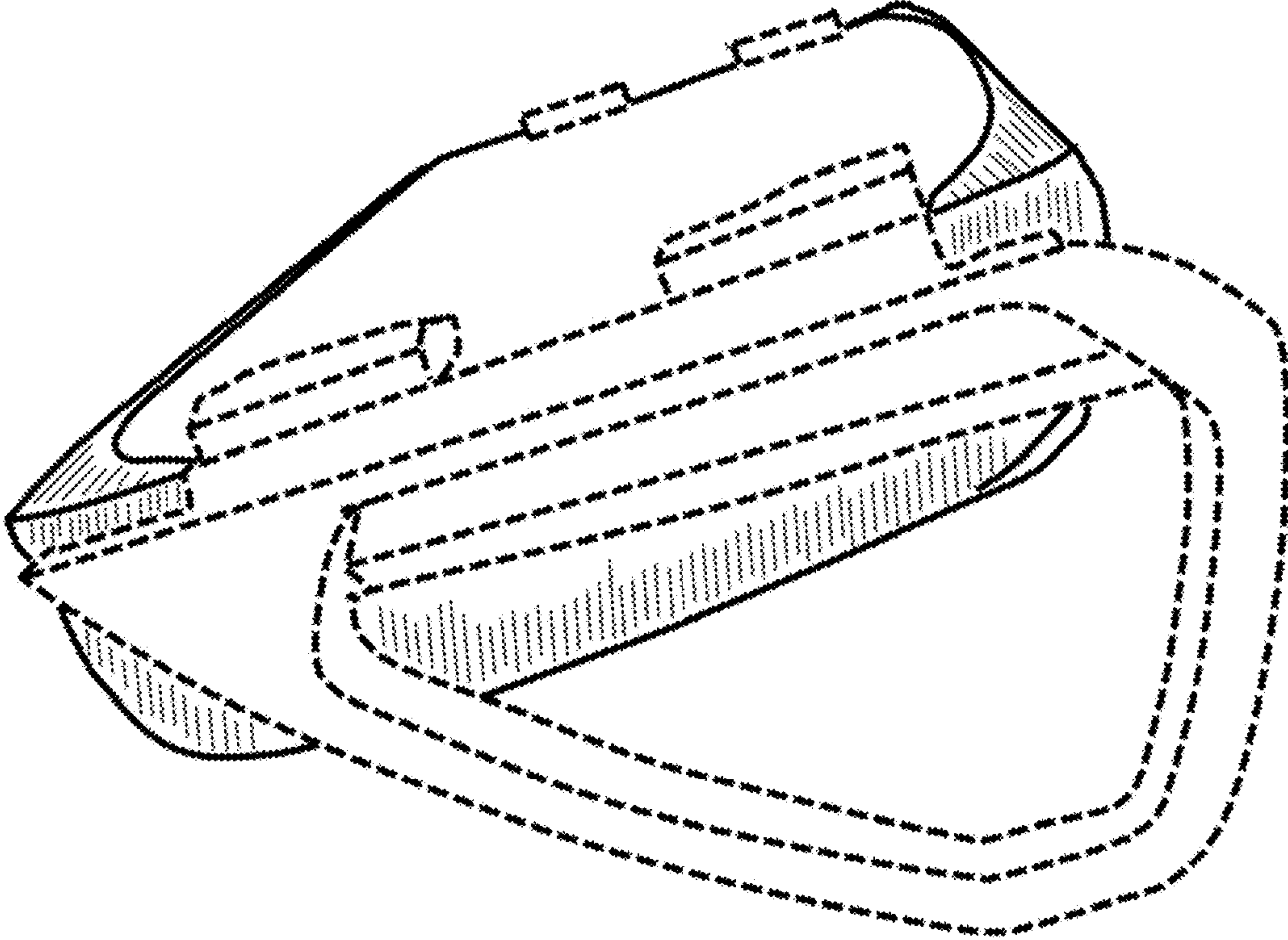

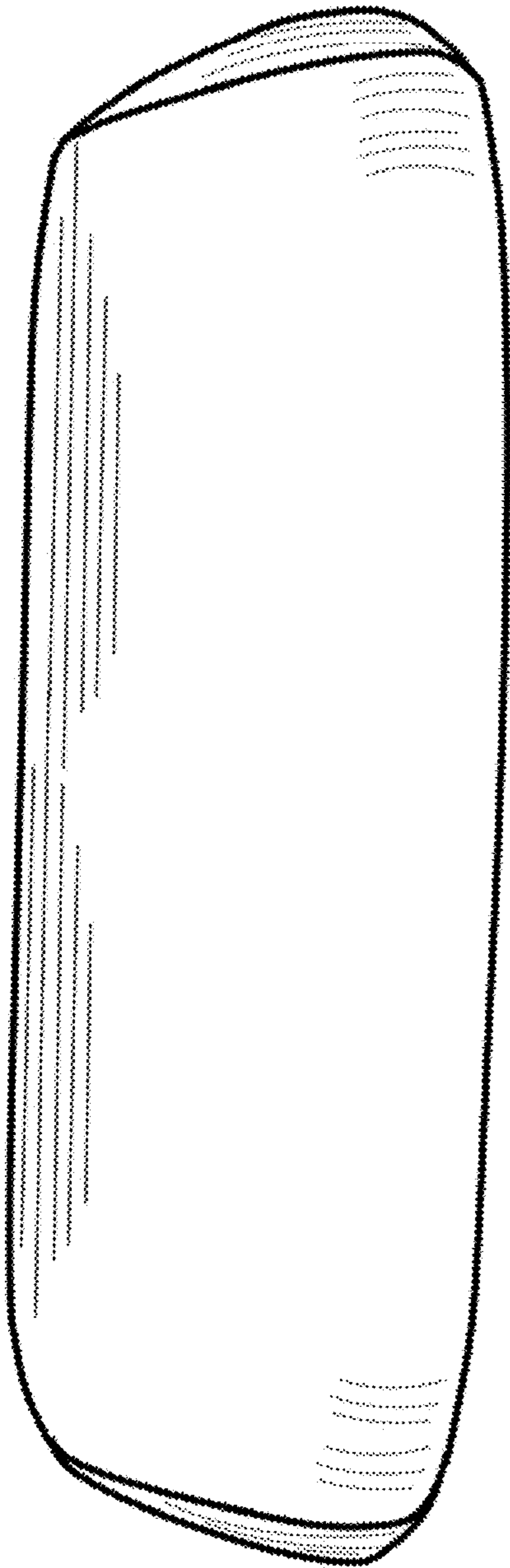

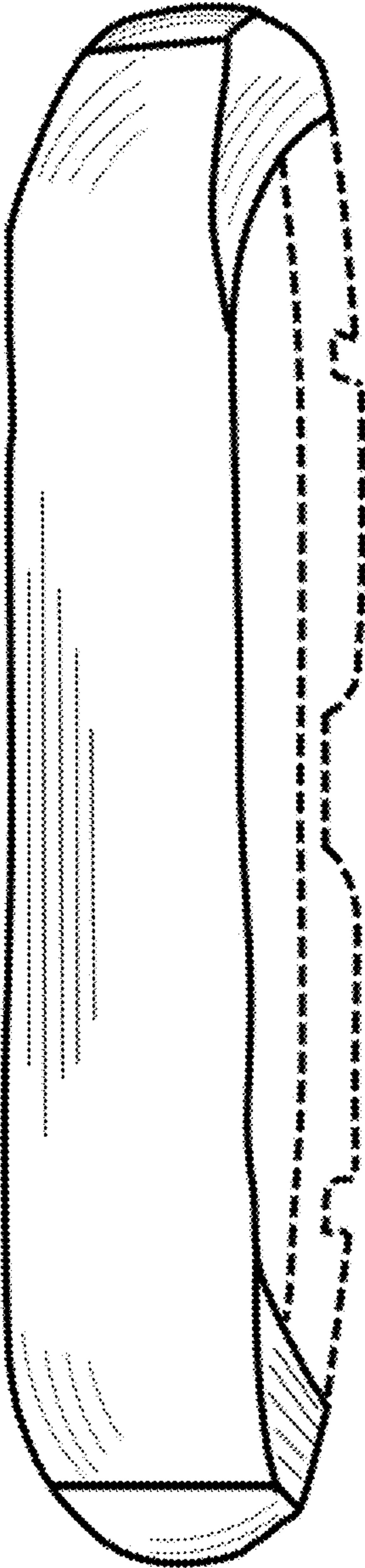

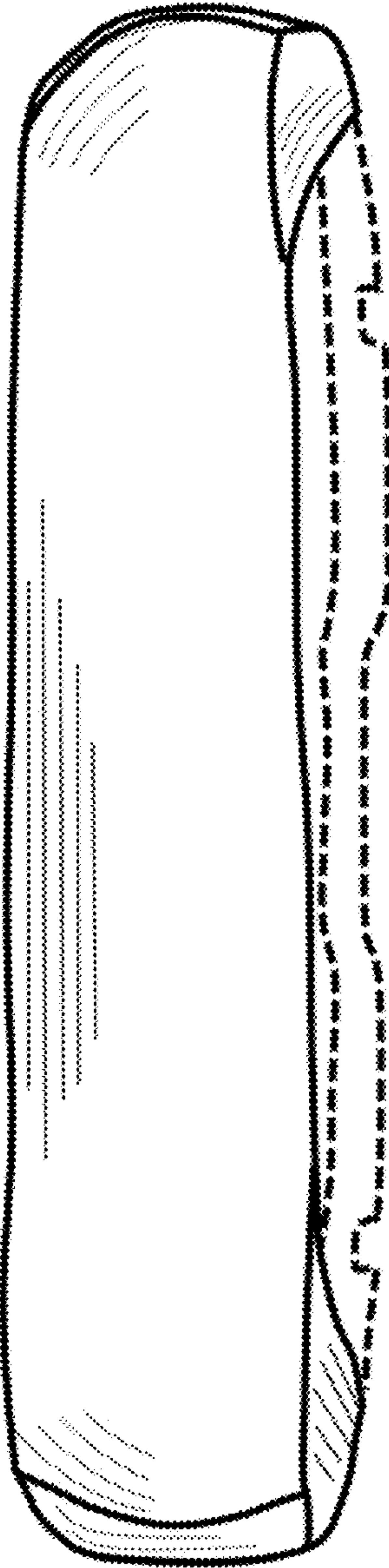

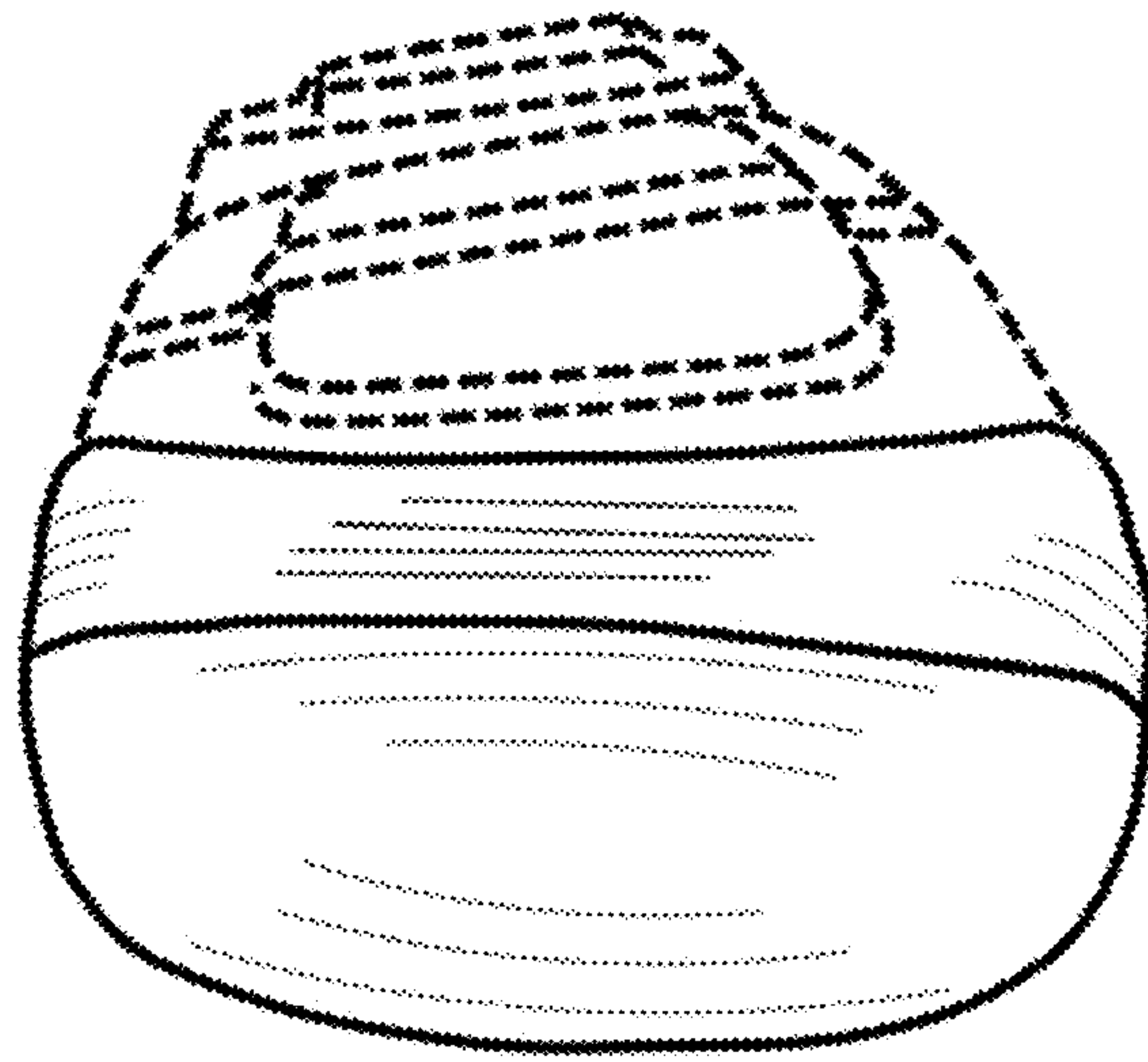

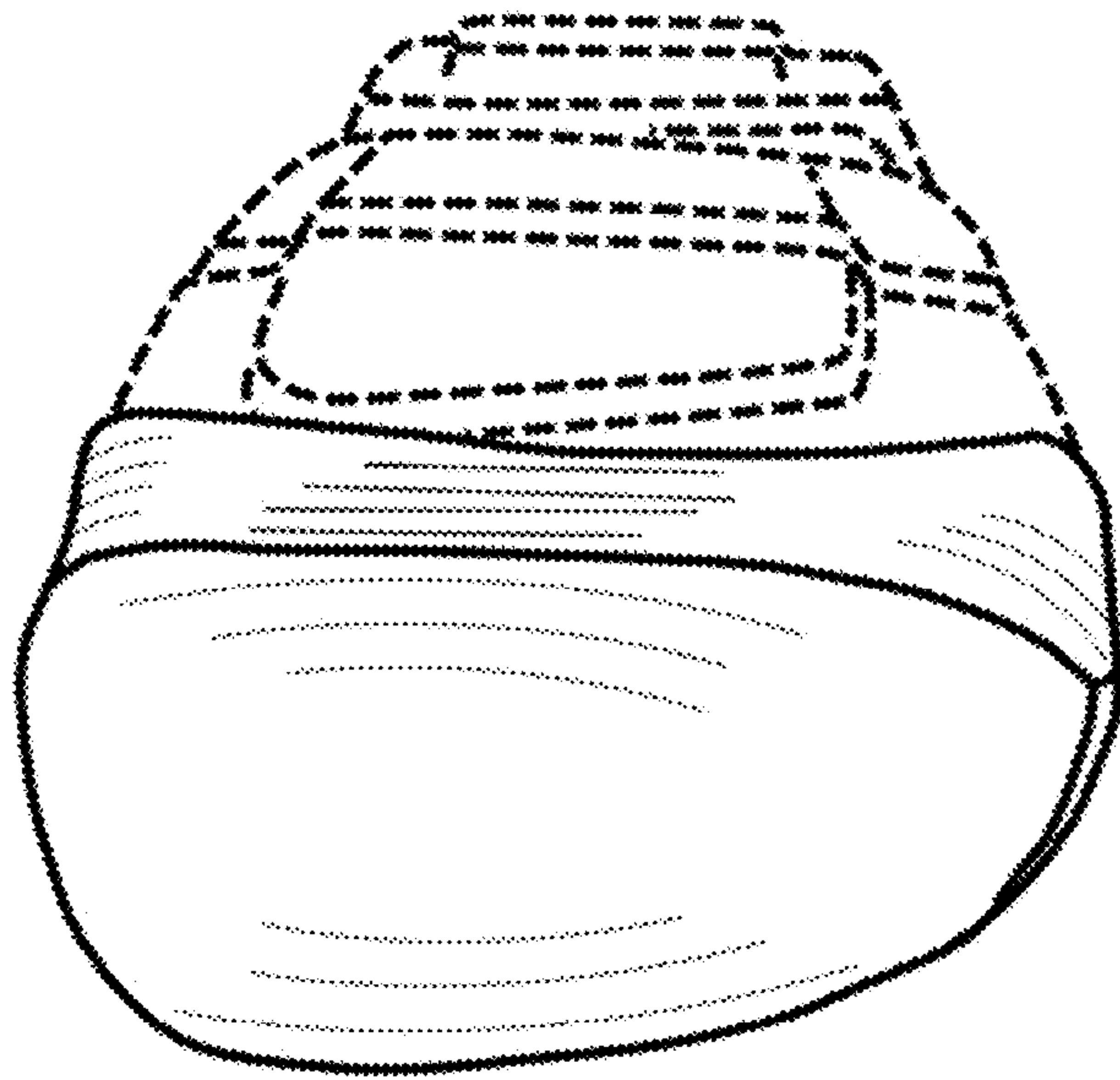

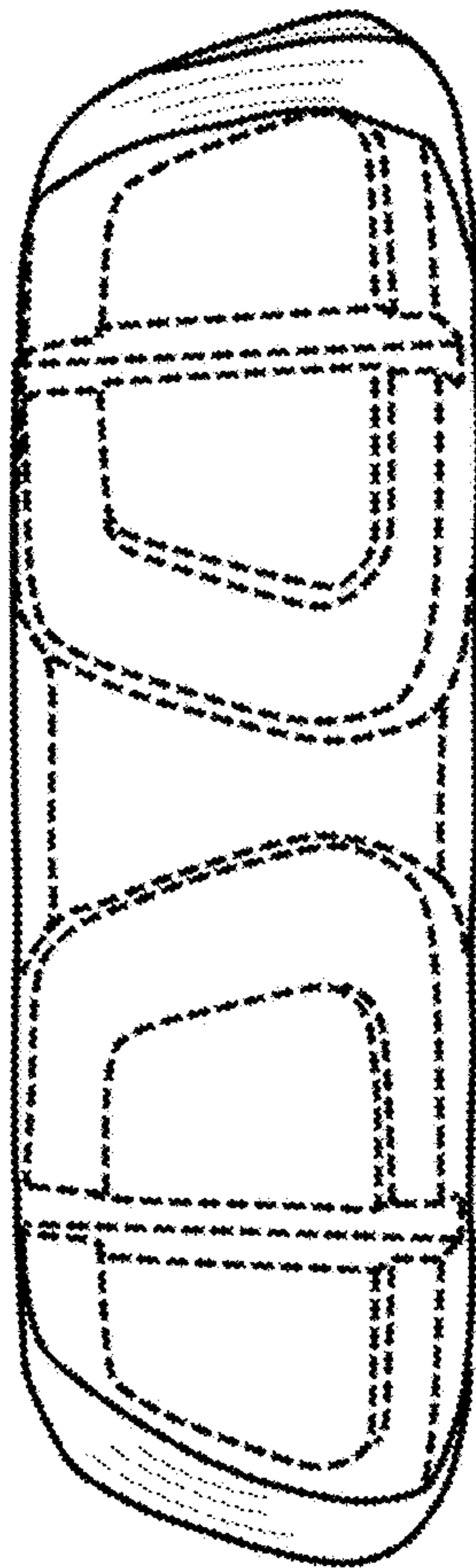
