**DESCRIPTION**

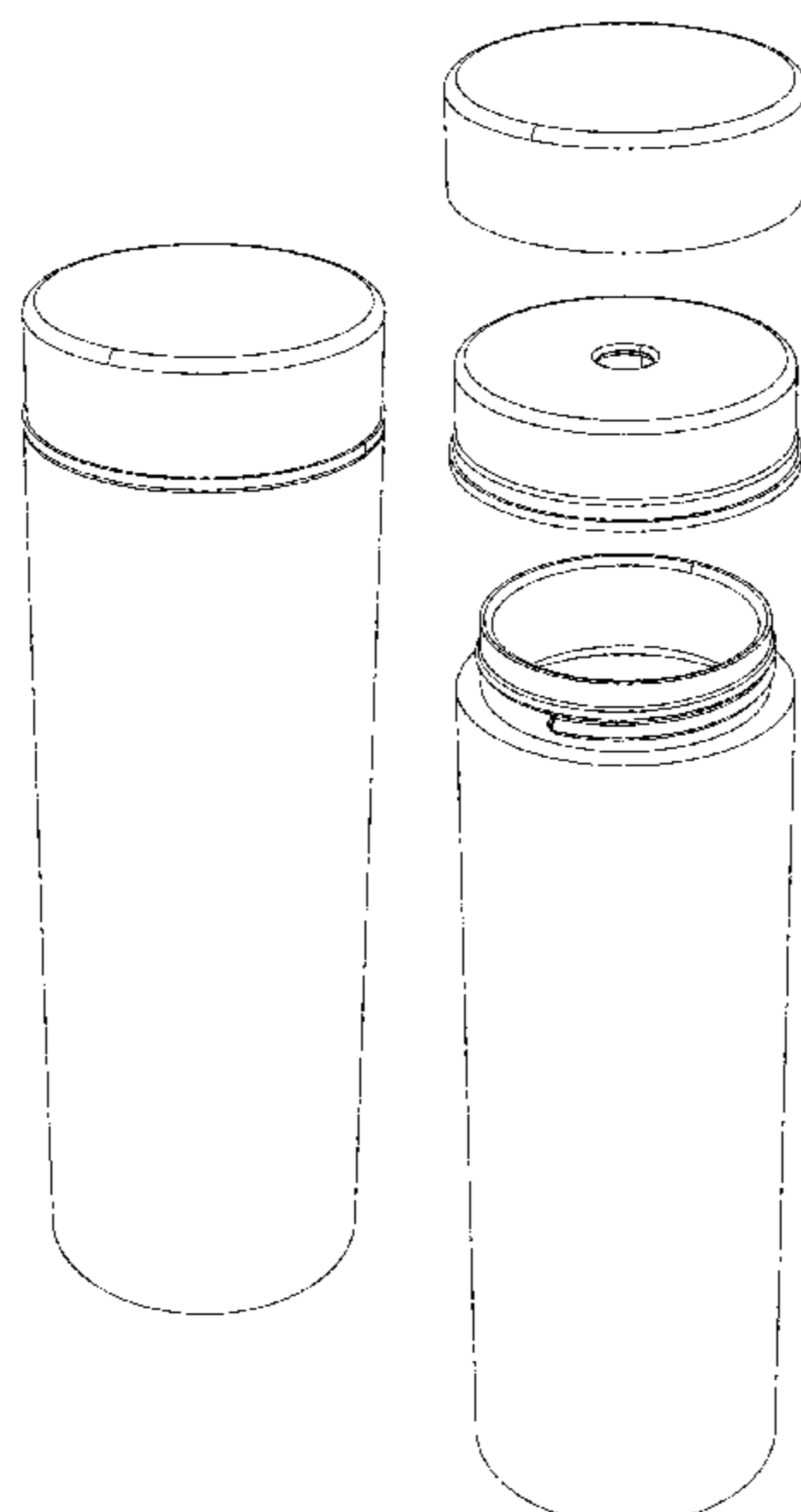
FIG. 1 is a perspective view of a beverage container showing my new design;

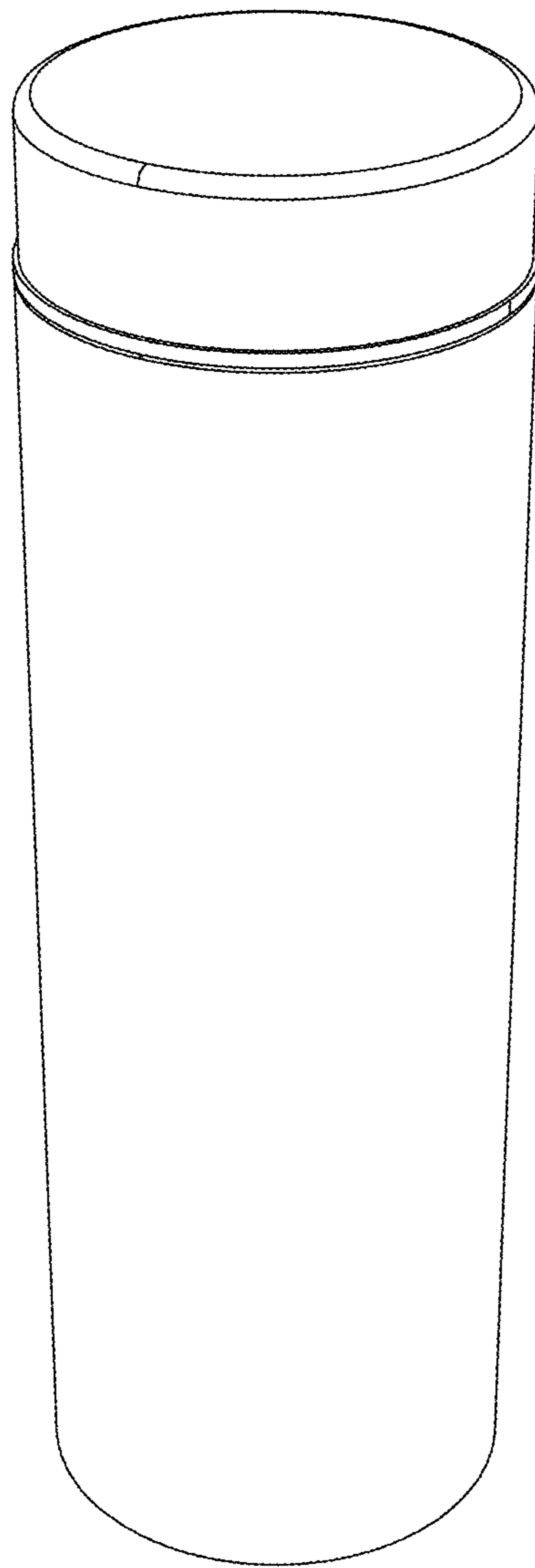

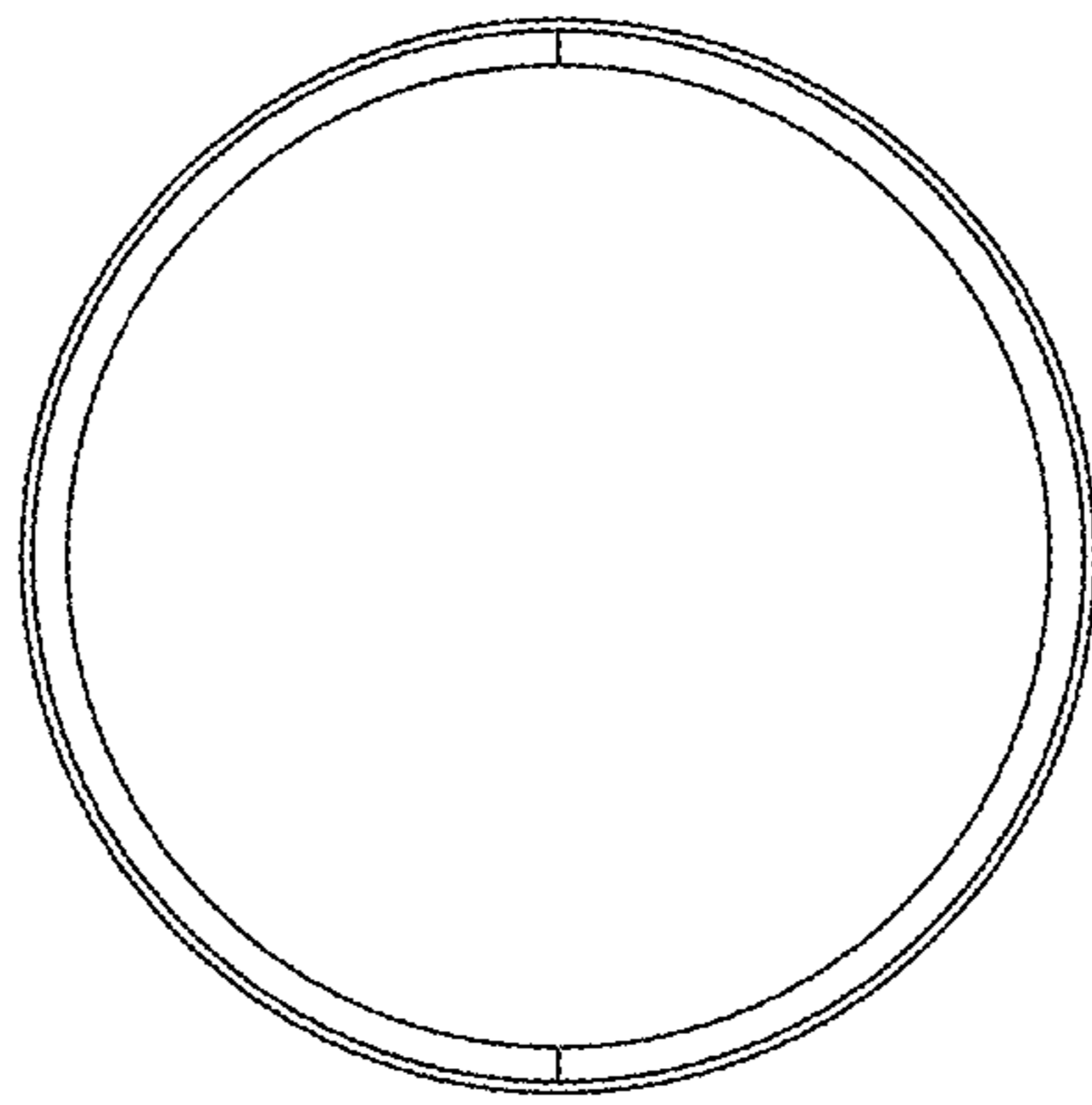

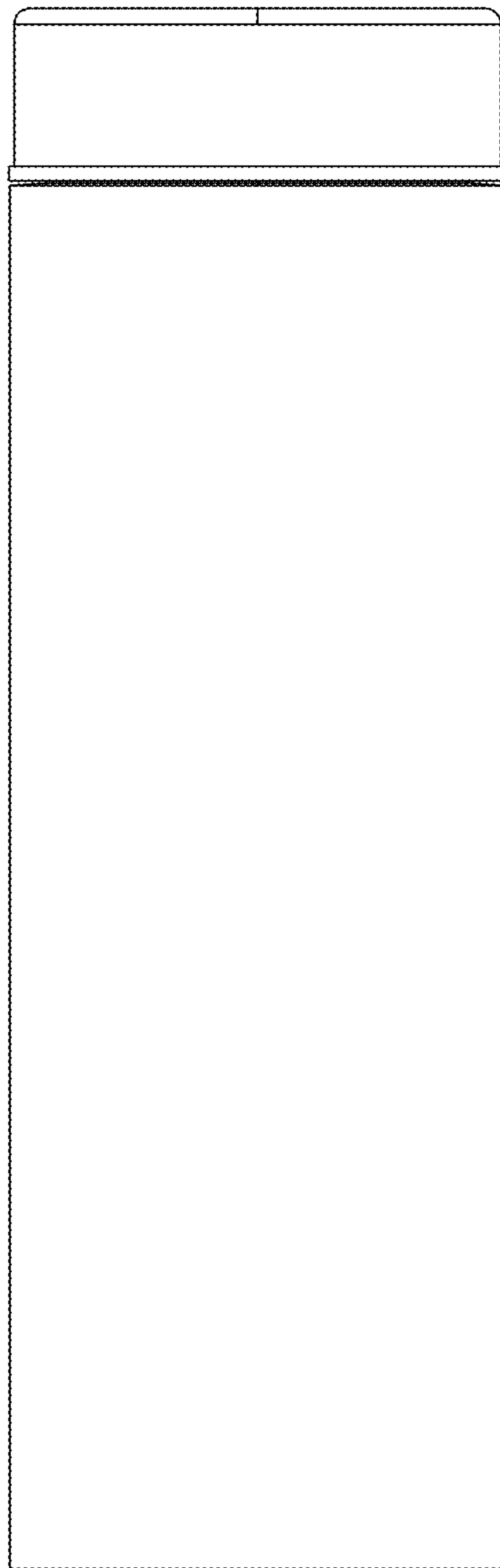

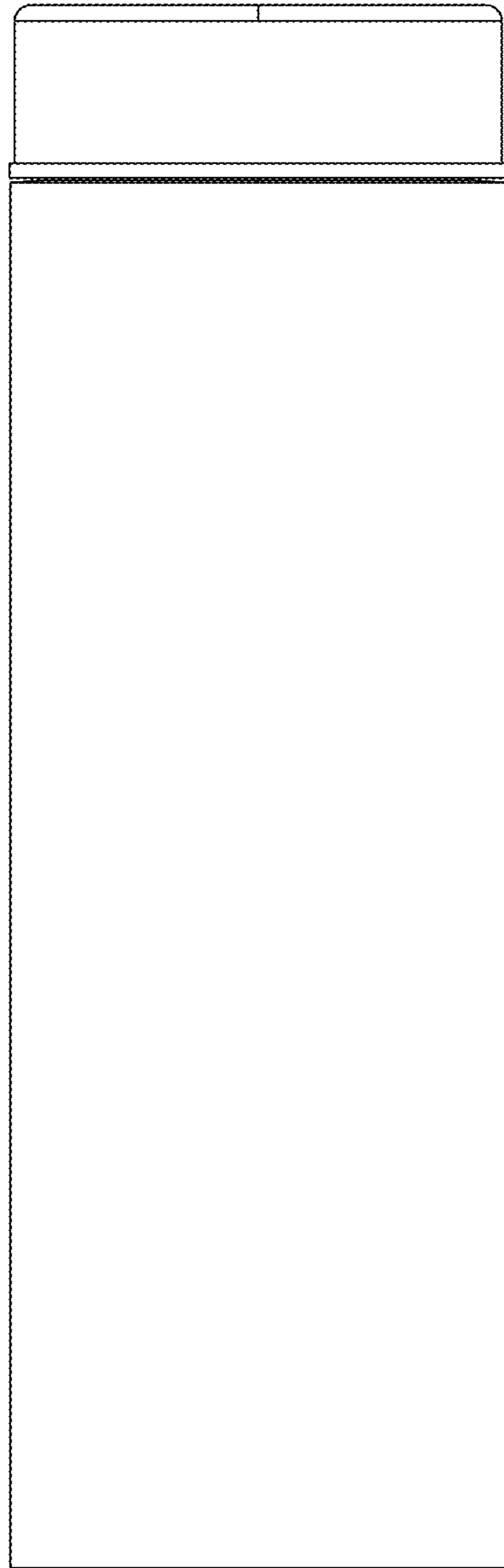

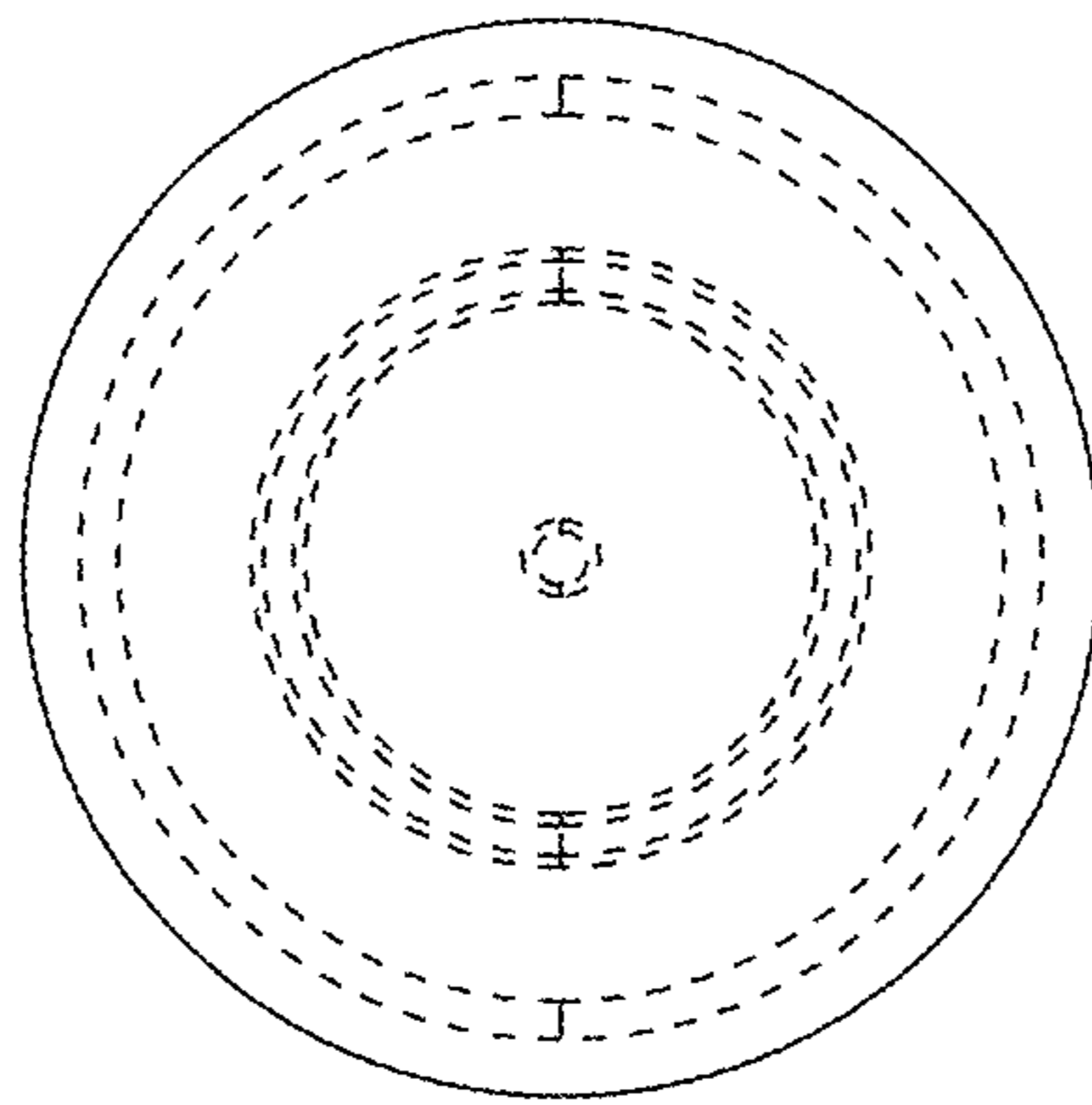

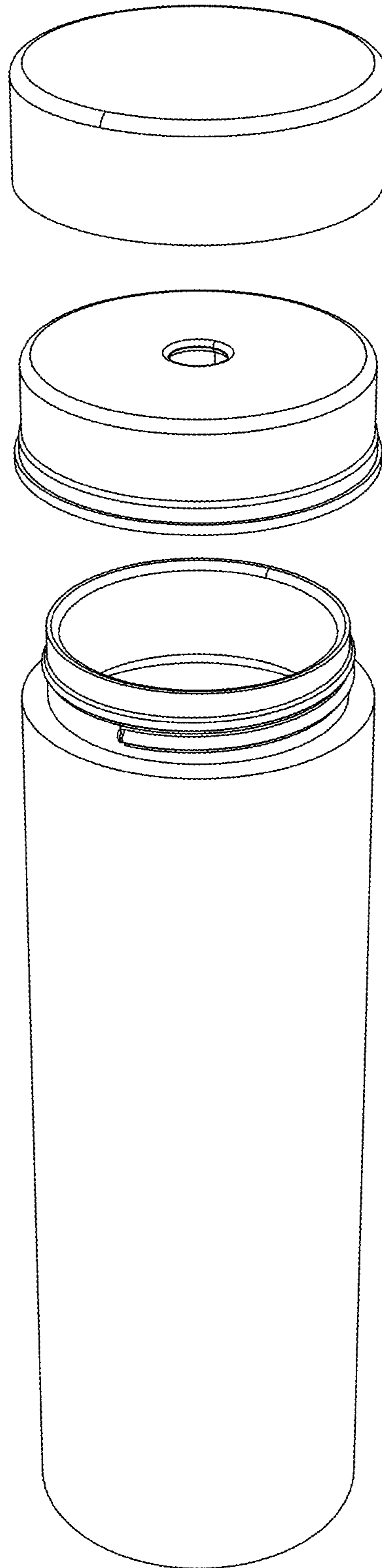

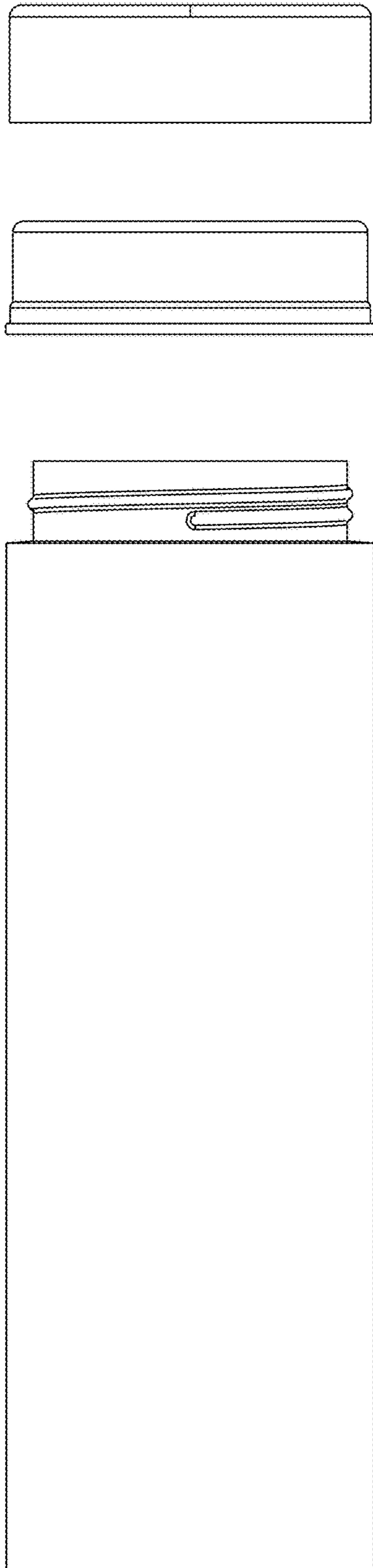

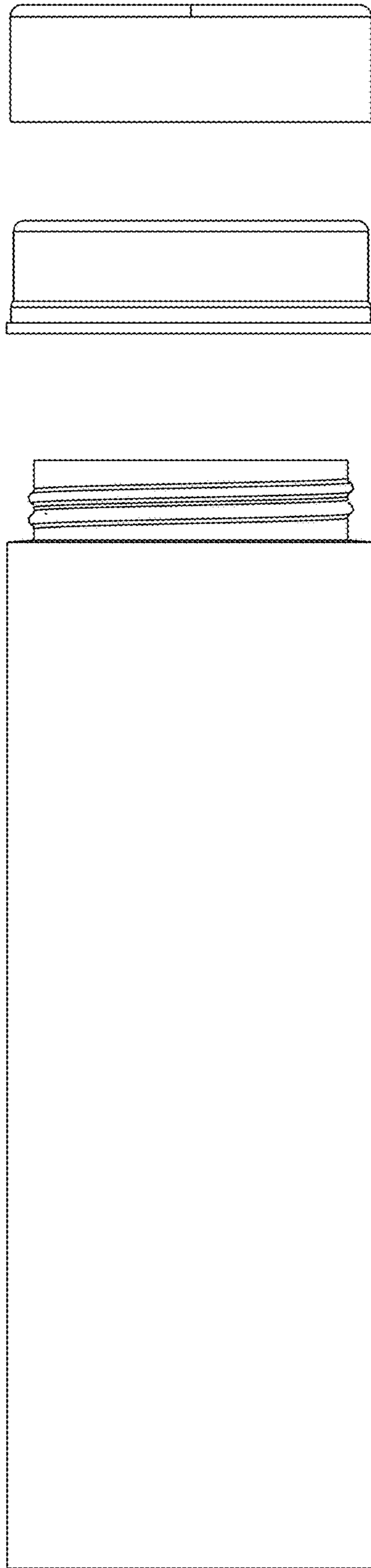
