DESCRIPTION

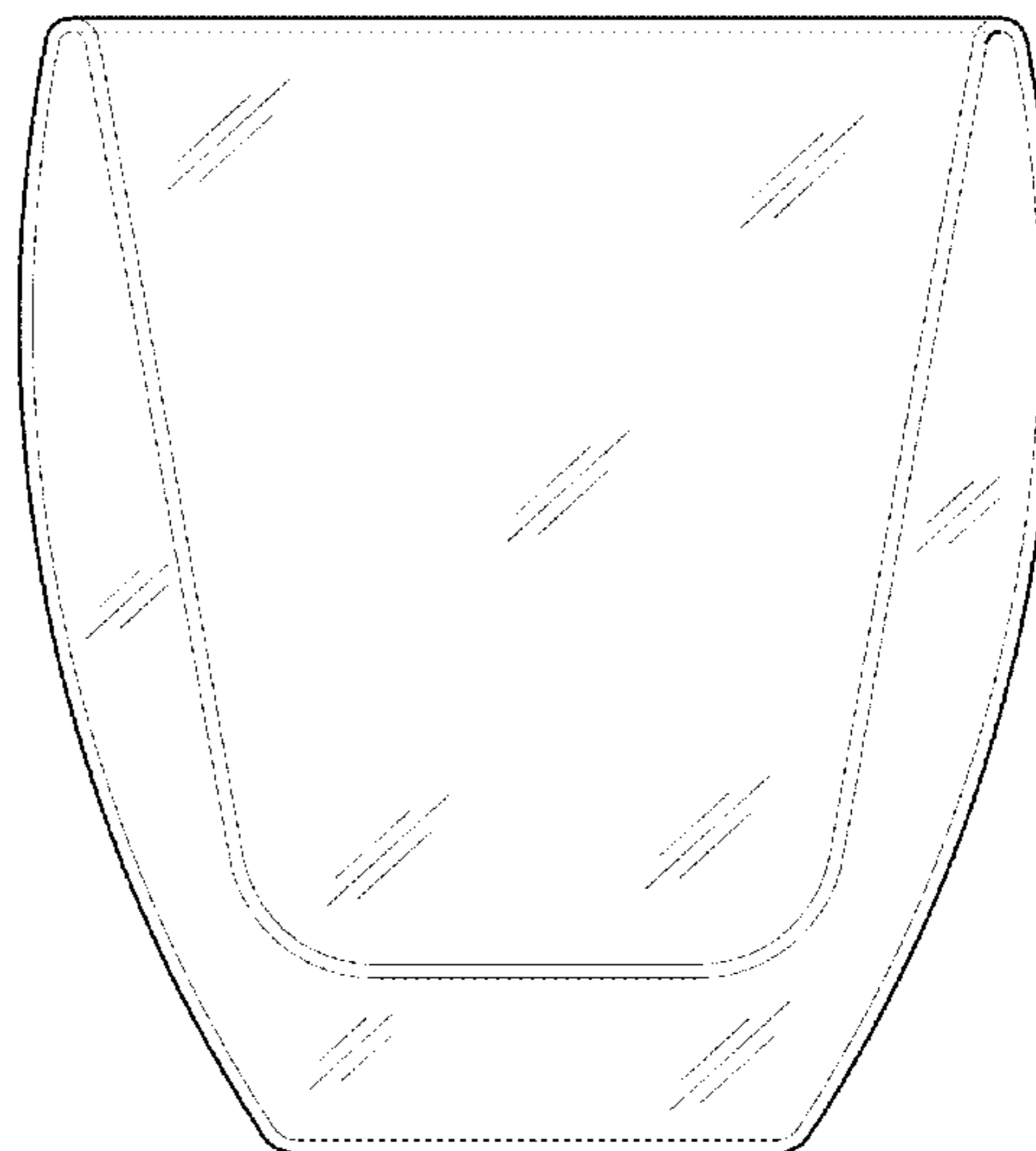
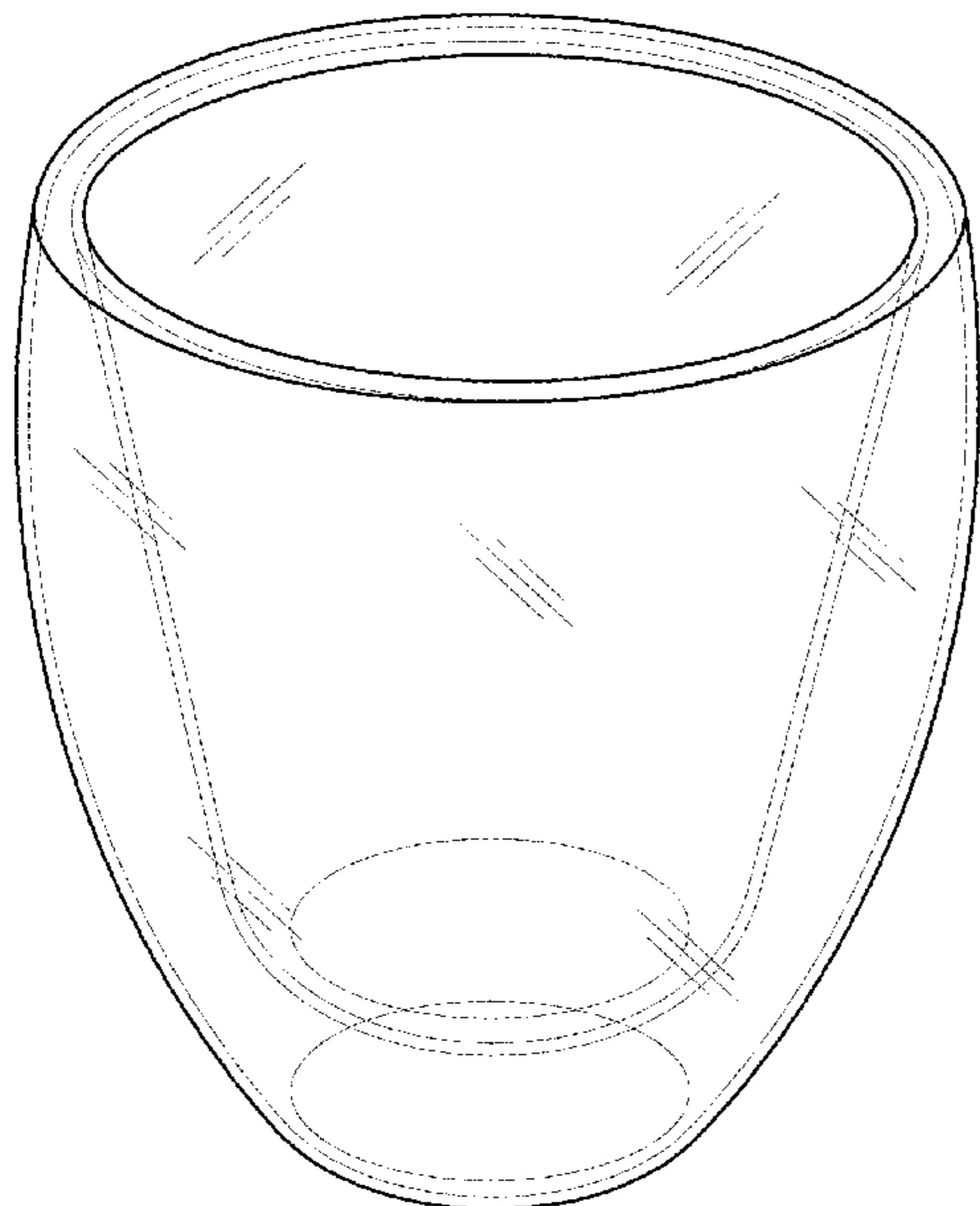
FIG. 1 is a front perspective view of a glass showing my new design;

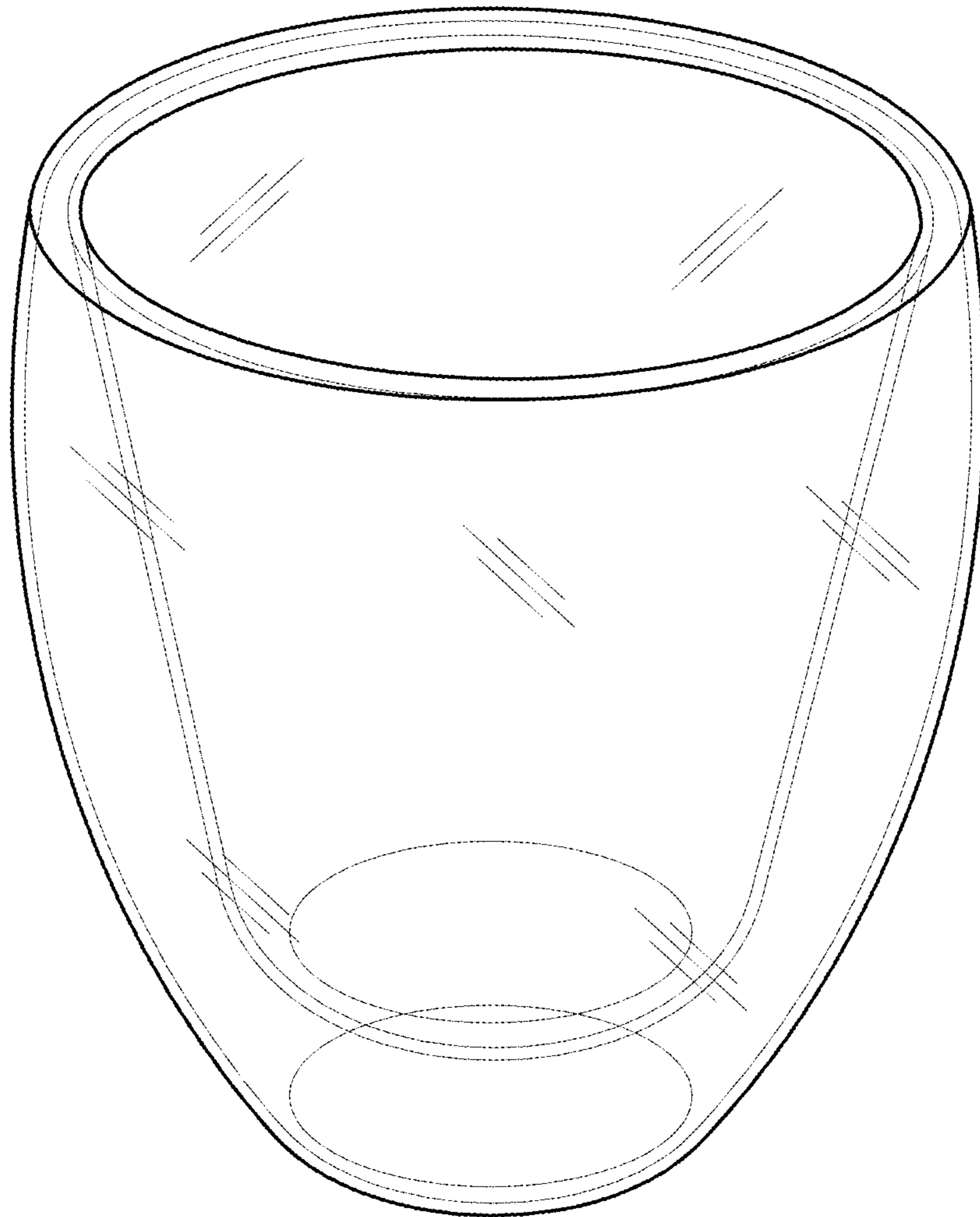

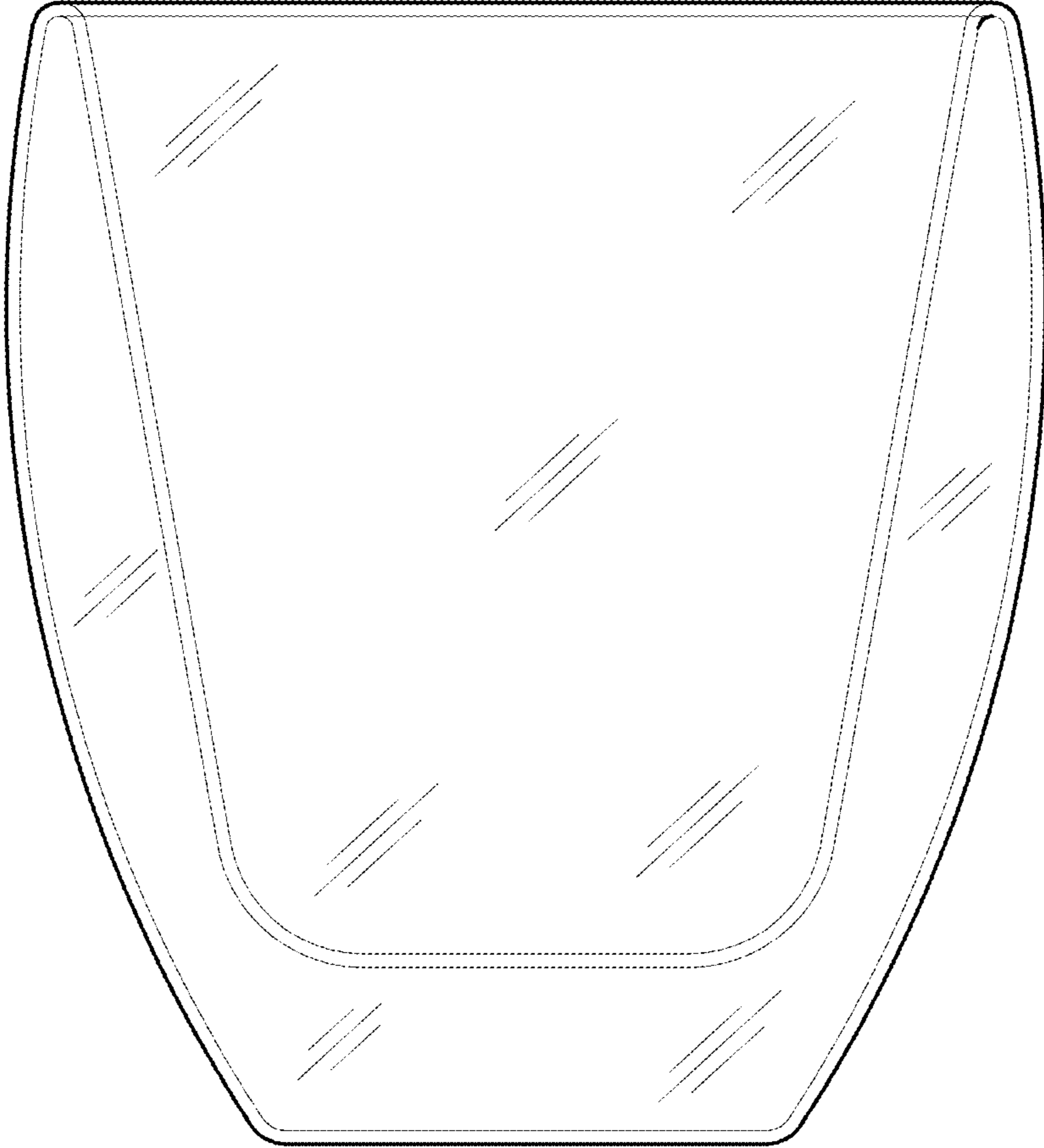

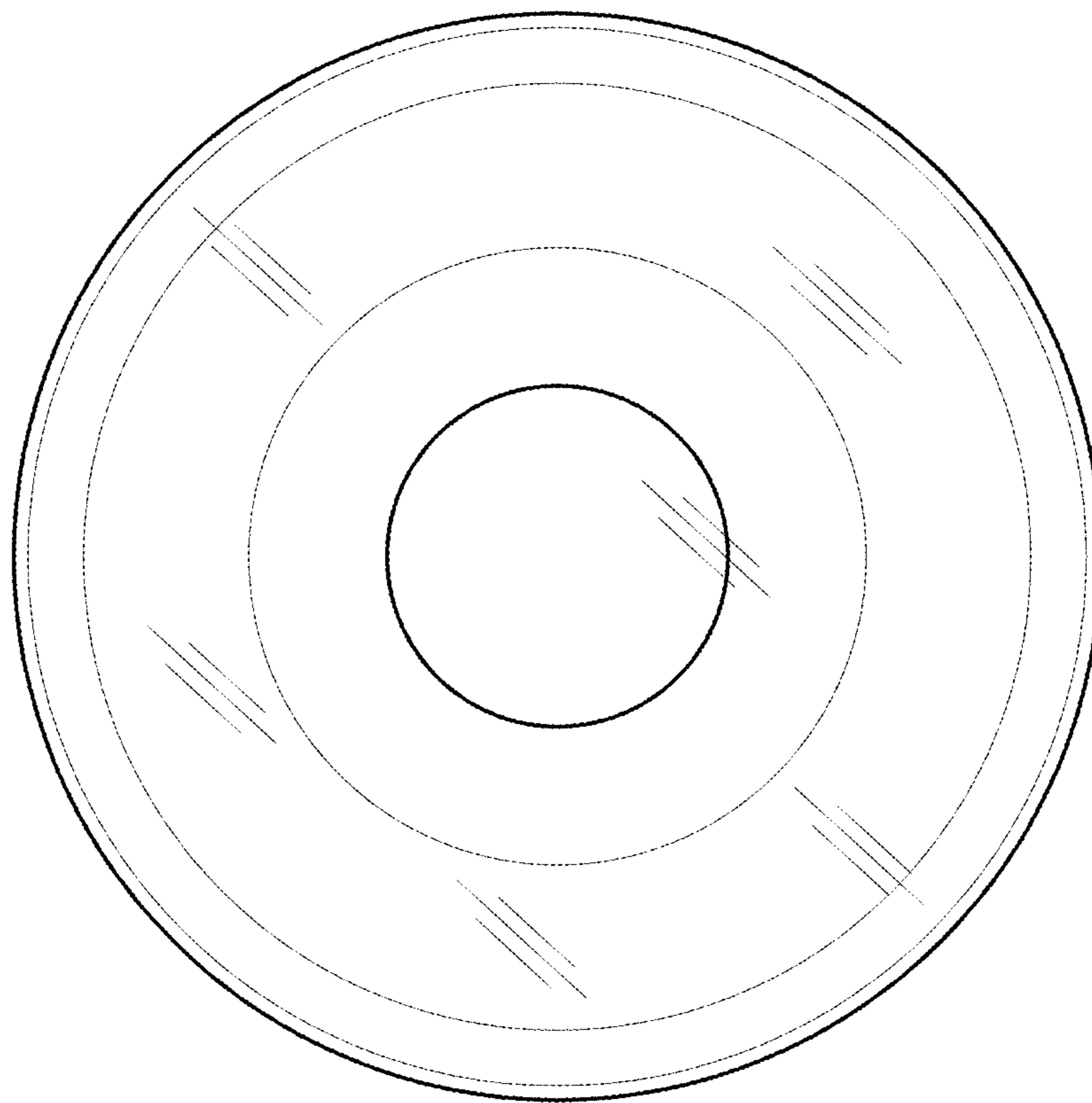

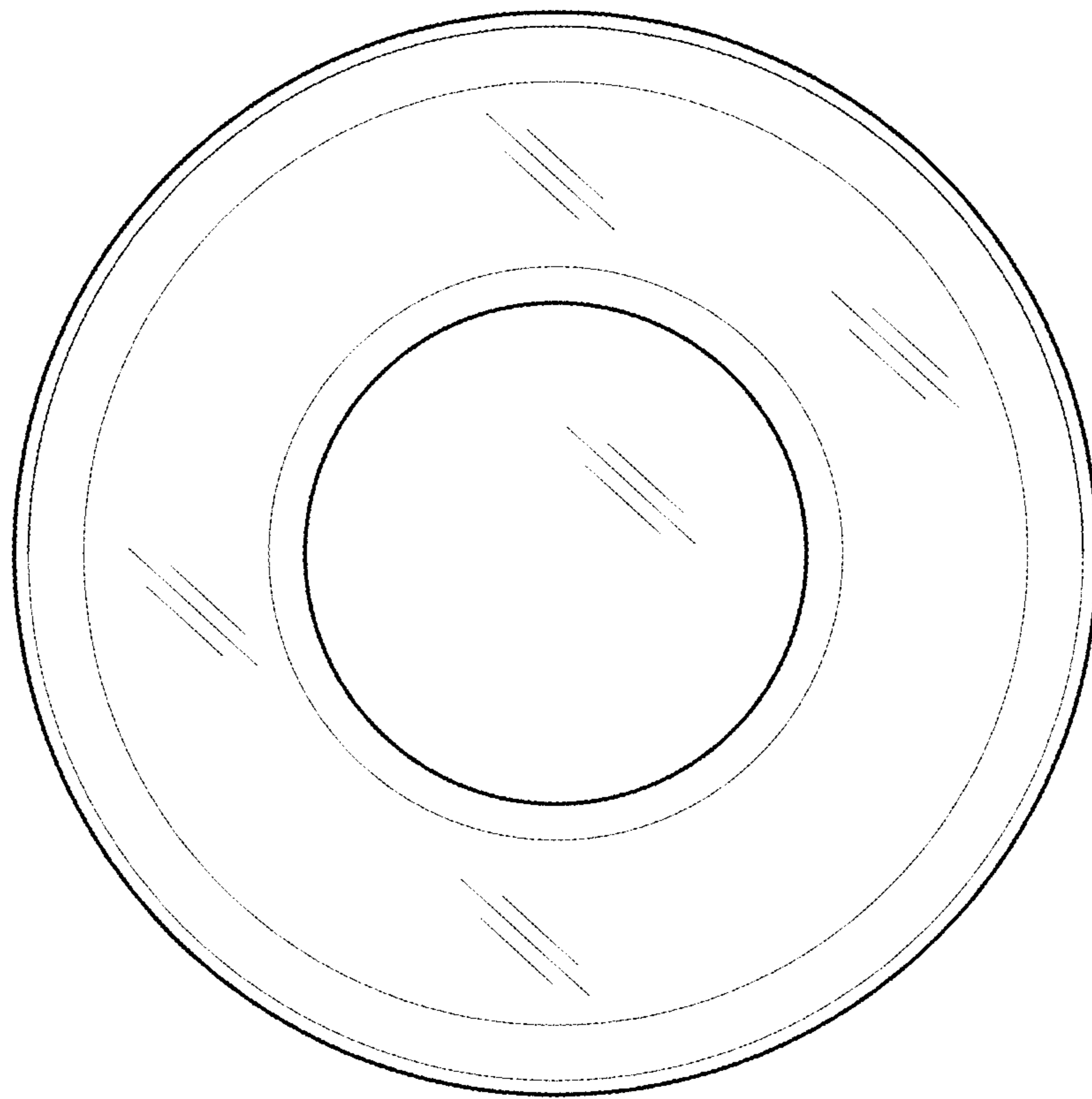
