DESCRIPTION

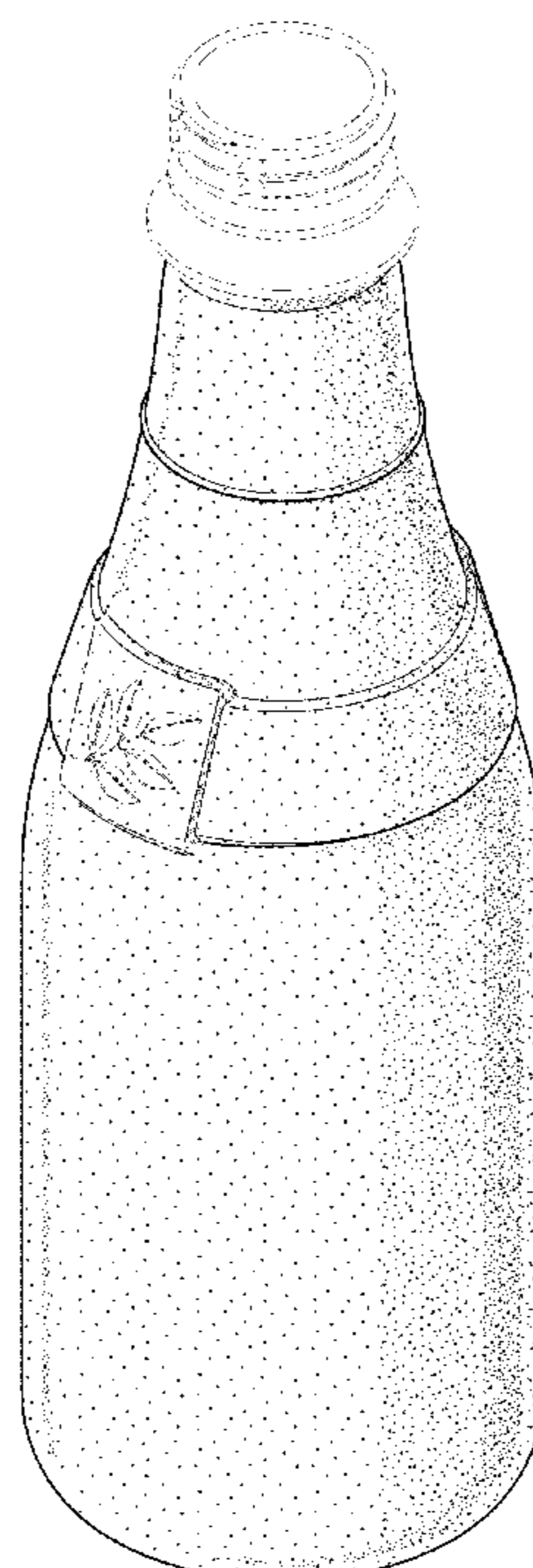
FIG. 1 is a perspective view of the bottle embodying the new design;

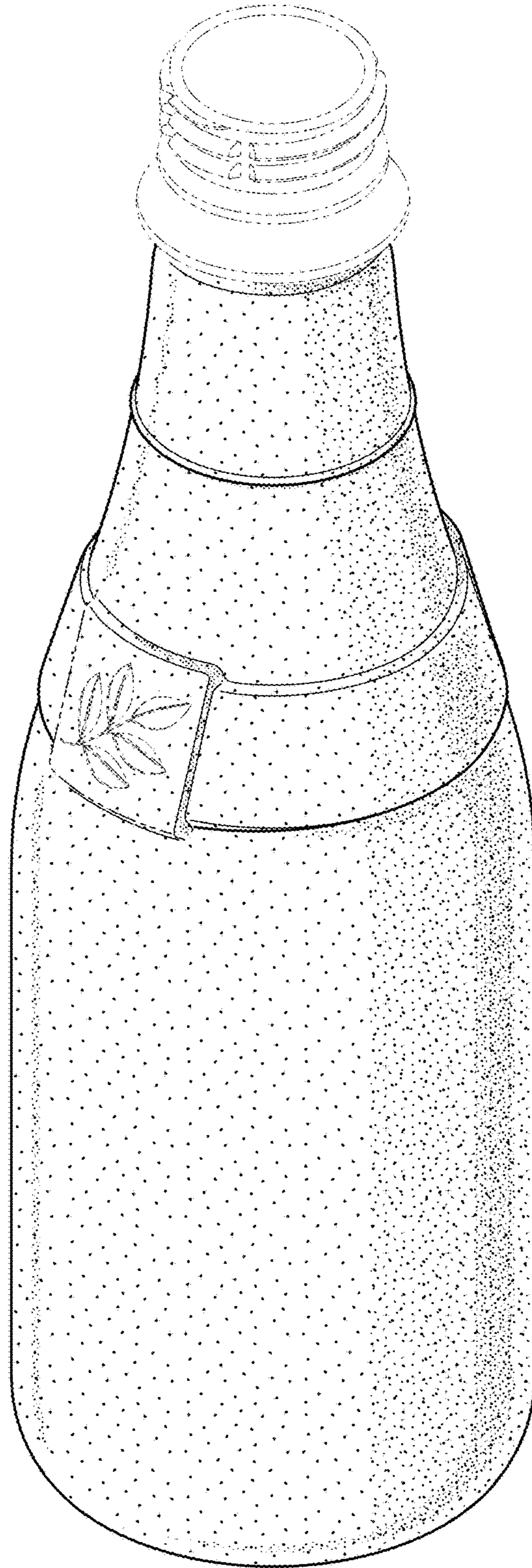

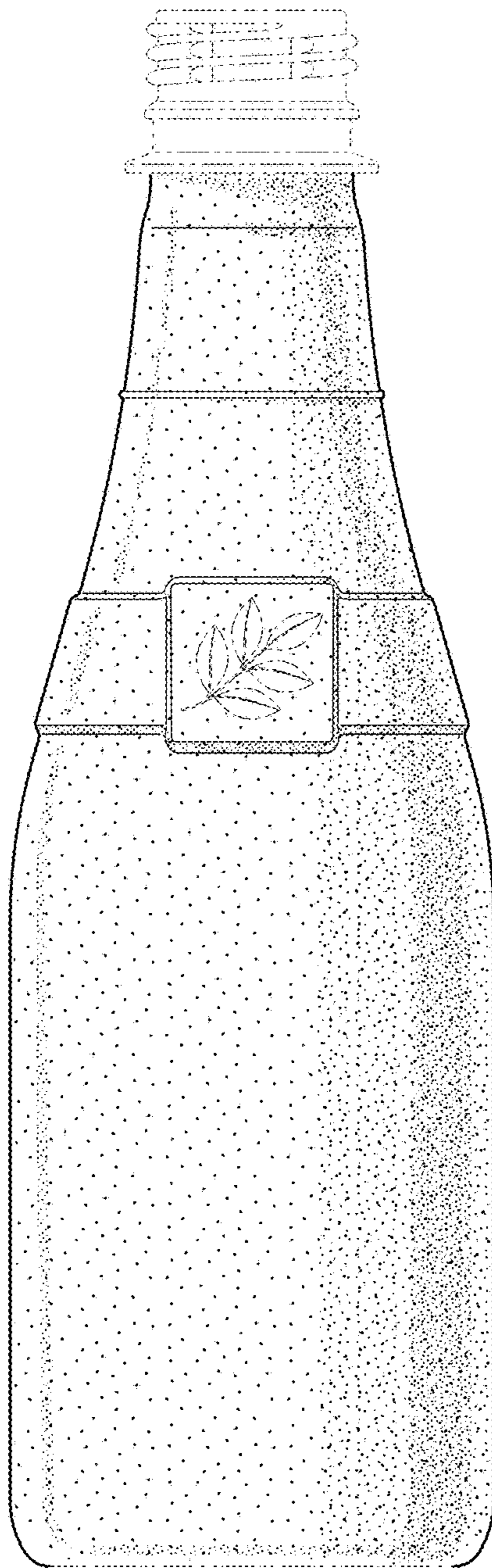

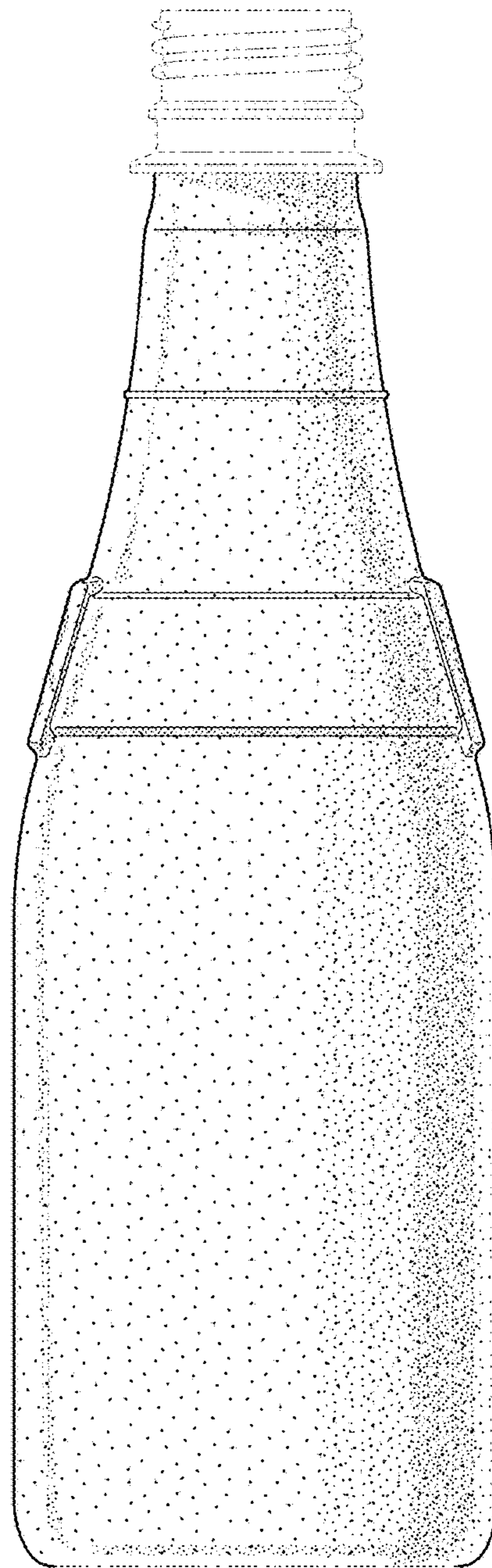

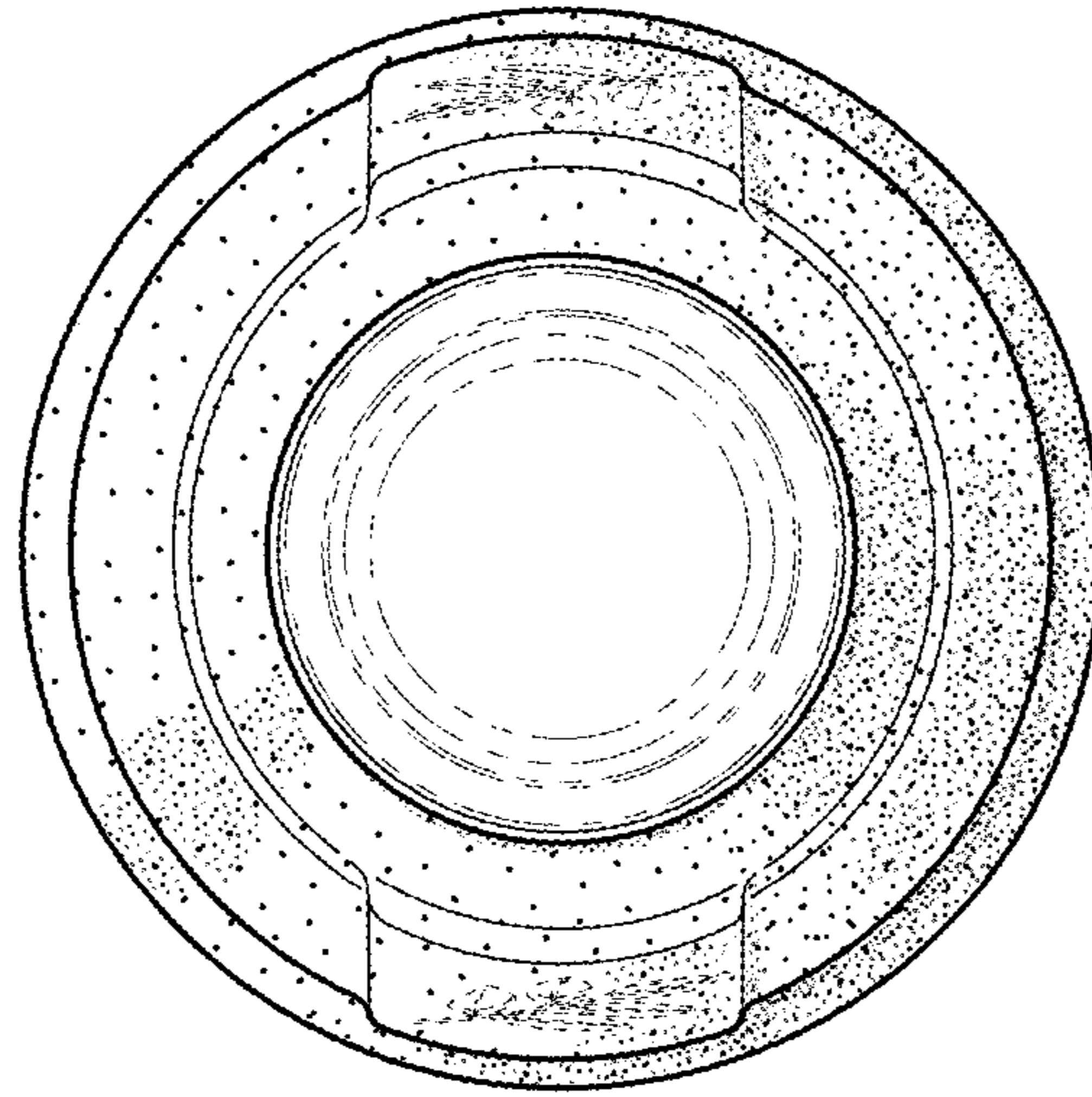

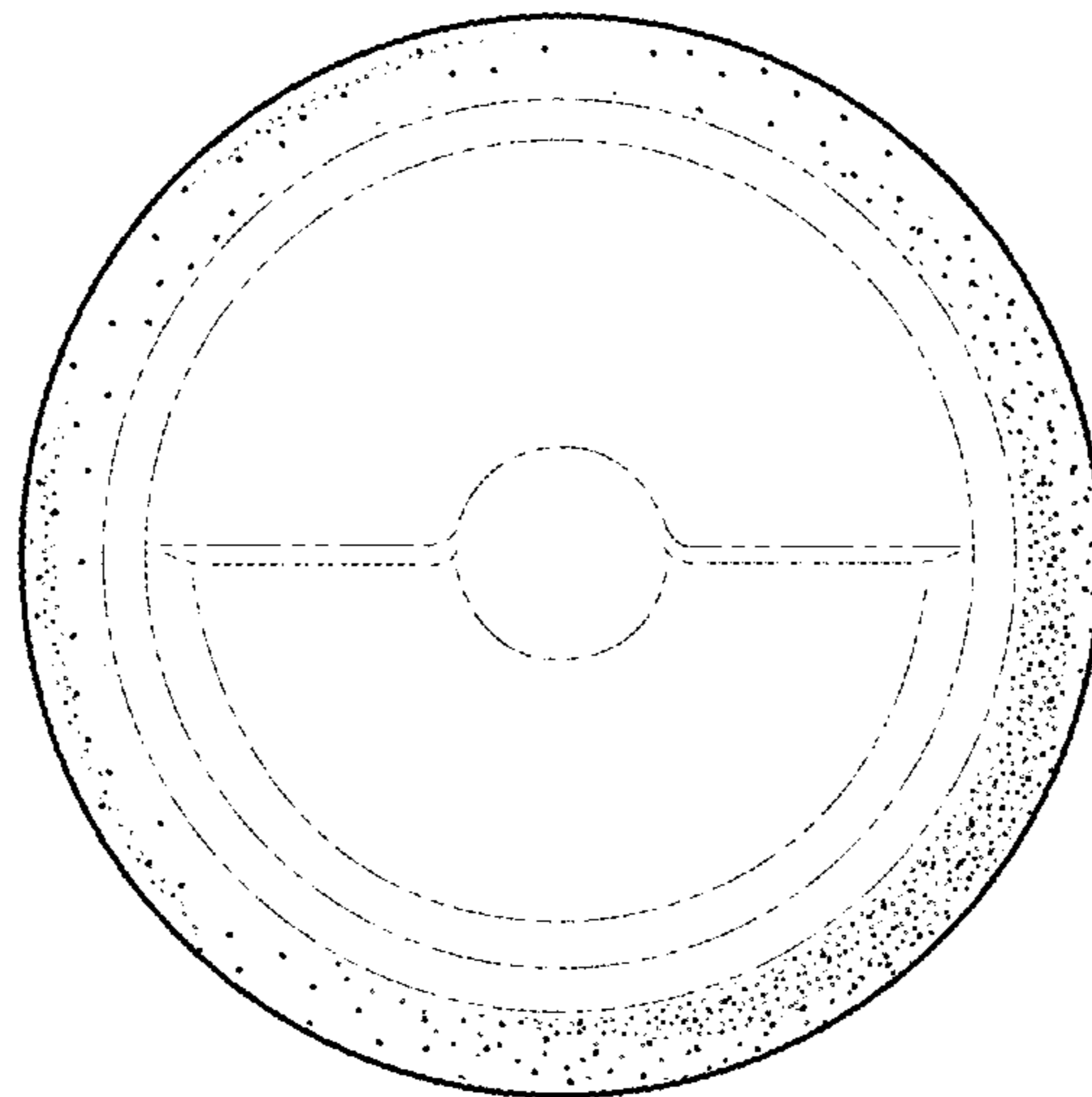
