**DESCRIPTION**

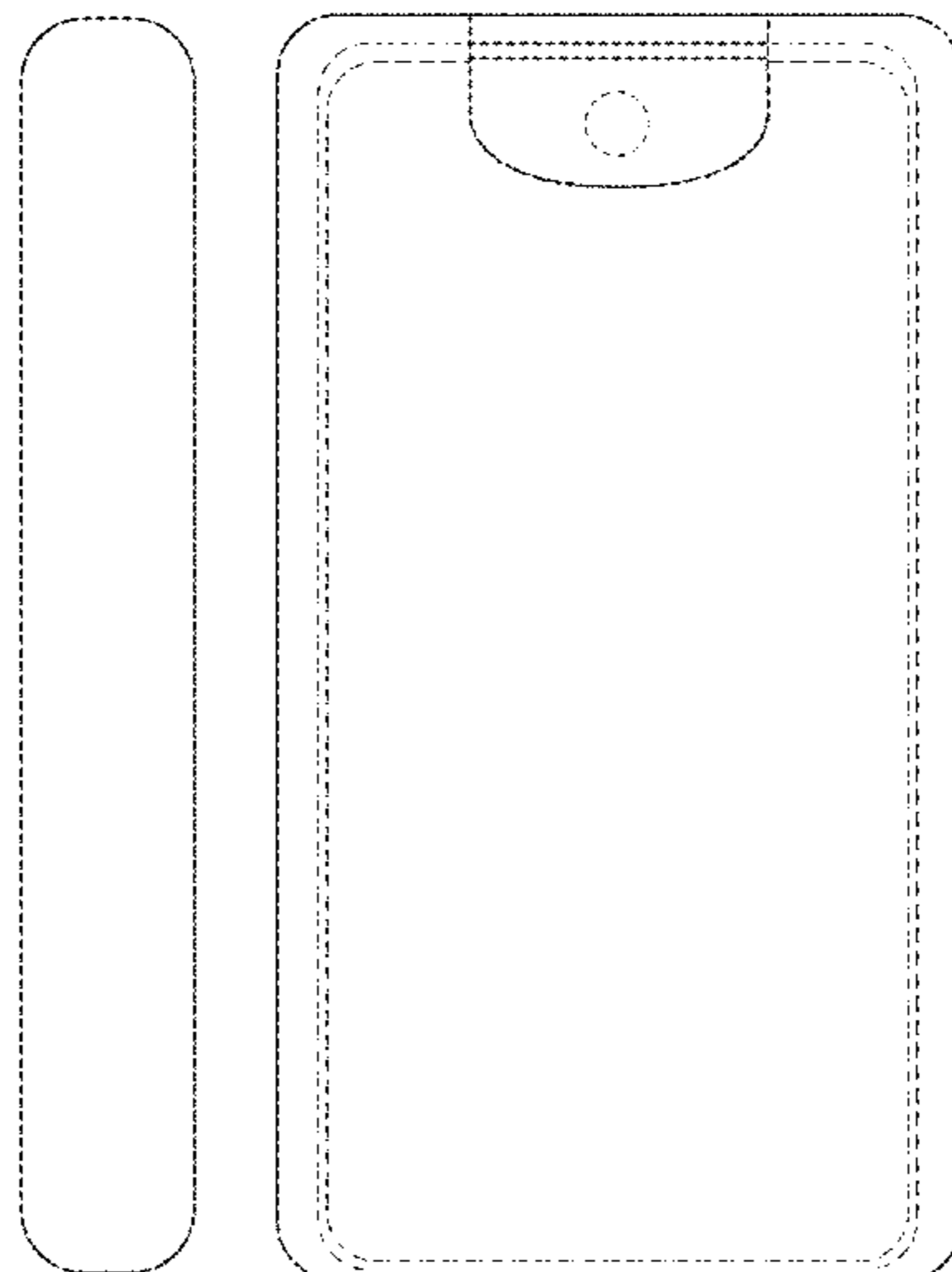
FIG. 1 is a left side view of a handheld liquid dispenser showing my new design;

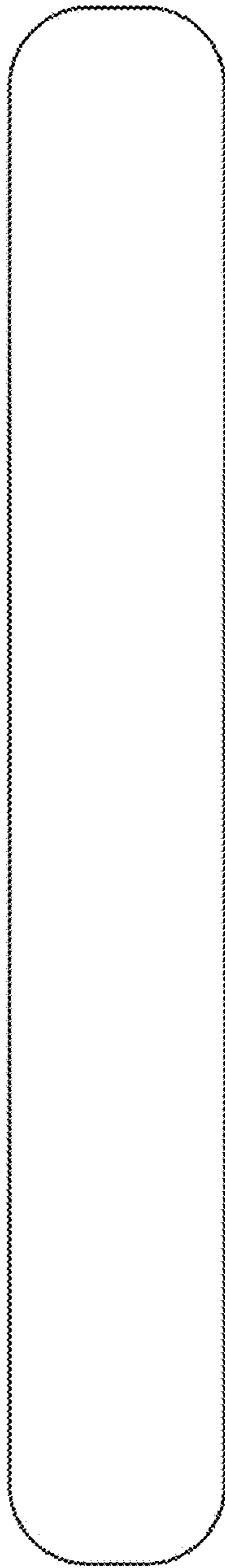

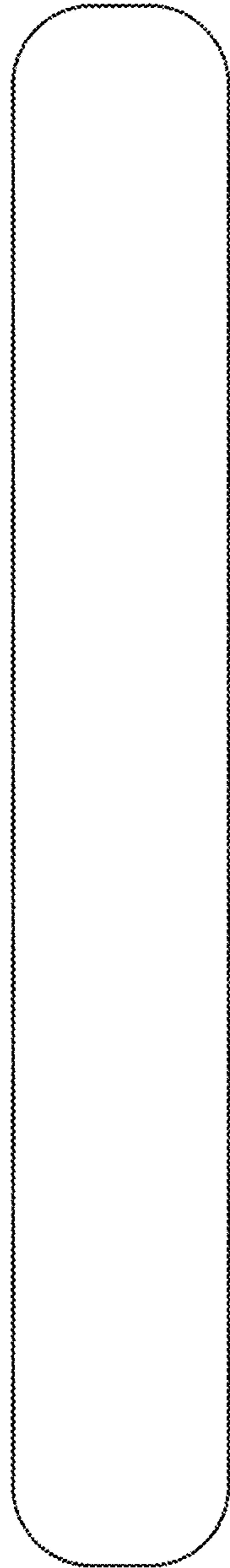

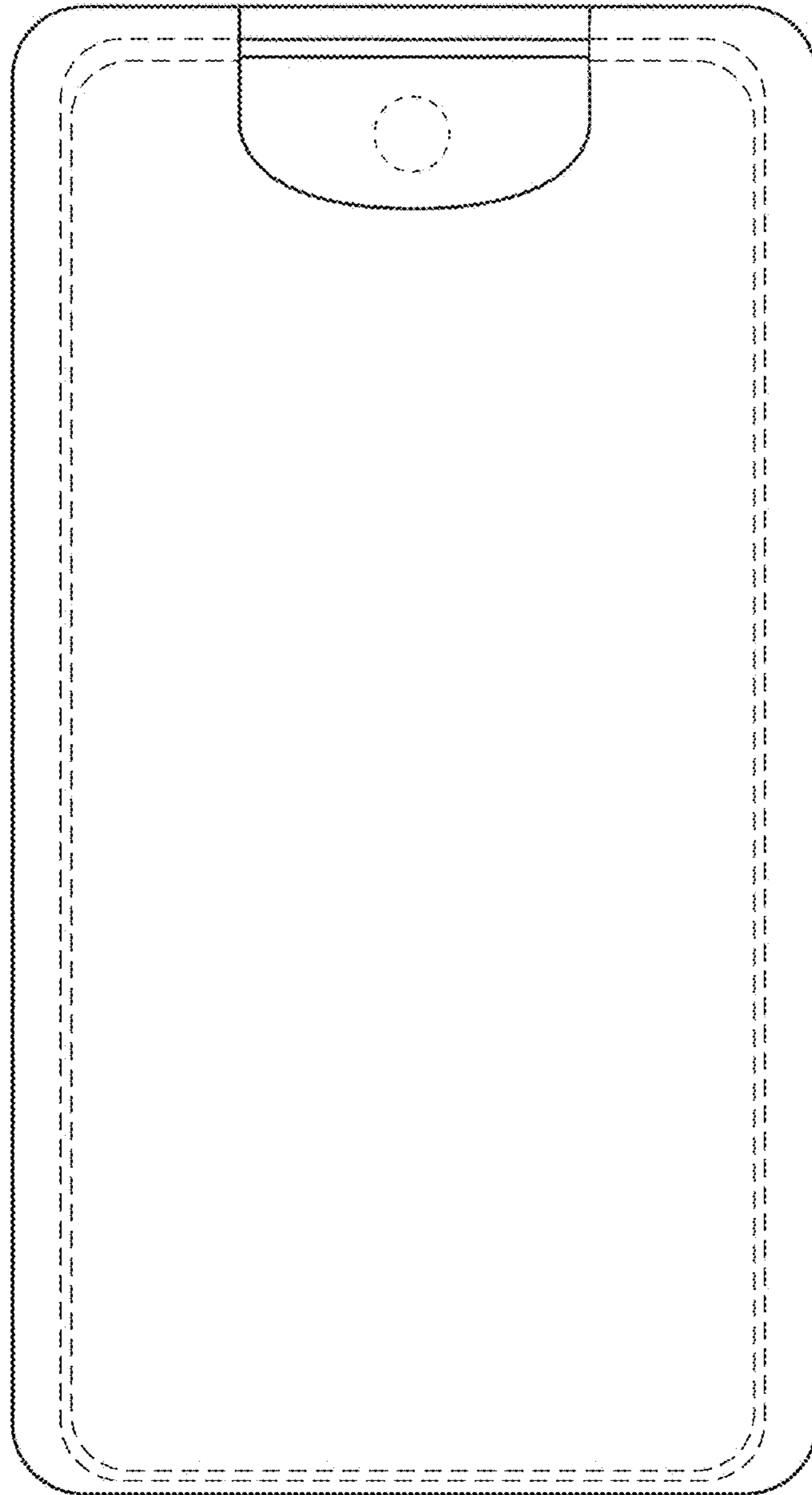

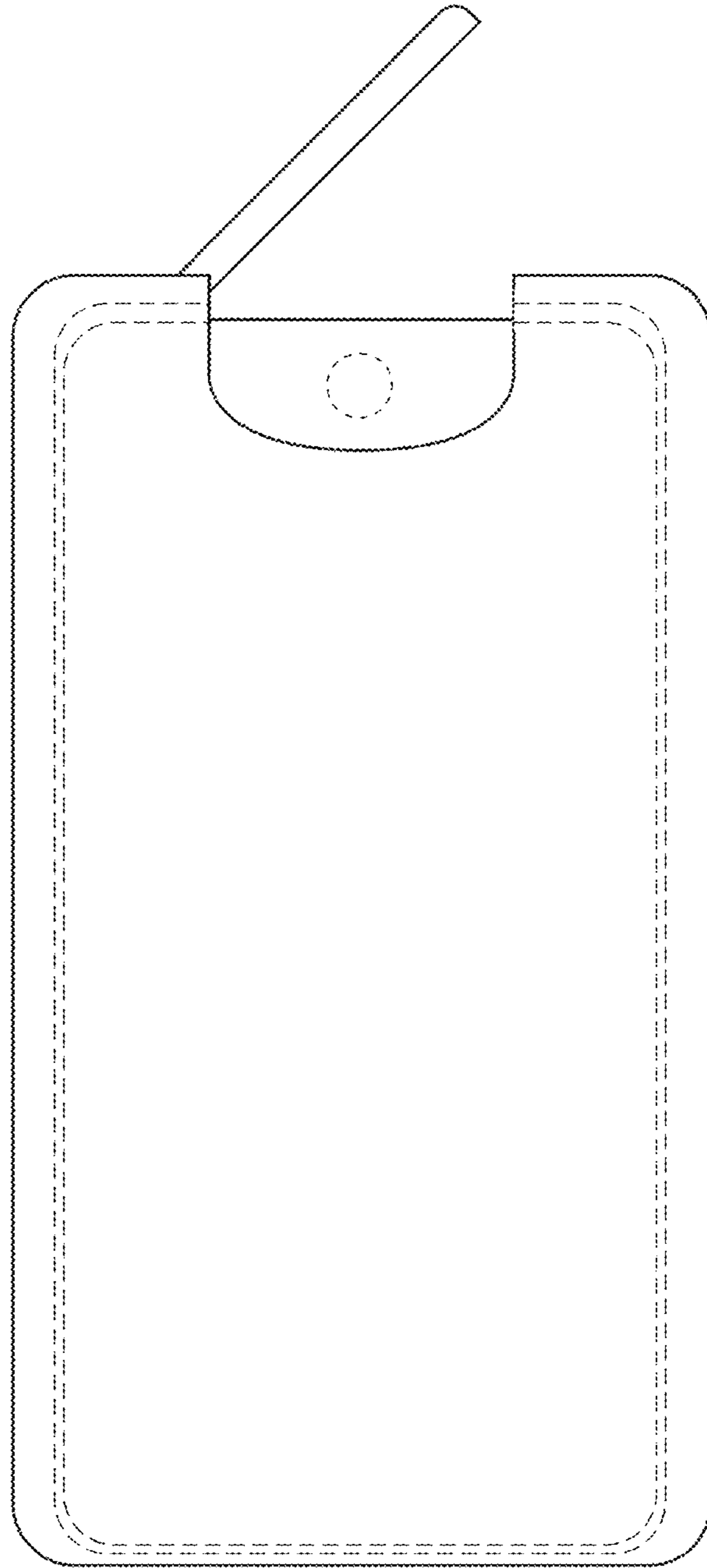

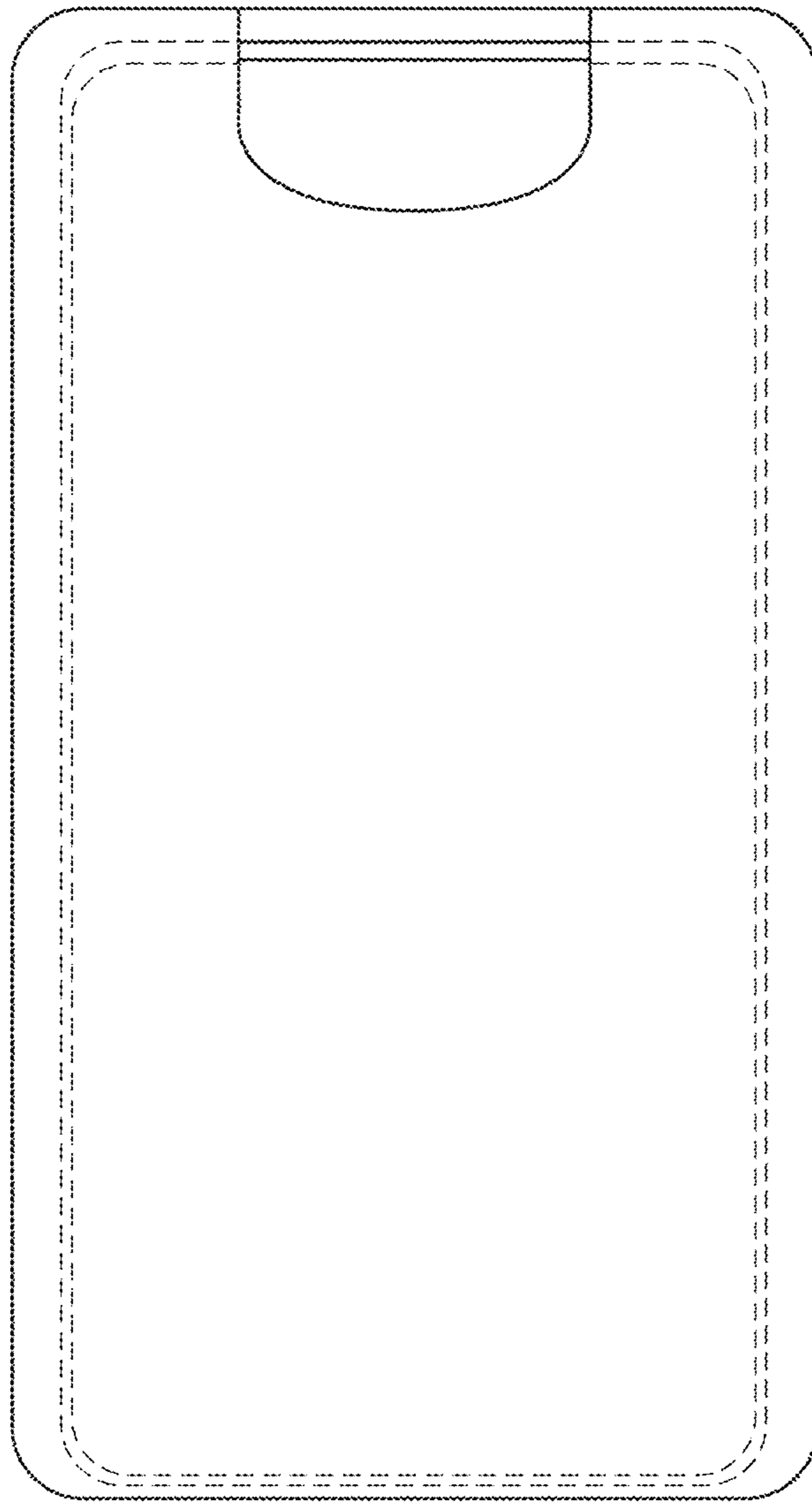

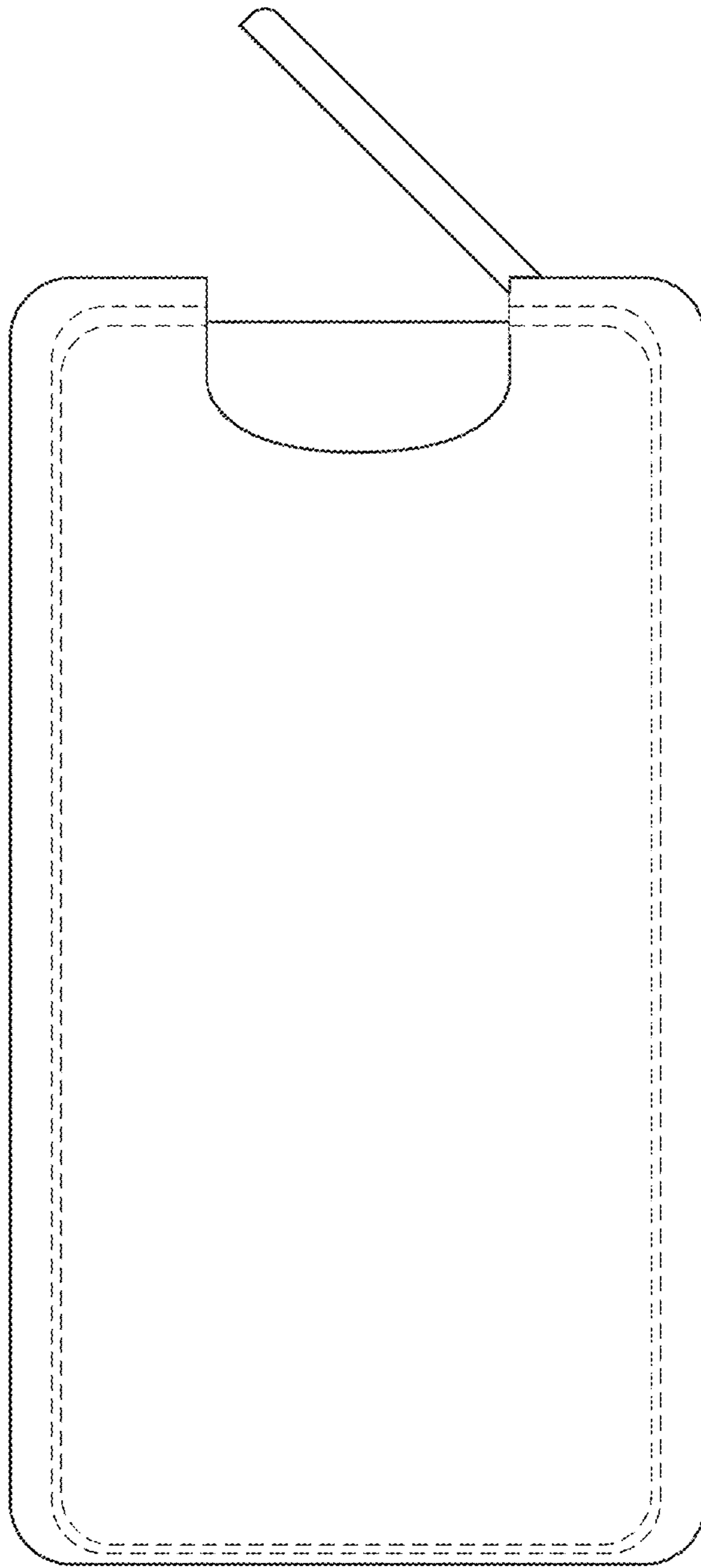

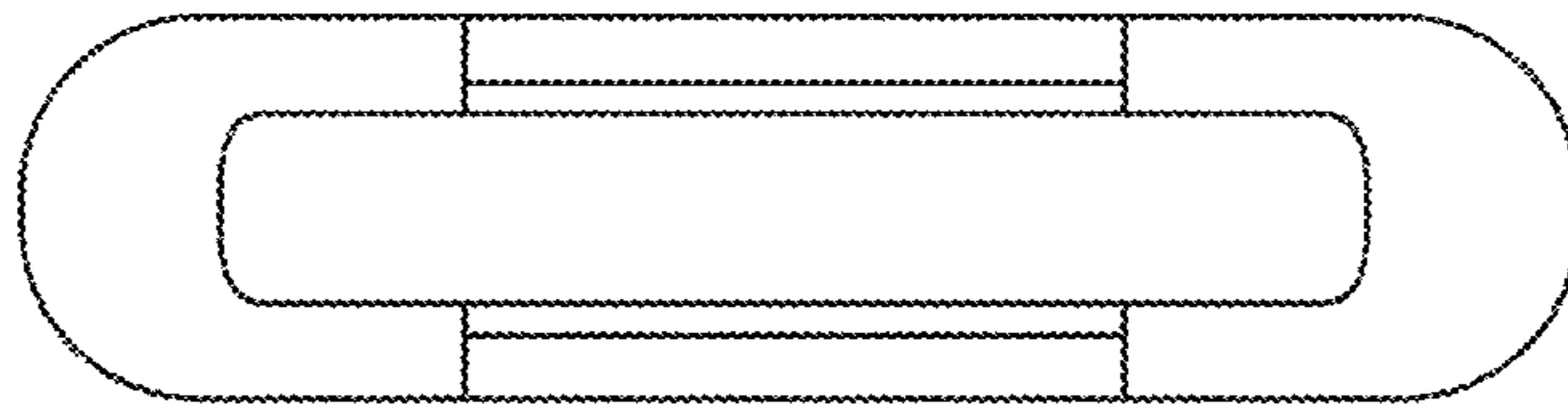
