transparent film to a flat base, as shown and described.

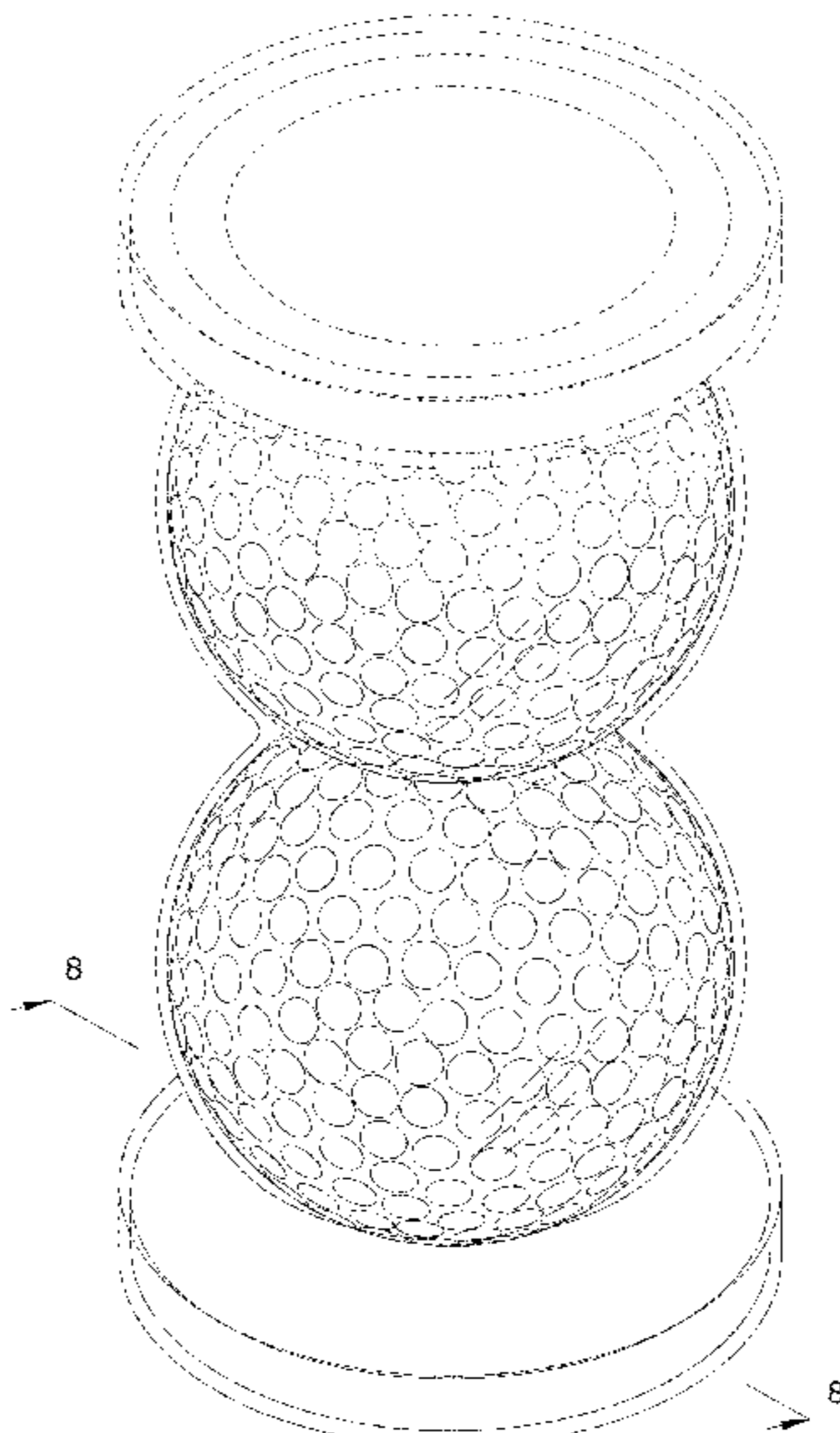
**DESCRIPTION**

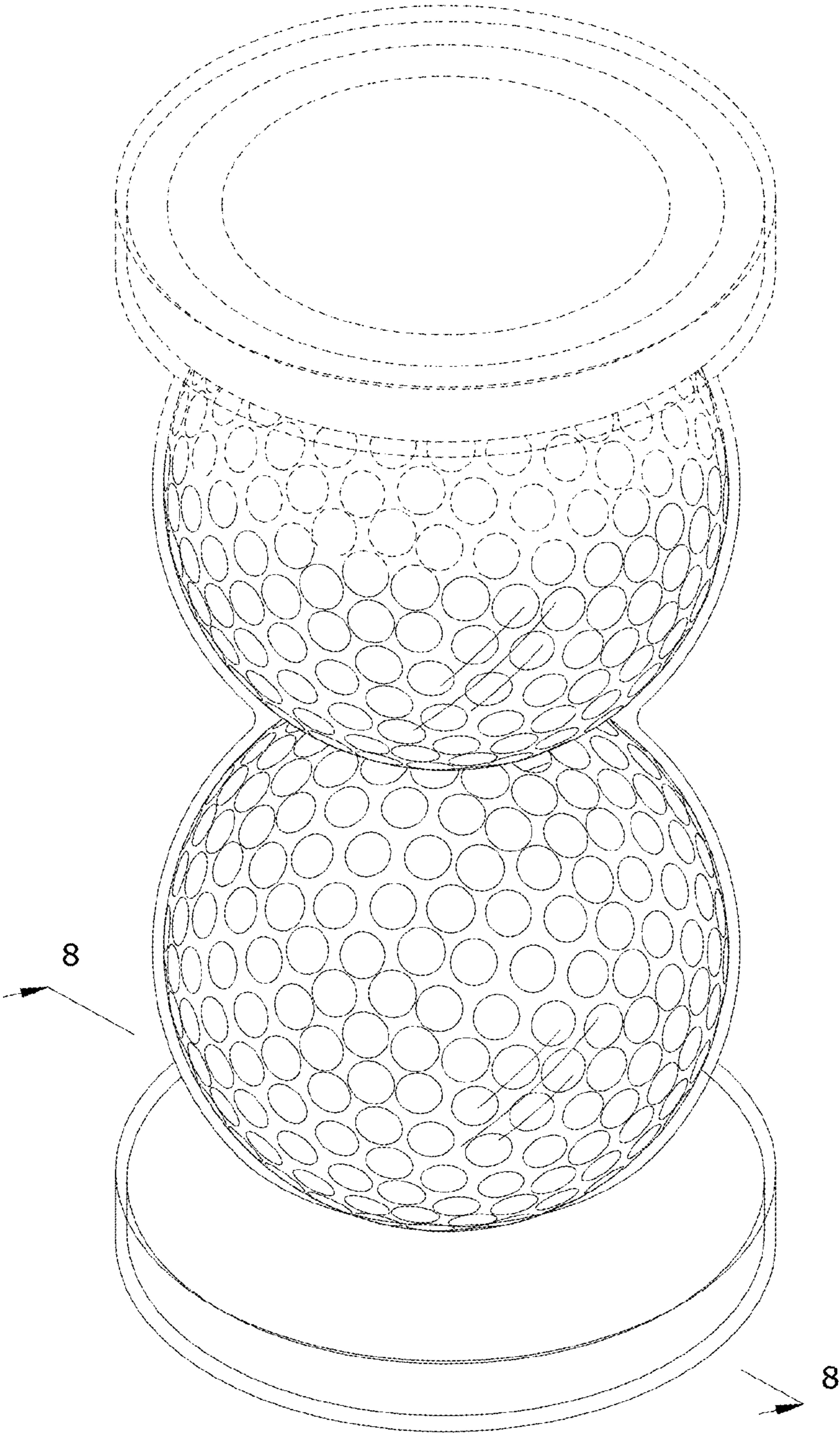

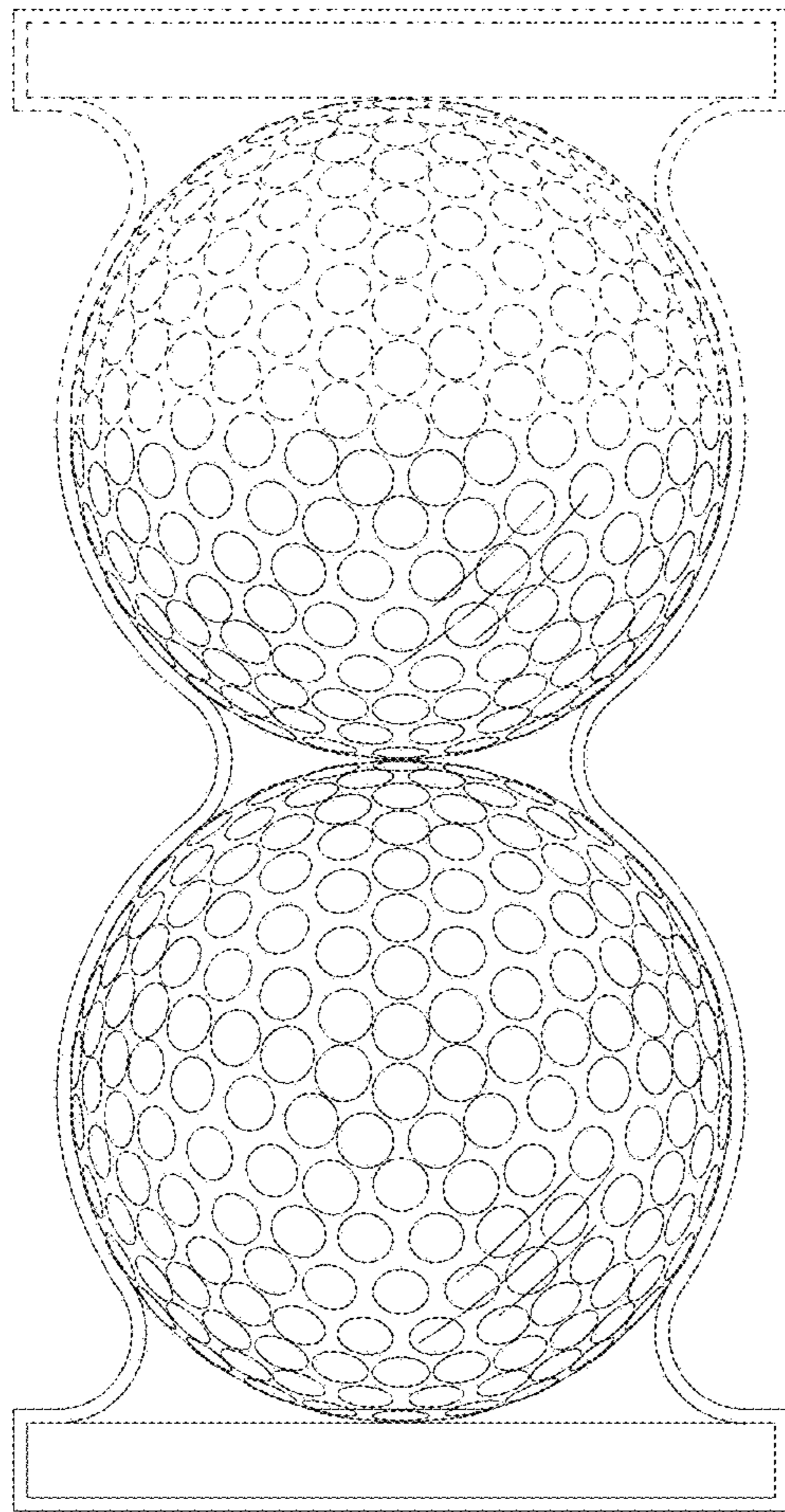

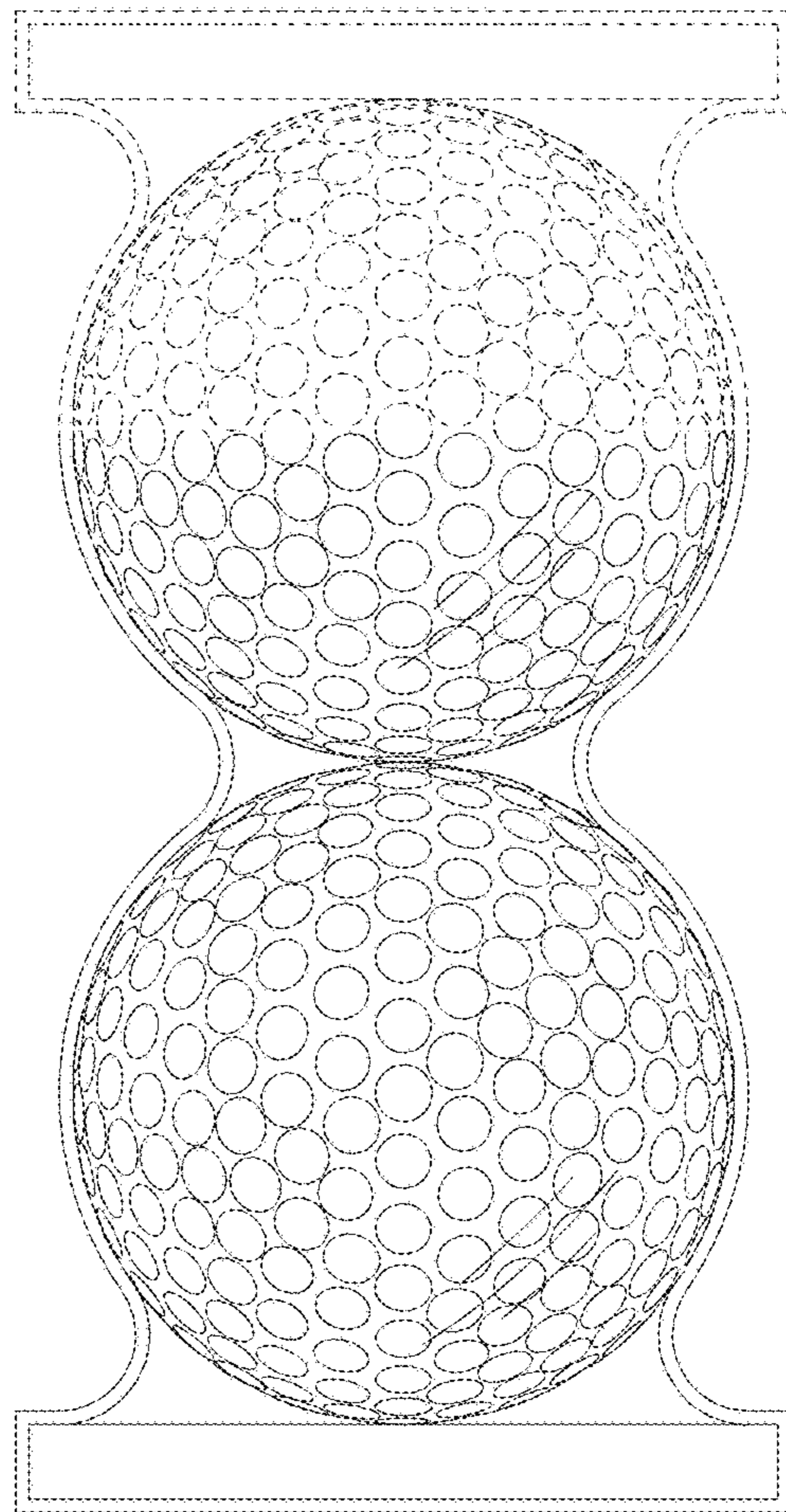

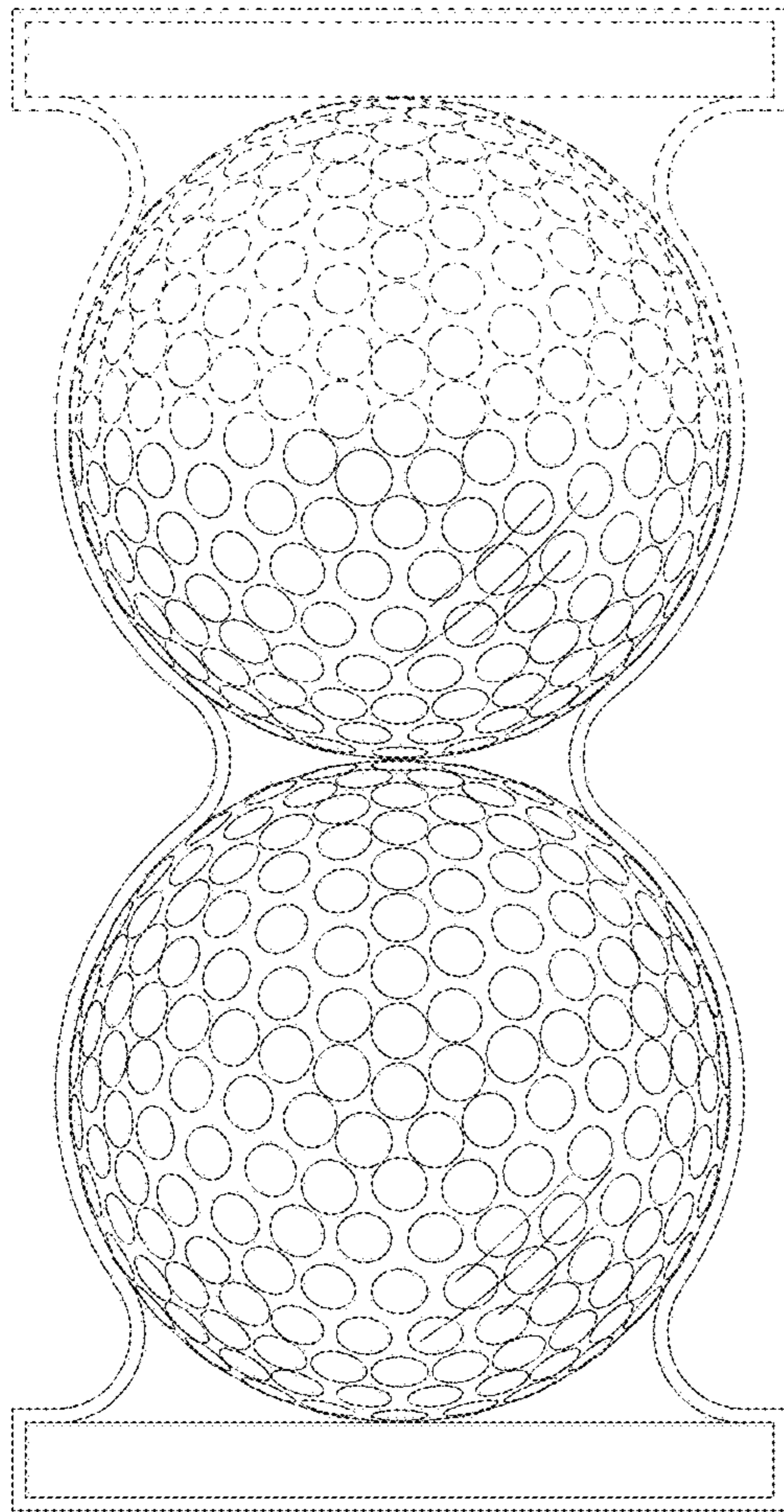

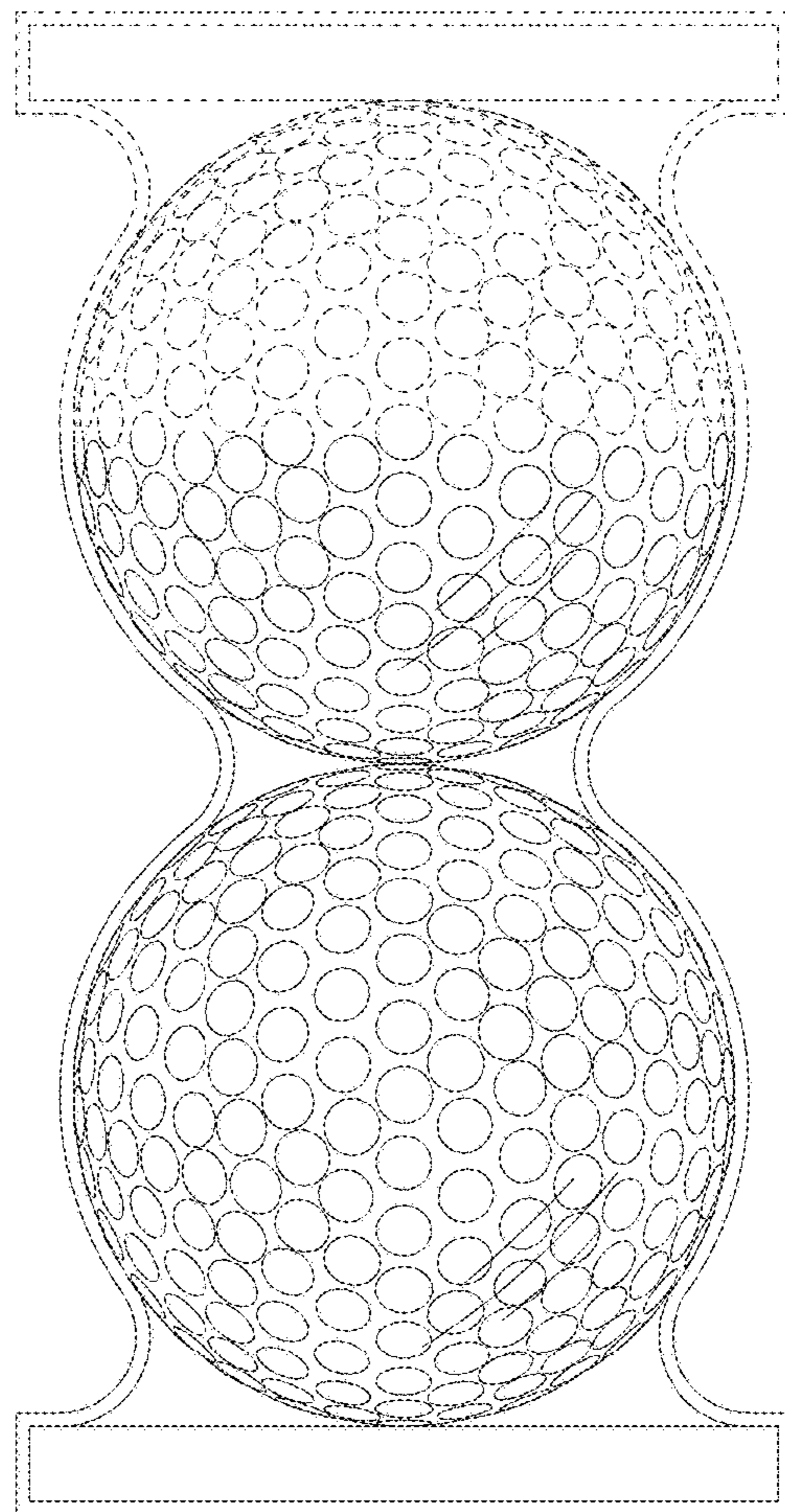

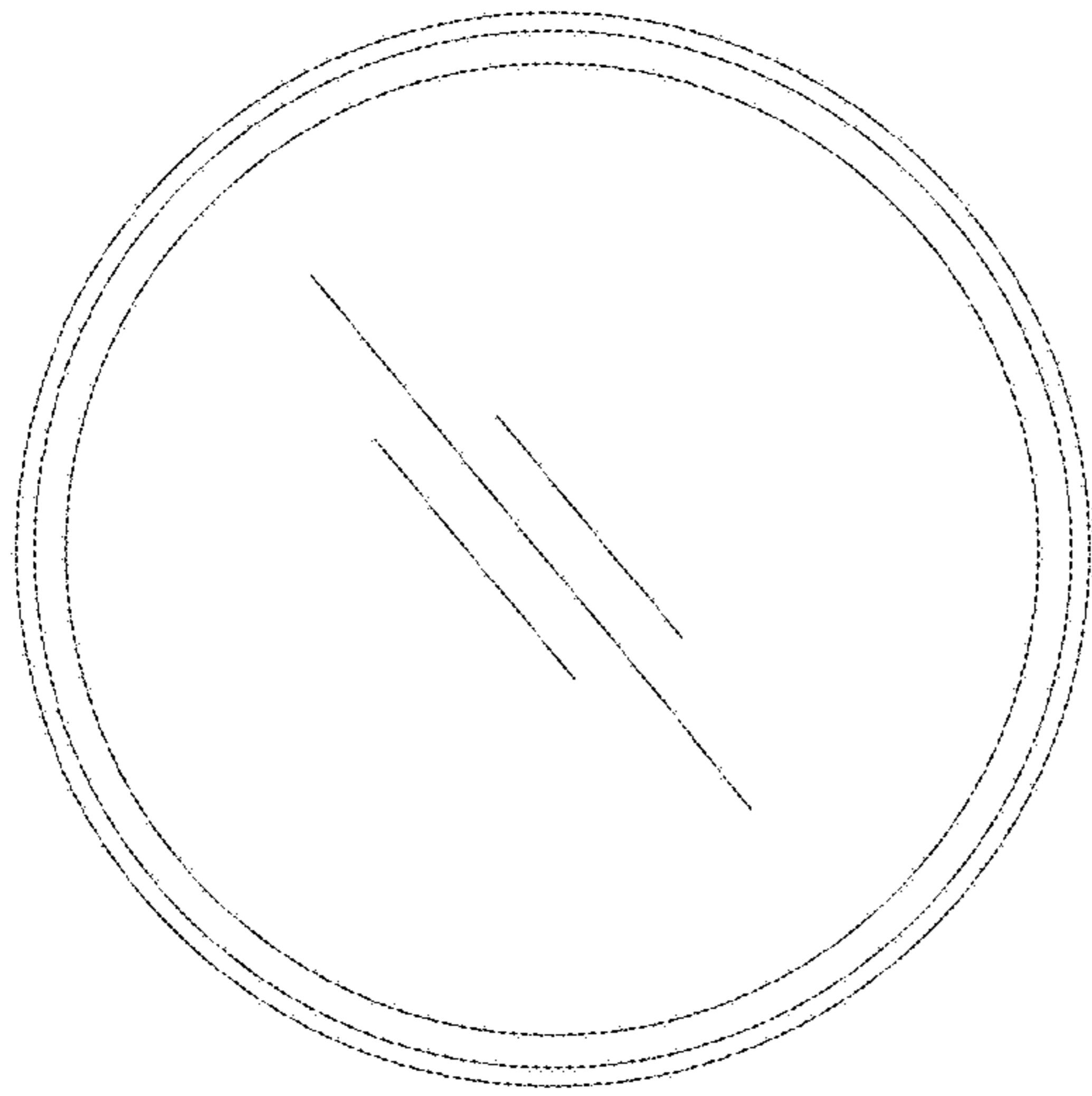

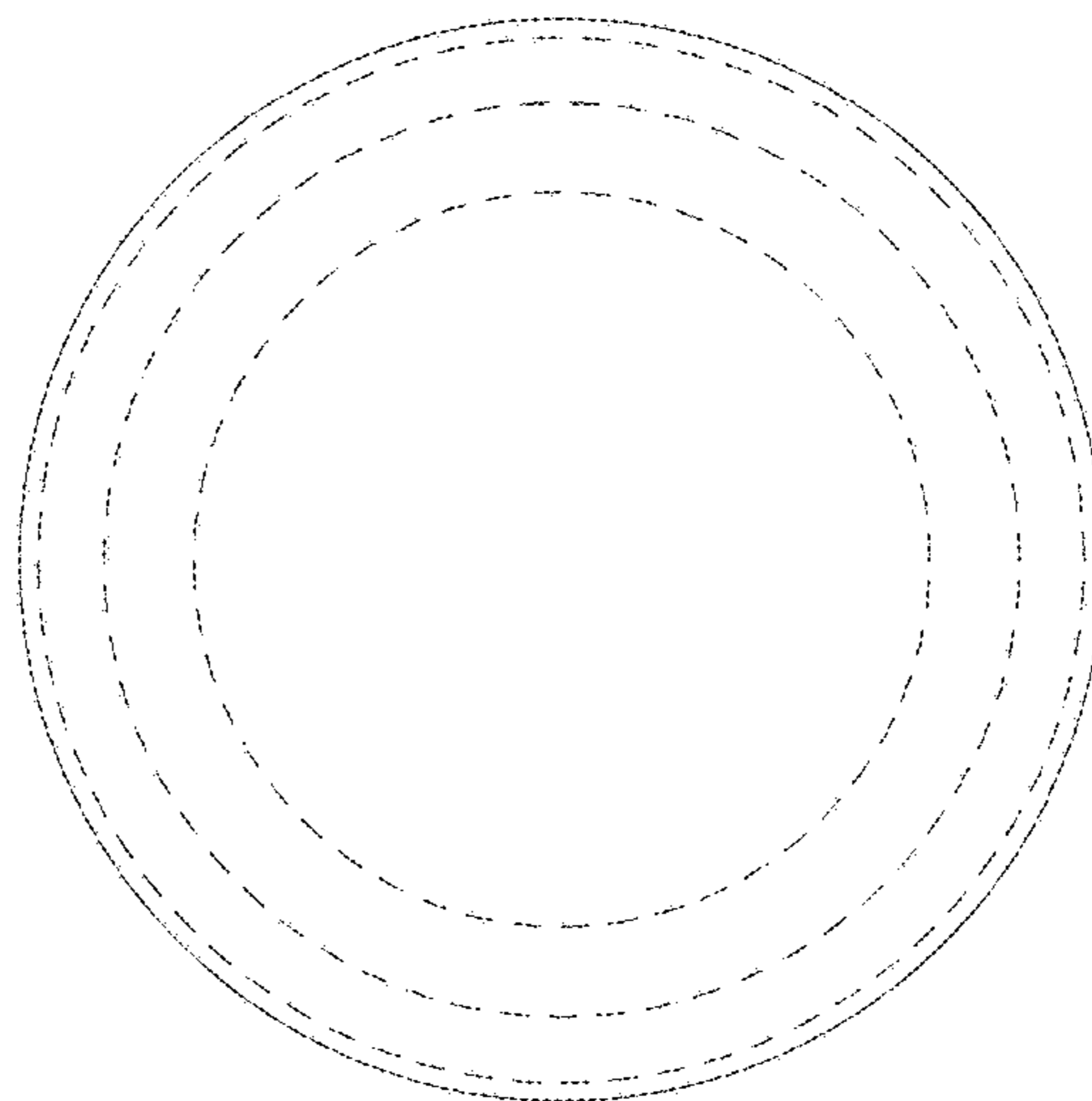

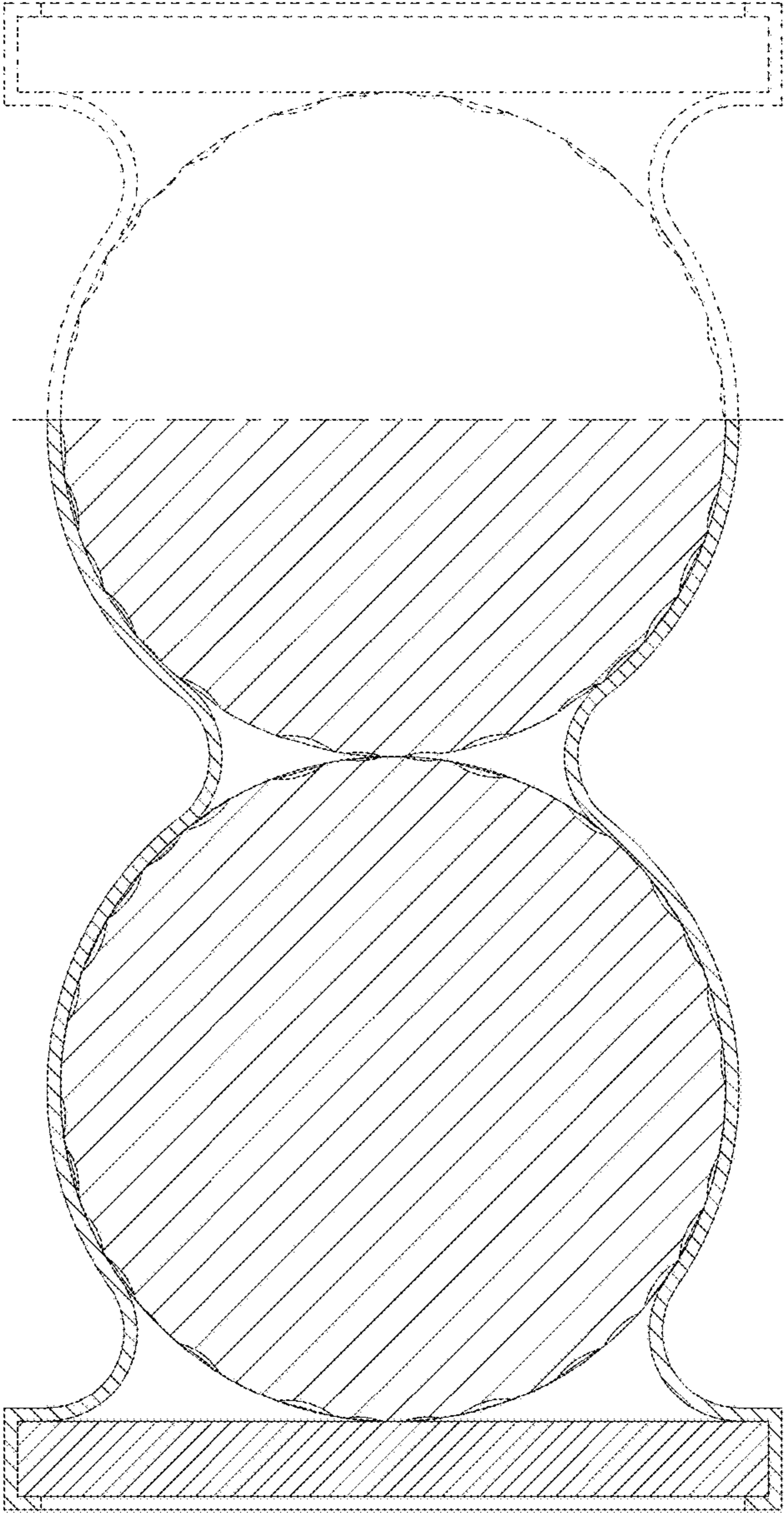
