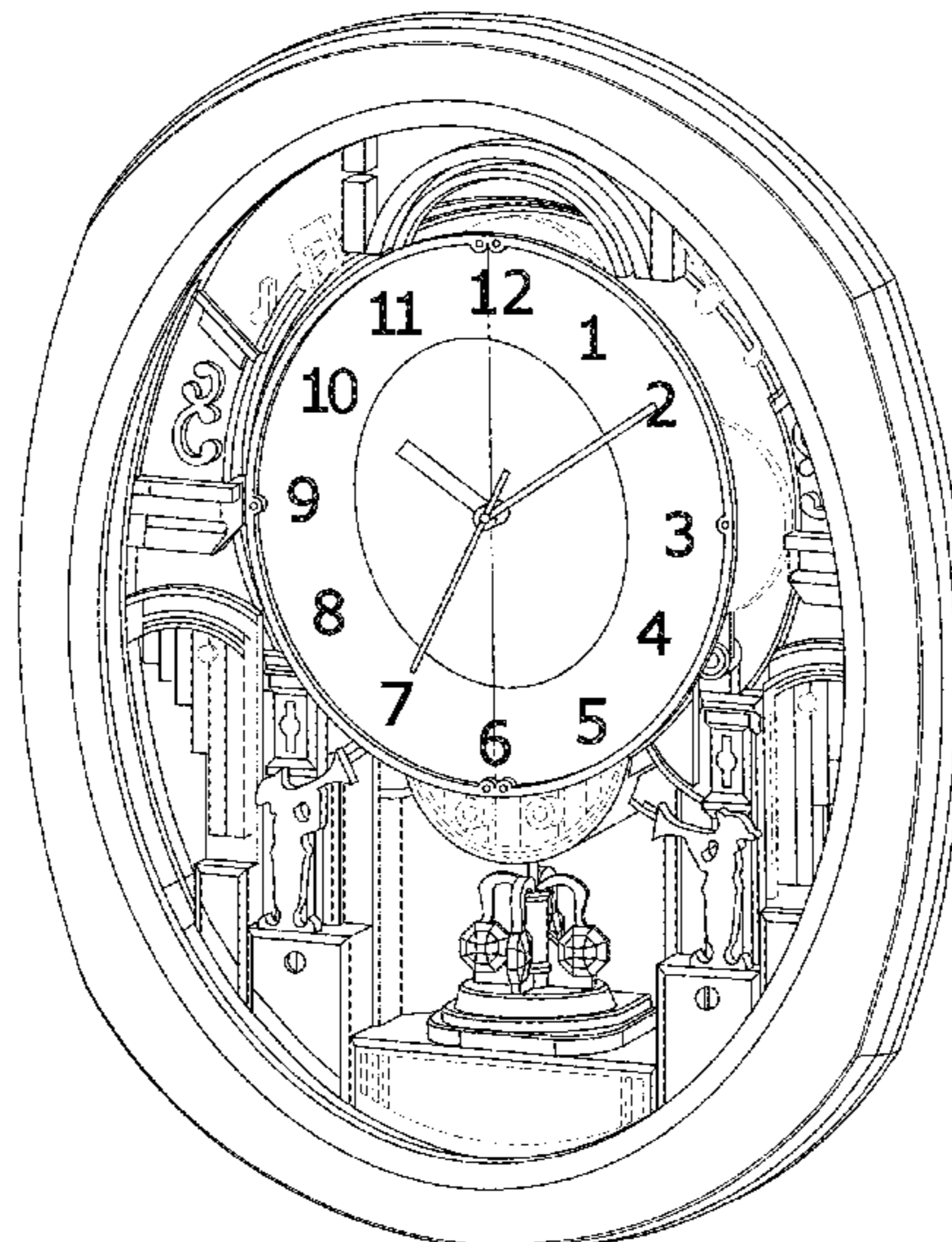
(57) **CLAIM**

The ornamental design for a clock, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a clock showing my new design;
 FIG. 2 is a front view thereof when a clock face is situated at an upper position;
 FIG. 3 is a rear view thereof;
 FIG. 4 is a left side view thereof;
 FIG. 5 is a right side view thereof;
 FIG. 6 is a top plan view thereof;
 FIG. 7 is a bottom view thereof; and
 FIG. 8 is a front view thereof when the clock face is moving downwardly;
 FIG. 9 is a front view thereof when the clock face is situated at a lower position; and,
 FIG. 10 is a perspective view thereof with a transparent front plate.

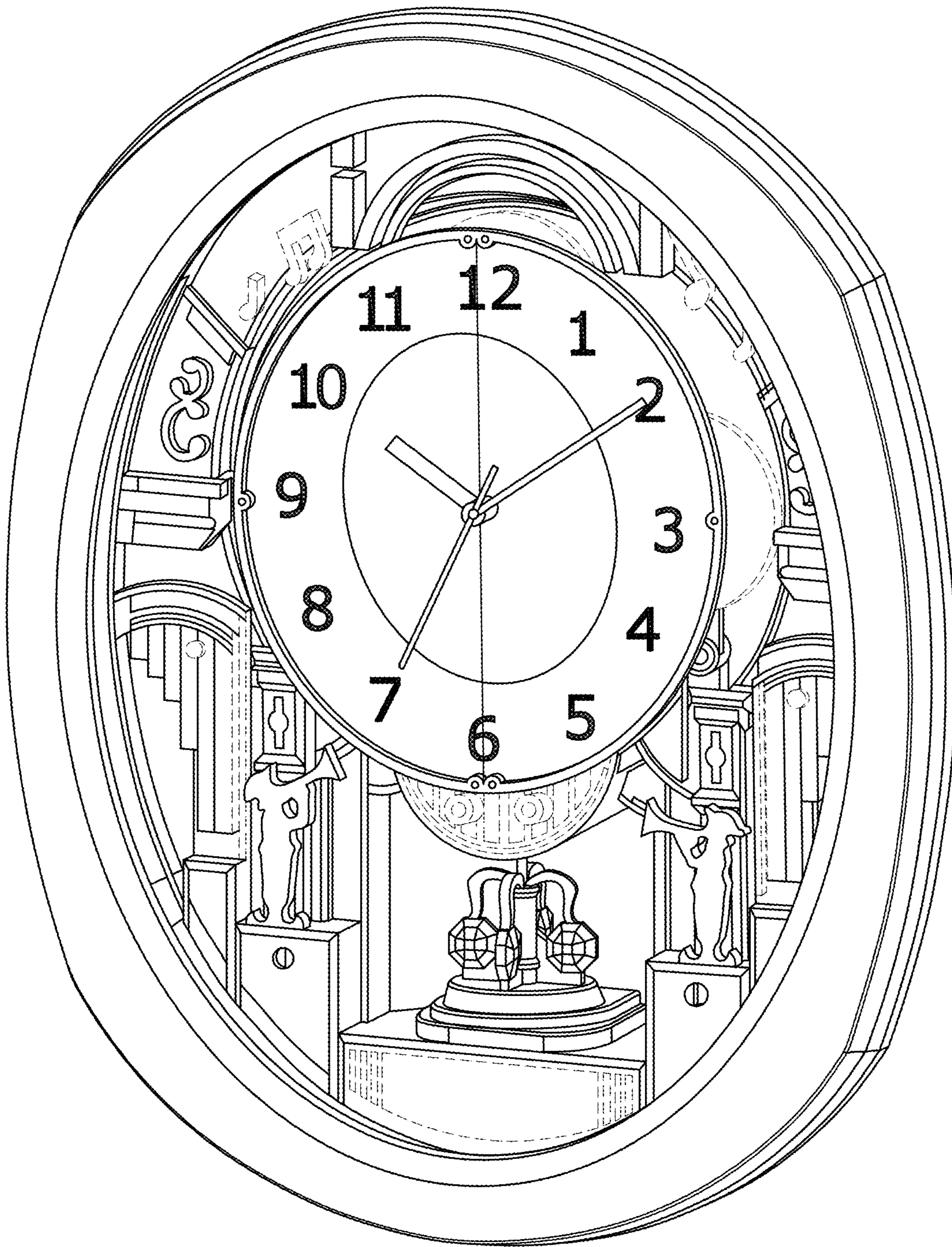

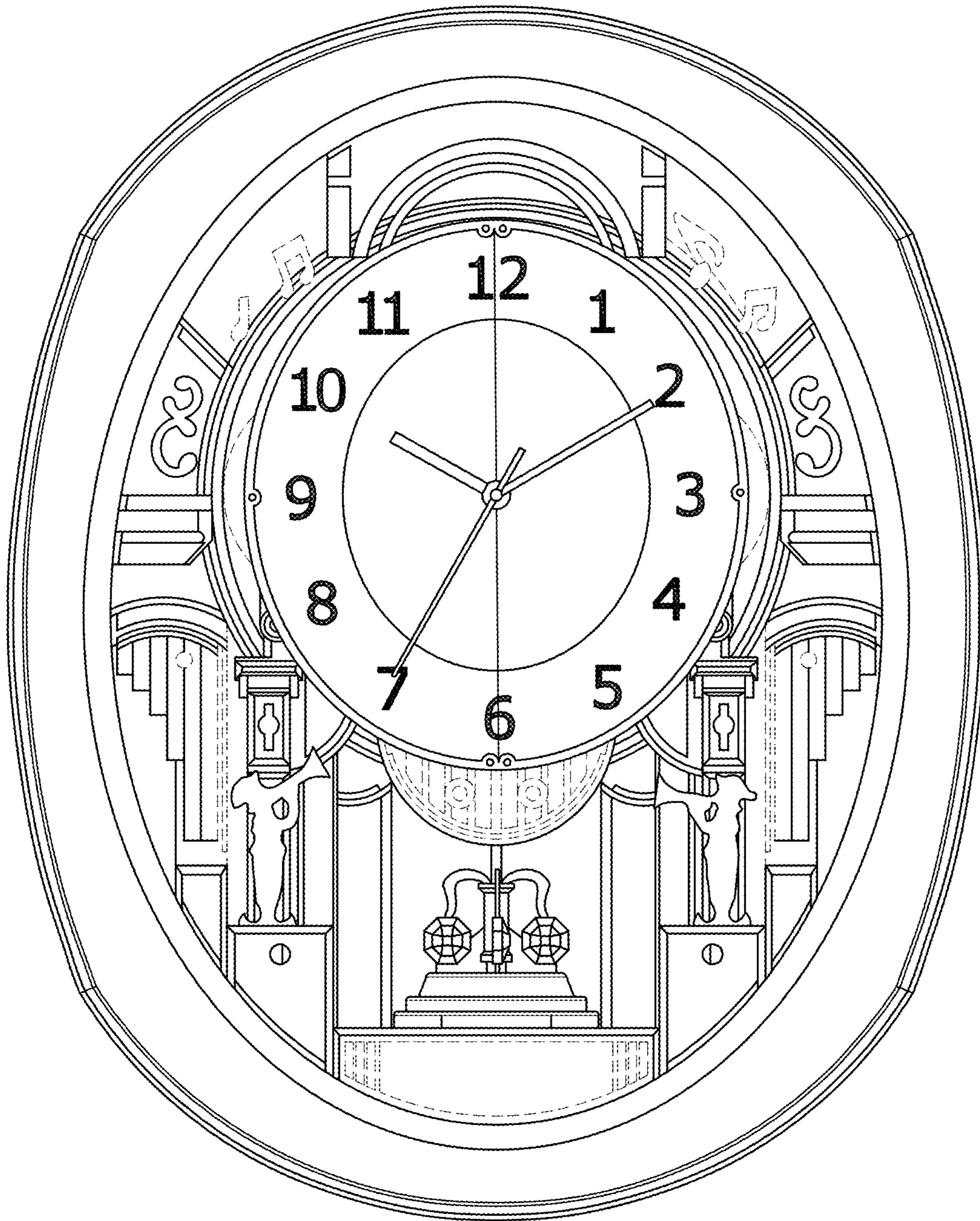

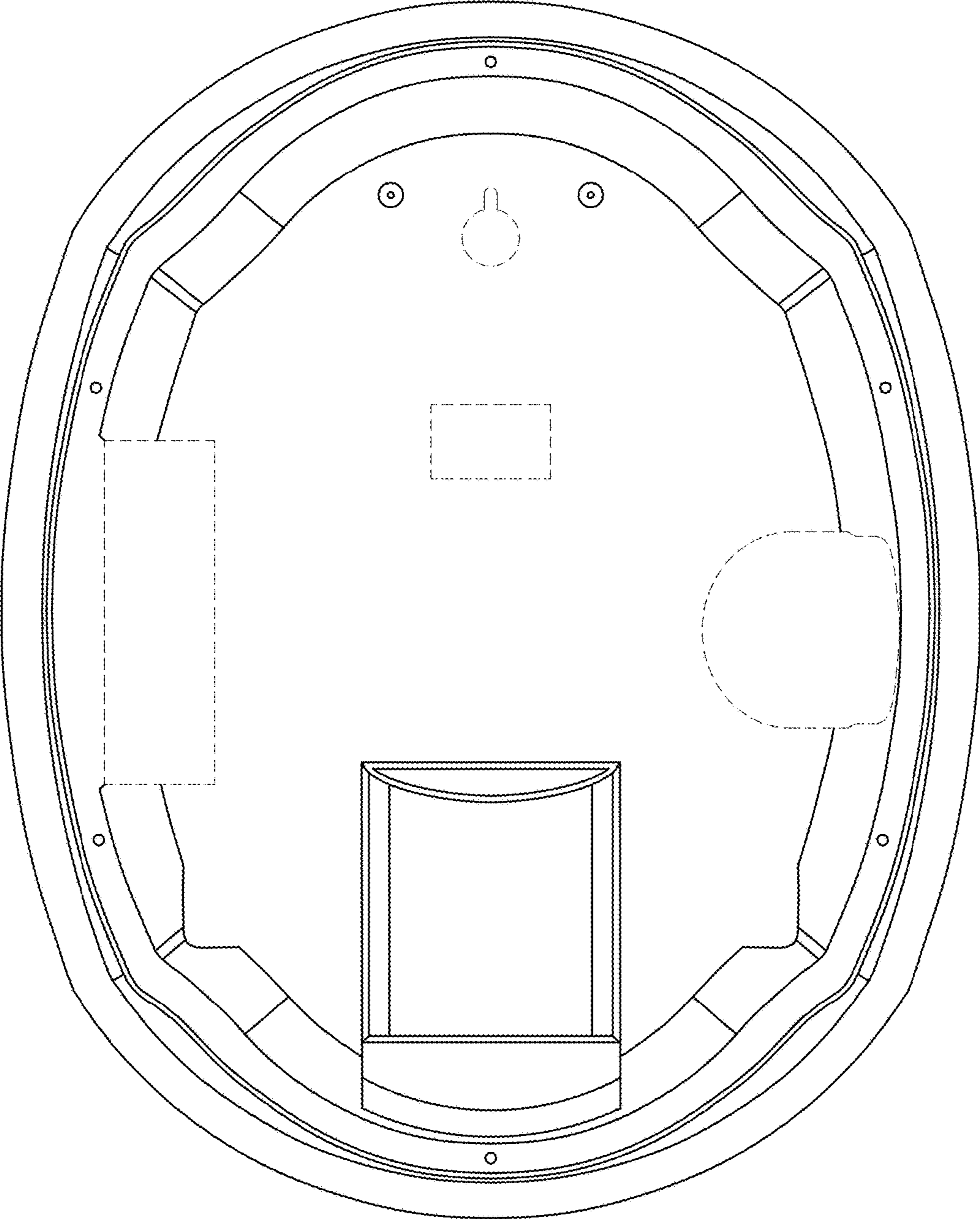

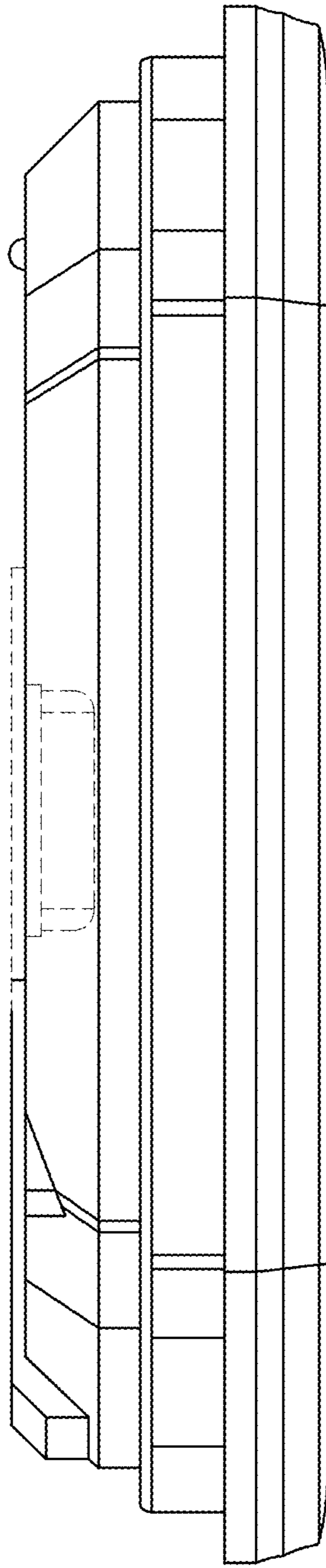

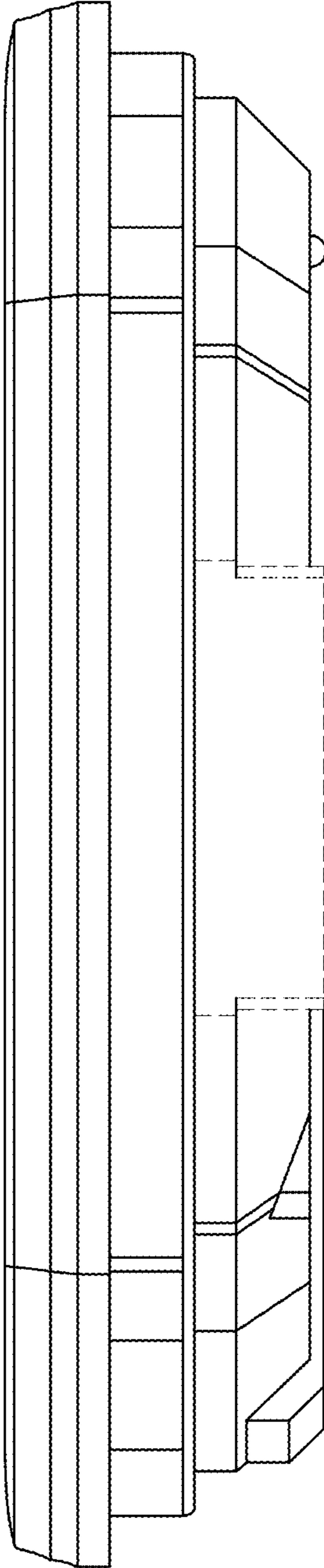

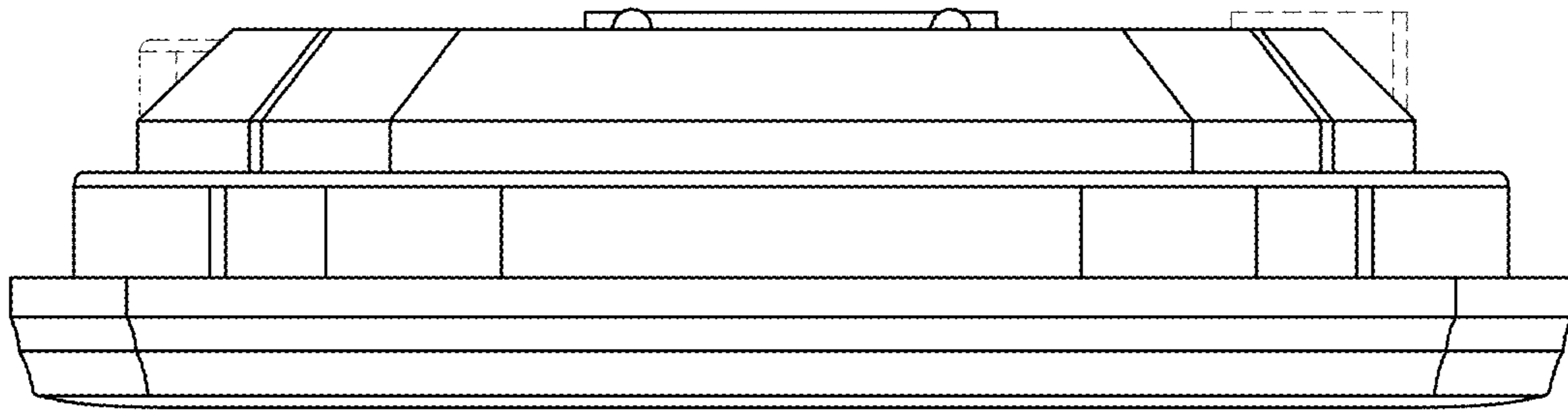

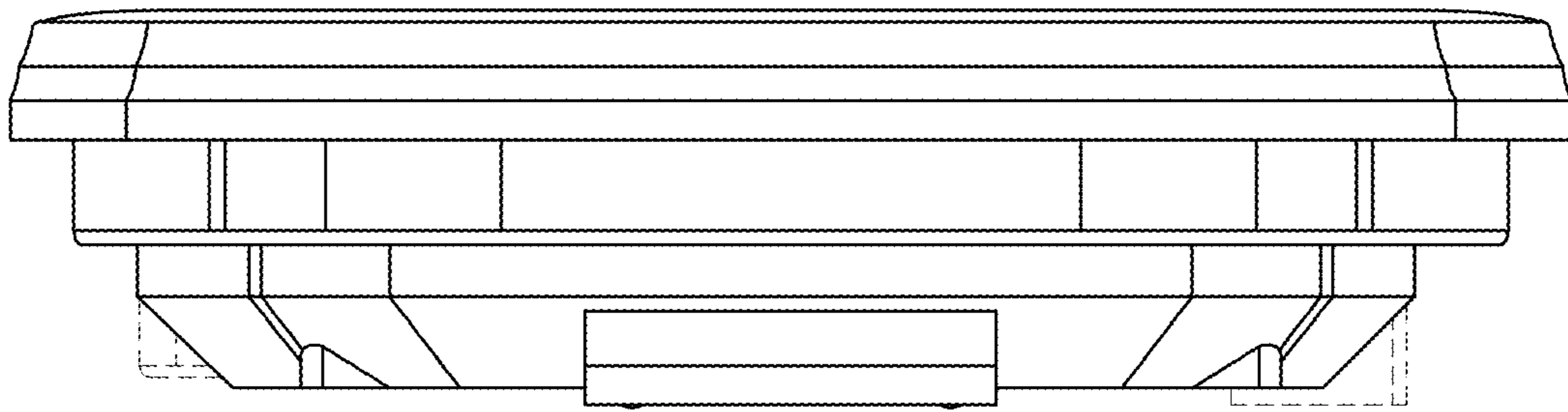

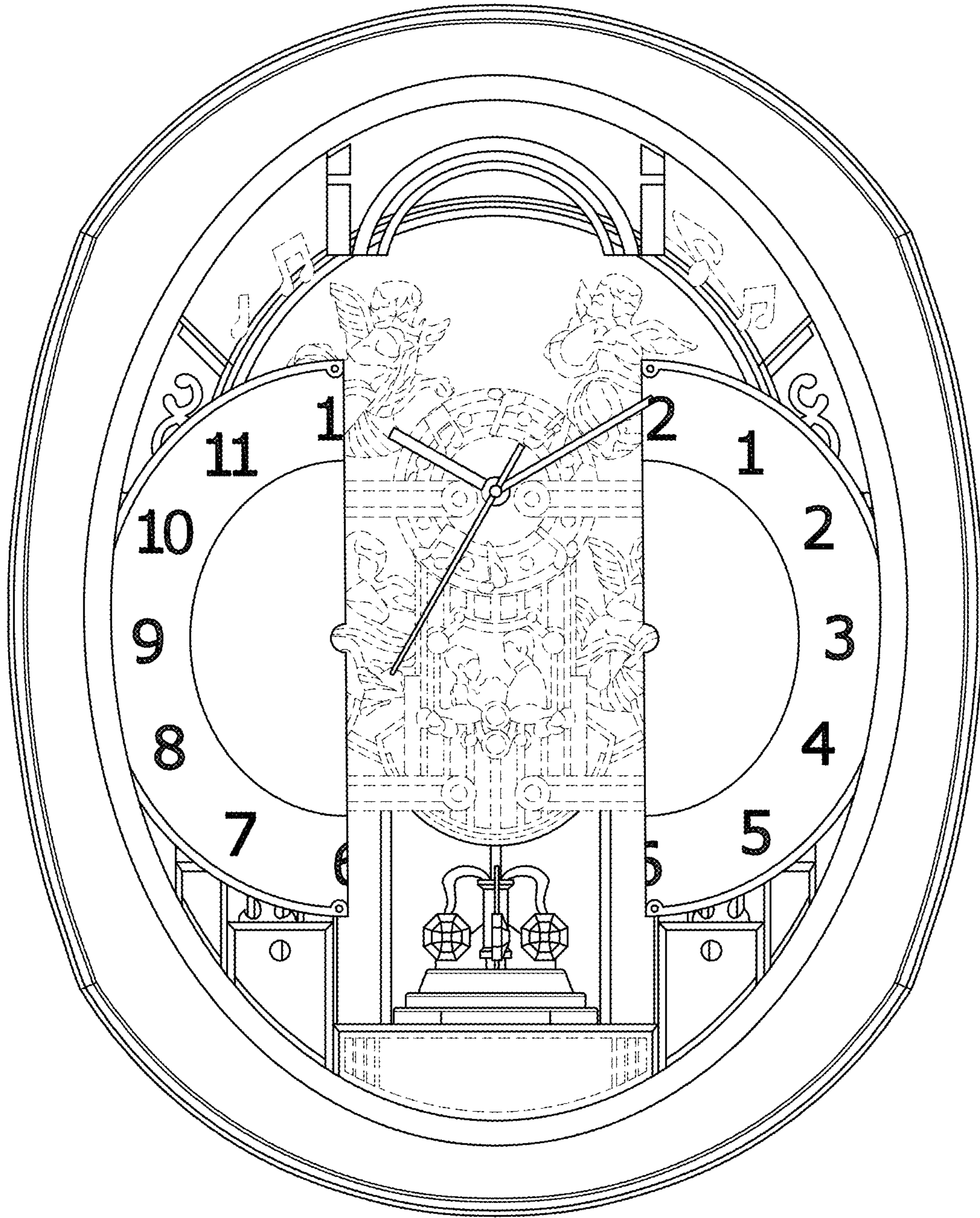

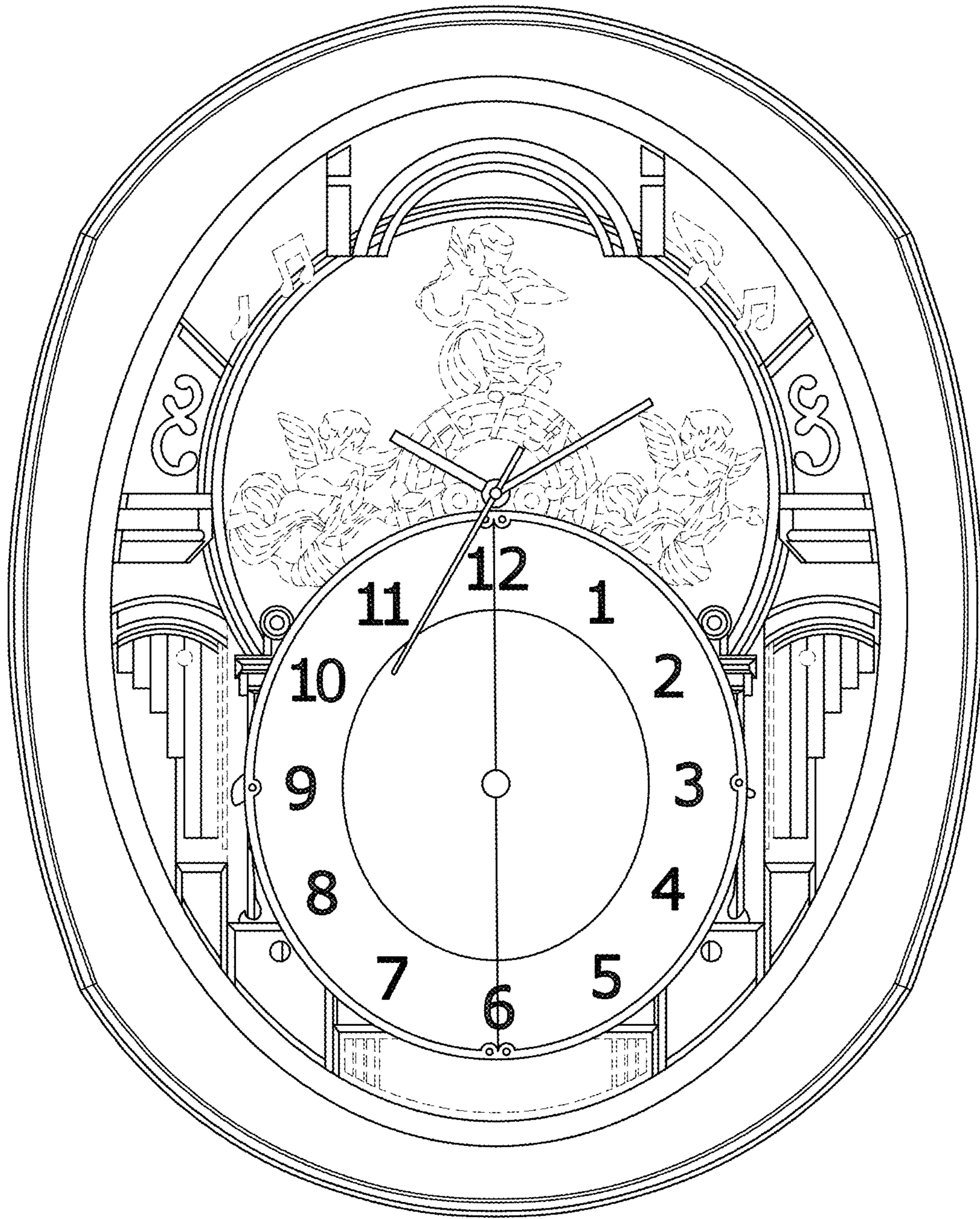

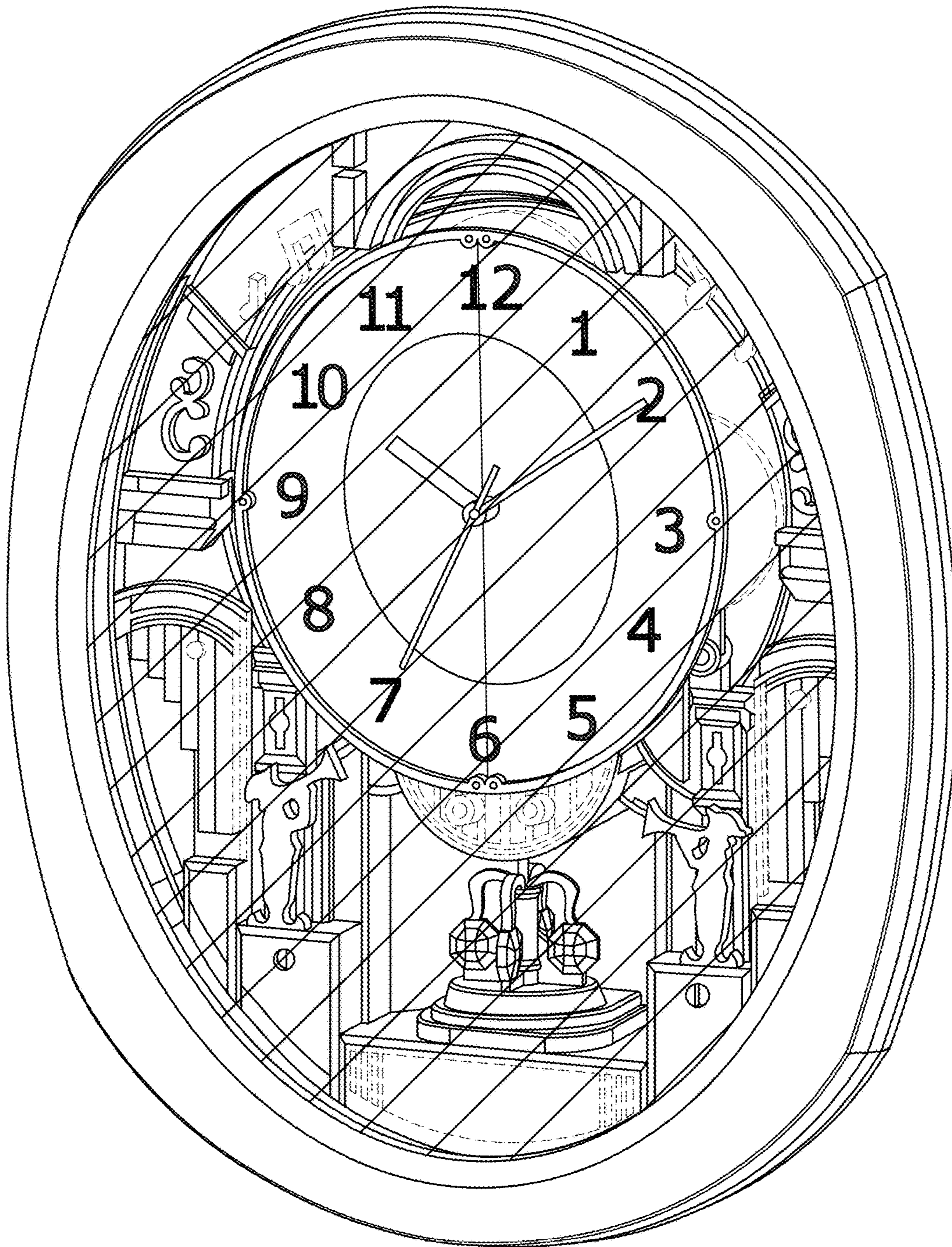
