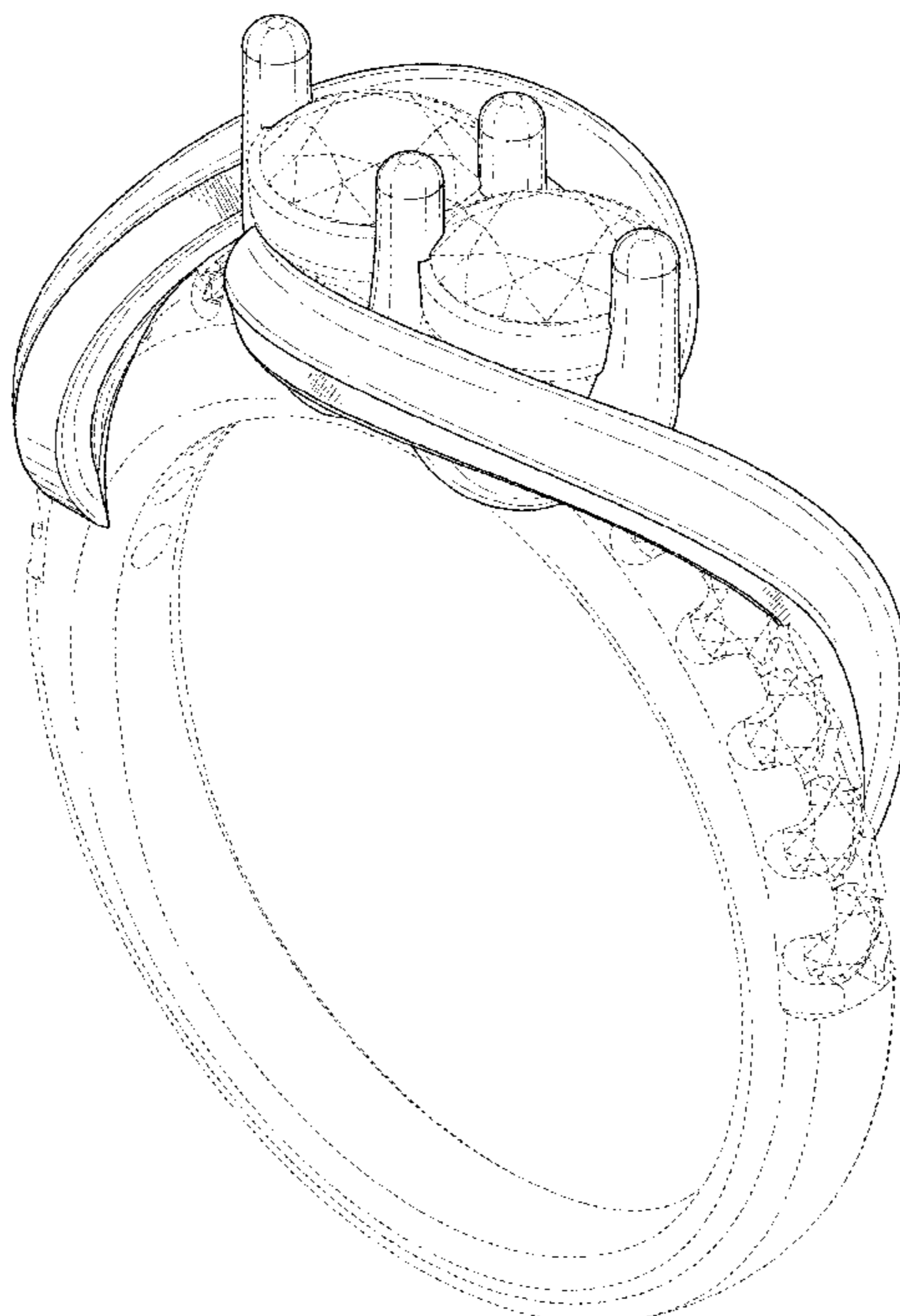
The ornamental design for a two stone setting with surround, as shown and described.

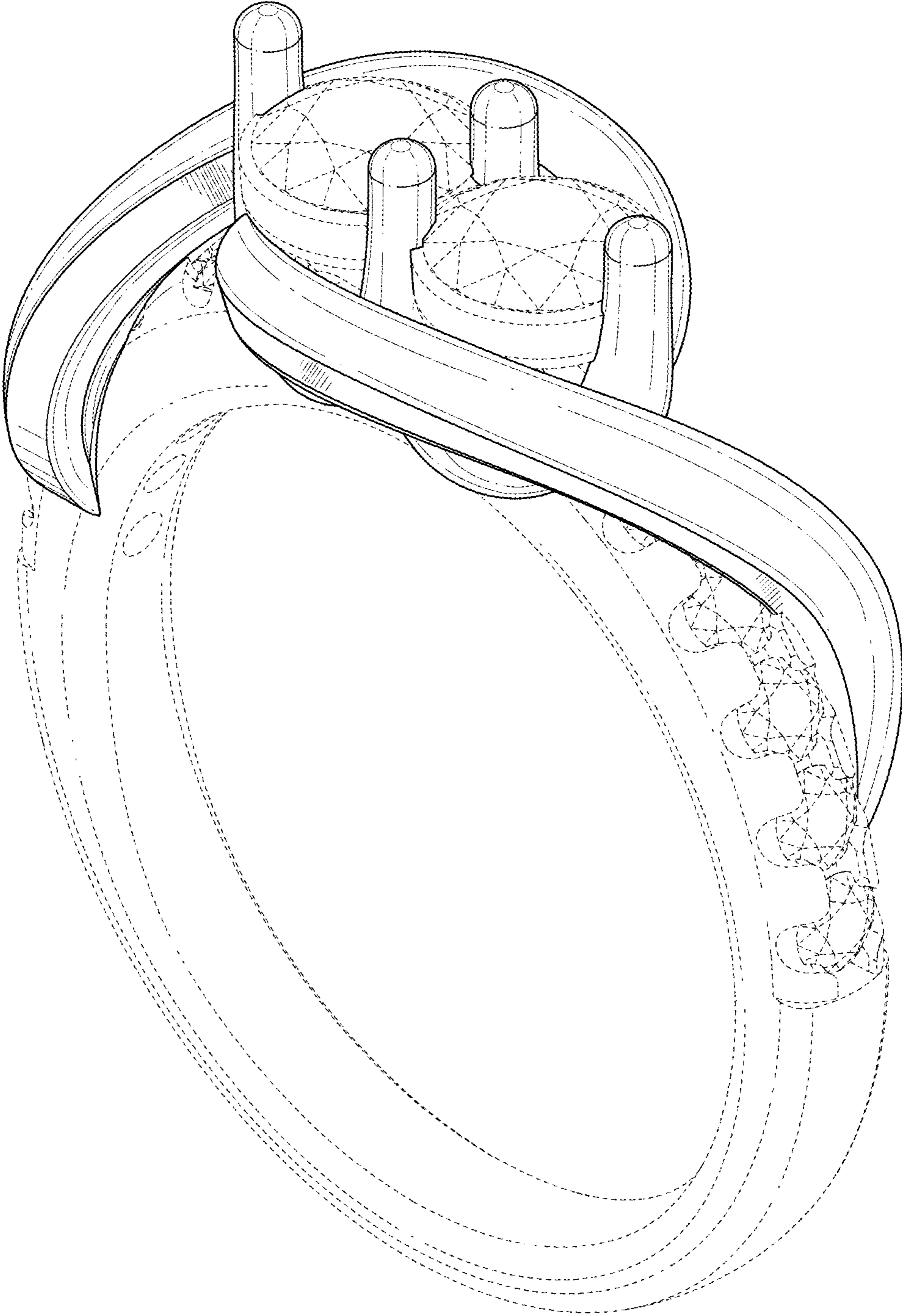
**DESCRIPTION**

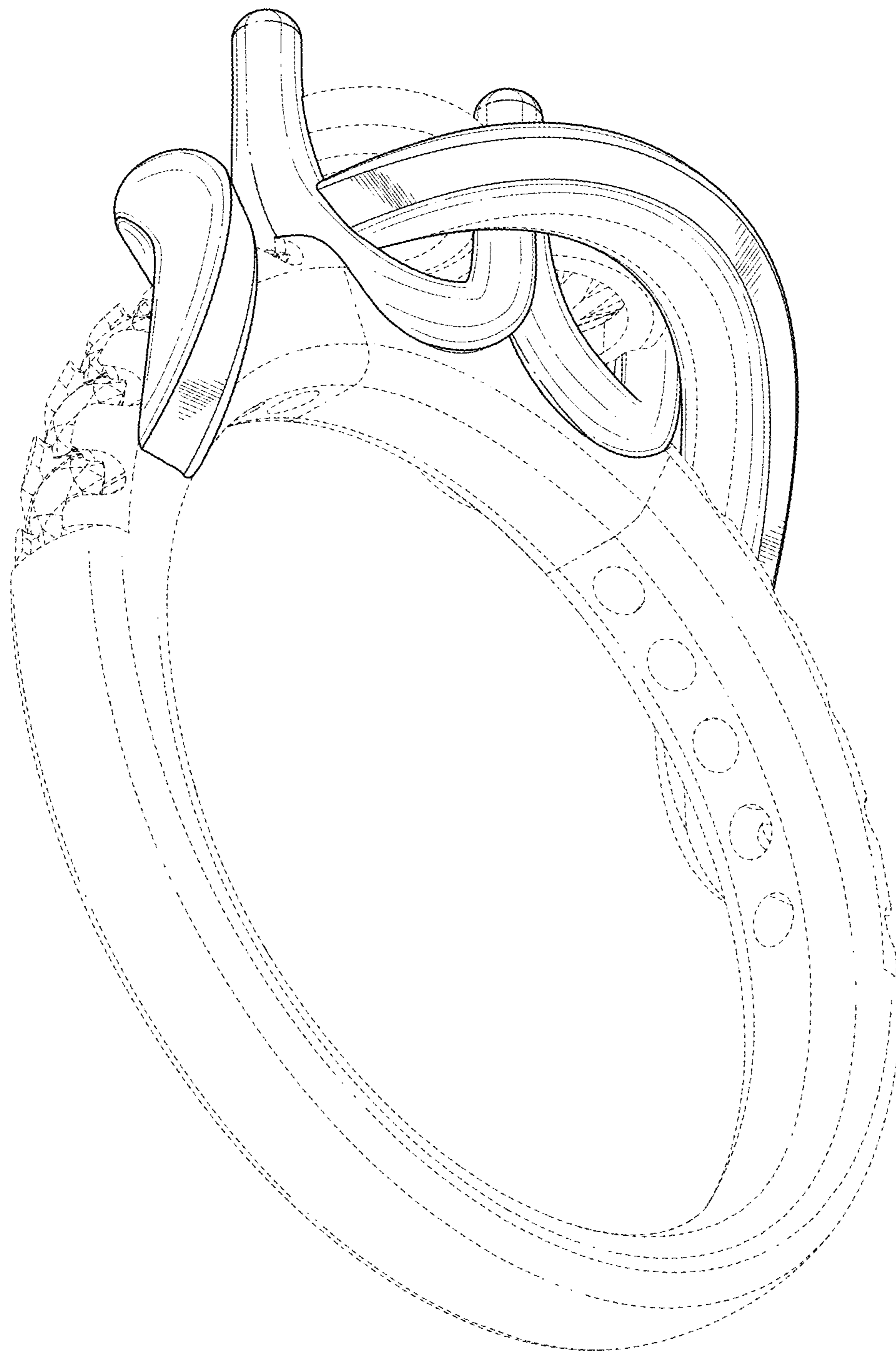
The broken lines shown in the figures illustrate unclaimed portions of the design.

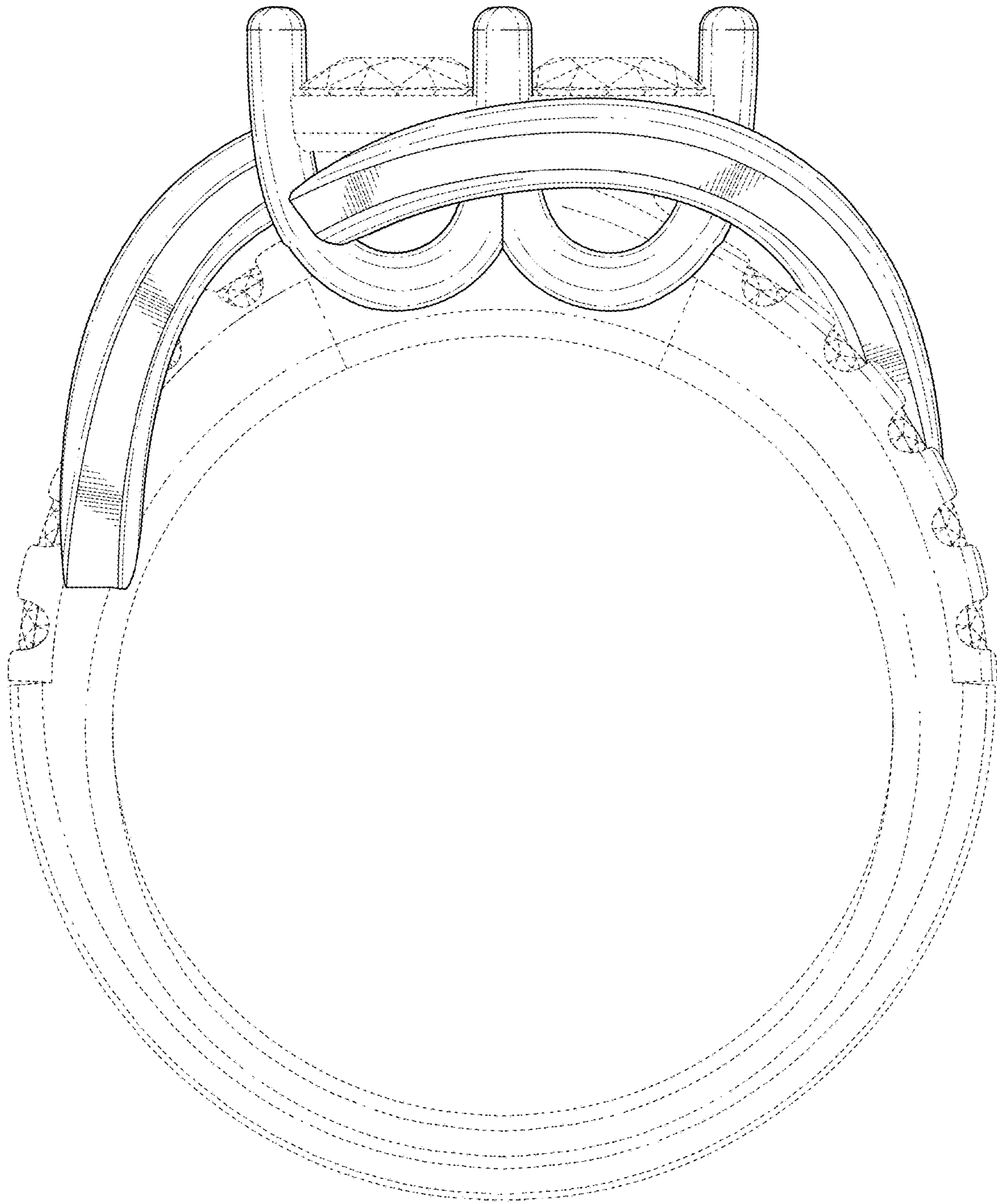




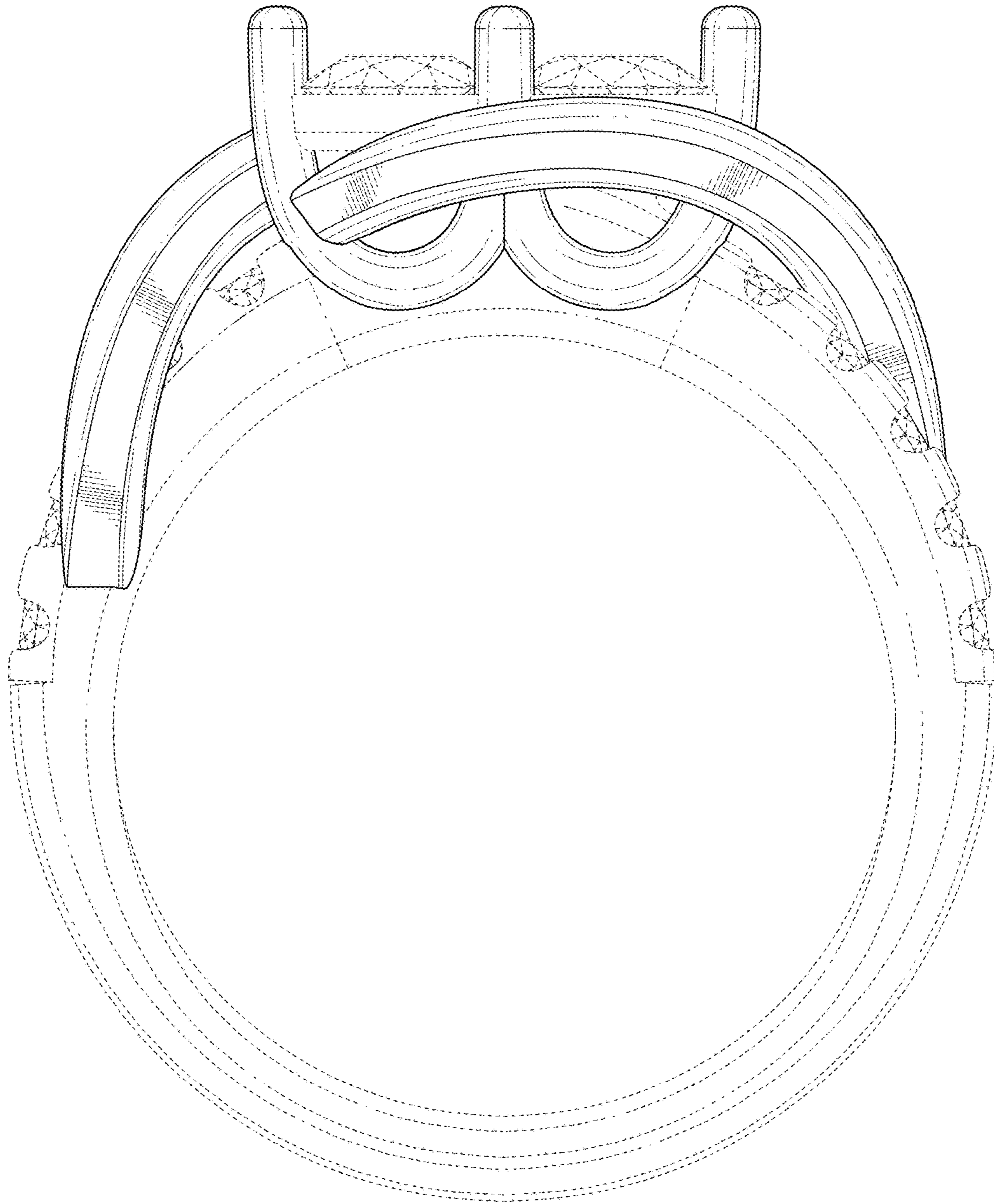

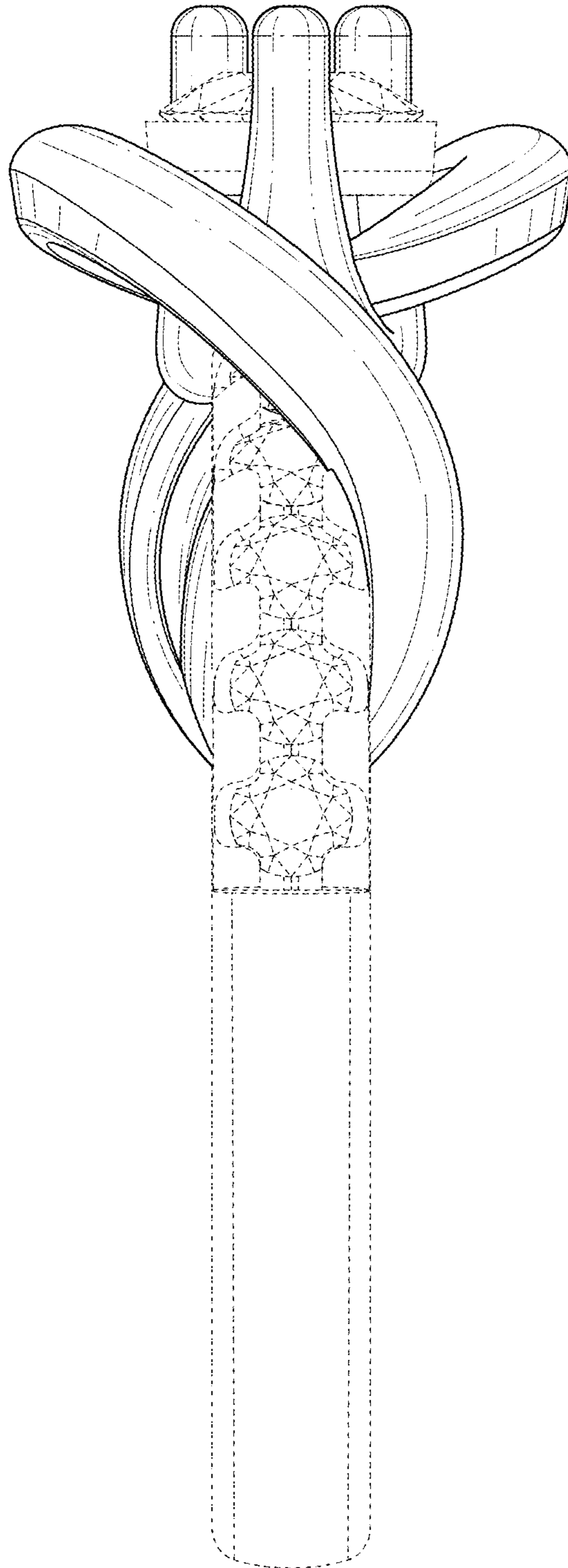

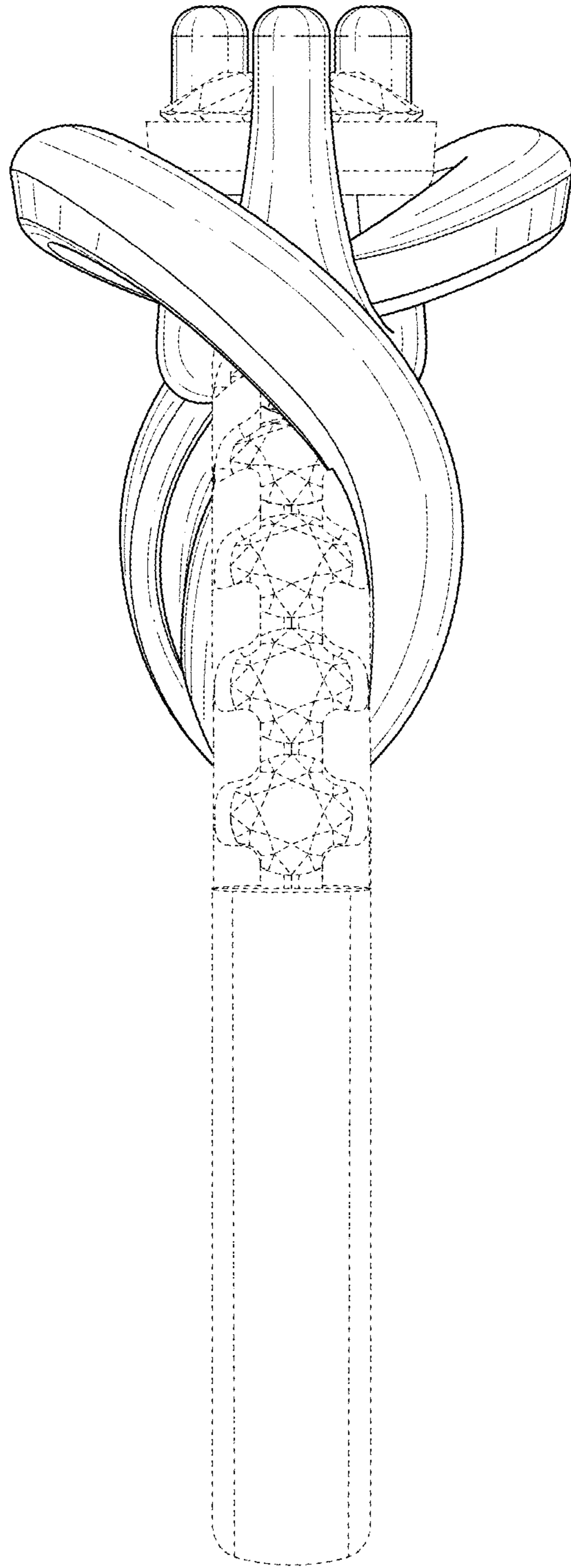

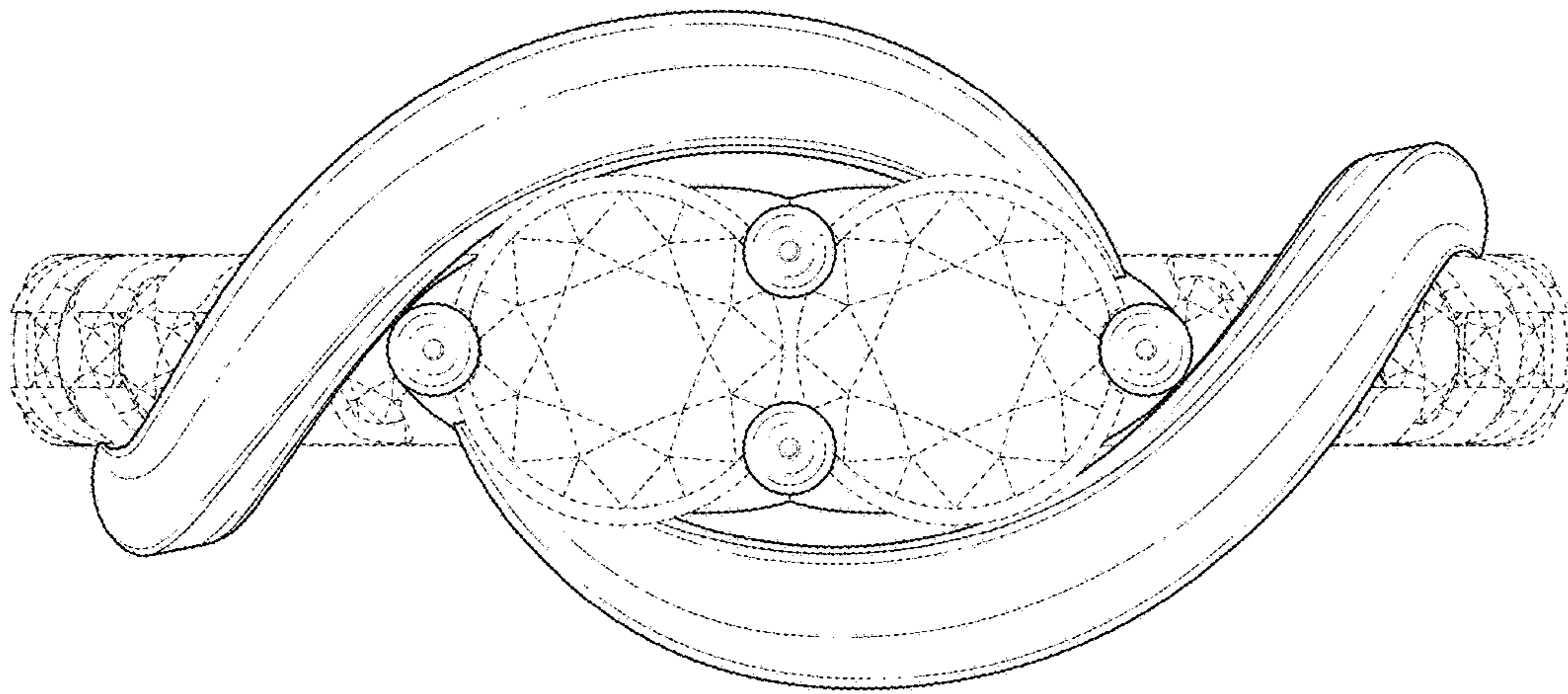

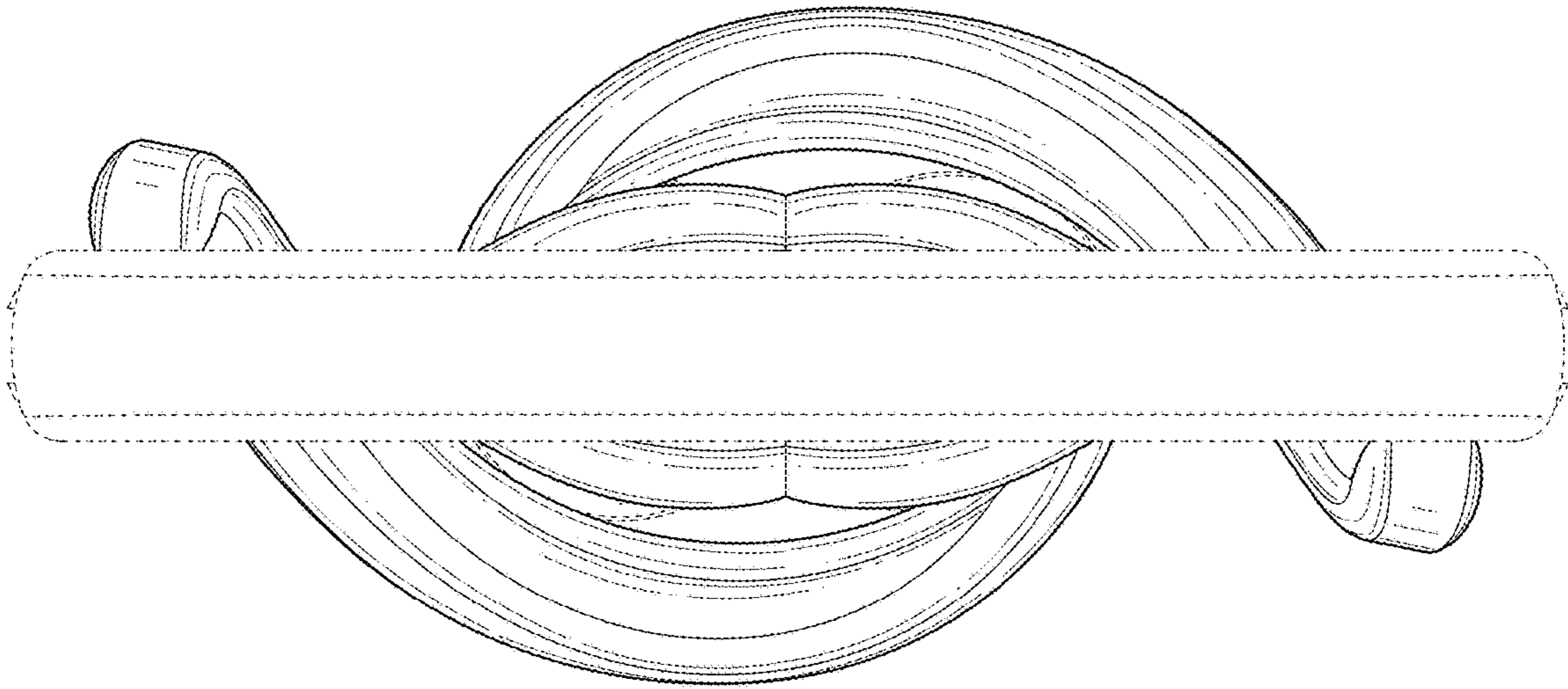
