DESCRIPTION

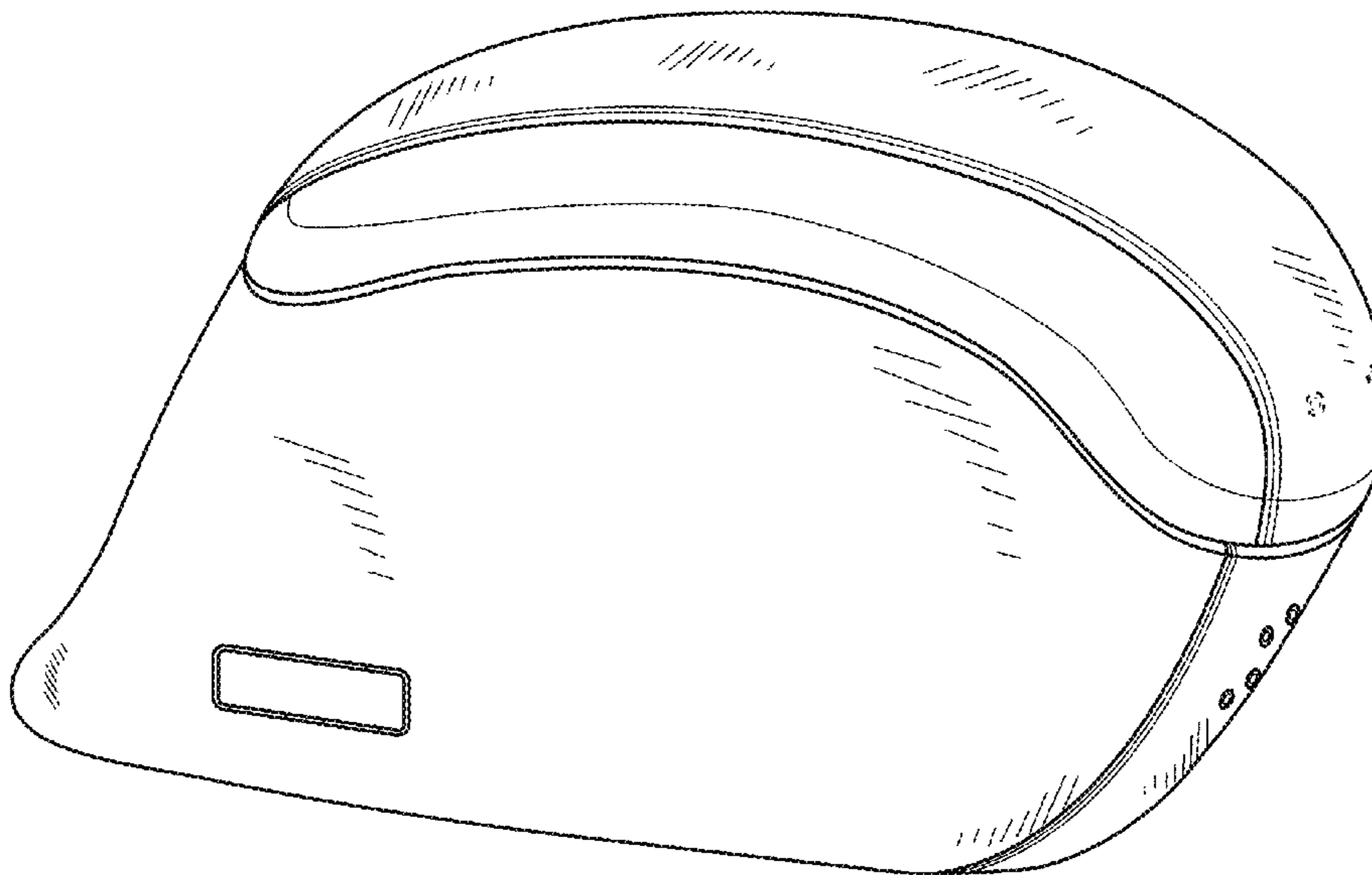
FIG. 1 is a perspective view of a side bag for motorcycle according to the claimed design;

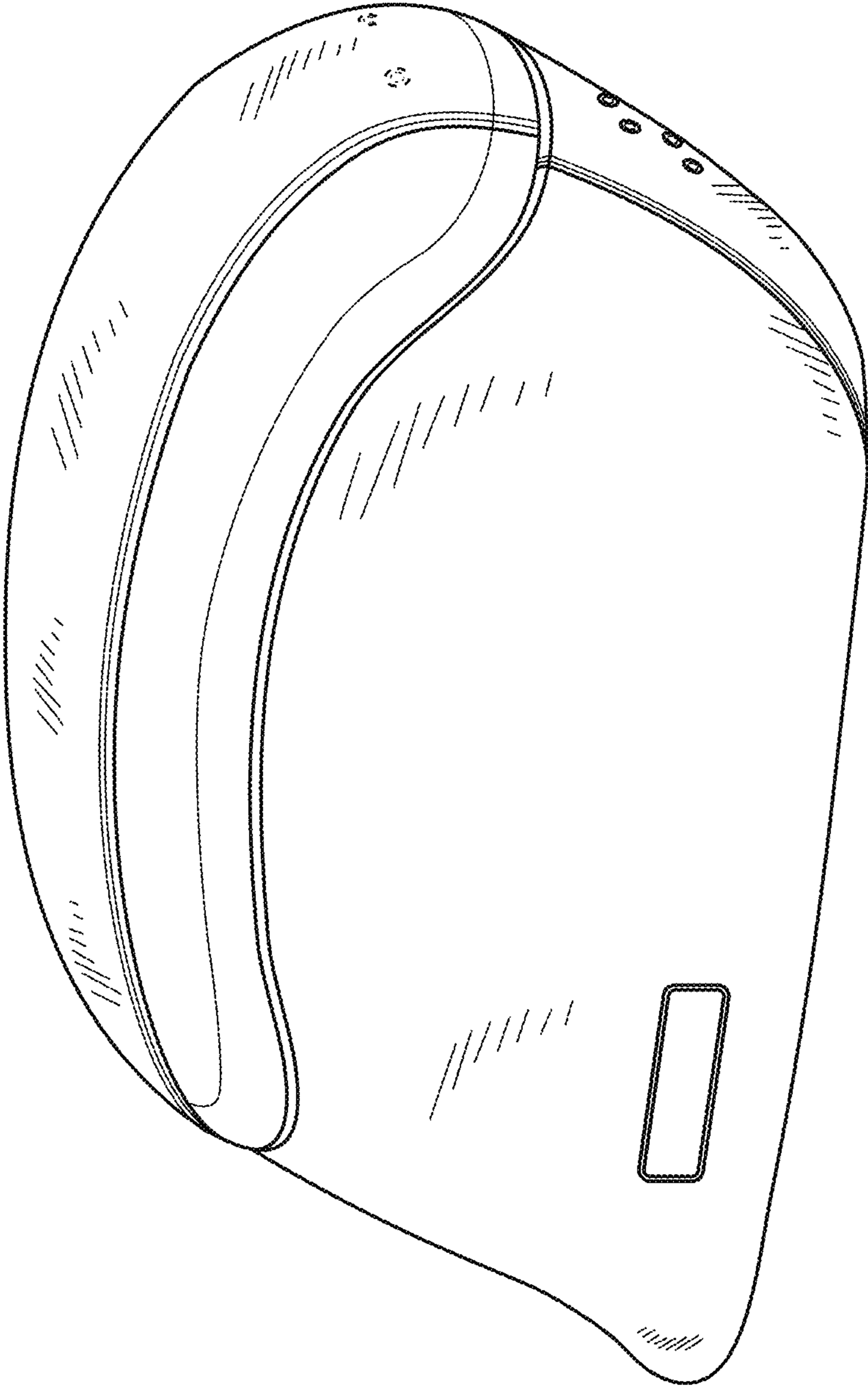

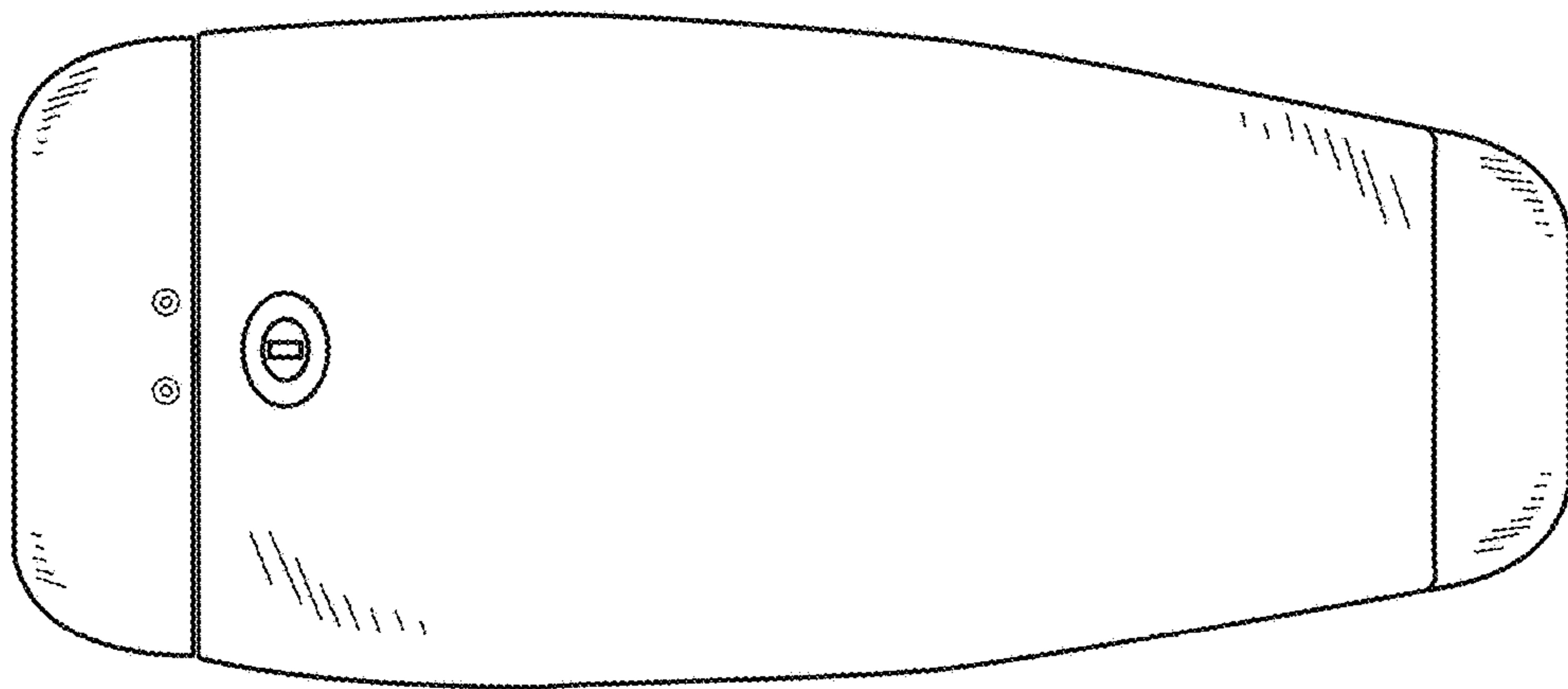

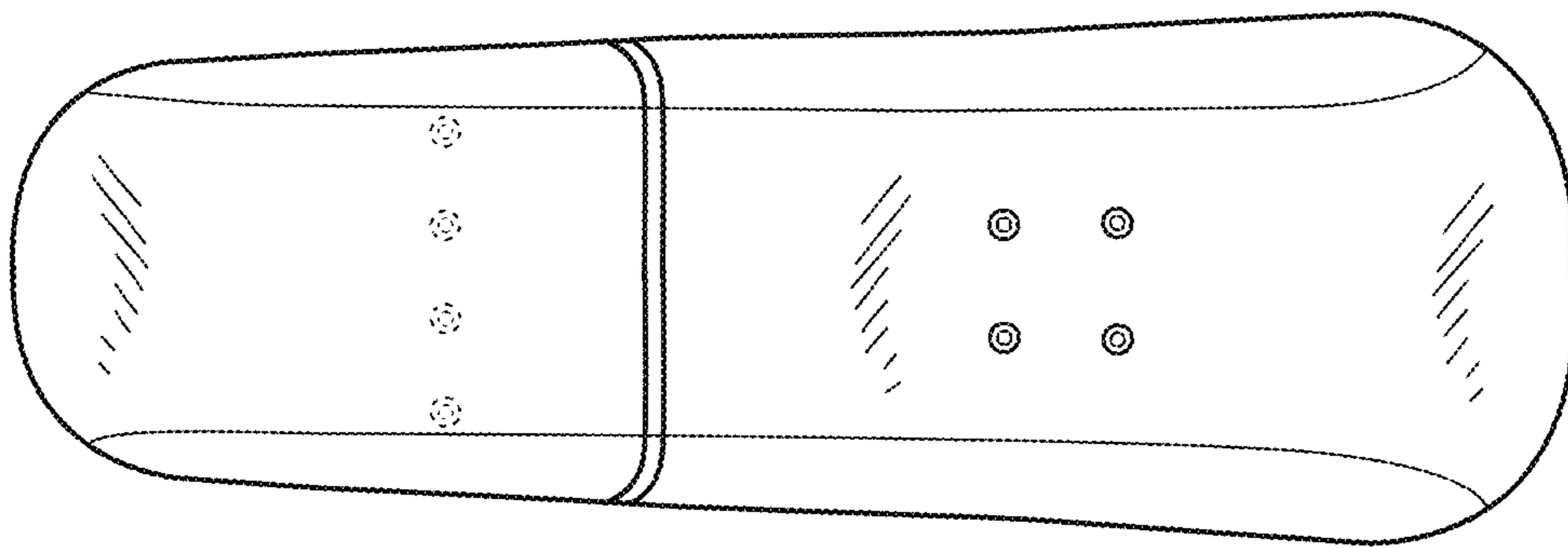

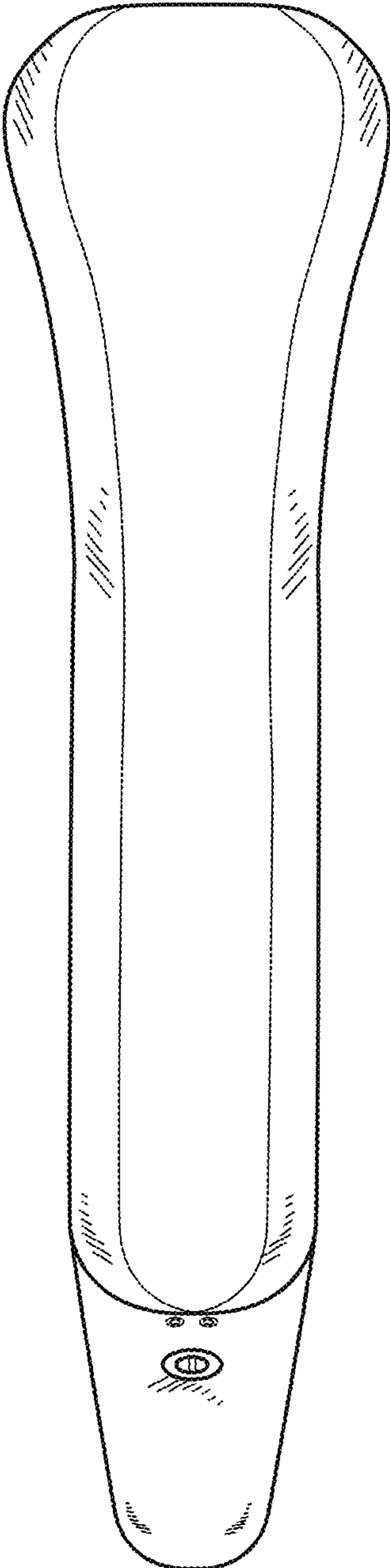

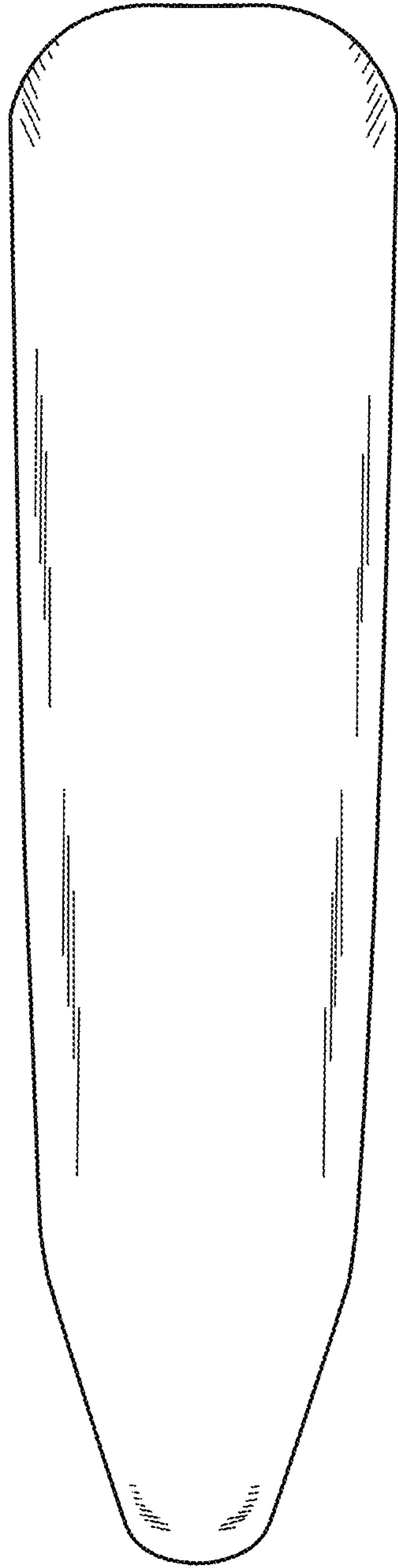

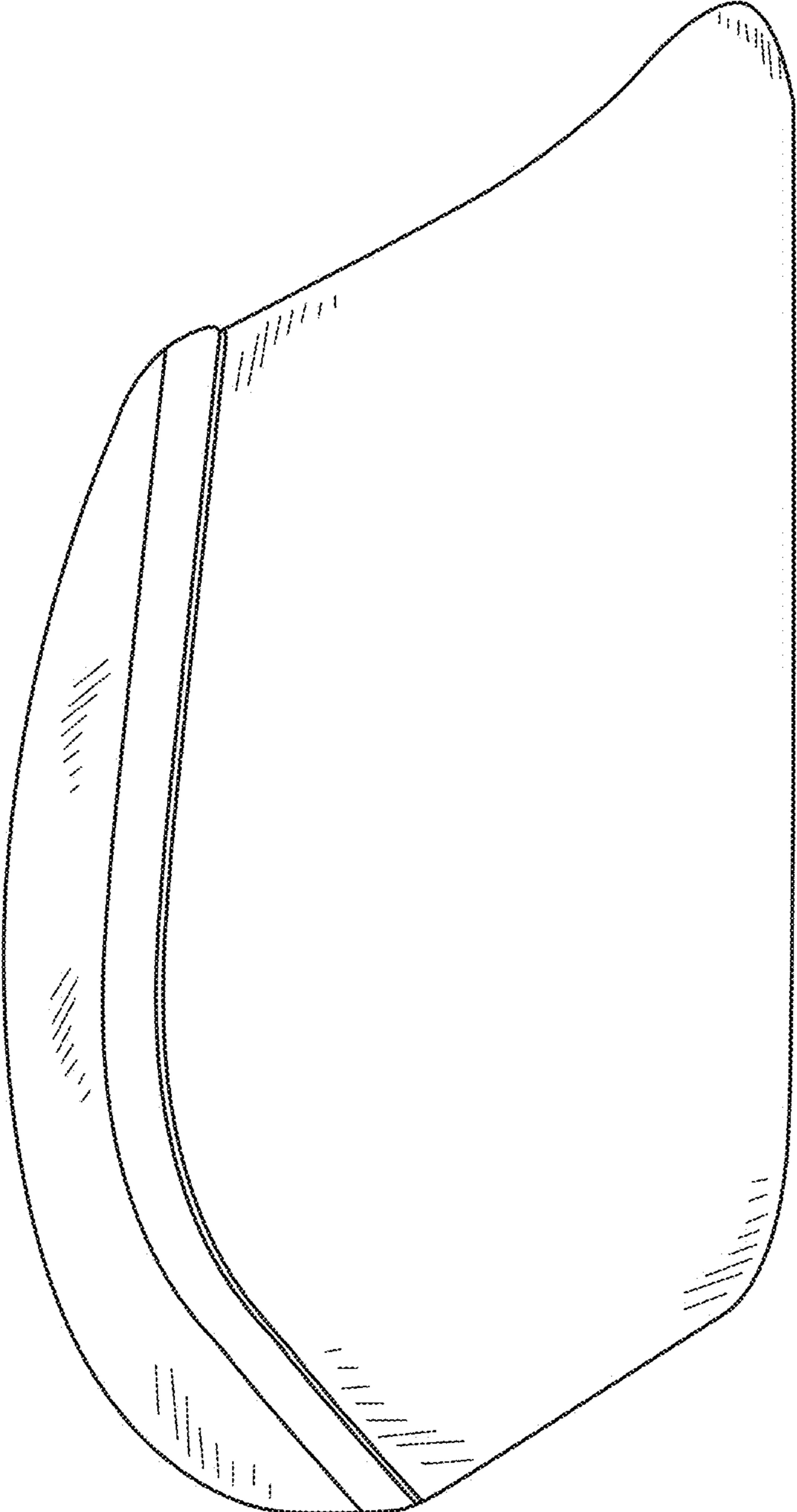

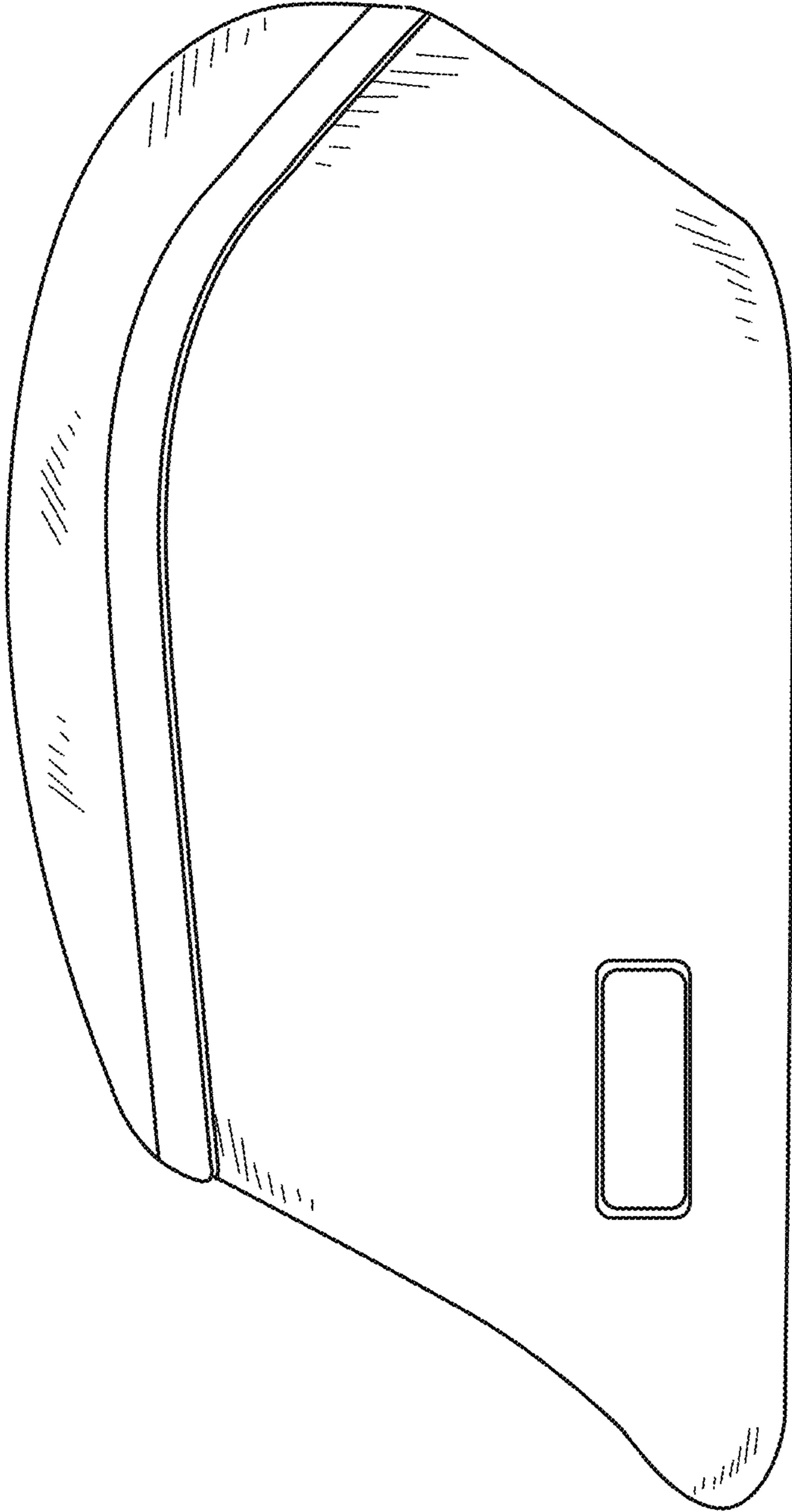

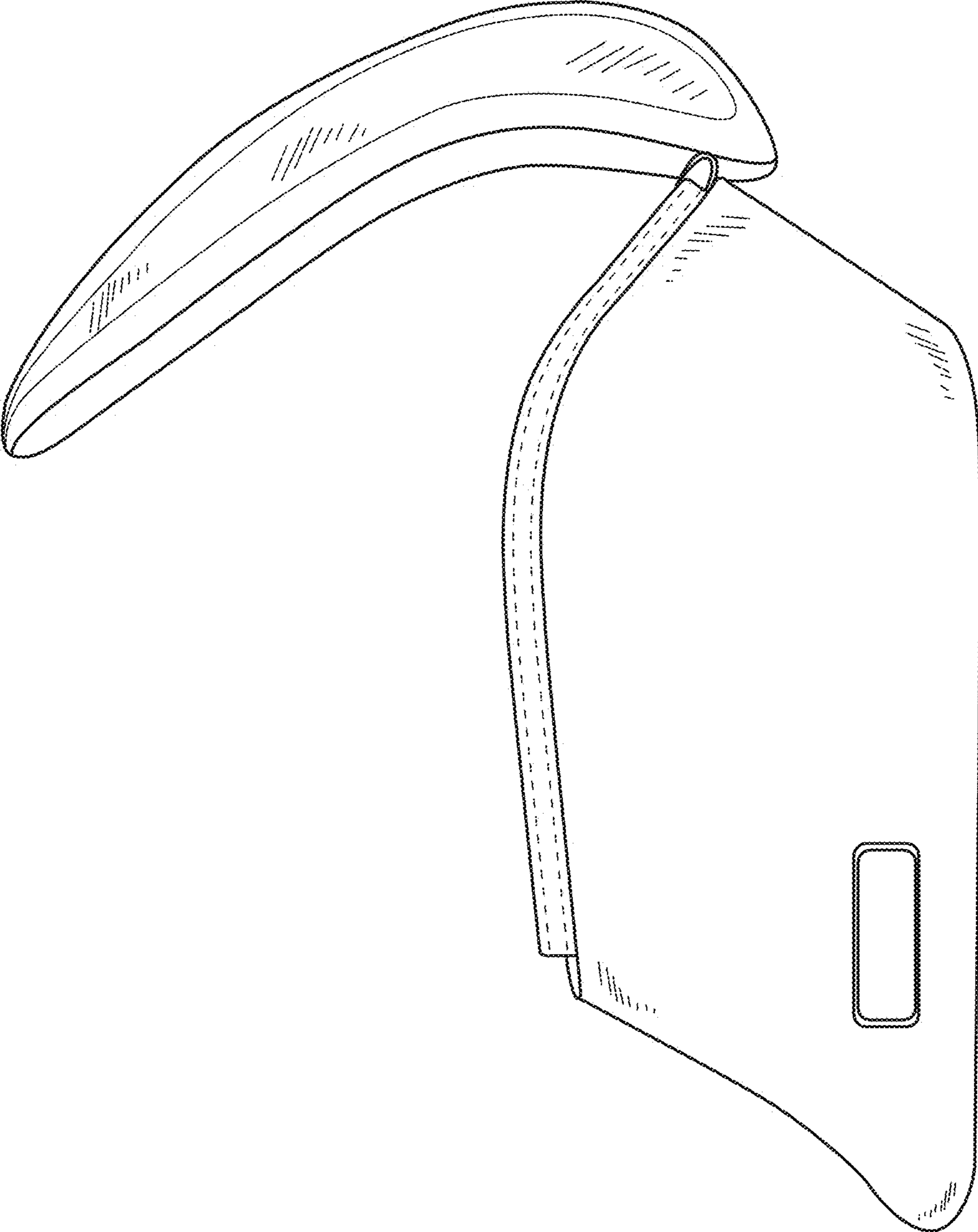
